# Four from Glen Cove HS Selected for All-State Music Conference

Four student musicians from Glen Cove High School have been selected to participate in the 2012 New York State School Music Association (NYSSMA) All-State Conference. Michael Banks (Bass I) and Claudia Kolonavic (Alto II) have been chosen as members of the Mixed Chorus, while Victoria Andreotti (Soprano II) and Matthew Kolbert (Tenor II) will serve as alternates. This marks the second straight year Victoria has received All-State recognition.

The NYSSMA All-State Conference, which honors the best high school musicians from throughout New York State, is held annually at the prestigious Eastman Theater in Rochester. Between 500-600 students are selected, including 250 members of the All-State Choir, which these students will perform with under the direction of renowned composer Dr. Rollo Dillworth. This year's show will take place Nov. 29-Dec. 2. The Glen Cove Board of Education honored the four at the September business meeting.

"These students were chosen based on their proficiency scores achieved during the NYSSMA solo festival last year. All four of them achieved perfect scores on their performance," said their chorus teacher, Edward Norris. "Congratulations to them. I know they will make us proud."

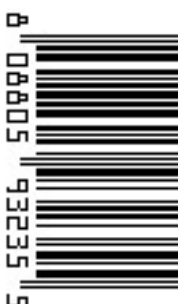

# Letters to the Editor

## In Support of McCoard To Whom It May Concern:

This is a letter in support of the re-election of Judge Richard McCord as Glen Cove City Court Judge. Over the period from 1998 through 2006 I worked for Judge McCord as his Law Secretary and as the Teen Court Coordinator. During that time I observed Judge McCord as he interacted with prosecutors, defense attorneys, plaintiffs and defendants, and courtroom observers. While often justifiably angered by the crimes committed against innocent victims and citizens of Glen Cove, Judge McCord always focused on the possibility of redemption as well as punishment; his goal was to stop future crimes as well as punish those guilty of present-day offenses. To that end, young offenders would be given sentences that gave them the ability to learn from their mistakes; those older who had made one bad decision would not have their otherwise exemplary lives ruined as a consequence. In sum, justice was tempered with mercy and compassion, and an understanding that everyone makes mistakes. It was for this reason that Judge McCord created the Teen Court program, the first of its kind in Nassau County, and focused on "Education as the Best Form of Crime Prevention." By having students from lo-

cal high schools act as judges, jurors and attorneys for sentencing hearings involving teenage offenders accused of minor offenses, Judge McCord allowed teens to see the type of behavior that could lead to destructive decisions and life-changing consequences. I know for a fact that many lives were changed because of this program. ## Cob Salad or Cob Salad To The Editor,

Question: When is a Cobb Salad not a Cobb Salad? Answer: When it is served at one particular restaurant in Glen Cove. All restaurateurs and most clients know that a Cobb salad includes Romaine lettuce, chicken, bacon, tomatoes, egg, avocado and blue cheese. The Cobb salad was created by Robert Cobb, owner of Hollywood's famous Brown Derby restaurant, in 1937 when he gathered leftover ingredients from the refrigerator in order to prepare a midnight snack for himself and Sid Grauman, owner of Grauman's Chinese Theatre. The very next day, Mr. Grauman returned to the Brown Derby and ordered "Cobb's

Salad." The salad, quickly added to the menu, became an instant success and the rest is history. The classic presentation of the Cobb salad is to arrange the ingredients in strips across a bed of greens, not tossed as with other salads. Presentation, however, is at the discretion of the chef. One may also find slight variations with the ingredients. For example, turkey may be substituted for the chicken and other greens may be substituted for the Romaine. However, the staff at one Glen Cove restaurant think a Cobb Salad is a bowl of greens served with 2 cherry tomatoes cut in half, half a hard boiled egg, a sprinkling of gorgonzola cheese and a half teaspoon of avocado, no bacon, no

chicken (\$3.95 additional charge), all for the ludicrous price of \$12.95. In addition to this insult, the waitress threw a saucer with the ½ teaspoon of avocado on the table to prove it was in the Cobb salad and screamed loudly at the customer later in the afternoon when given articles about Cobb salad from three different sources. In this case, the customer was right and the waitress, who banned the customer from ever entering the restaurant again, was and is extremely ill-tempered and ill-mannered. Is it any wonder that there were very few customers dining there on Sunday when the former restaurant on the site had full tables?

## North Shore Hospital at Glen Cove Welcomes IAC for Monthly Meeting

On Wednesday, June 13, the Glen Cove Interagency Council held its monthly meeting at North Shore Hospital at Glen Cove. Bob Savitt, Associate Director of the Division of Community Psychiatry and Substance Abuse Services welcomed agency representatives and gave them an overview of the addiction related services available at the hospital through Community House.

Community House has been in Glen Cove for 40 and currently operates four distinctive programs. The Women and Children Program is for young mothers with substance abuse problems. Child care is available for children under age 5. The program meets in the morning. Most patients stay in the program for about 1 year. There is a continuum of care available after a mother completes the program. Approximately 30 percent of the program participants receive psychiatric assistance as well.

The Dual Diagnosis Program is about 15 years old and can accommodate 50 patients. There is a morning and afternoon session; approximately 10 percent of the patients stay all day. The primary goal of the program is to offer restorative treatment to patients with both psychiatric and substance abuse problems. Some patients are chronically ill; others are capable of doing other things as well. Approximately 50 percent of the participants are working, going to school or participating in wellness programs (i.e.: smoking cessation, acupuncture, etc.)

The Adult Outpatient Program is a drug treatment program for individuals with mild to severe addictions. It was founded in 1972 and many of the pa-

tients are referred to the program by the courts after being convicted of a DWI. Patients are 18 years or older and most are reluctant to come at first. Initially, the patients come 2 to 3 times a week. Once a patient is stabilized, treatment is more individualized and less frequent. The average treatment lasts 1-1/2 years. The focus is on relapse prevention and healthy life styles.

Finally, the Adolescent Program is a substance abuse program for teens aged 13 to 18. It addresses drug, alcohol and prescription abuse. Most of the adolescents in the program have problems in many areas (i.e.: home, school, friendships, etc.) It is a day treatment program that runs from 9:00 am to 3:00 pm., with academics provided by BOCES. Treatment consists of individual and group therapy, with a strong emphasis on family. Most patients are in the program for 9 months to 1 year. The Adolescent Program also offers a 2-3 time a week program. The focus of this program is specifically on the family and the need to make changes in the family structure to address adolescent problems.

Members of the IAC include community leaders representing a variety of human and social service agencies throughout Glen Cove. It reflects Glen Cove's rich cultural, religious and ethnic diversity and meets regularly to identify and address changing needs in the community. This network has resulted in numerous projects and collaborations that benefit Glen Cove residents on a daily basis. For more information about IAC, please contact Dr. Sharon Harris at 676-2008.

# Name the Celebrity



### Last Week's Celebrity

Last week's celebrity was Lyle Talbot. He appeared opposite many famous actresses including Carole Lombard, Barbara Stanwyck, Mary Astor, Ginger Rogers and Shirley Temple. Talbot's activism in union affairs affected his career path. Warner Bros. dropped him from its roster. With fewer and fewer starring roles, he became a capable character actor, playing affable neighbors or crafty villains. Having been on Broadway, he returned to the stage in the 1960's and '70's starring in Thornton Wilder's "The Matchmaker" and Gore Vidal's political drama, "The Best Man", which, just this past summer, had a short Broadway revival starring Angela Lansbury, Candace Bergen and James Earl Jones. Talbot was the first live action actor to play prominent DC Comic characters on-screen, as "Commissioner Gordon" in "Batman and Robin" and supervillain "Lex Luthor" in "Atom Man vs. Superman", who at the time was simply known as "Luthor". He had many guest spots on "Perry Mason", "Wagon Train", "Green Acres", "The Beverly Hillbillies", "Rawhide", "Charlie's Angels", "St. Elsewhere", "Newhart" and many others. One of his 4 children, Margaret Talbot, is a staff writer for "The New Yorker" magazine. In the 10/1/12 edition, she writes about her father's long career beginning in Pre-Code Hollywood, why he never became a big star and his role in founding the Screen Actors Guild. Talbot died in 1996, at the age of 94, from pneumonia.

### Correct Callers

Callers who knew our celebrity last week were: Ted March, Mario Moccia, Roberta Pezza, Will and Babs Hutchins, The Tuthill Family and Don Adams.

This week's celebrity was an American film and stage actor. He was born in Canton, Ohio but was raised in Philadelphia. He started his film career at the age of 48. His film debut came in 1914 with the silent film "Too Many Husbands". In 1913, he co-founded, along with actor Eddie Foy, the Actors Equity Association, an American labor union for actors. The original organization, known as the "White Rats", was spearheaded by our celebrity. After a nine month stretch, the actors' group united in defiance of the appalling treatment of actors by theater owners such as the Shubert Family, by refusing to appear on stage by striking. The actions of the association caused the closure of all the theaters on Broadway, the only exception being theaters owned by George M. Cohan's company. # PUBLIC NOTICE

## RESOLUTION NO. 67, YEAR 2012

RESOLVED, that Section A153-1(A), (B) and (C) be amended to read as follows:

All sidewalks and curbs shall be constructed in accordance with the grade as established by the Superintendent of Buildings.

**Sidewalks.** In residence districts, sidewalks shall be three (3) feet in width and not less than four (4) inches thick. In business districts and adjacent to property where a nonconforming business use exist, sidewalks shall be constructed so as to cover the full area between the curb and the property line, unless otherwise directed by the Superintendent of Buildings, and shall be not less than five (5) inches thick. Where crossed by driveways, all sidewalks shall be not less than six (6) inches thick through the width of the driveway.

**Curbs.** Except in instances where otherwise directed by the Superintendent of Buildings, curbs may be formed by poured concrete or formed using Belgian or granite blocks as follows:

**Concrete Curbs.**

In residence districts, shall be eighteen (18) inches in depth and not less than six (6) inches thick.

In business districts and adjacent to property where a nonconforming business use exists, shall be eighteen (18) inches in depth and not less than eight (8) inches thick.

**Block Curbs.**

In residence districts, shall be either eight (8) inches wide by eight (8) inches long by four (4) inches thick or twelve (12) inches wide by eight (8) inches long by four (4) inches thick. Blocks shall be supported by a concrete base that is a minimum of ten and one-half (10.5)

inches deep and twelve (12) inches wide with two (2) - #3 bars running continuously along the length of the concrete at a depth two and one-half (2.5) inches from the bottom of the excavation. The bars are to be spaced six (6) inches apart and three (3) inches from each edge of the excavation. Block will be set four (4) inches below grade leaving a four (4) inch reveal on the street side of the curb. Blocks will be spaced three-quarters (0.75) of an inch between blocks. The back edge of the excavation will be poured to a depth of seven (7) inches to a depth of ten and one-half (10.5) inches at six (6) inches from the back edge of the excavation and continue that depth to the back of the block. Joints will be filled with mortar and a four (4) inch thick mortar backing will be placed behind the block leaving a one (1) inch reveal on the private property side of the block.

No block curbing is permitted in business districts or adjacent to property where a nonconforming business use exists.

All cement shall have a 28 day compressive strength of 3,000 psi.

Detail drawings for each curb type are available at Village Hall and on the Village website.

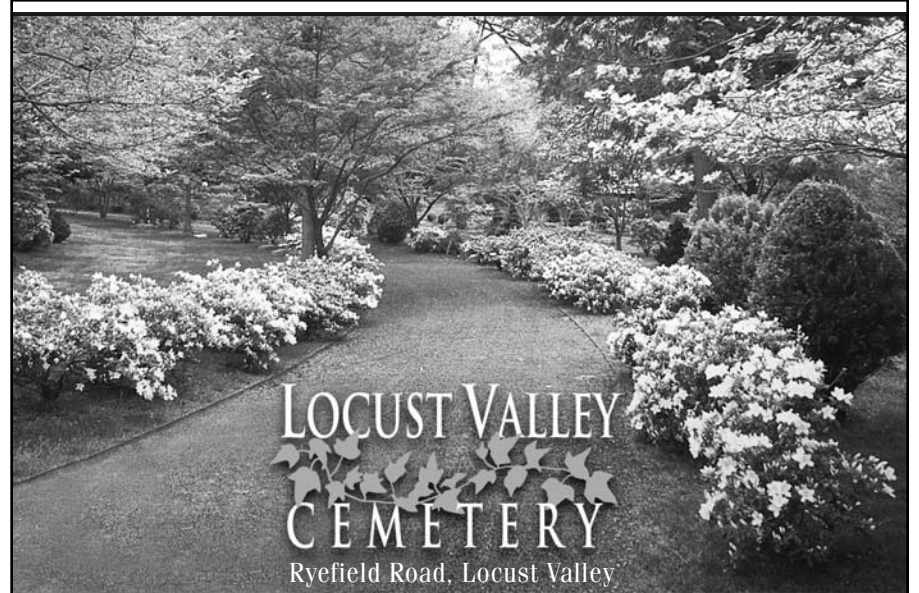
