



Glen Cove Aids Sister City

The community of Long Beach was hit hard as were many other places along the south Shore,” said Mayor Ralph V. Suozzi.

On Sunday November 19 a convoy of City of Glen Cove DPW vehicles and 31 men set out for Long Beach to assist with debris removal.

“Our Glen Cove DPW crews worked throughout Hurricane Sandy and its aftermath and all day Saturday to remove debris from the streets of Glen Cove.”

“Today [Sunday] we departed the Glen Cove DPW yard at 6am escorted by City of Glen Cove Police to our City’s border and we also had two Nassau County Police cars escort our DPW convoy all the way from the City yard down to Long Beach. The

convoy stretched almost a 1/4 mile back and the men worked collecting debris from 8am to about 5pm.

“We arrived with 5 garbage trucks, 4 dump trucks, a bucket truck, a chipper, one backhoe, an excavator plus crews and mechanics.

“I am so proud of the way our City employees,” said Mayor Suozzi, “first responders and volunteers handled Hurricane Sandy and its aftermath but I take my hat off to these guys for what they did today.

“Thank you DPW. You delivered once again.”

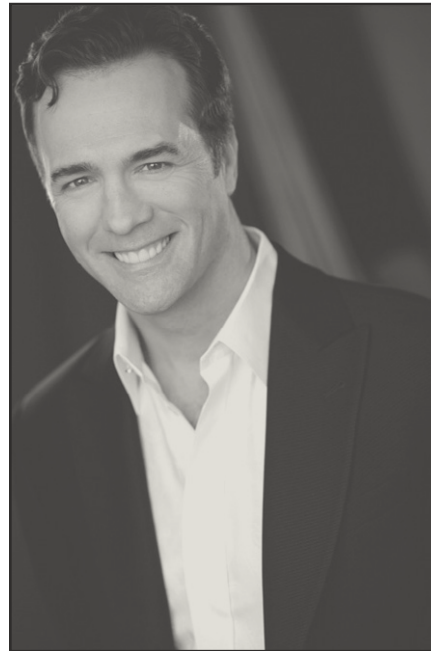
Tiaras off to Emary

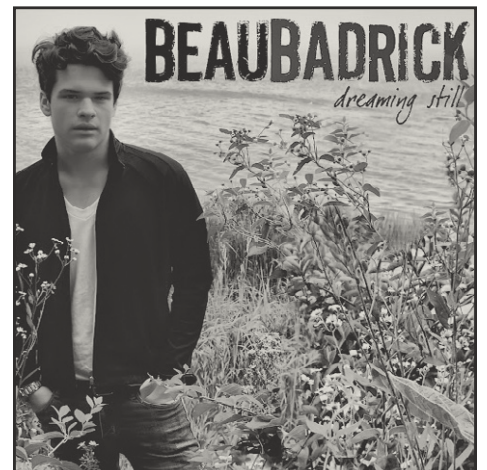

Mark Doherty of Long Island Home & Property Maintenance shared this great story with me. "Last month I went to Will Hutchins house to give him and his wife Barbara an estimate on their gutters. I asked the age of the house because I recently purchased a metal detector for my 10-year-old son Michael & myself and when Barbara told me about 100-year-old I asked for her permission to us it in her yard."

Doherty said, "Barbara replied "yes," and mentioned that her husband Will was throwing pears in the backyard 12 to 16 years ago when his ring flew off his finger. They looked day after day, week after week, month after month, year after year... They even had the late Tom Rennison spend a weekend with his metal detector and a friend looking for it about 10 years ago all to no avail. So, Barbara and I looked that day for a couple of hours also to no avail. My son Michael had the next day off of school, after finishing up on the days estimates with me at the end of the day, we decided to try and find Will's ring and look for a couple of hours with no success.

About a week later I stopped to check on my guys installing the new gutters and decided to look for the ring again. About an hour into looking my detector made the familiar sound of metal and I look down and there it was!

"Will was home at the time and came out shortly after the find. We spoke for 5 to 10 minutes, I asked him a few questions about the ring, but I didn't tell him I had found it. I was dying to tell him, but I wanted my 10 year old and his wife Barbara (whom was at work till 5:30) to witness the excitement of the find!"

Later that evening, I grabbed my son and his friend Mireya and drove to their house at 5:45. I gave the ring to Michael to give back, Michael made up a story spur of the moment story that we had found a silver coin. But when Michael opened his hand, Will looked down and it was an exciting moments to see the surprised expression on his face. Both Barbara and he screamed with joy because that ring was custom made by his mom when he was very young!"

beautiful pastel paintings by Kay Vickers, on view at Sea Cliff Village Library for November and December.

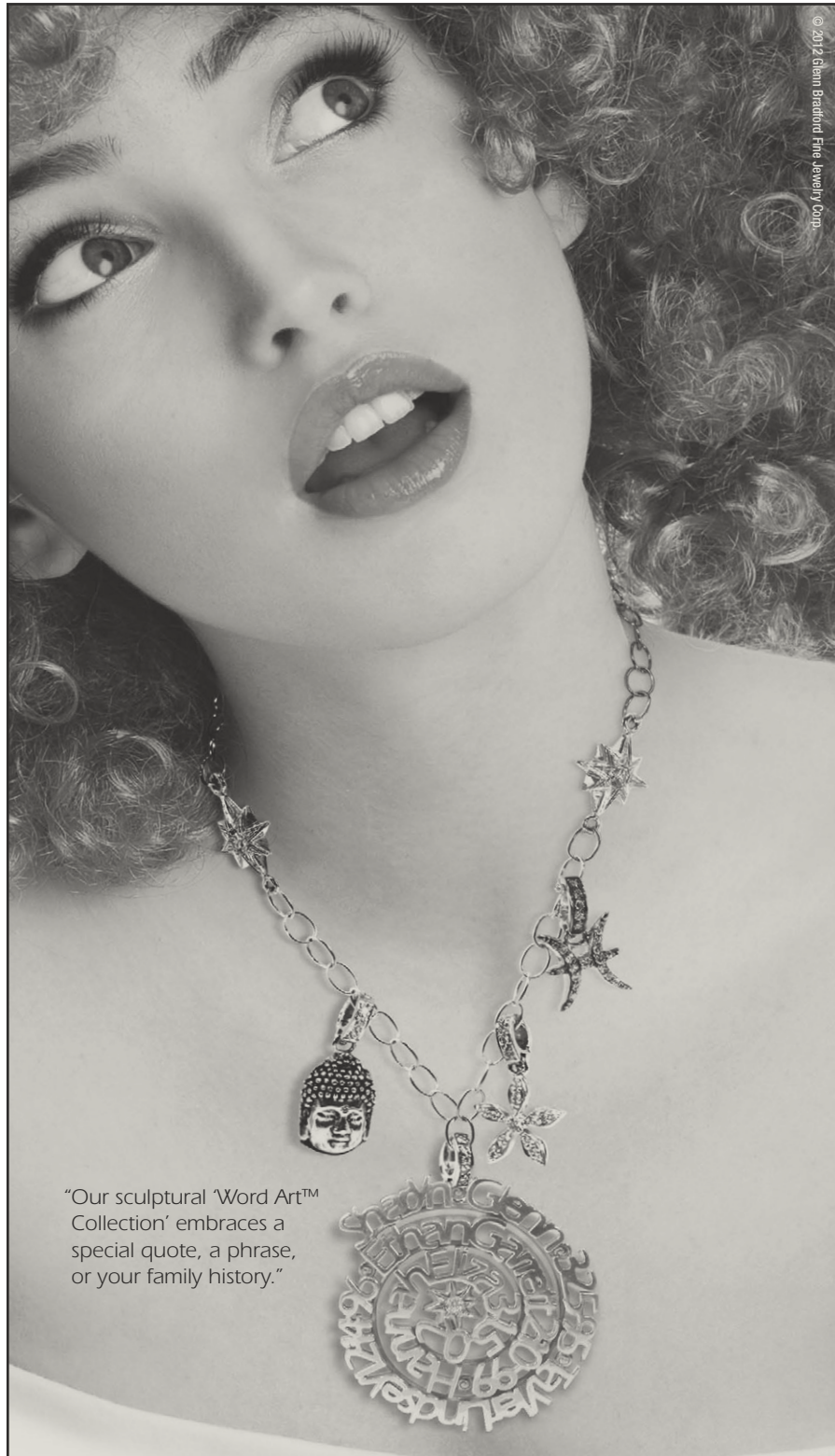

Kay Vickers and her husband, Rick, moved to Sea Cliff in 1972, the year they were married. They sensed that the Village could offer a small town community, along with peacefulness and beauty. Several of Kay's landscapes are local scenes – sunsets, the boat house, Shore Road after a snowstorm.

Kay is a practicing clinical psychologist (Ph.D.) However, after having her two wonderful children, Leah & Luke, she discovered the Long Island life style of lessons (in everything, or so it seemed). Kay proceeded to take ballet lessons for 20+ yrs, followed by piano lessons, and recently turned her attention to the visual arts. She finds that painting allows for greater self-expression than her other artistic endeavors.

Kay credits 2 teachers with encouraging a 'novice' to develop into a confident artist - Both Steve Lampasona, and Jane McGraw-Teubner emphasize keeping one's focus on abstract shapes, rather than the details. She has also learned the importance of value studies, as well as the distinction between soft and hard edges. However, the most important aspect to painting is to begin with a scene, or a subject, that moves you. Her philosophy is to 'paint something that excites you, and you will find a way to convey your enthusiasm to others.

NS Middle School Students Participate in Interactive Workshops Called Hunger 101

Keeping in line with the E3 (“Everyone Matters, Everyone Cares, Everyone Learns”) initiative at North Shore Middle School, students participated in Hunger 101, an interactive workshop aimed at addressing the causes and consequences of hunger on a local, national and global level. It is sponsored by Long Island Cares, Inc. which was founded by the late singer Harry Chapin in 1980.

Christine Brown, Coordinator of Community Education Outreach and Self-Sufficiency for Long Island Cares, conducted a number of interactive workshops with Team C students at the middle school in October. Her goals included: Raising awareness of the problem of hunger and poverty on Long Island, understanding the causes and consequences of hunger and suggest strategies to help alleviate, and empowering individuals to think critically about practical and effective solutions to hunger.

Social Studies classes at the middle school role-played the following “real situations:”

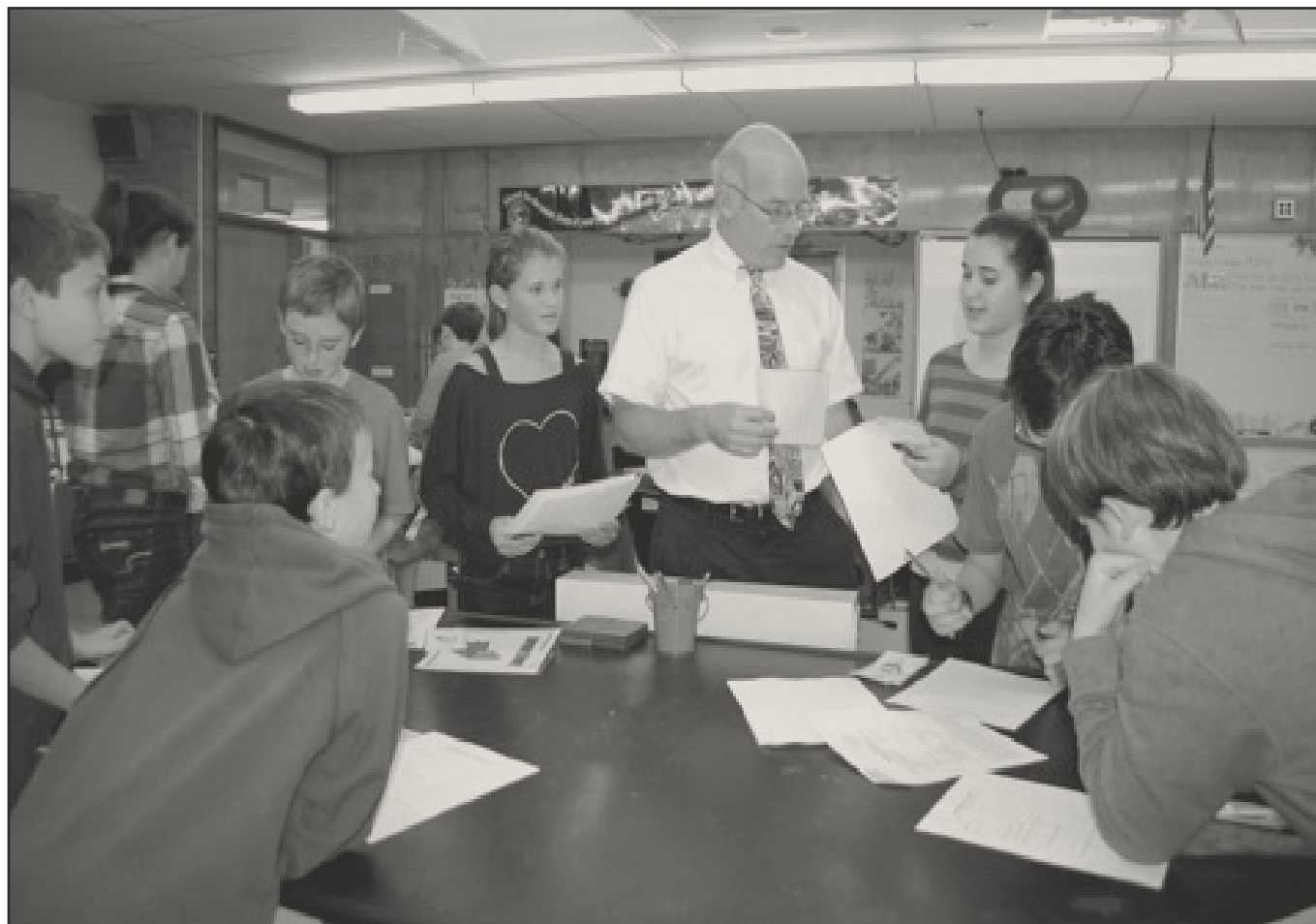
- Living within a tight budget
- Not having the money to buy nutritious food and sufficient foods
- The challenges of having to deal with social service agencies
- The restrictions and obstacles facing people experiencing hunger

Problems involving hunger affect approximately 260,000 people on Long Island. Ms. Brown said, “Hunger is a serious problem on Long Island even though it is one of the most affluent re-

gions in the United States. Long Island Cares helps people become more self-sufficient and provides food to those in

Movie Review



Skyfall

Rated PG-13 (Intense action violence and mild sexual content)

Runtime: 143 min

The latest entry in the internationally beloved 007 series almost did not exist. Its production came to a screeching halt in 2010 as a result of MGM Studio's financial distress. Had the studio not managed to rebound from the brink of bankruptcy, Skyfall may not have had a future. What a travesty that would have been to the cinema world. After record breaking success from its foreign openings Skyfall is on its way to becoming a mega hit, and for good reason.

We begin right in the middle of a mission in Turkey. Within minutes MI6 agents James Bond (Daniel Craig) and Eve (Naomie Harris) are in an adrenaline fueled pursuit of mercenary Patrice (Ola Rapace). Patrice has stolen a computer hard drive containing the identities of undercover agents around the world. Patrice makes off with the hard drive as Bond is accidentally shot.

Meanwhile in London, MI6 head M (Judi Dench) resists the pressure from Intelligence and Security Committee Chairman Gareth Mallory (Ralph Fiennes) to retire. This issue is temporarily put on hold when the MI6 computers are hacked followed by a massive office explosion, killing many employees.

Once being put through numerous tests to prove he still has worth as an agent despite his age, Bond is given the assignment. He meets his new Quartermaster (Ben Whishaw), who equips him with nothing more than a Walther PPK and a radio transmitter. Gone are the days of exploding pens and Bell Rocket Belts. The young Quartermaster is one of many reminders that Bond may be getting too old for his line of work.

Bond is eventually led to one of the series' most striking villains, Raoul Silva (Javier Bardem). While he does not exactly appear intimidating, what with his orange eyebrows and cream colored blazer, Silva presents himself with sinister flamboy-

ance. In addition to his fondness for a flashy entrance and complete disregard for human life, Silva has dedicated himself to settling a personal score with M.

This entry is unlike past James Bond films, beyond the fact that his current beverage of choice is a Heineken. In exchange for the innovative gadgets, we are given glimpses of Bond's traumatic childhood. The requisite "Bond Girl" is given a notably minor role, with the focus shifting to Bond's struggles with age and his commitment to the agency. Every ounce of skill, stealth and strength Bond puts forth is not just for the sake of the mission, but also for his own confidence. Daniel Craig expresses this concealed conflict with flawless subtlety.

This is also the first of the Bond films to be released in IMAX, and it is absolutely worth experiencing it as such. Every explosion, gunshot, and the destruction of a beautiful Aston Martin are felt as a pound against the chest. The elevated crystal clarity emphasizes some of the best action sequences seen all year. The full body, long-take combat shots are pure adrenaline surges set in stunning locations. The movie's theme could have been something special had it not been for Adele lifelessly moaning through the lyrics, though the movie should not be held accountable for this. As a whole, Skyfall is most definitely one of the best in the series, and, quite possibly, the best.

Lt. Tom Fitzpatrick Retires

Oct. 30 2012, Det. Lieutenant Thomas Fitzpatrick of the Glen Cove Police Department retired from his position as Commanding Officer of the Department's Detective Division after 24 years of service to the community, Lt. Fitzpatrick, who prior to being hired in 1988 by then Mayor Donald DeRiggi, had worked as a New York City Transit Police Officer in Times Square for three years. Lt. Fitzpatrick has been the Commander of the Detective Division for the past 14 years and if his name sounds familiar it may be because one of his responsibilities has been the role of Public Information Officer for the Department, or it may be because his family has had roots in the Glen Cove area since the mid 1800's.

Lt. Fitzpatrick was also well known in police circles as being one of the most highly trained officers within the Department. Records show that Lt. Fitzpatrick has received specialized training over the years in disciplines such as: Homicide Investigations, Dignitary Protection, Interviews and Interrogation, Financial Crimes, Narcotics and Gang investigations, certification as a Voice Stress Analyst, a Hostage Negotiator, and graduation from the FBI National Academy, Lt. Fitzpatrick was Deputized a U.S. Mar-

shall in 2003 by the FBI to facilitate a very successful joint investigation that began in Glen Cove and spanned the East Coast of United States. He has received awards of achievement from the FBI, Nassau PD, Nassau County Police Chiefs' Association, Old Brookville PD, and the U.S. Department of Justice. He's been awarded 28 Departmental commendations throughout his tenure at the Glen Cove P.D. and has been a guest speaker at John Jay College of Criminal Justice.

Chief Whitton lamented that not only was he was losing a key piece of his management team with Fitzpatrick's departure, but that the Department, as well as the community, was losing a talented and dedicated individual who had a reputation of shining brightest when things were at their worst. "It's a huge loss for this Department and it pains me to know that he's leaving us." When asked about some of the accomplishments Lt. Fitzpatrick was most proud of during his career he said, "It's hard to pick out one thing over another but I can tell you this, I'm very proud of how far this Detective Division has come in the last 15 years. Yes, it's a small town police department, but no one, no other department, no other unit or no other command, knows these streets like we do. Arresting criminals is the easier part of a detective's job. Careful case management and knowing the rules of the game are what helps win successful prosecutions. That's where our talent comes in. We've solved a lot of cases, we've helped an awful lot of people, and we've earned the admiration of our colleagues in other agencies along the way. I think that say's a lot. Aside from that, one other thing stands out: I'm proud of having had the opportunity to serve our community in this capacity; the opportunity to make a real difference in people's lives. And I'm extremely humbled by the notion that maybe I've accomplished that."



North Shore Schools Superintendent Dissolves Bussing Issue

Parents ready for bear who attended the November 14 North Shore Schools Board Meeting walked out of the meeting with smiles saying, "Now, I know why so many people like that guy." Superintendent of Schools, Dr. Ed Melnick spoke directly to the many parents from private and parochial schools in the audience who were there to complain about busing not being provided days after Super Storm Sandy despite their schools and North Shore Schools being open.

At the onset of the meeting, he simply said, "I'm sorry, it was a very difficult situation and we did the best we could..." In the aftermath of the storm, Dr. Melnick stated that a number of additional channels of communication have been put into place. All private and parochial school families living in the district should contact the transportation department (277-7930) to be included in the automated calling system for the future. Additionally, the school district has set up a passive Facebook page and Twitter account which they will utilize in addition to their school website at www.northshoreschools.org to convey important information.

Dr. Melnick went on to say that it was a difficult period of time when decisions were being made fast and furious with many different concerns in mind including primarily the safety of the children and also the gas shortage. (He said the district uses a total of 300 gallons a day servicing all the schools). He also

reiterated that at no time was bus service going to be suspended indefinitely for the private and parochial school children.

Resident Dave Whitting, initially upset and was ready to be the first speaker of the night remained seated and said, "Wow, you really took the wind out of my sail... You answered all my questions and concerns, thank you." Later, upon leaving the meeting he said, "Now, I know why so many people like that guy."

Dr. Melnick concluded by saying, "Please understand your kids are as important to me as any child in this district. Unfortunately, timing and judgement calls were difficult in this situation... If anything like this happens again, please feel free speak to us."

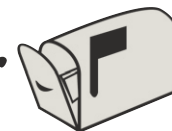

Name the Celebrity



Born on May 27, 1916, in Sunflower, Mississippi, this week's celebrity was an American TV and film actor, sometimes known as "Sleep n' Eat". He was one of the first well-known African American film actors and comedians, although his work, like that of Stepin Fetchit, is today sometimes reviled because he was often called upon to play stereotypical lazy, illiterate, and/or simple-minded characters in films. Of the 124 films he appeared in, he received screen credit in at least 77 of them, an unusual feat for a bit player. He arrived in Hollywood as a chauffeur for a vacationing couple, and began his performing career with a traveling show in southern California. He played " Chattanooga Brown" in two "Charlie Chan" films, 1945's "The Red Dragon" and 1946's "Dangerous Money". He also played the character of "Hipp" in 3 of RKO's six "Scattergood Barnes" films

with Guy Kibbee. He was also in "The Littlest Rebel" with Shirley Temple, "High Sierra" (1941) with Humphrey Bogart, and "Merrily We Live" (1938) with Constance Bennett and Brian Aherne.

Last Week's Celebrity

Born Simone Henriette Charlotte Kaminker, last week's celebrity was Simone Signoret. Besides being the first foreign actress to win an Academy Award, she also received a Cesar, a BAFTA, an Emmy, a Golden Globe, Cannes Film Festival recognition and the Silver Bear for Best Actress. Born in Germany, she grew up in Paris in an intellectual atmosphere and studied the English language in school, earning a teaching certificate. She tutored French and Latin and worked part-time as a typist for a French collaborationist newspaper, "Les Nouveaux Temps", run by Jean Luchaire, a French journalist and politician, who supported the Vichy regime's "Revolutions Nationale". During the German occupation of France, Simone mixed with an artistic group of writers and actors. They encouraged her to follow her acting ambition. In 1942, she began appearing in bit parts and was able to earn enough money to support her mother and two brothers, as her father, who was a French patriot, had fled the country in 1940 to join General De Gaulle in England. Simone took her mother's maiden name for the screen to help hide her Jewish roots. She was first married to filmmaker Yves Allegret, with whom she

had a daughter, Catherine Allegret, herself an actress. Her second marriage was to the Italian-born French actor, Yves Montand, in 1950, a union which lasted until her death. A life-long chain smoker, she died of pancreatic cancer in Auteuil-Anthouillet, France on Sept. 30, 1985, at the age of 64.

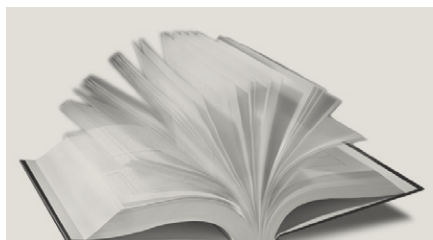
Great Book Guru

Dear Great Book Guru,
 What a beautiful weekend we had here in Sea Cliff! There were parties and family gatherings galore. In fact, I participated in a family reunion, a turkey hunt, and a bocce tournament all on Saturday afternoon. Despite the great weather and everything that was going on, I really wanted to see the new Spielberg LINCOLN movie so on Sunday we joined with friends for dinner and the movie. While I loved the movie, I was confused at times and would like to learn more. Do you have a book to recommend that will sort out all the historical figures we met?
 Loving Lincoln

Dear Loving Lincoln,
 We too saw LINCOLN this weekend and I was very happy to have a copy of Doris Kearns Goodwin's TEAM OF RIVALS on hand to clarify many points brought up in the movie. Our friends and fellow moviegoers Vic Ambrose and Linda Hallyday had read the book too, so it made for great dinner discussion. The book's

thesis is that Lincoln's genius lay in his ability to take his fiercest opponents and make them his greatest supporters. The book is really a series of multiple biographies: Lincoln, Attorney General Bates, Secretary of Treasury Chase, Secretary of State Seward, and Secretary of War Stanton. These men were dismissive of Lincoln and angry at losing to this underwhelming, unattractive opponent. By the end of his life, Lincoln had won them all over with his sensitivity, intelligence, and good will. The book is long (700 plus pages) but a compelling study of power and personality.



Sea Cliff Author Publishes Two Books on Urban Nature and New York Region

Sea Cliff author John Waldman recently published two books on urban nature in the New York region. Still the Same Hawk: Reflections on Nature in New York is a collection of 11 new essays of creative non-fiction by such noted naturalists and writers as Tony Hiss, William Kornblum, Phillip Lopate, Anne Matthews, and Robert Sullivan. The book began as the result of a conference Waldman convened at Queens College on "Why Nature Matters to New Yorkers." The conference helped launch the Institute for Sustainable Cities at the City University of New York, which was founded by a generous gift from the late labor negotiator and philanthropist, Theodore Kheel. The book's title derives from an observation in Robert Sullivan's contribution which considers that a hawk in the city (such as the famous Fifth Avenue resident hawk, Pale Male) is perceived much differently from a hawk in the countryside. Yet it's still the same hawk. The book also looks at how city dwellers react to the sudden appearance of nature, the symbolic value of historical images, the value of a community garden, environmental literacy and education, the possible environmental futures of New York, and much more.

The other volume is a revision of Heartbeats in the Muck: The History, Sea Life, and Environment of New York Harbor. Heartbeats in the Muck, which covers the arc of history of New York Harbor from its pristine origins through the ravages of the industrial era to its remarkable comeback today, was

first published in 1999, winning a New York Society Library Award. The revision includes an epilogue that brings the story of the Harbor to 2012, the 40th Anniversary of the critically important Clean Water Act, and includes the ambitious ongoing oyster restorations; alien species such as Asian shore crabs, zebra mussels, and snakehead fish; the effects of climate change; rehabilitation of the legendarily polluted Gowanus Canal, and even a return of bald eagles to Manhattan. Waldman's work on New York Harbor also resulted in a Norcross Wildlife Conservation Award and, just recently, the Wildlife Conservation Society's Conservation Award.

Both books were published by Fordham University Press and are available from their website and other web-based and storefront vendors. John Waldman also is a professor at Queens College, where he specializes in aquatic conservation biology. Waldman has published numerous other popular and technical books, including one on Hempstead Harbor and Western Long Island Sound with the Coalition to Save Hempstead Harbor. Presently he is working on Running Silver to Ghost Fishes, which looks at how mismanagement of rivers, particularly damming, has decimated North America's runs of migratory fishes such as salmon, shad, and sturgeon—and what can be done to reverse these losses.

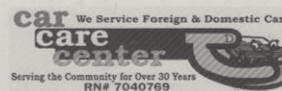

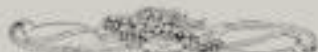

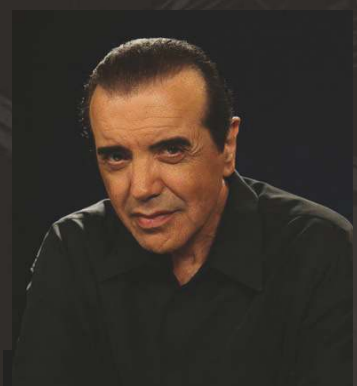
