David Leon was appointed as Police Sergeant with an annual base salary of \$151,534; Ryan Nardone was appointed as Police Sergeant with an annual base salary of \$149,984; and John Nagle was appointed as Police Lieutenant with an annual base salary of \$172,322.

the Police Department. Ryan is a PRIDE Instructor for the Schools. He scored number one on the New York State Sergeant's exam with a score of 98. He has a Bachelors Degree in Criminal Justice from C.W. Post. He lives in Glen Cove with his wife, Mena, and his 2 boys, Nicholas and Anthony. Sergeant Nardone will be replacing Sgt. Hall as a Patrol Supervisor."

### Sgt. David Leon

Mayor Suozzi said, "Sgt. David Leon has 12 years of service with GCPD. Dave Holds a Bachelors Degree from SUNY Old Westbury. Dave is also a PRIDE Instructor for the Glen Cove Schools and also one of the Departments Firearm Instructors. Prior to joining the Police, Dave served 3 years in the United States Navy. Sgt. Briana and Brandon. Dave will be taking Sgt. Nagle's position as a Patrol Supervisor."

Stango's is a special place. We want to keep it that way for a long time to come," said Stella. "We need some new blood to revitalize the restaurant that first

opened over 90 years ago."

The new partners will "revitalize" the restaurant, including upgrading the parking lot, enhancing the exterior lighting, remodeling the bathrooms, redecorating the main dining room including the floors and ceiling. "The key is make things better without changing the family-friendly, Southern Italian feel too much," said Stella, adding, "We'll keep the pizza the same!"

John, Stella's son said, " We want to stay involved and help keep things going while shifting some of the workload to the new partners. It's very exciting! Many of the new partners are Glen Cove and North Shore residents who have been coming to Stango's since we were all kids. We would only do this with people who understand and appreciate our history and who care about keeping the tradition going."

Renovations start this week and the restaurant will reopen in the early part of March. "We will keep you updated on the progress and with more details over the next few months," said John.

The program honors students for their exceptional achievements on the Preliminary Scholastic Assessment Test/National Merit Scholarship Qualifying Test, better known as the PSAT. Elias ranks among the nation's 34,000 top scorers on the PSAT.

GCHS Principal Dr. Joseph Hinton took the opportunity to announce that Elias is also the GCHS Class of 2013's top-ranked student academically. Additionally, Elias recently achieved the ranking of Eagle Scout and was a finalist for the prestigious Superintendent's Cup for athletic (cross-country) and academic achievement. He is also currently participating in the prestigious Partnership of the Future after-school science research internship with Cold Spring Harbor Laboratories, studying cognitive neuroscience under the tutelage of Dr. Sa-

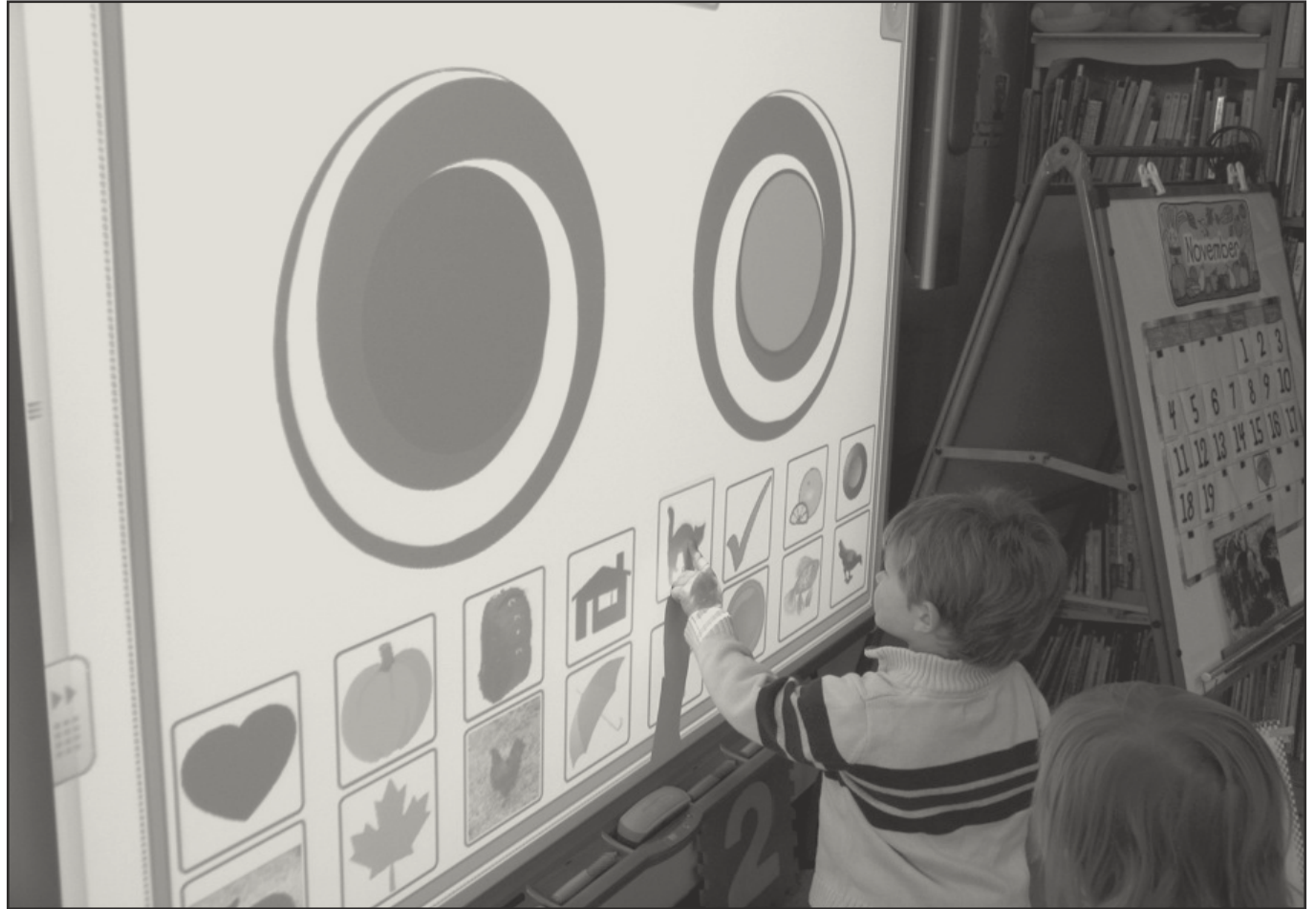
## All Saints Regional Catholic School Shows Off Its New Look

Sea Cliff welcomes another Italian restaurant, Tre Sorelle, to the community that opened recently in the Downing Avenue Plaza at 347 Glen Cove Avenue. Upon making its debut in the Village, much of the area had lost power during Sandy, but Downing Plaza was lucky enough to have kept its power, which immediately drew many customers to the restaurant for some Pizza or other Italian food and to warm up.

Speaking with the three Butindari sisters, Summer, Lauren and Lia Butindari Jorquera, who run the restaurant, they said the restaurant is a family run business that uses a lot of family recipes on their extensive menu. The space is all new and very fresh and attractive looking with warm woody colors all renovated by the girls' dad Larry, a contractor by trade. In the front section of the restaurant is the pizza counter and a few tables for quick meals, and in the back is a large dining room for dinners or a party.

Without reservation I would consider the food exceptional. They have two menus, a large take-out menu, and another one they use in the restaurant's dining room. My husband and I have ordered the pizza a couple of times for a take-out and we really enjoyed it. The crust was baked just right and it had an ample amount tomato sauce and cheese.

Dining in the restaurant to get warmed up during the power outage gave me and my family the opportunity

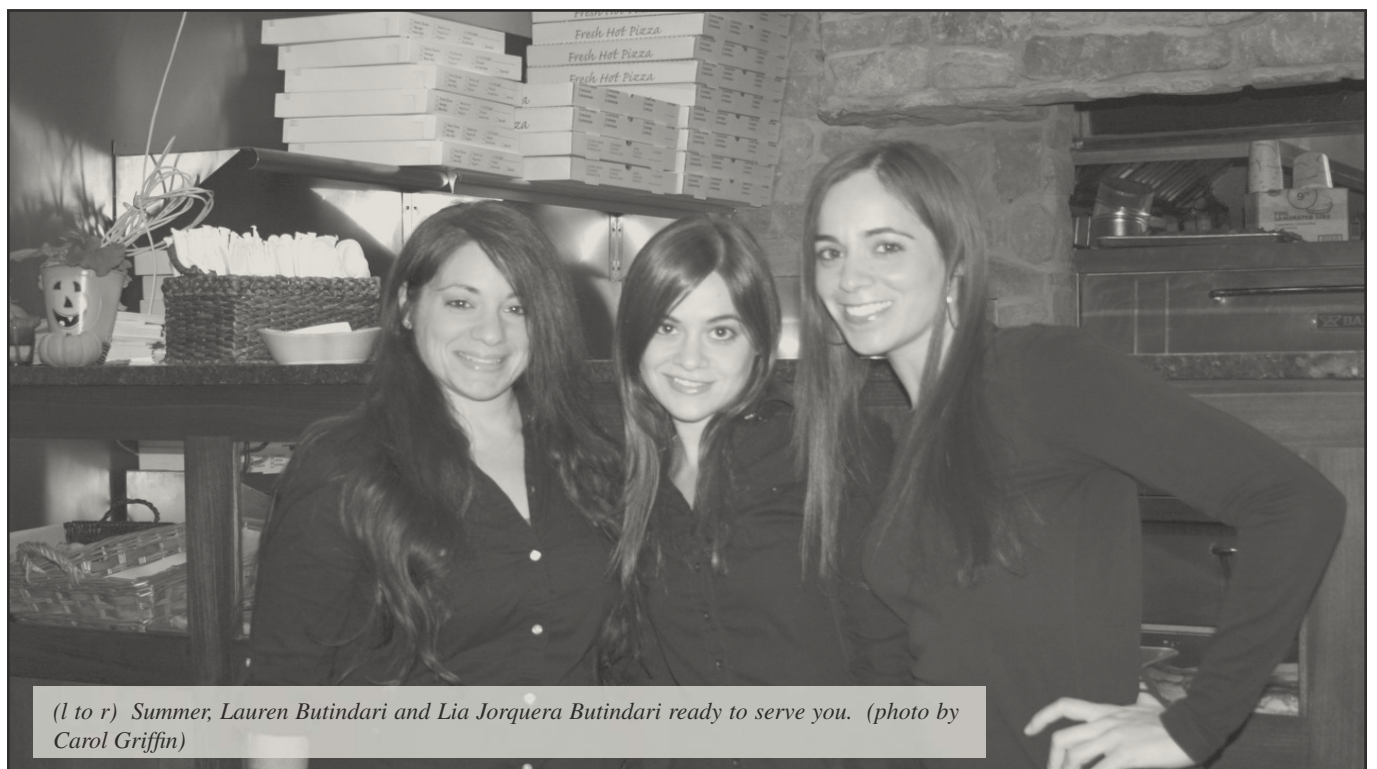
to try several things from the main menu. The chicken soup, Mama's recipe, was clear and light with ample vegetables and some pastina. My daughter had the stracciatella, which is Italian style, spinach egg drop soup and enjoyed it. Not wanting a full meal at lunchtime along with the chicken soup I ordered the mozzarella caprese salad. The mozzarella was very fresh and generous and the salad items were crisp and plentiful. A friend had the sautéed eggplant for her

main course which I tasted, and found it very tasty.

Another time my daughter and I ordered the chopped salad that had lots of fresh ingredients in it, which we both enjoyed. A friend tried an eggplant dish which I tasted and found delicious. My husband had the baked manicotti a favorite of his anywhere, and he really enjoyed the way it was made. Lastly, after eating at the restaurant the other night, my son-in-law stopped by at my house

raving about the pappardelle Bolognese, and now I can't wait to go back to the restaurant to try it out.

The tre sorelle, three sisters in Italian, are very friendly and accommodating and are really enjoying serving the customers who come to the restaurant. The quality of the food is great and the prices are moderate. If you haven't been there already, it's time to try Tre Sorelle and enjoy a delicious Italian meal.

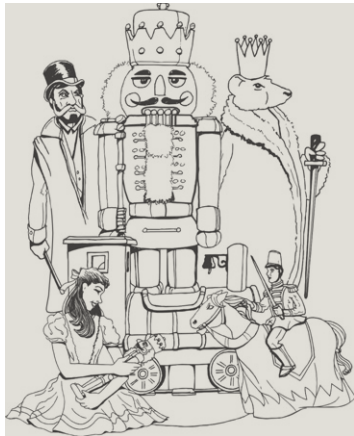

## Requesting West Shore Road Public Meeting

### To The Editor,

County Executive Mangano has agreed to hold an informational meeting on the West Shore Road plans he has created with Nassau's Department of Public Works engineers. I will continue to advocate on your behalf to the county administration, but it will also be helpful for your community leaders to come discuss the plans with the people directing the project. We expect to hear details on things like emergency plans, detours and whether the road can be open on weekends.

I have been pushing for the restoration to start since I took office. I was told that the permits were in and that the work could start as early as April of this year. Unfortunately, the first time they even brought it before the Legislature was months later in July. Then, instead of letting us approve it, it was tabled by the late presiding officer, Peter Schmitt. Had the work started in April like we were first told, the sea wall may have been completed, and maybe the road would have survived the storm.

Regardless, we are now at a point where County Executive Mangano believes the best course of action is to close the road for nine months in order to do the full restoration project "Phase One" (from around Cleft to about 2,000 feet north).

I am well aware of the impact this could have on day-to-day life and on the local economy. I have spoken with many residents and met with local business, community and school leaders. If the county maintains that this is now the only way they can do the project, I will keep pressure on them to finish the job before summer, which is the most crucial time of year for area businesses.

I am monitoring the project and will keep on top of their progress. As soon as we can get a date for a community meeting, community leaders and local officials will be invited to get more specifics and voice comments.

Commissioners are responsible for providing the necessary apparatus and equipment needed to assist the Locust Valley FD in the fire and rescue activities that are essential for the protection

of life and property within the LVFD district, while also remaining acutely aware of their fiduciary responsibility to the taxpayers within the district.

Commissioners are responsible for making policies and procedures under which the LVFD operate.

For a more complete definition of fire commissioner and responsibilities, you can refer to the NY State Town Law Section 176.

I believe one of the most important responsibilities of a commissioner is that of ensuring that their FD is properly equipped with various life saving equipment such as defibrillators, Jaws of life, hazardous material tools and the like. The Locust Valley Fire District is fortunate enough to have these tools and I know first hand that these tools have helped save numerous lives over the past 10 years since I have been a member. It is these types of responsibilities and decisions that a commissioner can make that can drastically affect your well-being.

If elected I will do all in my ability to ensure we continue to have these life saving tools and equipment.

Of course this equipment will not be of much good if we do not have the manpower to use them which is why I will also do all I possibly can to retain the members we currently have and actively encourage more of our residents to join the Fire Department.

I will also work to increase community and district relations, community outreach and good neighbor type programs. These are just some of the issues that I will work on if you elect me as one of Locust Valley Fire District commissioners.

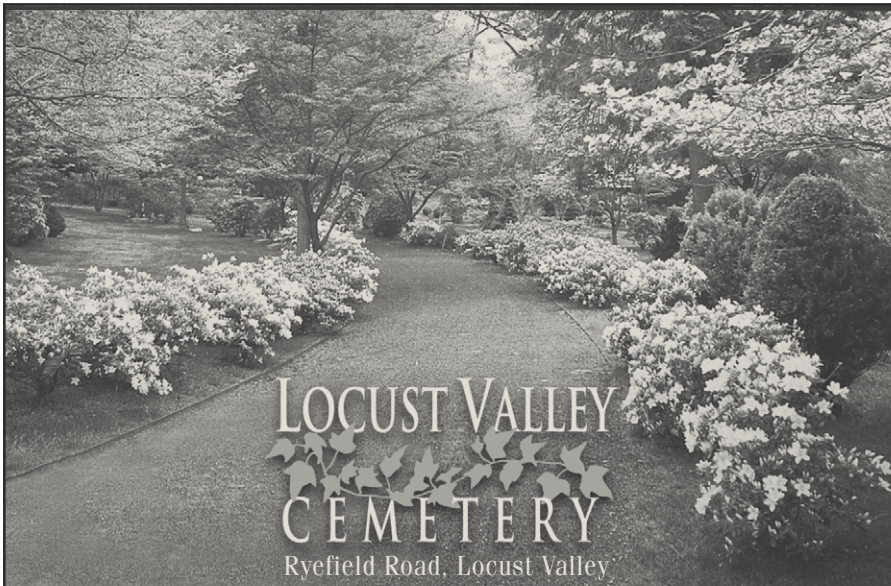

### Mercer Logan Stockell

STOCKELL, Mercer Logan, a prominent trademark attorney, died on November 23, 2012, at his home in Glen Cove, New York. He was 91. Mr. Stockell was a senior partner at the law firms of Rogers Hoge & Hills and later Pennie & Edmonds, both located in New York City. For over fifty years, he represented many of the most prominent brands of his time, including IBM, TEXACO, BLACK & DECKER, BACARDI, AMERICAN TOBACCO, LUCKY STRIKE, PALL

MALL, SWINGLINE, JIM BEAM, MASTER LOCK, SUNSHINE, ANDREW JERGENS, KALUHA, TIA MARIA, WILSON JONES, JACK DANIELS, MARTINI & ROSSI, AMF, TITLEIST, and many others, and was highly influential in the development of this area of law. Mr. Stockell was born in Nashville, Tennessee, the son of the late Matthew Delamere Cooper Stockell, whose colorful life included being a cowboy out West and service in World War I, and Dorthea Spotswood Logan, one of six daughters of the Rev. Dr. Mercer Patton Logan. Mr. Stockell graduated from the University of the South, fondly known as "Sewanee," with a degree in economics in 1943, and immediately enlisted into the US Marine Corps. He was a Captain in the US Marines in World War II. He was stationed on the Island of Kawaii in the South Pacific during World War II and fought in numerous battles, including the Battle of Peleliu, code-named Operation Stalemate II, and known as the "bitterest battle of the war for the Marines" due to its high number of casualties. Upon returning home from the war, Mr. Stockell attended Harvard Law School, earning his law degree in 1948. Mr. Stockell was married for 47 years to Eliane Grignard Stockell, who predeceased him in 1997. He is survived by his three children, Mercer Logan Stockell, Jr. (Stoney) of Glen Cove, Albert Grignard Stockell (husband of

Dorothy Russell Stockell) of Nairobi, Kenya, and Catherine Higgins Stockell Bannon (wife of Edmond R. Bannon) of North Salem, New York, and New York City. 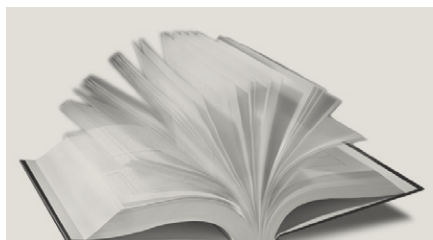

Dear In the Holiday Spirit, What fun and yes, I think I have a good book to fill any free moment you have: SWEET TOOTH by Ian McEwan. McEwan is a prolific writer (Atonement, Amsterdam, Solar, Saturday, On Chesil Beach....) whose novels are known for their clever twists. Told in the first person by Serena Frome, the novel takes place in 1970's England- an England of IRA bombings, Cold War spying, labor unrest, and a dreary economy. Frome ("rhymes with plume") has just finished an idyllic summer with an older man who is married, teaching at Cambridge, and a former spy. When he ends their romance abruptly, she finds herself courted by MI5- the British equivalent to our

FBI. Frome, the beautiful daughter of an Anglican bishop, and a speed reader of novels, is assigned to recruit writers whose image of the West is known to be positive; the operation is known as "Sweet Tooth". The novel is hilariously funny, occasionally bittersweet, and always intellectually stimulating. A great read and only 300 pages so it should be perfect for a busy weekend!

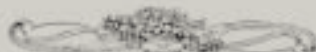

## Girls Varsity Soccer LI and Regional champions

*Team overcomes injuries, setbacks; advances to states for 2nd time in history*



**Class C Long Island Champions**

It was a season that started out as “not meant to be,” but ended with gritty and heartfelt wins at the Long Island championship and Regionals – and ultimately a historic return to the state championship.

“These girls never gave up and never stopped believing,” said Coach Gail Baker, last year’s Coach of the Year. “We had a lot of obstacles, including low numbers for both the JV and Varsity, but we were still able to make it to the state semifinals and compete against our co-champion from last year, Hoosick Falls.”

A number of early season injuries challenged this new blend of younger players and remaining seniors. Required to field 11, the Quakers battled through most of their season with only 14 players. Coach Baker credits the team’s tenaciousness to the leadership that the team’s older players exhibited. “It was much more challenging to keep the girls positive this year, but this core group of veterans never stopped believing,” said Coach Baker. “They not only showed the younger girls how you are supposed to work on the field, but also how to carry yourself.”

A pivotal turning point came in FA’s game against rival Cold Spring Harbor, who they played on their home field. “I remember the feeling – it was almost like a championship game,” said Baker. “There were so many people on the sidelines and after we beat them, we pushed ourselves into first in our division. It made us feel like we could challenge the other teams and that we had a real shot at this.”

Friends went on to beat Port Jefferson, 3-2 in the Long Island Championship and then S.S. Seward in the Regional game. “That Regional match was an outstanding game,” said Baker. “Even though the wind was against us during the first half, we held their best player scoreless. We knew where each other were.” Scoreless after the first half, FA rallied for a 2-0 final score, exhilarated by the reality that the 2011 reigning state champions were heading back to defend their title. Unfortunately, crucial injuries prevented the Quakers from advancing to the final round and capturing a second state championship.

For Coach Baker, this 2012 team

represents the end of an era. “I have so many memories of this team,” she said. “These girls have played with a lot of emotion and I have a very special bond with them. Our younger players really grew and a lot of them were put into positions that they thought they weren’t really ready for. But they listened to their coaches and improved. The older girls on this team have really set the standards ... the highest in my 21 years. They brought teammanship and heart to this program – and they were the role models for this team and will be missed.”

Enrolling 777 students from age 3 through Grade 12, Friends Academy is guided by its Quaker heritage and the principles of integrity, simplicity, patience, moderation and a peaceful resolution of conflict. The school is located on 65 acres at the intersection of Piping Rock and Duck Pond roads in Locust Valley/Glen Cove.
