Concerns Over Tree Cutting in Nassau Preserves

A month after superstorm Sandy, Nassau County Legislator Delia DeRiggi-Whitton said she was alarmed to hear that trimming crews were taking chain-saws to trees in two Nassau County preserves located in Glen Cove – Welwyn and Garvies Point.

The legislator was contacted by concerned residents who frequent both preserves, as well as environmental groups like the Audobon Society and the Friends of Garvies Point.

She went out to meet concerned people at both county preserves. Starting at Welwyn, the legislator had hikers walk her through the trails, showing many cut trees. She then went to Garvies, where members of the Friends of Garvies showed her the same kind of damage and told her that the crews did not seem to be properly monitored and had no knowledge of trees.

Legislator DeRiggi-Whitton called for a hold on the projects and demanded information from several involved managers within the Nassau County government. She was told that each tree crew

was led by an arborist who was selecting dead trees that were a potential danger to people. She was also told that each crew was following a careful plan within the preserve. However, testimony from many people on the ground at both Glen Cove locations suggested that there was not correct supervision and crews seemed to be carelessly damaging precious preserve area without a clear purpose. They said that many of the trees cut were alive and posed no danger.

Because of the attention drawn to the Welwyn cutting, the crews stopped and did not come back to cut any further or to remove the timber, as was rumored to be the plan. At Garvies, the legislator got to meet with a landscape architect in charge as well as an arborist. They went over the sophisticated process the county is supposed to follow, using iPads to identify and track trees that truly need to come down for safety reasons.

"I believe that this process was not

originally used in either of Nassau's preserves in Glen Cove," the legislator said. "It is terrible that while tree limbs are still hanging on wires right out on Glen Cove Road, crews were being set loose in protected natural areas and doing permanent damage."

At Garvies, she was promised on Monday, Dec. 3 that the crew would only take down about six clearly dangerous trees and would leave the timber inside the preserve to decay naturally, which is the right process for a preserve's ecosystem.

At the Nassau County Legislature's committee sessions on Monday, Dec. 3, Legislator DeRiggi-Whitton publicly raised her concern about this process. A Parks & Recreation head explained it away by saying that the wrong crew was sent into Welwyn for several days and was ultimately removed. The legislator was saddened to learn that the crews were removed after cutting down 143 trees.

Portledge School Community Comes Together To Help With Hurricane Sandy Relief Efforts

Portledge School (Locust Valley) has been helping the local community in the aftermath of Hurricane Sandy. From the beginning, they were assisting their families in need since the independent, pre-nursery through grade twelve, co-educational school draws students and faculty from all over Long Island. They established a Hurricane Help Relief Effort for those who could offer services, such as lodging, a hot shower, clothing, food, veterinary services, a place to do laundry, etc., to those who were in need of services. In the midst of a gas crisis, a carpool list was also established and people were matched as needed.

Once back in school, the students and staff began a Hurricane Drive collecting coats, blankets, boots, socks, non-perishable food items, baby food, formula and diapers, etc. which will be donated to the Salvation Army through the Locust Valley Rotary Club as well as Rock Can Roll and other local charities offering support in the Oyster Bay communities as well as the South Shore, Staten Island, and wherever else there is a need.

Portledge School opened its gymnasium to 26 power line workers from Canada, part of the Hydro One Networks, who came to help LIPA during the cri-

sis. These workers had been staying in trailers and didn't have the ability to take hot showers. This outreach fit with the school's philosophy and principle to "instill a spirit of responsible citizenship through service to the school and the broader community." Portledge's food-service company, CulinArt, brought the guests breakfast and hot coffee to get them started on their long day journeys around the island. The workers were conscious of being gone before the students and staff arrived on campus and arrived back well after everyone was gone. Hydro One Line Manager, Boyd Knox said "we are so grateful to the Portledge community who opened their doors and their hearts to us. It was a tough time for all, and their generosity was truly appreciated by me and my colleagues."

Head of School, Simon Owen-Williams, said "I am so proud of the Portledge community for coming together so quickly in such a difficult time. We pride ourselves on teaching good citizenship but seeing the students put it into action makes us all proud. Plus, the parents and faculty couldn't have been more generous. We are a close-knit community and it showed during this past month."

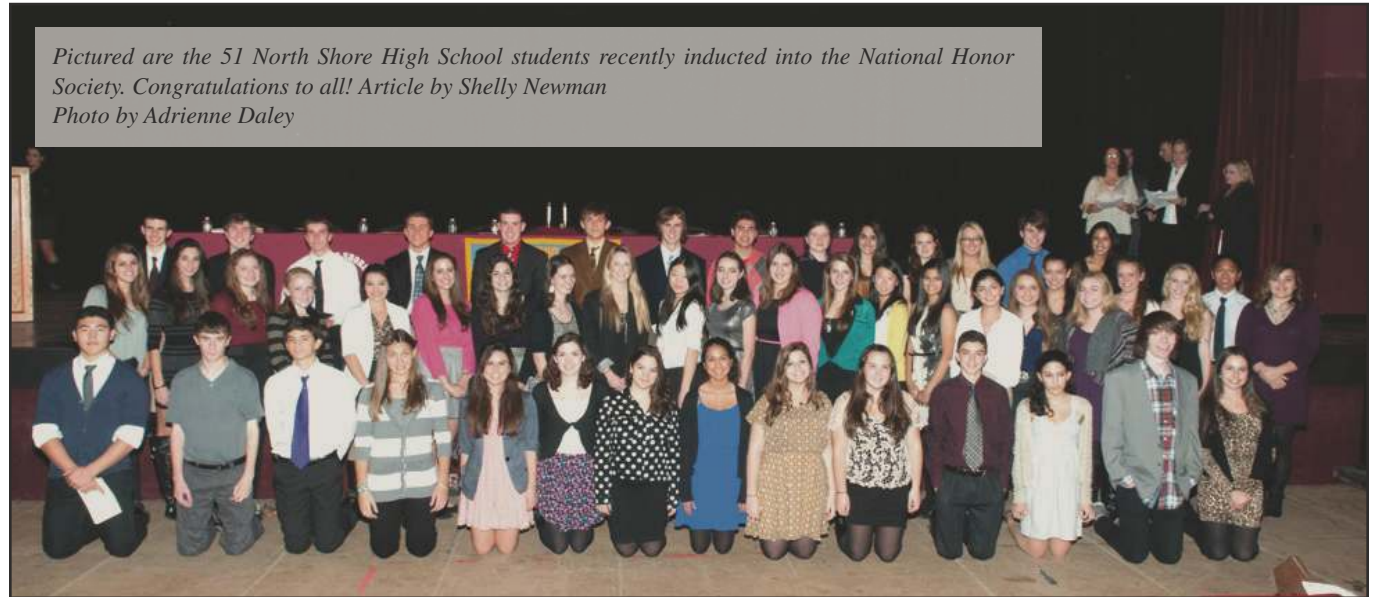

Military Dogs

For one member of the Navy SEAL team that executed one of the world's most infamous men, life after duty may not be so glamorous after all. Cairo, a Belgian Malinois dog, was an integral part in Operation Neptune Spear, the operation in which Osama Bin Laden was executed. Unfortunately for Cairo, as well as the other hundreds of dogs that heroically serve our country, many may not live to see a return trip home.

Despite the fact that military working dogs contribute to war as living beings, due to a loophole, they are classified under the broad category of 'equipment.' As a ramification of this, dogs that are already overseas and cannot serve due to either age or injury are deemed as excess equipment, and sadly, are not entitled to a return trip home. Although adoption is still a possibility, it requires private funding for the dog's journey home, which can cost upwards of thousands of dollars.

The U.S military have used military working dogs as early as the Revolutionary War. Today there are roughly 3000 enlisted dogs with 600 of those dogs serving in war zones overseas. In today's era of warfare, dogs have proved their worth in using their heightened sense of smell in locating and detecting hidden explosives and IED's (improvised explosive device). Dogs also search out for hurt victims in disasters, and perform tasks that most people would decline. Dogs aid to our war efforts in a plethora of ways with their intelligence and loyalty, yet their treatment by the military has been, and continues to be substandard. This was most notably demonstrated at the conclusion of the Vietnam War, when approximately 5,000 military working dogs served with 10,000 handlers. Only about 200 canine soldiers were redeployed, while the remaining approximately 4000 were either euthanized or left behind to an ally army due to their standing as excess equipment. However, after much public outcry in 2000, then President Clinton signed Robby's law, giving military dogs a possibility to be adopted if they could find a suitable owner willing to pay for the transportation. Although a small victory, this did not solve the greater problem of proper retirement for these military dogs.

Recently, North Carolina Rep-

resentative Walter Jones has been diligently working to offer a solution. Through a proposed bill, H.R 4103, Jones, the sponsor of the bill, has proposed to reclassify military dogs as 'Canine Members of the Armed Services.' In this new classification, transportation home would become guaranteed for all dogs serving overseas, while a non-profit organization would be created to provide lifetime veterinary care. Deserving dogs would also be recognized for their outstanding duty.

As a proud owner of a rescue animal, I know all too well how powerful the relationship with a dog can be. After our family rescued our dog Pepsie from a local shelter in the same year Robby's Law was enacted, we took in more than a pet, we adopted a new member into our family. After sharing 12 great years with Pepsie, I can really appreciate the strong bond between man and canine. As Pepsie was given a second chance on life, so to should these military dogs. Although Pepsie might not have the spunk in her step that she had 12 years ago, she continues to give our family an immeasurable amount of happiness.

It should be the moral responsibility that we all have towards these brave service animals and not the sheer economics in deciding the outcome of this bill. For these reasons, I implore every one of you to take action in spreading the word, either by speaking to your neighbors or writing to your congressman. I truly believe that as more people are made aware of the current standing of military dogs, more people will open up their hearts and homes to these canine veterans. If we are bold enough to integrate canines into the military, shouldn't we also be compassionate enough to reward these valiant heroes by affording them the same love and care that we do our own pets? In the midst of a decade long war, it is important for us as a society to not forget that our use of military dogs is a privilege, not a right. We owe these dogs that have given us so much the comforts for them to enjoy their lives up until their last natural breath.

Name the Celebrity



Last Week's Celebrity

Last week's celebrity was Ellen Corby. Aside from her film screen roles, she also had many TV roles in "Wagon Train", "Cheyenne", "The Rifleman", "I Love Lucy", "Bonanza", "The Virginian", "Alfred Hitchcock Presents" and "The Addams Family" to name a few. However, her best known role came in 1971 as "Grandma Esther Walton" on the made-for-TV movie "The Homecoming: A Christmas Story", which served as a pilot for "The Waltons". Her husband, "Zebulon Walton", in the movie version, was portrayed by famous ventriloquist, Edgar Bergen, Candace's Dad. He also starred as her husband 23 years earlier, in "I Remember Mama". Corby would go on to resume the role in the weekly TV series "The Waltons". She won 3 Emmys and earned 3 more nominations as Best Supporting Actress. She left the series in 1977 after a debilitating stroke, but returned to series. The ailment was written into the script. Her final role was in the Walton's reunion film in 1997. Her health continued to decline and she passed away on April 14, 1999 at the age of 87.

Born on Nov. 19, 1919 in North Shields, Northumberland, England, this week's maternal ancestors included a signer of the U.S. Declaration of Independence. The family moved to Edinburg, Scotland when he was a toddler and then to British Columbia when he was 6. After being rejected by the Canadian military during WWII for poor health, he became a broadcaster for the Canadian Broadcasting Corporation, In 1944, he had his own American radio program and was NBC's summer replacement for the Eddie Cantor Show. He made his film debut in "Margie" (1946) with Jeanne Crain. His best known role in films was as "Filby" in the 1960 H.G. Wells movie, "The Time Machine" with Rod Taylor and Yvette Mimieux. He reprised that role in the 1993 mini-sequel. In the 2002 remake, he had a cameo role as the flower store worker.



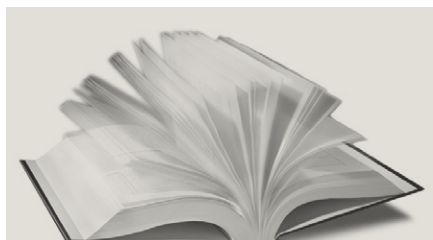

Are you familiar with it and, if so, would you recommend it?

Yes, these are two great events not to be missed and the book you have asked about should not be missed either. NEVER FALL DOWN by Patricia McCormick was a National Book Award finalist this year. It tells the story of Arn Chorn-Pond who is nine-years old when

we first meet him. His life is certainly not easy in the Cambodia of 1976 but it quickly turns horrific when the Khmer Rouge takes power and a bloody ethnic cleansing begins. Before it ends, one quarter of the population has been annihilated. Especially hard hit were the educated and literate including almost all of Arn's family. It is almost impossible to read about the traumatic suffering that haunts the boy's days and nights in Cambodia and then cruelly follows him to America where he starts a new life but one marred by guilt and remorse. The book, while spotlighting humanity's evil instincts, it is also a tale of goodness and redemption as we witness myriad acts of generosity requiring the utmost bravery by so many.

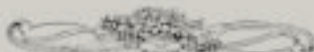
