

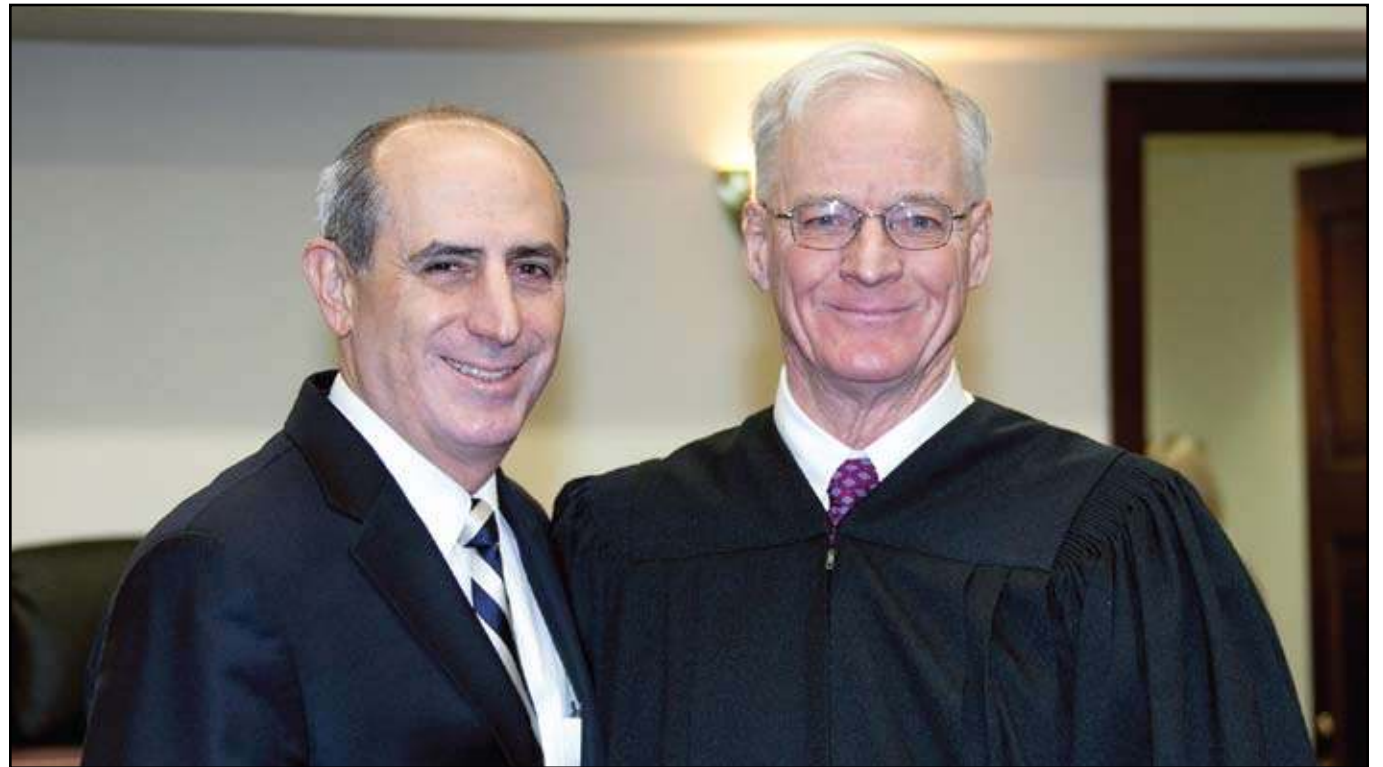


McCann Re-Appointed City Court Judge

The Honorable Joseph D. McCann has been re-appointed as City Court Judge for Glen Cove for another six-year term beginning on January 1, 2013. Judge McCann and his wife Julie have been residents of Glen Cove for seventeen years, and have an fourteen-year old daughter Margeaux.

Judge McCann is a graduate of Marist College (B.A.), SUNY at Stony Brook (M.A.) and St. John's University School of Law (J.D.) He also spent one year studying at Oxford University in England. Following graduation from law school, he served as a Law Assistant and then Deputy Chief Law Assistant to the Judges of the New York Court of Appeals, which is the highest court in the State.

Judge McCann was then appointed an Assistant United States Attorney in the Eastern District of New York, where he prosecuted or defended cases on behalf of the United States of America and its agencies for 7 1/2 years. While in the U.S. Attorney's Office, he was also ap-

pointed Chief Civil RICO Attorney with responsibility for all civil RICO actions brought by the United States in the Eastern District of New York During his service with the U.S. Attorney's Office, Judge McCann received commendations and awards from several federal agencies, and was presented with the Director's Award for Superior Performance as an Assistant United States Attorney by then Attorney General Janet Reno.

Upon leaving the U.S. Attorney's Office, Judge McCann served as General Counsel for the Jacob K. Javits Convention Center, before forming the law firm of Murray & McCann, which is located in Rockville Centre and is engaged principally in civil litigation and white-collar criminal defense. Judge McCann has served as an Adjunct Professor at St. John's University School of Law, and

is the author of several articles and bar association reports on a variety of legal issues. He looks forward to another six-year term on the bench in Glen Cove.

Sea Cliff Village Museum Opening: Architectural Details...Ceilings, Floors, Windows and Doors



On Sunday January 13, 2013 in Village Hall Room C at 2 pm the Sea Cliff Village Museum will open with a new exhibit and a new permanent display.

"Architectural Details...Ceilings, Floors, Windows and Doors" will feature mantels, iron gates, stained glass windows, tin ceiling pieces, marble sinks

and other bits and pieces from Sea Cliff homes.

The Village of Sea Cliff is a living museum and a walk down any street will bring you on a historical trip to the past. The Village is laden with corbels, brackets, spindles, slate roofs, gingerbread, porches, leaded and stained glass pan-

els and windows as well as a large stock of mid-century homes.

The exhibit shows through vintage photos, postcards and recent shots, the wealth of architectural details and beautifully preserved homes of the past two centuries.

"Gone but Not Forgotten" is a display depicting residences, businesses and churches that have been lost to fire or demolition. For all the striking buildings that remain intact in Sea Cliff, many incredible buildings with outstanding architectural details have

been lost. The museum has a notable photographic documentation of many of these buildings. The rare photos are part of the Museum's permanent collection. Included are photos of the Battershall Inn, Sea Cliff Hotel, the "Chinese House", the old Homestead on Little-

worth Lane, the Wellenbrock house on 8th Avenue, Haines on Bay Avenue, the Spangel House, Berner House, Parlaminan House, Nelson House, Muller House and the Kimmerle house.

Many color photos taken recently by Sara Reres and Museum Trustee Kathleen DiResta fill the gallery rooms with an amazing variety of details, colors and designs.

Ask This Old Museum...James Boughton of Sea Cliff Artisans will speak and answer questions on old house renovation and restoration at the Museum opening on January 13.

In addition, Dr. Glenn R. Williams has brought his collection of the remains of the Rye Cliff Ferry to the Sea Cliff Village Museum. The doomed ferry burned to the water line and sunk at a Sea Cliff pier in 1918. Dr. Williams' fascinating exhibit was displayed at the Museum in 2010. He has now given some of the artifacts and photographs for a long-term exhibit. Some of the items on display are the machinist's hammer, the ships vacuum gauge, charred timber, bronze spikes and bottles from the early 20th century. Some of the pieces show forensic evidence of the inferno that destroyed the ferry.

All are invited to the Museum's opening reception on Sunday January 13, 2013 at 2pm in Room C of Village Hall. The Sea Cliff Village Museum is located at 95 10th Avenue. Call 671-0090 for further information.

The Vikings Girls Varsity Basketball Team finished up their non-league schedule with the Second-Annual North Shore Holiday Booster Club Tournament. The girls opened up with two-time Class "B" County Champions Cold Spring Harbor. The team came out smoking and behind Erin Sheerin's 7 first quarter points, they raced to a 22-7 lead at the end of the first frame.

In the second quarter they received a boost from recently returned 8th-grader Ashleigh Sheerin and her hot shooting, as they took a 44-28 halftime lead. It was more of the same in the second half, as the Vikings cruised to an 83-54 victory, led by junior Caroline Robertson's 22 points, 7 rebounds, 5 assists, 4 steals.

This set up a showdown with AA power Uniondale where the Vikings really struggled on the offensive end early, as they had too many shots to count go in-and-out in the first half. With the offense down, they ratcheted up the defense, forcing 56 turnovers with their swarming, full-court pressure to keep

them in the game. Still, the Vikings found themselves down 24-21 at the end of the half.

In the third quarter, both teams began to hit their stride, as the game really picked up. The Vikings received sparks from senior Tara Feehan and freshman Gigi Telvi, but were still down by 6 heading into the final frame. In the fourth quarter, the girls went on a huge run, sparked by 5 points in thirty seconds by 7th grader Gabrielle Zaffiro (12 points, 4 rebounds, 3 steals) and sophomore Alexandra Cantwell's 8 points in the quarter, as they held on for a 59-57 victory in the championship game.

For the tournament, Erin Sheerin was named to the All-Tournament and for the second year in a row, Alex Cantwell was named MVP. This concludes the non-league portion of the girls schedule and as they head into league play, they are 6-1 and ranked #9 by Newsday for all teams on Long Island. Come out and support the Vikings!

Funds raised by DBE help support the work of the Victoria Home, a rehabilitation and nursing facility in Ossining, NY.

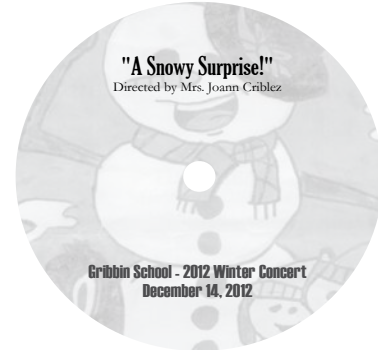

George Dunn, MD, Retires as Head of Medical Affairs at Glen Cove Hospital

After 35 years of service to the community, George F. Dunn, MD, has retired as senior vice president of medical affairs and the chair of the Department of Family Medicine at Glen Cove Hospital.

Dr. Dunn joined Glen Cove Hospital in 1977 and trained in the hospital's Family Medicine Residency Program after receiving his MD degree from the University of Bologna Faculty of Medicine and Surgery. He was appointed to the hospital's medical staff in 1980 in the Department of Family Medicine, an emerging specialty in the country at the time. From 1980 to 1993, Dr. Dunn maintained a private practice in Glen Cove and Oyster Bay, and also practiced obstetrics for 25 years. He was hired by the hospital as full-time faculty in 1993. He's lived in Glen Cove since 1977.

Born in Brooklyn, Dr. Dunn said that he wanted to be a family doctor for as long as could remember, saying "it was the only kind of doctor our family knew." During his tenure at Glen Cove Hospital, Dr. Dunn was a mentor and role model to hundreds of young physicians in the Family Medicine Residency Program and an advocate to physicians practicing at the hospital. Dr. Dunn rose up through the ranks at Glen Cove, being named chairman of the Department of Family Medicine in 1988 and then promoted to senior vice president for medical affairs in 2000. He served as the hospital's director of the Family Medicine Residency Program from 1993 to 2000, and was co-chair of the hospital's community Advisory Council for 12 years. The Family Medicine Residency Program serves as a training program for medical students from the Hofstra North Shore-LIJ School of Medicine and other medical schools.

During his career, Dr. Dunn directed numerous medical committees and served as a top administrator at a time when managed health care and increased government regulations introduced many challenges to the health care delivery system. Dr. Dunn credited the success of Glen Cove Hospital to the dedicated physicians and nurses with whom he worked. He said many talented and like-minded physicians who trained at Glen Cove joined the staff over the years, sharing the philosophy that the "patient always comes first" and that the "best physicians are the best listeners."

"The fun part of being a family physician is taking care of generations of patients in the same family," said Dr. Dunn. "It's not unusual for a doctor in my field to see four generations in the same practice – a close bond where you can talk to a patient about a grandparent."

Susan Kwiatek, RN, executive director of Glen Cove Hospital, who began working with Dr. Dunn when she was a nursing assistant at the hospital in 1980, said, "The entire staff will miss Dr.

Dunn -- his clinical expertise, wisdom and sense of humor. There is enormous respect and gratitude for his service and we wish him the best for his continued success."

During his tenure, Glen Cove Hospital was the first community hospital to align itself with North Shore University Hospital in Manhasset in 1990, becoming the North Shore Health System before the 1997 merger with LIJ Medical Center that cre-

ated the North Shore-LIJ Health System. Glen Cove grew its programs to meet the community's needs by developing a strong orthopedics and rehab program and building new critical care units and an emergency department, all while "maintaining a small town feel that visitors notice right away," Dr. Dunn said.

"Health care is always in transition, whether it's new medication, treatment, technology or reimbursements," he said. "The hospital constantly needs to evolve to provide the highest quality care to the greatest number of people and Glen Cove is right on target."

Digital Photography Students at North Shore Colorize Images Utilizing Photoshop Skills

Students in Laura Green's Digital Photography classes at North Shore High School recently studied techniques to successfully colorize photographs. Ms. Green said, "The goal of this lesson was to teach my students how to take a black and white image and employ the use of a vivid color to illustrate a person's point of view. My students first turned a color photograph to black and white and then selected a focal point (the most important element of the image) to colorize."

Some essential questions that Ms. Green's 10th graders had to answer included: "What element in the photograph grabs your attention?", "How can we make a photograph stand out?", and "Does the chosen color have meaning?"

Additionally, the young photographers had to learn about varying vantage points which give an image a unique look! These included:

- Birds Eye: The perspective above the subject looking down (as if you were looking out of an airplane window)
- Worms Eye: The vantage point below the subject looking up (for example, a bug's perspective)
- Eye Level: When you are looking straight at the subject
- Angles: These include left, right, and 45 degrees

For this colorizing project, students not only had to select photographs but needed to complete a writing proposal that explained the following: Why this particular image had meaning to them?, What the vantage points were?, and Which area of the photo was chosen to colorize? The students also had to give reasons for their color selections. For example, they explained that red represented energy, green symbolized the environment, and blue meant sorrow. Additionally, their projects had to contain a theme, title, and shooting location. Some themes chosen by the 10th graders were Pollution and Our Impact on the Environment, Pakistani Culture, and Take a Step into a Dance Studio.

Ms. Green concluded by saying, "My students had to make sure that their colorized images got everyone's attention. Their goal was to make sure that the audience noticed their individual subjects and the specific area of focus in their photograph." To complete their projects, the students had to be creative as well as utilize skills in photography, proposal writing, and Photoshop.

Don't Make my 8th Grader take High School Courses!

To the Editor,

When my 13-year old started 8th grade at North Shore Middle School I didn't know he was also starting high school. But, he was. At North Shore, 8th graders are required to take high school courses in math and science. It wasn't always this way. As recently as 2007, North Shore only offered these courses to advanced students. Why the change? School officials state that this curriculum enriches the school experience for all students. It appears more likely that it was designed to increase the number of students who get advanced Regents diplomas.

Marc Ferris, Middle School Principal, has stated that the 8th grade students are not being asked to do more. That's ridiculous. When you force students to take high school courses a year before they're supposed to, you are obviously asking them to do more. Dr. Edward Melnick, District Superintendent, said that student needs will drive the program. My child needs to be taught 8th grade math and science. His needs aren't being met. If he doesn't pass, he will be required to retake these courses in summer school and possibly again in ninth grade - when they should have been taken in the first place. Ironically, 8th graders do not get high school credit for taking high school

math and science. They do, however, get credit for the Regents exams. If students enter high school having passed two Regents, they are more likely to pass the five additional exams required to get an Advanced Regents diploma.

According to NY State's 2010-11 School Report Card, North Shore is one of only four districts in Nassau County that force their students to take high school math and science in 8th grade. An additional three districts require 8th graders to take high school math, but not science. The remaining 84% of the districts only offer these courses to advanced students or wait until ninth grade. That means that over two-thirds of 8th graders are not subject to the rigor of high school courses - my son should be one of them. But, he doesn't have a choice. North Shore does not teach 8th grade math or science. Nor do they offer remedial help in these subjects. All they offer are Regents review classes to get as many students to pass these exams as possible. Yet, at the end of the year, New York State is going to test him on the very material he isn't being taught.

Ironically, the North Shore Board of Education has repeatedly expressed their concern that the district needs to focus on deep and meaningful learning and not so much on test scores. If only the school administrators would listen.


Christmas in January at Finley Middle School

The City Of Glen Cove 2011 Annual Drinking Water Quality Report

Dear Neighbor,

The City of Glen Cove takes great satisfaction in delivering safe drinking water to the over 27,000 users who live within the City and to the additional 15,000 plus daily water consumers who work in and visit our beautiful City. This Annual Drinking Water Quality Report is furnished to the consumers of City of Glen Cove Water in compliance with Federal and State Regulations. This report is designed to inform you about the quality of water and services the City has delivered in the past calendar year and to give you other information regarding your water supply and conservation. It is important for customers to realize that extensive monitoring is required of all public water suppliers. Long Island water must comply with strictly enforced standards established by the U.S. Environmental Protection Agency, the N.Y.S. Health Department and the Nassau County Health Department.

In 2011, your tap water met all State drinking water health standards. We are proud to report that our system did not violate a maximum contaminant level or any other water quality standard.

Water System Information: The City pumped 1,387,735,000 gallons of water from the groundwater supply in 2011. Approximately 1,248,961,500 gallons were delivered to consumers in the City through metered sales. 138,773,500 gallons or ten percent (10%) of total withdrawal was un-metered from uses such as municipal and public school facilities, fire fighting, hydrant flushing, main breaks, undetected service line leaks and water tank overflow.

Cost of Water: Our residential rate structure for each 3 month period is as follows: \$2.36 per 1000 for the first 45,000 gallons, \$2.66 per 1000 gallons for the next 45,000 gallons, and \$2.95 per 1000 gallons for usage over 90,000 gallons.

Sources of Supply: The Water Department supplies water from five wells located on four separate well fields throughout the community. The wells are drilled into the Magothy aquifer beneath Long Island. Glen Cove has a total well capacity of 9.87 million gallons per day. Glen Cove water is excellent quality, meeting all State and Federal drinking water standards. All well stations are monitored daily for proper operation by Certified Operators who meet all the requirements of New York State and Nassau County Departments of Health. Please note that unregulated private wells should not be used for consumptive purposes.

In general, the sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activities. Contaminants that may be present in source water include: microbial contaminants; inorganic contaminants; pesticides and herbicides; organic chemical contaminants; and radioactive contaminants. In order to ensure that tap water is safe to drink, the State and the EPA prescribe regulations which limit the amount of certain contaminants in water provided by public water systems. The State Health Department's and the FDA's regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Water Treatment: The Water Department treats the water supply before it enters the distribution system. A small amount of chlorine is added to assure the water maintains its bacteria-free quality. Our water is also treated with sodium hydroxide (caustic soda) to increase its pH to reduce its corrosivity before it enters the distribution system. This treatment reduces the leaching of copper and lead from household plumbing. Source water from the Well N-9334 is treated by "air stripping" to remove various volatile organic chemicals (VOC's). Source water from Wells N-9210, N-9211 and N-5261 are treated by Granular Activated Carbon (GAC) filters to remove various organic chemicals. All treatment is approved by, and in strict accordance with, Nassau County Department of Health standards.

Source Water Assessment: The New York State Department of Health, with assistance from the local health department and the CDM consulting firm, completed a source water assessment in 2007 for this system, based on available information. Possible and actual threats to this drinking water source were evaluated. The source water assessment includes a susceptibility rating based on the risk posed by each potential source of contamination and how rapidly contaminants can move through the subsurface to the wells. The susceptibility of a water supply well to contamination is dependent upon both the presence of potential sources of contamination within the

well's contributing area and the likelihood that the contaminant can travel through the environment to reach the well. The susceptibility rating is an estimate of the potential for contamination of the source water, it does not mean that the water delivered to consumers is, or will become, contaminated. See section "Table of Detected Contaminants" for a list of the contaminants that have been detected (if any). The source water assessments provide resource managers with additional information for protecting source waters into the future. The source water assessment has rated most of the wells as having a very high susceptibility to industrial solvents, all of the wells as having a high susceptibility to nitrates and one well as having a medium high susceptibility to microbial contamination. The very high susceptibility to industrial solvents is due primarily to point sources of contamination related to transportation routes and commercial/industrial facilities and related activities in the assessment area. The high susceptibility to nitrate contamination is attributable to un-sewered residential land use and related practices in the assessment area, such as fertilizing lawns. A copy of the Source Water Assessment including a map of the assessment and a supplement to this annual water quality report can be viewed at the Water Department, City Hall.

Analytical Results: The City routinely monitors water quality taking 40 samples per month from 10 various locations citywide. Over 135 separate parameters are tested in each of our wells numerous times per year. As required by the USEPA, the New York State Sanitary Code and the Nassau County Department of Health, we routinely test your drinking water for numerous contaminants. These contaminants include: total coliform, turbidity, inorganic compounds, nitrate, nitrite, lead and copper, volatile organic compounds, total trihalomethanes and synthetic organic compounds. Analytical testing results and information regarding the contaminants detected in this testing can be found within the table of this annual report identified as 2011 Table of Detected Parameters.

Many of these parameters are naturally found in all Long Island drinking water. All drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. Some people may be more vulnerable to disease-causing microorganisms or pathogens in drinking water than the general population. Although our drinking water met or exceeded state and federal regulations, some people may be more vulnerable to disease-causing microorganisms or pathogens in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice from their health care provider about their drinking water. Please note that there have been no known outbreaks of Cryptosporidiosis and giardiasis linked to the water supply in Nassau County. EPA/CDC guidelines on appropriate means to lessen the risk of infection by Cryptosporidium, Giardia and other microbial pathogens are available from the Safe Drinking Water Hotline (800-426-4791).

In 2011, the City performed and submitted 2009-2011 lead/copper data to the Nassau County Health Department as part of its triennial reduced lead/copper monitoring program and was approved to continue on a triennial monitoring basis by the Department. The monitoring for the period 2012-2014 will be performed in the Spring of 2014. The City tests its water supply weekly at various monitoring locations within the City limits. An independent laboratory to insure water purity and quality also performs additional monitoring, sampling, and testing.

During 2011, our system was in compliance with applicable State drinking water operating, monitoring and reporting requirements. The City of Glen Cove did have a Tier 2 bacterial contamination violation in September of 2011 and a public notification was distributed to the public in October of 2011 which is within the 30 day notification requirement. As you can see by the table, our system had no other violations, but as demonstrated through our testing, some contaminants have been detected; however, these contaminants were detected within New York State drinking water standards requirements. Although nitrate was detected below the MCL, it was detected at 6.5 mg/l, which is greater than one half of the MCL. Therefore, we are required to present the following information: "Nitrate in drinking water at levels above 10 mg/l is a health risk for infants, less than six months of age. High nitrate levels in drinking water can cause blue baby syndrome. Nitrate levels may rise quickly for short periods because of rainfall or agricultural activity. If you are caring for an infant, you should ask advice from your health care provider." The Water Department also wishes to note that this Water Quality report is being issued beyond the May 31st reporting requirement deadline, however, system water quality has in fact improved over the prior years due to system wide improvements in treatment, operator training and system management.

Please share this information with all the other people who drink this water, especially those who may have not received this notice directly (for example, people in apartments, nursing homes, schools, and businesses). You can do this by posting this notice in a public place or distributing copies by hand or mail.

Capital Improvements: The City of Glen Cove is committed to providing Glen Cove residents with the best tasting water and to improve the overall efficiency of the system. With this in mind, we have replaced the carbon filter media at all well sites which utilize Granular Activated Carbon as a treatment method. The city continues to modernize the water distribution infrastructure including fire hydrant and valve replacements city-wide, instrumentation and control improvements at our well sites. Our water meter replacement program continues with the addition of Radio Remote Reading system in businesses and hard to access areas. The new meters are equipped with a remote head that will allow meters to be read without entering the customer's premises. The new system allows for more efficient computerized meter reading and automated billing. Capital improvements for 2012 included upgrades to water mains to increase water flow from the wells, a review of all water maintenance equipment. Capital improvements for 2013 include, but are not limited to, replacement of the well pumps at wells N-9210 and N9211, increased perimeter security, upgrading the primary power supply to selected well sites, improving and increasing stand-by/emergency power, updating of electrical control and monitoring systems, and upgrades to the City distribution mapping system. The City had its water engineers review four separately produced reports that all concluded the need for two additional wells for the City water supply system – one immediately, and a second for the near future. This need will be met by the proposed expansion of an existing well field through the purchase of adjoining private land allowing the City to add one additional well immediately for both redundancy and capacity with the possible addition of a second well at this site when needed. The City is also in the process of upgrading the VOC removal system from Well N-5261 from a GAC system, to an Air Stripper system, which will provide for enhanced VOC removal. An engineering study has already been prepared and approved by the Nassau County Health Department. Engineering design and preparatory work is anticipated to begin in 2013.

Team Work: The Water Department performs a city-wide hydrant flushing and maintenance program. All dead-end mains are flushed by opening hydrants in the spring and fall to remove rust and sediments that have may accumulated over time. The City also performs regular hydrant inspections and maintenance to ensure that all City owned hydrants function properly and are in a good state of repair to provide optimum fire-fighting service.

Vigilance of our drinking water: The City of Glen Cove is committed to protect our drinking water supplies, prevent contaminants from entering our aquifers, and ensure high quality by treating the water. As a result of our nation's current alert status we are diligent to ensure the continued safety and quality of our water supplies. We use the best available water treatment technology and provide continued training of our employees for emergency awareness and response.

The New York State Department of Conservation (NYSDEC) has instituted a program to manage storm water runoff to improve water quality within our water bodies. The City of Glen Cove has been extremely conscientious about protecting and maintaining our waterways by maintaining and improving our existing storm drainage network system and by enhancing wetland areas to improve water quality from storm water runoff.

The City of Glen Cove on an annual basis submits to the NYSDEC an annual report which outlines our Storm Water Management Program (SWMP). The annual report is available for public viewing and comment on the City of Glen Cove website, or at the Glen Cove Public Library. If you should have any comments they should be made in writing to the City of Glen Cove Department of Public Works, Attn: Storm-water, City Hall, 9 Glen Street.

If you would like to know how you can help improve our waterways, please visit our website at www.glencove-li.com or visit the Glen Cove Library to view storm water materials and the annual report.

Water Conservation: The City actively enforces the water conservation ordinance year round and has developed a water conservation plan as mandated by the N.Y.S. Department of Environmental Conservation. Lawn sprinkling, car washing and other outdoor water use is permitted at properties (houses and buildings) with odd numbered address on odd numbered days and with even numbered addresses or no address number on even numbered days between the hours of 5 am to 9 am and 4 pm to 12 midnight. For example, 1 School Street may sprinkle on May 1, 3, 5, etc. and 40 School Street may sprinkle on May 2, 4, 6 etc. Automatic sprinkler systems must be equipped with a rain sensor. Customers can take many measures to conserve water and lower their water bills and should be conscientious in their daily use of water. Customers can also save water by only using their existing dishwashers and washing machines with full loads. The Water Department provides its customers with free water conservation kits consisting of toilet tank displacement bags, toilet tank leak detector tablets, shower head restrictors and water conservation instructions. Customers should check all toilets, all faucets inside and outside, including hose bibs and showerheads for leaks which are often easily and inexpensively repaired. Since leaks waste water and inflate your bill, it is wise to fix them quickly.

Maximum Contaminant Level Goal (MCLG): the goal is the level of a contaminant in drinking water below which there is no known or expected risk to health.

Maximum Contaminant Level (MCL): The "Maximum Allowed" is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to MCLG's as feasible using the best available treatment technology.

Action Level: The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Non Detects (ND): Laboratory analysis indicates that the constituent is not present

Nephelometric Turbidity Unit (NTU): A measure of the clarity of water. Turbidity in excess of 5 NTU's is just noticeable to the average person.

Parts per million (ppm) or milligrams per liter (mg/L): One part per million corresponds to one minute in two years or a single penny in \$10,000.

Parts per billion (ppb) or micrograms per liter (ug/L): One part per billion corresponds to one minute in 2,000 years or a single penny in \$10,000,000.

Parts per trillion (ppt) or nanograms per liter (ng/l): One part per trillion corresponds to one minute in 2,000,000 years or a single penny in \$10,000,000,000.

Missing person/ Murder Arrest

On December 17th Nunzio Izzo went missing from a friend's house at 5 Madeline Place in Glen Cove. The missing person was suffering from epilepsy and heart problems and took medication daily for those medical issues. The missing person normally followed the same routine every day, using local cab companies to get around town. When he did not come home that night the family became very concerned. The family contacted the Glen Cove Police on December 20th . The Glen Cove Detective division began to investigate the case along with the Nassau County Missing Persons squad. Detective VanAllen, Albin and Detective Lieutenant Nagle began the time consuming process of interviewing everyone who last saw Nunzio. Every investigative lead and tip was investigated, a Silver alert was broadcast, and the local cable news displayed his picture. As a result of the investigation it was discovered that Edward Brown, an acquaintance of Izzo, had sold some jewelry that belonged to the missing person. On January 2nd the Glen Cove Police assisted by the Nassau Homicide Squad and Nassau Missing Persons squad arrested a 46 year old Glen Cove man identified as Edward Brown and charged him with Murder in the 2nd degree. The defendant lived at Madeline Place in Glen Cove. The defendant Brown gave investigators information which led to the discovery of a body on Dosoris Way. The body was secreted inside a container and covered with a tarp. At this time Police believe the body to be that of the missing person, but positive Identification cannot be made until the completion of the autopsy. The Defendant Edward Brown was arraigned at First District Court in Hempstead and was held without bail.



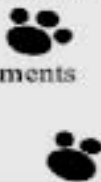
