# North Shore Historical Museum Opens

At a ribbon cutting ceremony on January 19, the North Shore Historical Museum opened its doors to the public. The opening ceremony, held on the 104th anniversary of the original opening of the building by the town of Oyster Bay in 1908, mirrored the Building's original façade and interior. Museum members, guests and visitors were able to take tours of the building and to hear of planned exhibits.

Glen Cove Mayor Ralph Souzzi and Museum President Brian Mercadante cut the opening ribbon and Museum Director Colleen Yoder hosted Museum tours and explained the Museum's future plans.

Initially, the Museum will be open Wednesdays from 2 pm to 6pm and Saturdays from 11am to 3pm. Guided group tours will also be available. Chartered by the New York State Department of Education, the Museum plans to showcase a wide variety of artifacts and archives depicting Long Island's "Gold Coast".

According to Ms Yoder the exhibits will include documents, art work, photographs and a unique collection of oral histories recording the memories and histories of many North Shore residents.

The completely restored building is a National Historic Landmark Building. Fees: Museum members free; non-members \$5.00 adults, \$4.00 seniors and teens, children free. ## North Shore School District Transportation Requests Due by April 3, 2013

The North Shore School District would like to remind all parents and guardians of children attending private and parochial schools that transportation requests for the 2013-14 school year must be submitted in person at the Transportation Office by April 3, 2013 or sent by Certified Mail postmarked on or before April 3, 2013. Failure to submit the transportation request form by the due date will result in your child being ineligible for district transportation for the 2013-14 school year. In this case, the cost and arrangement for transportation will be parental responsibility. The State Education Department and the Board of Education require that a separate application be filed each year even if your child is already receiving transportation.

In accordance with New York State Education Law, transportation requests received after the above date will not be accepted, even if a student is accepted to a school after the deadline. The only exceptions are those students who move into the District after the date noted.

## Portledge Science Teacher Selected to Score Advanced Placement Tests

Sonna Allen, Science Teacher and Department Head at Portledge School (Locust Valley, NY), was selected for the third year in a row to participate in the annual reading and scoring of the College Board's Advanced Placement Chemistry examinations this June in Louisville, KY. This year, approximately 12,000 college faculty and AP teachers will

evaluate and score about 18 million free-response answers. Representing many of the finest academic institutions in the world, AP Readers are made up of professional educators from the United States, Canada and abroad. The AP Reading is a unique forum in which an academic dialogue between high school and college educators is fostered and strongly encouraged. Candidates submit an application yearly which states they must have taught the specific AP class for at least three years.

Ms. Allen said, "I feel so honored to have been selected again, and I am looking forward to the networking and learning opportunities that come along with this responsibility."

# Letters to the Editor

## To the North Shore Community:

The Board of Education does not wish to lend credibility to any anonymous paid advertisements by responding to such ads; however, "An Open Letter to the North Shore Community" dated January 25th is wrong on the facts. We are concerned that those unable to attend the Board of Education's Town Hall Meeting on January 31st will be left with incorrect information and confused – this will make it harder for our community to face this challenge together.

To begin, the issue raised in the ad was directly answered by the Board more than a year ago, and posted on the Board website. Here again are the facts. On June 16, 2011, at a meeting held in the offices of the Town of North Hempstead, LIPA and National Grid informed the District and the Town that they decided to decommission Glenwood Landing Power Plant by 2013. That was the first meeting held between LIPA, National Grid, the Board, District Administration and the Town of North Hempstead on this subject. That same day, LIPA issued a news release announcing that it would seek approval from its Board of Trustees to remove the Glenwood Landing Power Plant from the current Power Supply Agreement between LIPA and National Grid. One week later, on June 23, 2011, the LIPA Board of Trustees approved the ramp down of the Glenwood Landing Power Plant.

Contrary to statements in the anonymous ad, no prior meetings between the then Board President, Igor Webb, the Superintendent and LIPA were held with respect to LIPA's decision to ramp down the Glenwood Landing Plant. Moreover, the June 16th meeting was not a meeting called by LIPA to discuss the decommissioning of the Glenwood Landing Plant; it was a meeting held to inform the Board, and the Town, of a decision that had already been made.

But the central point—one the Board has made repeatedly – is that even if the Board had been informed of or was made aware of a proposed closure at a much earlier date, there is no action the Board could have taken to minimize the impact of the plant closing to the School District . . . because there is no such available legal mechanism under State law that would have allowed the District to financially prepare for the decision made by LIPA at its June 2011 meeting.

The School Board does not control energy policy, environmental policy, building and zoning regulations, or tax policy. However, because LIPA is a New York State Public Authority, the best way to avert the worst consequenc-

es of the closing of the plant is to work to obtain help from Albany – the Board has worked with and continues to work with its legislative representatives in an effort to address the ramp down's impact on the School District. Since learning of LIPA's decision, the Board of Education, with the support of other local municipalities, has steadfastly pursued a legislative solution.

To get legislative relief and find a solution to our problem is a tough assignment and LIPA's specifics are ever-changing and their future is questionable. We can only hope to succeed if we are united as community, and work together.

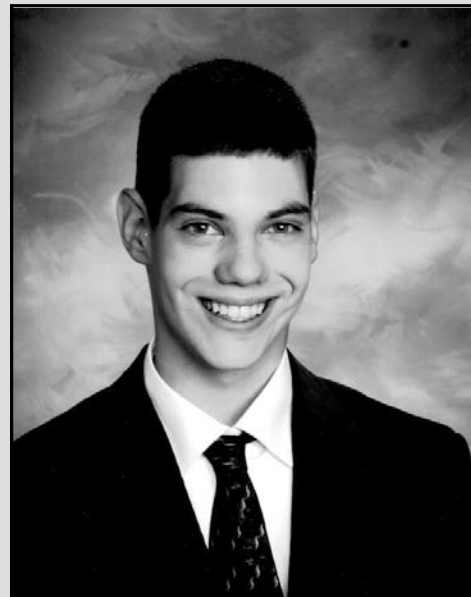

## Portledge School Hosts the Nassau County High School Chess League Finals

On January 17, 2013, the Nassau County High School Chess League Finals were held at Portledge School. Four teams competed (Chaminade, Friends Academy, Great Neck North and Portledge School). Round 1 consisted of Portledge School vs. Chaminade and Friends Academy vs. Great Neck North. At the end of the 90-minute time limit, Portledge and Chaminade were tied at 22.5 points each which meant they played a five-minute playoff. Chaminade came out victorious and played Great Neck North in the championship. Congratulations to the Chaminade team won first place, Great Neck North placed second, Friends Academy was third and Portledge School came in fourth. Simon Owen-Williams, Head of School at Portledge, had the honors of presenting the awards at the end of the day.

Each team had six players competing to achieve a minimum of 23 (out of 45) possible points to ensure the team victory. Players had 45 minutes to complete all of their moves. Two nationally ranked players competed. Alexander Fabbri, age 17, from Chaminade is ranked 27th in U.S. for his age and Anthony Cortese, age 15, from Friends Academy is ranked 38th in U.S. for his age.

The Nassau County High School Chess League is comprised of 16 teams which play in Fall/Winter league from October through December. Teams interested in joining this high school

Chess is very prominent at Portledge so it seemed natural for them to host the finals. The chess team started in 1995 making this their 18th year of competition. Despite its small size, Portledge School is able to compete with much larger schools because chess courses are offered aselectives at the high school level and the game is very popular with the student body. Roger LaFlair is the coach, and he himself is a Senior Chess Master. Coach LaFlair is planning on taking the chess team to the national high school championship in April which will be held in Minneapolis. Besides its competitive high school chess team which practices two times a week, the school offers chess as an elective course in upper school. In the Lower School, interested students attend a one hour a week class, plus an After School Adventures chess class, beginning in Kindergarten, is offered and open to the community. Portledge Summer Adventures also offers a three week session taught by Mr. LaFlair. Two giant chess boards are now permanent fixtures on campus (with one more on its way) so students are able to play during their recess or free period.

# SAFE's anti tobacco marketing campaign a success

The "We've Seen Enough Tobacco Marketing" Campaign spearheaded by the SAFE Pride Project Coalition's School Committee who partnered with the Glen Cove School District's Health, Physical Education & Athletic Department and the Tobacco Action Coalition of LI. at Glen Cove High School has ended.

The campaign concluded at the Glen Cove Boys & Girls Club and at the Glen Cove Youth Bureau's Youth Council Meeting.

"The presentation reinforced that the youth of Glen Cove are constantly exposed to tobacco marketing in the media and in their lives," said Melissa Rhodes, Executive Director of the Glen Cove Boys & Girls Club. "The youth involved in the presentation each want to live a happy, healthy life and therefore support this campaign fully."

The purpose of the campaign was to thwart tobacco company's efforts to encourage youth to smoke. They create marketing strategies that include advertisements to make smoking look appealing and paying store owners additional money to place cigarettes near the cash registers so youth can see them.

Students viewed two compelling videos, one that has a middle school student being followed by tobacco reps that are encouraging her to smoke, and another, depicting an elementary school age girl in a deli who is surprised when she is spoken to by cigarettes behind the counter. Students also signed team comment postcards, and posters stating their support for ending the advertising campaigns. Plans are underway to have these messages sent to the state.

## ISE Sponsors Sixth Grade Community Service Dance

The ISE (Inter School Exchange), comprised of independent schools on Long Island including Buckley Country Day School, East Woods School, Friends Academy, Greenvale School, Lutheran High School, and Portledge School, hosted its First Annual ISE CARES Sixth Grade Community Service Dance at East Woods on Friday, January 13. As the students entered they were randomly assigned a team and then went in to dance and socialize. Steve Fortuna, board member from the NSSP, gave a short speech telling the students how much he valued what they were doing and the type of service the shelter provides. Throughout the dance, teams were called to packing stations where they worked with their peers from

the different ISE schools to assemble the bags, and write notes to the recipients. Sixty care packages were assembled and over \$430 was collected, which will be used for food served at the shelter.

The majority of the Portledge sixth grade class was able to attend, and they



all admit it was a wonderful experience. Besides spending the night with their friends, they were able to see people they knew from other schools and meet new people. The best part of the night was doing something to help others in our community. Community service plays a big role at Portledge School. Beginning

in the Lower School, children learn the importance of helping others. The newly formed Interact Club in the Middle School is all community-service based. The Upper School boasts a very active Community Service Club which hosts a number of school-wide drives such as coat, candy, toy, plus they make cards for soldiers abroad and veterans, hold bake sales to raise funds to purchase groceries to make lunches for a local homeless shelter, participate in beach clean-ups, Habitat for Humanity and a lot more. Plus, the Middle and Upper School Student Councils host community service activities as well. Every student in the Upper School is required to complete community service hours throughout the school year.

## Glen Cove Hospital Names Barbara Barnett, MD, As New Medical Director



The North Shore-LIJ Health System today announced the appointment of Barbara Barnett, MD, as medical director of Glen Cove Hospital.

Dr. Barnett previously served as LIJ Medical Center's associate chair of the department of medicine, director of clinical affairs and section head of hospitalist medicine.

In her role as medical director, Dr. Barnett oversees medical affairs, quality management, patient care and safety issues and standards of care at Glen Cove Hospital, a 265-bed acute care community hospital with more than 700 affiliated physicians. Dr. Barnett succeeds George Dunn, MD, who recently retired after 35 years as the hospital's senior vice president of medical affairs and the chair of the department of family medicine.

At LIJ, Dr. Barnett also held the position of associate program director of the combined internal medicine and emergency medicine residency program. She joined LIJ in 1997 as an assistant director of employee health service. A member of several hospital committees at LIJ, Dr. Barnett was medical director

for two clinical care improvement projects on pneumonia and sepsis. She also served as physician co-chair of the Patient Centered Care Model Committee, which was focused on delivering high-quality patient and family centered care.

Dr. Barnett is associate professor of the departments of medicine and emergency medicine at the Hofstra North Shore-LIJ School of Medicine. She is a Fellow of the American College of Physicians, a Fellow of Academic Emergency Medicine and a Fellow of the American College of Emergency Physicians. Her professional affiliations include membership in the American Medical Association, Society of Academic Emergency Medicine and the Council of Residency Directors. Dr. Barnett has published several peer-reviewed journal articles and served as editor or contributor to medical text books. She has given presentations on a variety of internal medicine and emergency medicine topics in the New York metropolitan area as well as abroad.

She received her medical degree from SUNY Health Science Center at Brooklyn, and completed her residency in emergency medicine/internal medicine at the Albert Einstein College of Medicine and LIJ Medical Center. Dr. Barnett is currently enrolled in the Dartmouth HealthCare Delivery Sciences Master's Program.

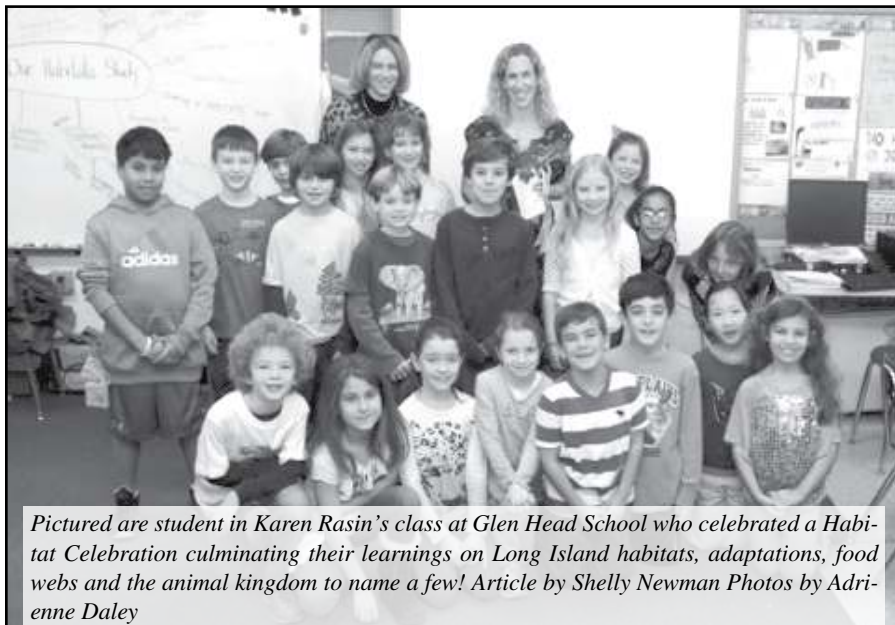

# Name the Celebrity



This week's celebrity was born in Los Angeles on April 18, 1919 and was an actress, singer and radio personality known for her comedic roles in MGM musicals of the 1940's. Among the films she appeared in during her time at MGM were "The Big Store" (1941) with the Marx Brothers, "Ship Ahoy" (1942) with Eleanor Powell, "Thousands Cheer" (1943) with Gene Kelly and Kathryn Grayson, and "Du Barry Was a Lady" (1943) with Lucille Ball and Red Skelton. Also, she appeared with Red Skelton, Robert Young, Lionel Barrymore and Eleanor Powell in "Lady Be Good" (1941), which won an Academy Award for Best Song for "The Last Time I Saw Paris", which was composed by Jerome Kern and Oscar Hammerstein II. It was sung by Ann Sothern, our column's celebrity two weeks ago. She made her Broadway debut in the short-lived 1940 musical with Jimmy Durante, Ray Bolger and Ilka Chase. She recorded four of the songs for Columbia Records in 1940. She continued to perform well into the 1990's with both her one-woman show and "Show Boat", co-starring Alan Young.

## Last Week's Celebrity

Last week's celebrity was born Stanislaus Pascal Franchot Tone, known professionally as Franchot Tone. His maternal great-grandfather was Congressman Richard Franchot (1816-75 R-NY 19th District). In 1935, he was nominated for the Academy Award for Best Actor, but lost to Victor McLaglen in the "In-

former". Tone also appeared in "The Lives of a Bengal Lancer" (1935) opposite Gary Cooper and "Dangerous" with Bette Davis, in her first Oscar-winning role. By the way, on Dec. 14, 2002, Steven Spielberg anonymously bought Bette's Oscar at a Sotheby auction in NYC and returned it to the Academy of Motion Picture Arts and Sciences. The statuette was among the memorabilia sold by the Planet Hollywood restaurant chain, which has emerged from bankruptcy protection. Tone worked steadily through the 1940's, but often played second leads or love interests in films that focused on a major female star. Frequently, typecast as the wealthy cafe-society playboy, he notably played against type in films like "Five Graves to Cairo" (1943) with Anne Baxter, a WWII espionage story directed by Billy Wilder and "Phantom Lady" (1944), a film noir thriller with Ella Raines. In the 1950's, facing subtle blacklisting in Hollywood, he found parts in New York-based live TV, including the original production of "Twelve Angry Men". In the 1960's he returned to Hollywood and appeared aged beyond his years, allegedly due to alcohol abuse. He did TV character roles on "Wagon Train", "Bonanza", "The Twilight Zone", "Ben Casey" and "The Alfred Hitchcock Hour". On film, he received acclaims as the dying president in Otto Preminger's 1962 film version of "Advise and Consent". In 1951, Tone's relationship with actress Barbara Payton made headlines when he suffered numerous facial injuries and fell into a coma for 18 hours following a fistfight with actor Tom Neal, a rival for Payton's attention. Plastic surgery nearly restored his broken nose and cheek. Tone subsequently married Payton, divorcing her in 1952, after obtaining incriminating photographs proving she had continued her relationship with Neal. Tone died of lung cancer in NYC, on Sept. 18, 1968, at the age of 63.

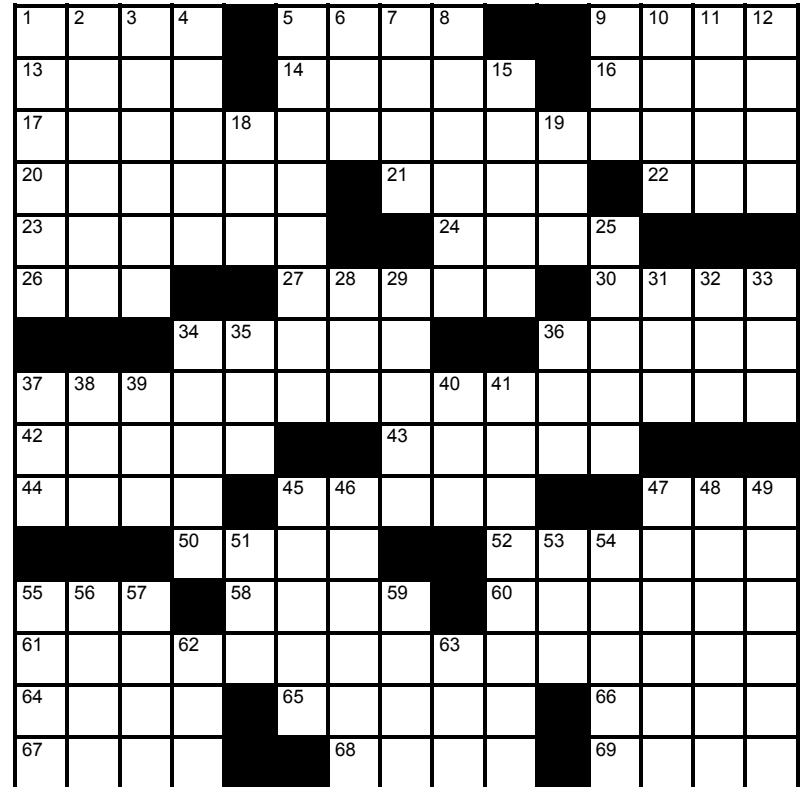

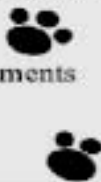

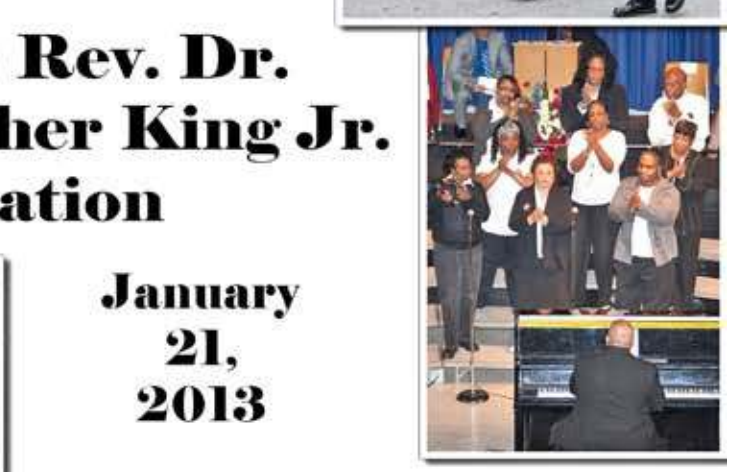
