



# Residents Express Concern Over LIPA Plant Closing

*North Shore District Reform Group puts together diverse multiparty panel of politicians to answer residents questions*

Residents packed the American Legion Hall in Glen Head on February 26 expressing concerns regarding the decommissioning of the portions of the Glenwood Lading LIPA Power Plant. One resident said people are scared to death about the possible tax hikes due to the loss of taxes from LIPA on the property. Senator Carl Marcellino said, "Should people be scared? No. Should they be concerned? Yes. But we will get something done to get this phased in over time, which is the best we can do to let the school district and residents time to adjust. Hopefully they will be good neighbors and get the property cleaned up quickly and set up for redevelopment quickly."

The meeting was put together by the North Shore District Reform Group Inc. who's mission statement is, "We are a group of concerned community members who have united and formed a civic organization. We will proactively participate and meaningfully interact with our elected local and state officials."

"It is our mission to be an active voice in the community. We will inform, represent and advocate for our residents on the many significant issues that affect our children, our schools, our property taxes, the values of our homes, and the quality of life within our community."

Assembled to speak to the residents was a diverse multi-party panel of

politicians: Senator Carl L. Marcellino, Senator Jack M. Martins, Assemblyman Michael Montesano, Assemblyman Charles Lavine and Assemblyman Edward P. Ra.

First to speak was Senator Marcellino who, according to NSDRG, was been the most active in the fight for the residents concerning the plant closing. He said the Glenwood Landing plant isn't unique, in fact other plants are being decommissioned including one in

Northport. "They claim they don't need them to supply power to the Island," he said. Marcellino said the plan for the area is not to totally remove everything with some generators remaining.

## Building Condo's?

"If you thought they were going to take down everything and make room for condos, that's never going to happen." He said it is projected that they will be decommissioning approximately half

of the land, bringing the approximate taxable property value from 14 million down to half. That is what has residents concerned about the decrease in tax revenue to the school district. "They pay about twenty-five percent of the taxes for the school district."

Marcellino said he is looking to the Senate to include in the budget, a funding stream to protect the taxpayers over the transition until either the property can be redeveloped or the school district can make adjustments.

## Governor Is Open

"I feel good about it," said Marcellino, "The Governor's office is open to it and I think we will come to a conclusion."

Senator Jack M. Martins said they have had many meeting regarding the issue and noted, "Though he won't say it himself, no one has done more than Carl on this issue."

Martins noted that the property is owned by a private company, noting that the government can't make them continue to keep the building in place and continue to pay taxes. Should they want to remove the buildings and pay taxes on vacant land, reducing their tax bill, that is their choice.

# Concerns Over Student "Hit" List

The Glen Cove Police Department was contacted by the Glen Cove Finley Middle School Principal Nelson Iocolano regarding a hit list on February 24. Detective Lieutenant John Nagle, Detective Christopher Albin, and officer James McDonnell responded to the school. Mr. Iocolano showed the police a "hit list" which was taken from a 7th grade student (12 years of age) from the school.

The hit list contained names of people that the student allegedly wanted to kill. The list included numerous Finley Middle school students, school faculty, and members of the students family. Apparently the student, while writing the list in class, was observed by another student who proceeded to physically take the list from him and turned it over to a teacher. The teacher then notified school security

and the school's Principal. The Principal then notified the Glen Cove Police who responded to the school. The student and his mother were taken to the Glen Cove Police Department for further investigation.

The youth was interviewed and a determination was made that he should be mentally evaluated. The youth was transported to the North Shore University Hospital in Glen Cove. Police interviewed family members and physically checked the youths home and it does not appear that he had access to any type of weapons. The school district has contacted every parent of all the children who appeared on the list. The school has suspended the youth at this time.



## Glen Cove St. Patrick's Day Parade March 17, 2013

## Dr. Michael Israel Speaks at Coalition for Glen Cove Meeting

Dr. Michael Israel, Assistant Superintendent for Curriculum and Instruction for the Glen Cove School District, was the guest speaker at a meeting of the Coalition for Glen Cove on February 19th. Dr. Israel is currently overseeing many aspects of the District "Action Plan for Improvement", much of which is focused on meeting the challenges of the Common Core Curriculum, recently adopted by New York State as part of their educational reform initiatives. To comply with the Common Core, our teachers need high quality professional development and our students need access to new texts and technology aligned with the new, more rigorous standards. Given the 2% property tax cap and a tight budget, it is becoming even more challenging to close the gap in resources and achievement that exists between communities of more and less wealth on Long Island. The board of education is currently at work on a budget which supports needed curriculum improvements and invests in the most effective programs for our students.

Dr. Israel described some initiatives that will be achieved with state or federal grants, rather than coming out of the annual school budget. One is "Virtual AP" grant in conjunction with BOCES. It provides professional development for AP teachers and access to online resources to support "blended learning". This grant will also allow for all Glen Cove 9th graders to take the PSAT for free, which help to identify more students who could benefit from taking AP classes, as well as help students to start focusing on their college goals. In addition, there will be several online AP courses available and additional laptop computers for students to use in their classrooms will be provided.

Another technology grant through NYSED is designed to facilitate the transition to computer-based testing and the overall integration of technology in the classroom. Vouchers will be provided, which can be redeemed for eligible products from any technology company, to be used to purchase computer hardware, software, and equipment needed for computer networks and technology infrastructure. Fifty percent of the value of a voucher will be eligible to purchase hardware; the other 50 percent can be used to purchase specific category software. This grant through NYSED is earmarked for schools in which over 50% of students qualify for free or reduced lunch.

There are many programs designed to support the academic growth of our students in K to 12th grades. Dr. Israel reported that our 3rd through 5th grade teachers are excited about the new "Jour-

ney" ELA resources, which were chosen by a committee of our own professional educators. These materials are aligned with the Common Core and use a "balanced literacy" approach to reading and writing. A district-wide math committee is currently at work on the selection of a new Math program which must also be consistent with Common Core. Another initiative, called SIM, Strategic Instructional Model, a research based program is being used to develop our students' foundations in ELA, such as sentence and paragraph writing. Additionally, our district has implemented an ESL Saturday Academy, which provides additional support focusing on ELA and Math for our ESL students and their families. This initiative is financed through a Title III Grant.

The district will be providing extra support for our high school students in the form of AP review classes. Regents review sessions are also in the planning stages. Additionally, Method Test Prep through Castle Learning will be available on-line to all GCHS students to provide additional preparation for the SAT and ACT. For grades 3 to 8 students, there will be a 4 week Saturday Academy to provide additional preparation for the state ELA and Math assessments for targeted youngsters.

Dr. Israel explained that districts across the state are bracing for the results of the NYS Grade 3-8 ELA and Math assessments which will be taken in April 2013, and based on the Common Core curriculum for the first time. The challenge for districts across the state is that the common core standards were not phased in one grade level at a time, but instead implemented across the grades. The CCS instructional shifts in ELA and Math continue to be emphasized as follows:

Common Core ELA Instructional Shifts: Pre Kdg. - Gr.5: Balancing informational and literary texts; Gr. 6-12: Knowledge in the disciplines; Staircase of complexity; Text-based answers; Writing from sources; Academic vocabulary. Common Core Math Instructional Shifts include the following: Focus; Coherence; Fluency; Deep Understanding; Application; Dual Intensity. Dr. Israel emphasized the importance of community involvement and encourages attendance at school board meetings as the budget season unfolds and many important decisions are being made that affect the quality of education in Glen Cove.

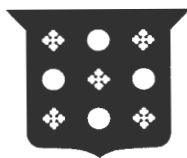

He noted that the property has been used for power generation since 1908 and is known to be contaminated. He said a large section of the building is to come down but overhead lines and gas turbines are to remain. He said the county assessor is working on the tax value the company will ultimately pay sans the structures. "But it won't be zero." He said the company has said they will remediate quickly and completely so the property can be used for another use and put back on the tax rolls at close to its current status. "We only have to hope that they will do the right thing... It's a valuable piece of property and our job is to get the State to make up the difference [in tax shortage]."

Assemblyman Michael Montesano thanked NSDRG for putting the event together saying, "It's a great way to get the information out because a lot of the time most of the message often gets lost in translation.

"I live here," he said, "I'll be effected too. He said what many residents can do is create a letter writing campaign to the Governor's office. Montesano said the property is owned by a private company, much like Waldbaums, if they wanted to leave, "We can't make them stay." He said that the School District also has to make adjustments and prepare for the future regarding the number of employees and services provided.

Assemblyman Charles Lavine

said, "We don't know what is going to happen here but we are all going to bat for our community had you have our pledge to be sure that the quality of your school district remains high."

He noted School Board President Carolyn Geoveise along with Superintendent Dr. Edward Melnick sitting in the audience. "The school district has been working to make sure our community is protected."

Assemblyman Edward Ra noted that this is something that has and will repeat itself in other parts of the State, "Which can be a good thing," he said, when trying to get the attention of people in other parts of the state. "I think Senator Marcellino's bill is the best way to get through this difficult time frame until the property is put back on the tax rolls."

### Questions From The Public

Answering a question from the public Senator Marcellino said it would be LIPA that would be responsible for the cleanup of the property but ultimately up to the DEC to determine the future use.

Another resident asked why the plant has to be decommissioned considering our needs for electric have been going up two percent per year. Marcellino said they have simply determined the plant is too old and just isn't worth using. It's cheaper to get power from elsewhere."

Sea Cliff Mayor Bruce Kennedy said a lot of work has begun at

the site including cleaning out the main building, removal of debris, etc. "I was down looking for a permit but there was none." He said the Army Core of Engineers were there, and the DEC, he asked, "Who is the lead agency?" Senator Martins said he would take it upon himself to get the Mayor the answers. The property is located in the township of Hempstead, so it falls under them.

At the end of the meeting resi-

dents were encouraged to write individual letters to NYS Governor Andrew M. Cuomo expressing a need for the State to help make up the shortfall of the tax income.

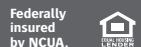

## Sea Cliff Arts Council Features an Interesting Show

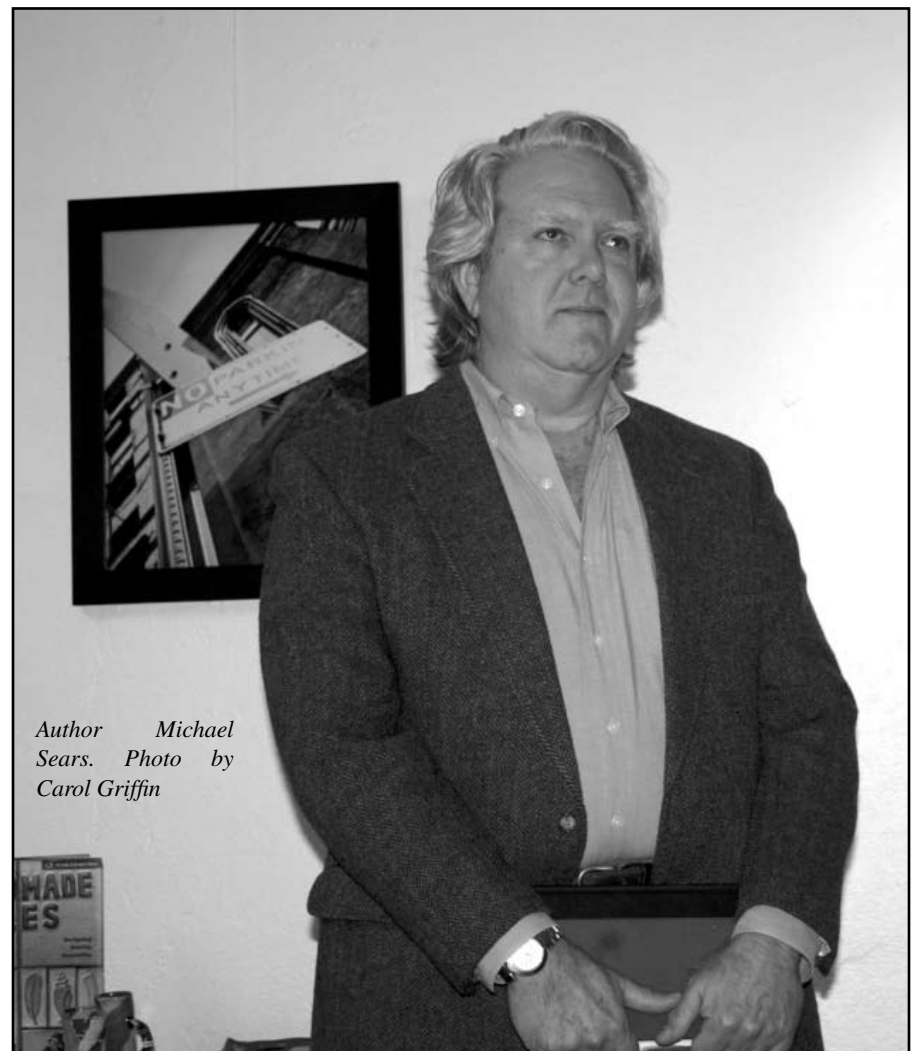

The Glen Cove Board of Education has unanimously appointed Maria Rianna to serve as the next Supt. of Schools beginning July 1. The Glen Cove City School District Board of Education has unanimously appointed Maria L. Rianna as the next Superintendent of Schools, effective July 1, 2013. A veteran educator and administrator, Ms. Rianna has successfully served as an Assistant/Deputy Superintendent since 2000.

After reviewing numerous resumes and public questionnaire responses and conducting several rounds of interviews, the Board members conferred and identified Ms. Rianna as their candidate of choice to lead the Glen Cove School District into the future. In fact, when polled, each of the seven members of the Board identified her as his/her top choice. District Wise Search Consultants assisted the Board in narrowing the field to find the candidate who best met the criteria of the Board, as well as staff and community following multiple input sessions.

We felt she embodied every one of the characteristics described as desirable by our community members. She is the right fit for Glen Cove and we look forward to

working with her to accomplish great things for our children."

Since 2011, Ms. Rianna has been the Assistant Superintendent for Instruction and Administration for the Smithtown Central School District, in charge of all aspects of the K-12 instructional program in a district comprised of 13 schools. Her additional responsibilities include the creation and supervision of the district budget pertaining to program; supervision and evaluation of all building and district-level curriculum administrators; implementation of all professional development; and participation in negotiations of labor agreements.

"I am honored to be the next Superintendent of the Glen Cove School District. My thanks go out to each and every Board member for showing faith in me to lead this school system at a time when new Common Core Standards are being implemented and challenges in public education become more complex," said Ms. Rianna. "From what I have seen, the Glen Cove community is dedicated to doing what is best for its children. I look forward to working with my new administrative team, the teachers, parents and other concerned residents and organizations to help our students to realize their vision and achieve greatness as they advance through the Glen Cove schools."

Prior to Smithtown, she served as Assistant Superintendent and later Deputy Superintendent of the Port Jefferson School District. With similar responsibilities as those held in Smithtown, following her promotion to Deputy,

Ms. Rianna's role expanded to include recruitment of instructional staff, participation and input into district capital projects and assisting the superintendent of schools in all aspects of district operations.

Her accomplishments include: increasing the number of students receiving Regents diplomas with distinction and improving the percentage of students attending four-year colleges while enhancing student eligibility and acceptance into more rigorous institutions of higher education; increasing the number of Advanced Placement exams while maintaining exceptional passing rates; expanding access to student data to improve instruction and overall achievement; integrating leading-edge technology resources to enhance instruction (iPads, SmartBoards, laptop carts, Skype, etc.); fostering a partnership with Stony Brook University for student E-tutorials; implementing cost saving measures to purchase services and software; creating a middle school science research program to increase interest and future participation in the Intel Science Search and regional science competitions; designing and implementing elementary science labs and an elementary foreign language (FLES) program; restructuring RtI programs to more effectively identify at-risk students while improving understanding of student progress; enhancing the work of Child Study Teams to provide students interventions that best meet their identified learning needs; and enhancing secondary support for special needs stu-

dents through inclusion programs.

Ms. Rianna also served as Director of Special Education for the William Floyd School District, responsible for a \$15 million special education budget and charged with the task of aligning the special education curriculum with the ever-evolving, more rigorous New York State standards. She also served as both the Assistant Director for Special Education as well as the Coordinator for ELA, Reading, Preschool and Special Grants in the Patchogue-Medford School District where she taught elementary special education and later developed master schedules and coordinated pupil personnel services as dean of students at the middle and high school levels. Ms. Rianna began her career as an assistant special education teacher at Herricks High School in 1982.

This spring Ms. Rianna anticipates completing her doctoral program at Hofstra University, where she also completed her business administrator's certification. She earned her Professional Diploma from C.W. Post and received both her Masters and Bachelor degrees from Adelphi University.

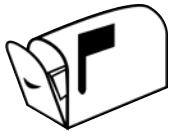

On February 12, 2013, the Long Island Alzheimer's Foundation held its 25th Annual Coping and Caring Conference and Awards Luncheon. This is always a wonderful event filled with renowned guest speakers and an awards presentation. This year, Carol Waldman, Executive Director of the Glen Cove Senior Center was amongst the recipients for the Center's cutting edge brain fitness program called Campaign Against Dementia thanks to a substantial grant from the Unitarian Universalist Congregation at Shelter Rock and managed through the SAGE Foundation. Now entering its 3rd session, the Campaign Against Dementia runs for eight weeks for three hours per class and incorporates information about the workings of the brain, time for puzzles, and a guest speaker rang-

However, it seems like it's taking a long time for first responders to arrive. Meanwhile, the responders have arrived on your street but they're having problems finding your house. The house doesn't have any easily identifiable numbers on it and the mailbox is blocked by trees. This is a common scenario that is totally preventable.

Finding your house, especially at night, can be challenging if address numbers are unreadable, blocked, unlit or not even there. Dear Great Book Guru, I went with friends this week to a book signing for our friend Fred Stoppel's new book *LUCKY ME* that he wrote with Sachi Parker. There was a huge crowd and we had so much fun! While on line, I heard a group of literary types talking about a novel they had chosen for their book club. It wasn't a bestseller and certainly not new but it sounded very interesting—something about sibling relationships, astronomy, and J. Robert Oppenheimer. Have I given you enough clues? Always Looking for a Good Book

Dear Always Looking, I know just the book: *THE FIRST LIGHT* by Charles Baxter. Written in 1987 and recently re-released, this novel uses a very interesting technique: beginning in the present, each chapter brings us further into the past. Baxter opens with Dorsey and her brother Hugh,

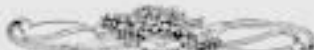

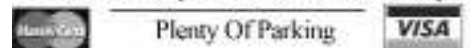
