



North Shore Trustees Eliminate \$683,397 from Initial 2013-14 Budget Proposal, It is Within Allowable Tax Levy Limit

School Budget Will Be Adopted on Thursday, 4/4, at BOE Meeting

At the recent Board of Education meetings, Trustees eliminated a total of \$683,397 from the preliminary budget proposal while still maintaining the quality of our current academic programs. The 2013-14 Budget Proposal is within the allowable tax levy limit this year.

Last year, N.Y. State implemented legislation requiring a cap on the tax levy limit. This law does not restrict the proposed tax levy increases to 2%. The State allows for certain exemptions from the cap which enable school districts to go above the 2% but still remain within the allowable tax levy limit; these include increases in costs related to Retirement and Pension, Capital Projects, and Debt Service.

Prior to his initial budget presentation on January 17th, Superintendent Dr. Edward Melnick cut approximately \$3 million. With the additional Board cuts, the budget proposal is currently \$93,985,568 for 2013-14, representing a 3.85% budget to budget increase from last year. Of this increase, 3.31% is made up of Pension and Health costs which must be paid whether or not the budget is passed by the community and 0.54% represents the increase in the rest of the school budget.

In recent years, our Board of Education has taken many steps in an attempt to slow down the increase in school property taxes for district residents. In fact, in each of the five prior years, the percentage increase in the budget proposal has declined, and unlike many other school districts around the state, we have been able to maintain our programs. These cost savings measures have included: Construction of the Transportation

Depot resulting in savings over \$1M per year as a result of not having to contract out for a major portion of our bussing. In addition, the facility is actually generating revenue as we have contracted with East Williston, Locust Valley and Roslyn for use of various facility services.

Energy Management Contract. The Board negotiated an energy management contract with Honeywell, saving residents millions of dollars in reduced energy costs for all district facilities over the next decade.

Conservative Collective Bargaining Agreements. Faced with the potential of major cuts in order to remain under the newly imposed tax levy limit, our teachers and administrators agreed to very conservative contracts, enabling us to save over 20 positions that were being considered for elimination

Now, more than ever, we need to work together in order to protect the quality of our schools, and ultimately our community. Please remember to go to the polls on Tuesday, May 21, from 7 am-10 pm at the North Shore High School Gym. The Election of Trustees and Celebration

of Student Work will also take place on May 21st. Under N.Y. State legislation, if voters reject the spending plan twice, the district will be forced to adopt a budget with the same or lower tax levy as the prior year. For North Shore this will result in DRASTIC cuts of approximately \$3 million from the North Shore Schools 2013-14 Budget Proposal.

Trustees will officially adopt the final 2013-14 budget proposal on Thursday, April 4, in the MS Café at 8 PM. The budget vote by district residents will be on May 21, 2013 from 7am -10pm in the Gymnasium at North Shore High School. Voter registration will take place in the High School on May 4th, for those not already registered.

Dr. Grace Hsu, DDS and students from the New York College of Osteopathic Medicine recently visited Glen Cove Boys & Girls Club to educate Club members about healthy habits and familiarize them with the profession of Medicine.

Dr. Hsu, who has a dental practice in Oyster Bay, and her staff, instructed members on dental hygiene and how to properly take care of their teeth. Dr. Hsu and her team gave the kids a glimpse into dentistry, allowing members to practice the tips they had learned during the session on an oversized model of teeth. Members took turns brushing and flossing the model and received goody bags filled with toothbrushes and dental masks.

Students from The New York College of Osteopathic Medicine held a mini seminar at the Club to allow members to try their hand at being a doctor for a day. Club Members worked with medical instruments like thermometers, stethoscopes, reflex hammers and blood pressure cuffs to take their own vital stats.

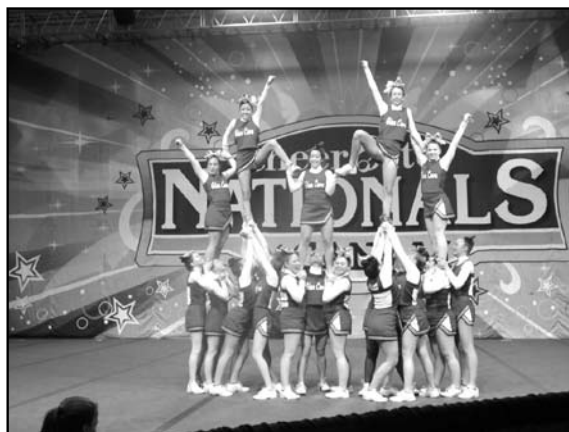

LIPA UPDATE: First Steps Towards A Solution

As a first step towards a solution to the loss of the tax base as it relates to the decommissioning of the LIPA plant, the school district will receive an allocation of \$2,500,000 from the State to be used in the first year that the reduced tax assessments are felt by the tax payers. Both the State Senate and the Assembly have appropriated money in this year's state budget to help cushion the tax impact. The Senate, led by Senator Marcellino, has ensured that there will be two million dollars (\$2,000,000) in this year's budget and the Assembly, led by Assemblyman Lavine, has ensured there will be five hundred thousand dollars (\$500,000). The appropriations were made on March 24, 2013 and the bills will be official on Wednesday, March 27, 2013.

President Carolyn Mazzu Genovesi said, "Senator Marcellino has been a champion on behalf of this community and his efforts are to be commended."

The Board of Education's leadership on this issue for the last year and

a half has been essential to this decision. President Genovesi said, "We will continue to pressure our representatives and consider every option available to the School District to seek a long term solution regarding the ramp-down of the LIPA Power Facility with the help of the entire community."

In March, President Genovesi Sea Cliff Mayor, Bruce Kennedy, Sea Cliff Trustee and Legislative Action Committee (LAC) Chairperson, Thomas Murphy, Gold Coast Library Trustee, Miles Sibell, School Board Trustee, Thomas Knierim, and LAC Liaison, Igor Webb, visited officials in Albany to discuss the ramifications and the need for a state solution for the loss of taxes from the decommissioning of the Glenwood Landing LIPA plant.

EMS Members Display Green Lights In Personal Vehicles

In the City of Glen Cove we have 2 public safety departments that have volunteer members use their personal vehicles to respond to emergencies. They are the Glen Cove Emergency Medical Services (EMS) and the Glen Cove Fire Department. Each department displays a different colored light. These lights are usually displayed in the grill or on the dashboard of the vehicle.

Green Lights - EMS

Volunteer EMTs, paramedics and ambulance drivers display green lights in their personal vehicles when responding to medical emergencies. These members could be responding to EMS headquarters or directly to the scene of the emergency. New York State law authorizes green lights to be displayed by volunteer ambulance workers only.

Blue Lights - Fire Dept

Volunteer firefighters display blue lights in their personal vehicle when

responding to fire alarms. These members are usually responding to the Fire House. New York State law authorizes front-facing blue lights to be displayed by volunteer firefighters only.

These green lights and blue lights are a courtesy only and do not give our members any special privileges while operating a vehicle. The purpose of these lights are to alert other drivers that members are responding to an emergency. It's up to the other drivers to voluntarily yield and let them pass by. These members are your friends and neighbors responding to emergencies in our community. Please give them this courtesy and allow them to pass.

Movie Review

Oz the Great and Powerful

Rated PG (A few intense action sequences)
Stars: James Franco, Mila Kunis, Rachel Weisz



Upon hearing a prequel was in the works for *The Wizard of Oz*, innumerable fans of the 1939 original were taken aback with shock and rage. As is the case for any remake, reboot or expansion of a beloved film, devotees were quick to clamor "how dare the demons in Hollywood vilify the symbol of my childhood?" The prequel was plagued with unfounded assumptions that it was utterly impossible for the movie to be nothing more than a shallow cash grab, maliciously exploiting the immortal legacy of a classic. Despite this crushing pressure, *Oz the Great and Powerful* has proved all the naysayers wrong.

It is in Kansas of 1905 that we meet the man who will soon be known as the ruler of Oz, Oscar Diggs (James Franco). A carnie magician and admitted con man, Oscar is constantly reminded by his torn coat and slim earnings that he is not living the life he dreamed of. As he says, "I am many things, but a good man isn't one of them." Unbeknownst to him, Oscar will soon get a chance to change this. After a show with his new dimwitted assistant goes awry, a tornado sweeps through the carnival. Oscar, who finds himself in a hot air balloon at the time, is carried off by the winds in a finely executed scene of debris dodging and hanging on for dear life.

Having just narrowly escaped death, Oscar is transported to a vividly enchanted land unlike anything he had ever seen before. He is soon greeted by Theodora (Mila Kunis), a gorgeous witch who informs him he has arrived in Oz.

Not wanting to disappoint, Oscar goes along with Theodora's inference that he is the prophesized wizard destined to save the people of Oz from the evil witch and take the throne. On their way to the Emerald City castle were Theodora and her sister Evanora (Rachel Weisz) reside Oscar saves Finley (Zach Braff), a winged monkey sporting a bellhop uniform, from a lion. Eternally grateful, Finley swears his servitude to Oscar. He later comes to the rescue of a young girl made of China (Joey King) in a devastated village of teapot buildings, restoring her shattered legs with "magic in a bottle," otherwise known as glue.

Carrying on with his mission accompanied by Finley and the delicate but sassy China figurine, Oscar learns that

he may have been too trusting in Theodora and her sister. When he comes face to face with the accused wicked witch Glinda (Michelle Williams), she seems to be nothing of the sort.

Oscar's journeys revel in the stunning beauty of Oz, with sprawling vibrant landscapes and bizarre creatures, particularly enhanced by IMAX and 3D. Every detail has been carefully and whimsically crafted while building this world, from the emerald castle to the massive bellflowers acting as actual bells. Directed with competence and a clear love for the story by Sam Raimi (directorially known for his 2002-2007 *Spiderman* trilogy) we can appreciate every ounce of magic in this land from an array of thrilling camera angles. The screenplay credited to David Lindsay-Abaire and Mitchell Kapner is pure good natured fun, with abundant smile inducing dialogue. Every character, even the minor ones, is colorful and memorable.

It is apparent the cast is enjoying the story's whimsy. Kunis and Weisz relish the opportunity to portray corrupt hearted witches terrorizing the good Tinkers, Quadlings and Munchkins of Oz. Franco finds a way to balance the imperfections in his character with the genuine want to be a better man. It is a group effort made fruitful by dedication and lightheartedness.

The movie's only real flaw is in the ill-defined mechanics of the witches' powers. There is some blurring as to when, how and to what degree their magic abilities can be used. However this is simply a slight scuff that only minutely detracts from its soulful high polish.

Some may still be leery of *Oz the Great and Powerful's* intentions. It is to be assured that this movie was created with the goal of elaborating on what was established back in '39, while simultaneously celebrating it. Any financial success is well earned. To miss out on such a cheerful, thrilling adventure would be a shame.

Local Youth Participates in Tourette Syndrome Youth Ambassador Training Held in Washington D.C.

The national Tourette Syndrome Association, Inc. (TSA) hosted its sixth annual Tourette Syndrome (TS) Youth Ambassador Training Program in Washington D.C. on March 19 and 20, 2013 for teens (with and without Tourette Syndrome) ages 13 to 17. After completing an application and submitting an essay regarding his intent and motivation to become a TS Youth Ambassador, Dylan Brady, (son of Nancy and John Brady) who has Tourettes, 14 years old from Sea Cliff, NY has been selected to complete this elite training. Dylan will now be able to educate his peers and younger children with accurate information by going into classrooms, schools and clubs to teach understanding, sensitivity and tolerance of TS and its symptoms, while displacing the myths and stereotypes that are often attributed to and associated with this misunderstood and misdiagnosed disorder. Dylan will be accompanied by his mother, Nancy Brady, who will also participate in the training.

The TSA Youth Ambassador program trains teens to advocate for themselves and for others and to educate their peers and younger children with accurate information. Youth Ambassadors also meet with politicians, appear in the media and assist with fundraising and awareness raising campaigns. Youth Ambassadors have found there are many personal benefits as well, such as learning to work as

team members and developing increased confidence in public speaking. Youth Ambassadors learn skills that they will use for the rest of their lives and at the same time are helping to enlighten our generation about Tourette Syndrome.

TSA conducted a Youth Ambassador training for the first time in April 2008 and this training has become such a success that TSA makes it an annual program. Since the first training, this collective group of over 150 dedicated teens have completed nearly 500 activities including presentations, print and TV media interviews, and training other Youth Ambassadors and have reached over 5 million people through their combined efforts.

Jennifer Zwilling, now 22, program founder says, "The goal of this exciting program is to educate children all over the country about TS, a widely misunderstood disorder. We are following the motto 'think globally, act locally.'" Understanding and tolerance are the program's goals.

This unique experience is possible thanks to the American Legion Child Welfare Foundation, Inc., Teva Pharmaceuticals, and The Frank J. Antun Foundation for their generous contributions to this program.

understanding of Tourette Syndrome," said Judit Ungar, President, TSA.

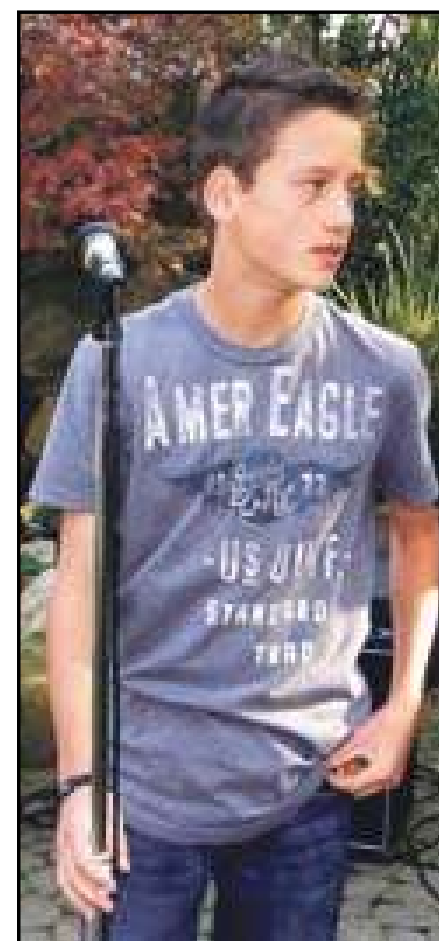

Memory Piece

by Dylan Brady

Completely relaxed, nothing on my mind, but the math test question, suddenly I move. I move and move again, I cannot concentrate; the tics change the topic in my brain to them. All the movements and all the tics that make me move back and forth take a toll on my body. They started as far back as I can remember; there was always something I would



do: if it was tapping my fingers together, making clicks in my throat, blinking, winking, sniffing, flexing my abdomen or stretching my back. The obnoxious taunting of my tics drive me crazy, I can never concentrate, the tics are too distracting. I couldn't take the pain of the movement anymore, something had to be done.

All the tics are extremely annoying, but there is one that affects me the most. Flexing my abdomen every five seconds non-stop gives me terrible stomach aches. This is the tic that put me over the edge, and made me tell my parents that I need to get help from a doctor. After I told my parents that I needed help, my dad suggested that I go to acupuncture to calm my body down. I first said that there was no way I would go, but as the tics became more relentless, I decided to give it a try.

After my first visit the tics lessened greatly, but a few days later they came back even worse. I went a few more times and there was no difference, so we went to a pediatric neurologist to get an examination on why these tics were happening. The doctor told us that I have Tourette's Syndrome; after 13 years of never knowing what was happening to me, we had an answer. The doctor suggested I take medicine, but I did not know if I wanted to try that until a couple more sessions of acupuncture. I did not want to put unneeded substances into my body that I could avoid with acupuncture. After a few more sessions of acupuncture,

Sea Cliff Elementary Students Showcase Their Science, Technology, Engineering and Math Knowledge at the 2013 S.T.E.M. Fair

On Tuesday, March 5th, Sea Cliff students showcased their science, technology, engineering and math knowledge in the 2013 S.T.E.M. Fair. In a symposium format, students displayed and presented their projects for the entire school to see! In the evening, parents and guests were invited to explore the uniquely innovative selection of S.T.E.M. related projects.

4th grade students worked in partnerships and used the math problem-solving process to solve complex math word problems. At the Fair, 4th graders presented the strategies they used to understand and solve their problems, as well as hands-on approaches to check their solutions. Students used a wide range of strategies to work toward valid solutions to their challenging word problems; draw a diagram, guess and test, work backwards, make a table and algebraic reasoning. 4th graders said, "Presenting our math problems to the 5th graders was fun because we got to show older students that we know how to solve complicated problems too!"

This year, the 3rd graders joined fifth grade students in presenting experimental projects at the Fair. Some of the topics that third graders explored were solar energy, magnetic fields, plant growth, and marine biology to determine the age of a lobster. Third graders commented, "I really liked working with a live animal for the science fair!"

The 5th grade science projects investigated a variety of science areas including; "How does the type of bedding affect my hamster's preference?, What affect does the type of bird call have on my cat's behavior? How does texting affect video game driving performance?, How does the amount of vinegar affect the consistency of milk? A 5th grader said, "I think the S.T.E.M. Fair is a great experience because I had the chance to present a topic that I am interested in and share what I learned with others."

Third and fifth grade experimental studies followed the steps to the scientific method and students demonstrated their skills at making observations, following procedures, forming hypotheses, drawing conclusions, and stating results.

Technology and engineering projects were presented by students in second through fifth grades. Applying the principles of magnetic repulsion, second grade students designed and tested Maglev Racers on a magnetic levitation track. Some fourth grade students built, programmed and presented a new line of We Do LEGO robots, while others presented the skills that forensic scientists use at a crime scene. Fifth grade students shared their work on the Future City engineering design project. This project offered students the opportunity to research, analyze and imagine solutions to a real-world engineering problem: The Effects of Rainwater Runoff

and Storm Water Pollution. First students planned and designed virtual cities using SimCity 4 software. Then, students engineered physical models of cities 150 years in the future, which demonstrated solutions to the problem. Lastly, students presented their research, models and solutions for Rainwater Runoff and Storm Water Pollution.

A Sea Cliff parent summarized by saying, "We love the S.T.E.M. Fair! There is a lot of excitement for learning going on here!"

I decided the best thing for me would be to start medicine.

Tourettes Syndrome is an inherited disorder in which people acquire frequent tics. The tics are motor and/or vocal. People have varying complexity of their tics; simple tics involve one muscle or a very small movement, and complex tics involve several muscle groups. I have motor tics that are both simple and complex. Blinking, winking, tapping my fingers, and sniffing are all simple tics. Flexing my abdomen and stretching my back are both complex tics. I also have one vocal tic which is making a click in the back of my throat. Tics do not completely go away during sleep, but there is a considerable reduction in the amount of them. There are other behaviors that coincide with Tourettes Syndrome, a couple of which I have: anxiety and perfectionism. A sensation or urge causes the tic; once the tic is performed, the sensation goes away until the urge comes back, but the period of time between sensations varies for everyone. Some people who have Tourettes Syndrome have the need to perform the tic a certain amount of times or in a specific way, to fulfill the need, or sensation, similar to obsessive compulsive disorder. I have this need, but it is not every time I do the tic.

I have now been taking my medicine for about a month. I have noticed my blinking and winking getting better, but my abdomen flex and back stretch are still constant. I am trying to get a better understanding of what Tourettes is in order to know what is happening to my body. Both the memory of my childhood tics and the development of my tics are a part of me. While I have to deal with these tics I am still an active member in North Shore High School and other activities I have a passion for. I am proud to recognize that I have Tourettes Syndrome, and still be an avid student, athlete, and musician.

I have talked about where I have come and where I am today. I don't know what will happen in my future, but I have some definite ideas and some concerns. I will continue to be an excellent student. I will continue to push myself to my athletic best. I will continue to deliver great performances with my band, DOINK. My concern is that my teachers know when I have an involuntary twitch in class that I am not being disruptive, I just can't control it. I will always pursue my passions in life and continue to do my best. Tourettes will not stop me. I just hope someday my tics will slow down or go away so I can live a tic free minute. I have Tourettes, Tourettes doesn't have me.

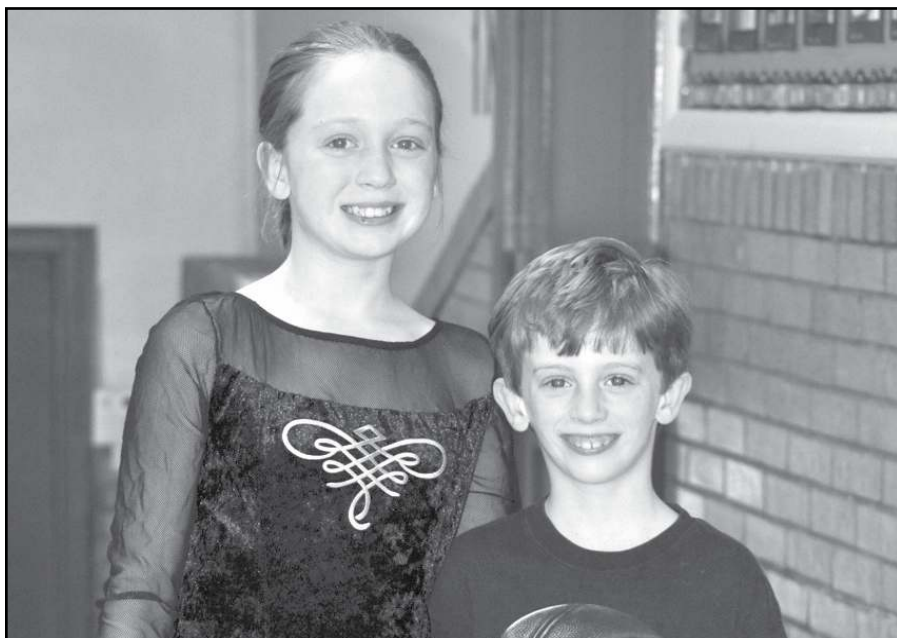


Everyone is Irish at Landing

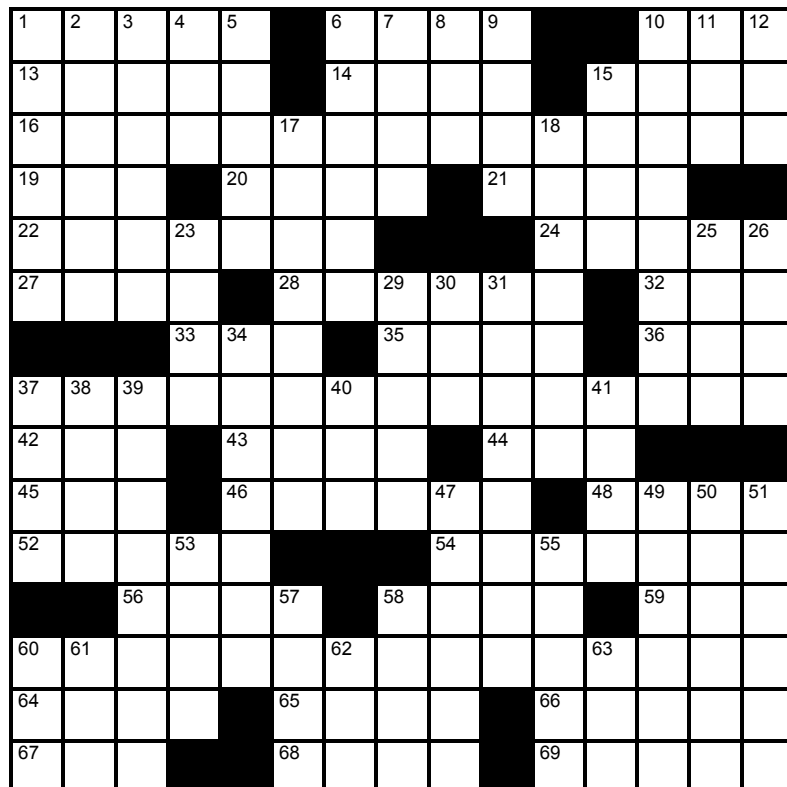

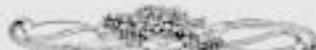
