# Sea Cliff Holds Annual Meeting

Sea Cliff Village Board of Trustees held its Annual Meeting on April 1 at the Village Center. The meeting opened with a welcome from Mayor Bruce Kennedy and the Presentation of Colors by Boy Scouts from Troop #43 followed by the Pledge of Allegiance. Rev. Kirkland Watkins did the Invocation.

Trustee Carol Vogt presented the approval of payments of Abstract No. 2234 in the amount of \$133,793, Abstract No. 2235 in the amount of \$50,734, and Abstract No. 2236 in the amount of \$92,958 seconded by Trustee Hayes.

#### Swearing-In

Justice John Reali swore in Bruce Kennedy as Mayor for a term of 2 years. Mayor Bruce Kennedy gave the State of the Village Address. "Board of Trustees, Appointees, Volunteers and fellow residents, thank you for your attendance this evening and your renewed vote of confidence by granting me re-election to the position of Mayor of the Incorporated Village of Sea Cliff.

Tonight, thanks to the commitment of our elected officials, dedicated staff, countless volunteers and proud residents as there is a lot of positive things to report."

Before going further Kennedy recognized the passing of former Mayor Norm Parsons. "Norm served this Village well, in many capacities, for many years. Norm was a mentor, and I will miss his not-so-gentle guidance over the years. He will be missed by many and has left a wonderful legacy of community service and leadership."

"Despite years of difficult economic recession, our business district is stronger than ever, our roads and sidewalks are in good shape, we have a new beach Arts Gazebo, our real estate values are increasing, work is ongoing in our municipal buildings and our bond rating has increased. At the same time, our budgets have been tight and balanced with our tax levy remaining relatively flat. While the upcoming year will continue to present ongoing challenges, the outlook for the Village is excellent. We will be hold-

ing our budget hearing for fiscal year 2013-2014 in two weeks and despite incredible increases in healthcare, pension and insurance costs; my proposed budget keeps a lid on spending. It currently appears that we will be looking at a tax increase in the neighborhood of 1.5%, said Kennedy.

This past year has had some emphasis on Senior Services with the leadership of our Senior Outreach Worker, Karen Montagnese. We have completed a Village wide Senior Survey to better serve our aging population and lowered the requirement for seniors to qualify for property tax exemptions. The initial focus of the Youth Board will be to identify ways to serve the needs of Sea Cliff's youth as well as how they can better serve the needs of their community. I

am confident the two of our young leaders, Brian Ciampa and my son Alex Kennedy can help build a group that will be a vibrant part of the lives of generations to come."

"We are preparing to go out to bid on Phase 2 of the repair/renovation of this building," which includes the Village Hall, Library, Museum, Court and assorted meeting rooms. The building has been leaking for decades and so far a professional assessment some years ago with an engineering firm to identify problem areas and to develop a plan to address the issues had been completed. "Phase one which focused on the slate roof, parapets, valleys, and flashings has been completed. Phase 2 will address the bell tower and re-pointing the exterior masonry walls. We also are working with the Library Board to establish a plan for and interior renovation of the Junior Library to upgrade the bathroom, HVAC system, lighting, shelving, carpeting and furniture."

"We have installed multi-media displays in both this room and upstairs for use by the assorted Village Boards dur-

ing public hearings. The large screen TV's allow the audience to be able to see the information and presentations of the applicants in Zoning and Planning hearings. Additionally, both the court and meeting rooms have been completely renovated.

Road work, curbs and sidewalks continue to be a large part of our annual budget and this past year we were successful in getting the County to repave the entirety of Glen Avenue as well a part of Prospect Avenue. Our Department of Public Works has once again proven this year to be second to none. Their response and handling of the aftermath of Superstorm sandy was superior. This upcoming year we will be purchasing two new low entry garbage trucks that are more fuel efficient and will reduce pollution. I renegotiated a contract with the DPW union that both sides are happy with that includes a better way to address recycling. No longer will paper and cardboard have to be bundled for pickup. There will be two separate recycling pick-ups on

# Sea Cliff's Jim O'Donnell Retires from Village

Well liked foreman of Sea Cliff Village DPW James O' Donnell received a great party in his honor on March 3 at the Sea Cliff Manor. One hundred and ten friends, relatives, and co-workers turned out to thank Jim for his service and give him a fond farewell.

Jim himself said he was overwhelmed by the party. He personally thanked the Village, the people who attended, Eileen Krieb for hiring him, his DPW crew, Pat Guy who chaired the PARTY, Clerk/Treasurer Marianne Lennon and each and the every contractor who helped the Village accomplish the job during his nine year's tenure as foreman of Sea Cliff DPW.

Jim was hired as general foreman at Sea Cliff Village Department of Public Works and Sanitation nine years ago after retiring from several years of work at the TOB Public Works, where he said he learned many skills he used as foreman of Sea Cliff DPW. Before that, he ran his own asphalt roadwork business for 30 years, "James O'Donnell and Son," which he took over when his father retired and also worked at St. John's University building and grounds department for some years.

A long line of speakers came up to the podium to reminisce about Jim and the outstanding job he did for the Village of Sea Cliff. Fr. Bob Romeo of St. Boniface Maartyr parish opened by offering a blessing for Jim and his family in his retirement. Next, Emcee John Mirando, Village Administrator, spoke about the good job Jim did. Giving some examples, John said when it snowed, Jim would check on the snow plows and then be up all night making sure the streets were cleared for residents when they got up in the morning, how he could be creative financially to get the job done, would trade equipment to benefit residents, and was known by everyone for his famous expression, "Don't worry about it!"

Former Mayor Eileen Krieb said when she heard Jim was free she thought

he would be the ideal person Sea Cliff DPW. Phil Como, a trustee when Jim was hired, said Jim was a great choice for the job. He said he found him especially helpful each year when the Village was getting ready for the Memorial Day Parade. Marianne Lennon commented that Jim was always a gentleman and pleasure to work with. "He has the biggest heart of anyone I know," she said. Before leaving the podium she presented Pat Guy with a bouquet of flowers to thank her for all her work putting Jim's retirement party together.

When Mayor Bruce Kennedy had a chance to speak, he said he recently thought about Jim stepping down. Kennedy wondered what he and the trustees would do without Jim O'Donnell. "Jim made me look so good, he respected his crew, and the work got done...Thank you for four years since I have been mayor of always making me look good," he said. He also read a long proclamation from the Village that commented on Jim's life. Noteworthy was the fact that Jim has lived his entire life in Sea Cliff and served the community in numerous ways, including 54 years as a Volunteer Firefighter, being awarded the Fireman of the year in 1979, being a department driver, and presently being the organiza-

tion's treasurer. "Jim will tell you the best thing he did for the fire service was to bring his sons Sean and Timothy in the department, who have both served as chiefs, in the department," said Kennedy.

Also among Jim's other volunteer contributions and honors received from the community are several years working with the Sea Cliff baseball organization and being awarded a White Cap Award some years ago for his volunteer spirit.

In closing, the proclamation directed James O'Donnell to begin enjoying each and every day of his retirement under the direction and supervision of his wife Alice, visiting his children and grandchildren often, driving and showing off his antique cars, responding to fire calls and spending many quiet and relaxing evenings side by side with Alice in his home out east.

Dan Maddock read a humorous presentation he had written. He commented in earnest that "Jim knows the people of the Village, he cares about the Village and showed it in the job he did.... He was the first on at the garage in a snowstorm and the last one to leave. He enjoyed being out in the action..." The Public Works Department and the entire Village will miss him. In closing, Dan did a humor-

ous take off on Jim's Irish heritage claiming he is "The O'Donnell" leader of the O'Donnell clan and that we all recognize him as "King of Public Works.... We thank him for his service to the Village and wish him happiness in his two remaining castles and a long and healthy retirement."

Sea Cliff Beautification President Sally Davies thanked Jim for all his help to Beautification and presented him with a lovely plant. Village Code Enforcer Deacon Ted Kolokowski spoke of Jimmy's efforts in the Village and in jest presented Alice O'Donnell with a bottle of wine.

### Family Comments

Seeing everyone else speaking, Jim's adorable little grandson Matthew asked to speak. He told everyone about his grandfather who helps him with his baseball practice, "he comes to my house and is nice to him, and so is Alice O'Donnell," said Matthew.

Jim's son Sean, speaking for his family said his parents will be celebrating their 50th wedding anniversary. "It was great growing up in a house with parents that truly loved each other..." When he and his brothers were growing up his dad would take them to work, he would let them drive the trucks and operate the machines, "always teaching us and showing us." When his dad came home from a hard day at work, he would get out of his truck and start playing ball with us no matter how tired he was. He coached Little League every year and never missed a game. "As we got married and bought houses, he was there helping us to move or fix up our houses." Sean went on to say after he and Timmy joined the fire department, when the whistle blew, they could never beat their father out of the house.

Sean said he treats his grandkids with the same love and care he showed him and his brothers, and now attends their games. .

To sum up Jimmy O'Donnell, said Sean, "he's a man that always gets the job done, no excuses, a man that always puts others before himself."

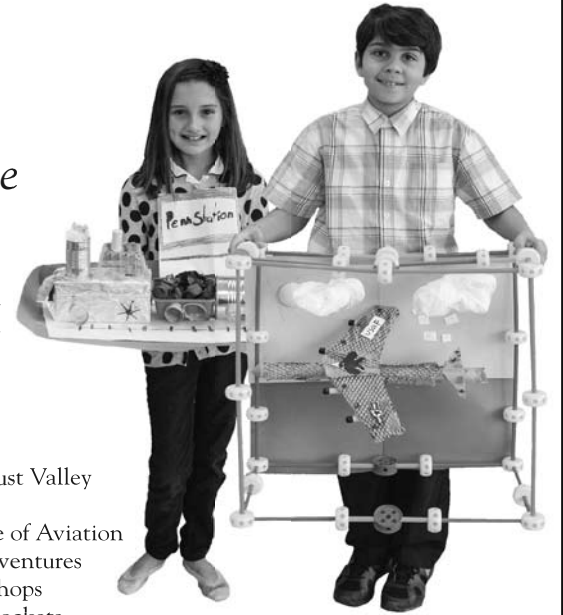

## Glen Cove Parks & Recreation Instructional Teeball Program

The City of Glen Cove Parks & Recreation Department is sponsoring an Instructional Teeball Program For boys and girls ages four and five not yet attending kindergarten. The program will be held at Landing School on Saturday mornings from April 27 through June 1. The program, which is in its 12th season, is run in a clinic format with rotating skill stations, not game play.

The 2013 program will likely be held in two sessions, depending on final enrollment numbers:

9:15 -10:15 AM and 10:30 – 11:30 AM. Children will be grouped according to age. Parents will be notified by mail which session their child is in one week before the program begins. Glen Cove residency is required and children must have a birth date between December 1, 2007 and November 30, 2008 to participate. There will be no exceptions.

There is a registration fee of \$35.00, which includes a uniform. Children should bring their own glove labeled with their name. Cleats and other equipment are not necessary. # Enforcing underage drinking laws in Glen Cove



New York State's Office of Alcoholism and Substance Abuse Services (OASAS) held the 2013 Prevention, Law Enforcement and Coalition Conference at Barnard College in New York City on March 21, 2013. Dr. Sharon Harris and Sgt. Christopher Ortiz of SAFE Inc.'s PRIDE Project Coalition were invited again to discuss their collaborative successes with the implementation of environmental prevention activities through the Enforcement of Underage Drinking Laws Program (EUDL).

Through the EUDL grant, the Coalition and the Glen Cove Police Department have been able to partner to increase law enforcement efforts, while also providing informative media campaigns and increased public prevention education. Policing efforts include shoulder tap drills, the use of underage decoys, and the implementation of Social Host party patrols at times that are high risk for underage drinking, such as prom and graduation season.

Through the use of these environmental strategies, the PRIDE Coalition and the Glen Cove Police Department have been able to decrease the availability of alcohol to youth and teens in Glen Cove. According to the 2010 BACH Harrison Prevention Needs Assessment 3.9 percent of 6th graders reported binge drinking in the last two weeks, 14.9 percent of 8th graders reported binge drinking in the last two weeks, 40.5 percent of 10th graders reported binge drinking in the last two weeks, and 43.2 percent of 12th graders reported binge drinking in the last two weeks. The 2012 BACH Harrison Prevention Needs Assessment revealed a decrease in binge

drinking across all grades; 1.0 percent of 6th graders reported binge drinking in the last two weeks, 5.9% of 8th graders reported binge drinking in the last two weeks, 27.4 percent of 10th graders reported binge drinking in the last two weeks, and 39.1 percent of 12th graders reported binge drinking in the last two weeks. Although significant strides have been made in decreasing binge drinking across all grades, 10th and 12th graders in Glen Cove still exceed the national average.

The PRIDE Coalition showcased their accomplishments, including the SAFE Inc. public service announcement, anonymous Social Host Hotline public prevention education events, vendor compliance statistics for the sale of alcohol, and social host violation statistics as of March 2013.

"The partnership between SAFE, Inc. and the Glen Cove Police Department is the key to making sustainable change regarding alcohol in our community," stated Dr. Sharon Harris, SAFE Inc. Executive Director and PRIDE Coalition Co-Chair. "By utilizing environmental strategies, we have been able to change social norms pertaining to alcohol, paving the way for a safer Glen Cove. We are grateful to have had the opportunity to utilize the EUDL funds to accomplish this goal."

# PUBLIC NOTICE

A Local Law To Amend The City Of Glen Cove Zoning Ordinance To Establish Vested Rights In An Approved PUD Master Development Plan In The MW-3 Marine Waterfront-3 District, And To Establish An Expiration Date For A PUD Site Plan Approval In The MW-3 Marine Waterfront-3 District Local Law No. 1 for the year 2013 Section 1. Purposes.

The City Council proposes to establish vested rights in an approved Planned Unit Development ("PUD") Master Development Plan in the MW-3 Marine Waterfront-3 District located on the south side of Garvies Point Road and Herb Hill Road, and including the portion of the approved PUD Master Development Plan for the RXR Glen Isle Mixed-Use Waterfront Development Project located on the north side of Garvies Point Road and Herb Hill Road. The City Council also proposes to establish an expiration date for a PUD Site Plan Approval in the MW-3 Marine Waterfront-3 District. This local law would amend the MW-3 District regulations to create such vested rights and expiration date.

Section 2. Section 280-73.2 of the City of Glen Cove Zoning Ordinance, entitled "MW-3 Marine Waterfront-3 District" is hereby amended by adding the provisions set forth below, and shall read as follows:

280-73.2(C)(3)(d). Vested Rights.

[1] Legislative Intent and Findings. The implementation of a PUD Master Development Plan often involves a multi-year build-out following substantial investment in the land use approvals process. This vested rights regulation is enacted with the intent of providing a reasonable balance between the expectation and desire of private applicants/property owners seeking to implement an approved PUD Master Development Plan to know that zoning and other applicable laws and regulations will not change during the project build-out period, and the right of the present and future City Council to enact and apply zoning amendments and other planning and environmental regulations when the public health, safety, or general welfare requires. The City Council finds that it is necessary and desirable, as a matter of public policy, to provide for the establishment of certain statutory vested rights given the practical timing, cost, phasing and other considerations involved in implementing an approved PUD Master Development Plan, as well as to stimulate economic growth and foster cooperation between the public and private sectors in land use planning. The City Council further finds that this vested rights regulation is consistent with the general principles set forth in the City's Master Plan, dated May 2009. Nothing in this section shall prohibit, preempt or otherwise prevent in any way an applicant from obtaining vested rights to complete any part of its approved PUD Master Development Plan by common law or otherwise.

[2] Vested rights.

For twelve (12) years following the Planning Board's approval of a PUD Master Development Plan in the MW-3 District located on the south side of Garvies Point Road and Herb Hill Road, and including the portion of the approved PUD Master Development Plan for the RXR Glen Isle Mixed-Use Waterfront Development Project located on the north side of Garvies Point Road and Herb Hill Road, and subject to the extension provisions below, an applicant, or its successor(s) in interest, shall retain vested rights to undertake and complete the development shown on said PUD Master Development Plan, and under the terms and conditions of all relevant approving resolutions and SEQRA Findings. All City local laws, ordinances, and enactments, and all other City zoning, planning, and environmental rules, requirements or regulations, which are in effect at the time of the Planning Board's approval of a PUD Master Development Plan, shall remain applicable to said approved PUD Master Development Plan for twelve (12) years, except when there is (i) newly discovered information or a change in circumstances establishing that the project or any portion thereof is likely to materially harm or endanger the public health, safety, general welfare or biological habitat if the project were to proceed as contemplated in the approved PUD Master Development Plan, and that such harm or endangerment would not be prevented by existing laws, codes, ordinances, rules or regulations, or by any governmental entities, as determined by the Planning Board in its sole discretion, which determination shall be set forth in writing and shall be deemed a final agency action, or (ii) a change in supervening Federal or State laws, rules or regulations, which would materially and adversely affect said development as contemplated in the approved PUD Master Development Plan. In the event that a vesting exception set forth in (i) and/or (ii) above is implicated, said exception shall relate only to the portion or aspect of the development affected by the newly discovered information, change in circumstance or new law, rule or regulation, and the vesting protections provided herein shall continue with respect to any portion or aspect of the development not affected by the newly discovered information, change in circumstance or new law, rule or regulation. A vested property right is not a personal right, but shall attach to and run with the applicable property. The twelve-year vesting period shall not be extended by any amendments or modifications to the PUD Master Development Plan unless expressly provided by the City Council.

[3] Status Report.

An applicant that has retained vested rights hereunder shall submit annually to the Planning Board, City Council, Glen Cove Industrial Development Agency, and Glen Cove Community Development Agency, a written Status Report describ-

ing the progress of the development of the approved PUD Master Development Plan. Such yearly Status Report shall be submitted not sooner than thirty (30) days, and not later than fifteen (15) days, prior to each anniversary of the Planning Board's approval of the PUD Master Development Plan.

[4] Rescission.

[a] Following the Planning Board's approval of a PUD Master Development Plan, the Planning Board shall evaluate periodically the progress of the development of the PUD Master Development Plan, and shall have the right to rescind any vested rights retained hereunder through approval of a PUD Master Development Plan for a particular applicant at any time if the Planning Board finds in a written determination supported by substantial evidence that the applicant's actions or inactions with respect to developing the approved PUD Master Development Plan constituted extreme or egregious unreasonableness under a rational commercial person standard.

[b] The City Council may, by a duly adopted resolution, make a referral to the Planning Board to notify the Board of a potential basis to rescind any vested rights retained hereunder. The Planning Board shall make a written determination supported by substantial evidence regarding whether rescission is warranted in accordance with the standard set forth in subsection [a] above. The Planning Board's determination shall be made within sixty (60) days after referral from the City Council, unless said time period is mutually extended by the City Council and Planning Board.

[5] Extension.

Upon the expiration of the aforementioned twelve-year period or any time prior thereto, the City Council shall have the right in its discretion to adopt a resolution extending the vested rights retained hereunder based upon the applicant's good faith efforts in completing the build-out of the PUD Master Development Plan. Notwithstanding anything to the contrary in this section, the vested rights retained hereunder shall be extended automatically for the amount of time equal to any material delay in the City's completion of any major public infrastructure work, environmental re-

mediation or any other obligations required for the PUD development that the City or any of its agencies is responsible for completing pursuant to any agreement concerning the PUD development, provided that the delay was not caused by the actions or inactions of the applicant.

[6] Expiration of PUD Master Development Plan Approval.

Nothing herein relating to vested rights shall be deemed to modify or alter in any way the expiration date of a PUD Master Development Plan Approval, or the Planning Board's right to grant an extension of said Approval, as provided for by law.

[7] Applicability.

This Section shall be applied only to PUD Master Development Plans approved by the Planning Board in the MW-3 District located on the south side of Garvies Point Road and Herb Hill Road, and including the portion of the approved PUD Master Development Plan for the RXR Glen Isle Mixed-Use Waterfront Development Project located on the north side of Garvies Point Road and Herb Hill Road.

Section 3. Section 280-73.2(C)(3)(c)[11] of the City of Glen Cove Zoning Ordinance is hereby amended by adding the provisions set forth below, and shall read as follows:

[g] Approval of a PUD Site Plan by the Planning Board shall expire eighteen (18) months after the date of the PUD Site Plan Approval. The Planning Board shall extend the duration of the PUD Site Plan Approval period for additional six-month periods, without limitation, if an applicant demonstrates that it is proceeding in good faith to develop its property in accordance with the PUD Site Plan Approval.

Section 4. Severability.

The invalidity of any word, section, clause, paragraph, sentence, part or provision of this local law shall not affect the validity of any part of this local law which can be given effect without such invalid part or parts.

Section 5. Effective Date.

This local law shall take effect immediately upon its filing in the Office of the Secretary of State.

"The Man From U.N.C.L.E.", intended as a vehicle for Robert Vaughn, made McCallum into a sex-symbol, his Beatle-style blonde haircut provided a trendy contrast with Vaughn's traditional appearance. Although the show aired at the height of the Cold War, McCallum's Russian alter-ego became a pop culture phenomenon. He did several stage productions in Europe and Australia, documentaries and various small TV appearances. He never quite repeated the popular success he had gained as "Kuryakin" until "NCIS". According to the behind-the-scenes feature on the 2006 DVD of "NCIS" season, McCallum became an expert in forensics to play "Mallard" including appearing at M.E. conventions. In the feature, producer Bellisario says that McCallum's knowledge became so vast that at the time of the interview he was considering making him a technical advisor on the show. In an inside joke "NCIS Agent Leroy Jethro Gibbs" (Mark Harmon) is asked, "What did Ducky look like when he was younger?" "Gibbs" responds "Illya Kuryakin". In late April 2012, it was announced that McCallum had reached agreement on a two-year contract extension with CBS-TV. The move means he would remain an "NCIS" regular past his 80th birthday!

This week's celebrity was an American actor and artist. He was a Native American Muscogee (Creek) and was born in Okmulgee, Oklahoma. 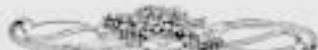

## Keep lines of communication open to stop bullying SAFE, Inc. Parent University at Gribbin School well attended

SAFE, Inc. led a Parent University presentation on Bullying Prevention at Gribbin Elementary School on January 16th as part of a joint Gribbin-Connolly PTA Meeting. Robin Mead, a licensed social worker and SAFE, Inc's Parent and Life Skills Coordinator and SAFE's Coalition's Parent Committee Chair Laurent Caballero shared the presentation with parents and teachers.

Mead began by discussing the Dignity for All Students Act (DASA), which was created to prohibit harassment of students by other students and district personnel. The law's five areas of regulation include: the creation of school policy and revising the code of conduct, providing for school employee training, the appointment and training of a Dignity Act coordinator, an annual reporting of information to state and notifying students and parents utilizing the district's website, mail, evening events, and open houses.

This was followed by a video, Bullying What Every Parent Needs to Know. The purpose of showing the video was to make parents and teachers aware of the current bullying trends and to share what other parents and teachers are doing to address this.

Mead and Caballero presented a power point presentation as well about the facts regarding bullying and answered questions from parents.

"The main concerns were how to handle ongoing instances of bullying. One parent said their child had been bullied for over a year" said Mead.

Caballero said she believed the bullying presentation was very valuable to teachers but especially to parents. "Some of the parents appeared to be in shock when they heard stories from other parents in the meeting about bullying," she said.

Mead and Caballero discussed the subtleties of bullying from "friends" and the emotional drain that takes its toll on kids who are bullied daily. They discussed the different types of bullying from the physical to the emotional and defined exactly what bullying is not.

"My goal was to open up the discussion about bullying and to make parents aware of what they can do, and I encouraged them not to let it go and brush it off as kids will be kids," said Mead. "It's important to keep the lines of communication open."

Caballero agreed adding that she hopes to bring the workshop to everyone

in the community, especially to children and the staff at schools. "I think it would be very helpful to all of them," she said. "Children should hear the stories directly from those who have been there."

The Parent University Presentations are being led by SAFE's Coalition's Parent Committee to address the findings of the Bach-Harrison Prevention Needs Assessment Survey given by the Glen Cove School District to students in grades 6, 8, 10, & 12 in January 2012. The survey assessed the use of alcohol, marijuana, tobacco and other negative behaviors.

The next Parent University will be on Bullying Prevention at Connolly Elementary School on Tuesday, March 19 at 7:30 p.m. All parents and caregivers are welcome to attend to understand their role in preventing and responding to bullying.
