

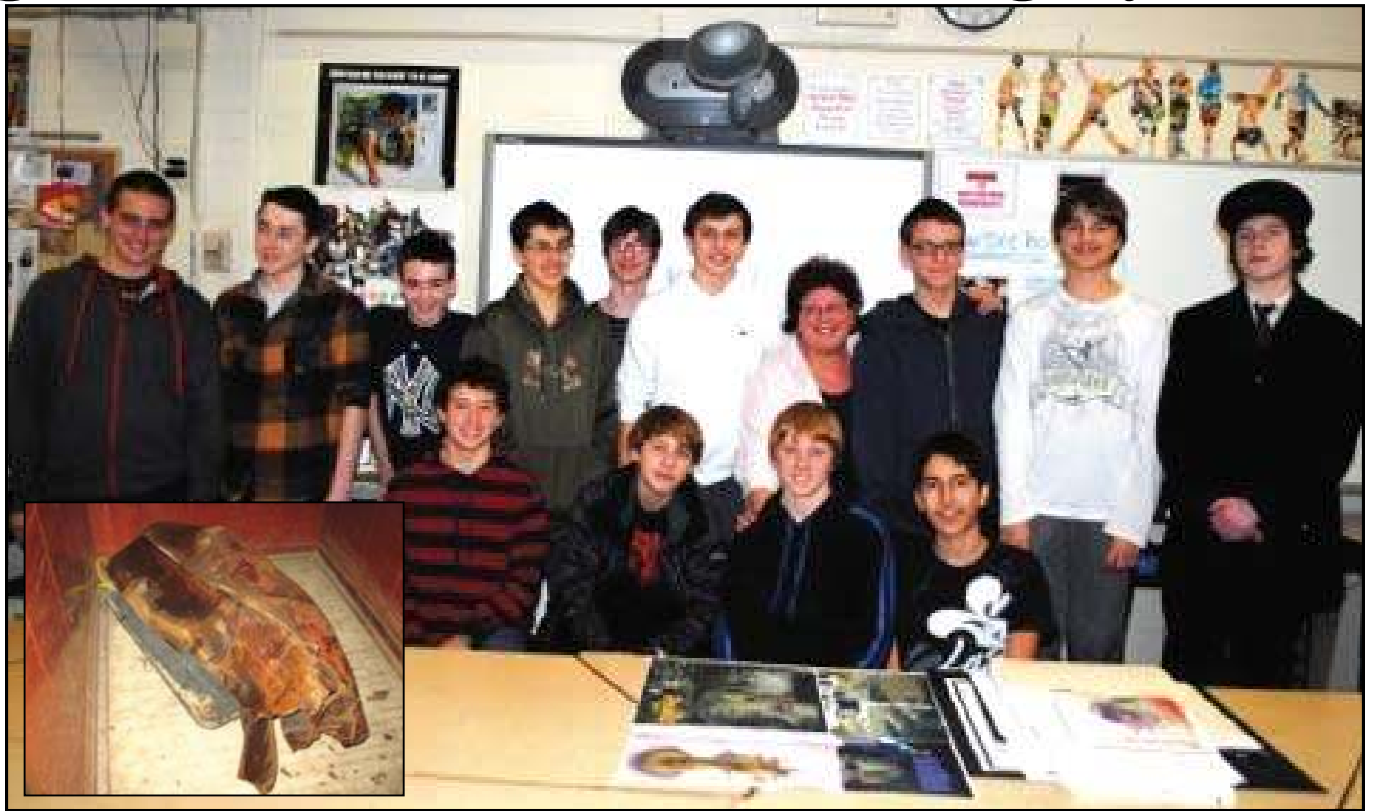

Ninth graders in Laura Green's Design and Drawing for Production classes at North Shore High School recently utilized interdisciplinary skills including art, traditional and digital design, math, architectural drawing, and public speaking to design a base for an artifact from the World Trade Center. Yes, the actual World Trade Center! But, that is not all! The students also had to design a memorial site in the back of the high school (near the School House) that would incorporate the artifact and be an inviting location for the North Shore community to visit.

## 9th Graders Design World Trade Center Memorial Site Utilizing an Artifact from the 9/11 Tragedy

### The Artifact:

In January 2013, teacher Dr. Rob Gerver was able to get the artifact from the Port Authority after many months of discussions. The artifact is 69 inches long and weighs about 400 pounds. It is a twisted piece of a box beam that was a window frame of the World Trade Center. Dr. Gerver said, "We need to preserve this special artifact so it doesn't erode; as a piece of American History, it has a chance to be around for hundreds of years!" Upon its arrival to the North Shore Schools, students engaged in many discussions about the tragedy of 9/11 since they were very young when the actual events took place.

### The Lesson Objective:

"In this project, my students explored their knowledge of the design process," said teacher Laura Green. "They utilized drawing and computer software skills to create a 'student' design project with a real-life application." She added, "Interdisciplinary projects like these got my students excited about applying lessons learned in the classroom to real-world situation."

To begin the project, 9th graders researched the World Trade Center Memorial, Memorial Parks as well as common building materials including I-beams and Lally columns. Additionally, students were required to do the following:

- 2 thumbnail sketches (of the base design)
- 2 Isometric drawings (3D)
- 1 finalized drawing consisting of the memorial base and site
- 1 site plan (to-scale) for the location/materials used on the memorial site
- 1 digital file of all the parts utilized in their design (e.g., 69" by 22" by 26" box beam, three I-beams or Lally columns, a bronze plaque, etc.)

• 1 digital color assembly of their base design utilizing the Autodesk Inventor computer software program

• 1 Power Point presentation for judges to review their work

To create the design of the memorial site, students had to measure the dimensions of the entire location behind the high school including: the walls, rock, tree to rock, rock to door/walkway, and bench. As a constraint, the space needed to be delineated from the rest of the school grounds.

### Judging of Design:

Upon completion, all of the designs will be judged and the winning design (or design parts) will be utilized to create a historic World Trade Center Memorial Site located on the North Shore High School campus for everyone in the community to visit for many years to come.

Ms. Green concluded by saying, "Overall, the project was very successful in achieving significant learning. As I observed my students during their final presentations to our faculty and administration, I felt a real sense of pride and accomplishment for them."

## SAFE attends PTA Council Meeting sharing youth drug and alcohol findings *Gorman encourages parents to be proactive with their children*

SAFE Inc., brought the latest data gathered from the Jan. 2012 Bach Harrison Prevention Needs Assessment Survey administered by the Glen Cove School District to students in grades 6, 8, 10, & 12 to assess the use of alcohol, marijuana, tobacco and other drugs by Glen Cove youth at a recent PTA Council Meeting on April 16 at Glen Cove High School. Dr. Bernard Gorman, Research Psychologist, spoke to parents about these findings.

The Bach Harrison Prevention Needs Assessment Survey is one avenue SAFE, Inc. utilizes to support the efforts of the PRIDE Project Coalition to eliminate drug and alcohol abuse among Glen Cove youth. Funded by a Drug-Free Communities Support program federal grant, the survey is used to gauge the effectiveness of the Coalition's efforts and to remain cognizant of the areas that need to be addressed. The Drug-Free Communities Support Grant requires that

the Prevention Needs Assessment be administered every 2 years; the Glen Cove PRIDE Project Coalition will again partner with the Glen Cove School District in administering the Prevention Needs Assessment in the coming January of year 2014. The Coalition is composed of four Committees, School, Youth, Community and Parent, each with their own respective charge to address the needs assessment findings at school and in the community.

Gorman shared the following:

Across the board there has been an increase in student's beliefs that alcohol is harmful;

Alcohol continues to be the substance of choice for Glen Cove's youth as 6th graders are using alcohol earlier, from age 11 in 2010 to age 10 in 2012.

This trend continues through the 8th and 10th grade.

12th graders said they began drinking at 14, the same age the onset was reported in the 2010 survey.

Tobacco use has increased across all grades tested

Marijuana use is higher than the national average among Glen Cove 10th graders.

For all grades the combined prescription drug use decreased from seven percent in 2010 to three percent in 2012.

## Oblivion

Rated PG-13 (Sci-fi action violence, brief nudity)

Stars: Tom Cruise, Morgan Freeman, Olga Kurylenko

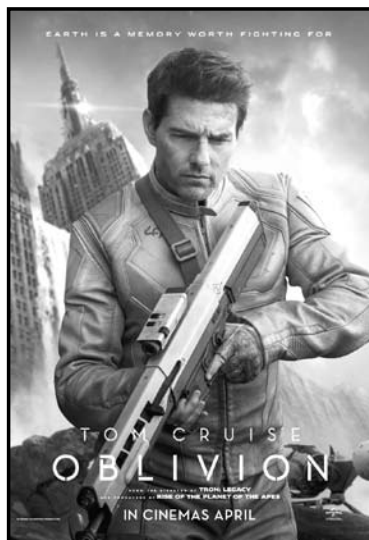
When a movie is equipped with an arsenal of high class special effects, A-list actors, a promising plot and present day significance, its shortcomings are exponentially more disappointing than if it was doomed from the start. Oblivion, the latest Tom Cruise vehicle, flaunts many impressive qualities instead of utilizing their full potential. This movie is a prime example of how a lack of cohesion can prove to be the greatest downfall, masked by the presence of an acclaimed action star to up the chances of financial success.

Cruise is Jack Harper, a technician who is one of few humans permitted to walk the earth in the year 2077. He explains the damage that has left our planet nearly uninhabitable. Sixty years prior, humans waged war against a colony of supposed aliens known as Scavengers or "Scavs." The most disastrous result of the battle was the destruction of our moon, bringing about devastating natural disasters. Seeing no other option the humans resorted to nuclear weaponry. As Harper relates gravely, "We won the war, but lost the planet."

Now, with the remaining humans colonized on the Saturn moon Titan, most of earth is a wasteland populated by the scavengers and regulated by armed drones. It is Harper's job to visit the planet when a drone is in need of repair, with the guidance of his partner and lover Victoria (Andrea Riseborough). His routine is suddenly shaken by the crash landing of a spacecraft. Against orders Harper inspects the wreckage, amongst which is a survivor by the name of Julia (Olga Kurylenko).

After continuously stalking Harper the Scavengers finally make contact with him and Julia. What their leader Beech (Morgan Freeman) asks of Harper rattles everything he thought was true and forces him to question his alliances.

Directed by Joseph Kosinski with the same visionary flare seen in his previous work TRON: Legacy, we are treated to vast and startling images depicting the ruins of our future. In terms of a proper story however, Oblivion falls short. Af-



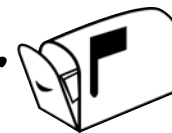
ter an exceptional first act, the details begin to muddle and by the end there are innumerable questions left unanswered. What makes this ever more frustrating are the flickers of brilliance scattered throughout. For instance, playing off of our current and very real fears of armed drones added an alarming touch of realism. Though these drones would have been more disconcerting had they better resembled advanced military technology instead of machinegun wielding Pokémon.

Cruise effortlessly carries the movie, showing off some well-done combat in a number of high intensity action scenes. Olga Kurylenko on the other hand is just as blank as her poorly developed character. This is when she is actually awake, as her character is frequently unconscious. Not much was required of Morgan Freeman, only that he show up with a condescending smile and wear a ridiculous cape.

Kosinski based this movie on his unpublished graphic novel of the same name, reportedly paying homage to science fiction films of the 1970's. Technically speaking, he achieved his goal. Oblivion borrows from a multitude of movies spanning various decades, from 2001: A Space Odyssey to Star Wars to I, Robot to WALL-E. There is not a single original idea here, which could be detrimental in the long run considering the numerous upcoming likeminded films being released within a short time span. Still, the dearth of originality is not automatically a flaw. At first these ideas, while not groundbreaking, are presented in an innovative and thrilling manner. If only this had not faded.

### Cluster-Flush

To the editor,

I read "Will Sewers Save the Beach?" by Jill Nossa in the April 12, 2013, current issue of the Record Pilot with great interest. It makes fascinating reading about a mucky subject. Thank you!

Last spring I visited Mayor Suozzi's office to discuss the contamination of Crescent Beach. I was impressed to see that his office was at the hub of a multi-agency effort to reduce the pollution and reopen it for public wading and swimming.

Since that time I have communicated with NY Assemblyman Charles Lavine, Glen Cove City Councilman Anthony Gallo, and Nassau County Representative Delia DeRiggi. I learned that the problem is not an easy fix. There are seventy properties in the area around Crescent Beach that are not connected to Glen Cove's sewer system. As Representative DeRiggi explained to me, some of the larger and older properties have many old cesspools that have been inactive for years and some of the owners don't even know where they are located. They may be leaching toxic waste and overflowing into LI Sound.

Mayor Suozzi explained to me that he has been offering free pump-outs to these residents every year, at the City of Glen Cove tax payers' expense. He reported that some homeowners refused the freebie and claimed it was a violation of their civil rights for the city to investigate their properties with intent to remedy derelict cess pools.

Now we are considering plans to hook up our sewer system to these seventy properties, assuming that all the property owners would allow it. It would ameliorate that portion of our problem to some great degree, that problem being the overflow of fecal human waste from active cell pools. But it would not reduce the biological hazard from uncounted overflowing and leaching systems on our larger properties and estates.

I commend our public officials and environmental groups for generating political will to reduce raw sewage contam-

ination of Crescent Beach and reopen it for public recreation. But is hooking up these private properties to our public sewer system at taxpayer expense the right thing to do?

Paying just for the seventy properties in Glen Cove, has been estimated to cost \$3.5 to \$5 million. The average cost would be \$70,000 per property, and politicians suggest that it all be paid with taxpayer dollars.

An experienced septic engineer claimed that state of the art septic systems are much better than old cess pools. He claimed that they are even better than sewers and better than municipal waste treatment facilities like Glen Cove's. Septic systems are best for cleaning up the waste and preventing pollution. They don't require public investment and their cost to property owners would be about the same as a new roof, \$5000-\$8000. The entire project for seventy properties would cost \$500,000. That is 10% of the cost to do a better job at solving the problem than the proposed sewer project.

These proposals need to be analyzed and compared.

Glen Cove cannot seem to pay its bills without borrowing. Taxes are already too high and rising. It would seem that upgrading the septic systems would be a more prudent, efficient and environmentally friendly solution.

State Assemblyman Charles Lavine advised me that a simple ordinance passed by the Glen Cove City Council might suffice to bring our seventy unconnected neighbors into compliance and prevent them from further polluting our public waters. It has already been done successfully with great savings in Connecticut.

Other water front communities sited in the article, Sea Cliff and Locust Valley might follow Glen Cove's and Connecticut's examples. A similar ordinance passed by Nassau County's assembly could broaden the scope of the clean up. This would prevent more wasteful spending of taxpayers' dollars and avoid further degradation of our public waters.

### Last Week's Celebrity

Gertrude Maud "Binnie" Barnes was last week's celebrity. She did 26 comedy shorts with Stanley Lupino which led her to playing Catherine Howard in Charles Laughton's 1933 film, "The Private Life of Henry VIII". A year later she had a part in Douglas Fairbanks' "The Private Life of Don Juan" (1934). Carl Laemmle Jr. brought her to Hollywood where she played in more than 75 films including "Diamond Jim" (1935) with Edward Arnold. In 1940, she married UCLA football star and later Columbia Studios producer, M.J. Frankovich. They moved to Italy after WWII where she made more films. She returned to Hollywood in the 1960's playing in TV series and as "Sister Celestine" in the two Rosalind Russell "Angels" movies. Her last film was "40 Carats" (1973) starring Liv Ullmann and Gene Kelly. Her husband died in 1992 and she died six years later, aged 95 and was survived by two sons and one daughter.

This week's celebrity was an American actor born on Jan. 31, 1921 in Chicago, Illinois. Following his father's death, he and his family moved from Chicago to Los Angeles. During WWII, he served as a sergeant and physical instructor in the Army Air Corps and received an honorable discharge in 1946. His marriage to a prominent movie star put him in the public eye for the first time and a seven year movie contract with independent producer David O. Selznick quickly ensued. He starred alongside John Wayne in the films "Sands of Iwo Jima" (1949), "Fort Apache" (1948), and "She Wore a Yellow Ribbon" (1949). He was later relegated to B movies such as "Tarantula", "The Mole People" and "The Brain from

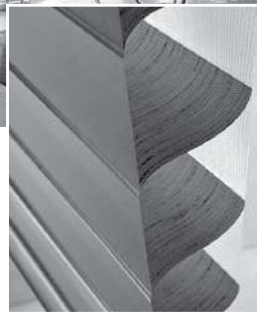

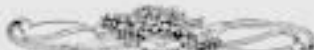

into every ground ball they see. Whether they come up with it or not, these young Knights keep scrapping until the final whistle!

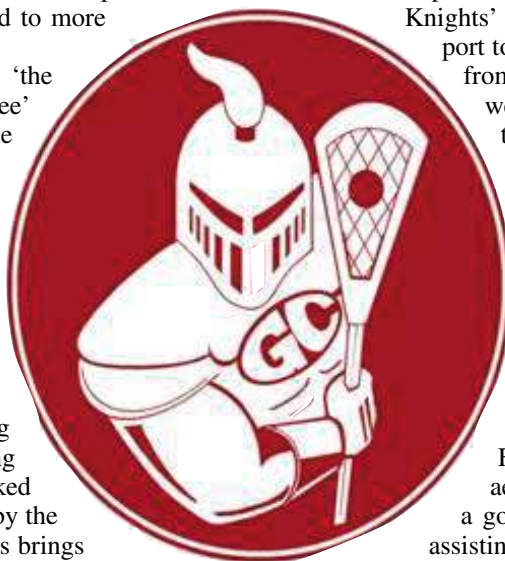
