

## Glen Cove PD Takes \$60K of Drugs Off Street

On May 3rd Detective lieutenant John Nagle began an investigation regarding a possible drug shipment coming into Glen Cove. The shipment was tracked to the UPS pickup/drop-off site on Brewster Street in Glen Cove. Later that day three individuals arrived at that location ( Mail Boxes Etc 5 at 5 Brewster Street ) to pick up their delivery. Once there, the three individuals proceeded to load the packages into their vehicle. As the defendants began to drive away they were pulled over by police and were arrested. The boxes were recovered from the trunk of their vehicle. The boxes contained approximately 43 pounds of marihuana with a street value between \$50,000-\$60,000. Over \$2,000 was also recovered during the arrest. The three individuals were each charged with Criminal Possession of Marihuana in the First Degree, a class "C" felony. The arrested persons are as follows; Voncliff Bish 45 years old from Mount Vernon NY, Damion Cox 31 years old from Jamaica Queens, Devon Wheatley 50 years old from the Bronx. All three defendants were arraigned in First District Court in Hempstead on May 5th and were each held on \$20,000 bail.

## A Message from the North Shore Schools Board of Education 2013-14 School Budget Is Within The Allowable N.Y. State Tax Levy Limit

Our schools have been recognized as among the best in the country for the excellent achievements of our students in academics, the arts, and athletics.

In January, we agreed to stay within the N.Y. State cap on the allowable tax levy limit, needing approval of a majority vote to pass. The adopted budget for 2013-14 (Proposition 1) represents a 3.84% increase from last year.

Under N.Y. State legislation, if the community fails to pass a budget twice, the district by law will be forced to adopt a budget with the same or lower tax levy as the previous year - essentially a zero percent cap. This will result in cuts of almost \$3 million from the 2013-14 Budget Proposal affecting positions and programs.

Additionally, Trustees were very active in Albany this March 2013. As a first step towards a solution to the loss of the tax base as it relates to the LIPA power plant, the school district will receive an allocation of \$2.5 million from the State.

It is imperative for all of our community members to learn the facts and stay involved. Please attend upcoming Board meetings and Budget Coffees. The Budget Vote/Election of Trustees is on Tuesday, May 21, in the North Shore

## Nature Nick Visits Glen Head School on Earth Day

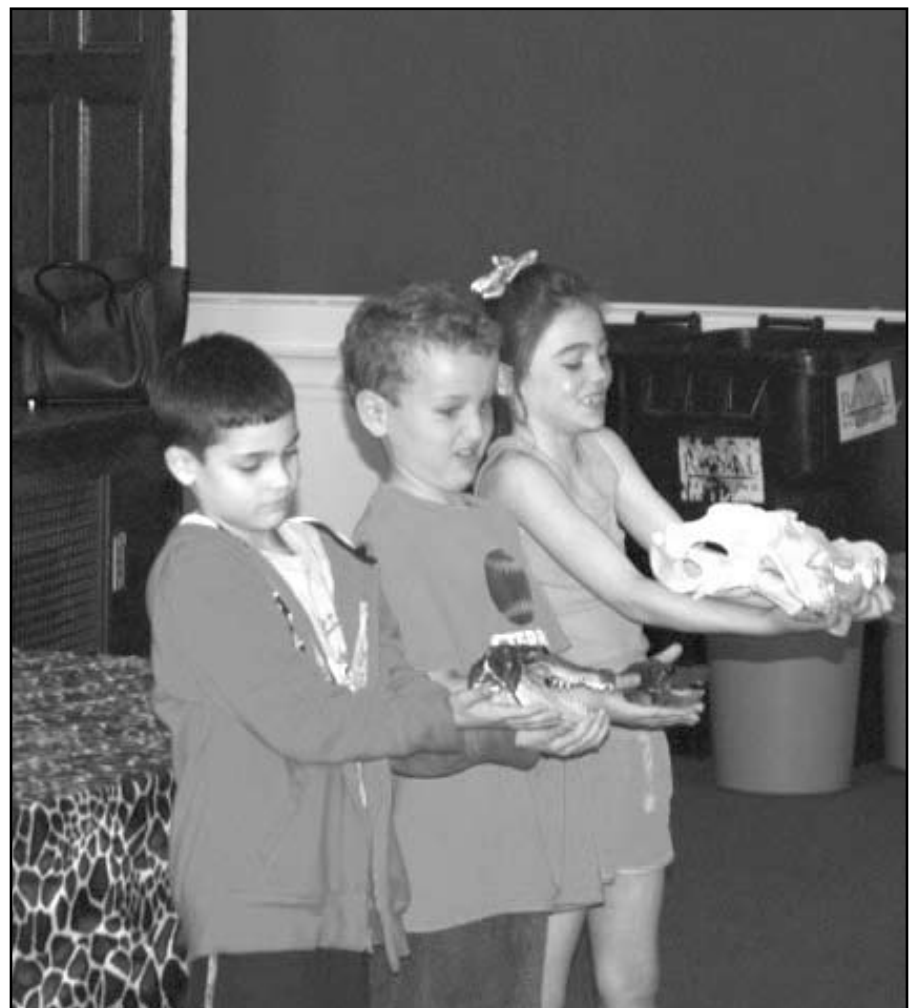
To help celebrate Earth Day on April 19th, students and faculty had a special treat when Nature Nick and his exotic animals paid a visit Glen Head School.

## Apples Prior to the ELA Tests at NS Middle School

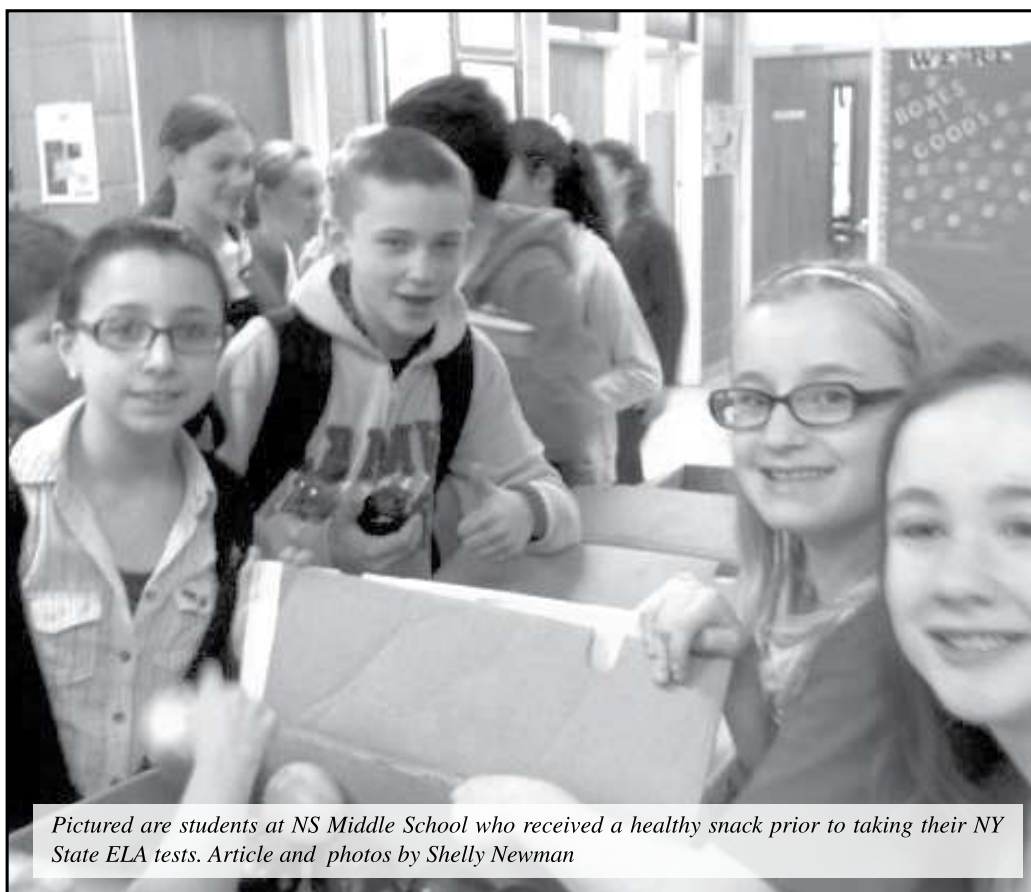

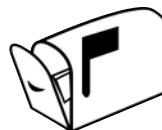
## Support Russo-Manning and Nightingale for NS Board of Education Trustees

## What A Difference A Day Makes

### To The Editor,

As the avalanche of campaign signs attest, six candidates are vying for three openings on the North Shore School Board and they all fielded questions during Meet the Candidates Night. I had the privilege to serve two terms on the North Shore School Board from 2002 to 2008, so I know what it is like to run for local office. While I applaud all the candidates for stepping forward, only two of the five non-incumbents demonstrated the knowledge, temperament and communication skills required of a school board trustee - Sara Jones and Tim Madden.

Tim, a social studies teacher at Great Neck South High School, served on the Northport-East Northport School Board before relocating to our district with his wife and three children. His comments were direct, substantive and clearly stated. Given his 23-year experience in the classroom and his prior school board experience, Tim would bring an invaluable perspective to discussions pertaining curriculum, budget and the ongoing battle to ensure that state-mandated

testing requirements do not overwhelm true learning.

Sara, the mother of a kindergartener and a 4th grader, is a graduate of Princeton University and a successful business-woman. Having raised millions of dollars for Citymeals on Wheels, Sara then applied her organizational and financial skills to revitalize the Viking Foundation. Like Tim, she is a strong and articulate advocate for public education and fears that mandatory testing is crowding out other important subjects. I could not agree more.

Michael Nightingale seemed like a nice man, but some of his statements were chilling. When asked about teacher assessments, he said that teachers should not be judged based on whether they have a "good" class or a "bad" class. While grades will always vary in a classroom, the notion that children should be labelled in this way was troubling and revealed either a lack of understanding or a lack of communication skills. He also denied signing a petition encouraging others to vote down the school budget if Italian was made an elective. What he did not say is that he circulated that very petition far and wide and helped to form the self-proclaimed "Reform Group" that drafted it. There is already far too much brinksmanship in our national politics. We can do better.

Marianne Russo also seemed nice enough, but her comments lacked depth or clarity. She is a lawyer with a specialty in commercial and residential real estate - areas largely unrelated to anything that would reasonably come before the school board. And her alignment with Mr. Nightingale suggests either that she shares his views or did not do sufficient due diligence to distance herself from them. She returns for a second try at election following last year's defeat. She did not say much to improve her chances this time around. Since only one incumbent is in the running, this election cycle will definitely bring new faces and new voices to the North Shore School Board. For me, the choice is clear. Vote for Sara Jones and Tim Madden on May 21st.

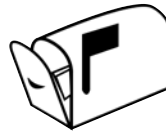

I have served on the North Shore School District's Legislative Action Committee since its inception in the fall of 2011, and have worked with the committee, the School Board and the community to minimize the financial impact of the LIPA plant decommissioning on the District. I have been a Social Studies teacher at Great Neck South High School for the past 15 years and prior to that had taught in the New York City system for 8 years. I was an adjunct professor in the Teacher Education program at Adelphi University for three years where I taught a social studies methods course and a philosophy of teaching course to graduate students about to begin their student teaching. These experiences, as well as being a parent and a taxpayer, have helped me develop a well rounded and unique perspective on public schooling that I think will be useful to the School Board and the district in confronting the many challenges that we face – both financial and educational.

The financial challenges include rapidly rising mandated costs; the decommissioning of the LIPA power plant in Glenwood Landing; and the costs that will be pushed onto the district should Nassau County win its appeal regarding its guarantee of school district tax certiorari settlements. My experiences as a school board trustee in Northport and as a member of our district's Legislative Action Committee, have allowed me to develop a solid understanding of these issues, and will enable me to effectively contribute to the development of approaches and actions to address them. In addition to confronting these outside pressures, we must of course do our best to limit costs over which we have direct control through fiscally responsible policies that will ease pressure on taxpayers, while at the same time maintaining an outstanding educational program that includes a rich variety of opportunities in athletics and the arts, and a program that is responsive to technological change. The district must therefore operate in the most financially efficient way possible. Some of the ways this can be done is through long-term planning, zero-based budgeting, and embracing technology that will lead to long-term lower costs. Other possibilities must be explored as well. At the same time, we must work with our Legislative Action Committee, other districts, outside organizations, and the New York State School Boards Association to urge Albany to transfer back to the state the cost of financial obligations and mandates that have been pushed onto local school districts.

Educationally, state imposed high stakes standardized testing is adversely impacting our students, our financial resources and our overall educational culture. In addition, the newly introduced Annual Professional Performance Review is pressuring educators across the

state to abandon meaningful instruction in favor of methods that simply train students for the test. As an educator for more than 20 years, I understand very well the differences between the teaching methods used to prepare students for a four hour exam and those methods used to prepare a student for life. At the district level, I will strongly support efforts to foster a learning culture that minimizes the impact of these new tests, and embraces high quality education that promotes creativity, innovation, critical thinking, problem solving, socialization, and a love of learning – the skills and attributes that are necessary for success in our rapidly changing society. More broadly, I strongly support the efforts to reform New York State's top-down "one size fits all" approach to education that ignores differences among school districts and students, and has had the effect of quashing innovation and creativity within the classroom.

Our school system is an excellent one. I look forward to the opportunity to work with the Board, administrators, teachers, and the community to meet both the educational and fiscal challenges facing our district today. I ask for your vote for School Board Trustee on May 21st and urge you to vote YES on the budget.

# The Glenwood Landing Power Plant: Past, Present and Future

A thought—

An opinion piece by Karin Barnaby

We must never allow ourselves or LIPA/National Grid to think that the utility has done Glenwood Landing and our larger North Shore community a favor, by being there in that prime waterfront location, just because it has paid its taxes. The taxes paid by the utility over the years cannot begin to make up for our lost real estate wealth, tax revenues and quality of life. Let us imagine that the power plant had never been there, and that those lands, pristine and picturesque, had been allowed to develop in the way all prime waterfront properties traditionally develop—giving our communities a vastly more beneficent and enduring tax base in that location—to remind ourselves that we owe nothing to LIPA or National Grid.

Quite the opposite: The time has come for the utility and the Town of North Hempstead to compensate our communities for enduring the visual blight, noise, air-ground-and-water pollution of this monstrously ugly utility in such close proximity to our densely populated neighborhoods for so many generations—immeasurably and permanently reducing area property values by virtue of its presence there. Even now, as it bails out, it leaves behind fouled lands, horrid turbines, oil tanks and high voltage overhead power cables and transmission towers.

Presently, LIPA/National Grid are poised to apply to the Town of North Hempstead for demolition permits to eliminate anything of value on the site to reduce their tax assessment. They plan to demolish the classic brick building—the utility's only attractive and redeeming feature—before proper consideration can be given to that grand structure's potential benefit to the community. Elsewhere, such monumental landmarks are increasingly being repurposed as showcase, community-oriented, commercial enterprises.

We must not allow LIPA and National Grid to demolish what is no longer useful to them, merely to reduce their own tax assessment. They have an obligation, first and foremost, to give full consideration to helping the community that they have exploited for generations. We have every reason to demand compensation and reparations from the utility and the Town of North Hempstead in the form of creating something wonderful in that location and in that building—something that will contribute to the regeneration and future well-being of Glenwood Landing and the greater North Shore community.

A vision—

Let us stop lamenting and fully embrace the demise of the Glenwood Landing (GWL) power plant as a unique opportunity for re-imagining the building and site as a fabulous, revenue-generating asset and resource for the greater North Shore community.

Just last week, The New York Times featured an article on the growing practice of successfully repurposing power plants, because their location near

water, their solid construction and their unusual size and shape make them ideal for repurposing (See "From Power Plant to Civic Renewal Centerpiece," NY Times, April 25, 2013).

Let us re-imagine the GWL plant's magnificent waterfront building and site, for example, as a revenue-generating commercial sports and recreation facility that would be a win-win-win-win for all concerned—for the tax-paying community, for National Grid/LIPA executives and investors, for political leaders and, last and most important: for area team-sports families and enthusiasts, whose demand for playing fields and sports facilities such as this has long exceeded supply.

The GWL building appears large enough to house several regulation playing fields indoors, one on top of the other, with plenty of room to spare for other recreational and arts activities. Just last year, Chelsea Piers CT launched such a facility in a residential area in Stamford, CT, completely inside a repurposed Clairrol factory, eliminating any concerns neighbors had about noise and lights in the area ([www.chelseapiersct.com](http://www.chelseapiersct.com)). The conversion took just two years to complete (See "Chelsea Piers Puts Ashore in Stamford," The Wall Street Journal, June 27, 2012).

To succeed as a viable commercial undertaking, such a facility in GWL would necessitate optimal access. In addition to existing routes from the north, south and east, a western link, from Glenwood Road across to Bar Beach and beyond, would offer total access from all directions. A short bridge, attractively designed in keeping with the GWL brick arches perhaps, with multiple lanes for accommodating strollers, skaters, bicycle riders and anglers, as well as motorists, would need no more than a single support pier (if that) to span that narrow channel. It would not block the tidal exchange and hardly disturb the sea floor.

This long overdue direct link from Hempstead Harbor's east to its west shore and to 25A and beyond, would also allow Glen Cove/Sea Cliff/ Glen Head/ Glenwood Landing commuters to bypass many miles of tortuous, narrow back roads through Roslyn Harbor and Roslyn, while easing the horrific twice-daily traffic congestion in those communities.

Imagine a generous, newly revitalized and accessible stretch of natural waterfront, plus a world-class recreational facility, housed completely inside a repurposed GWL plant. Imagine a waterfront walkway, jogging lane, skating and bicycle path, leading all the way from Sea Cliff to Pt. Washington. Imagine what a glorious asset to the North Shore, the Towns of North Hempstead and Oyster Bay and Nassau County such a facility would be in that place, where area residents, for generations, have endured the visual blight of the relentlessly ugly and polluted GWL utility.

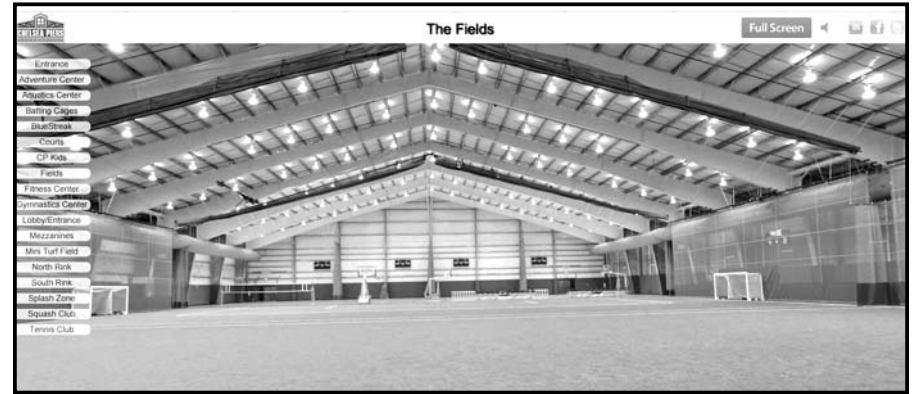
The greatest obstacle to realizing a good idea is the lack of imagination, will and courage on the part of policy makers and politicians. Let us spark their imagination and ignite their enthusiasm. Let

us remind them of their responsibility to the communities they serve. Let us insist that they find the will and courage to do the right thing, at long last, for Glenwood Landing and for the larger North Shore and Hempstead Harbor community now and for future generations.

### Last Week's Celebrity

Last week's celebrity was born Edna Mae Durbin but her many fans, including British Prime Minister Winston Churchill, would remember her as Deanna Durbin. It was also noted that her photo is, today, still on the wall of the Acterhuis, the secret quarters of Anne Frank, another fan, and her family when they hid from the Nazis during the invasion of Amsterdam. As she matured, she grew dissatisfied with the girl-next-door roles assigned to her, and attempted to portray more womanly and sophisticated roles. The film-noir "Christmas Holiday" (1944) and the who-done-it "Lady on the Train" (1945) were however, not as well received as her musical comedies and romances had been. She retired from acting in 1949 and withdrew from public life. In 1950, she married for a second time to the director of her last film, Charles David.

They moved to a farmhouse outside of Paris and had one son. David died in 1999. According to the May 3, 2013 edition of Newsday, a family friend, Bob Koster, reported that Deanna died at age 91 about April 20th, the cause not given. Koster's father was Henry Koster who directed six of Durbin's films. She is survived by her son, Peter David, and daughter, Jessica Jackson, from a previous marriage.



Fee for this year's summer program is \$350.00 for 6 weeks and a payment plan is available with 4 payments for those who need it.

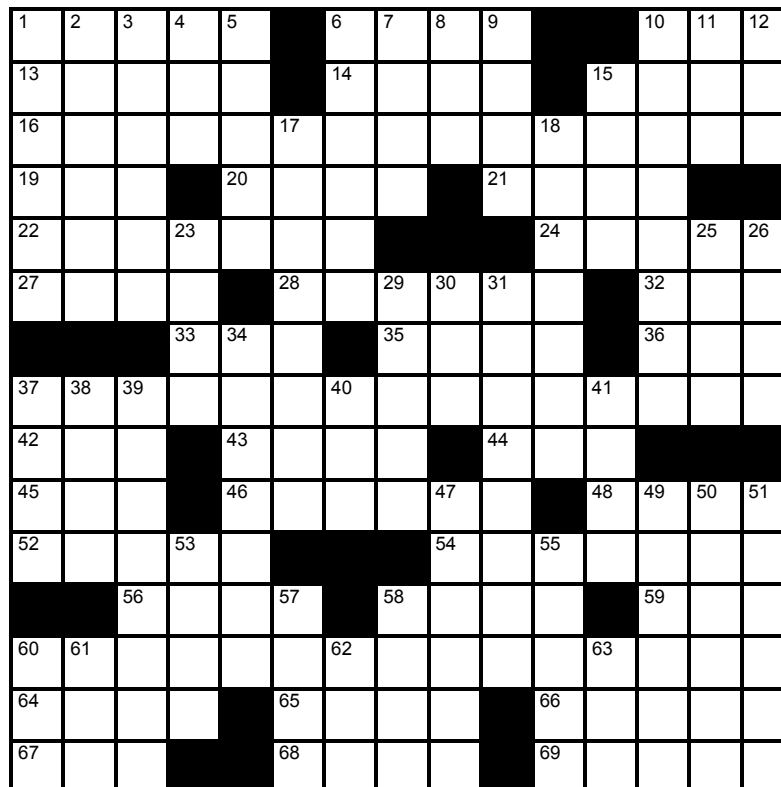

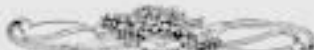

## Middle School 8th Graders at North Shore Participate in Rocket Study

April 15, 2013 - Mrs. Kelly's 8th grade Science Research class and Mr. Slack's Robotics & Automation class joined forces to study how and why rockets work. Each student constructed and launched their own rocket powered by an A-8 engine. Using the scientific method, students investigated the question "Can the number of fins on a model rocket change the apogee of the rocket flight?" Apogee, is the term used for the highest point of a rocket flight. During the lab investigation, students were introduced to trigonometry and used an instrument to measure the angle of elevation in order to calculate the height of their rocket.

Using their findings, the students completed their calculations and graphs while following NYS Regents exam formats. Mrs. Kelly and Mr. Slack's classes were able to utilize their specific class skill sets to help their peers think critically and solve problems. At the end of the lesson, students were hypothesizing what would happen if they changed a different variable such as; engine size, fin shape or body tube length.
