Letter To The Editor

Unfair Forced Resignation Of Our Superintendent To The Editor,

On May 8th, the Glen Cove Board of Education forced the resignation of School Superintendent Joseph Laria for allegedly allowing a 16 year old high school student, with a valid NYS Learner's Permit, to operate his motor vehicle on school property for approximately 10 minutes on the morning of May 7th. Unusual to say the least, not good judgment, but exactly what enforceable laws, rules, guidelines, or authorized practices did he in fact violate that can justify the Glen Cove Board of Education to summarily force his resignation without any due process of law or administration whatsoever?

By comparison or contrast, what is so "outrageous" about this, is that the Glen Cove Board of Education did nothing more than apply its own value judgments overnight in an ex-parte manner to a relatively inconsequential act or omission involving the most senior school administrator in our City. This appears to me to be a gross injustice to any person regardless of stature and/or standing. Internecine behavior involving

poor leadership and management on the part of the Board of Education is probably the major contributing factor to what happened. Some of your readers will disagree with me, but I don't feel the Board acted fairly. Decisions made by emotion rather than using established protocols sets dangerous precedents.

I'd like to know exactly what members of the Board of Education, after having been advised of the penalties and consequences of perjury, are willing to come forth before an authorized tribunal, swear under oath, and specify in a clear and convincing manner in written deposition format, as to exactly what charge, or charges under any of the Consolidated Laws of the State of New York, or any other jurisdiction, were in fact violated by Superintendent Laria. I question whether the Glen Cove Board of Education did in fact have the subject matter jurisdiction to force the resignation of the Superintendent without further formal inquiry governed by requisite burdens of proof and rules of evidence established by statute, rules, regulations, guidelines, et. seq. We are Americans - Our history and traditions of juris prudence involve "fair play" for everyone. Speaking for myself, I am not willing to give this up in favor of a bureaucratic Board of Education that seems to march only to the beat of their own drums.

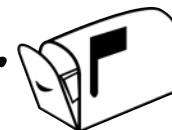

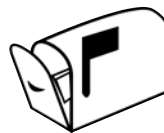
Walk The Walk

In hearing the community's needs and to help facilitate communication between the community and the board, I became a VP and executive board member of the NSDRG and found a way to further assist our community in dealing with the LIPA decommissioning by procuring all of our legislators to speak at a town hall meeting. Nearly 400 community members attended this meeting and, as a result of this meeting, I initiated the letter writing campaign which delivered personal letters directly to Governor Cuomo ahead of the 2.5 million dollar grant provided to our district.

As a parent in this district, I also believe in supporting our children's education. I was eager to become a founding donor to the Viking Foundation. I have attended almost all board meetings, I have hosted budget meetings, I attended the Nassau County PTA Roundtable highlighting the impact of the reduction of state aid to our district, and most recently I participated in a grass-roots movement to curb State Mandates/testing though the Take Action Long Island Network which has a membership of teachers and teacher unions all coordinating to find relief from Testing Mandates.

I would like to be a new voice for our community and will respectfully listen to the needs and desires of our residents. 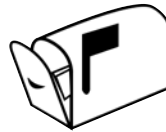

In Response To Vollmer

The following is in response to a letter printed in the May 9 issue of the Gazette by Peter Vollmer)

Dear Peter,

I was quite surprised by your recent letter (May 9, 2013) criticizing the role of those that seek changes to the school board under the banner of "reform". For those of us that have lived in the community for more than a decade, we remember the days when YOU WERE THE REFORM CANDIDATE, running AGAINST THE SCHOOL BOARD AT THAT TIME. You ran against a school board that you felt was out of touch with the community! I wonder if the Peter of 2013 would be so critical of the Peter of 2002.

I am particularly surprised by your public letters given the content of our conversation when I ran for the school board three years ago. I reached out to you and Tom Murphy for advice at the time. You both shared with me insights into your frustrations, which became the basis for my platform at the time. You, in particular, shared with me your frustrations with a school board that was dominated by the Superintendent; a Superintendent that was overly controlling and not transparent; where you were denied repeated attempts to independently visit classrooms so that you could gain direct knowledge of events, and not through the prism of "one voice".

It was based on our conversation that I campaigned on a platform of 360 degree interviews of the Superintendent and providing an independent forum for teachers to speak with the Board, amongst other ideas of yours. I took a lot of criticism for those positions at the time. I never shared with the community the inspiration for those views (yours and Tom's) because I did not want either of you to be the topic of scorn, which seems to be the standard course of action for the school board toward those that have a different view of how to improve the school. We all have the same goal – the improvement of our schools. Some of us have a different idea of how to get there.

So I ask, what would the Peter of 2002 be campaigning for as a reform candidate in 2013?

Is it acceptable to seek reform for a school district that has implemented a number of programs over the past decade that have not been effective? Over the past ten years, we have implemented at least six new programs, many without any measurable results to support the continuation of these programs, or an explanation when these programs are eliminated within two or three years of their introduction.

Given the history of failed programs (i.e. the 9th grade experience), is it acceptable to seek reform and ask why we would introduce Mandarin into the elementary school curriculum – a language with more than 100,000 characters - when it may be best to have our children focus on English grammar and writing. Do our first graders understand the difference between the English words through and thru; or too, to and two? Do our fourth grade children understand what a past participle or gerund is in grammar? Is Mandarin in elementary school another path to a failed program?

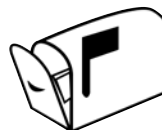
Is it acceptable to seek reform when the School Board favors certain candidates – Toni LaBatte speaking at last year's Spring Concert and Sarah Jones in this year's CBS LIPA video – while publicly commenting on their neutrality in the elections?

Is it acceptable to seek reform when the teacher's union – for the first time ever - is openly and aggressively endorsing certain candidates: i) without ever meeting with the other candidates; or ii) in anticipation of their next contract negotiation? Is the teacher's union seeking to influence an election to elect a Board that will be generous to them in the next contract negotiation? Is there a conflict when members of the teacher's union are elected to a Board that negotiates a union contract? If elected, will they re-use themselves from voting?

Is it acceptable to seek reform when our school board has been less than candid with the community with regard to LIPA? I met with LIPA in the fall of last year. I ran a full page ad in January detailing the fact that LIPA representatives met with Dr. Melnick and Igor Webb to tell them that the future of the plant was at risk of closing. This meeting and notice occurred much earlier than the school board admits (almost two years earlier). The President of the school board denied that such a meeting took place. And yet within two weeks of running the ad, the School Board President altered her testimony in Albany from that which she previously gave; and the School Board named Igor Webb LIPA Liaison at 11:30pm at night, when most of the public had gone home for the night. Shouldn't Dr. Melnick as Superintendent, or the School Board President, be in regular communication with LIPA? Of all the people in the community – why name Igor Webb as liaison? Dr. Melnick and Igor Webb have yet to communicate with the public directly on this issue. They need to do so out of respect for the community and respect for being totally transparent with the public.

LIPA's story was confirmed by

elected officials that I spoke with at the State and County level. LIPA used the word “disingenuous” to describe the School Board's public statements. The State and County elected officials used the word “lie” to describe the School Board's public statements. I would prefer to use the word “myth”. All of us that believe in holding our elected officials to be honest and forthcoming to the community should demand that the school board members who perpetrated this myth on the community RESIGN. And that would include members of the Administration. As a person of integrity, Peter, I believe you would agree with me on this basic tenet of accountability. We ask our children to always tell us the truth, regardless of the consequences. The same is true of our elected officials. Is it acceptable to seek reform of a school board that looks the other way when students engage in intimidation and bullying of other students involved in a recent alleged incident within the school district?. Are the children of the powerful and influential treated differently than the rest of us? We should all be concerned when the term “obstruction” or “interference” is used within the same sentence as our school district.

Is it acceptable to seek reform for a school district where the school board President would state to members of the community, that the school board elections are about absolute control of the school district; and that we cannot tolerate even one voice different than our own? Who will represent the rich diversity of opinion in this community? One has to wonder what truly goes on in the schools – a question that you posed yourself as a board member – when the President of the School Board does not embrace diversity.

Is it acceptable to seek reform of a school board that engages in email campaigns to denigrate candidates and members of the community whose opinions are different than that of the Board? Opposition candidates have been called names and labeled in terms that are not worth repeating. When I contemplated running for the Board, Carolyn Genovese welcomed me as a candidate and a prospective Board member, if only I would convince George Pombar not to run. Carolyn did not want a competitive election. I told Carolyn that I was tired of seeing the Board manipulated, and that I would run as an independent voice. The rest is history. Please refer to my prior paragraph for insight into the mindset of the leadership of the Board. You either agree with the Board 100%; or you are persona non-grata.

Dr. Melnick is well aware of the fact that members of the community are denigrated by school board members. The fact that he remains quiet in allowing this to occur says more than his words ever could.

As for your comment that we should abandon candidates that have lost prior

elections – there were other school board candidates that lost their first election, only to be subsequently elected and went on to become President of the School Board.

Lastly, I would like to address the elementary school parents and those that are new to the community. You remain the focus of a school board intent on remaining in control. You are the recipient of numerous emails that tell you that those that run as reform candidates are “misinformed”. When my four children attended Glenwood Landing – the school and my view of the school district was that of Shrangri-la. But like others in the community, as my children

got older and I got more involved in the school district, I saw things that needed to be improved. I would ask you the following question – why is it that some of the most active members of our community are seeking reform? And why is the school board working so hard to denigrate them?

Peter Vollmer wanted independence from the Superintendent to truly understand what was happening in our schools. We are no different.

We tell our children to accept diversity. And yet, do we follow that maxim when it comes to those representing us on the school board?

Three years ago, Peter, you told me you left the Board because of your inability to effectuate change. Why not embrace those that are running for the Board to do so?

Sal Guastella, started the fast break and found rookie Gabrielle Guevarra for the game's first score.

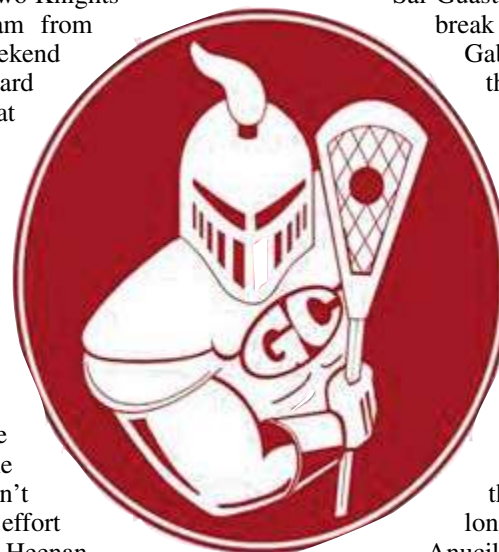
Shortly after Bobby Kiaer intercepted a pass and streaked untouched to the goal for the second score of the game as the first quarter ended.

This week's celebrity is an American actress born in Milwaukee, Wisconsin on July 14, 1928. She was signed to a film contract by Paramount Pictures in 1948 and, after a few supporting roles, producers began to consider her for more prominent parts. She was up for the role of "Delilah" in Cecil B. DeMille's 1949 film "Samson and Delilah", for which she later said she was not suited. When she was passed over in favor of Hedy Lamar, director Billy Wilder cast her for his upcoming project. In "Sunset Boulevard" (1950), she played with William Holden and Gloria Swanson. Her pairing with William Holden was considered a success and she appeared with him in three other films: "Force of Arms", "Union Station", and "Submarine Command", all released in 1951. None of those films repeated her success in "Sunset Blvd." which garnered her an Academy Award for Best Supporting Actress nomination for her character, "Betty Schaefer".

Last week's celebrity was John Rummel Hamilton. He was often typecast in the role of an authority figure such as a prison warden, judge, politician or a police chief, but played various types of characters, appearing in over 300 films, movie

serials or television programs from the 1930's through the 1950's. Some of the TV shows were "The Cisco Kid", "Tales of Wells Fargo" and "The Gene Autry Show". However, he became much more widely known when he was cast as the irascible "Daily Planet" newspaper editor "Perry White" in the 1950's TV classic "The Adventures of Superman" with George Reeves. "Great Caesar's Ghost!" After that, he appeared in TV commercials for a line of bifocals called "Inviso No-Line Glasses". The idea was to render invisible the seam between the lenses "that tells the world you are over 40!". John Hamilton died Oct. 15, 1958 in California of a heart attack at the age of 71.

Daniel A. Casey

Casey, Daniel A., a lifelong resident of Locust Valley, died on May 6, 2013 at the age of 83. He retired in 1989 as an Accounting Manager for Verizon after a forty year career with the Company. In 1963 he was appointed to the Town of Oyster Bay Zoning Board of Appeals and was Chairman at the time of his retirement. He was drafted into the US Army in 1951 and served in the Korean War. He was in the Signal Corps, establishing telephone communications beyond enemy lines. He was awarded the Bronze Star for his heroic and meritorious service. Civic and religious organizations were a big part of his life. The City Of Glen Cove 2012 Annual Drinking Water Quality Report

Dear Neighbor,

The City of Glen Cove takes great satisfaction in delivering safe drinking water to the over 27,000 users who live within the City and to the additional 15,000 plus daily water consumers who work in and visit our beautiful City. This Annual Drinking Water Quality Report is furnished to the consumers of City of Glen Cove Water in compliance with Federal and State Regulations. This report is designed to inform you about the quality of water and services the City has delivered in the past calendar year and to give you other information regarding your water supply and conservation. It is important for customers to realize that extensive monitoring is required of all public water suppliers. Long Island water must comply with strictly enforced standards established by the U.S. Environmental Protection Agency, the N.Y.S. Health Department and the Nassau County Health Department.

In 2012, your tap water met all State drinking water health standards. We are proud to report that our system did not violate a maximum contaminant level or any other water quality standard.

Water System Information: The City pumped 1,394,516,000 gallons of water from the groundwater supply in 2012. Approximately 1,255,064,400 gallons were delivered to consumers in the City through metered sales. 139,451,600 gallons or ten percent (10%) of total withdrawal was un-metered from uses such as municipal and public school facilities, fire fighting, hydrant flushing, main breaks, undetected service line leaks and water tank overflow.

Cost of Water: Our residential rate structure for each 3 month period is as follows: \$2.36 per 1000 for the first 45,000 gallons, \$2.66 per 1000 gallons for the next 45,000 gallons, and \$2.95 per 1000 gallons for usage over 90,000 gallons.

Sources of Supply: The Water Department supplies water from five wells located on four separate well fields throughout the community. The wells are drilled into the Magothy aquifer beneath Long Island. Glen Cove has a total well capacity of 9.87 million gallons per day. Glen Cove water is excellent quality, meeting all State and Federal drinking water standards. All well stations are monitored daily for proper operation by Certified Operators who meet all the requirements of New York State and Nassau County Departments of Health. Please note that unregulated private wells should not be used for consumptive purposes.

In general, the sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activities. Contaminants that may be present in source water include: microbial contaminants; inorganic contaminants; pesticides and herbicides; organic chemical contaminants; and radioactive contaminants. In order to ensure that tap water is safe to drink, the State and the EPA prescribe regulations which limit the amount of certain contaminants in water provided by public water systems. The State Health Department's and the FDA's regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Water Treatment: The Water Department treats the water supply before it enters the distribution system. A small amount of chlorine is added to assure the water maintains its bacteria-free quality. Our water is also treated with sodium hydroxide (caustic soda) to increase its pH to reduce its corrosivity before it enters the distribution system. This treatment reduces the leaching of copper and lead from household plumbing. Source water from the Well N-9334 is treated by "air stripping" to remove various volatile organic chemicals (VOC's). Source water from Wells N-9210, N-9211 and N-5261 are treated by Granular Activated Carbon (GAC) filters to remove various organic chemicals. All treatment is approved by, and in strict accordance with, Nassau County Department of Health standards.

Source Water Assessment: The New York State Department of Health, with assistance from the local health department and the CDM consulting firm, completed a source water assessment in 2007 for this system, based on available information. Possible and actual threats to this drinking water source were evaluated. The source

water assessment includes a susceptibility rating based on the risk posed by each potential source of contamination and how rapidly contaminants can move through the subsurface to the wells. The susceptibility of a water supply well to contamination is dependent upon both the presence of potential sources of contamination within the well's contributing area and the likelihood that the contaminant can travel through the environment to reach the well. The susceptibility rating is an estimate of the potential for contamination of the source water, it does not mean that the water delivered to consumers is, or will become, contaminated. See section "Table of Detected Contaminants" for a list of the contaminants that have been detected (if any). The source water assessments provide resource managers with additional information for protecting source waters into the future. The source water assessment has rated most of the wells as having a very high susceptibility to industrial solvents, all of the wells as having a high susceptibility to nitrates and one well as having a medium high susceptibility to microbial contamination. The very high susceptibility to industrial solvents is due primarily to point sources of contamination related to transportation routes and commercial/industrial facilities and related activities in the assessment area. The high susceptibility to nitrate contamination is attributable to un-sewered residential land use and related practices in the assessment area, such as fertilizing lawns. A copy of the Source Water Assessment including a map of the assessment and a supplement to this annual water quality report can be viewed at the Water Department, City Hall.

Analytical Results: The City routinely monitors water quality taking 40 samples per month from 10 various locations citywide. Over 135 separate parameters are tested in each of our wells numerous times per year. As required by the USEPA, the New York State Sanitary Code and the Nassau County Department of Health, we routinely test your drinking water for numerous contaminants. These contaminants include: total coliform, turbidity, inorganic compounds, nitrate, nitrite, lead and copper, volatile organic compounds, total trihalomethanes and synthetic organic compounds. Analytical testing results and information regarding the contaminants detected in this testing can be found within the table of this annual report identified as 2012 Table of Detected Parameters.

Many of these parameters are naturally found in all Long Island drinking water. All drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. Some people may be more vulnerable to disease-causing microorganisms or pathogens in drinking water than the general population. Although our drinking water met or exceeded state and federal regulations, some people may be more vulnerable to disease-causing microorganisms or pathogens in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice from their health care provider about their drinking water. Please note that there have been no known outbreaks of Cryptosporidiosis and giardiasis linked to the water supply in Nassau County. EPA/CDC guidelines on appropriate means to lessen the risk of infection by Cryptosporidium, Giardia and other microbial pathogens are available from the Safe Drinking Water Hotline (800-426-4791).

In 2011, the City performed and submitted 2009-2011 lead/copper data to the Nassau County Health Department as part of its triennial reduced lead/copper monitoring program and was approved to continue on a triennial monitoring basis by the Department. The monitoring for the period 2012-2014 will be performed in the Spring of 2014. The City tests its water supply weekly at various monitoring locations within the City limits. An independent laboratory to insure water purity and quality also performs additional monitoring, sampling, and testing.

During 2012, our system was in compliance with applicable State drinking water operating, monitoring and reporting requirements. As you can see by the table, our system had no violations, but as demonstrated through our testing, some contaminants have been detected; however, these contaminants were detected within New York State drinking water standards requirements. Although nitrate was detected below the MCL, it was detected at 6.5 mg/l, which is greater than one half of the MCL. Therefore, we are required to present the following information: "Nitrate in drinking water at levels above 10 mg/l is a health risk for infants, less than six months of age. High nitrate levels in drinking water can cause blue baby syndrome. Nitrate levels may rise quickly for short periods because of rainfall or agricultural activity. If you are caring for an infant, you should ask advice from your health care provider."

Our water system violated a drinking water reporting requirement in 2012. Under New York State Sanitary Code, Part 5: 5-1.72 (h) (1), (3) and (6) The City of Glen

Cove as a community water system was required to deliver a copy of the 2011 Annual Water Quality Report (AWQR) to its bill paying customers, with a copy of said report also being delivered to the required regulatory agency on or before May 31st of the year immediately following. The City was also required to provide a copy of the certification that those requirements were met, to the State Health Department and the County health department office having jurisdiction by September 1st of that same year. As the City was late with its 2011 AWQR, and did not meet the deadline requirements, the City was found in violation of the preceding Subparts of Chapter 1 of the New York State Sanitary Code (NYSSC) as cited above. The 2011 report was released after these deadlines through a direct mailing to all bill paying customers, published in the Gold Coast Gazette, and posted on the City website on January 2, 2013. The affidavit of compliance was sent to the NCDOH on February 8, 2013. The City of Glen Cove has implemented a system of checks and balances to avoid the reoccurrence of such a violation in the future.

Capital Improvements: The City of Glen Cove is committed to providing Glen Cove residents with the best tasting water and to improve the overall efficiency of the system. With this in mind, we have released contracts for the well rehabilitation and pump replacement for well N-9210, initiated the preliminary investigation and rehabilitation of Well N-5261 in preparation of a major water quality treatment system upgrade, and released contracts for upgrades to the chemical storage and treatment system for Ph adjustment and corrosion control. The city continues to modernize and upgrade the water distribution infrastructure including fire hydrant and valve replacements city-wide, and instrumentation and control improvements at our well sites. Our water meter replacement program continues with the addition of Radio Remote Reading system in businesses and hard to access areas. The new meters are equipped with a remote radio head that will allow meters to be read without entering the customer's premises. The new system allows for more efficient computerized meter reading and automated billing. Capital improvements for 2013 include, but are not limited to, replacement of the well pumps at wells N-9210, N9211, and N-9334, increased perimeter security, improvements to telemetry and automation systems, improving and increasing stand-by/emergency power, updating of electrical control and monitoring systems, and upgrades to the City distribution mapping system. The City had its water engineers review four separately produced reports that all concluded the need for two additional wells for the City water supply system – one immediately, and a second for the near future. This need will be met by the proposed expansion of an existing well field through the purchase of adjoining private land allowing the City to add one additional well immediately for both redundancy and capacity with the possible addition of a second well at this site when needed. The City is also in the process of upgrading the VOC removal system from Well N-5261 from a GAC system, to an Air Stripper system, which will provide for enhanced VOC removal. An engineering study has already been prepared and approved by the Nassau County Health Department. Engineering design and preparatory work will begin in 2013.

Team Work: The Water Department performs a city-wide hydrant flushing and maintenance program. All dead-end mains are flushed by opening hydrants in the spring and fall to remove rust and sediments that have may accumulated over time. The City also performs regular hydrant inspections and maintenance to ensure that all City owned hydrants function properly and are in a good state of repair to provide optimum fire-fighting service.

Vigilance of our drinking water: The City of Glen Cove is committed to protect our drinking water supplies, prevent contaminants from entering our aquifers, and ensure high quality by treating the water. As a result of our nation's current alert status we are diligent to ensure the continued safety and quality of our water supplies. We use the best available water treatment technology and provide continued training of our employees for emergency awareness and response.

The New York State Department of Conservation (NYSDEC) has instituted a program to manage storm water runoff to improve water quality within our water bodies. The City of Glen Cove has been extremely conscientious about protecting and maintaining our waterways by maintaining and improving our existing storm drainage network system and by enhancing wetland areas to improve water quality from storm water runoff.

The City of Glen Cove on an annual basis submits to the NYSDEC an annual report which outlines our Storm Water Management Program (SWMP). The annual report is available for public viewing and comment on the City of Glen Cove website, or at the Glen Cove Public Library. If you should have any comments they should be made in writing to the City of Glen Cove Department of Public Works, Attn: Stormwater, City Hall, 9 Glen Street.

Water Conservation: The City actively enforces the water conservation ordinance year round and has developed a water conservation plan as mandated by the N.Y.S. Department of Environmental Conservation. Lawn sprinkling, car washing and other outdoor water use is permitted at properties (houses and buildings) with odd numbered address on odd numbered days and

with even numbered addresses or no address number on even numbered days between the hours of 5 am to 9 am and 4 pm to 12 midnight. For example, 1 School Street may sprinkle on May 1, 3, 5, etc. and 40 School Street may sprinkle on May 2, 4, 6 etc. Automatic sprinkler systems must be equipped with a rain sensor. Customers can take many measures to conserve water and lower their water bills and should be conscientious in their daily use of water. Customers can also save water by only using their existing dishwashers and washing machines with full loads. The Water Department provides its customers with free water conservation kits consisting of toilet tank displacement bags, toilet tank leak detector tablets, shower head restrictors and water conservation instructions. Customers should check all toilets, all faucets inside and outside, including hose bibs and showerheads for leaks which are often easily and inexpensively repaired. Since leaks waste water and inflate your bill, it is wise to fix them quickly.

Maximum Contaminant Level (MCL): The "Maximum Allowed" is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to MCLG's as feasible using the best available treatment technology.

Action Level: The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Non Detects (ND): Laboratory analysis indicates that the constituent is not present

Nephelometric Turbidity Unit (NTU): A measure of the clarity of water. Turbidity in excess of 5 NTU's is just noticeable to the average person.

Parts per million (ppm) or milligrams per liter (mg/L): One part per million corresponds to one minute in two years or a single penny in \$10,000.

Parts per billion (ppb) or micrograms per liter (ug/L): One part per billion corresponds to one minute in 2,000 years or a single penny in \$10,000,000.

Parts per trillion (ppt) or nanograms per liter (ng/l): One part per trillion corresponds to one minute in 2,000,000 years or a single penny in \$10,000,000,000.

Congratulations to all the students who participated in this program to raise money for those in need.

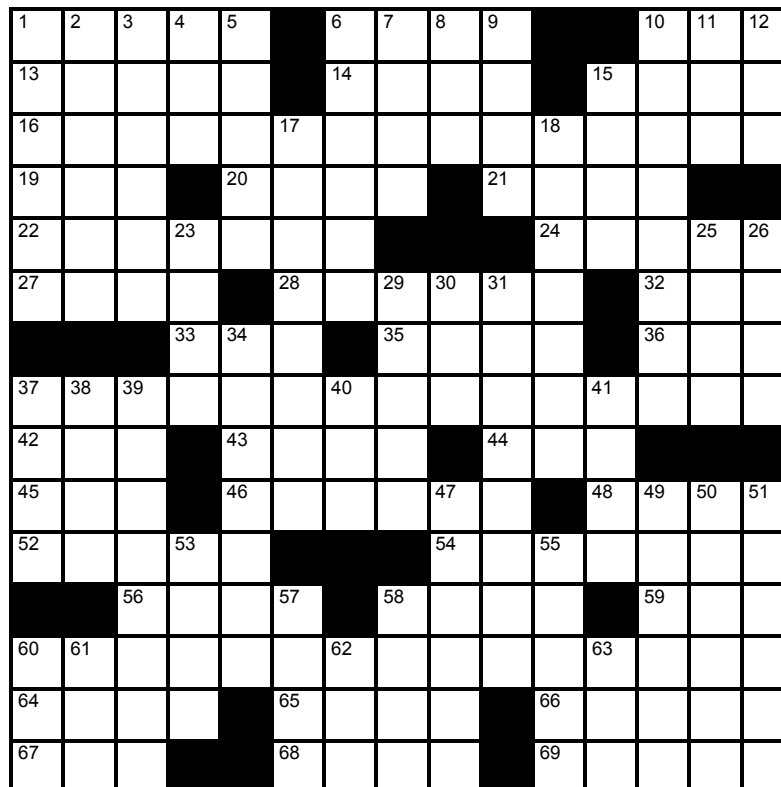

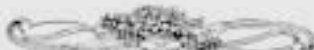

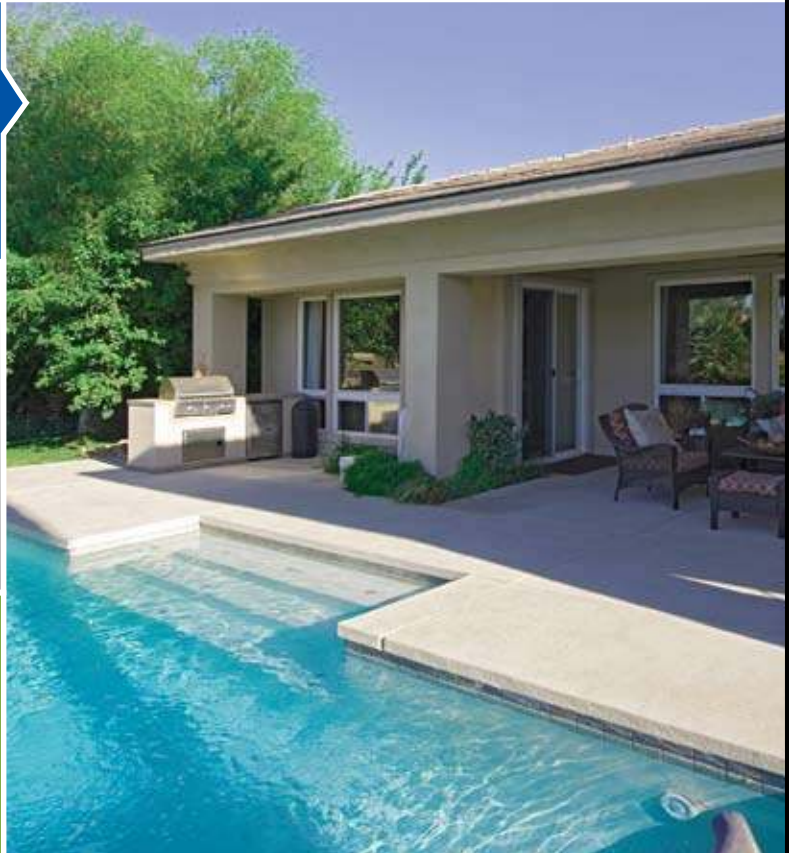
