



# Local School Budgets Pass

*North Shore Budget Passes By 513 Votes, while Glen Cove Passes by 20*

The 2013-2014 North Shore School Budget passed by 1,735 yes votes to 1,222 no votes. Marianne Manning Russo, Michael Nightingale, and Sara Jones have been elected as Trustees to the North Shore Schools Board of Education.

The Glen Cove budget passed by 799 yes votes to 779 no votes, a mere 20 votes. Richard Maccarone was elected with 1050, Grady Farnan with 859 and Eric Bailey by 832.

## Glen Cove Schools

Louis M. Zocchia, Jr., Interim Superintendent of Glen Cove Schools said, "On behalf of the Glen Cove City School District, I thank voters for their support of the proposed 2013-14 school district budget. During these challenging times in Glen Cove, it's gratifying to see that our shared goal of providing the best possible education for children has not wavered.

"As a community, you recognize the importance of supporting a strong, rigorous educational program, rich with extracurricular opportunities. The proposed budget continues this, with an eye toward both the educational and financial future of Glen Cove.

# North Shore Relay for Life Almost Here

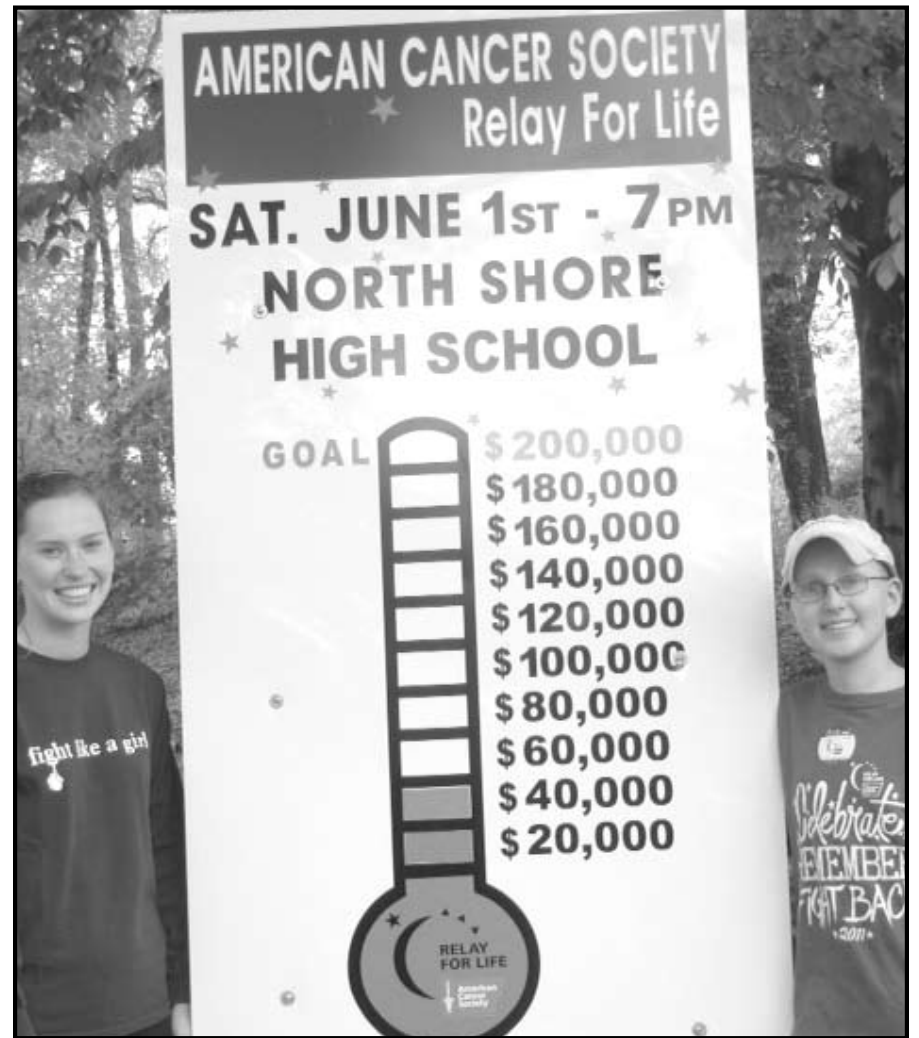

On May 24, 1668 Joseph Carpenter of Warwick Rhode Island purchased about 2,000 acres of land to the northwest of the Town of Oyster Bay from the Matinecock Indians. Later in that year he admitted four co-partners into the project - three brothers, Nathaniel, Daniel, and Robert Coles, and Nicholas Simkins, all residents of Oyster Bay. The five young men named the settlement "Musketa Cove," which in the Matinecock language means "this place of rushes." These settlers have been known forever after as the five original proprietors of Musketa Cove Plantation.

In addition to the official opening of our beautiful beaches this Memorial Day weekend, another sign of the season is the opening of two yacht clubs located in our City. Glen Cove Yacht Club celebrated its 53rd Commissioning Day this past Saturday, May 18th at their clubhouse located at the bottom of McLaughlin Street. # NSCC's 30th Anniversary Gift to the Community: A Free Pops Concert

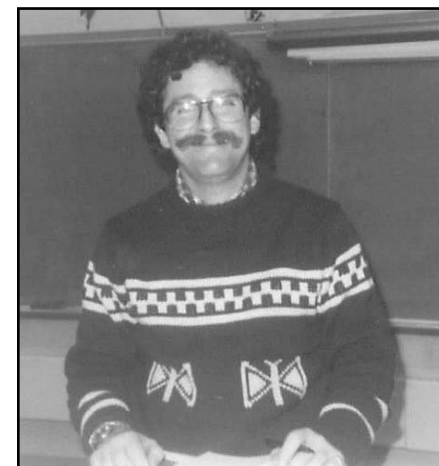

## North Shore Ninth Graders Study Volcanoes

North Shore Schools, Glen Head, May 21 - Ninth graders at North Shore High School in Laura DiLallo's class recently learned that volcanoes are not always only big cone-shaped mountains that spew out lava in giant explosions. They researched that volcanoes come in all shapes and sizes with varying degrees of activity as well notoriety including Mount Vesuvius (Italy), Mount St. Helens, (USA), and Mount Mayon which just erupted in the Philippines.

The Earth Science class had the opportunity to choose a volcano from a list of notable events in history and conduct research, experiment, and gather facts and information. To culminate their studies, each student either alone or with a partner made a presentation to their classmates in the form of a poster, scientific letter, or model of their volcano. Mrs DiLallo, said each presentation had to contain, "The name and type of volcano studied, the location/country where the volcano erupted, and its map of coordinates and elevation of summit (i.e., height)." She added "My students had to summarize the important eruption dates and provide a volcano diagram representing the tectonic plate, general shape, crustal movement, and magma."

On the day of the presentations, each group excitedly got up in front of their peers and expertly communicated

the facts, events, and characteristics of their historic volcanoes. Using baking soda and vinegar, some of the class even

got their volcanoes to erupt!

It was apparent that each of the students engaged in passionate learning and criti-

cal thinking while having fun studying notorious volcanoes in history.

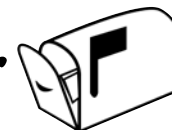

### Memorial Day

#### To The Editor,

As Memorial day approaches our thoughts turn to the men and women who have served and are serving our country all over the world. To many of my generation world war II was just history. We read about it in history books in school or watched the Hollywood version on television. It wasn't real, we were too removed from the actual experience. I'm sure my children feel the same way about the Vietnam War. But in recent years with the publication of Tom Brokaws "The Greatest Generation" and movies like Saving Private Ryan and Schindlers List I was able to see a much more realistic story of the war and the enormity of the sacrifice that was made became much clearer. This is my fathers story of his war experience. Most old timers in Sea Cliff will remember him , Bob Blackburn. He lived his whole life in Sea Cliff and was affectionately known as Skinny.

He joined the army air corp in June 1942. He was called up in November and sent to Texas to begin evaluations to determine weather he would be a pilot or a gunner or a navigator. He got sick during pilot training and washed out of flight school so they sent him to gunnery school. After training in several different places they were all put on a plane bound for England where he was assigned to the 96th bomber group based in Norwich England. From there they would take off to fly bombing raids over Germany. It would take hours to get to the target area so they didn't have much to do during most of the flight but when they got into enemy territory anti -aircraft fire and flak was a constant threat. He recalled one time during a raid over Berlin that suddenly there was a big bang and a flashlight that he was using as a lamp suddenly hit him in the back. A piece of flak had come through the plane and just missed him hitting the flashlight and knocking it over on him. He had several close calls like that but managed to

come through uninjured.

Unfortunately that was about to change. Flying a major bombing mission in March 1944 his plane headed for Germany along with eighty one other planes , they weren't told what the target was, just where it was. On the way to the target they encountered some flak but it wasn't bad but a little while later developed engine trouble. Whether they were hit by flak or the engine went bad on it's own he never knew but they managed to drop their bombs over the target and then headed back immediately. As soon as they started back the pilot told everyone that he had to shut down one engine which meant they couldn't keep up with the rest of the group. Then to make matters worse another engine on the same side quit. It was then they knew that they would not be able to make it back at all. The crew unanimously decided to head for Switzerland where planes in trouble often landed. Unfortunately German fighters who were always looking for stragglers had seen them pull off from the group and were on them in no time. He heard machine gun fire and he thinks they must have hit the radio room because a box of flares went off and started a fire. At that point ( he found out from the pilot later ) the pilot hit the bail out button and the five crew members in the front all got out just before the plane went into a spin, but Skinny couldn't get out of his tail gunner compartment. When he tried to open the door to his compartment the handle came off in his hands. Fortunately as the plane went into a wicked spin the tail section broke off and he fell out. He managed to pull his rip cord before passing out and woke up on the ground with only a broken ankle and two very sore knees. The pilot and four other crews members survived but the three men in the middle off the plane were killed.

German soilders had seen the plane go down and he was captured within fifteen minutes. Because he couldn't walk they put him on a sled they had gotten

from some kids and pulled him on it. The pilot was also captured and he ended up carrying my father till they took him to a hospital where they x-rayed both his knees and put a cast on his ankle. After a while recuperating in the hospital he was put on a box car for the five day journey to prison camp, Stalag XVIII B

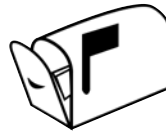
There he would spend the next fourteen months till the end of the war. It was cold but they did have blankets, however the food was pretty bad. Red cross packages did get through and there was an escape just like in the movie. Some of the prisoners tried to organize mass escapes but the overwhelming sentiment was to stay put.

They kept themselves occupied playing sports, listening to music if it was available and sometimes putting on plays. These were organized by Don Beaven and Ted Trezanski who would later write the screenplay for the Broadway play Stalag XVII which then became the basis for the movie.

As it became clear that the war was lost the Germans started marching the prisoners east, away from the Russians and toward the Americans. They were finally liberated by the 7th army when the Germans surrendered to a lieutenant who carried only a sidearm.

It took another six weeks or so before he made it back to the U.S. where he resumed his life and career. I have heard that there was another Sea Cliff native who was also a P.O.W. but I don't know who he was.

My father and my mother Marion raised three children, my brother Tom my sister Ann and myself and went on to live the lives he had fought to protect. My mom worked for the North shore school district and my dad spent his life working in the insurance business. He was president of the Sea Cliff little league, a member of the architectural review board and a founding member of our local Kiwanas club. Several years before Skinny died in 2003 my son sat down with his grandfather and asked him to talk about his war experiences. I have him to thank for the written words we have now.

On the west side of the big rock in Clifton park there is a bench dedicated to our dad and we hope that all who sit on it will be mindful of how much was given and how much was lost by the men of that special generation and that we will all strive to do what private Ryan was urged to do, earn this. It is a debt and sacrifice we cannot hope to pay off, but

should never stop trying.

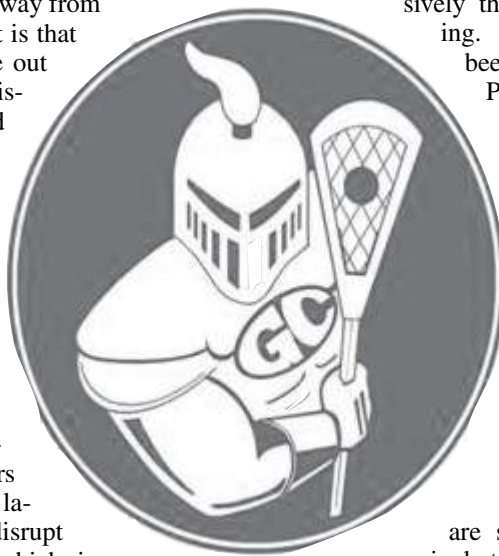

### Six other fifth graders win honorable mentions for letters to George Washington

"Dear George Washington, My name is Anna Garnwich. I am a widow and I am originally from Germany. I came to America when times were tough in my home country. I have three children and many worries about their future. I hope you can understand my concerns."

So began Friends Academy fifth grader Madeline Scanlon of Locust Valley in her prize-winning letter to the first President of the United States as she implored him to consider strengthening the country through the creation of a public school system, especially for girls.

Awarded first place by the Gilder Lehrman Institute of American History in the annual national Dear George Washington Contest, Scanlon's letter immediately impressed the judges. "We were all blown away by how mature Madeline was in her letter," remarked Gilder Lehrman Education Coordinator Courtney Roy. "We were so impressed by her insights at such a young age," she added, also noting that "what struck us most in her letter was the line, 'Since the Declaration of Independence was signed, I feel more free but nonetheless scared. I feel like a new person was born inside of me but another part of me died.'"

In addition to Scanlon, six other Friends Academy students took honorable mention for their submissions, each one writing about what he/she thought the President should focus on during his first term. Students were asked to imagine themselves as a member of the audience at the inauguration on April 30, 1789 in New York City, either as an average person or member of Congress.

## The Great Gatsby

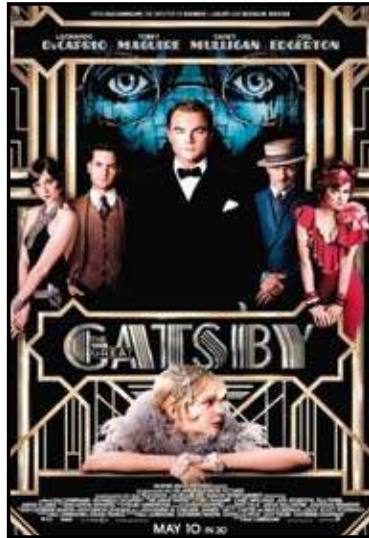

Stars: Leonardo DiCaprio, Tobey Maguire, Carey Mulligan



Much is speculated about who exactly Jay Gatsby is. Some say he is a prince, while others believe him to be a sociopathic killer. Some say he does not even exist. All that can be certain, as an attendee at one of Gatsby's lavish soirees observes, he is "richer than God." One can be in just as much wonderment as to director Baz Luhrmann's inspiration for his unconventional version of F. Scott Fitzgerald's 1925 classic. Was this truly how Luhrmann envisioned the seedy romantic tale or a recreation of a fever dream he had after reading the novel?

At the height of the roaring 20s in New York, there are few people who haven't heard of the mysterious Gatsby. Despite his fame Gatsby, played with charismatic sensitivity by Leonardo DiCaprio, remains little more than a myth. What people do know is that they can count on him for the most indulgent of parties hosted in his grand mansion of Long Island's "West Egg."

The story is recalled by Nick Carraway, a Yale graduate and humble writer now suffering with depression and anxiety. In the summer of 1922 Nick earned a job as a bond salesman. Moving to Long Island he by chance rents a modest home right next to Gatsby's mansion. Across the bay, in "East Egg," live his cousin Daisy Buchanan (Carey Mulligan) and her husband Tom (Joel Edgerton).

Nick soon realizes behind all the friendly hospitality and upscale gatherings is a plethora of secrets, betrayal and infidelity. Once Nick receives a formal invitation to Gatsby's mansion he is inescapably ensnared in a web of gossip and deceit.

Under Nick's narration the movie unfolds in a glossy, almost hallucinatory fashion. His words scrawl across the screen as the camera swoops down city skyscrapers and glides over bridges. We see the sparkle and grandeur of New York that fascinates Nick.

While beautiful to look at, there is

one aspect that threatens to destroy any authenticity the movie had. It is utterly impossible to be immersed in the New York and Long Island scenes of old when the characters are dancing to awful Jay-Z rap music. Slowing down a Beyoncé pop song does not make it fit a period noted for jazz, either. It all becomes a distraction. What's baffling is this was a mistake that actually required significant effort to make.

The screenplay, partially credited to Luhrmann, contains honest attempts to capture the signature eloquent text of Fitzgerald's novel mixed with flagrant overuse of the phrase 'old sport.' Some adjustments to the pacing would have been beneficial. After a dizzyingly rapid opening, the movie begins to stretch with some overly long confrontations.

DiCaprio radiantly succeeds in portraying both a legendary icon of the highest class and a man with aspirations we can all relate to. When Gatsby reconciles with his lost love, DiCaprio's flawlessly confident demeanor crumbles to delightful awkwardness in what is the most charming scene in the film. He easily picks up the slack from Carey Mulligan, who as usual confuses dramatic acting with mournful staring. She comes off passionless and hollow, failing to give humanity to her cold character.

If a touch of realness was given to this surreal embodiment of a classic, *The Great Gatsby* would have more of a lasting impact. Still it is hard not to become entranced by the extravagance and the scandals that come with it. Surely this was not what Fitzgerald had in mind, though he would probably be decidedly entertained nonetheless.

## Wiggle your arms, shake your legs...

### Now you're ready for public speaking

Friends Academy Middle and Upper school students spend day learning the ins and outs (and ups and downs) of how to address an audience

LOCUST VALLEY — "Question: I'm a public speaker ... what is my instrument? Answer? My whole body."

And with that statement, public speaking expert Michaela Hall proceeds to take dozens of sixth graders through a series of physical exercises designed to get them ready to address an audience. The students stand and start to warm up tongues and stretch their jaws; shake arms and legs; create small, tight faces; and sound out high and low notes. Finally, they're ready.

Working on a collaborative team project about an island, these sixth graders must ultimately present to their entire class. Teams of four will create a brochure about their island, a map, provide the history and answer why someone would want to visit. And they are looking for ways to improve their final delivery.

"People would prefer to be entertained," explains Hall. "But how do we inform and entertain?" asks Hall. "We can add fun facts and interact with the audience."

As a consultant, Hall currently

works with independent schools to institute a pedagogy for public speaking that is consistent across divisions, integrates public speaking instruction into existing curriculum and better prepares students for college and internship interviews.

In her sessions, students learn to create a story with their presentation, which includes an intro, middle and conclusion. And most importantly, they learn how to be an audience.

Hall also met with older students, including college-bound Friends seniors, and discussed how to give a compelling college interview. For 40 representatives of the Friends Academy Admissions Club, Hall not only offered tips on how to give interesting tours, but also coached them on their speeches and presentation style. "Use eye contact, not eye tag," cautions Hall, which tends to speed up speech. "You need to be in a sincere relationship for a whole phrase or idea before everyone feels included."

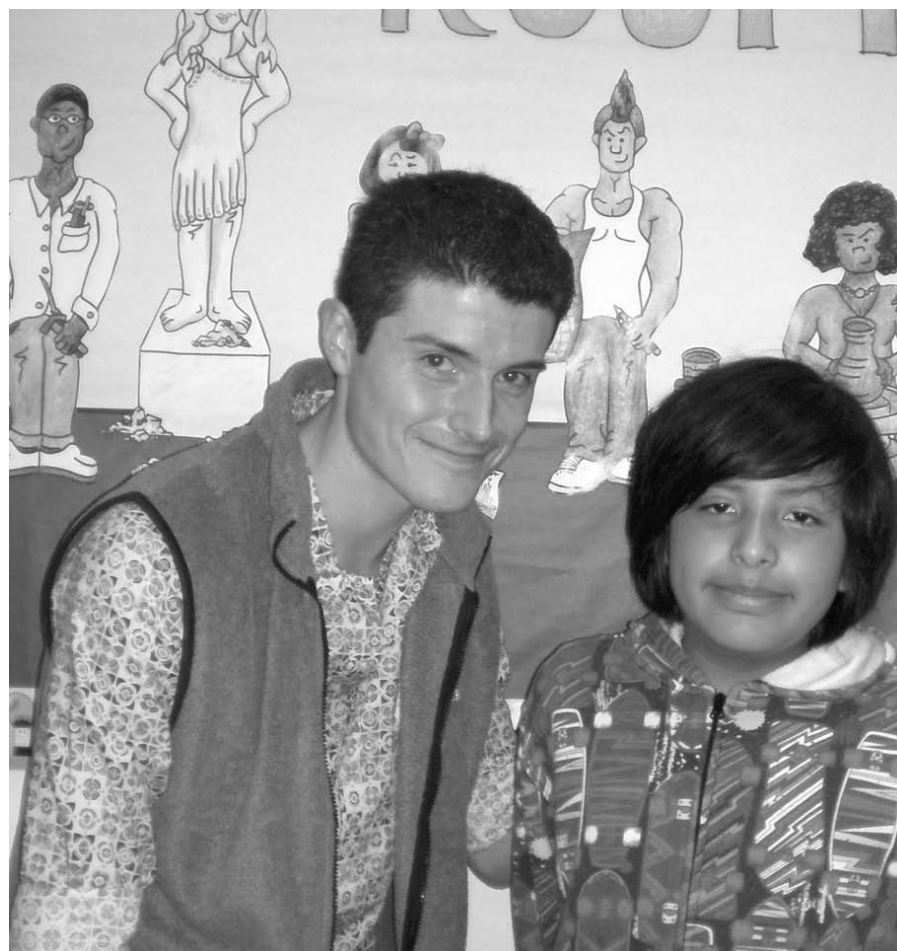

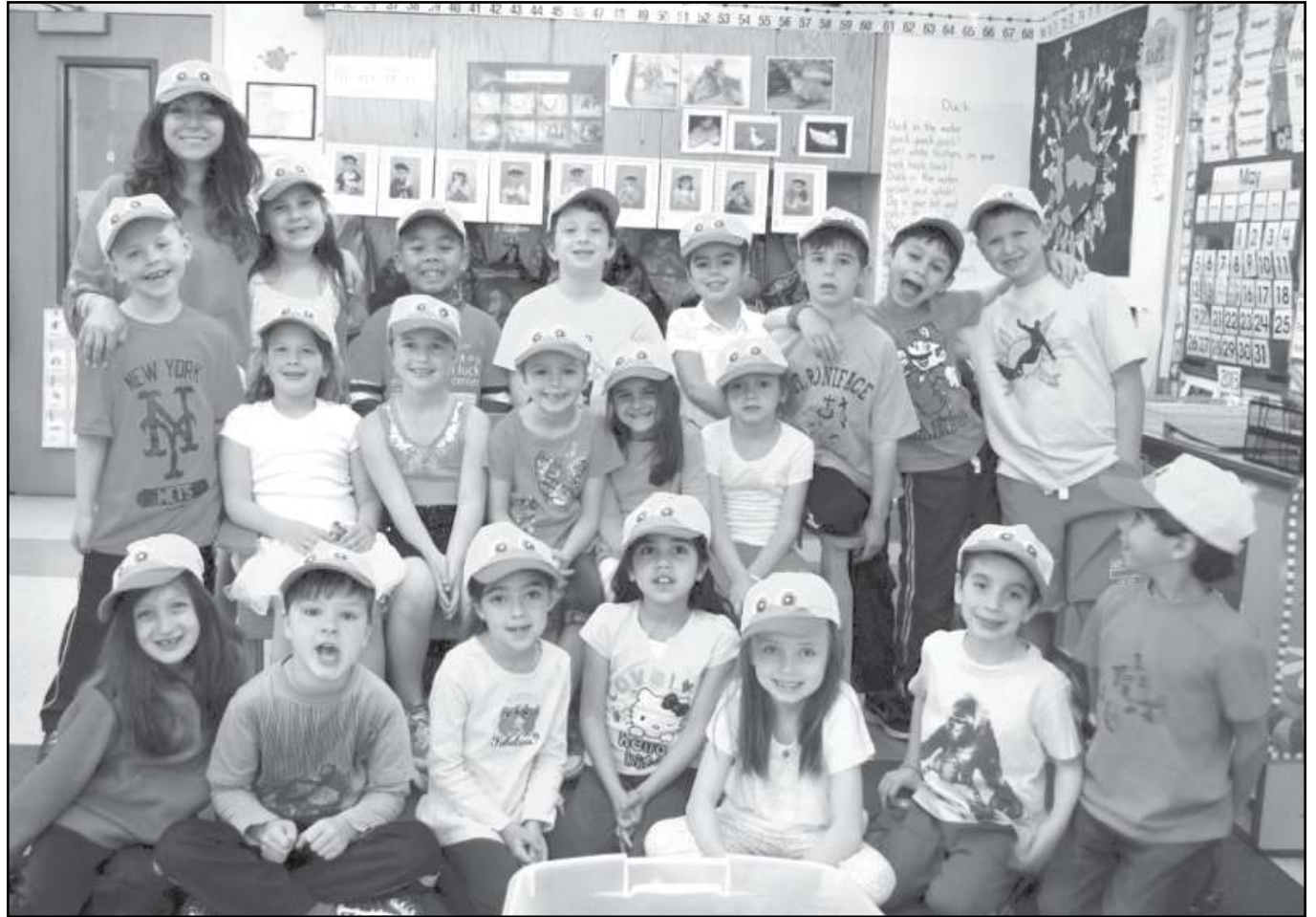
# Glen Head First Grade Hatching Celebration

North Shore Schools, Glen Head - On May 14, all first grade classes at Glen Head School participated in a Hatching Celebration to formally welcome their little yellow, furry friends into the world – their ducklings!

As part of their study on organisms, each class received duck eggs from Massey Duck Farm in the Hamptons. As their ducklings incubated for 28 days, the students engaged in research as well as hands-on experiments. This included examining the eggs, learning how things grow and develop, experiencing the hatching, and providing proper food and care for the ducklings. Experiments involved analyzing hard boiled eggs vs. fresh eggs and feathers in oil vs. water.

The classes also took a trip to the duck pond in Roslyn to further observe duck behavior as well as draw sketches of these animals in their natural environment. In addition, the students also read many stories about ducks as well as wrote detailed stories of their own like “scientists” in their individual classrooms.

During the Hatching Celebration, the first graders invited their families to join in the festivities as they sang songs, shared their journals, and became “eggsperts” on these adorable living organisms!

# Name the Celebrity



### Last Week's Celebrity

Last week's celebrity was Nancy Olson. Besides her successful role in "Sunset Blvd.", her other film credits include "Big Jim McLain" (1952 with John Wayne and James Arness, "So Big" (1953) with Jane Wyman, and "Battle Cry" with Van Heflin. She also made several appearances in films for Walt Disney Studio. "The Absent-Minded Professor" (1961) and "Son of Flubber" (1963) paired her with Fred MacMurray and were popular with movie-goers. She also appeared alongside Hayley Mills in "Pollyanna" (1960) and Dean Jones in "Snowball Express" (1972). Throughout the 1960's and 1970's, she did guest roles on TV and has been retired since the mid-1980's, although she made a brief, uncredited appearance in "Flubber" with Robin Williams, the 1997 remake of "The Absent-Minded Professor".

In her private life, she became the third wife of lyricist Alan Jay Lerner in 1950. Lerner wrote the lyrics for "I Could Have Danced All Night" and "I've Grown Accustomed to Her Face" for "My Fair Lady", along with "Brigadoon" and "Paint Your Wagon" and many others. They had two children, but divorced in 1957. She then married longtime Capitol Records executive Alan W. Livingston. He was probably best known for creating "Bozo the Clown" and signing Frank Sinatra and the Beatles with Capitol. They had one child. Olson has made few rare returns to TV, and mostly enjoys her retirement.

### Correct Callers

Callers who knew our celebrity were: Sal C. Will and Bab Hutchins, The Tuthill Family, Roberta Pezza, and Mario Moccia.

This week's celebrity was a local Long Island native and born on Oct. 10, 1926 in Long Beach. He was a film and TV actor. He was a short, tough guy and played a variety of characters during his fifty years in movies and TV. He became one of the best known character actors in Hollywood. He got his start in the business at the age of seventeen while he was employed as a mailboy at 20th Century Fox studios in Hollywood. A casting director auditioned him for a key role in Director Lewis Seiler's 1943 film "Guadalcanal Diary" with Preston Foster, Lloyd Nolan, William Bendix, Richard Conti and Anthony Quinn. Winning his film debut's role in book author Richard Tregaskis' "Guadalcanal Diary" settled him into a lengthy career in supporting roles. He stepped away from films to serve his country in the U.S. Merchant Marines from 1944 to 1949. Then he starred in two of the most remembered war films of 1949, William Wellman's "Battleground" with Van Johnson, John Hodiak and Ricardo Montalban and "Sands of Iwo Jima" with John Wayne. 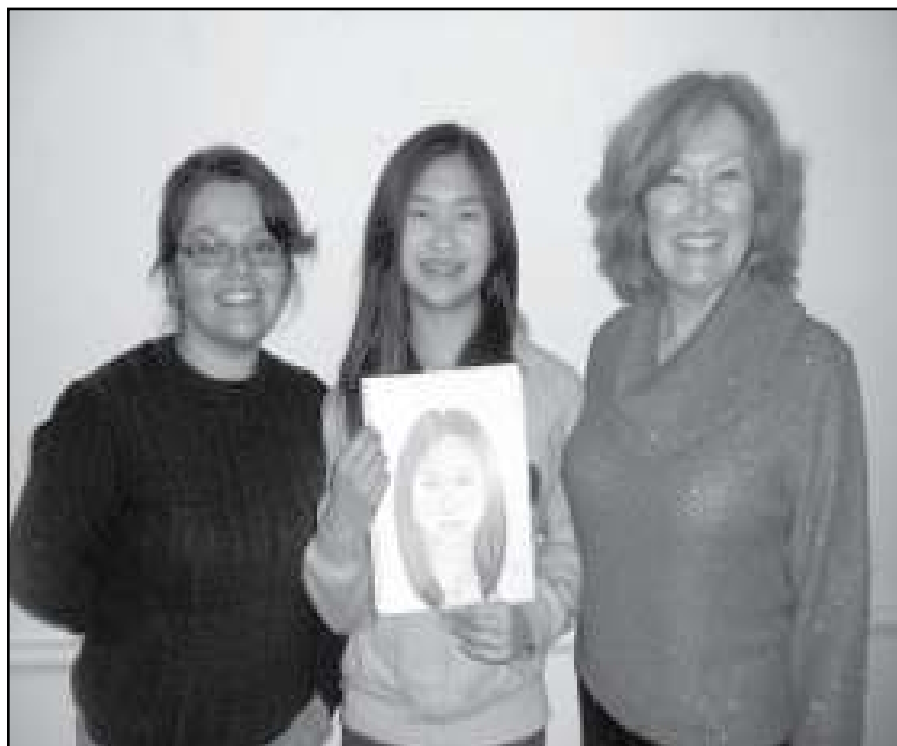
## GCAC Awards Art Scholarship to Katie Cheng

The Glen Cove Arts Council brings

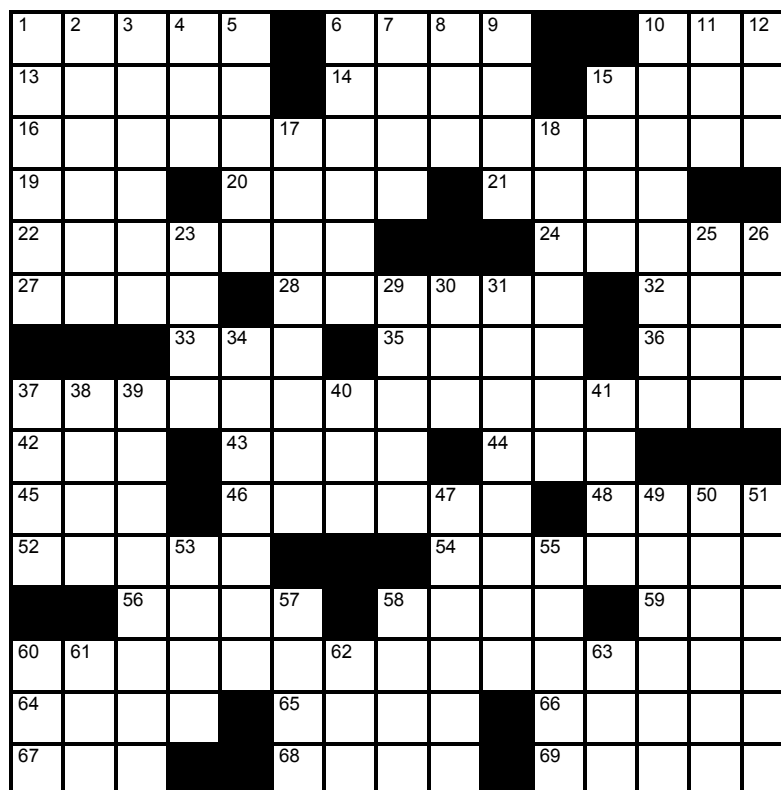

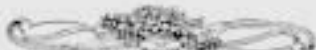

## SAFE and Kiwanis Key Club help prevent the sale of alcohol to minors

Store owners got a surprise visit on April 24th when members of the Glen Cove High School Kiwanis Key Club stopped by to help broaden the SAFE PRIDE Project Coalition's outreach efforts to get Glen Cove business owners to commit to not selling alcohol to minors. The kids spoke to the business owners about the importance of making this pledge and requested that they display SAFE's decal in the store window. The decal, created by the Coalition's Community Committee and Chaired by Councilman Tony Jimenez is shaped like a stop sign indicating clearly that the establishment will not be selling alcohol to minors.

"The need for prevention strategies and consistent law enforcement of underage drinking and sales has been an ongoing goal for the Coalition since 2004," said Dr. Sharon Harris, Director of SAFE and Coalition Co-Chair. Under the direction of the Community Committee, "The Downtown Business Improvement District has been an active member of the Coalition committed to protecting Glen Cove youth from the dangers of underage drinking. They adopted an initiative years ago called SAFE Downtown, which includes getting a commitment from business owners to not only not sell alcohol to minors, but also to display a decal to let everyone know of their commitment."

At a full Coalition Strategic Plan-

ning meeting in the fall, the initiative was expanded to "SAFE Glen Cove" after reports from Coalition member Lt. Chris Ortiz indicated the need to address other areas in Glen Cove where alcohol is sold said Harris. Through collaborations and full support to rally for this cause from the Glen Cove Chamber of Commerce, the Glen Cove Downtown Business Improvement District, and the Glen Cove Police Department, the Coalition has been able to respond to policing reports and expand its efforts to the entire city of

Glen Cove.

Mary Cooper, a member of SAFE's Board of Directors, said she believed the effort was very valuable not only for the community, but also for the kids in the Key Club. "This gives the kids something to do rather than sitting around with idle time where they might be tempted to do things that they shouldn't do," she said. "We are very appreciative of teacher Mary Ellen Cuomo and the Key Club students for participating in helping SAFE's Coalition to reduce the

sale of alcohol to minors."
