Can You Help Us Fill a Child's Bookbag? Back to School Donations Wanted

The Glen Cove Youth Bureau, in cooperation with the Friends of the Glen Cove Youth Board is teaming up with local citizens, organizations and businesses to provide back to school supplies to disadvantaged youth in our community. A backpack filled with supplies is presented to children who otherwise would not have what they need to succeed in their studies. Last year, close to 200 children in grades K – 12 received back to school supplies as a result of this effort.

Given the economy and cost of getting ready for school, the need is greater than ever this year. For example, on average it costs \$78.00 to purchase all of the supplies on the school list for a 1st grader in the Glen Cove School District and \$83.00 to supply a 4th grader. This cost simply covers school supplies. It does not cover back to school clothing, shoes, coats, etc. For families living on a fixed income, especially those with more than one child, these expenses are often impossible to absorb. When the family forgoes purchasing school supplies, it is the student who suffers.

The Glen Cove Interagency Council held its last meeting before the summer break at the The Regency, Glen Cove's oldest assisted living facility. Members were warmly welcomed by Jennifer Barrett who told members about the personal care and active lifestyle that is enjoyed by residents at The Regency.

The Glen Cove Interagency Council (IAC) held its final monthly meeting before the summer break at The Regency. Jennifer Barrett of The Regency warmly welcomed IAC members and provided an overview of Glen Cove's oldest assisted living facility.

The Regency is licensed to provide housing for 105 residents in 96 units. The studio and one-bedroom apartments are fully furnished and have recently been renovated. The building was originally built as condos; therefore the apartments are quite spacious. The Regency will soon undertake a major 18-month renovation that will add a movie theater, second private dining room, bistro and dementia unit. Most residents are in their mid-80s and all are known by the staff. It is a very personal and caring place to live.

The Regency's goal is to promote a stress-free lifestyle for seniors. Residents enjoy delicious meals, go on lots of trips and outings and have in-house programs. For example, "Regency University" offers lectures on a wide range

of topics from history to nutrition to residents and the public. The emphasis is on having a full and active life.

The Regency offers many levels of care from no care to incontinence care, medication management, escorts to meals, etc. The level of care is personalized to the individual. Veterans' benefits are accepted and shared accommodations are available for seniors on a restricted budget. The Regency also provides short term respite stays. Some residents come to The Regency from area rehabilitation facilities before going home. Others live in Florida and stay at The Regency when visiting the area.

Members of the IAC include community leaders representing a variety of human and social service agencies throughout Glen Cove. It reflects Glen Cove's rich cultural, religious and ethnic diversity and meets regularly to identify and address changing needs in the community. This network has resulted in numerous projects and collaborations that benefit Glen Cove residents on a daily basis.

Pet Therapy with Cooper at The Regency at Glen Cove

Every Wednesday at 10:00 AM, The Regency at Glen Cove has a very special visitor. This is the time when Cooper stops in with his handler, Tracy, for some much anticipated Pet Therapy. Cooper is an adorable 4-year-old Golden Doodle certified by The Good Dog Foundation. The Good Dog Foundation was founded as a 501(c) (3) charitable organization in 1998 to promote the use of animal-assisted therapy. Good Dog's mission is to elevate the stature and promote society's understanding of the therapeutic value of the human-animal bond.

When Cooper enters the building, he is a dog on a mission! He knows exactly where to go and can't wait to get there. He has an incredibly sweet and loving disposition. Cooper is always excited to see the residents and eagerly greets them with his tail wagging while lowering his head for all of the pets and snuggles he knows are soon to follow. It is amazing to see so many faces light up

upon seeing and interacting with Cooper. There are many documented benefits of Pet Therapy which include: lower blood pressure and anxiety levels, diminished physical pain and decreased feelings of isolation and alienation. It is said that the simple act of petting releases endorphins which in turn produces a calming effect that lifts spirits and lessens depression. These benefits are easily apparent when observing Cooper's interaction with the Regency residents.

The Regency at Glen Cove is very grateful to have Cooper and Tracy and thanks them for their kindness and dedication. The Regency also has other amazing Therapy dogs they wish to acknowledge: Macy, Maggie and Chiquita. Mayor's Column

As many of you know, North Shore-LIJ has announced a significant down-sizing of the Glen Cove Hospital that includes de-certification of its 265 inpatient beds affecting 76,000 residents in this vicinity.

If approved now, the changes will begin in January. In order for this plan to move forward it must be approved by the NYS Health Commissioner. My immediate goal is to postpone this approval so that we can present alternative plans in conjunction with the medical community.

Paramount to our community would be the loss of jobs within our City ---1200 people are employed here in Glen Cove --- those jobs must remain here to avoid serious damage to our local economy.

To help resolve this situation I have met with Congressman Steve Israel, Governor Cuomo's Regional and Intergovernmental representatives, NS-LIJ COO Mark Solazzo, and spoken with many local government officials. I expect to meet with NS-LIJ CEO Michael Dowling in the near future.

It is important that you sign my electronic petition, which is on my Facebook page and at www.cityofglencoveli.us. Alternately, paper petitions are at City Hall, the Senior Center, Glen Cove and Locust Valley Libraries, the Med Station, Glen Cove Chemist, Dunkin Donuts, Forest Pizza, Sunrise Assisted Living, Leo's Tasty Corner, January's Salon in Locust Valley, and Women's Health Pavillion in Glen Head. This list is growing daily.

The volunteer fire departments, Sons of Italy, and clergy have joined this battle as well. More will be announced as we get more petitions in the field. Please call my office at City Hall 676-2004 if you want a petition packet for your business, homeowner's association, place of worship -- anywhere people stop by or gather.

Community Mourns Professor Vera von Wiren- Garczynski

Professor Vera von Wiren- Garczynski died suddenly in Glen Cove, NY on Saturday, August 3, 2013, after two massive strokes. She was born in Novi Sad, Yugoslavia, and was placed in a Nazi detention camp during WWII, when the Nazis invaded that country. After being released by the American forces, she met Stanley Garczynski, a polish officer who was also freed by the Americans after being imprisoned in the Nazi concentration camp, Auschwitz. They married in Munich, and she gave birth to her daughter Maria. The teenage bride and her husband immigrated to America via Ellis Island with her mother, Helen and their infant daughter. Soon after, she had two more children, Barbara and Waldemar. Before obtaining her doctorate, she worked as a model for Oleg Cassini, taught dance at Arthur Murray and acted as interpreter during the Khruschev visit to New York. She tutored Van Cliburn in the Russian language at Carnegie Hall before his 1959 award winning performance in Moscow. In 1961, after graduating from Brooklyn College, and while working on her graduate studies, she gave birth to her son Robert. Soon afterwards, she received her Masters degree from Columbia University, and her doctorate in Russian Area Studies from NYU. She taught Russian language and literature at the CUNY, and was a visiting scholar at the School for International Affairs at Columbia University.

Professor von Wiren Garczynski, who spoke seven languages, was very energetic, and enjoyed traveling. She was fervent in promoting good relations between her adopted country, America and the Slavic countries, whose heritage she shared. She carried messages between the White House and Lech Walesa in Poland in the early 1980's during the Solidarity Movement, and met with President Yeltsin in Moscow in the early 1990's. In 1998, she traveled to Russia at the invitation of the mayor of St. Petersburg to attend the funeral of the last Russian Tsar and his family. Her grand father, Admiral Robert Wiren was the first victim of the Bolshevik Revolution in Kronstadt. She was frequently invited to presidential luncheons at the White House during the Reagan and the older Bush administrations, and later by Hillary Clinton to discuss the First Lady's Central European trip. In the mid eighties, she spoke at the World Affairs Council in San Francisco on Soviet American relations. In 1990, she became the 33rd member of the International Women's Press club, a prestigious club known as "33Women and One Man."

She was chairman of the Commemorative Community of US Dept of Defense WW II Commemoration Committee. She was a member of the Nassau County Holocaust Committee, and a delegate of AIMAV, a subdivision UNESCO. She was Cultural Advisor to the Pulaski Police Association of NYC, and received Citizen of the Year Award in 1979. In 1986, she received the Ellis Island Congressional Medal of Honor for National Heritage contributions on the 100th anniversary of the Statue of Liberty.

She was the founder and president of Slavic American Cultural Association, and for over twenty years, together with SACA executive, Paul Wisniewski, had arranged for Slavic Dance Festivals at Morgan Park in Glen Cove. She and Mr. Wisniewski led the Solidarity March on the Soviet Compound on Dosoris Lane in Glen Cove. They put on cultural programs for deaf children in Milneck, L.I. For over twenty years, she arranged for exhibits of Eastern Culture, including teaching the art of painting Easter Eggs at the Glen Cove Library

Professor Vera was an active supporter and contributor to animal causes, and disabled veterans She is survived by her two daughters, attorney Maria Lawcewicz and attorney Barbara Wierbicki., and her three grandchildren from her son Robert: Maximilian, Alexandra and Katherine Garczynski.

An open letter to Mr. Michael Dowling, President and CEO NSLIJ Health System

Dear Mr. Dowling,

Having heard anxious concerns from friends and colleagues in different areas of my life, I would like to summarize several of the ways in which re-configuring Glen Cove Hospital from a full-service facility to an ambulatory care center will adversely affect our community.

With respect to full disclosure, in addition to being a resident of Glen Cove for 20-plus years, I am also a physician on staff at NSLIJ at Glen Cove, and I am also a candidate running for City Council this November on Mayor Suozzi's slate.

I've received calls from friends who work at the hospital but were afraid to voice their opinions in public. They and their co-workers are concerned - they've bought houses to be near their jobs, they chose jobs to be near their homes, and they've leased office space near the hospital where they have admitting privileges. They want to keep their seniority and their positions, and they want to stay where they are comfortable, especially in a small community hospital setting.

Granted, an ambulatory care facility will require staffing, but not the same numbers as are currently employed by the hospital. To Glen Cove, economically, this translates to fewer staff members frequenting our restaurants or ordering take-out, and fewer out-of-town staff running in to patronize, for example, our grocery stores, dry cleaners and hardware stores which are conveniently located near their workplace. Physicians may have to re-locate their practices so they can more easily pop back and forth between their office and their new hospital. This, too, affects the local economy and may lead to empty office spaces in Glen Cove. Unfortunately, not all patients will follow their physicians,

because proximity of care is important to a lot of people, and they may change to physicians who aren't even part of the NSLIJ system. If doctors, staff, and services move away, and if our businesses lose customers, then the ramifications to Glen Cove's economy and our tax base will be tremendous.

I believe having a hospital in our community adds to our property values, as well. When I promote Glen Cove, I speak of the services available to our residents, the parks, the beaches, the concerts, the golf course - and, I typically add, we have a hospital right here.

When Glen Cove Hospital was brought into the NSUH system approximately 20 years ago, City residents expected an even more full-service hospital; never was it expected that the City could actually lose access to nearby inpatient care. In fact, I doubt the acquisition would ever have been supported if there had been any doubts about the longevity of the facility. My understanding is that the ER is to remain, but who is going to pay for every patient who needs admission to be transported? Health insurance companies are already over-burdoned. Will the ER be staffed to manage unstable critical patients who need an ICUtype setting while managing all of the other emergencies? Have studies been performed to determine casualty rates of transported critical care patients? I, myself, have been admitted direct from this ER to the ICU upstairs - I can't imagine being transported in the condition I was in, and possibly having my specialty care delayed.

I hope the extremely dedicated auxiliary department is not going to be disbanded. My son recently started volunteering at the hospital, and I was told that this was not just a summer job, but that they expected a long-term commitment. I'm asking the NSLIJ system to show its commitment to Glen Cove now.

I kindly urge you to re-consider your decision and allow Glen Cove to retain the full-service hospital that, on many different levels, the City has come to rely on.

Furthermore, City residents can be assured that it will continue to stand, since a crucial part of the zoning that Mayor Suozzi adopted included a Preservation Plan – that must be recorded in the County Clerk's office – which GUARANTEES that the Glen Cove Mansion cannot be demolished to make way for additional development.

Mr. Spinello's convenient omission of this fact, along with the fact that the property's tax generation will nearly DOUBLE from this project, reveals an underlying political motivation that has nothing to do with his contrived concern for preserving the City of Glen Cove's historic treasures.

The harsh beauty of the land is as much a character in the book as Faina, their snow child. What is magic, what is real - these are the questions that haunt the reader long after the story has ended. TEL (516) 676-9000 FAX (516) 277-20 North Shore Schools, Glen Head, N.Y., August 7, 2013 – This summer, dedicated North Shore students and alumni participating in the LI Studies (LIS) Program continued construction inside of the new Victorian TV and Recording Studio located at the front entrance of the North Shore High School campus under the direction of Technology teacher Bruce Fichtman. Student workers included Eric Borchert, AJ Cavaliere, Ken Daly, Bryan Goetz, Rob Lerch, Andrew Poddoubnyi, and Emmanuel Varveris.

Mr. Fichtman said, "I was so impressed this summer by the students' work ethic and eagerness to make the building look absolutely perfect. In the heat of the summer, students diligently worked on a number of projects including:

- · Finished installation of all sheetrock and insulation
- · Taped and spackled all the sheetrock seams
- · Began priming interior walls with paint
- · Installed wooden jambs in interior openings
- · Installed a concrete (mud) floor in the foyer and bathroom (supervised by Ernie Di Vincenzo, former Board of Ed. President)
- · Installed subway white wall tiles in the bathroom
- \cdot Installed a mosaic pattern of floor tiles in the foyer and bathroom
- \cdot Began assembling duct work for geothermal cooling and heating system
- · Stained and polyurethaned interior doors of building

The tremendous task of building the Victorian TV and Recording Studio began in 2008. It is a collaboration among volunteer community members and North Shore students in the LI Studies (LIS) Program, just one of five interdisciplinary humanities courses offered to seniors at North Shore High School. It is the first building at the North Shore School District that will be heated and cooled using geothermal energy. Several school districts have visited North Shore to observe senior programs which have been recognized as Programs of Excellence by the New York State Council of Teachers of English. This project is funded by generous grants from the Viking Foundation.

Mr. Fichtman added, "During the years of construction, we have been fortunate to have the supervision and insight provided by residents of the district who are experts of their respective trades. Our community members have worked alongside our kids and have been fantastic mentors and teachers. It has been a lifelong learning experience for all involved in the building of the studio."

In the upcoming school year, the focus will continue to be on the interior construction of the building with projects including: installation of the geothermal heating and cooling system, painting of all interior ceilings and walls, installation of countertops and wooden floor in the studio, hallways, editing room and control rooms, and wainscoting of the studio, foyer and hallways. The estimated time of completion is for the 2014-15 school year.
