



Relationship Didn't Seem Right To Officer

While on patrol Glen Cove Police Officer Jason Grella observed a relationship that just didn't seem right which lead to the arrest of a 25-year old male. Detectives Glennon and Detective Lieutenant John Nagle of the Glen Cove Police Department arrested Tereso DeJesus Ruiz-Hernandez on Bayville Ave in Bayville and charged him with Rape 2nd degree and two counts of Criminal Sexual Act 2nd degree on August 19 at 6:50pm.

According to Glen Cove Det. Lt. John Nagle, The defendant, who is 25-years-old, allegedly met the 13-year-old female victim on Face Book, and arranged to meet the victim in Glen Cove. The defendant drove his 2001 Nissan Maxima to Glen Cove on multiple occasions to meet with the victim and

engaged in sexual activity with her according to police. The case was initiated when Glen Cove Police Officer Jason Grella observed the defendant and the victim sitting together in the defendant's vehicle in the early morning hours of August 9th.

The Officer alerted the victims family who did not know of their daughters meeting with the 25 year old man. The Glen Cove Detectives were assisted in the investigation by the Nassau County Special Victims Squad. The Glen Cove Police are asking anyone who may know of additional victims to contact the Glen Cove Police at 516-676-1002. The defendant was arraigned today in First District Court in Hempstead and held on \$20,000 bail.

City Charges Against Hospital Continue

The Gold Coast Gazette has learned that the City of Glen Cove's suit brought against Glen Cove Hospital, Montclair Care Center, Inc., Forest Care Center, Inc., I. Dupont de Nemours & Co., Arkema, Inc., and Honeywell International Inc. has two less defendants. According to the Stipulation of Discontinuance Against Montclair Care Center Inc. (MCCI) and Forest Manor Care Center Inc. (FMCCI), [filed: Nassau Co. Clerk 6/11/13] ... "any and all claims existing at the time of the Complaint (8/31/12) or otherwise set forth in the Complaint by the City of Glen Cove against MCCI and FMCCI, in the above-entitled action are hereby discontinued without prejudice subject to the Parties' tolling agreement dated May 31, 2013. Each party shall bear its own costs."

In the City's original complaint it stated that, "as a result of Defendants' E.I. du Pont De Nemours & Co., Arkema, Inc. and Honeywell Intl., Inc. (the "Manufacturing Defendants") manufacture and sale of the defectively designed product chlorodifluoromethane (commonly referred to as R-22 or HCFC-22) and discharge and release of R-22 by Defendants NSUH at Glen Cove [Glen Cove Hospital] into underground aquifers that resulted in contamination of the City's groundwater supply." According to Defendant Honeywell Intl., Inc.'s Memorandum of Law in Op-

position to Plaintiff's Motion for Protective Order, [filed: Nassau Co. Clerk 6/20/13]... "The following facts are drawn from Plaintiff's Complaint and testimony taken to date. On March 8, 2010, a test (the March 8 test) conducted on a sample drawn from Seaman Road Well (Well 2S) in the City's water system reported the detection of R-22 at a concentration of 5.2 parts per billion (ppb). According to the Plaintiff, the legally allowable concentration for R-22 in the City's drinking water is 5 ppb. EcoTest Labs, which conducted the analysis, immediately notified the City of the test result, and the City shut down Well 2S.

"That same day, after receiving the call from EcoTest, the City also received a call from Nassau County Department of Health (NCDOH), which had also been notified by EcoTest of the March 8 test result. Among other things, the NCDOH requested that the City shut down the well and conduct tests of water drawn from points in the distribution system within one mile of the well. The Mayor was notified of the detection of R-22 in Well 2S, and the NCDOH's notification to remove Well 2S from service. As directed by the NCDOH, the City took water samples from six different locations within a one-mile radius of the well. Every one of those samples showed the amount of R-22 in the drinking water was either non-detectable or far below

5 ppb. In fact, none of the distribution samples showed readings anywhere near 5 ppb, and the average of the six sample test results was 0.6 ppb.

"The City did not immediately retest the raw water sample to attempt to ascertain the reliability of the earlier 5.2 ppb detection. However, for the next sixteen months, the City conducted monthly tests on water drawn directly from Well 2S. Each of those tests showed that water drawn from the well had levels of R-22 well below 5 ppb limit. In fact, other than the single March 8 test result, there has been no test result showing R-22 at a level over 5 ppb.

"The City and the NCDOH engaged in discussions regarding how to address the possible presence of R-22 in the water drawn from Well 2S. In particular, the Mayor directly received or was copied on numerous letters and e-mails concerning Well 2S, and corresponded with William Archambault, the City of Glen Cove's Director of Public Works ("DPW") regarding what was to be done with regard to the well. Mr. Archambault met and corresponded with representatives of the NCDOH concerning NCDOH's requirements. Although testing subsequent to the March 8 test showed levels of R-22 as either non-detectable or significantly lower than 5 ppb, City employees have stated that they understood that the NCDOH was nonetheless requiring the City

to keep Well 2S out of service and to install additional treatment.

"In the months after the March 8 test result, the Mayor held meetings with the Mr. Archambault, the City Attorney and others to discuss the R-22 issue and the City's response. Documents provided by the City in response to defendants' discovery demands confirm that the Mayor was an active participant in decisions made concerning Well 2S.

"Mr. Archambault engaged Holtzmacher, McLendon & Murrell, P.C. (H2M), an engineering consultant, to conduct a study of possible alternatives for treating water drawn from the well. In its report to the City, H2M emphasized that it had insufficient information to determine what amount of R-22, if any, is in the groundwater drawn by Well 2S. Instead, in order to be 'conservative,' H2M simply assumed, without analytical evidence, that theoretically there could be a 'plume' of R-22 in the groundwater, and that the concentration in such hypothetical plume could reach 200 ppb. Based on these conjectures, H2M detailed a plan for a \$5.4 million treatment system. The Mayor received the H2M report and discussed it with Mr. Archambault. He asked whether there were alternatives

Victoria is President of the Daughters of the British Empire (DBE) in New York State, a national organization of women of British birth and heritage, and Regent of the Long Island chapter.

She has been the DBE poet laureate since 2009. In 2012, Victoria was elected to the Board of Trustees of the Historic Royal Palaces in London. The palaces include The Tower of London, Kensington Palace, Whitehall Palace, Hampton Court Palace and Kew Palace.

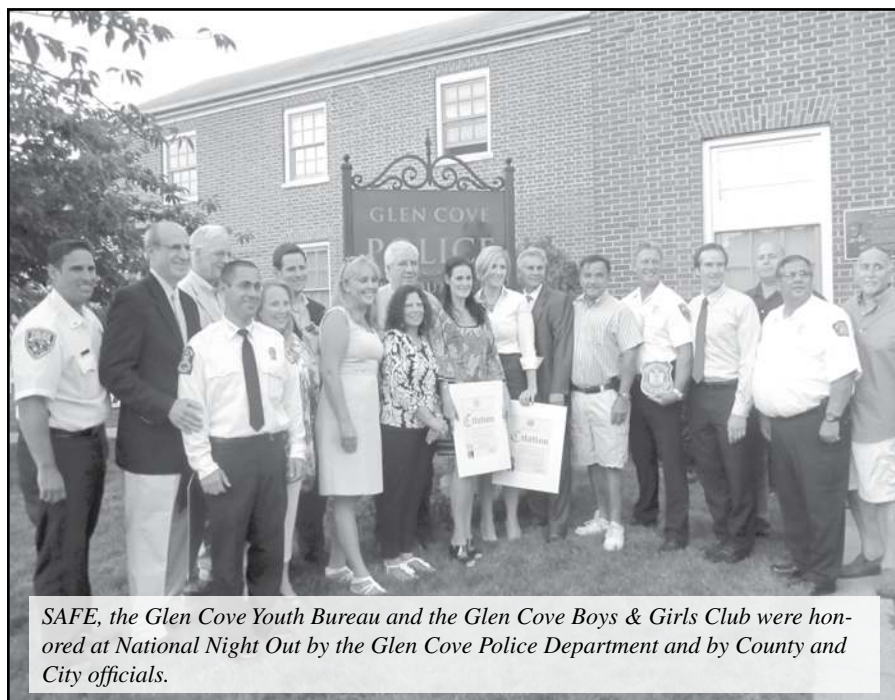

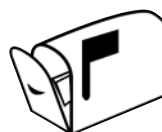
The Mansion was not Saved Part 2

A response to comments from Mr. Langley Co-President Montclair Hotel

I usually am very careful in doing my research and when necessary seek opinion from a legal professional before putting pen to paper. Hence, it is with total confidence that I repeat my original statement that the Mansion Was Not Saved. As a general statement of law, a property owner cannot be stopped from demolishing a building he owns. As per the Declaration of Easements, Restrictions and Covenants, if they demo the original historic building, any reconstruction must be "in kind" to match the appearance and character of the original structure. Alternatively, if the building were to be demolished or destroyed and not restored, that would trigger the transfer to the City of Area C (the contributory grounds), because the uses of the historic building would have ceased for one year. Mr. Langley also claims that this preservation plan will preserve the commercial tax base. The simple fact is by law, schools are permitted as of right in an R-1 District and houses of worship are allowed by special permit. With that being said there is no preserving of the commercial tax revenue with this subdivision. Perhaps Mr. Langley should look at his business model rather than having the city compromise our green belt for answers. Why take aim at me, I'm only

I've lived in this area for over 35 years, more than half of which I spent as a Glen Cove resident. I first moved to Glen Cove right when those ridiculous eyesores of parking garages on Brewster Street were going up. I was here to watch the construction of the two completely out of place office buildings that were needed in order to attach something to the garages that should never have been erected in the first place. I was around when Village Square – an astonishingly inept attempt to revitalize a failing downtown – got built. Cheap metal doors and even cheaper signage adorn that wall. It could have been different with even the slightest grain of thought if only the board that approved it simply said, "You can build it, but it's got to look like Wheatley Plaza; other-

wise, don't put it up." So, instead of a downtown park, Glen Cove got downtown blight because of a complete lack of competent leadership.

Each and every one of these projects and more, I dare say, were undertaken through successive administrations which, oddly enough, had one thing in common – the utter ineptitude and abysmal lack of skill exhibited by leaders who did not put the City's interests first. Democrats, Republicans, it made no difference. One administration after another – one mayor after another – they all played a role in helping to despoil Glen Cove's image. Whether it was in a vain attempt to broaden the tax base of a municipality that spent money like a drunken sailor, or whether it was to do political friends a favor, or whether it was for any other number of other ham-fisted reasons, the fact is that each successive city administration has managed to pile one bad project on top of another. And now the City is besieged with buildings that do nothing except diminish the beauty of what could have been had anyone come along with the single-minded, apolitical purpose of focusing only on making Glen Cove a better place.

Now, it appears that there may be an opportunity for Glen Cove to save itself before many more Village Squares or Avalons or other miscreations like them continue to spread like a blight on what could and should otherwise be a beau-

tiful city. It's pretty simple, and here's how I see it.

In all the years I've been here, there has never once been a politician running for the office of Glen Cove Mayor who either (1) didn't need the job, or (2) didn't envision the job as anything other than a stepping stone to some other political office. This year, however, is the first year of which I am aware in the last four decades that someone is running for the mayoralty and he neither needs the job nor appears to have any agenda to move on to another elected office using Glen Cove as a springboard. Nope, this time there's a guy whose only interest appears to be making Glen Cove a better place to live. And he may be the only fellow around who has the skillset necessary to stop the decades-old slide that has been steadily transforming Glen Cove into the next Hempstead.

If, on the other hand, you'd like to see something change, and if you want to take part in helping Glen Cove save itself, you may just want to consider voting for Reggie Spinello for Mayor. His qualifications? Simple. He's a successful businessman with a proven record of accomplishment who doesn't need the job, and he isn't looking to run for another office. That alone doesn't just qualify him for the job, it makes him the only candidate in this race capable of handling it. The fact is, given Glen Cove's political history – both past and current – there's almost nothing Mr. Spinello could do to make things worse, but without someone like him at the helm of this sinking ship . . . well, who even wants to think about that?

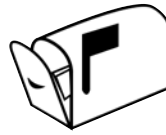
Councilmen Spinello and Gallo Meet with Hospital Officials

To The Editor,

From the moment the news broke that North Shore LIJ was downsizing its Glen Cove campus by closing its inpatient facility, we have heard from many residents who are fearful at the prospect of not having a nearby hospital that runs at full capacity. I assure you that we share your concerns.

As your City Councilmen, and most of all lifelong Glen Cove residents, we have spent countless hours worried about

the impact the inpatient closure will have on Glen Cove's fragile economy. Can North Shore LIJ live up to their promise to preserve each job by placing employees in other facilities? How will each employee deal with being displaced? How do we address the fears of Glen Cove's growing senior population as it relates to being transported to other facilities instead of being able to stay near their home and families? Will there be any inpatient beds and, if so, how many?

These are some of the questions we had. So, on Friday morning, August 16, we met with Mark Solazzo, COO of NSLIJ and Susan Kwiatek Exec. Dir. Glen Cove Campus. We asked them to share the hospital's vision and long term goals for the changes as they relate to our community. The following is a summary.

Employees

Employees are classified into four groups and they are: Employees not affected (for example ER, Ambulatory, and Critical Decision Beds, etc); Employees being transferred to different jobs within the Glen Cove campus; Employees being transferred to another facility (Brain Trauma, Orthopedic Surgery etc); and Employees offered other positions but unable to transfer (i.e. no means of transportation). The hospital is placing a high priority on this last group to accommodate their situation.

Seniors

The Emergency Room services will continue with planned expansion of Geriatric services.

The transferring of patients to other facilities will be done at the hospital's expense. NSLIJ will be working directly with local senior facilities to provide more resources such as nurse practitioners who can evaluate patient needs and make decisions on patient treatment and placement.

Beds

A limited number of inpatient beds will remain. These are referred to as critical decision beds or 36-hour beds that will accommodate patients who must be transferred to other facilities for treatment. The number of beds to remain and for what period of time is yet to be determined. No final decision has been made at this time.

Conclusion

Glen Cove Hospital is NOT closing. The Emergency Room will remain. The ambulatory services will remain. For now a limited number of inpatient beds will remain. Family Practice will remain.

We will continue to keep you informed with facts. Moving forward in our elected capacity and responsibility we will partner with NSLIJ to make sure the hospital in Glen Cove continues to provide services for our community.

Questioning Comptroller Maragos on Tree Cutting

To The Editor,

I want to submit a short note to my constituents who are undoubtedly upset over recent news reports, in which Comptroller George Maragos states that all tree cutting in Welwyn and other county areas was completely necessary. The short version of his statement is that all trees needed to come down. Plenty people have raised a case to the contrary.

Since Mr. Maragos has put out this report seeking to clear himself and the candidate for County Executive with whom he will be sharing a party line on the ballot this November, Edward Mangano, I need to respond.

First, to me, the report raises more questions than it answers. It says that the comptroller sent auditors out to the sites. Were they certified arborists or his accountants? Further, if I read the report correctly, it suggests that "independent monitors" said the work was OK, therefore it was OK to the comptroller. My understanding is that the monitors were hired by Mangano – some may be campaign contributors, possibly even the sister of the Public Works Commissioner – therefore they are not necessarily independent. The comptroller's office is actually supposed to be the independent office that verifies what the county pays. If they are relying on these companies that the county hired, I have an issue.

Second, I met with the comptroller's staff earlier this year to inquire into his process for reviewing and verifying the "emergency" tree work.

When we visited Comptroller Maragos' office to do this review, my Legislative Caucus attorney, my Finance Director and I were not satisfied with what we saw.

We have spent subsequent months seeking follow-up information with so little success that we were forced into a prolonged Freedom of Information or "FOIL" process, which is still ongoing to this day. Legislators should not have to resort to FOILING – government offices are obligated to share information. If everything is so clear cut and above board, I don't understand why there is not more transparency, and why Maragos' office would avoid basic inquiries and force a legal back-and-forth. (Just this week, I had to appeal the comptroller's denial of certain information, including the actual documentation Comptroller Maragos used to verify that all tree work was necessary and was billed correctly.)

I have much more to say that will soon be relayed to you. I certainly have questions about the Comptroller's report that I am looking into now. For today, I simply want to assure my constituents that my office is still deep in the process of investigating the issues covered in the Comptroller's report, which reflect the

tree cutting ordered by County Executive Mangano.

Also still investigating this entire issue of Nassau County's post-Sandy debris work are the Nassau County District Attorney and the New York State Attorney General.

Last Week's Celebrity

Last week's celebrity was born Frank Andrew Lovejoy Jr.. Among his many roles, he played a police lieutenant in a 1953 American horror film, "House of Wax", starring Vincent Price. It was a remake of Warners' "Mystery of the Wax Museum" (1933) with Fay Wray. He was in several war movies, notably Joseph H. Lweis' "Retreat, Hell" (1952) which portrayed the U.S. Marine Corps' retreat from the Chosin Reservoir during the Korean War. In 1951, he had the title role in "I Was a Communist for the FBI". He starred in two short-run TV series, "Man Against Crime" and "Meet McGraw". Among his last performances were roles on an episode of ABC series "Bus Stop" with Marilyn Maxwell and the ABC crime drama "Target: The Corruptors". On Oct. 2, 1962, Lovejoy died of a heart attack in his sleep at his residence in NYC. His wife, Joan Banks, called for medical help after she was unable to wake him. The couple had been appearing in a New Jersey production of the Gore Vidal play "The Best Man". As a note, the original play "The Best Man", which opened on Broadway on March 31, 1960, starred Melvyn Douglas. Ronald Regan auditioned, without success, for the lead. Ironically, Vidal did not think he could play a credible president. The play just celebrated a Broadway revival in 2012 with James Earl Jones, Angela Lansbury, John Larroquette, Candace Bergen, Eric McCormack and Michael McKean.

This week's celebrity was an American actor and author. He was born in Montclair, New Jersey on March 26, 1916 and grew up in coastal towns of New England. He was a genuine adventurer and man of action, not dissimilar from many of his movie parts. He dropped out of high school at the age of 16 and took a job as a mate on a schooner. His first voyage was to Newport Beach, Calif. from New London, Conn.. Later, he was a fisherman on the Grand Banks of Newfoundland, ran a charter yacht and served as a fireman on trips to Cuba aboard a steamer. He skippered a trading schooner in the Caribbean after earning his master's license, and in 1937, he served as a mate on a world cruise of the two mast schooner, YANKEE. He became a print model and later signed a contract with Paramount Pictures, who dubbed the 6'5" actor "The Most Beautiful Man in the Movies" and "The Beautiful Blond Viking God". His first film, "Virginia" (1941), starred Madeleine Carroll, with whom he fell in love and married (1942-46). For most of his career as a leading man, he specialized in westerns and film noir, such as "Johnny Guitar" (1954) with Joan Crawford and Mercedes McCambridge, "The Asphalt Jungle" (1950), a film noir directed by John Huston with Jean Hagen and Sam Jaffe, and "The Killing", another film noir directed by Stanley Kubrick with Vince Edwards and Elisha Cook, Jr.

ly, the widely accepted RFP (Request for Proposal) process was not utilized by the Mayor to negotiate the sale of Pascucci Field. The lack of an RFP was an error in judgment for all involved. A healthy conversation must take place to discuss amending a City Charter that trumps the RFP process.

There is an expectation of transparency in government and I made a motion to table the sale of Pascucci Field because the process was greatly flawed. Thankfully, Councilman Spinello supported the cause and seconded my motion to table the sale. A few weeks before the vote, by coincidence it was discovered that there was actually another party with interest and an additional proposal to enhance and improve upon the public recreational space known as Pascucci Field. Unfortunately, this critical information was not presented to the Council by the Mayor. Going forward, in order to protect these

valuable public green spaces it is in the best interest of our community to require an RFP for the future sale of any public land. In doing so, this will create a fair and transparent opportunity for all future proposals.

I believe that the public's recreational spaces must be preserved and redesigned with a focus on creating spaces that allow for participation in life-long recreational activities.

As a teacher and councilman, my students urge me to help create an environment in Glen Cove that is safe, fun, entertaining, and youth centered. to installing the proposed \$5.4 million stripper. Mr. Archambault cannot recall whether he discussed with the Mayor the extent of H2M's uncertainties regarding the amount of R-22 in the aquifer.

"As part of his capital budget proposal, Mr. Archambault proposed to the Mayor that funds be allocated to study what amount of R-22, if any, was in the groundwater. The study would have cost \$35,000 to \$50,000. However, that item was cut from the DPW budget after having been proposed to the Mayor. As a result, the study was never done. The Mayor also discussed with Mr. Archambault, and possibly with the City Attorney, the potential source of the R-22, in order to allow the City to 'possibly open up a dialogue with them to see if they would assist the city to address those issues.'

"The Mayor was involved in, and directed, discussions relating to the litigation. The Mayor received certain information from Mr. Archambault, but it was the Mayor--- not Mr. Archambault--- who made the decision to commence litigation. And no other witnesses can speak with certainty about other individuals with whom the Mayor may have consulted regarding the detection of R-22, what information the Mayor considered, what facts the Mayor found persuasive and/or dispositive, what other witnesses may have been involved, and why the obvious gaps in the evidence of a 'plume' were apparently disregarded."

According to the Affirmation in Opposition to Motion for Protective Order, [filed: Nassau Co. Clerk 6/20/13]... "To date, Plaintiff has not provided a single witness that can explain any link between the Hospital and Plaintiff's damages, nor a single witness who authorized the choice to commence this lawsuit against the defendants. And, as numerous wit-

nesses testified, Mayor Suozzi is the one who ultimately chose to sue the Hospital, and therefore is the only one who could possibly explain these decisions... Incredibly, Plaintiff commenced this action against the Hospital despite collecting samples two months prior to serving its complaint that showed non-detect levels of R-22 in the Hospital's wells. Ignoring this data, Plaintiff determined that it was more worthwhile to sue rather than conduct an adequate investigation into potential source of contamination."

Also, according to the Affirmation of Ken L. Hashimoto [Esq.] in Support of Motion on Consent of All Parties for Subpoena of Nassau County Department of Health [filed: Nassau Co. Clerk 8/7/13], in one of the claims of relief... "the hospital defendant's actions and inactions have caused the unauthorized invasion of and interference with Plaintiff's property... and continue to cause, the interference with Plaintiff's interests in, and use and enjoyment of, Plaintiff's property... this invasion and interference constitutes a trespass and has proximately caused and continues to cause Plaintiff to suffer harm and damages... as a result of said negligence per se, the Hospital is liable to plaintiff for damages including, but not limited to, costs incurred in treating the R-22 contamination, attorneys' fee, engineering and consulting fees, and other damages, incidental and consequential, plus costs of the ongoing operation and maintenance of a treatment system at Supply Well. No. 22."

Also, on June 29, 2012, sixty-four days before the City filed suit against all the defendants, EcoTest Labs, who performed the analysis of the March 8, 2010 Well 2S water sample, and H2M, the engineering consultants who detailed a plan for a \$5.4 million treatment system for that well, merged. (<http://www.ecotestlabs.com/>)
