

## Little Hero Honored at Glen Cove City Council Meeting

Tuesday night's Glen Cove City Council Meeting verified the date of August 30th to be officially named as Nicholas Pedone Day, in honor of the late 8 year old boy who suffered from Leukemia. Esteemed and loved by his community, friends, and family, Nicholas Pedone was a reminder of hope, strength, and courage to the lives he's touched with his story and his smile. In an emotional tribute, Mayor Ralph Suozzi took a moment to pay his condolences to Pedone's parents, Josephine and Nicholas Sr., while presenting a plaque in recognition of their son's official day.

"I never knew how great of a community we had until 8 years ago," states Josephine Pedone, in recognition and gratitude of the immense support, love, and kindness the citizens of Glen Cove have shown toward Nicholas in his lifetime.

In his memory, discussions of a garden and bench at Stanco Park are in place, as well as making the 5k run which took place last year to be now an annual event. The Pedones have also stated they will be in the works of placing two college scholarships at the Glen Cove High School, as they feel it is important to pay it forward.

### Glen Cove's Annual STOP Program is Saturday September 21st

Mayor Ralph V. Suozzi has announced that this year's second STOP (Stop Throwing Out Pollutants) Program will be held on Saturday, September 21 from 9 a.m. to 4 p.m. (Raindate September 28th) at the Winters Brothers facility located at the end of Morris Avenue.

Each year, Glen Cove provides our residents with an environmentally sound way to dispose of household trash that is too unsafe or hazardous for regular disposal. This year the City of Glen Cove has added a second STOP Program, in addition to our E-Waste Program and Shed the Meds Program.

On September 21st, residents are urged to bring items such as aerosol cans, air conditioning refrigerants, antifreeze, automobile batteries, household batteries, brake and transmission fluids, bug and rodent killers, enamel, lead and oil based paints (Water or latex based paints are no longer accepted), paint thinner, automobile tires, oven cleaner, polish and wood preservatives, unused flammable liquids, waste oil, insecticides, pesticides, fertilizers, rug and upholstery cleaners, pool chemicals and empty barbecue propane tanks to the Morris Avenue site for proper disposal.

This program is open to Glen Cove Residents Only, proof of residency is required. Only residential waste will be accepted, commercial waste will not be accepted. Please do not bring explosives, smoke detectors, fireworks, medical waste or unidentifiable items.

tember as "Childhood Cancer Awareness Month" after our own community was struck by the loss of one of our little fighters. The Mayor urges citizens to wear and display orange in recognition.

Also discussed at the meeting was the controversial topic of recent claims of a lawsuit between the Glen Cove Hospital and the City of Glen Cove brought up by media outlets. It had been stated that the lawsuit, which took place long before the announcement of the hospital's proposed closing of in-patient beds, was against unsafe levels of Freon contaminating well water and that the hospital was the "most likely" source of the contaminants. The Mayor states the city was simply doing what was needed to be done to keep citizens safe from contaminated water, and that in no way did it play any influence on the hospital's decision to remove in-patient beds. Two residents raised questions concerning the validity of the lawsuit, asking why the city would sue if there was no direct evidence that the hospital contaminated the well? The Mayor made the point that the hospital had a geo-thermal system unit since 1966 and it was almost fifty years old when it was recently upgraded. Also, City Attorney Vincent Taranto added that the law firm chosen by the city to represent it was a very successful and promi-

nent firm and was contracted on a contingency basis, so it wasn't costing the city any money. He also added that the City Council voted in July 2010 to retain the law firm.

The Mayor also announced to the public a rally to take place this Saturday at 11am outside the Glen Cove Public Library in opposition to the hospital's decision to remove in-patient beds. The Mayor hopes everyone will be able to attend.

Also on the agenda was a discussion about the redesigning of the Herb Hill/Garvies Point Road in order to both improve as well as pave the way for accommodations on the larger scale waterfront project.

Events coming up in the following months were also resolved, including St. John's Lattingtown's annual Country Fair to be held on September 7th, as well as the Hermandad Latino-Americana Del Señor De Los Milagros De Glen Cove procession to take place October 13 from St. Patrick's Church to Walnut Road. The Glen Cove Junior Soccer League also will have their annual parade September 21st at 9am on Forest Avenue. Martino Auto Body will be hosting their annual "Gold Coast Concourse" on September 8th 3pm to 6pm on Cove Street. The council hopes to see you at these upcoming events.

## Fall Sports Squirts And Tennis Programs Offered By Glen Cove Parks & Recreation

The City of Glen Cove Parks & Recreation Dept., in partnership with US Sports Institute, is pleased to offer two exciting fall program for local youth.

Sports Squirts, for children ages three thru five, is a fun way to introduce children to a variety of sports such as soccer, teeball, basketball, lacrosse and hockey, as well as fun playground games. All activities promote hand-eye coordination, movement, balance and most importantly – fun!

The 2013 Fall Sports Squirts program will be offered as an after-school program on Wednesday afternoons from September 18 through October 30 (seven sessions). Sports Squirts will be held at John Maccarone Memorial (City) Stadium from 4:00 PM – 5:00 PM. The fee is \$105 per child.

First Play Tennis is geared towards players who are of beginner to intermediate level and will teach children the basic fundamentals of forehand, backhand, volley, serve and rallying, as well as court movement, shot selection and footwork. The enthusiastic coaches follow USTA guidelines and curriculum. Instruction is in small groups, not individual, and players are required to supply their own racquet. Sessions will be held at the Stanco Park courts at the Glen Cove Golf Course on Sundays from September 15 through October 27 (seven sessions). Children ages 5-7 will attend the 12:30 PM to 1:30 PM session; ages 8 -10 will attend the 1:45 PM to 3:15 PM session and ages 11-14 from 3:30 to 5:00 PM. The Tennis Clinic program fee is only \$100 for the one-hour 5-7 year old session and \$145 for the one-and-a-hour sessions for ages 8-14.

These programs promise to provide a learning experience for your child in a fun environment. Space is limited, so enroll today. Glen Cove residency is not required for these unique programs. # Mayor Suozzi Announces Reelection Run and His City Council Team

Incumbent Ralph Suozzi today formally announced that he will run for reelection as Mayor of Glen Cove. "I'm running on my record," said Suozzi. "We've trimmed the deficit by 79%. We've had five budgets in a row for which our expenses came in under budget. We negotiated historic public employee and police contracts so that all new employees contribute to their health benefits." Suozzi also announced that the following candidates will run on his ticket for the Glen Cove City Council: Eve Lupenko, M.D., Martin Carmody, Nick DiLeo, Mike Famiglietti, Tony Jimenez, and Tim Tenke.

"I look forward to working with these exemplary public servants to continue to improve life in our beautiful waterfront community," said Suozzi. Dr. Lupenko, who is running for the first time, applauded Mayor Suozzi for his tireless efforts regarding the Glen Cove Hospital. "Ralph Suozzi is always looking out for the health and well-being of the citizens of Glen Cove. He cares very deeply about this community. It's an honor to run with him," she said. Councilman Famiglietti said, "As former CEO of the YMCA of Long Island, I am amazed at how dedicated, focused and results-driven Ralph is, and how he handles everything thrown at him from Superstorm Sandy to the budget. He has demonstrated the ability to keep this city moving forward during some very challenging times. He never stops fighting for Glen Cove."

Mayor Suozzi has the support of the Democratic Party, the Working Families Party and the independent Glen Cove Voters Party, which he created in 2005.

Other achievements by Ralph Suozzi in Glen Cove are:

- Eliminated \$4 million in annual expenses for the city's sewage treatment plant, transferred to Nassau County in 2008, saving \$23 million to date.
- Initiated third-party ambulance billing in 2009, bringing in non-taxpayer revenue from insurance companies exceeding \$3 million.

- Secured more than \$35 million in federal, state and county grants.
- Secured nearly \$1 million in FEMA funds following Superstorm Sandy, and helped thousands of residents during and after the storm.
- Upgraded key city equipment, including 3 new ambulances, fire trucks, police vehicles, sanitation trucks and street sweepers.
- Purchased lifesaving Automatic External Defibrillator (AED) devices for all public buildings and parks.
- Recently acquired \$815,000 from the U.S. EPA to remediate the final acre and

one third of the 52-acre waterfront redevelopment area.

- Saved the historic Glen Cove Mansion on Dosoris Lane.
- Implemented the Emergency Notification System, used to alert citizens about storms, emergencies, changes in municipal and special services, like the E-waste, S.T.O.P and Shed-the-Meds programs.
- Improved infrastructure throughout the city, at the Glen Cove Course and other city park and recreational facilities.
- Joined with Downtown Sounds to extend concerts beyond July to encompass August.

• Major improvements to roads, sidewalks and the water distribution system affecting all neighborhoods.

• Instituted cardboard recycling which lowers city trash expenses and provides a new non-taxpayer revenue source. Mayor Ralph Suozzi has opened a headquarters office at 3 School Street, which supplements the Nassau County Democratic Glen Cove headquarters located at 102 School Street.

# Name the Celebrity



This week's celebrity was born in Red Bank, New Jersey on Nov. 5, 1900. Her secretive habit of concealing her true age was legendary, never even telling her husband, Louis Calhern (m. 1933-42). The year 1912 was generally given as her birth for many years, which few believed, yet her actual year of birth of 1900, not discovered until after her death, shocked even her intimate friends.

Appearing in seventeen plays between 1927 and 1959, she began her career as an actress on Broadway before moving to Los Angeles in 1941 to work on films. She often played supportive roles. She and her husband had no children and long after their divorce, the two appeared together in the 1956 film, "Forever, Darling" with Lucille Ball, Desi Arnaz and James Mason. During much of the 1940's and 1950's, she was romantically linked to author and playwright, George F. Kaufman. Other films in which she appeared were "Reunion in France" (1942) with John Wayne and Joan Crawford, "Dishonored Lady" (1947) with Hedy Lamarr and "The Snake Pit" (1948) with Olivia de Havilland, Celeste Holm, Beulah Bondi and Lee Patrick. She was a guest star on many TV series, including "I Love Lucy", "The Brady Bunch", "The Beverly Hillbillies", "Mayberry RFD", "Phyllis", and the CBS daytime serial, "Search for Tomorrow" as "Helen

Collins", the mother of characters "Wade and Clay Collins."

## Last Week's Celebrity

Last week's celebrity was Sterling Hayden. During WWII, after he appeared in two movies, he joined the Marines under the "John Hamilton", which was a pseudonym Hayden only used in the military. While at Parris Island, he was recommended for Officer Candidate School. After graduation, he was transferred to service as an undercover agent with William J. Donovan's COI office. He remained there after it became the OSS. As OSS agent "John Hamilton", his WWII service included sailing supplies from Italy to Yugoslav partisans and parachuting into fascist Croatia. He also participated in the Naples-Foggia campaign, established air crew rescue teams in enemy occupied territory, became a first lieutenant on 9/13/44 and a captain on 2/14/45. He received the Silver Star for gallantry in action in the Balkans and Mediterranean, and a Bronze Arrowhead device for parachuting behind enemy

lines. He was honorably discharged on 2/24/45.

He became noted as a character actor for such roles as "Gen. Jack D. Ripper" in "Dr. Strangelove or How I Learned to Stop Worrying and Love the Bomb" (1964). He also played the Irish-American policeman, "Capt. McCluskey", in Francis Ford Coppola's "The Godfather" in 1972, and the novelist Roger Wade in 1973's "The Long Goodbye" with Elliott Gould, as detective "Philip Marlowe." With the resurgence of his career, he bought a canal barge in the Netherlands in 1969, and eventually moved it to the heart of Paris and lived on it part-time, while having another home in Wilton, Conn.. He had told TV personality Tom

Synder that he had lived a very full life. He passed away from prostate cancer on May 23, 1986, at the age of 70.

I just finished a book you might enjoy A PERSON OF INTEREST by Susan Choi. Choi's novel combines two high profile cases of the early 2000's- the Unabomber and Wen Ho Lee, a scientist falsely accused of espionage. Choi's person of interest is not a particularly appealing character- Professor Lee is a rather elderly Asian-American who has a tenured position in the math department of a third rate mid

-western university. He is suspicious, jealous, and intractable. The novel opens with the violent death of a charismatic young math teacher whose office Lee shares. Why was this young man chosen- or was he chosen? Could Lee have been the target or was Lee actually the perpetrator? As we watch with horror, we see Lee making mistake after mistake, cementing public opinion against him. Lee gradually reveals his shameful past, but we continue to root for him as more and more damaging circumstantial evidence is unearthed. This is a fascinating study of the power of fear, antipathy, prejudice and 'otherness'... and how all of us are complicit. Recommended!
