tinue offering emergency services while maintaining an unspecified number of beds depending on need.

Prompted by Officials including Glen Cove Mayor Ralph V. Suozzi, Assemblyman Charles Lavine, Nassau County Legislator Delia DeRiggi-Whitton, and others, residents shouted, "Save our Hospital," and carried signs with slogans such as, "It's about people not money."

The Glen Cove Chamber of Commerce announces it has secured a section of a beam retrieved from the twin towers and 9/11 tragedy. Over the course of two years, since it was first obtained in 2011, Executive Director Phyllis Gorham has been coordinating the creation of the beam into an outdoor sculpture for all to admire and reflect on this “never to forget day” in history. Tony Tripp, then the Fire Chief, was instrumental in getting the beam delivered to Tom Molloy of Tom’s Lawnmower Service in Glen Head. Tom is well known for his skill and talent at welding and was asked to put his creativity in motion to design the beam into artwork worthy to both commemorate the 9/11 event and to honor those who continue to put their lives on the line as firefighters.

# City Release On Hospital Litigation

The following press release was issued by The City of Glen Cove this week.

In recent articles, questions have been raised about a pending litigation between the City of Glen Cove, North Shore Long Island Jewish Hospital (“NS-LIJ”) and others. Speculation related to recent cutbacks in NS-LIJ’s services to the community (Glen Cove Hospital) has suggested that the litigation is the reason for the changes. As Mayor Ralph Suozzi confirmed in speaking with Mark Solazzo, COO of the NS-LIJ Health System, the cutback in services is completely unrelated to the litigation.

In an attempt to set the record straight and address some of the issues wrongfully reported in the Gold Coast Gazette, [all reports were printed from court documents filed with the Nassau County Court Clerk by both parties] the City refutes baseless accusations of extortion and conspiracy in court filings by an attorney for NS-LIJ. As Mayor Suozzi explains, the City had no choice about commencing its suit against those who negligently polluted the City’s water. Indeed, said the Mayor, “City Council tried to avoid litigation but ultimately we had no choice. The choice was either the citizens pay or the polluters pay. We chose to go after the polluters.”

In September 2009, testing revealed the presence of a toxic chemical called Chlorodifluoromethane in the groundwater pumped from the City’s “Seaman Road Well”. Chlorodifluoromethane (“R-22,” sometimes referred to as Freon-22) is a liquefied gas used in refrigeration and air conditioning systems. Due to its deleterious effects on the ozone layer, this man-made chemical compound is being phased out world-wide by signatories to the Montreal Protocol, including the United States of America.

From September 2009 through February 2010, routine monthly water testing showed that the amount of Freon in the City’s water from the Seaman Road Well was steadily increasing. Fortunately, the City was able to utilize a pre-existing Granulated Activated Carbon (GAC) filter to make sure the Freon did not reach its water customers.

On March 8, 2010, however, Freon levels in the City’s water supply surpassed the New York State and Nassau County Department of Health’s Maximum Contaminant Level (also known as the “MCL”). According to Nassau County Department of Health (“NCDOH”) policy, when a contaminant exceeds the MCL, the Well must be shut down, distribution samples must be taken and the system must be flushed to prevent those contaminants from reaching citizens’ taps. The City complied with these requirements to protect its residents and the Seaman Road Well has been off-line ever since.

The Freon did not make it to residents’ taps because of the hard work and diligence of the Department of Public

Works and Mayor Suozzi, working in conjunction with the NCDOH. Since the Freon exceeded the MDL, the NCDOH requires that the City install a new Air Stripping Treatment Plant before the well may be brought back on-line. The Air Stripping Plant is estimated to cost approximately 5.4 million dollars to build and operate. According to NCDOH, while the current GAC treatment system works well in removing other contaminants that have historically been found in the Seaman Road Well capture zone, that system is not an effective or efficient filtering system for removing Freon.

Even though the City could operate the Seaman Road Well Freon-free for up to fifty (50) hours using the existing GAC treatment, the NCDOH refused to permit even emergency use of the well (i.e. in case of a fire).

It was after extensive investigation and research that the City’s expert water engineers (H2M Engineers) determined that the source of the Freon was NS-LIJ and its geothermal well. This determination was made upon review of the available data, calculation of the groundwater flow and contaminant flows.

NS-LIJ is located about 1,400 feet up gradient from the Seaman Road Well and is located within the Seaman Road Well’s capture zone (the area from which the our City Well pulls its water supply). The Hospital runs an Open Loop Geothermal Well utilizing Freon to run the system. Recent repairs were made to their Geothermal Well in the hope of cutting off the source of the contamination.

City engineers found that NS-LIJ’s Geothermal Well transfers water to and from the Magothy aquifer (the source of water for our Seaman Road Well) through a system used for air conditioning. Until recently, that system used Freon as a coolant. At or about the end of April, 2011, NS-LIJ replaced the well casing of their Open Loop Geothermal Well. More recently, NS-LIJ discontinued use of this system and installed a brand new Open Loop Geothermal Well that does not use Freon.

In July 2010, the City Council retained—on a contingency basis -- Napoli Bern Ripka Shkolnik & Associates, LLP (NBRSA), a New York City-based law firm that previously recovered over \$1million for the City arising from contamination of its groundwater by the gasoline additive methyl-tertiary butyl ether (“MTBE”). The law firm would represent the City in attempting to recover the cost of the Air Stripping Tower now required of the City by the NCDOH.

NBRSA and the City repeatedly attempted to open a dialogue with NS-LIJ to find some resolution of the Freon contamination and its cost to the City without resorting to litigation. Rather than engaging in meaningful discussion, however, NS-LIJ simply forwarded all attempts at outreach to their outside counsel for response. By the same to-

ken, NS-LIJ attorneys declined to meet with the City or its counsel to open a meaningful dialogue forcing the City’s hand due to the approaching statute of limitations. Litigation was commenced and is now in the discovery phase, with no trial date set at this time.

“The downsizing of the hospital has nothing to do with the lawsuit, explained Paul J. Napoli, NBRSA’s Managing Partner, it is an unfortunate coincidence. The claims of Environmental contamination are covered by the Hospital’s insurance and will not affect the Hospital’s bottom line or patient services in any way. Insurance will cover any verdict or settle-

ment of the City’s claims.”

“As all citizens of Glen Cove know, my first and foremost responsibility is the health and safety of our citizens. In addition protection of our critical City assets is my fiscal responsibility. The City’s 2012 lawsuit to stop the pollution of our water supply had only one purpose - to protect everyone who lives and works in Glen Cove,” said Mayor Ralph Suozzi. “There is absolutely no correlation between the two issues. Anyone who thinks that NS-LIJ would even considering closing a hospital on the basis of a year-old lawsuit that protects human health and safety and our City assets is misguided.”

# North Shore High School Sisters Achieve Prestigious Medals in Field Hockey

and Mrs. Conklin commented, "We are very proud of our daughters, as this is a huge accomplishment in the field hockey world."

At the National Futures Field Hockey Tournament held in July in Virginia Beach, Frankie played hard as her team went on to receive the bronze medal. She said, "My greatest accomplishment has

been playing in the USA Field Hockey National championship two years in a row and finishing in the top three teams in the tournament [both times]. My goal would be to play in the Junior Olympics on the National Field Hockey Team."

While Maddy proudly watched her sister win bronze at the National Futures Field Hockey Tournament, she also achieved a high feat by being chosen to play in the Junior Olympic Games. After a tough week in competition in Michigan against the best players in the United States, her team went on to win the prestigious silver medal! They concluded by saying, "We hope that we can be role models for younger children (including our 8 year old sister) and families of newly diagnosed Cystic Fibrosis patients as we continue to show them that there is life and hope outside of CF."

Our sincere congratulations go out to both Frankie and Maddy Conklin as they continue to excel on and off of the fields now and in the future!

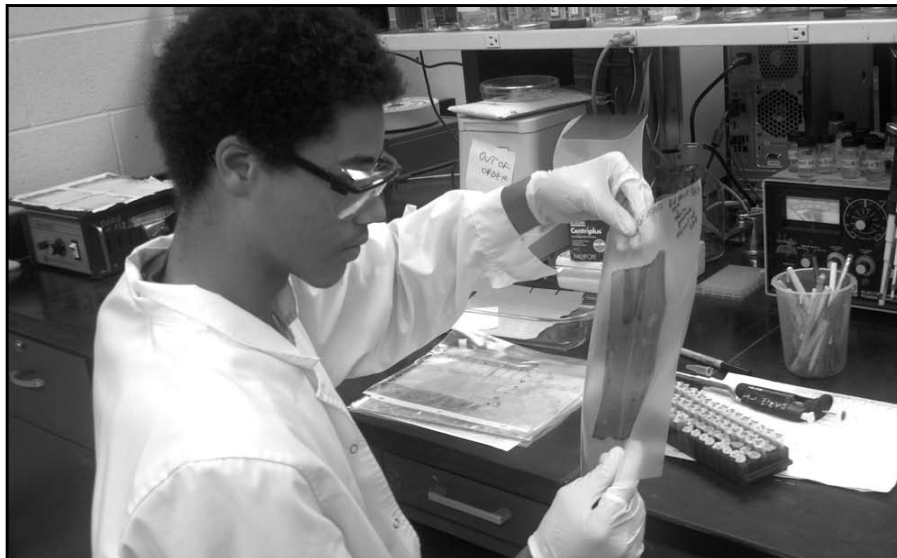

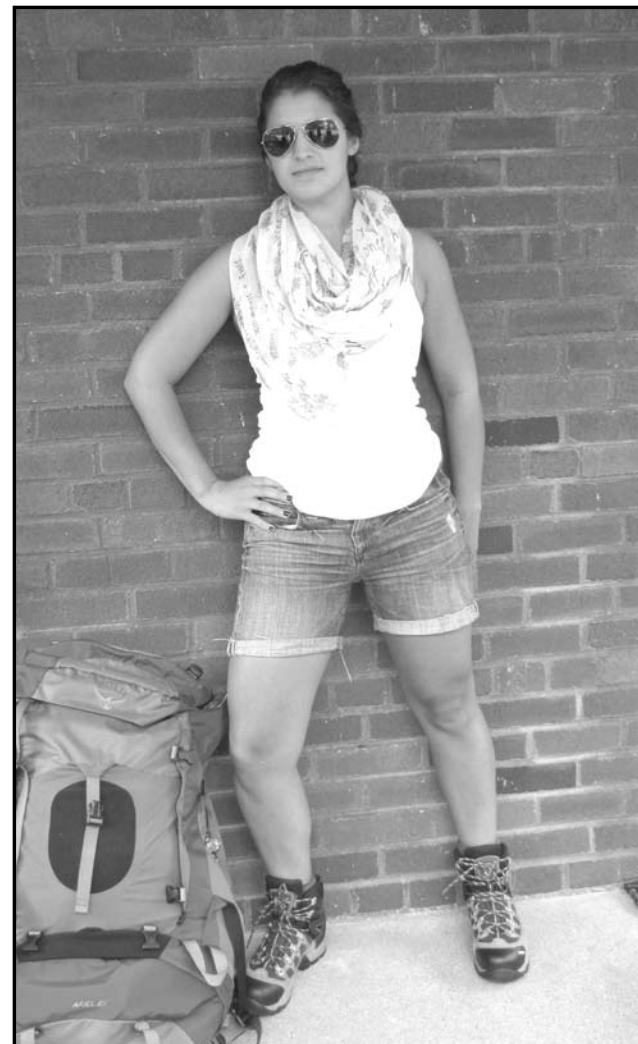
## To the East – A Four Month Journey

## Montesano Calls for Investigation in Hospital Changes

Assemblyman Michael Montesano (R-Glen Head) recently petitioned the Federal Commission Trade Commission's Bureau of Competition--Healthcare Services to investigate proposed changes to Glen Cove Hospital. These changes would cost 1,200 employees of the hospital their jobs and have detrimental effect upon 50,000 plus community members who rely on the essential services provided there, Montesano said in a release.

In a letter to the Federal Trade Commission, Montesano also cited alleged monopolistic practices of North Shore/LIJ in building a conglomerate that ef-

fectively oversees all aspects of health care in Nassau County. "North Shore/LIJ's practices are having a significant negative impact on our local hospitals, remaining medical practices, and surrounding communities and it needs to stop," said Montesano.

"Between muscling out competing practices and their recent changes to Glen Cove Hospital, North Shore/LIJ is engaging in practices that are not only costing good people their jobs, but putting the physical wellness of our residents in jeopardy. I am calling on the Federal Trade Commission to investigate this matter immediately."

# Movie Review

## Only God Forgives

A movie review by Katherine Kranz 2013

Runtime: 90 min

Rated R (Grisly violence, sexual content, strong pervasive language)

Stars: Ryan Gosling, Kristin Scott Thomas, Vithaya Pansringarm



2011 brought the first collaboration of Danish director Nicolas Winding Refn and Ryan Gosling with the slick, offbeat phenomenon that was Drive. Refn's long periods of silence, peculiar selection of music and beautifully depicted violence mixed with Gosling's charming reserve were a perfect pairing, leaving audiences eager to see what they would do next. Only God Forgives, which premiered at Cannes and is crawling its way into theaters and on demand services, is such a far fall from its predecessor as it comes off as a vague outline of what could have been a gripping movie.

Gosling is essentially playing the same type of character he did in Drive, only one that is uncharismatic and thinly written. That nondescript man is Julian, an American living in Bangkok whose primary source of income comes from narcotics trafficking under the cover of boxing matches. His despicable brother Billy (Tom Burke) savagely slaughters a teen prostitute after raping her. Lieutenant Chang (Vithaya Pansringarm) arrives at the crime scene with the girl's father, giving him permission to exact revenge on her killer. Beaten beyond recognition and dying before he could make much of an impact, Billy received apt punishment.

Having all of this transpire in the very beginning and taking the plot further is one of the movie's few points of

interest. Julian and Billy's foulmouthed, manipulative mother Crystal (Kristin Scott Thomas) travels to Bangkok to identify her son's body. Crystal is the type of woman who, when told of her son's crimes, casually replies "I'm sure he had his reasons." She demands that Julian avenge his brother's death. All the while she alludes to having an incestuous relationship with Billy, though these feelings end up being a very bizarre throwaway detail.

The script, penned by Refn, consists mostly of similarly unfinished thoughts. Lieutenant Chang's hobby of serenading his fellow law enforcers with karaoke is nothing but laughable. Crystal's relations with Julian's father are brought up in a shocking revelation before being immediately forgotten. Julian's supposed attraction to a constantly frowning prostitute (Yayaying Rhatha Phongam) is dubious at best. Gosling is given almost nothing to work with and very little to do.

## The Importance of Keeping Glen Cove Hospital Open

### To The Editor,

The field of healthcare is rapidly evolving. Changing reimbursement patterns and a renewed focus on preventive services has already resulted in the reduction of in-patient hospital services. This has been a huge issue for Long Islanders--one that will become greater as changes in the healthcare market are accelerated by the Affordable Health Care Act.

An example of this evolution was the recent decision by the North Shore-LIJ Health System to convert Glen Cove Hospital into an ambulatory center with no beds for in-patient care. Glen Cove Hospital has long been the cornerstone health care facility for the North Shore community, and needs to remain open and active for both out- and in-patient services. Although representatives from North Shore Hospital system have been willing to discuss the issue with concerned physicians, they will not guarantee they won't seek to decertify in-patient beds. While North Shore-LIJ may be experiencing fiscal pressure due to current healthcare economics and its recent spate of acquisitions (including Lenox Hill Hospital), the system must understand that its number one goal must be to ensure quality healthcare for the communities it serves.

Although there are economic reasons why Glen Cove Hospital should remain a thriving institution, including preservation of jobs and local businesses, as a clinician, I am deeply concerned about the potential impact on the health of my patients for two reasons.

First is the geographic isolation of Glen Cove Hospital. The closest area hospitals include Syosset Hospital, which already has somewhat limited in-patient services, and St. Francis Hospital, which is often over-burdened with high patient volumes. It is not medically appropriate

to transfer critically ill patients on a routine basis-- when every minute counts, time would be lost relocating patients that come via ambulance from the Glen Cove area to an outside hospital.

Second is the potential impact on the future of Long Island health care as a whole. If this plan by North Shore-LIJ to close a profitable, high quality community hospital is realized, this will only serve as an incentive to other hospital executives to do the same. Ultimately, I fear we will be left with a local health care system that will not be up to standards or able to meet the needs of our local community.

During my more than two decades in the field of medicine I have witnessed many local and national challenges, but none more significant than this. There are a growing number of residents, including Nassau County Executive Ed

Mangano, and former Nassau County Executive Tom Suozzi, who have joined my medical colleagues and are making their voices heard and fighting to keep Glen Cove Hospital fully open. In addition, Glen Cove's current mayor, Ralph Suozzi has initiated print and online petitions that have already totaled more than 13,000 signatures. I urge all Long Islanders to sign the petition, as this closure would have a lasting impact on all of us. Please visit [change.org](http://change.org) and search Glen Cove.

I hope that residents of Nassau and Suffolk will rally for this worthy cause and help save the future of Long Island's healthcare.

### Last Week's Celebrity

Last week's celebrity was Natalie Schafer. She appeared in many films usually portraying beautiful sophisticates, but she is best known for the situation comedy "Gilligan's Island", playing the role of the millionaire's (played by Jim Backus) wife "Eunice 'Lovey' Wentworth Howell." She reprised her role in the made-for-TV spin-off films that were made after the show's demise, along with the animated spin-off "Gilligan's Planet" in 1982. Originally written as a humorless grande dame, Schafer worked with the writers to create a character not unlike the scatterbrain roles played in the 1930's films by Mary Boland and Billie Burke. Schafer specifically suggested that the writers read George S. Kaufman (her companion)-Marc Connelly play "Dulcy" for its dizzy title character. Her final appearance was given in 1990, in the TV film "I'm Dangerous Tonight" opposite Anthony Perkins.

Her investments, particularly in real estate, made her a multi-millionaire. Differing sources state that most of this fortune was bequeathed to either her "Gilligan's Island" co-star, Dawn Wells, who played "MaryAnn", or to care for her dogs. Wells has not commented, but did reveal on the talk show "Vicki", starring Vicki Lawrence, that Schafer spent her last few years living with Wells, who took care of Schafer. Wells also revealed that one of Schafer's favorite things on the show was "falling through quicksand." Schafer died of cancer, at the age of 90, on April 10, 1991.

This week's celebrity was born on Nov. 18, 1942 in New York City. She was raised in Freeport, Long Island and graduated from Freeport High School in 1960. She got her acting start in the 1960's playing opposite Dustin Hoffman in the Broadway play, "Jimmy Shine." She landed a contract with Universal Studios in 1969, guest starring in several shows. It was during this time, she played parts in daytime dramas.

Starting with a role on "A World Apart" in 1970, she moved on to a five-year stint as "Lenore Moore Curtin Delaney" on the daytime soap opera, "Another World." She played Charlton Heston's girlfriend "Ann", a new character written into the TV version of the film "Midway" in 1976. She then played "Dr. Elaine Marks" opposite Bill Bixby in "The Incredible Hulk" TV series pilot in 1977 and portrayed "Poker Alice" opposite James Garner as "Bret Maverick" in "The New Maverick" in 1978. She received an Emmy nomination for the role of "Maggie Porter" in the TV drama "Rich Man, Poor Man Book II."

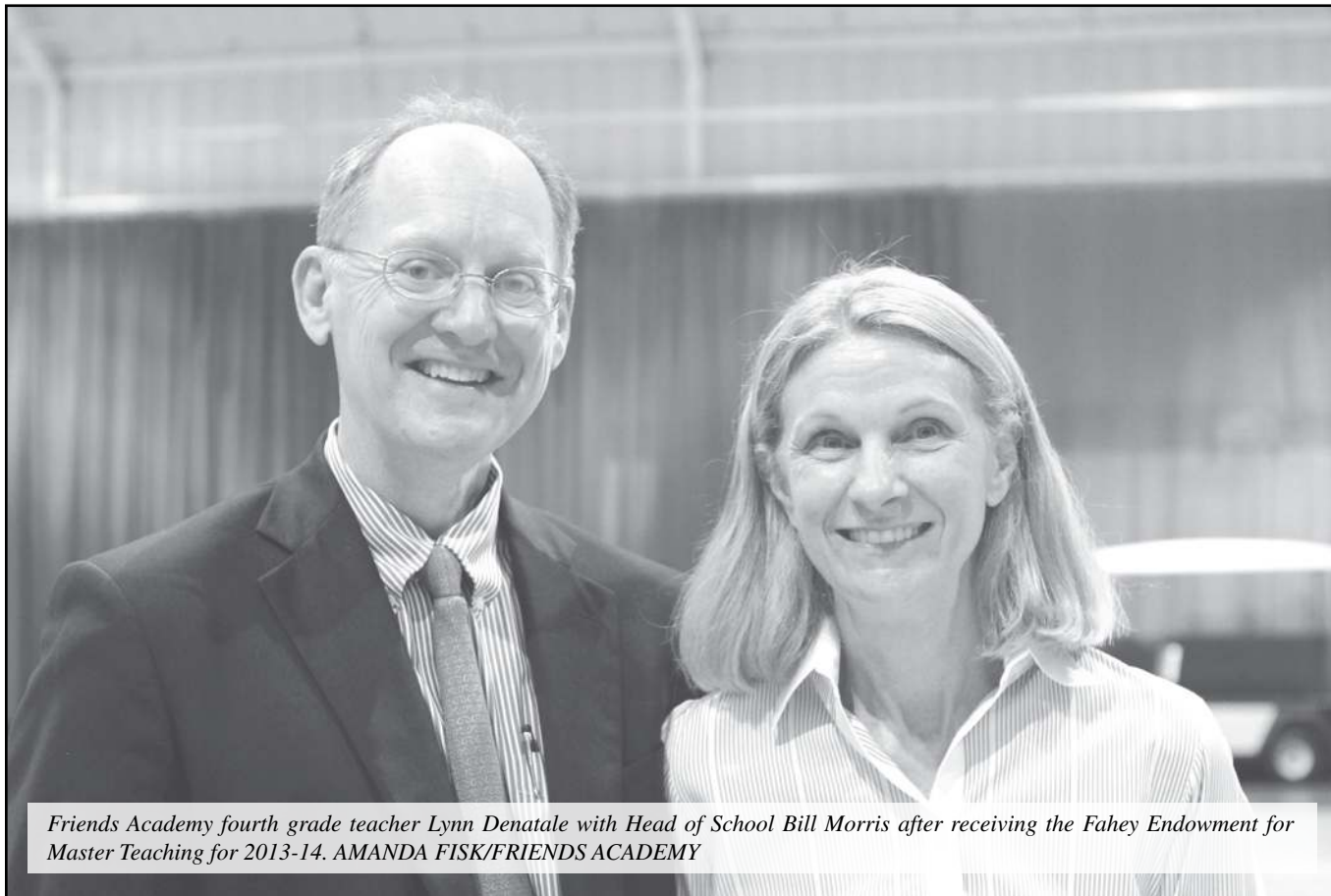

The novel focuses on two young people who particularly need to move on: Jon whose immigrant parents have shut down emotionally, and Ray whose family life is suffused with violence. Both families are suffering from the after effects of World War II

but the country has little sympathy, as it is emeshed in another war. Vietnam, the Beatles, the draft, Charles Manson - all color the lives of these teenagers. The tragedy that finally allows the boys to leave is long in coming but shocking nevertheless. This is not an easy book to read, but worthwhile.

# Harvard's Dr. Daniel Gray Wilson Visits Portledge School

Portledge School and Harvard University have been seeing a lot of each other lately. Last spring the Advisory Board of the Harvard Graduate School of Education Principal's Center came to observe the student-centered classrooms at Portledge. This summer Portledge teachers trained in Cambridge and took online graduate classes through Harvard. And now, just as school is re-opening, Harvard's Principal Researcher at Project Zero, Dr. Daniel Gray Wilson, noted author, educator and speaker is at Portledge to conduct a workshop for faculty aptly entitled, "Cultivating Collaborations in the 21st Century". The two schools are working closely together to explore the most effective ways to instill essential 21st Century skills like curiosity, critical thinking, and on this particular day, collaboration.

At first glance, the workshop exercises looks to the uninitiated like someone lost a contact lens at a cocktail party. But in fact some vitally important work is going on. Educational researchers report that informal learning accounts for a whopping 70% of professional knowledge, and group learning approaches are a major driver of informal learning with huge payoffs in academic achievement and pro-social behaviors. So yes, collaborative learning is key. But anyone who has tried to tackle a project with a spouse, a sibling or a teenager will tell you its not as easy as it looks. That is where Daniel Wilson comes in. He is a Principal Investigator on Harvard's "Making Learning Visible Project," which engages pre-k through high school educators in adapting the Reggio Emilia pedagogical principles (in English that means he figures out how to provoke students to become active participants in their own learning). For Dr. Wilson, at its core, collaboration is about co-creation, and relies on the inherent social tensions of knowing, trusting and leading. His cutting edge studies in education have taken him to schools across the globe and Dr. Wilson's insights are detailed in a recently published book, Visible Learners (Jossey-Bass).

Back at Portledge, educators are learning about effective collaboration themselves in order to engage their students to collaborate effectively within the Reggio-Emilia and project-based learning models the school has already embraced with great success. And if the collaboration between Portledge and Harvard is any indication, the future for today's students looks bright.
