## Why Glen Cove Matters

### To The Editor,

If you ride into Locust Valley, you might be surprised to see a “Reggie Spinello for Mayor” sign sitting on the corner of Forest Avenue and Weir Lane. And you might think that to be odd at first blush, wondering why anyone who doesn’t live in Glen Cove would care about its politics. Well, perhaps it’s not so odd after all.

What happens in Vegas may very well stay in Vegas, but what happens in Glen Cove doesn’t necessarily stay in Glen Cove. Surrounding communities, like Locust Valley, Lattingtown, Glen Head, Sea Cliff and Old Brookville are significantly affected by Glen Cove’s fortunes. People from these communities shop in Glen Cove’s remaining stores, share Glen Cove’s remaining amenities with friends and families who live in Glen Cove, go to the movies in Glen Cove when it can manage to keep a movie theater open, buy food in Glen Cove, go to restaurants in Glen Cove, use doctors and the hospital in Glen Cove, and perhaps most importantly, rely upon Glen Cove to sustain itself as a vibrant community which reflects well not just on the value of its own real estate, but on the values of the homes in its neighboring communities.

When Glen Cove does well, all the villages which abut it do well. It does not make a single homeowner in a surrounding town happy to see the closure of a store in Glen Cove. When a beach closes in Glen Cove, or when its schools do not do well, real estate values in Glen Cove suffer, and so do the real estate values in its neighboring communities. No, not one of Glen Cove’s neighbors are the least bit happy to see the city they rely upon for so many things fail at the hands of politicians who, for decades, have been running it into the ground through breathtaking incompetence and personal political agendas.

And that’s why there’s a “Reggie Spinello for Mayor” sign on Forest Avenue in Locust Valley. The folks next door may not be able to vote in Glen Cove’s election, but that doesn’t mean they can’t express their opinion on who they wish to see running the place. There’s a symbiotic relationship between Glen Cove and their neighbors. If Glen Cove voters will put someone into office who can turn it around and bring good businesses back to town, they can rest assured that the people next door will jump at the chance to help restore the City to sound fiscal health by frequenting its commercial establishments and adding to the expansion of economic activity that creates revitalization and brings a place back to life.

Every homeowner who lives in a community next to Glen Cove only wishes it well because of the simple principle that Glen Cove’s success is a win-win for everyone. And that, in a nutshell, explains why Reggie Spinello for Mayor has captured the interest of everyone around and there’s a sign up on Forest Avenue to prove it.

## Hospital CEO and President

### To The Editor,

As almost everyone is aware, there are major changes underway in the way health care is delivered and financed. The scope of this transformation is national, regional and local. No entity, hospital or healthcare organization can avoid the impact of these developments, whether we like them or not. Without the need for elaboration, this is the relevant context of our ongoing discussions about the current circumstance and future plans for Glen Cove Hospital. The following is intended to provide further clarity with regard to Glen Cove and builds on our previous discussions. I have divided the following into two components: A), a general contextual overview, and B), a description of how Glen Cove Hospital will continue to serve the needs of the community.

#### A. Overview

- Glen Cove Hospital has been serving its community with competence, compassion and commitment for over 90 years – a remarkable and proud history.

- The goal and commitment of North Shore-LIJ, wholeheartedly supported by the community, is to build on that history, continue that commitment and preserve Glen Cove Hospital as a robust and essential asset, serving the needs of the Glen Cove community now and into the future.

- There is no plan or intent to close the hospital. It is imperative that this be understood by the community and its leaders.

- However, given all the changes affecting health care and the iron-clad commitment to maintain the facility as a successful enterprise, changes are necessary. Too many hospitals across the New York area (13 in recent years) and the nation have closed because of a failure to anticipate, adapt and evolve. This must not happen to Glen Cove.

- Maintaining the hospital as-is has proven to be unsustainable – despite all best efforts. It is worth noting just a few facts:

- o Overall inpatient volume continues to decline and will continue to do so.

- o Some of the services common in a “full-service” hospital already have been closed (e.g. obstetrics and pediatrics) because of declining volume.

- o More and more care that was once provided in a hospital is now provided outside the hospital – and with better results. This has greatly reduced the need for beds. Current and future state and federal policies penalize hospitals for admitting patients who should not be hospitalized.

- o A significant portion of the building is currently under utilized.

- o A significant portion of Glen Cove residents do not use Glen Cove Hospital. They go elsewhere for their care,

such North Shore University Hospital, St. Francis, etc.

- As we transition to a facility that will meet the community’s future needs, we have committed that all affected employees will be protected and offered jobs elsewhere in the North Shore-LIJ Health System. This, of course, protects family income and the economic base of Glen Cove.

- Glen Cove Hospital will be a model for how a hospital (with its proud history) can adapt and change as we enter a new era of health care delivery. Local residents will be proud of the new facility we develop.

- The “New” Glen Cove Hospital will be a demonstration of how to enhance services to the community by providing or being the catalyst for a broader array of community based services.

#### B. The Future Plan

While discussions and input on the transition are not complete or final, it is important to outline what the facility will include.

- Emergency Services: The Glen Cove Hospital Emergency Department will continue to provide 24-hour access to board-certified emergency physicians, as well as specialty trained nurses and other staff. Services will be enhanced, not reduced.

- o As is the case currently, patients who present at Glen Cove Hospital requiring diagnostic or interventional cardiac catheterization, cardiac bypass surgery, complex neurosurgery, etc. will be evaluated, stabilized and then transferred to another hospital.

- o The Emergency Department will continue to serve patients with behavioral health conditions, and connect patients to home care and their primary care physician.

- o There will be a special emphasis and focus on the needs of the elderly – a major priority in the Glen Cove area.

- o Ambulance transport (as is the case today) will be on 24/7 standby to ensure rapid transport when necessary.

- Inpatient Care: The hospital will continue to maintain a number of inpatient beds to meet the essential needs of

the community. Typical conditions that we treat in-house today include such diseases as pneumonia and gastritis. Our ability to treat those conditions will be unchanged.

- o For patients requiring a shorter period of treatment or observation, a short-stay clinical decision unit (CDU) will be established. This unit will allow clinicians to monitor their patients longer than a typical emergency room visit, ensuring that their condition is properly evaluated before they are treated and discharged.

- o The total number of beds will be dictated by need and may fluctuate over time.

- Ambulatory Surgery: Glen Cove Hospital will continue to perform a small complement of ambulatory surgical procedures. Various subspecialty practices, including podiatry, ear nose and throat, and others, are in discussions with our clinical and administrative leadership to establish an operating room presence. Ambulatory endoscopy services will continue to be provided within the hospital.

- Hospice Care: The hospital currently has a hospice presence, providing care to patients at the end of life (most hospice services are home-based). We are currently working with Hospice Care Network to increase our presence in the Glen Cove community through a combination of increased hospital as well as home based programs. Other palliative care enhancements will be introduced as plans solidify.

- Cancer Services: Outpatient cancer services delivered in the Don Monti Cancer Center will continue as they exist today.

- o Chemotherapy infusion is currently performed in a five-chair unit at Glen Cove Hospital – this will continue. Radiation medicine services will continue to be performed in the state-of-the-art linear accelerator at Glen Cove Hospital for radiation oncology patients.

- o Community physicians will continue to be available to their patients as they are now.

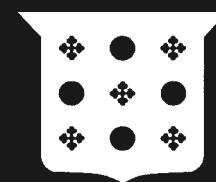
- Outpatient Therapy: Glen Cove Hospital has a long tradition of provid-

ing excellent physical rehabilitation services. Once again, the demographic profile community calls for this to continue.

- Physical and Occupational Therapists who currently treat community residents in the hospital's Wunch Center will maintain their presence. Treatments for orthopedic injuries and neurological conditions will continue to be available. Home-based therapy services will also be available through the North Shore-LIJ Home Care Network.

- Respiratory therapy services will also be offered on-site and in the community through the geriatric medicine leadership based in the hospital.

- Family Medicine: The North Shore-LIJ Health System has a proud tradition of offering care to all members of the community, regardless of their ability to pay. The Family Medicine practice at Glen Cove Hospital carries on this work every day.

- General primary care services will continue to be offered, including prenatal care, behavioral services, pediatrics, immunizations and sexual health.

- The connection of this program with hospital care will continue through Glen Cove Hospital's menu of services, in addition to North Shore University and

Huntington Hospitals.

- Dental medicine services will continue to be offered.

- The advanced imaging center at 10 Medical Plaza will continue to offer imaging services such as CT scan, MRI and general X-Ray.

- Home-Based Services: Part of our commitment to the residents of Glen Cove includes highlighting our presence in the community through our robust offerings of home care and house-calls program, and solidifying our relationship with the local skilled nursing and assisted-living facilities. Robust planning is currently underway with our local medical and administrative leadership.

- Increased access to home nursing, therapy and health aide services will be provided by emphasizing community based discharge planning in the hospital. Patients will be offered a variety of home care services by North Shore-LIJ or the agency of their choice. Discharge planners, case managers and social workers will be available throughout the continuum of care at Glen Cove Hospital. This includes the inpatient beds, the emergency room, as well as the family medicine practice.

- North Shore-LIJ Home Care also offers a Geriatric Care Manager Service

through its Circle of Care Program. Geriatric care managers provide a range of services to patients and their families, including health advocacy and referrals for other hospital treatments, home health needs, transportation, elder law, financial planning and others.

- Increased home-based hospice services will complement our existing in house beds.

- Other Services: As discussed at some of the meetings I have been having with local elected officials, we are reviewing whether there are opportunities to deploy other services and some back-office functions to Glen Cove to take advantage of the large, unused space currently in the hospital. While we have no specific plans currently, the evaluation process is continuing.

We will continue to work with local elected officials, community leaders and local physicians in a collaborative, reasonable manner to meet the current and future health care needs of the Glen Cove community.

Let's not forget what our downtown once was - a thriving hub that brought people in from surrounding communities to shop and spend time socializing.

# Name the Celebrity



This week's celebrity was an English assistant director, screen writer and editor. She was born in Nottinghamshire, England on Aug. 14, 1899. She is best known as the wife and collaborator of a very famous director of suspense films, whom she met while they were working together at Paramount's Famous Players-Lasky Studio in London, during the early 1920's. A talented editor, she worked on British films with directors such as Berthold Viertel and Maurice Elvey, though her main focus was her husband's work. Cinema was the couple's passion. She converted to Roman Catholicism from Protestantism before their marriage and was one day younger than her husband. Their union produced a daughter, Patricia, who wanted to be an actress. Patricia had small roles on "Strangers on a Train" (1951) with Farley Granger, "The Mudlark" (1950) with Irene Dune and Alec Guinness, and a bit part in DeMille's "Ten Commandments" (1956). Our celebrity became her husband's collaborator and sounding board with a keen ear for dialogue and an editor's sharp eye for scrutinizing a film's final version for continuity flaws. **Last Week's Celebrity**

Last week's celebrity was Darla Hood. Of course, she was sweet "Darla" in the Hal Roach "Our Gang/Little Rascals" comedies. When she grew out of

that role, she appeared in a couple of B-movies and then organized a vocal group called "The Enchanters." She was a regular on the Ken Murray Show" (1950-51). In 1955, she was a leading lady act of ventriloquist Edgar Bergen, Candace's Dad. She had a hit record in 1957, "I Just Wanna Be There." Her final film role was a secretary in the suspense drama "The Bat" (1959) with Vincent Price and Agnes Moorehead. She was a guest on such TV shows of the early 1960's as "Tell It to Grouch" and "The Jack Benny Show", where she appeared on Oct. 30, 1962 as "Darla" in a spoof of the "Our Gang/Little Rascals" comedies with Jack Benny as "Alfalfa". She did the voice overs on TV commercials which included Campbell Soup and Chicken of the Sea tuna. She was also featured in "The Little Rascals Christmas Special" (1979) as the voice of "Spanky" and "Porky's" Mom. During the 1960's and the 1970's, Hood attended many "Our Gang/Little Rascals" festivals and conventions meeting and greeting various generations of fans. She was busy organizing the 1980 "Little Rascals" reunion for the Los Angeles Chapter of The Sons of the Desert when she underwent an appendectomy at Canoga Park Hospital, Canoga Park, Calif.. After the procedure, she died suddenly of heart failure on June 13, 1979. She was 47. An autopsy disclosed that she contracted acute hepatitis from a blood transfusion given during the operation, leading to death. The "Our Gang" community was stunned at her unexpected death. Fellow "Our Gang" member Billie "Buckwheat" Thomas said, "I hate to hear it. It is a shock. She was an awfully nice person, a fine woman. During a lecture at Murray State University in 1985, George "Spanky" McFarland attributed her death to a broken heart.

## George W. Fellendorf

George William Fellendorf, 88, of Keene, died on Thursday morning, September 12, 2013, with loved ones at his side, at Langdon Place of Keene.

He was born on September 11, 1925, in Glen Cove, NY, to Frederick and Sarah Amelia (Bouton) Fellendorf. George grew up in and attended Sea Cliff, Long Island Schools. He married Hazel Maisey of Scranton PA on November 30, 1946, in a ceremony in Schenectady, NY.

He joined the US Navy during WW II, was sent to study engineering at Union College in Schenectady, NY, and was honorably discharged in 1945. He graduated from Union in 1947 with a BS in Engineering, and from Rensselaer Polytechnic Institute in 1949 with a Bachelors and Masters in Management Engineering. He was president of an Easton PA engineering company in 1962 when he was inspired by his young deaf daughter, Linda, to shift careers.

He and his family moved to Washington, DC after he was selected to serve

as Executive Director of the Alexander Graham Bell Association for the Deaf. While working there from 1962 until 1978, he received a Doctor of Education from Teacher's College-Columbia University in NY in 1974. He served as Executive Director of the HEAR Foundation of Arlington, VA from 1978 to 1980, and consulted in special education and services for the deaf for non-profit, governmental, and international organizations from 1980-2007 including service on the Veteran's Advisory Committee on Education in 2004-2005.

George was often tapped for service as a board member and leader for non-profit organizations. He was chair of NH Christian Coalition (1993-1996) and most recently served as board member of the Pregnancy Resource Center of the Monadnock Region.

George was a skilled public speaker, writer and editor, and was well known locally in the Keene region for serving as talk show host on WKBK in Keene, NH from 1996-2001 and for his frequent published letters to the editor in the Keene Sentinel. He was a bold, unwavering and vocal conservative voice in Keene.

From 2000-2002 George served as Acting Principal of Trinity Christian School, Keene, NH. Upon his retirement, the school honored him and his wife by establishing the George and Hazel Fellendorf Award, given annually to a graduate who has excelled in contributing to the Christian ideals that the school promotes.

George combined his education background and missionary zeal by serving as educational consultant in 2004 to help set up a school for radio missionary's children in Bratislava, Slovakia. In 2005 he served as a short term missionary with Concordia English Center in Macau, China.

In March 2013 George was honored by the Alexander Graham Bell Association

for the Deaf and Hard of Hearing for his professional contributions as executive director and editor with the naming of the George W. Fellendorf Editorial Suite in their headquarters, the Volta Bureau, Washington, DC.

George and his wife of 66 years, Hazel, are longtime members of the Missouri Synod Lutheran church with active memberships at Calvary Lutheran Church in Silver Spring, MD and then at Trinity Lutheran Church in Keene, NH. He is survived by wife Hazel Fellendorf of Keene; three daughters: Carol Barbi-erri and her husband Richard of Shaftsbury, VT, Linda Mousavi and her husband Hossein of Mesa, AZ, and Joyce Jackson and her husband Craig of Seattle, WA; a brother Frederick Fellendorf of Lisle, IL; six grandchildren: Ramin, Kamran, Cara, Cody, Collin and Ashley, and two great grandchildren: Brandon and Miranda.

He was preceded in death by his parents Frederick and Sarah (Bouton) Fellendorf, a sister Phyllis Carty and her husband Alwyn, and sister-in-law Helen Fellendorf.

George will be remembered for his deep love of his wife Hazel and extended family, his passion to share the Good News of Christ, and his extraordinary efforts to help and improve the lives of many others, especially those with special needs. He was very proud of his book published in 2007, available at Amazon.com, My Problems, God's Solutions, which shared his life story and how God helped him solve his problems. # TO THE EAST

## A FOUR MONTH JOURNEY

Kilometers away from the smog of Saigon and my jet lag finally receding, I reached the Mekong Delta's city of Cần Thơ. My travel companion, Julia, and I met a local woman named Hà who agreed to take us, along with a newlywed Israeli couple, to the floating markets the following day. The city is famous for them: around 6am every morning, merchants meet on the river (large boats for selling, small for buying) to bargain on goods, namely fruits and vegetables. The experience is worth hiring a boat for, and Hà and her sisters have been guiding tourists through the river for years. Their boats fit up to four people, so the tours are intimate and authentic; the women are proud to share their vast knowledge of the city's markets, waterways, factories, and produce with travelers.

At 5am, we walked along the river with Hà's sister, Rose, our guide for the day's journey. Our group followed her down an alleyway in the dark, where the strong, buttery aroma of Vietnamese coffee woke us from our predawn daze. The Vietnamese begin their day early; from my guesthouse balcony, I saw groups of locals exercising around the Ho Chi Minh Statue as early as 4am. For the markets, it is necessary to begin early for the top choice produce (and for us to beat the tourist crowds).

The four travelers were seated in a simple boat with a three blade, coconut sized propeller connected to a wooden paddle. As the sun rose over the Mekong, Rose pointed out the different types of boats that passed by and made us jewelry out of freshly cut bamboo - a lovely gimmick of the sisters' tours. Rose asked about New York and the "Freedom Angel" (Statue of Liberty), while telling us all about the culture and superstitions on the river. The many boats with painted red eyes were an old tool used to fool the crocodiles that once inhabited the

waters. Upon seeing an owl just before sunrise, Julia's hoots were scolded by Rose. "That is very bad luck, you cannot make the sound of the owl!" she said. The fisherman believe that if the owl hoots at them, they will have an unlucky catch. Thankfully, our day continued on without a hitch.

After a quick stop for fuel (Rose called it the boat's beer), we were at the city's largest market, Cá Rêin, by 6am. Truly, we were alone among locals, acting as on lookers apart from a few pineapples the Israeli's purchased for 10,000 VND (about 50 cents). The hoard of boats was unlike anything I'd seen, a site so unexpected and warming that it was hard to do anything but sit in awe. The peaceful way the Vietnamese exchanged goods was reminiscent of old friends meeting over a (very early) morning coffee.

Rose had much more planned for us, as we had paid \$15 USD each for seven hours with her as our guide. The driver expertly navigated through thick jungle full of tiny river pathways which our boat could barely fit down. Apart from a local who drove by with three spotted pigs in the bow of his ship, we were utterly alone. With the motor cut, the silence within the sounds of the swamp hummed our insignificance. We pulled up to the dock of a family owned noodle and rice factory around 7am, where production had been in full swing for hours. The rice patties drying in the rising sun fulfilled a quintessential image I've always held of Vietnam, and to have it validated was comforting so far from home.

As the morning progressed, we disembarked from the boat and walked through jungle and rice fields. To shade my face, the driver gave me his conical hat, made from the leaves of the coconut trees that surrounded us. Our late breakfast was served at a family home

deep within the jungle, where Julia and I ordered coconuts to drink. After sharing shrimp rolls wrapped in rice paper and fried tofu with sliced cucumbers, we all napped in hammocks before returning to our boat for the hour long return.

Back on shore, we settled up with Rose and our fantastical morning came

to an end just before noon. On the walk back to our guesthouse, a small child ran after me, asking for the bamboo cricket Rose had made for us, a token he seemed used to receiving from Hà's guests. To find Hà and her sisters, visit the Tây Hồ guesthouse, where they are well known.

**Dear Great Book Guru,**  
*I have noticed that many former Brooklynites are moving here to Sea Cliff. In fact, many say that Sea Cliff has a Brooklyn feel. Do you have a book to recommend that is set in Brooklyn so I can judge this for myself?*  
**Burgeoning Interest in Brooklyn**

Dear Burgeoning,  
 At last year's Newcomers' Party, we noted that the majority of newcomers were indeed from Brooklyn. I just recently read VISITATION STREET by Ivy Pochoda, but the Brooklyn she writes about bears little resemblance to Sea Cliff or the Brooklyn most of us have experienced. In many ways it is closer to the communities described by Dennis Lehane in "Mystic River" and "Gone Baby Gone." Set on Visitation Street in Red Hook, a neighborhood devastated by the Balkanization tactics of city planner Robert Moses, the novel opens with two young teenage girls floating in the murky waters of the Gowanus Canal. Val is rescued but June remains missing. We meet an interesting array of characters all of whom are marginally connected to the missing girl: Fadi, the enterprising Lebanese bodega owner who loves his

adopted community and tries to bridge the gap between old time residents and the affluent newcomers; Jonathan, a local musician- teacher whose life is being destroyed by grief and guilt; Cree, a boy from the projects, whose father was murdered years before; Ren, a young graffiti artist recently released from prison; and Lil, the alcoholic bartender whose bar attracts new and old residents, all troubled. While the author describes these damaged characters in exquisite detail, the most vivid portrait is that of Red Hook. Recommended!

Reminder: Silly Shakespeare Company's THE REAL HOUSEWIVES OF HENRY VIII is this Saturday, September 21 at 6pm at the Sea Cliff Beach Pavilion. The Great Book Guru has a small but meaningful role in this production.


