# Stillwagon Among Veterans Honored

At precisely 11am, on the 11th day of the 11th month, as is the tradition, Glen Cove honored its many veterans including Mr. Howard Stillwagon who served in the U.S. Army during Vietnam.

On hand to honor Stillwagon was Congressman Steve Israel who presented him with an American Flag, saying, "The very flag he fought to protect." Glen Cove Mayor Ralph V. Suozzi said, "I want to thank the Veterans and their families for their service to our country "Without you there would be no freedom.

"Without you there would be no America.

He said, "This morning at 9am there was a rededication of 'Big Ralph' Park over on Kelly Street. It was dedicated in 1965 for Glen Cove resident Ralph Mastalio. He served in both World Wars I and II receiving the Bronze and Purple Star.

"When I was a child that park was just a wooded area full of briar and dirt paths. We used to search for a lost Army Jeep but we never found it. Sometimes we played hide and go seek but most of the time we played WAR. We shot at each other with toy rifles and threw imaginary hand grenades and then we

went safely back to our homes to fight and play another day. We didn't know then as children that War was not a game."

The Mayor then asked everyone in attendance to join him in singing God Bless America.

Suozzi continued, "In 2005 I stood here among you as your Mayor-elect and after the ceremony I posed her with my father - himself an Army Veteran of WWII- in front of this Doughboy.

Since then, over the course of these last eight years I have embraced a deep respect and love for our Veterans.

It is my distinct privilege to honor the men and women of our nation these

last 8 Memorial and Veteran's Days and I will continue to honor them until my last breath.

"The 15 men I have honored I refer to as

# Glen Head Gym Teacher 'Vindicated' -Charges Dropped

The case against a Glen Head gym teacher accused of watching pornography in his office has been thrown out, after one of the four students who made the allegations admitted that he lied.

Marc Gann, an attorney for Long Beach resident Aaron Kozlowski, 32, said that prosecutors dropped the child endangerment charges against his client on Sept. 27, after they told a judge that they had insufficient proof.

Gann said that when one of the boys recanted his accusation, the case collapsed. On Wednesday, Nassau District Court Judge Valerie Alexandra threw out

the four charges against Kozlowski, including allegations made by a boy who is standing by his claim.

"The D.A.'s office did a thorough investigation and ultimately realized there was nothing here to substantiate the charges and dismissed them — they did the right thing," Gann said, adding that his client feels vindicated after enduring months of "false" allegations.

"He's lived with the idea that people are staring at him and are ridiculing him; his life has been on hold for the last eight months," Gann said.

## Glen Head gym teacher 'vindicated' Child endangerment charges against Long Beach man dropped

Kozlowski, a physical education teacher at North Shore Middle School, was arrested on April 12. According to police, Kozlowski was in his office in February when three 12-year-old male students and one 13-year-old male student claimed that they observed him through a partially opened door watching pornography on his computer and fondling himself.

At the time, Kozlowski's other at-

torney, Rick Ostrove, told the Herald that the kids had a grudge against his client and made the whole thing up. Gann said that the students did not report the incident until March, and that early on, their stories did not match up.

# Old Sea Cliff Buildings Beautifully Renovated

Two old Sea Cliff Avenue buildings # 309 and #311 that have stood in the Village since 1869-70, actually before the Village's incorporation in 1883, have been beautifully restored to their original condition and vintage look by their present owner Bill Long. Mr. Long is a man of many talents including having been a commercial fisherman, proprietor of a bar in Port Washington, and more recently is a designer of computer technology for transportation systems. He is also the owner the of Bronx Toys, a charitable organization that give away toys. The Village is lucky to have Mr. Long in Sea Cliff with his interest in preserving some of Sea Cliff's heritage by restoring his buildings to their former state glory.

Mr. Long bought the buildings he renovated in 2010 with the intention of restoring them to their original condition. He hired a historical restoration design architect from NYC that specializes in vintage architecture to design the plans

for the buildings restoration. Contractors followed through restoring the buildings to their its original look inside and out. Long has used vintage materials such as tile floors, tin ceilings, similar windows, and beautiful dark stained wood paneling and trim. According to Long, #309 was originally a dry goods store and #311 housed Sea Cliff's first post office. More recently the buildings were used as a ceramics shop by Dot and Glenn Barnes who taught a couple of generations of children and adults to create ceramics.

At 311 Sea Cliff Avenue, Mr. Long has set up a unique office for himself which he has named "Woodpecker Hall." The space is used as his office and for meetings. It features vintage furniture an old time bar, and a stage area that can be used for presentations. The other storefront #309 completely restored and is ready to be rented. Above each store are spacious apartments, completely renovated that will eventually be rented.

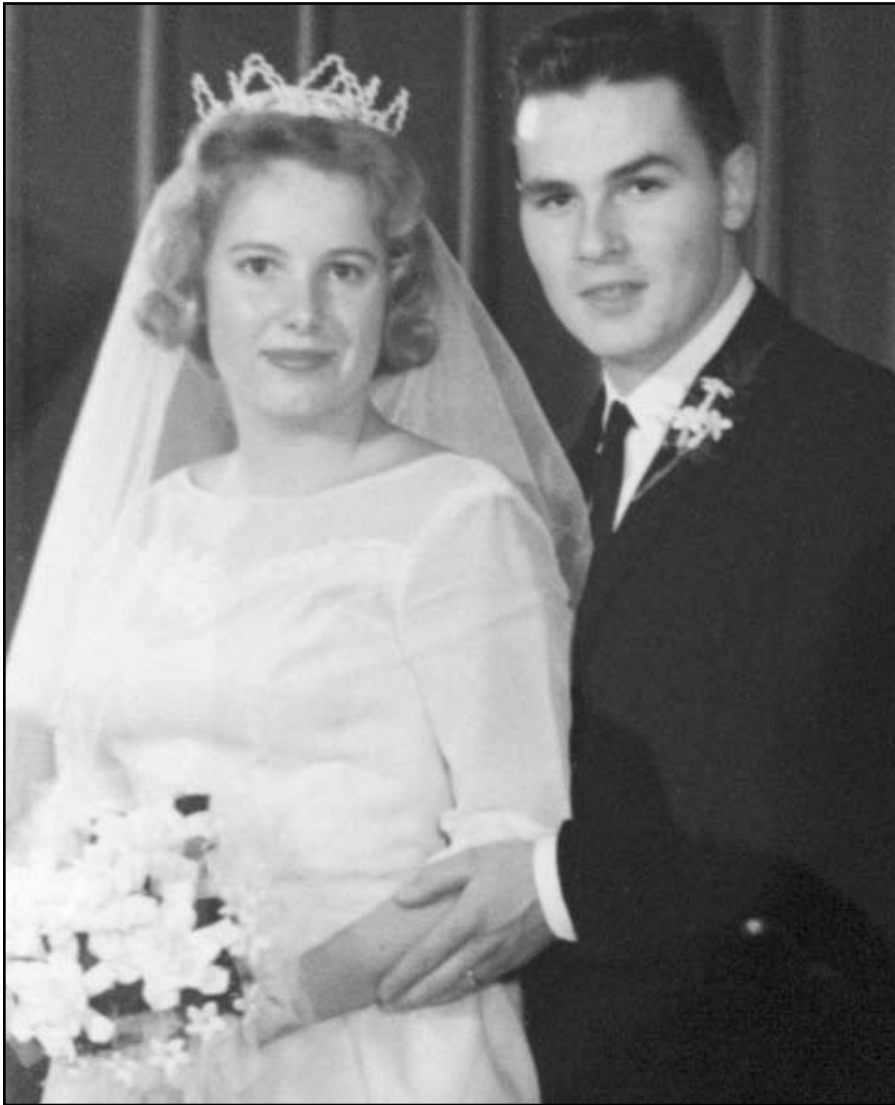

# Concert Festival Orchestra



On October 20, 2013 at 2:00 pm, a packed auditorium of the Jericho Public Library was treated to the inaugural performance of the Concert Festival Orchestra under the direction of Maestro Vladimir Polezhayev.

The Concert Festival Orchestra consists of advanced students and professionals of exceptional talent. This volunteer-based orchestra gives students the unique educational opportunity to perform alongside their teachers and other talented musicians ([www.concertfestival.org/orchestra](http://www.concertfestival.org/orchestra))

The concert began with an elegant rendition of Mozart's Eine Kleine Nachtmusik and ended with a rousing performance of Johann Strauss' Tritsch-Tratsch Polka. In between, seven soloists rang-

ing in age from 9-16 showcased their abilities on violin, flute, and voice with the orchestra as Gran Prix Winners of the Concerto Competition 2013.

10 year-old violinist Marco Motroni performed Vivaldi in a forceful and dramatic style. Kyoko Saito, a 10 year-old violinist, born in Tokyo, gave a fluid performance of a Mozart's Concerto#3. 16 year-old flautist Yuri Kim showed good attention to contrasting phrases and dynamics in Mozart's Flute Concerto. Michele Ripka, 15, performed a violin concerto by J.S. Bach with strong rhythmic impulse and attention to dynamic contrast. 13 year-old violinist Eunice Park gave a spirited performance of Mozart's Concerto #4.

Within this sea of talent two performers stood out. 9 year-old violinist Serin Park, performing a Haydn Concerto, had a big warm sound, perfect intonation, and a sophisticated bow technique beyond her age. Vocalist Gwyneth Campbell sang arias by Handel and Vivaldi. Aside from vocal quality, projection, and musicianship unexpected at age 14, her endurance was stunning, particularly in long legato coloratura passages in the Handel, and the final note of the Vivaldi.

Overall, Concert Festival was admirably successful in its first orchestral/Gran Prix concert, both with the ensemble itself and quality of the young winners it chose to feature. ## Glen Cove Rehab Staff Dances for Charity



The spirit of selfless giving comes naturally to the folks at Glen Cove Center for Nursing and Rehabilitation, so it is of little surprise that the team of trainers, nurses, cooks, and custodians came together to participate in a charity event recently. Their inspirational charity work, however, comes with their signature flair for overachieving.

The staff participated in the annual Pink Glove Dance Competition, which invites participants from hospitals to star in their own music videos, performing choreographed dances while wearing pink-colored exam gloves. The project seeks to raise awareness about the importance of early breast cancer detection through mammograms. Medline, the manufacturers of the pink exam gloves, has sponsored the competition since 2011, since which more than 80,000 have participated.

After all of the videos are submitted, voting begins, and the winning team is awarded a \$25,000 donation to any breast cancer charity group.

Glen Cove Center's video submission features the staff dancing to "Brave" by Sara Bareilles, pink gloves adorning the various hand-jives and jazz-hands that pepper the choreography. The nurses perform a kick-line, while the rehab team grooves in the courtyard. There are close ups of pink-laced sneakers performing some sort of elaborate hop-scotch, and two stern looking men in sunglasses stare into the camera as they straighten their ties—also pink. It is loud, fun, and impossible to watch without smiling.

"We are caregivers professionally, so it only seemed right to extend that same kind of caregiving to a noble cause like [the Pink Glove Dance Competition]," said Glen Cove Center Administrator Jill Smoller. "Plus, everyone looks great in pink."

The original Pink Glove Dance video premiered in November 2009 and featured 200 hospital workers from Portland, OR wearing pink gloves and dancing in support of breast cancer awareness and prevention. The video generated more than 13.8 million views on YouTube and has inspired hundreds of similar videos throughout the world.

"Gloves are the first point of contact between the health care worker and the

patient," said Andy Mills, president of Medline. "As a way to extend our breast cancer awareness campaign, we developed a line of pink gloves called Generation Pink, with the aim of getting people to talk about breast cancer."

The gloves and the videos have certainly contributed to the breast cancer discussion in no small way. In 2010, a sequel to the original video featured 4,000 healthcare workers and breast cancer survivors throughout North America.

"We wanted to create something as close to that scale as possible," said Smoller.

The team behind the Glen Cove Center video hosted a premier party on October 24 to celebrate the beginning of the voting period. Over 100 guests, including representatives from various Long Island hospitals, attended to show their support for breast cancer awareness and to experience the unveiling of the video. Attendees were treated to Glen Cove Center's gourmet hors d'oeuvres and decadent desserts from the in house bakery. Many of the items were "pink" themed, including some of the fine wines and champagnes served throughout the evening.

Glen Cove Center has gained considerable recognition over the years for the staff's outstanding commitment to top-notch rehabilitation and nursing. Most recently, the center was included in U.S. News' 2013 list of best nursing homes in the country. The halls of the facility are festooned trophies and awards amassed in various categories of excellence. Specific staff members, too, are commemorated in banners for their dedication to quality caregiving.

While charity work is nothing new for the Glen Cove Center staff, this is their first year to participate in the Pink Glove Dance Competition, but Smoller assured us that it would not be the last.

"It is a terrific contest, and we could not be happier to be a part of it," said Smoller. "Now we just need those votes."

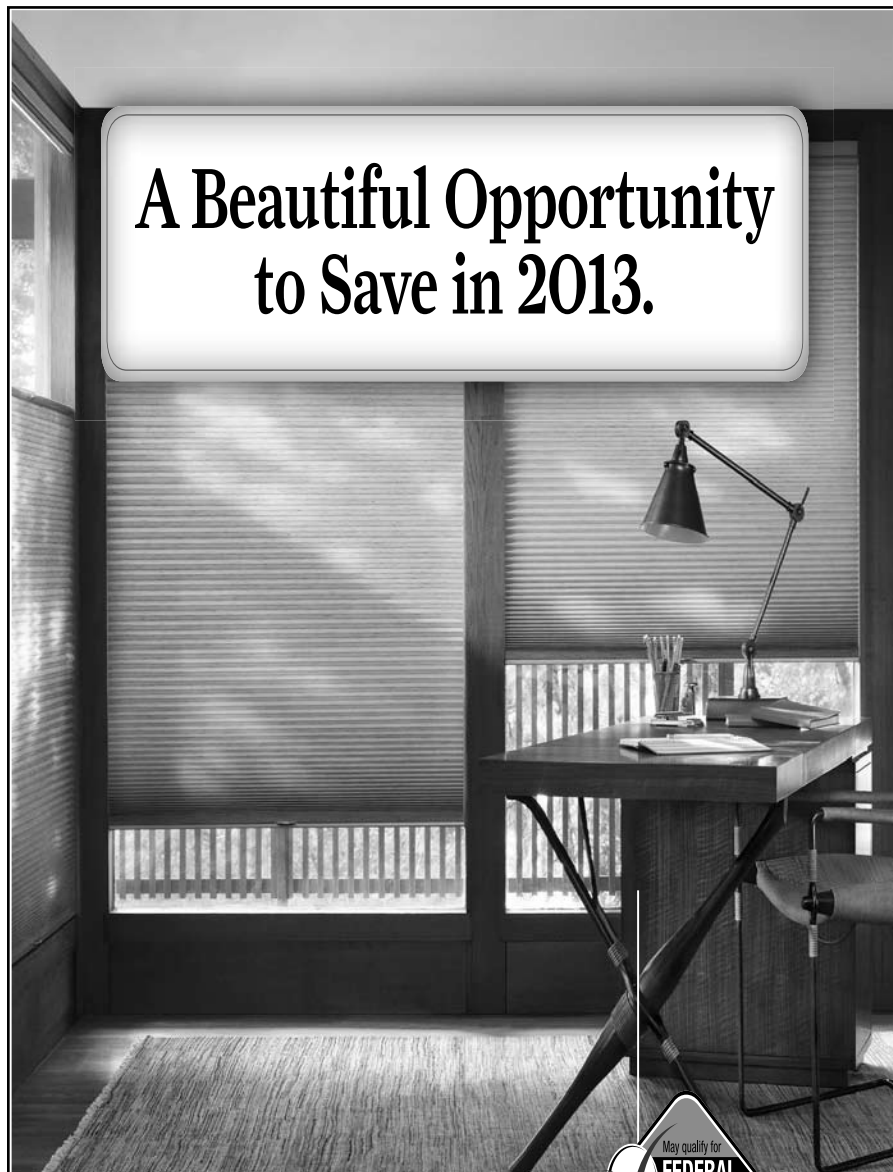
## Vincent Marmorale Speaks at Loggia Glen Cove No. 1016

Mr. Marmorale spoke about how Jews were saved by the Italians in Italy. For years Vincent worked with a survivor by the name of Walter Wolff. Walter was saved by the Italians and lived to tell his story. He wrote a book called, "Bad Times Good People". Walter and Vincent traveled throughout the United States and Europe telling his story. He died a few years ago at about the age of ninety. Walter told a deep and neglected story of how Italians proved their human-

ity during the worst period of 20th century history, despite Nazi brutality. After Kristallnacht in 1938 the author's family fled to Italy. There his family survived because strangers kept risking their lives to save them.

As a result of his dedication to human rights education, Vincent Marmorale was awarded the Louis B. Yavner Award by the New York State Board of Regents for outstanding contributions in the fields of Holocaust Studies and other violations of human rights. Vincent produced a documentary dealing with the role of the Italian people saving Jews during the Holocaust. Vincent returned from a trip to Italy where he was a guest of the President of Italy.

## 8th Graders at North Shore Middle School Study in Small Groups to Learn Algebra

North Shore Schools, Glen Head, NY, October 16, 2013 - In preparation for their 8th Grade Algebra I Inequalities Assessment at North Shore Middle School, students in Mrs. Horton's class gathered in small groups to work through three different review stations. The stations included Miscellaneous Mix Up, Solving Absolute Value Inequalities, and Solving Compound Inequalities. Mrs. Horton said, "These stations provided students with the opportunity to review the concepts and to challenge their thinking regarding the various topics studied in the Inequalities unit."

Mrs. Horton continued by saying, "Students were partnered up at each station and they had the opportunity to take turns selecting the problem that they wanted to work on from a collection of problem cards. After students worked on their problems individually, they then communicated to each other their problem solving strategy and their answer. Once the partnership agreed on the solution to the problem that they chose to work on, they checked their answer and then went on to select an additional problem. They could select an easier problem or a harder one based on how successful they were on the previous problem."

Mrs. Horton spent approximately three weeks presenting the material within the Inequalities unit to her students. Additional practice was assigned daily. Extra-help sessions were also provided at least twice each week to further assist students in mastering their study of inequalities.

'My Veterans'. It is especially pleasing for me today to honor Howard Stillwagon or Howie as we all know him. He is a personal friend I have known almost 40 years now. He is usually back here with the color guard but today he is being recognized for his service to our country during the Vietnam War.

"These past few years, as Memorial Day approached, I would ask Veterans to accompany me to the different Elementary Schools to show our children who they were honoring and to let the Veterans share the stories of their service to our nation. The children were always fascinated. I was trying to instill in them a respect for Veterans much like was demonstrated by the scouts this morning at the Big Ralph Park Re-Dedication Ceremony.

"This year Howard Stillwagon accompanied me to the Deasy Elementary School. He war his green jungle fatigues. I remember it was cool on the day we were there and Howie was hot and practically sweating in the cool gymnasium. After

the assembly I went over to Howard and I asked him, how he ever wore those fatigues in the hot humid jungles of Vietnam while carrying all of his gear plus his rifle? Howie said to me, 'I was 19 years old and about 150 pounds back then.'

"The children also asked me where I met Howie and I replied, 'Stroppe's' although they didn't understand a couple of the teachers acknowledged the reference.

"The point of all of this brings me back to the beginning. We send our children, our young men and women off to war, kids not much older than I was playing in the Kelly Street Jungle that eventually became Big Ralph Park. While I was pretending to be at war, Howie was actually fighting a war.

"Howie, I am so proud of you, and I'm glad you made it back home to be with us. Thank you for giving up part of your youth to preserve mine.

"On behalf of myself, your friend and mayor, our City Council, your family, our community and our nation, I say Thank You for Your Service. Thank you for standing beside us."

## 8th Graders Dissection at North Shore Middle School

Dissections are a common way for students to learn about the parts of the body in most science classes across the nation.

"The students were most fascinated when the brain was cut on its sagittal plane," said Mrs. Kelly. "Using scalpels

and a stereomicroscope, my students were able to view the arbor vitae ("tree of life") of the cerebellum. The arbor vitae or the white matter of the brain is comprised of a mass of axons which appears like a beautiful tree."

Talking about vacations, I am planning a trip to China this summer and I would like to begin preparing. Do you have any suggestions?

Dear Eager Traveler,  
I have just finished reading the perfect book for your introduction to present day China: *DREAMING IN CHINESE* by Deborah Fallows. Subtitled "Mandarin Lessons in Life, Love, and Marriage," this book recounts the author's attempt to learn Mandarin, the principal language of large parts of China, but it is much more than an exploration of lan-

guage. Fallows divides this short book (200 pages) into sections which detail the years she spent working and traveling throughout China with her husband and young children. She uses her study of the language to underscore cultural differences whether it be the limited use of personal pronouns, arrangements of north and south on maps, the order of names and addresses from large to small (country, city, street, apartment number), or the fact that 85% of Chinese share 7 family names and how all this impacts the individual's view of self, family and nation. Throughout, Fallows offers interesting anecdotes about her adventures with the language and culture of China. A very good introduction, indeed!


