Diversity Celebrated at Finley Middle School

Eighth-grade ELA and social studies teachers at Robert M. Finley Middle School in Glen Cove recently organized a day of cultural sharing entitled Diversity Day. Held in the school's mini center, the event served as a culmination to the students' studies on immigration. The gathering included presentations research projects as well as a feast of foods from different countries around the world.

ELA students read a compilation of short stories taken from the book "New Kids in Town" by Janet Bode, which explored experiences that teenage immigrants faced while coming to America and the difficulty they had assimilating into American culture. Students created cultural diversity dolls that resembled themselves and each student wrote a small narrative that discussed their cultural background and how it has shaped them as a person.

In social studies classes, students studied immigration in America during the late 1800s early 1900s. In preparation for Diversity Day, they created projects that reflect the diverse groups of immigrants who came to America seeking refuge, prosperity, and new beginnings. Honors students even created journal/scrapbooks in which they wrote from the

Regents classes created two character profiles; one from an immigrant in the book "New Kids in Town" and another from the era studied.

"Being that our school is very diverse, we wanted to host a Diversity Day so that our students could celebrate the culmination of the unit as well as all the wonderful cultures that surround us," said English teacher Claudia Marra, one of the coordinators of the event who also prepared a dish of chicken outlet parmigiana for the feast. Angels, jesters, candy canes, snowflakes, Chinese and Arabian dancers—see them all in Sea Cliff on December 14 at the Long Island Ballet Academy & Dance's annual Nutcracker. Directed by the school's founder Irina Lebedeva, the one-hour ballet performance features dancers ages 3 to 18.

"The holiday season is a good excuse to take a child to a show and The Nutcracker is a beautiful one," says Lebedeva. "The story centers around 9-year-old Clara who dreams about fun, excitement and friends. When her new wooden nutcracker doll comes alive, Clara's dreams turn into an amazing journey."

A Ballet Background

Born in Russia, Lebedeva started studying ballet at the age of 5. "Ballet school was a block from our house and I walked by myself to classes where I danced 3 to 5 days a week," Lebedeva explains. When she was 9, she moved away from home to begin training professionally, at some of the country's top schools. Lebedeva was a principal dancer at Ballet Festival Moscow.

Lebedeva defected to the United States in 1990 and has danced here ever since. She performed and taught with the Eglevsky Ballet and has led seminars and classes in 28 states.

In 2006, Lebedeva founded the Long Island Ballet Academy, which



trains students in the Vaganova method of classical ballet. Ballet stars trained in this leading method include Mikhail Baryshnikov.

Lebedeva is also a ballet coach and

choreographer at the Connecticut Ballet.

"Ballet is my life, love, everything," says Lebedeva. "Classical ballet requires strength, elegance, high technique and a lot of hours and years to become a pro-

fessional ballerina."

Scouts Visit Labyrinth

On November 23rd – 24th, 2013, the Boy Scouts of Troop 43 from Sea Cliff, NY went to Mohonk Mountain House to try and do the “Labyrinth”. The “Labyrinth” is a 1 mile rock scramble in which hikers ascend 300 feet up a mountain and have to climb over, under and through rock formations to get to the very top, which is called Sky Top Tower. Along the way, the scouts encountered challenging rock formations such as “Head Ache Rock”, “Fat Man’s Misery”, “The Lemon Squeeze”, and “The Crevice.” It was tough to make it through the entire course, but after about an hour the scouts found themselves at the final section called the “Lemon Squeeze”. The “Lemon Squeeze”, which is a deep crack inside the face of the mountain, is where the scouts had to climb several series of narrow, wooden ladders, some of which were on strange angles, making them hard to climb. Finally, the scouts came out the very top through a tiny crack called “The Crevice”.

After the scouts had finished the climb and their lunch, they headed to their campsite, which was only fifteen minutes away from the Mountain House. After the scouts set up camp, the temperature dropped and even started to snow for several minutes. The scout’s dinner was either pasta with marinara sauce or steak, depending on what patrol that scout was in. Overnight, the temperature dropped from 32 degrees to 22 degrees, with the wind chill making seem like it was 8 degrees. In the morning, all of the

troop’s water froze, so they had to warm it up by the campfire. Most of the scouts refused to leave the campfire since it was so cold out, but soon everybody got packed up and ready to leave, despite

the harsh weather. This trip was an especially cold trip, but it was also one of the very best adventures the Troop has done. The Troop’s next camping trip is practicing outdoor skills at Schiff Scout

Reservation in December. Hopefully, it will be warmer!"

Chris Crosby and Dave Berg are Glen Cove residents who perform together as part of the group DNA +C2 at the Metropolitan Bistro and the Oak Room in Sea Cliff. Mark Rechler's Band Circus Mind also includes Chris Crosby and Dave Berg.

Jason Crosby played some of his own compositions, some Pink Floyd and some Grateful Dead as he played guitar, or keyboards and sang.

Name the Celebrity



Last Week's Celebrity

Last week's celebrity was Jay C. Flippen. He had many guest roles in the 1960's including "Bonanza", "The Virginian", "Gunsmoke", "Johnny Ringo", "Bus Stop" and in "The Untouchables". In the 1962-63 season, he played "Chief Petty Officer Homer Nelson" on the NBC sitcom "Ensign O'Toole" with Dean Jones in the starring role. In the first season of the "Dick Van Dyke Show", he played "Rob Petrie's" former mentor "Happy Spangler". Later in life, Flippen continued acting although he used a wheelchair after an amputation. he died Feb. 3, 1971, during surgery from an aneurysm caused by a swollen artery one month before his 72nd birthday.

This week's celebrity was born in NYC on June 25, 1925. She is the daughter of actor parents. In fact, she made her acting debut opposite her parents in the 1938 film version of Dickens' "A Christmas Carol" opposite Reginald Owsen and Leo G. Carroll. In 2002, she appeared in two episodes of "The Drew Carey Show", as "Lewis' mother, "Misty Kiniski, alongside fellow TV mom, Marion Ross, who played Drew's mom.

BOND ORDINANCE OF THE CITY OF GLEN COVE, NEW YORK, ADOPTED NOVEMBER 26, 2013, AUTHORIZING THE PAYMENT OF REAL PROPERTY TAX REFUNDS PURSUANT TO TAX CERTIORARI PROCEEDINGS BROUGHT UNDER ARTICLE SEVEN OF THE REAL PROPERTY TAX LAW, STATING THE ESTIMATED TOTAL COST THEREOF IS \$400,000, APPROPRIATING SAID AMOUNT THEREFOR, AND AUTHORIZING THE ISSUANCE OF SERIAL BONDS OF THE CITY IN THE PRINCIPAL AMOUNT OF NOT TO EXCEED \$400,000 TO FINANCE SAID APPROPRIATION

The object or purpose for which the bonds are authorized to be issued is the payment of real property tax refunds pursuant to tax certiorari proceedings brought under Article Seven of the Real Property Tax Law.

The amount of obligations to be issued is not to exceed \$400,000. The period of probable usefulness is a minimum five (5) years and maximum twenty (20) years, dependent on the total amount of tax certiorari claims paid in a single fiscal year.

A complete copy of the Bond Ordinance summarized above shall be available for public inspection during normal business hours at the office of the City Clerk, City Hall, Glen Cove, New York.

PLEASE TAKE NOTICE THAT the Glen Cove City Council adopted the following Local Law 02-2013, at the City Council Meeting of November 26, 2013:

I. Section 252-40 of the Code of the City of Glen Cove is hereby added as follows:

ARTICLE XI

Superstorm Sandy Relief Act

Definitions.

Unless otherwise expressly stated, the following terms shall, for the purpose of this Chapter, have the meanings as herein defined. Any word or term not noted below shall be used with a meaning as defined in Webster's Third New International Dictionary of the English Language, unabridged (or latest edition).

IMPACTED TAX ROLL - the final assessment roll which satisfies both of the following conditions: the roll is based upon (a) a taxable status date occurring prior to October 28, 2012, and (b) taxes levied upon that roll were payable without interest on or after October 28, 2012.

IMPROVED VALUE - the market value of real property improvements excluding the land.

PROPERTY - Real property, property or land as defined under paragraphs (a) through (g) of subdivision 12 of New York Real Property Law.

RELIEF ACT - the Superstorm Sandy Assessment Relief Act as enacted by New York State Legislature, Chapter 424 of 2013 Laws of the State of New York.

SUPERSTORM SANDY - the storms, rains, winds or floods which occurred within the State of New York and the County of Suffolk during the period October 29, 2012 and ending November 3, 2012.

TOTAL ASSESSED VALUE - the total assessed value of the property prior to any and all exemption adjustments.

Implementation and Adoption of Superstorm Sandy Assessment Relief Act.

This law adopts and implements the provisions of the Superstorm Sandy Assessment Relief Act, as enacted by the New York State Legislature, Chapter 424 of the 2013 Laws of the State of New York, granting assessment relief to the victims of Superstorm Sandy.

Eligibility criteria and relief granted.

Notwithstanding any provision of law to the contrary, the City of Glen Cove elects to provide assessment relief for properties damaged by Superstorm Sandy, as authorized by the Relief Act, as follows:

<u>Lost Improved Value of Property as a result of Superstorm Sandy</u>	<u>Reduction of Assessed Value Attributable to Improvements on the Impacted Assessment Roll</u>
At least 10% but less than 20%	15%
At least 20% but less than 30%	25%
At least 30% but less than 40%	35%
At least 40% but less than 50%	45%
At least 50% but less than 60%	55%
At least 60% but less than 70%	65%
At least 70% but less than 80%	75%
At least 80% but less than 90%	85%
At least 90% but less than 100%	95%
100%	100%

Other provisions.

A. To receive relief under this law, a property owner must submit a written request to the City Assessor's Office on a form approved by the Director of the New York State Office of Real Property Tax Services and in accordance with the specific requirements of the Relief Act. Such request shall attach any and all determinations made by the Federal Emergency Management Agency, any and all reports made by insurance adjusters, and describe in reasonable detail the damage caused to the property by Superstorm Sandy and the condition of the property and shall be accompanied by supporting documentation, if available.

B. The percentage of loss in improved value shall be adopted by the Assessor from a written finding of the Federal Emergency Management Agency, or where no such finding exists, shall be determined by the Assessor in a manner provided by the Relief Act, subject to review by the Board of Assessment Review.

C. Where an Assessor determines a property has lost at least 10% of its improved value due to Superstorm Sandy, the assessed value attributable to the improvements on the property on the impacted assessment roll shall be reduced by the appropriate percentage specified in §245-22 of this law, provided that any exemptions which the property may be receiving shall be adjusted as necessary to account for such reduction in the total assessed value. To the extent the total assessed value of the property originally appearing on such roll exceeds the amount to which it should be reduced pursuant to the Relief Act and this local law, the excess shall be considered an error in essential fact as defined by subdivision 3 of Section 550 of the Real Property Tax Law. If the error appears on a tax roll, the tax roll shall be corrected in the manner provided by Section 554 of the Real Property Tax Law or a refund or credit of taxes shall be granted in the manner provided by Sections 556 or 556-b of the Real property Tax Law. If the error appears on a final assessment roll but not on a tax roll, such final assessment roll shall be corrected in the manner prescribed by Section 553 of the Real Property Tax Law.

Applicability.

This law shall apply to the impacted assessment roll, as that term is defined in the Relief Act and this local law.

II. SEVERABILITY

If any clause, sentence, paragraph, section, or part of this Local Law shall be adjudged by any court of competent jurisdiction to be invalid, the judgment shall not affect the validity of this law as a whole or any part thereof other than the part so decided to be unconstitutional or invalid.

IV. EFFECTIVE DATE

Local Law 02-2013 shall take effect immediately upon its filing in the Office of the Secretary of State.

The Circle is magical- everyone is young, beautiful, smart, and so very friendly and so, so willing to share. Yes,

that is the company motto: "to share is to care." Soon Mae is caught up in the company culture, her parents (and she, of course) are given the best health insurance imaginable, her meals are prepared by gourmet chefs on the exquisite company campus, her every need - known and unknown- is met. So ...what could be wrong? Nothing really just that she and all those around her have no private thoughts, no private moments. Everything is shared with the entire world. Everyone rates everyone and the company keeps score of all these ratings or "likes" which run into the multi- millions at times. This novel is our Orwellian 1984, our Faustian bargain with the devil, our Bonfire of the Vanities, and to some degree, all of us are complicit. A terrifying look into the present and the future!

To Bond or not to Bond ?

To The Editor,

On December 3rd between the hours of 7 AM and 10 PM, the North Shore Schools community will have the opportunity to vote on a proposed bond referendum in the amount of 19.6 million dollars. This is a large sum of money and it led me to take an extra suspicious look in to what could be costing so much, particularly in these economically difficult times. I don't like doing homework any more than my children, but for this size project, extra due diligence was necessary.

What I found out is that this amount of proposed borrowing is dedicated solely for the infrastructure of our five schools, our central administration office and the District transportation facility. This amount came to be after the elimination and rejection of many more contemplated projects, some that would greatly enhance the schools and the students, others simply " wish list " items that would be nice to have but that economic realities couldn't support.

I learned that the bond would enable the district to address real time health and safety concerns posed by structures which have dramatically deteriorated with age, conditions or whose life expectancy has expired. Not only will this bond confront immediate building defi-

ciencies, it will pay for numerous other projects already identified in the school districts five year building and grounds maintenance plan, allowing the community to spread the payments out over fifteen years rather than having to absorb a significant spike in any one year due to a major infrastructure failure. And all the work to be completed with funds from the bond will have no increase in school property taxes. No smoke and mirrors, just the coinciding of one school bond being paid off with the adoption of another.

But most assuring to me is the fact that the bond was crafted not just by the school officials and administration but by community representation and input from students, alumni, parents with children in the schools and taxpayers with children no longer attending.... those with a vested interest from varying perspectives. And there should be no small significance that our Board of Education, who do not always agree on all topics, have reviewed this bond with all their means and have unanimously agreed that this is the most fiscally responsible infrastructure proposal for the current and future integrity of the North Shore Schools.

Please do your homework and pass the bond. Vote YES on December 3.

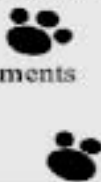

SAFE PRIDE Project Coalition set next year's goals to benefit Glen Cove kids

SAFE's PRIDE Project Coalition held their annual Sustainability Planning Meeting on Oct. 22 to address the implementation of environmental strategies for the upcoming year. The agency continues to be the only alcohol and substance abuse prevention agency in Glen Cove emphasizing education and abuse intervention.

The Coalition is overseen by the Board of Directors of SAFE. It is Co-Chaired by Councilman Tony Gallo and SAFE's Executive Director Dr. Sharon Harris. The Coalition's four established committees (Community, School, Parent and Youth) met as a full membership to review their work from the previous year and strategically plan to set goals for the upcoming year.

"SAFE initiated and supported the Coalition for the last nine years under the auspices of a Drug-Free Communities Support program grant," said Georgie Connett, SAFE Board Chair.

Connett maintained that the environmental strategies set in place are sustainable. Laws have been initiated and passed, community and school based services have thrived and needs assessments indicate a decrease in alcohol and substance use, but more work needs to be done.

"From inception, it has been the long-term sustainable goal to establish the Coalition as a separate entity after the funding ends," said Connett add that in the process the Coalition has been established as its own Foundation. Much has been accomplished in this area as the Foundation website has been created, Logo has been created and the IRS 1023 form has been submitted for tax exempt status. It is anticipated that the Town Hall meeting in April will serve as the venue to launch the Foundation."

The Community Committee, Chaired by Councilman Tony Jimenez, serves as a think tank to examine needs assessment data and to make recommendations with goals focused on education and communication and make recommendations and implement media campaigns regarding underage binge drinking, enforcement of underage drinking laws and social host law.

Community Committee members

plan this year to continue their efforts to make the community aware of Project 21, an initiative designed to identify vendors who sell to minors. As in years past, the committee will increase public service announcements for educational purposes and share data with the community regarding efforts like the Glen Cove Police Hotline, where residents can call to report underage drinking and violations to the Social Host Law anonymously.

In year 10, the School Committee plans to improve and increase participation in SALT, the student athletic leadership teams, where high school students meet with younger students to support and encourage them to make healthy choices. The committee would like

They promoted and implemented the Annual Youth Substance Abuse Awareness Day and the "I've got 100 better things to do than drugs campaign" last year and have additional ideas for this year too. Their goal this year is to reach out to as many younger children as possible to promote anti-smoking campaigns promoted by the Anti-Tobacco Action Coalition of Long Island and they plan to use high school students to convey the message. Committee members are hard at work planning the "Kick Butt Day" in Nov. at the



The School Committee, Chaired by Denise Kiernan, Director of Health and Athletics for the Glen Cove School District, expands and enhances health education curriculum to address Bach Harrison Prevention Needs Assessment (PNA) Survey findings which is released every 2 years and works to enforce the district's Tobacco Policy and drug-free school zones. Initiatives of the committee include implementation of evidence based Tobacco Cessation program, Athletes helping Athletes Program, Family University, Red Ribbon Week celebrations throughout the school district by promoting prevention activities geared around living a drug-free lifestyle for students.

Some committee members are teachers in the school district. They use their expertise to enhance the health education curriculum to target avenues to address what would be useful to address

The Parent Committee, Chaired by Laurent Caballero, SAFE's bi-lingual Outreach Worker, acts as a bi-lingual parent resource for prevention, education, intervention and research on alcohol and drug abuse in Glen Cove. They serve as a liaison with the PTA and are also active in assessing the causes of substance abuse problems in Glen Cove among the youth. It is the members of this committee that work to promote Coalition activities like the Annual Health and Fitness fair, the Parent Universities
