The group sang to an audience of national dignitaries, led by President Barack Obama and First Lady Michelle Obama, as well as U.S. Senators and members of the House of Representatives.

The Select Chorale was told that the President and First Lady would likely stop in for a brief hello. The GCHS students were overjoyed when President Obama entered the room and said "Hey Glen Cove" before stopping to shake hands and talk with every member of the Select Chorale.

Pictured are scenes from the trip, which included a stop at the U.S. Capitol. Superintendent of Schools Maria L. Rianna met the students down in D.C. and was proud to be a part of the experience.

Students Wrap Packages for Military "Any Soldier Program"

The Glen Cove area students pictured in the photo below are wrapping packages to be sent to active military personnel. What a wonderful learning experience for these young people.

Ms. Anna Dunlop, Young Adult Librarian, Coordinator of the "Any Soldier Program" has been involved since December 2006. The patrons of the Glen Cove Public Library have been sending letters and packages to the soldiers serving in Iraq and Afghanistan. This project is based on a program called Any Soldier, Inc., started on August 26, 2003 as a simple family effort to help the soldiers in one family unit. It now includes any member, of any of the Armed Forces in harm's way, and has 21,186 Service Members with 565 Military Contacts. On February 14, 2008, the Any Soldier project reached a milestone. Through the efforts of 35,000 volunteer contacts and countless supporters worldwide, donations have been given to over one million troops!

In the Library, there is a box for donations which may include DVD's,

CD's, computer games, sporting equipment, small games, snack food, holiday decorations, hygiene items, paperback books, crossword puzzles, socks, hats, etc. and especially letters. You may include your e-mail address and possibly, you will hear from one of the soldiers.

So far, they have received contributions from people coming into the library, our local schools, and the Senior Center. To enable us to cover the cost of mailing, monetary donations from the Friends of the Library, Veterans of Foreign Wars, the Glen Cove Fire Department, Boy Scout Troop 6, and individual patrons have been very generous. The Nassau County American Legion has started a matching dollar program with the Young Simmons American Legion Post in Glen Cove for the "Any Soldier Program". The County will donate \$200 and the Young Simmons Post will match it with a \$200 donation of their own. One of the most rewarding things I have seen is the enthusiasm and generosity of our Young Adults (6th Grade and up), who have volunteered to organize and mail the packages. We have had an average of fifteen students come on Saturday mornings to help with this project. There

is a list of suggested items, please call Anna Dunlop, coordinator, at 676-2130 for further information.

These letters and packages go into the hands of Soldiers who don't get much or any mail first. Everything is

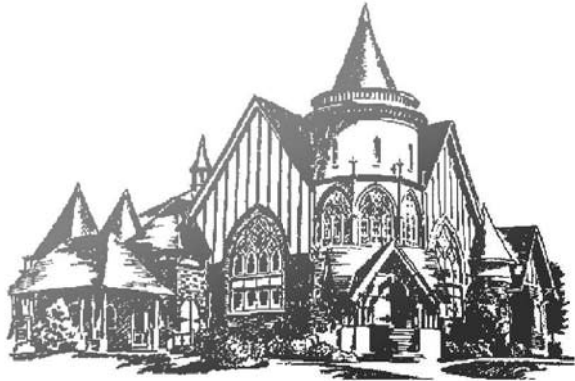

The INN is located in the basement of the Baptist Church on Continental Avenue where "behind the scenes" volunteers start their day at 9:30 a.m. by diligently preparing, cooking, organizing supplies, and clothing to be distributed to the guests who arrive at 11:30 a.m. Food is served to the hungry, indigent and needy every Tuesday, Thursday and Friday from 12 noon through 1 P.M. Special volunteers are advocates who help the physically challenged guests, entertain the pre-school children with toys and books and deliver meals to the tables to mothers and children where needed. A Social Worker is available to help other guests with their situations in need of direction.

After the meal, donated non-perishable items of food, fresh fruits and vegetables and bread are distributed to the guests to take home. Highlights of the year: Thanksgiving where volunteers distribute turkeys and all the trimmings for the guests to take home; at Holiday time, the INN purchases and receives donations of new clothing, accessories, and gift cards, where volunteers in full force, sort, package with fancy red and green shopping bags, then distribute these gifts to over 300 individuals according to their age and gender for families in need helping make their holidays special. The INN is extremely grateful to the volunteers for their hard work, expending time, energy and dedication in helping others who are faced with difficult times.

President Estelle, who has volunteered her services to the Soup Kitchen for the past 5 years, is the guiding force of the INN. North Shore Schools Kindergarten Registration Begins for the Kindergarten Class of 2014-2015

In September 2014, your child will enter Kindergarten and start an exciting journey.

The first step into school is one of the passages in life that marks the beginning of new experiences and relationships. It begins an educational experience that will serve as a foundation for their future.

During the Kindergarten Registration Week and Orientation Week, you will learn more about North Shore Schools and the Kindergarten program. First you must complete a registration process that provides assurance of your residency in the North Shore School District and the necessary demographic information on your child. Parents enrolling their child(ren) in non-public (private and parochial) schools must also prove residency and meet eligibility requirements in order to qualify for transportation.

The first step in this process is to complete a residency packet. You may obtain this packet in person at the main office at any of the three elementary schools including Sea Cliff Elementary School, Glen Head Elementary School or Glenwood Landing Elementary School. Upon completing the required documents, please call Mrs. Katherine Miller, Registrar for the North Shore Schools, at 277-7824 to schedule an appointment to review your completed documents. Appointments will be available beginning January 13, 2014. This meeting should take no more than ten or fifteen minutes. At this meeting you will receive a second packet of information pertaining to the second step in the process, which is to register your child at the appropriate elementary school.

Glen Head School
Monday, March 10th through Friday, March 21st

Glenwood Landing School
Monday, March 17th through Friday, March 21st

Sea Cliff School
Monday, March 24th through Friday, March 28th

The third step in preparation for Kindergarten will be orientation. Your school will contact you with the dates and details regarding the orientation program during which you will have an opportunity to become better acquainted

with the school, the principal and some of the people who your child will work with beginning in September 2013.

Superintendent Dr. Edward Melnick and everyone at the North Shore School District warmly welcomes you and your family. The next thirteen years will be ones of fulfillment and growth.

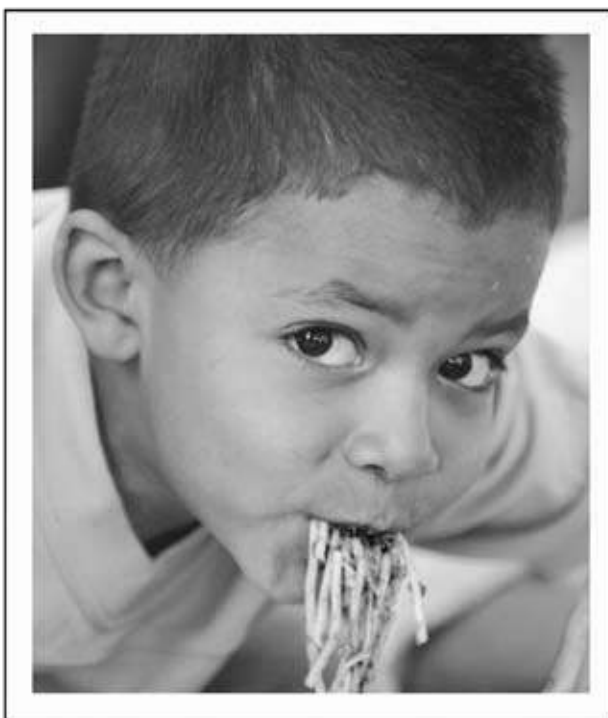
Chip-A-Tree Drop Off Program at Morgan Memorial Park

A particular standout, and the movie role she is probably best remembered for, is the untidy, hen-pecking wife "Agatha Souse" in the comedy classic "The Bank Dick" (1940), the prime source of W.C. Fields' misery. They remained quite friendly off-stage with frequent cordial letters throughout their remaining years. Though her home base was in NYC where she continued to perform in the theater, she made her living commuting to Hollywood in the post-war years, ending her career with brief appearances on TV. She died on Nov. 17, 1957 at the 67 in New Mexico.

This week's celebrity was born in Boston, Massachusetts on May 21, 1924. She became interested in acting as a member of the drama club at Cambridge Latin School. However, she attended all of high school without a speaking part. After graduating HS, she spent most of the 1940s in search of an acting career, eventually landing Jan Sterling's role in a traveling production of "Born Yesterday". She made her Broadway debut in 1949 with the play "Touch and Go". In the late 1960s and early '70s, she replaced other actresses in "Don't Drink the Water", as "Marion Hollander" and in Neil Simon's "Plaza Suite". She played "Mollie Malloy" in two revivals of "The Front Page". She also appeared in the 1969 film comedy "If It's Tuesday, This Must be Belgium" with Suzanne Pleshette and Mildred Natwick. In the 1980s, she returned to the stage in "42nd Street" with Jerry Orbach. In 1987, she

PLEASE TAKE NOTICE THAT the Glen Cove City Council adopted the following Local Law 03-2013, at the City Council Meeting of December 10, 2013:

BE IT RESOLVED, that the City Council hereby adopts Local Law 03-2013, Chapter 235, Part 4 – Bamboo, Article XI General Provisions and Regulations: Chapter 235.

Part 4 – BAMBOO

Article XI General Provisions and Regulations (§ 235-82 - § 235-85)
 § 235-82 Purpose and intent.

A. Purpose. The purpose of this chapter is to promote and protect the property, property values and welfare of the residents of the City of Glen Cove and their guests, and of the visitors to the City, and to protect the property and preserve the aesthetic qualities of the environment of the City of Glen Cove.

B. Intent. It is the finding of the City Council that the planting and/or the growing of bamboo, within the City of Glen Cove has been and will continue to be destructive to the natural environment, including indigenous flora, and destructive to structures and walks on properties within the City adjoining and neighboring those properties where bamboo has been planted and/or permitted to grow; that because of these effects the planting and the growing of bamboo threatens the value and physical integrity of both public and private property in the City; and that therefore, in order to protect and preserve said environment and values, the City declares it necessary to regulate or prohibit the planting and/or growing of bamboo within the City.

§ 235-83 General provisions.

A. Definitions. As used in this section, the following terms shall have the meanings indicated:

BAMBOO

Any tropical or semitropical grass of the genera Bambusa, Dendrocalamus or of any other related genera.

BAMBOO PROPERTY OWNER

A property owner in the City who has planted or grown or caused the planting or growing of bamboo on his property and/or permitted or permits the growing of bamboo of his property that had initially encroached onto his property from an adjoining or neighboring property.

B. Applicability. For purposes of this section, if bamboo is found growing upon a property that shall constitute presumptive evidence that the growing of bamboo on the property shall have occurred with the consent of the owner of such property, except that such property owner shall not be presumed to be a bamboo property owner if the property owner did not plant or grow or cause said bamboo to be planted or grown in his property and he shall provide the Code Enforcement Official with proof, satisfactory to the Code Enforcement Official, that within a reasonable period of time after he first learned of the encroachment of bamboo onto his property from an adjoining or neighboring property he advised the owner of such adjoining or neighbor-

ing property of his objection to the encroachment of bamboo onto his property and/or initiated steps for the removal of the bamboo from his property.

C. Prohibition. Effective upon the date this provision shall become law, the planting or growing of bamboo shall be prohibited within the City of Glen Cove. Any person who thereafter plants or grows, or causes to be planted to grow, bamboo within the City shall be deemed to be in violation of this section, and shall be subject to such penalties as are set forth hereunder.

D. Regulation.

(1) Any bamboo which has been planted or otherwise permitted to grow in any property within the City of Glen Cove prior to the effective date of this chapter may remain on such property subject to compliance with § 235-83D(2). Each bamboo property owner shall be responsible to ensure that the bamboo planted or growing on his property prior to the effective date of this chapter does not encroach or grow upon any adjoining or neighboring property or properties, including all public property and rights-of-way held by the City, and shall be required to take such measures as are necessary to prevent such bamboo from invading or growing onto adjoining or neighboring properties. Such measures shall include but not be limited to the installation of sheathing comprised of metal or other material impenetrable by bamboo at a sufficient depth within the property line or lines where the bamboo is planted or is growing to prevent the growth or encroachment upon adjoining or neighboring property by said bamboo. The City Council may from time to time prescribe such rules and regulations as may be necessary to give effect to this.

(2) No Bamboo property owner within the City of Glen Cove shall cause, suffer, or allow bamboo to be planted, maintained, or otherwise permitted to exist within ten (10) feet of any property line, street, sidewalk, or public right-of-way in a fashion that blocks or otherwise impedes lines of sight at intersections or impedes pedestrian access to City sidewalks, thoroughfares and rights-of-way.

E. Removal.

(1) In the event that bamboo growing on a bamboo property owner's property invades or grows on an adjoining or neighboring property that is owned or held on behalf of the City of Glen Cove, the City shall notify the bamboo property owner that the bamboo said owner had planted or caused to plant or had permitted to grow on his property has invaded City property, and that the bamboo property owner is responsible for the removal of such bamboo from the City property. This notice shall be sent by certified mail return receipt requested and regular mail to the latest address of the bamboo property owner on file with the Building Department records or as available through other records of the City of Glen Cove.

(2) In the event that the bamboo property owner does not remove or contract for the removal of said bamboo from the City property, or does not make an arrangement with the City for removal of such bamboo within thirty (30) days from the date the City first deposited the notice as provided in Subsection § 235-83E(1) above with the United States Postal Service, then the City, at its discretion, may remove or arrange for the removal of such bamboo from the City property. The bamboo property owner shall be liable and responsible to the City for the City's costs in removing the bamboo from the City property. Such costs

may be assessed against the property of the bamboo property owner as a tax payable by such bamboo property owner in the event that the costs remain unpaid more than thirty (30) days after demand for payment has been made by the City on the bamboo property owner.

(3) In the event that the City is compelled to undertake the removal or to contract for the undertaking of removal of bamboo, as provided for in Subsection § 235-83E(2) above, it will do so in a reasonably workmanlike manner. Neither the City nor its employees shall have any liability for damages or other claims to the bamboo property owner by reason of the removal of such bamboo. In the event such removal entails or causes damages to the flora or other property of a person other than the property of the bamboo property owner, the bamboo property owner in violation of this section shall be responsible for such damages.

(4) In the event that bamboo growing on a bamboo property owner's property invades or grows on an adjoining or neighboring private property, the neighbor shall notify the bamboo property owner that the bamboo said owner had planted or caused to plant or had permitted to grow on his property has invaded his property, and that the bamboo property owner is responsible for the removal of such bamboo from his neighbor's property. This notice shall be sent by certified mail return receipt requested and regular mail to the latest address of the bamboo property owner on file with the Building Department records or as available through other records of the City of Glen Cove.

(5) Notice. If the provisions of § 235-83E(4) of the foregoing sections are not complied with, then the Director of Public Works shall serve written notice in person or by mail upon the owner, lessee or occupant or any person having the care or control of such lot or land to comply with the provisions of this section.

(6) Noncompliance with notice. If the person upon whom the notice is served fails, neglects or refuses so to comply with such written notice and demand of the Director of Public Works within five (5) days after service of such notice, the Director of Public Works shall cause such condition to be remedied, and the actual cost of such work, plus 50% for supervision and administration in connection therewith shall be certified by the Director of Public Works to the Controller, and shall thereupon become and be a lien upon the property in which such violation of this section occurs, and shall be added to and become and form part of the taxes next to be assessed and levied upon said lot or land, and shall bear interest at the same rate as taxes and shall be enforced by the same officer, and in the same manner, as taxes.

F. Replanting prohibited, unless otherwise permitted and approved by the City Council. Any bamboo either planted or caused to be planted or existing on a property prior to the effective date of this section may not be replanted or replaced in kind once such bamboo is or has become, for any reason, dead, destroyed, uprooted or otherwise removed.

G. Notification. Within thirty (30) days after the effective date of this chapter the City shall give notice by reasonable means to all property owners in the City advising them of the enactment of this section and requesting that each property owner who would be deemed a bamboo property owner hereunder as of the effective date of this section notify the City in writing no later than sixty (60) days after the date of the aforementioned notice from the City that bamboo is present on the property of such property owner and such other information as may be requested in the notice from the City.

§ 235-84. Violations and penalties.

A. Violations. Any property owner who violates any of the provisions of this sec-

tion shall be guilty of a violation thereof. Each and every day that a violation of this section shall exist shall constitute a separate violation of this section.

B. Penalties.

Any person or corporation violating any provision of this section shall be deemed guilty

of a violation and, upon a first conviction, shall be punished by a fine of no less than \$250 and no more than \$1,000 for each day the violation exists; upon a second or subsequent conviction, by a fine of no less than \$500 and no more than \$2,000 for each day the violation exists.

§ 235-85 Severability.

In the event that any portion or portions of this chapter shall be determined to be invalid or unenforceable for any reason, the remainder of the chapter and its provisions shall remain in full force and effect.

This local law shall take effect immediately upon its filing in the Office of the Secretary of State.

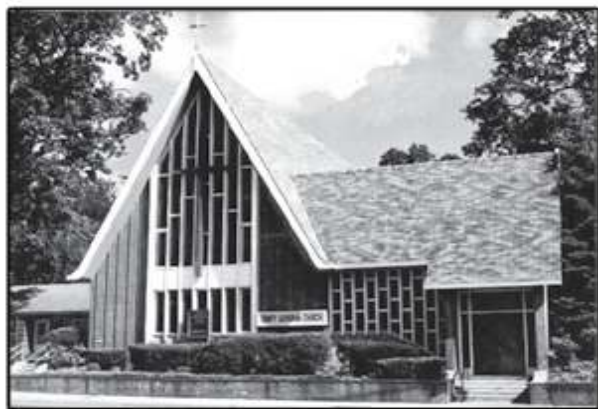

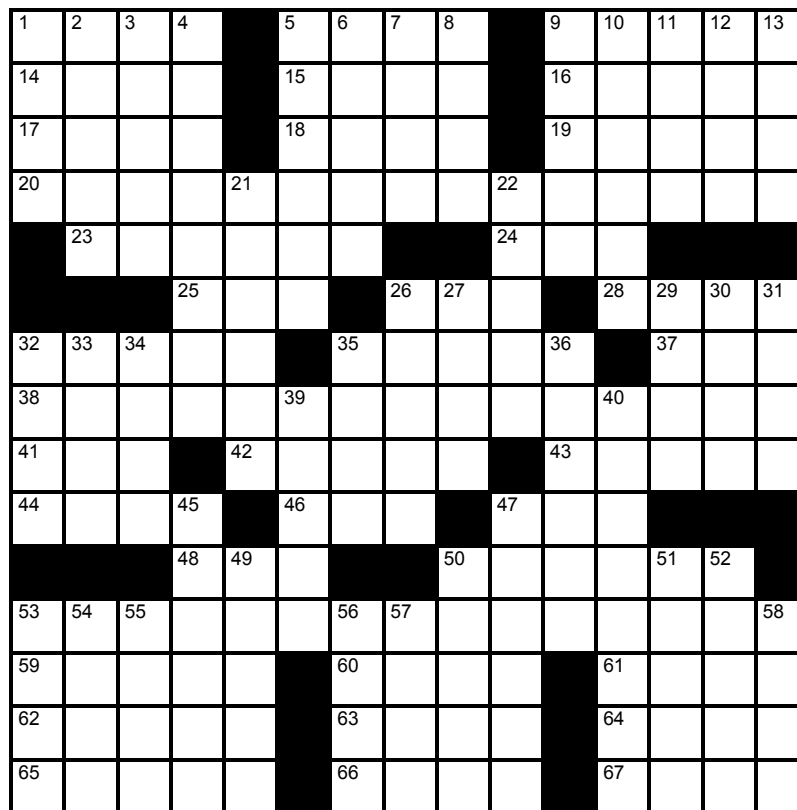

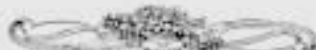
