Glen Cove Pays Tribute to Rev. Dr. Martin Luther King, Jr.

On January 19, 2015, the City of Glen Cove and Glen Cove School District Rev. Dr. Martin Luther King, Jr. Birthday Commemorative Commission held their 31st annual tribute to the champion of civil rights and Nobel laureate, Rev. Dr. King. The events and program, with the theme "overcoming the Challenges to the Dream," honored Rev. Dr. King as well as the memory of Maya Angelou.

The morning began with a symbolic march from the First Baptist Church to Finley Middle School which always brings to mind the voter registration march from Selma to Montgomery led by Dr. King in 1965. Commission Chairwoman Sheryl Goodine welcomed everyone with a hearty "Harambe" and introduced Mayor Reginald Spinello whose remarks included the importance of education to eradicate prejudice, guarantee justice and to ensure that the history of the Civil Rights movement is accurately handed down to future generations.

Participants were treated to an inspiring program in Finley School the highlight of which was the keynote speech given by Glen Cove Police Department Detective Brian Simmons who related GLEN COVE Gelebrates Martin Luther King Jr. Day

On Thursday evening, January 15, friends and supporters of the Civic Progress Committee gathered in Sea Cliff to nominate candidates for the Village election, which will be conducted on March 18 to elect two Trustees as well as the Mayor. The nominating caucus was conducted by Dan Maddock, chairperson of the committee.

Before the nominating process began, however, a number of tributes were made in honor of Carol Vogt who is stepping down as trustee after six years of steadfast service to the Village. Mayor Kennedy stated the sentiments of many when he expressed his deep appreciation for Carol's contribution to the civic life of the Village. He also reminisced a bit about their work together on the Board of Trustees: "Carol and I had the extreme pleasure of coming into office with the global economic meltdown, the failure of the world's biggest banks. We were told 'Welcome to government. Now don't spend any money!" I am so grateful to have had Carol by my side as we shredded proposed budget after proposed budget, figuring out how we were going to provide our constituents the highest quality service at the lowest possible cost.

Carol is kind, fair, conscientious, steadfast and persistent, while at the same time she can be comical and uplifting. She

There are new grapes and regions to discover and with so many different wines available to us from all over the world, why limit yourself to the same 2 or 3 grapes over and over again? In fact, with the quality and diversity available in today's market, there has never been a better time to be a wine consumer. My advice is to take advantage of this and there are several easy ways to go about it. You can try an indigenous wine from a classic wine producing country, like Lagrein, Friulano, or Schiava from Italy, maybe

a Plousard from France, or a Monastrell from Spain. Another option is to go with a wine from a country that has a long wine making tradition, but one you are less familiar with, like Austria, Croatia, or Slovenia. Additionally, there has been a movement by many winemakers to go back to working with some ancient and very traditional methods, so if you'd like to experience ta different range of flavors and textures then try one of the so called 'Natural Wines". Drinking wine doesn't have to be snooty and pretentious, and the wine experience doesn't have to be so serious. Be adventurous, take a chance. You may be pleasantly surprised. Most of all have fun!

is an incredible public servant and a good friend. She will be sorely missed by the Board of Trustees and me."

Following those words, the chair opened the floor for nominations. Ed Lieberman was nominated for trustee by Carol Vogt. The nomination was seconded by Kathleen DiResta. Dina Epstein was also nominated for trustee by Kristine Janusas. That nomination was seconded by Cindy Neugebauer. Bruce Kennedy's name was then placed in nomination for mayor by Phil Como and seconded by Bruce's wife Robin. With no further nominations being made, the nominees were approved unanimously.

Each of the nominees then responded to their selection. After thanking the committee for his nomination, Ed Lieberman stated his commitment to work on behalf of the Village: "With Trustees Villafane and McGilloway, along with my fellow nominee Dina Epstein, it is certain that our Village will continue to be a special place to live and raise a family. As a public servant I will continue to ensure that my oath of office will be honored; to be vigilant to the general welfare of our residents; to be responsive to their needs and concerns; to be faithful to Sea Cliff's heritage of tolerance; to champion the preservation and protection of Sea Cliff's natural beauty and its resources.'

Following Mr. Lieberman, nominee Dina Epstein detailed her reasons for accepting her nomination with the following words: "My family and I are the beneficiaries of all that Sea Cliff has to offer. There are beautiful, scenic places to walk, jog and ride bicycles. There are street fairs, beach parties, musical gatherings, plays, art shows - too many civic and community events to mention. Sea Cliff has services for seniors. We have an incredibly dedicated Fire and EMS Department who respond immediately if you need them. The infrastructure of our Village is well tended. We enjoy a tremendous level of services from our public works department, yet unlike most of our neighbors, our taxes have remained level. "The excellent quality of life here in Sea Cliff has not happened by accident, nor is it a given. Rather, it is the result of the cumulative efforts of generations of Sea Cliff volunteers who have given their time and expertise to guide Sea Cliff's future while honoring and protecting its past. It would be my honor to join them as a Trustee of this Village.

"It is my hope that the residents of Sea Cliff see fit to place me in this position of trust. Thank you."

Brue Kennedy then accepted the nomination for mayor. Among his remarks were the following: "When I originally ran in 2009, I promised to work hard, to put a lid of Village taxes, to rebuild our downtown and to fairly represent our residents. I believe that I have kept those promises and we have seen great progress in the past six years. The success we have experienced has not been a one man show—it has been the collaborative efforts of ten different hardworking Board members, a dedicated staff, countless volunteer groups and many members of our community.

"We have seen a total resurgence of our downtown area with class A restaurants, shops, jewelers, artists and photographers. Part of this success has been incredible synergies between the restaurants and the arts community. I am proud to have been part of this collaborative effort.

"I picked up where previous administrations left off with the renaissance of our waterfront. We have expanded the old pavilion and built a full scale kitchen. We have built a performing arts gazebo on the beach that is fully equipped with a professional sound system and LED lighting. Additionally, we were able to realize the hard work and vision of 3 previous administrations with the completion of the Scudders Pond remediation project.

"A project that is currently underway that will help shape the next generation is the interior renovation of the Children's Library which will make the facility handicap accessible, energy efficient, and historically restored.

"The first of three phases in the restoration of Village Hall occurred a few years back but we were unable to continue onto Phase II because of budgetary constraints. Through perseverance and relationship building with other levels of government, we were recently awarded a \$300,000 grant that will enable us to complete Phase II and part of Phase III, which will include some much needed interior work.

"An environmental and downtown revitalization project that has been one of my main goals for the past 6 years will begin next week—the downtown sewer project. Former Mayor Krieb started this project with a feasibility study and the securing of assorted grant money. We picked up where she left off and this nearly \$2 million project will be completed by the spring.

"Taking a leadership role such as being Mayor or a member of the Board of Trustees is a true labor of love and at times requires a very thick skin. It requires countless hours of work, time taken away from your family, and a willingness to take chances. The rewards come from leaving behind a community that is in better condition than when you started.

"We have accomplished tremendous success in the past 6 years, but I am not done yet. I still have the fire in my belly, the desire to work and serve, and the support of my family to serve another term. I accept your nomination and look forward to working together throughout this campaign. Thank you."

Following those words, chair Dan Maddock concluded the meeting and exhorted one and all to support the committee's nominees in the coming election.

From Dream To Reality Grand Opening of the North Shore Schools Victorian Communications Center

Almost a decade ago, the dream of building the Victorian Communications Center at the North Shore School District began when Superintendent Dr. Edward Melnick approached Technology teacher Bruce Fichtman with an innovative idea of renovating an existing classroom at the high school into a student operated communications studio. Mr. Fichtman said, "I countered Dr. Melnick' s proposal with the vision of designing a Victorian-style building from scratch with my students in the LI Studies (LIS) Program that would be located on school grounds." He continued, "The Victorian house construction tied in perfectly with our Long Island Studies curriculum, in which high school seniors study in-depth local history and literature and then take on the multi-year task of building a usable structure that represents our rich North Shore history."

On September 18, 2014, the dream became a reality as the Viking Foundation joyously celebrated the grand opening along with past and present Board of Education members, administrators, faculty, staff, students, and numerous North Shore community members. Dr. Melnick welcomed everyone in attendance and whole-heartedly thanked the many people involved. He stated, "This was a wonderful, collaborative effort made possible by the generous financial support of the Viking Foundation along with Bruce Fichtman and local citizens who shared their craft and expertise with our students and faculty." He proudly added, "It truly exemplifies projectbased learning at its best - the kind of learning that our students will remember forever.

Dr. Melnick summarized that this beautiful communications center located at the front entrance of the North Shore High School campus will provide a rich and authentic interdisciplinary experience in multimedia for our students now and in the future. The curriculum will include the following: the study of broadcast journalism, pre/post production of digital video editing, camera, lighting, and composition, the development of screenplays and storyboards, student produced documentaries, short films and newscasts, in-house interviews with selected guests, the broadcast of sporting and theater events via the internet, student operated internet radio station, and the development of music videos."

Mr. Fichtman said, "My students and I were so lucky and thankful to have the opportunity to work alongside numerous local community members for the past seven years. Masters of their trade, these volunteers acted as both mentors and teachers to our students, providing authentic learning experiences that are not found in any standard textbook."

He proudly proclaimed, "Today, I congratulate all 325 students in the LIS program who worked so hard over the past ten years on this project. You should feel very proud of your accomplishment.



It is with great pride that I look at this studio, knowing that it was built by student hands. The structure and everything it encompasses is a testimony to the value of a progressive, rigorous, interdisciplinary program in the North Shore School District."

At the ceremony, other speakers included Viking Foundation Board Member, Mr. Phil Como, President and CEO of Bethpage Federal Credit Union (a major contributor), Mr. Kirk Kordelski, and North Shore High School Principal, Albert Cousins. Mr. Como discussed the involvement of the Viking Foundation and passionately reminded everyone of the numerous community members and alumni that came forward to donate to this project. He stated that, "It is a strong indication of what type of education the North Shore School District represents." He added, "The North Shore Schools is one of the best school districts in the state and across the nation. More than 175 students entered kindergarten this year and will have access to ample resources along with the dedication and commitment of our entire faculty and staff. 13 years from now these children will be better prepared to embark on their next step in life."

He was followed by Mr. Kordelski who communicated how Bethpage Federal Credit Union is actively involved with partnering with school districts. He mentioned that his son attends the North Shore Schools and looks forward to the production of a new TV commercial for his company in the near future!

The North Shore School District again would like to thank everyone who participated in this tremendous undertaking. Mr. Fichtman said, "I cannot thank the members of the Viking Foundation enough for providing the vision, funding, and opportunity for North Shore students over the past seven years to construct the communications studio. And, of course, the students and I could not have attempted or completed a project of this scale without the assistance, wisdom and knowledge of members of the local community. Thank you to administrators Superintendent Edward Melnick, Assistant Dr. Superintendent for Instruction, Rob Chlebicki, and Assistant Superintendent for Business, Olivia Buatsi, John Hall, Facilities and Operations Manager, John Hall and his staff, North Shore High School, Jerry Boertzel and Jerry Blackburn, Gerard Pascucci and Todd Siewers) North Shore High School technology teachers Tom Melito Bob Sather, and Teresa Paolilli-Schiano and her fashion design students for the red ribbons. 

The Victorian Studio is the first building at the North Shore School District that will be heated and cooled using geothermal energy. In addition, the LI Studies (LIS) Program, is just one of five interdisciplinary humanities courses offered to seniors at North Shore High School. Several other school districts have visited North Shore to observe our senior programs which have been recognized as Programs of Excellence by the New York State Council of Teachers of English.

In closing, Mr. Fichtman so elegantly said, "It is both an honor and privilege to be a school teacher in the finest school district in New York State, if not the nation, in which the local community, Board of Education and administration, are willing to support learning experiences such as the Long Island Studies program and the Victorian Studio project. North Shore Summer Theater Workshop Is Back! Apply Today To Join A Great Tradition!

Revived after a decade-long hiatus, the North Shore Summer Theater Workshop is accepting applications from students in grades 7 through 12 for six weeks of intensive production-based instruction in all aspects of the dramatic arts. The beloved program, which ran for 42 years before falling to budget cuts, was revived thanks to efforts of dedicated alumni, among them the district's most celebrated performers.

With space for up to 60 students, and a wait list for 6th graders, the workshop will take place in the air-conditioned performing arts facilities of North Shore HS Mondays through Thursdays, June 29 to August 6 from 2 p.m. to 6 p.m. (after summer school classes) with additional evening

hours added for technical rehearsals in the final two weeks. Performances will be July 31 and August 1, 7 and 8. Two productions are envisioned, according to producer Julia Brennan of North Shore Arts Angels Inc., which is overseeing the program. A selection of one-act plays will be performed on the first weekend followed by a musical with a student orchestra on the second weekend. Staff will be comprised of theater professionals and theater educators supported by paid college-age interns.



Thousands of North Shore students have participated in the Summer Theater Workshop which ran from the summer of 1962 to the summer of 2003, including one season when four musicals were staged. Over 140 alumni returned to the NSHS stage in June of 2013 to participate in the Viking Masquers 50th Anniversary Gala, a musical revue that raised funds to revive the summer program as an entity independent of the school district, which was forced to cut funding in 2004 after a rare school budget defeat.

Actor Michael McKean NSHS '63 (on TV in "Laverne & Shirley," on film in "This Is Spinal Tap" and most recently on Broadway in "All the Way") sent a film (view it here) recalling his first audition for Summer Theater Workshop founder Bruce Mooney, and actress Kate McKinnon NSHS '02, a current cast member of "Saturday Night Live," also known for her work on the "Big Gay Sketch Comedy Show" and the Upright Citizens Brigade, performed a number with her sister, the actress and director Emily Berthold, NSHS '07.

The alumni event raised over \$45,000 to help keep tuition affordable. The pay-oneprice tuition of \$1,800 includes over 120 hours of performance-based instructional time, a refundable \$100 damages fee, two tickets to each performance, a souvenir t-shirt, program and poster, tech week meals, and all materials associated with the workshop. Thanks to the generosity of many, the holidays were truly a time to give thanks, both for a delicious meal and for the people and groups that made it possible.







Week of January 22, 2015

Name the Celebrity



This week's celebrity was born in San Francisco on June 17, 1880. He reportedly prospected for gold in Alaska in his youth, but by 1909 had gone into the theatre. He appeared in at least two plays on Broadway between 1909 and 1912, and made his motion picture debut in Cecil B. DeMille's 1914 original film version of "The Virginian" in a bit part. By 1923, when the film was remade, he progressed to playing the lead villain, "Trampas" opposite Kenneth Harlan as "The Virginian". With the advent of "talkies", the film was soon overshadowed by yet another remake in 1929 with Gary Cooper as "The Virginian" and Walter Huston as "Trampas". He also starred in "Law and Order" (1932) with Walter Huston, Harry Carey Sr., and Andy Devine. He was the old man on the wagon train in the pre-Code drama "Call Her Savage" (1932) starring Clara Bow in her secondto-last film before retiring to become a rancher in Nevada. He also played "Dr. Petry" in "Drums Along the Mohawk" (1939) with Claudette Colbert, Henry Fonda and Edna May Oliver. The film produced by Darryl F. Zanuck and nominated for two Academy Awards, was Director John Ford's first color feature. *Last Week's Celebrity*

Last week's celebrity was Nina Foch. She was born Nina Consuelo Maud Fock. For obvious reasons, her last name was altered to prevent any movie marquee mishaps. Her movie career came during the height of the 1940s, when she played cool, aloof and often foreign women of sophistication. She would ultimately be featured in over 80 films and hundreds of TV shows. She was a regular in John Houseman's CBS-TVs "Playhouse 90." In 1951, she appeared with Gene Kelly in the musical "An American in Paris", which was awarded the Best Picture Oscar. Foch appeared in "Scaramouche" (1952) as "Marie Antoinette", and in Cecil B. DeMille's "The Ten Commandments" (1956) as "Bithiah", the Pharoh's daughter who finds the infant Moses in the bulrushes, adopts him as her own son, and joins him and the Hebrews in their Exodus from Egypt. She received an Academy Award nomination for Best Supporting Actress for her role in the boardroom drama "Executive Suite" (1954) starring William Holden and Barbara Stanwyck. In "Spartacus" (1960) starring Kirk Douglas and Laurence Olivier, she played a woman who chooses gladiators to fight to the death in the ring, simply for her entertainment. In her final years, she appeared on the TV series "Just Shoot Me", "Bull", "Dharma and Greg", and NCIS", the latter portraying "Dr. Donald 'Ducky" Mallard's" elderly mother. On Dec. 5, 2008, at the age of 84, she died of complications from blood disorder myleodysplasia.

Spelling Bee success for Finley's LeBaw




Axelle LaBaw, a seventhgrade student from Finley Middle School in Glen Cove, was selected as the winner of the school's Spelling Bee.

I just finished a fabulous book that has been sitting on my bookshelf for years that I had just never gotten around to reading: BEHIND THE SCENES AT THE MUSEUM: A NOVEL by Kate Atkinson. Written in 1996, this was Atkinson's first novel and what a stellar achievement it is! First, let's make it clearthe museum in the title is the families we are part of over many generations, in this case four generations from the late 1850's up until the1990's. We first meet the narrator in 1951 as she is being conceived and we follow her through the years into young adulthood; in between we meet her great-great grandparents, great grandparents, grandparents , parents and waves of cousins, siblings, aunts, uncles, suitors, friends.... In a

series of footnotes- actually chaptersthat fill us in on the connections to the present, we learn many secrets that Ruby will never know. Life in York, England is filled with humorous , poignant, and sometimes tragic adventures for Ruby and her relatives, and as we move back and forth between past and present, we see how family traits resurface and mistakes are made anew by each generation. A truly memorable book and highly recommended!
