Preying On Elderly Homeowners

Two unknown men are suspected in deceiving local elderly residents to gain access into their homes by posing as maintenance workers. Once inside one incident resulted in the burglary of fifty thousand dollars of one couples life savings.

According to Det. Lt. John Nagle on February 3, 2015 at approximately 1:30pm a male white approximately 5'11 with a mustache wearing a baseball cap knocked on the door of 47 Wolfle Street in Glen Cove.

According Nagle, When the 85 year old resident answered the door, the man proceeded to walk into the house take the homeowner by the hand and led her to the back door of the house. "This unknown man was wearing some type of walkie talkie around his neck," said Nagle. "At that time her 79 year old husband woke up from his nap and joined the man and his wife at the back door. The unknown man then told the homeowners that he needed to cut some trees down in their yard. The husband pointed out to the man that he doesn't have any trees in his yard. The man then started talking on his walkie talkie and a second man entered the house.'

The second man is described as a heavy set male white with short dark hair possible 5'7 wearing dark clothing. This second man was also wearing some type of a walkie talkie around his neck. Both of the men then walked the husband into the backyard. The men then continued to talk with the husband. After a few minutes the second man entered the house while the first man remained in the back yard with the husband. After a minute or two the first man walked into the house accompanied by the husband. When they got to the front of the house the husband noticed a silver or grey 4 door pickup truck backing out of his driveway. The husband remembers that this pickup had some type of cover on the back bed of the truck.

"The first man then proceeded to walk out of the house and toward the pickup truck which was now driving south bound on Wolfle Street," said Nagle. "The husband then checked his bedroom and noticed that his safe containing his life savings of over \$50,000 was missing from his bedroom."

Approximately 15 minutes earlier, according to Nagle, a block away at 11 First Street, a man fitting the description

of the first man entered the residence of another elderly couple. Once inside the house the man confronted the 93-year-old man living there with his wife and told him he was there to pick up a table. The couple's home health aide emerged from another room and confronted the

Keith Callaghan was the runner up in the competition. Principal Rosemarie Sekelsky congratulates the following students:



The Blind Truth- February 8th!



THE BLIND TRUTH, a one-man show with music, follows the singular life of Vincent Basile, a.k.a Vinny St. Marten, who was born with severe glaucoma in both eyes and eventually lost his sight by the age of seven. Growing up poor, the last of sixteen children, Vinny's childhood was marked by personal and social challenges - bullying, racism, hate, violence, abuse - and a series of harrowing operations to regain his sight. When those operations failed, he was thrown into a Kafkaesque system of special schools where "they just tried to make me blinder."

Rebelling against the role society had carved out for him, Vinny followed his own dream, and his eventual triumph, as a world-traveled singer-drummer working with some of the greats of the music business, is thrilling and inspirational. "With all the adversity I faced," he says, "it was the gift of blindness and my passion for music that literally saved my life."

Vinny St. Marten has been called "a blind visionary" for his keen and unflinching insight into the human condition. And THE BLIND TRUTH takes us on Vinny's musical odyssey, with songs and scenes drawn from his own personal experience. He is joined onstage by Elysa Sunshine, a frequent collaborator and long-time member of his band, who provides keyboard accompaniment and vocals. The book of THE BLIND TRUTH is by Vinny St. Marten, Elysa Sunshine and Frederick Stroppel, with music & lyrics by Vinny St. Marten and Elysa Sunshine. The production is directed by Frederick Stroppel.





Richard Walter Heurtley

Richard Walter Heurtley, gentleman, scholar, sportsman, adventurer, Renaissance man par excellence, died in his 95th year at his home in Sea Cliff on 19th January.

He was born in Manhattan, son of Richard Heurtley and Helen Thatcher Heurtley. Richard attended Allen- Stevenson School and Philips Exeter Academy, graduating at 15 with a full scholarship to Harvard University. After two years he left Harvard looking for adventure. He was adept at canoeing and embarked on a solo canoe trip form his parent's summer home in Darien Connecticut to Daytona Beach, Florida. Later he travelled to Panama where he bought a 36 foot ketch and sailed her through the Panama Canal and up to Stratford Connecticut. He then lived on the ketch for several years while working on an oyster boat hauling 'spat' to the Oyster Bay Oyster Company.

In 1944 Richard sold the sail boat and entered Columbia University where he earned BA, MA, and PhD degrees, majoring in Western European History. He specialized in German History and German Intellectual History. He held teaching posts at Colombia University, North Carolina University, Carnegie Institute, and Long Island University.

He eventually settled in Sea Cliff where he continued sailing, running –which he did competitively into his 80's- and traveling with many adventures.

Richard had a lifelong love of music, his favorite being the works of J.S.Bach and the Baroque composers. He was a sponsor of Music at St. John's, a professional group performing

masterpieces of the Baroque. He also loved opera and attended as much as he could. He loved dancing, especially folk dancing and in his youth belonged to a folk dance group. He could often be seen joining dancers at local folk festivals. After retiring from teaching at C.W.Post., Richard turned his talents to investing, and enjoyed stock market trading. He was a very 'handy' man and enjoyed working on his property and maintaining his antique furniture collection.

His was a well-rounded life, filled with energetic enjoyment of good things, good friends, good conversation, and sharing with family.

Richard is survived by his wife Janette Kling Heurtley, stepchildren Peter Ames of Boston, Hugh (Sheila), and Kristian (Kristen) Mariaca of Loudonville, NY, and Teresa Mariaca Barnett (William) of Bloomington, Indiana. Grandchildren Loran Cook, Amya Crounse, Nicholas Mariaca, Nathan, Tyler, Emma, Tessa Barnett and Liliana Mariaca.

WHEREAS, the City Council of the City of Glen Cove is desirous of enacting a Local Law to protect the health, safety and welfare of its citizens; and

WHEREAS, a public hearing on the proposed Local Law was held on January 13, 2015, whereat all interested persons were given an opportunity to be heard with respect to the enactment of said Local Law;

NOW THEREFORE BE IT RESOLVED, that the City Charter be amended as

§C2-19 Department of Code Enforcement; powers, duties.

There shall be a Department of Code Enforcement, the head of which shall be the Director of Code Enforcement.

The Director of Code Enforcement shall be appointed by the Mayor with the consent of the Council, and shall be under the direction and supervision of the

The Director of Code Enforcement shall:

Be responsible for enforcement of all laws, ordinances, rules, regulations, codes and orders applicable to the use of land and the location, design, materials, construction, alteration, repair, equipment, maintenance, use, occupancy, removal and demolition of the buildings and structures and their appurtenances located in the City of Glen Cove; and

b. Provide to the Mayor quarterly reports of all activities of the Department and all inspectors, in addition to any reports directed to be made to the Mayor.

D. If any provision of this section shall be in conflict with any other provision of this Charter or the City's Code of Ordinances the provisions of this Section

E. This Local Law shall take effect upon their filing with the Office of the Secretary of State.

Article 5: Police Force

Section C5-3: Division of Code Enforcement

There shall be within the Police Department, the Division of Code Enforcement. Said division shall be supervised by the Chief of Police or his designee and shall be staffed with civilian employees. Employees in this division serving as Multiple Residence Inspectors shall also have the enforcement powers of

Code Enforcement Officers.

B. As section 10 of the Municipal Home Rule Law of the State of New York grants the City Council of the City of Glen Cove the authority to enact local laws and amend local laws and for the purpose of promoting the health, safety or general welfare of the City of Glen Cove and for the protection and enhancement of its physical environment, the Mayor with the consent of the City Council shall appoint to the Division of Code Enforcement from time to time such municipal officers, employees, or independent contractors deemed necessary to effectuate, administer and enforce such local laws.

C. The Code Enforcement Division

shall be responsible for enforcement of all laws, ordinances, rules, regulations, codes and orders applicable to the use of land and the location, design, materials, construction, alteration, repair, equipment, maintenance, use, occupancy, removal and demolition of the buildings and structures and their appurtenances located in the City of Glen Cove. Furthermore, the Code Enforcement Division shall be responsible for enforcement of all other codes and ordinances as so conferred by the Code of the City of Glen Cove upon code enforcement officials as well as the Fire Prevention, Housing Standards, Landmark Preservation, and Noise codes.

The Code Enforcement Division shall provide to the City Attorney quarterly reports of all activities of the division and all inspectors as necessary for prosecution, in addition to any reports directed or requested to be made to the Mayor.

If any provision of this section shall be in conflict with any other provision of this Charter or the City's Code of Ordinances, the provisions of this section

Name the Celebrity




Our celebrity was born Etienne Pelissier Jacques de Bujac in Carlsbab, New Mexico on April 20, 1904. His mother died shortly after childbirth. As a young man, he left the University of the South in Sewanee, Tenn. without graduating. He worked at many jobs, including as a sailor, an insurance man, oil worker, surveyor, prize fighter, car salesman, real-estate agent, and also worked at a slaughterhouse. A meeting with David O. Selznick at a Hollywood party started his acting career. He appeared in nearly one hundred feature films. He made his debut in 1931 in "Heroes of the Flames." He tested for the lead role of the "Ringo Kid" in John Ford's western "Stagecoach" (1939), but John Wayne got the part. He played a soldier who seduced a naive woman, portrayed by Irene Dunne, and got her pregnant as he left for the war, in the 1933 production of "Ann Vickers." He starred in the 1933 blockbuster "King Kong", which became an enormous success and established him as a star. He also played villains, appearing as a gangster in "Let 'Em Have It" (1939) and as the Huron warrior Magua opposite Randolf Scott in "The Last of the Mohicans" (1936). He starred with

Spencer Tracy playing the leader of a lynch mob in Fritz Lang's first Hollywood film "Fury" (1936), and with Errol Flynn in Michael Curtiz's epic western, "Dodge City" (1939), which became one of Warner Brothers' biggest hits. A consistent box office draw, he appeared in many movies at many studios before leaving Hollywood to serve in WWII.

Last week's celebrity was Montague Love. He had a commanding, puckeredlip British delivery of speech which he could believably weld to any part, but it particularly fit characters of authority, as in the silent era. One of Love's first sound films was the part-time talkie "The Mysterious Island" co-starring Lionel Barrymore. In 1937, perhaps his best known character tour-de-force displaying his genuine acting power was his Henry VIII in the first talking version of Mark Twain's "Prince and the Pauper" with Errol Flynn. It is hard to forget him in purple, as "Bishop of the Black Canons" in "The Adventures of Robin Hood" (1936) also with Errol Flynn. He played gruff authoritarian figures such as Monsieur Cavaignac", who, contrary to history, demands the resignation of those responsible for the Dreyfus coverup, in "The Life of Emile Zola" (1937), as well as, Zorro's father in the 1940 version of "The Mark of Zorro" starring Tyrone Power. In 1939's "Gunga Din" with Cary Grant, it is Montague Love, who reads the final stanza of Rudyard Kipling's original poem over the body of slain "Din". His last film, "Devotion" was released three years after his death on May 17, 1943, at the age of 63.

Daly Lecture at NSHM





Dear Sea Cliff Sun and Snow Lover, My evening book group just read a wonderful historical novel (just 200 pages) that will take you far, far away without your having to leave Sea Cliff: EUPHORIA by Lily King. Set in New Guinea in the 30's, this book tells the story of three young scientists who find love, intrigue, and despair in their study of tribal life. With some startling changes, the story is largely based on the lives of Margaret Mead, her two husbands, Reno Fortune, Gregory Bateson, and her lover Ruth Benedict- all renowned anthropologists. Anthropology was a relatively new science in 1930 and each of the characters takes a very different approach to its practice. Nell- the Mead character-is the most appealing of the trio, but she too shows remarkable callousness and misguided benevolence toward the men and women she encounters. The

characters' back stories, especially of their early years in London and New York, prove a fascinating contrast to their lives in the South Pacific. With a touch of mystery and a strong overlay of tropical romance, you have a fine read for a snowy evening. Recommended!

Question: Where are our tax dollars going?

Answer: To pay John Chase, Counsel for the City of Glen Cove Planning Board, to help the developer of the Villa Project gain approvals from the Nassau County Planning Commission. On January 29, our Planning Board Attorney, who is supposed to be neutral was advocating for the Villa Project at the Nassau County Planning Commission in a meeting with Bob O'Brien, County Attorney. of the Villa Project, the County just abdicated its role and allowed Mr. Chase to convince them that Glen Cove can move the Villa project forward without the required scrutiny.




