



Drug Arrests In Glen Cove and Glen Head

Glen Cove Police Detective Lieutenant John Nagle reports that on February 13th the Glen Cove Police Department conducted two search warrants, one at 100 Mcloughlin Street in Glen Cove and another at 123 Glen Head Road in Glen Head. The Glen Cove Crime Prevention Unit (CPU) and Police officer Steven Grella began investigating the two locations after receiving information that drugs were being sold there.

After months of investigation the officers were able to secure a search warrant for both locations. The search warrants were executed in the morning hours of Friday the 13th by Glen Cove Police department. Officers recovered a quantity of cocaine and a bullet proof vest at the Glen Head address. They arrested Carlos Jaco age 21 at that location and charged him with two counts of criminal sale of a controlled substance 3rd degree, two counts of possession of a controlled substance 3rd degree and 7th degree criminal possession of a controlled substance.

At the 100 Mcloughlin Street address, Officers recovered over 11 grams of cocaine, scales, drug packaging materials, and over \$700 in cash. Michael Martinez, 24 years-old was arrested at that location and charged with four counts of possession of a controlled substance 3rd degree, and two counts of criminal sale of a controlled substance 3rd degree.

While executing the search warrant at Mcloughlin Street officers observed illegal living conditions.

Between 9-11 people were found living in the house and an illegal business was being operated out of a detached garage. Several beds were located in upstairs bedrooms and three separate rooms were found in the basement each with hot plates and rigged wiring. Code enforcement officers issued multiple citations to the home owner for unsafe conditions including numerous fire safety violations and illegal basement habitation. Glen

Cove Police Deputy Chief Christopher Ortiz, who currently heads the Code Enforcement said, "This incident underscores the reason behind the recent realignment of code enforcement. In many cases, the most egregious housing violators are the homes that call for the most police attention either due to drug involvement, public nuisance violations or other issues. By working together, we can multiply our efforts and make an impact that will increase public safety."

North Shore Schools Kindergarten Registration

In September 2015, your child will enter Kindergarten and the start of an exciting journey. The first step into school is one of the passages in life that marks the beginning of new experiences and relationships. It begins an educational experience that will serve as a foundation for their future.

During the Kindergarten Registration Week and Orientation Week, you will learn more about our Kindergarten program and about our schools. First you must complete a registration process that provides us assurance of your residency in the North Shore Schools and the necessary demographic information on your youngster. Parents enrolling their child in non-public (private and parochial) schools must also prove residency and meet eligibility requirements in order to qualify for transportation and textbooks.

The first step in this process is to complete a residency packet. You may obtain this packet in person at the main office at any of the three elementary schools. Upon completing the required documents, please call Mrs. Katherine Miller, Registrar for the North Shore Schools, at 277-7824 to schedule an appointment to review your completed documents. Appointments will be available beginning January 12, 2015. This meeting should take no more than ten or fifteen minutes. At this meeting you will receive a second packet of information pertaining to the second step in the process, which is to register your child at the appropriate elementary school.

Please note the following registration dates for the Elementary Schools:

- Glen Head** **Monday, March 23rd through Wednesday, March 25th**
- Glenwood Landing** **Monday, March 16th through Friday, March 20th**
- Sea Cliff** **Monday, March 23rd through Friday, March 27th**

The third step in preparation for Kindergarten will be orientation. Your school will contact you with the dates and details regarding the orientation program during which you will have an opportunity to become better acquainted with the school, the principal and some of the people who your child will work with beginning in September.

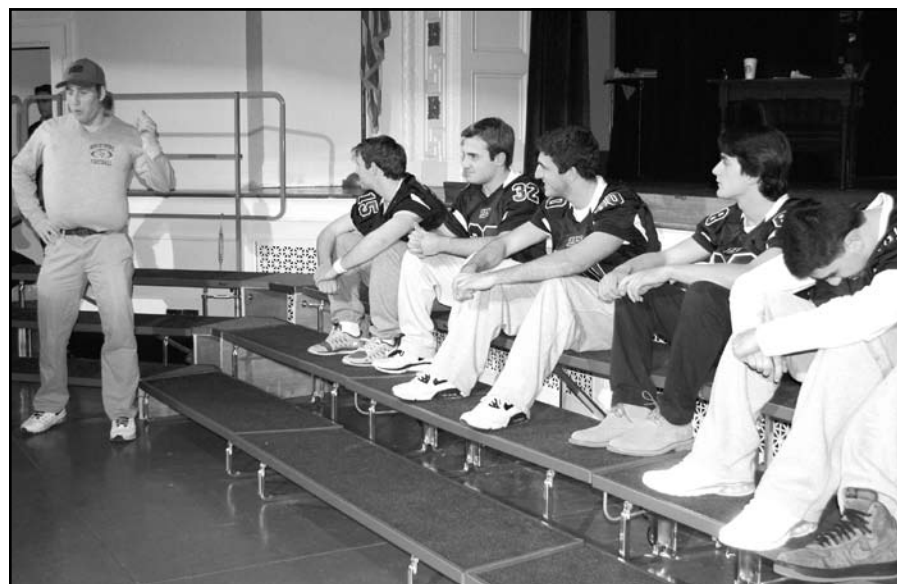

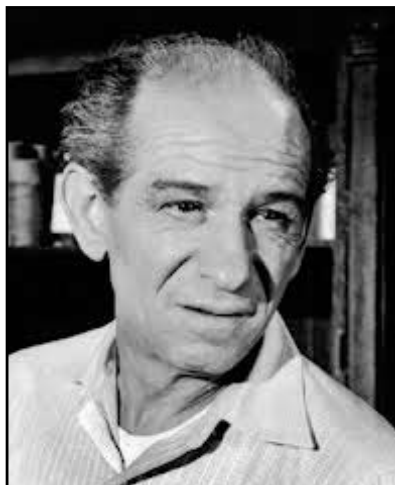

in "The War of the Worlds" (1953) with Gene Barry, "The Bad and the Beautiful" (1953) with Lana Turner and Kirk Douglas, "Requiem for a Heavyweight" (1959) with Jackie Gleason and Anthony Quinn and in "Experiment in Terror" (1962) with Glenn Ford and Lee Remick.

Last Week's Celebrity

Last week's celebrity was Mary Nash. She moved to Hollywood from NYC in 1934, where she was in films until 1946. According to Allmovie, "Nash was often cast as seemingly mild-mannered women who turned vicious when challenged, as witnessed in her work in "College Scandal" (1936) and "Charlie Chan in Panama" (1940). Her most sympathetic role was as the long-suffering wife of blustering capitalist "J.B. Ball", portrayed by Edward Arnold, in "Easy Living" (1937)." She also showed those colors for her Shirley Temple fans, first as "Fraulein Rottenmeier" in "Heidi" (1937) and then as "Miss Minchin" in "The Little Princess" (1939). She played Katharine Hepburn's socialite mother in both stage and movie productions of "The Philadelphia Story" (1940). She played a supporting role in Howard Hawks and William Wyler's 1936 Academy Award winning film "Come and Get It", again with Edward Arnold. She also had a featured role in Otto Preminger's "In the Meantime, Darling" (1944) with Jeanne Crain. Her second to last film was the very popular, star-studded ensemble "Till the Clouds Roll By" with June Allyson, Lena Horne, Frank Sinatra, Judy Garland and many more. Mary Nash died at the young age of 92, on Dec. 3, 1976.

Cirrect callers: Will and Babs Hutchins, Don Adams, Mario Moccia, Roberta Pezza

This week's celebrity was a veteran Polish born character who grew up in New York, and, after vaudeville experience, started acting in small parts on Broadway from the early 1930s. He gained further experience in the capacity of theatrical production supervisor, before entering motion pictures in 1937 as an MGM contract player. He made his first film appearance with an uncredited role in "True Confession" (1937) and his first credited film appearance came in two episodes of the serial "Dick Tracy Returns" (1938). Helped by friends like producer John Houseman and his next door neighbor, Moe Howard of the Three Stooges fame, who got him parts in the Stooges' films "Nutty But Nice", "Uncivil War Bonds", "Hokus Pokus", and "Three Hams on Rye", our celebrity would eventually appear in more than eighty films and on TV more than 100 times. Until the 1950s, he was seen primarily in tiny, supporting roles as clerks, reporters, bank tellers and small time managers. His career was briefly put on hold after being blacklisted during the McCarthy Era. By 1953, he found a new lease of life in TV and began a slow return to the big screen. Some of his roles were

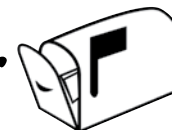
