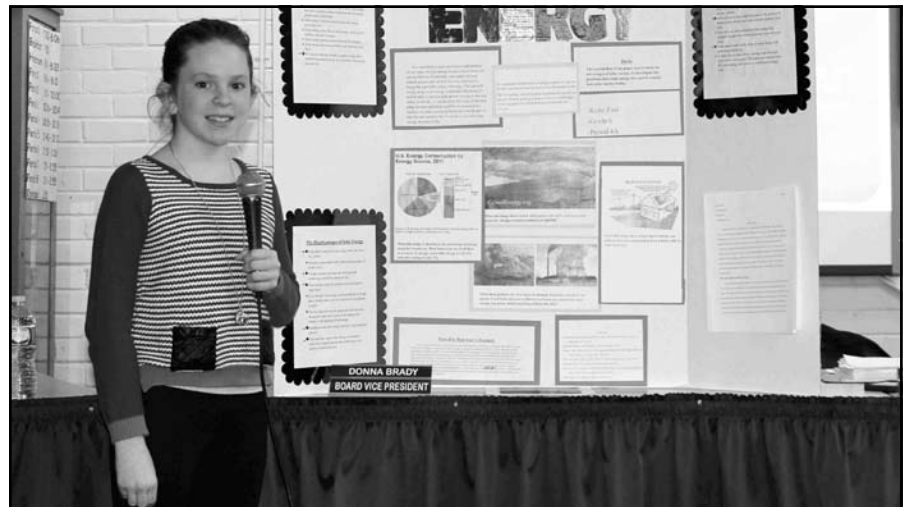
Townsend expressed his gratitude to

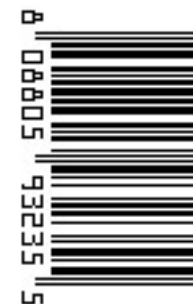

Sea Cliff 3rd Graders Participate in Interdisciplinary Brazilian Culmination



At Sea Cliff School, third graders had an interdisciplinary culmination combining lessons in art, music, history, and global issues as they ended their extensive study of Brazil.

Music teacher Ashley Hassett said, "The music primarily focused on the rainforest and its different layers. My students and I talked about how the instrument sounds were meant to mimic the sounds heard in the rainforest. The drum circle represented the four layers of the rainforest - the forest floor, the understory, the canopy and the emergent layer - and how they all connect and work together." She added, "During the culmination, each group of students played a different rhythm pattern. These patterns were layered together creating one overall sound - just like in a real rainforest!" The Brazilian instruments were made from natural products from the region.

In addition, as part of the Interdisciplinary unit, third graders in art learned to organize their thoughts prior to creating their artwork through participating in discussions, visualizing, sketching, experimenting, and reflecting.

Art teacher Lisa Giurlanda said, "We analyzed artwork as a form of text. We discussed a variety of global issues and students were encouraged to use different mediums to research and express their various topics of concern." Some global issues as expressed by the students included "Save the Animals," "It's Raining Acid Because of You!", "Put a Paw on Poaching," and "A World Without Trees is a World Without Life."

The young Sea Cliff artists were encouraged to make thoughtful decisions about their work and really shared topics they felt passionate about. Ms. Giurlanda concluded by saying, "All of the third graders at Sea Cliff were immersed in the art processes to create a powerful work of art. They learned that through thoughtful decision making, art can be used as a way to express their feelings, ideas, and thoughts with the world."

Name the Celebrity



Born Laura Hardie, on January 22, 1878 in Windsor, Berkshire, England, this week's celebrity made her stage debut at, the age of 3, when she played "Fairy Peasblossom" in "A Midsummer's Night Dream." In 1883, at the age of 15, she joined the Gaiety Girls, the famous dance troupe based at the Gaiety Theatre in London. She soon became so tall that she towered over all the other dancers. In December of 1906, Beerbohm Tree's extravagant revival of "Antony and Cleopatra" opened at His Majesty's Theatre, with Tree as "Mark Antony" and our celebrity as "Cleopatra". Her performance received much critical praise. Beerbohm Tree had been the manager of the Haymarket Theatre in the late 1880s and founder of the Royal Academy of Dramatic Art. She performed on many more British stages before her departure to the U.S. in the late 1920s. She became a voice coach and teacher in diction. In 1935, German born actress Luise Rainer, the first person to win multiple Academy Awards, and the first person to win them consecutively,

hired our celebrity to improve her (Rainer's) theatre acting and English. Among her many film appearances, our celebrity appeared in "Shadow of Doubt" (1935) with Virginia Bruce and Betty Furness, "Anna Karenina" (1935) with Greta Garbo, "Wee Willie Winkie" (1937) with Shirley Temple, in Mitchell Leisen's "Kitty" (1945), a comedic performance as "Lady Susan", the drunken aunt of Ray Milland and in Alfred Hitchcock's first Technicolor film, "Rope" (1948) with Jimmy Stewart.

Last Week's Celebrity

Last week's celebrity was Tom Poston. After his stint on the "Steve Allen Show", he frequently appeared on Broadway and as a game show panelist including regular appearances on "To Tell the Truth" and "What's My Line?" While his film career was limited to quirky comedies, his TV career was expansive. Mel Brooks wanted him as the lead in "Get Smart", but it went to Don Adams. However, Poston made guest appearances on the show with Adams. He had a recurring guest star appearance on "The Bob Newhart Show" in the 1970s. He later played the role of "Franklin Delano Bickley" on "Mork & Mindy" with Robin Williams. A long time friend of Bob Newhart, Poston played "George Utley", the bumbling country handyman of the Stratford Inn on "Newhart" and again with Newhart in "Cold Turkey" (1971), as the town drunk, "Edgar Stopworth." He was nominated for an Emmy three times for Outstanding Supporting Actor in a comedy series for his appearances on "Newhart" in 1984, '86 and '87. He also had regular roles on "Family Matters", "Murphy Brown", "Home Improvement", "Cosby", "ER", "Grace Under Fire" and as "Kitty Forman's" father, "Burt Sigurdson" on "The '70s Show". After a brief illness, he died of respiratory failure on April 30, 2007, at the age of 85, with his wife and actress, Suzanne Pleshette, at his side.

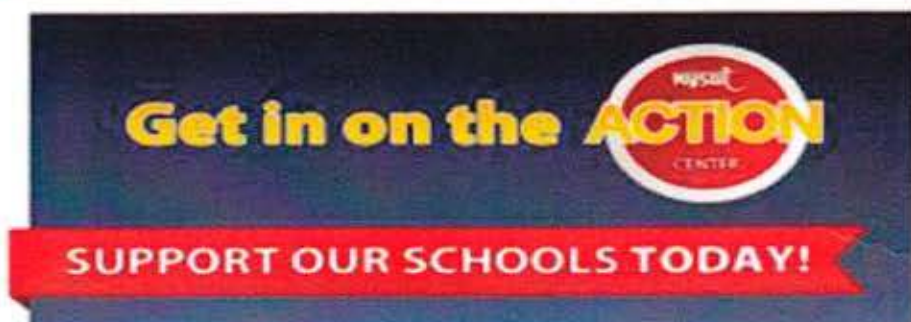

Cliff Way, One Way For Six Months?

To The Editor,

On February 10, the Village of Sea Cliff's Mayor and Board of Trustees entertained the possibility of transitioning Cliff Way and The Boulevard from two-way to one-way traffic beginning April 1 (two months earlier than in previous years) and resuming its two way traffic pattern sometime after September 30. According to the Mayor and several Trustees, they cited public safety and increased popularity of the beach during the spring and summer months as their reasons for the six month one-way traffic flow.

Yes, "... the safety of pedestrians along The Boulevard when it gets congested" is a concern especially when some motorists congregate in creative parking patterns along and within designated parking zones. Furthermore, some of these very drivers then rev up their engines and speed eastward on The Boulevard, speed up Snake Hill Road, turn right onto Prospect Avenue, another right turn onto Cliff Way and proceed down to The Boulevard to complete the "circuit." Additionally, some pedestrians will skateboard, play ball, toss Frisbees, and sit in beach chairs on The Boulevard. These behaviors clearly jeopardize public safety and can be corrected through enforcement of Nassau County and Village of Sea Cliff traffic rules and code regulations, respectfully.

Cliff Way should remain a two-way road to facilitate property access for home owners, delivery drivers, and emergency vehicles resulting in less traffic on the already congested Boulevard. Also, maintaining Cliff Way as a two-way road could reduce the number of skateboarders traversing the road and lessening the possibility of pedestrian and vehicle injuries and accidents.

The behaviors/activities along Cliff Way and The Boulevard during the spring, summer and fall months are nothing new to residents, drivers, Village Administrators, Nassau County Police, nor Code Enforcers. It's time for change, change that will encompass law/code enforcement in order to prevent accidents, injuries, and even death. Let's keep everyone safe.

Now is the time to share your concerns with Mayor Kennedy and the Village Trustees; let your voices be heard.

Enough is Enough, It's Time to Move the Villa Forward

To The Editor,

For years now, a small group of people in our community have made every effort to misrepresent and discredit the condominium application known as the Villa at Glen Cove. This group will go to extreme lengths to achieve their objectives, including disseminating

knowingly false and defamatory information, in local newspapers and on social media, among other means. Some of the most recent issues which require truth and clarification are as follow:

- Ms. Marsha Silverman of Rooney Court alleged that the Villa's zoning attorney was "partnering" with the City's planning board counsel to convince the Nassau County Planning Commission to recommend local determination on the Villa application. Ms. Silverman further alleged that the Villa's attorney attended the internal meeting with the Planning Commission during which the referral issues were discussed. The truth is that the Villa's attorney never attended this meeting and no "partnering" occurred.

- Ms. Silverman suggested that the Planning Commission "abdicated its role" by permitting local determination. The truth is that the Planning Commission unanimously resolved to permit local determination only after considering the changes and mitigations that are proposed by the applicant.

- Ms. Silverman alleged that the developer of the project "gave significant campaign contributions to Reggie Spinello and that this is simply payback". The truth is that the developer supports the elected City leaders; however, no significant campaign contributions were made to Mayor Spinello either prior to or subsequent to his election.

- Ms. Ronnie Epstein, also of the same Rooney Court residence, has repeatedly alleged that the Villa building nearest to her property is 7 to 8 stories high and on grade with the rear of her property. The truth is that all of the buildings are proposed at 3 to 4 stories, well below what is permitted by the City's Code, and below the grade of Rooney Court.

- Ms. Epstein acquired her property in September, 2011, approximately 2 years after the adoption of the City's Master Plan which recommends the redevelopment of this area, and over one year from the establishment of the zoning district which permits it. Ms. Epstein was also told of this development prior to her purchase of the property. As she knowingly chose to proceed with the purchase, her complaining is unjustified. Further, this development will only enhance the value of all properties which surround it, and encourage redevelopment to the rest of the corridor leading to the downtown.

- Every aspect of this project is well within the City's zoning regulations, and now significantly below the height and size permitted.

The leaders of our City are mindful of their civic responsibility to uphold and enforce the City's zoning regulations and not be pressured from people who distort and misrepresent the facts. The Villa project will revitalize an important entryway into our City. It will add significant streetscape improvements to both sides of Glen Cove Ave., Craft Ave. and Ralph Young Ave., including pavers,

new sidewalks, numerous trees, lanterns, as well as landscape and fountain areas. The first and last impression of people entering and exiting our City must be a positive one. In accordance with the Master Plan, this development will create a handsome new gateway leading to the downtown. The applicant also proposes a 22 passenger shuttle service to take Villa residents to our downtown stores and restaurants, local train stations and proposed ferry terminal. Further, all parking will be provided underground. The Villa is smart development that should proceed. It will only assist in revitalizing our City and its downtown, and increase revenue for the City and its businesses. The time has come for our City's leaders to disregard the voices of fear and misinformation, and move Glen Cove forward again to a bright and sustainable future.

Pentalties For Tampering With Code

To The Editor,

The Glen Cove Charter contains the Code of the City of Glen Cove. It is our local Constitution and contains the legislative rules that guide our City government and affects the lives of our citizens, in a myriad of ways, from A to Z, (Alarm Systems to Zoning Laws). It is of the utmost importance that the web site containing our legislation be impenetrable to tampering.

Mayor Spinello intends to establish a Charter Revision Commission, consisting of 9 appointed members, chosen by the Mayor, whose duties will be to recommend changes, additions, deletions and new sections to the current Charter and its Code, while retaining those sections in place that do not need to be repealed. Chapter I of the Charter entitled General Provisions, Section 1-10, contains the following shocking paragraph:

"Penalties for tampering with Code

Any person who, without authorization from the City Clerk, changes or amends, by additions or deletions, any part or portion of the Code of the City of Glen Cove or who alters or tampers with such Code in any manner whatsoever which will cause the legislation for the City of Glen Cove to be misrepresented thereby or who violates any other provision of this local law shall be guilty of an offence and shall upon conviction thereof, be subject to a fine of not more than \$250 or imprisonment for a term of not more than 15 days, or both."

The fact that this section was incorporated into the Code, in the first place, is troubling. Who would believe that such an act would even be possible and raises the unthinkable questions: has it occurred, how often, when and by whom? If tampering is a possibility, how can WE, THE PEOPLE, trust anything that is written in the Code? We should be informed as to which individuals have access to it, and what safeguards are in place to prevent its occurrence. The City must continually use updated technology to enable it identify any individuals involved in violating the Code.

The tampering of the Code is a criminal act and should be called at least a felony. It is a secret and intentional modification of the Code so as to subvert an intended purpose and deserves a penalty that fits the crime. The described penalty is only a slap on the wrist, instead of handcuffs.

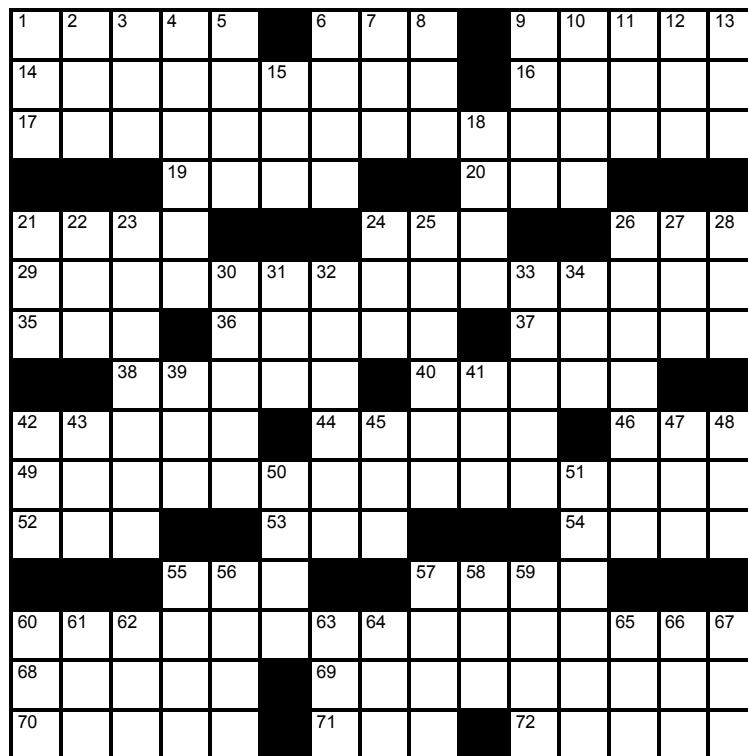
