Glen Cove P.D. Make Marijuana Arrest On Glen Cove Ave.

On Friday March 6th Glen Cove Detective Brian Glennon and Officer Eddy Linares arrested Randell R Lyons (age 23) of Westbury NY, on Glen Cove Ave in Glen Head. According to Det. Lt. John Nagle, The officers arrested defendant Lyons and charged him with Criminal Possession of Marihuana in the second degree, and Criminal possession of a controlled substance 5th degree. The officers recovered over four pounds of marihuana and over 18 grams of concentrated cannabis inside the vehicle the defendant was operating. Officers also recovered over \$7,500 in cash from the vehicle. The Glen Cove officers were assisted at the scene by the Nassau County Police.




Glen Cove ESL students analyze the work of Dr. King

"It's important that students are aware of American history," Chase said. "It wasn't that long ago that things were different and there's still a long way to go."





Senior Moments



This column features a life-altering event that has had a great impact on a senior citizen's life, molding that person into who he or she is today. The people interviewed are all members of the Glen Cove Senior Center.

On a warm summer's evening on the Village Square there is a lean figure gracefully jamming and gyrating to the beat of the Downtown Sounds. Although seemingly entranced by the music, he greets each person walking by. With every greeting, his face lights up with a warm and friendly smile. This is Brian. Brian was born in 1954 in Port of Spain, the capital of the Caribbean country of Trinidad and Tobago which lies just off the Venezuelan coast. His family lived just south of the capital in Saint James. He is the second oldest of four sons. Brian grew to manhood in this tropical paradise and like the local produce his life seemed to be kissed by the sun. He's a happy, kind-hearted soul who loves life and lives every day to the fullest.

At age 22, Brian married a young lady in Trinidad. They left paradise, moving to Glen Cove to be close to her parents and to raise their son Roger. Brian's first employment in Glen Cove was working the night shift at a local newspaper doing paste-ups and mechanicals, a trade he mastered in Trinidad where he also worked as a photographer for the local newspaper. But working the night shift for five years took a toll on his marriage. The young couple soon divorced and his ex-wife and son moved to Miami.

Next Brian got a job as an electroplating technician at Photocircuits on Sea Cliff Avenue in Glen Cove. It was at Photocircuits that Brian noticed a lovely young woman, Mary, who worked in Personnel and Human Resources. He mentioned to his supervisor, Louie, that he was smitten with Mary, unbeknownst to him that Mary was his supervisor's sister. Every day Brian would comment to Louie what a fine woman Mary was and how he'd like to get to know her. Brian soon discovered that Mary and her family lived on the same street, Prospect Avenue, as did he. Both Mary and Brian were going through divorces and both

had a child. After his separation, Brian would often eat at Davila's Restaurant not knowing that the restaurant was owned by Mary's mother. At a Photocircuits Christmas party in Locust Valley, Brian asked Mary for a dance. As Brian says, it was love at first step; it was kismet. That first dance at the Christmas party was the catalyst for a wonderful romance. Brian and Mary met in 1977 and it was merely a matter of time before they would fall in love because their lives kept crossing paths. They married in 1988 and have a son, Sean.

In 1993, desiring a quieter, slower lifestyle, Mary and Brian left Glen Cove for the warmer climes of Florida. There they established a "cleaning" company. Snowbird clients entrusted Brian and Mary with their house keys; they were bonded and insured. They would routinely check clients' houses and property. If there was any damage, for example, after a hurricane, they would contact the home owner, notify the homeowner's insurance company and oversee the repairs and clean-up. It was a successful business that offered the couple a good living. But in 2009, they decided to return to Long Island.

They spend several days a week at the Glen Cove Senior Center where everyone knows and adores them. These lovebirds are always together. If you see Mary, you know that Brian can't be far away.

Next summer when you go to Downtown Sounds on Friday evening, look for Brian near the bandstand gently swaying to the beat of the music. Watch a few minutes and you will see him reach down to his lovely wife to ask her to dance. He will hold her gently and lovingly in his arms as they glide in unison across the dance floor as one.



Improving Quality of Life

Extreme Winter Recovery Operations I am proud to say that the City's Department of Public Works and all of Glen Cove's first responders have done an outstanding job this winter season. It has been one of the toughest winters on record but Glen Cove DPW and all of our police, fire, and EMS crews were up for the challenge. Our Department of Public Works instituted a new organizational strategy aimed at reducing expenses and enhancing services. My office in conjunction with DPW remediated 34 winter related residential issues using a Mayor's issue log which is tracked to ensure accountability. The city implemented a 24-hour live phone operator hotline to help mediate residents' issues during this January's winter super storm. All of the city's staff worked together effectively to ensure residential safety during this long winter season.

Code Enforcement Reconfiguration and Illegal Housing Remediation

My administration has reconfigured the code enforcement department and Deputy Police Chief Chris Ortiz has taken responsibility in overseeing the newly reconfigured department. These changes will allow the department to focus on improving maintenance of department logs, additional training, and increased surveillance. These changes in Code Enforcement only act to strengthen our already robust efforts to curb illegal housing issues in the City. In the first two months of 2015 the City has issued \$28,000 in fines and has approximately 35 pending prosecutions. My administration will not tolerate dangerous and illegal housing in our City.

Making the City Safer For Our Seniors

Senior citizens across Long Island have been the target of scammers and Glen Cove is not immune to this new trend. I have initiated a "Senior Outreach Safety" (S.O.S.) program for our seniors. This program will work to build a relationship between the Police Department and our city's seniors by establishing a Police Department liaison to the Senior Center. The liaison officer will stop by the Senior Center each week to keep them apprised of happenings around town along with responding to their concerns. The initial meeting resulted in nearly 100 seniors signing up for the city's emergency notification service. The safety of our senior citizens is a top priority of my administration.

Preserving Our City's History

As our city continues to grow it is important to preserve Glen Cove's rich history here on the Gold Coast. For the last several years our city's Landmark Preservation Commission was inactive. I have taken a proactive approach and reconstituted the Commission. The Commission is made up of volunteer members who are appointed and voted on by the City Council. With an impressive group of volunteer commissioners I am confident that they will provide guidance in maintaining our history as we move Glen Cove into the twenty first century.

Building Business and Growing Revenues

Panera Bread Opening This Spring

This April is targeted for the grand opening of a Panera Bread eat-in and drive-thru restaurant in our downtown community. This welcomed addition is the first phase of the Piazza Project, which after being dormant for many years is finally moving forward. In addition to creating approximately 25 jobs the new restaurant will add much needed pedestrian foot traffic to our downtown. Clearly, Glen Cove is open for business.

50 Glen Street Development

Our downtown has for too long been blighted with empty storefronts and buildings. I am pleased to announce that 50 Glen St., a previously empty office building, has been renovated. The upper levels of the building are now home to forty state of the art satellite offices, offering small business startups affordable office space with pooled amenities. The ground floor is also being remodeled for rental to several potential upscale retail brands helping to create a vibrant business community including a browse factor for shopping and increased recreational opportunities that entertain locals and attract visitors to Glen Cove.

Coles School Update

The former Coles School property has been one of the city's most underperforming assets. Our recent request for expressions of interest (EOI) has been answered with enthusiasm from a plethora of developers and organizations interested in investing in Glen Cove. The city has received nine proposals of possible uses for the four acre property at 27 Cedar Swamp Road. The various proposals include transit orientated development, a dementia care center, and a high end soccer training and dormitory facility. As per my campaign promise, my administration will continue in their efforts to return underperforming assets back to the tax rolls to assist us in improving our city's overall financial position. Expanding our tax-base is a key component to holding the line on taxes for our residents.

Glen Cove Rifle Team captures bronze at State Tournament

The Glen Cove rifle team placed third in the NYSPHSAA State Tournament on Feb. 28.


The team spent three weeks practicing the new rules and guidelines for shooting at the state tournament, which are different than what is used during regular season matches. The student-athletes practiced mornings before school to get prepared.

Four team members, comprised of three sophomores and one senior, were responsible for the team score. Matt Pemberton shot extremely well and finished fifth overall with a score of 283. Julie Micko finished 15th with a score of 264, and Peter Budraitis finished 16th with a score of 263. In addition, Selena Guastella shot a 252, and Matt Arena shot a 247.

Glen Cove High School has been to the NYSPHSAA State Tournament three times in the past 15 years. This year, the team set a school record with a score of a 1057, and is looking forward to returning to the NYSPHSAA State Championship next year.

Name the Celebrity



This week's celebrity was born on October 30, 1911 in Providence, Rhode Island. Following graduation from high school, she went on to attend Pembroke College graduating in 1936. Trying very hard, she never landed a role in any of the plays she tried out for at Pembroke. She then studied drama in graduate school at the University of Michigan School of Drama, and worked as an actress with a summer stock company in Michigan for two seasons. After working summer stock, she returned to Providence and worked as a radio fashion commentator on a local station. Along the way to land a role in the Providence Playhouse, she worked as a model with the world famous Powers Agency. With the help of a talent agency, she landed a number of stage roles with touring companies. While touring with "Dead End", which eventually became a Humphrey Bogart-Bette Davis film, she

was spotted by an MGM talent scout, Billy Grady. MGM signed her to a players contract and she made her first film in 1937, "Madam X" with Gladys George and Warren William. She would follow that film with: "Man-Proof" (1938) with Myrna Loy, Rosalind Russell and Franchot Tone, "Rich Man, Poor Girl" (1938) with Robert Young and Lew Ayers, "Another Thin Man" (1939) with William Powell and Myrna Loy and "Susan and God" (1940) with Joan Crawford and Fredric March.

Last Week's Celebrity

Last week's celebrity was Constance Collier. In the late 1920's, Collier relocated from England to Hollywood, where she became a voice coach and teacher in diction. This was during the tumultuous changeover from silent films to sound and many silent actors with no theatre training were scrambling for lessons. One of her most famous clients was Coleen Moore, who was one of the most fashionable stars of the era and popularized the bobbed haircut. Other clients that received her expertise were Audrey Hepburn, Vivien Leigh and Marilyn Monroe. In 1932, she starred as "Carlotta Vance' in the original stage version of the original production of George Kaufman and Edna Ferber's comedy "Dinner at Eight". The role was played in the the 1933 film version by Marie Dressler. She appeared in "Stage Door" (1937) with Katharine Hepburn and they became great friends which lasted the rest of Collier's life. Upon Collier's death on April 25, 1977 from natural causes, Katharine Hepburn "inherited" Collier's secretary, Phylllis Wilbourn, who remained with Hepburn as her secretary for 40 years.

Reaching Out to Seniors Everyday ROSE Program Aims to Provide Peace of Mind to Independent Seniors

Do you live by yourself and worry what will happen if you need help but cannot reach someone? Do you have similar concerns about an elderly loved one? The City of Glen Cove Senior Citizen Advisory Council is pleased to announce that the City, in cooperation with the Glen Cove Hospital Auxiliary is beginning a new daily wellness program, Reaching Out to Seniors Everyday (ROSE), designed to allay the fears of the elderly who live by themselves.

Under the ROSE program, a member of the Glen Cove Hospital Auxiliary will reach out daily by phone to make sure that the senior is okay. If the volunteer does not receive a response, he or she will try to contact the emergency numbers that are on file. Failing to get a response, the volunteer will notify the Glen Cove Police who will discharge an officer to check on the senior. The program is designed to give peace of mind and a sense of security to those who enjoy the independence of living alone but realize a medical crisis could render them helpless.

In establishing this new program, the Senior Advisory Council reached out to the Glen Cove Hospital Auxiliary for assistance in managing the dayto-day operation of the program. The response was immediate. According to Pam Panzenbeck, a Glen Cove Hospital Auxiliary member, "The hospital auxiliary is a natural fit for the ROSE program. Our members are always eager

of our everyday lives."

Similar programs have been established in many other communities across the United States including Garden City and Hudson, New York; Wilmington, Delaware and Freemont California.

SAFE, Inc. encourages Seniors to Lock Up Your Meds!

Ashley Ferrufino, the SAFE Glen Cove Coalition Liaison visited seniors at the Glen Cove Senior Center on March 3 to share some information on securing and safeguarding prescription drugs. She offered them national and local statistics related to prescription drug abuse and misuse, discussing steps they could take to reduce use utilizing the "Lock Up Your Meds!" campaign.

The "Lock Up Your Med's" is a national campaign supported by National Family Partnership. The campaign utilizes a multi-media approach to educate communities about what adults can do to stop prescription drug abuse among youth.

In Glen Cove statistics indicate that prescription drug use on the whole is one the downside, however there is still potential for youth to engage in abuse. According to the results of the 2014 Bach-Harrison Prevention Needs Assessment Survey that was given to Glen Cove students grades 6,8,10, &12, lifetime rate of prescription narcotic abuse has increased for the students in the 10th grade. Results also indicated the 10th grade lifetime use rate of prescription narcotics has increased from 2.6% in 2012 to 4.3% in 2014.

"It is important that we educate the community on prescription drug abuse because family and friends have become the unwitting suppliers in this epidemic" Ferrufino said. "With increasing accessibility to prescription medication in the household teens are able to begin experimenting at younger ages". It is important that the community become aware of this growing problem and what actions they can to prevent and reduce use.

During the presentation SAFE Inc., distributed Medication Tracking cards that can be used to keep inventory of all household medications. By tracking medication the individual is quickly alerted if any medication has gone missing. Seniors were encouraged to speak with grandchildren about the risk and dangers of both over-the counter and prescription medication. Ferrufino discussed misconceptions and potential reasons youth may lean towards prescription drug abuse with seniors.

Both the Glen Cove Chemists and Walgreens pharmacies have pledged support of the campaign, agreeing to attach a special sticker to all prescriptions of controlled substances during the month of March that read "Don't forget to Lock Up These Meds!" reminding patrons of the importance of safeguarding medications. Both pharmacies will also have medication tracking cards and prescription medication prevention literature on hand to distribute to patrons during the month of March.

On Gallo's Run To The Editor,

Republican Party leaders most likely view Tony Gallo's primary challenge as unbecoming a "good party soldier." A good party soldier clicks his heels and snaps to attention on cue--not someone who bucks the party's leadership. The one word that does not drip from the party leader's mouth is "dissent." The unctuous machine, which is headquartered in Westbury, succeeded in undermining primary challengers such as Steve Labate and Frank Scaturro in their Congressional races. Should we assume that Gallo will not face the same resistance in a local race?

Here is something to consider about the unseen sludge of machine politics: the person who crosses the establishment threatens its grip on patronage and power. Reggie Spinello's potential loss of Republican Party support could result in a loss of Independence Party endorsements for Republican candidates. The ripples of a political shakeup could touch future countywide races--i.e., if the Independence Party does not get the Republicans to back its guy, it could pull its endorsement of a Republican candidate in another tight race. Spinello's loss would also put uncertainty on who receives lucrative government contracts from the city or which party hack gains city employment.

The reader should not assume that this is an endorsement of Gallo for mayor. As his campaign matures, he should be able to articulate a complete platform that includes his positions on issues from economic development to the city's charter reform--this has not happened yet.

Gallo should be prepared to defend his record. The voters should ask if his administration would include Bloomberg-esque, nanny-state policies of which the government knows best. For example, did Gallo vote to ban hookah bars, which is a lawful business, for the same reason former N.Y.C. Mayor Mike Bloomberg declared his war on large soft drinks? Voters should also know why Gallo voted for city budgets in nonelection years (when few pay attention) whereas he voted against it when in the spotlight of an election year. Was this a mere coincidence or does he only showboat as a fiscal conservative when he needs to rally the Republican base for an election?

Despite the concerns about Gallo, his decision to challenge the machine's anointed candidate is laudable. His campaign may encourage other Republicans to challenge the rest of Spinello'sbootlickers suchas Councilman Joe Capobianco and Councilwoman Pam Panzenbeck. Republicans will see democracy in action as they choose their candidate on Primary Day. Although a primary is anathema to the Republican machine's rusty cogs, it is good for the political process.

Letty, Marcia, Norman, and Edwin tell their stories over four seasons, and gradually we come to realize that their apparently gray, lonely, conscribed lives are much richer, much more complex that we could ever have imagined. Set in the 1970's this beautifully written novel has little plot- its merit lies in its unflagging attention to detail- the extraordinary details of the lives of ordinary people. Highly recommended any time of the vear!




