

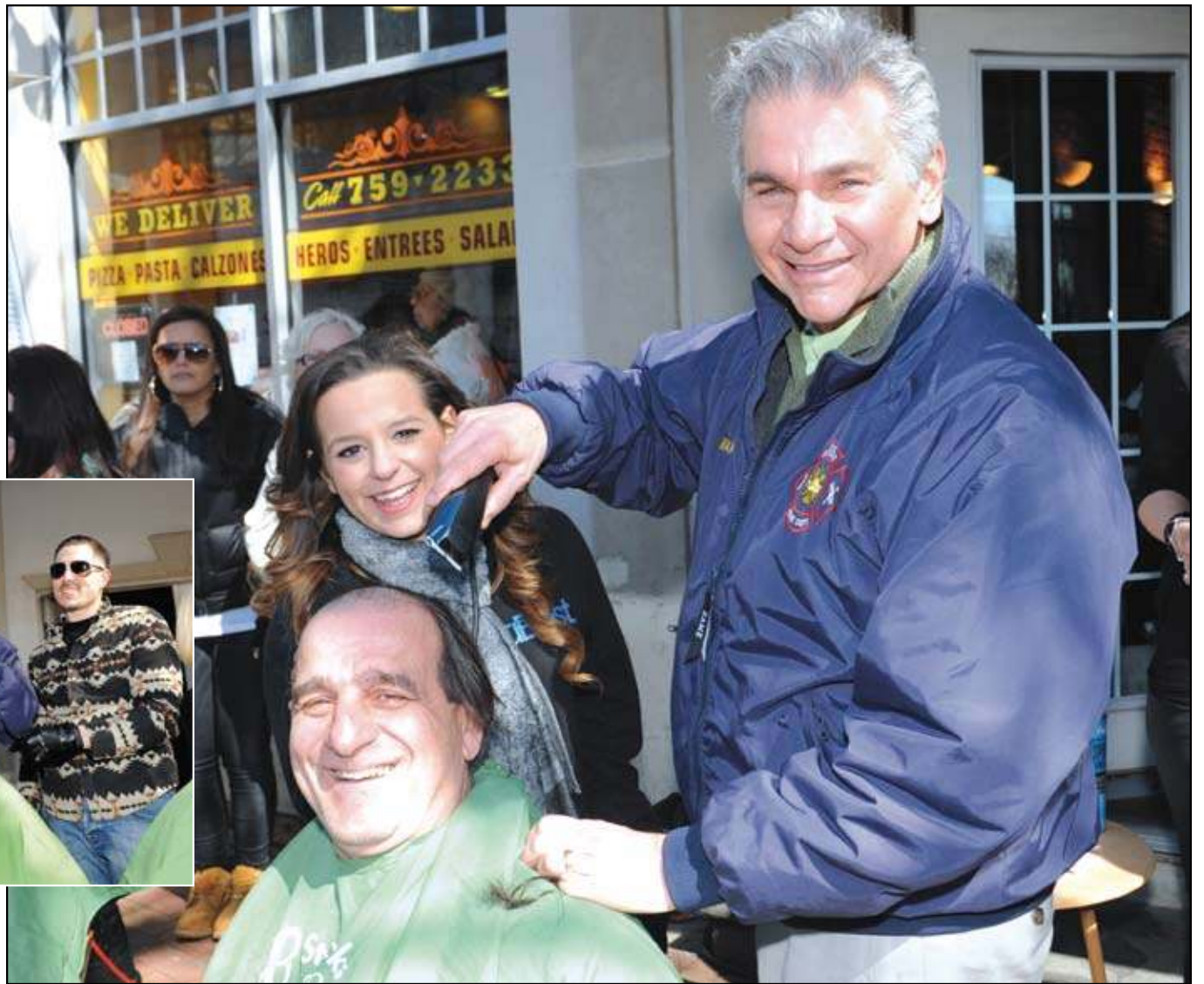

## Scheme To Defraud Arrest

On 03-18-2015 Glen Cove Officers Lt John Nagle, Detective Karl Van Allen and officer Eddy Linares arrested Norma Espinoza (age 37) at her home in Glen Cove and charged her with three counts of Grand larceny 3rd degree, two counts of Grand larceny 2nd degree and Scheme to Defraud in the first degree. In 2012 Espinoza allegedly started a game known in the Spanish community as a "Cuchubal". To participate in this game the players were asked to make a regular \$200.00 cash contribution to a common fund which Espinoza would oversee. Each player would make their weekly payment to Espinoza and after a year they would be entitled \$10,400. According

to Lieutenant Nagle, "after their year of contributing was up, the defendant Espinoza, made excuses for not paying the players their money. This caused some of the players to report the game to the Glen Cove Police." Glen Cove Detective Karl Van Allen and officer Eddy Linares began their investigation into the game back in November. As the investigation intensified the Nassau District Attorney's Office assisted Glen Cove in the investigation culminating with the arrest of the defendant. Espinoza's next court date is Friday march 20th. If convicted of the top charge, Espinoza faces up to 7 years in prison.

## Gold Coast Little League To Kick Off Inaugural Season With April 18 Parade

Join the 340+ young baseball and softball players as they celebrate the start of the 2015 season with an Opening Day Parade from Finley Middle School through downtown Glen Cove and ending at John Maccarone Memorial (City) Stadium on Saturday, April 18. The parade will kick-off at 10 AM.

Gold Coast Little League is a baseball and softball program for boys and girls in Glen Cove and surrounding communities currently in Kindergarten through Grade 9, operating under the direction of the City of Glen Cove Parks & Recreation Dept.

A Coaches Clinic was held on Sunday, March 15 at Glen Cove High School, with coaches developing formats for their team practices and participating hands-on with a variety of drills. The clinic included specifics on how to instruct players in batting and fielding, as well as pitching mechanics for both baseball and softball.

Thanks to the generosity of Cove Sports Academy in Glen Cove, each team will have a complimentary indoor practice session as the practice fields continue to thaw. Players will also be given the opportunity to participate in clinic packages offered at Cove

Once the season kicks off, in addition to "home" games at the stadium all girls

divisions and several boys teams will be participating in a cooperative league that includes teams from Bayville, Locust Valley, Grenville Baker Boys & Girls Club, Oyster Bay and new for 2015, teams from Sea Cliff as well.

All players in grades 3 & up are guaranteed a 12-game season plus playoffs. The format for younger players is instructional clinics mixed with modified game play. There is also an Instructional Teeball Program for pre-school aged children, which begins on April 25.

Registration fees include a uniform (shirt, hat, pants & socks) and team photo for each player. Financial assistance is available to any Glen Cove family in need with application through the Financial Assistance and Scholarship program, which was established by the Glen Cove Recreation Commission in 2014. The program is additionally supported by over 30 local businesses, organizations and professionals who have sponsored the program.

Anthony LaMarca will be the featured artist at the Golden Gallery in the Glen Cove Senior Center during April. Tony is a naturally talented artist who didn't start painting until his retirement a decade and a half ago.

Tony fell into painting accidentally when he decided to take classes at the Westbury Senior Center to occupy his time and stimulate his mind. He signed up for several painting classes and discovered that he not only enjoyed painting but also had a natural flair for expressing himself on canvas and paper. He started painting with acrylic paints under the mentorship of Shain Baird. Later he would enroll in acrylic and watercolor painting classes with Nettie Burke at the Herrick Senior Center.

Among his other watercolor instructors were Selma Stern and Mary Jo Anzel. He also studied oil painting with Joe Occhipinti, Bart DeCeglie, Debra Mnuik and Howard Rose. He quickly excelled and refined his techniques to produce quality paintings.

Tony focuses mainly on landscapes but has been known to paint an occasional portrait. Many of his landscapes are a documentation of the many trips he has taken and the wonderful vistas he has seen. Sometimes he will paint a vacation spot in acrylics and then reinterpret

responsibilities. His days seem to pass by ever too quickly when he is completely absorbed in his work.

Professionally Tony has been the past President of the Suburban Art League for the past six years and is now the 2nd Vice President and Program Chairman.

**Serena**

Stars: Bradley Cooper, Jennifer Lawrence, Toby Jones

The task of realizing this cinematic adaptation of Ron Rash's novel of the same name, focusing on the crumbling partnership between a timber baron and his wife in Depression-era North Carolina, was an arduous one. The screenplay had drifted around for years, with Darren Aronofsky set to direct and Angelina Jolie in the titular role at one point. Directorial duties eventually went to Danish filmmaker Susanne Bier, who holds an Oscar for "In a Better World" (2010). Once Jennifer Lawrence was slated to star, she sent a copy of the script to her "Silver Linings Playbook" (2012) costar Bradley Cooper. "Serena" would become the third film in which the pair would appear. Issues arose as these high in demand actors could barely manage to add post-production work to their packed filming schedules and multiple cuts of the movie were made, but 2015 would be the year US audiences could finally view the film. So how did a movie based on a popular novel, led by an Academy Award winning director, starring two of the most admired celebrities of today, go largely unheard of by the public?

Quality seems to be a key factor in the film's low-profile. The plot is simple enough. George Pemberton (Cooper) is in the business of clearing forests for lumber, with hopes of expanding to Brazil. While attending a horse show one of the riders, Serena (Lawrence), catches his eye. George's sister tells him she is a damaged woman, haunted by the death of her family when she was a child. They meet, fall in love, and marry. For some unfathomable reason, this evolution of their growing relationship takes only minutes of screen time. The nuances and sincerity of their bond are sacrificed in this rushed presentation, proving to be one of the film's gravest flaws.

Serena and George move to the beautiful mountains of North Carolina and become business partners. She is adamant in proving her worth in a male dominated industry. Serena gradually gains respect, although is continuously leered at by another young woman named Rachel (Ana Ularu) with whom George has a romantic history. All

seems well until some shady dealings with one of George's confidants lead to bloodshed. This calls the attention of Sheriff McDowell (Toby Jones) who was already weary of George's plans for the mountain. A string of tragedies follows, straining Serena and George's marriage to the point of emotional break.

Bribery, romantic scandals, murder, and psychological meltdowns all would have made for a gripping watch. Apparently Bier and screenwriter Christopher Kyle did not think so. Shocking revelations are pushed to the side in favor of tedious conversations and interactions. Sexual scenes are used as filler. George's character is preoccupied with finding and hunting a panther, which serves no purpose to the plot. The script is so poorly written that the melodramatic dialogue is often laughable.

The most egregious mistake however, is how underdeveloped Serena's character is. Since the start of her relationship with George was hastily glossed over, we have no idea who she is and what her motivations are. Her sorrowful backstory is explained in an underwhelming monologue. There is no foundation on which to build her character. This becomes most problematic in the film's second half, after Serena endures a great deal of trauma. The more unhinged she becomes, the less believable her actions are. Serena's arc is reduced to a nonsensical, dissatisfying ambiguity, which is the last thing you want your titular protagonist to be. The whole affair comes across as a first draft, though a promising one.

It is for these reasons that Jennifer Lawrence does not shine in this role. She has already established herself as one of the most talented modern actresses, and should not be to blame for lackluster filmmaking. Bradley Cooper emerges as the standout, fitting the period perfectly and finding humility in the troubled businessman who only wants to succeed in all areas of his life. Toby Jones, disappointingly underused here, still creates an interesting presence. In this quiet, understated movie, the actors did the best with what they were given.

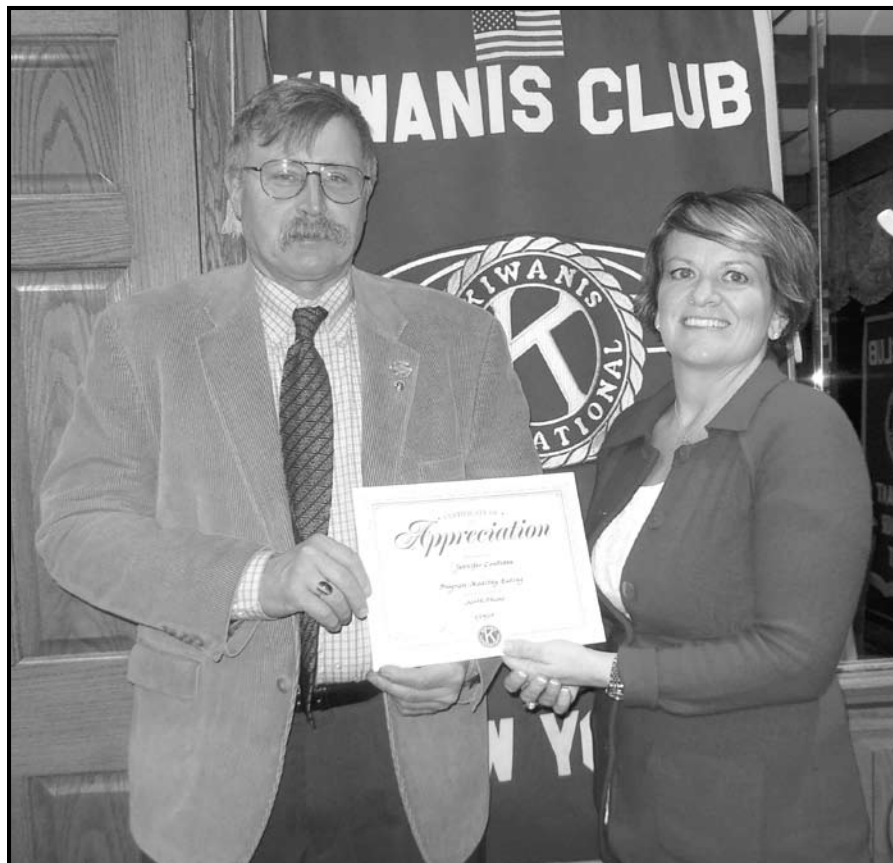
Indeed, it can be suspected that everyone behind the camera was banking on the star power of those in front of it. There are many compelling themes in this story, with highly capable actors willing to see it through. How unfortunate that no one else wanted to explore them.

the 1940 film "Lillian Russell." He also played a similar role in "The Toast of New York" (1937), another fictionalized version of real-life chicanery for which he was billed above Cary Grant in the posters with his name in much larger letters.

### Last Week's Celebrity

Last week's celebrity was Robert Donat. In 1936, he took on the management of the Queen's Theatre in Slaughterhouse Lane where he produced "Red Night" by J.L. Hodson. He made two more films under his contract with Alexander Korda, "The Ghost Goes West" (1935) and "Knight Without Armour" (1937). His co-star in the latter film was Marlene Dietrich, who took over the part when Madeline Carroll became unavailable. Her arrival in Britain to do the film caused quite a stir and caught much attention in which Donat was included. This was enough for him to suffer a nervous collapse a few days into the shooting schedule. He entered a nursing home to recuperate. The production delay caused by Donat's asthma, which some say was psycho-somatic, led to talk of replacing him. Dietrich, contracted by Korda for \$450,000, threatened to leave the project if this happened and production was halted for two months. By then Donat was able to return to work.

In 1938, he signed a contract with MGM British with a commitment to making six films. "The Citadel" (1938) which was about a newly-credentialed Scottish doctor, won him his first Best Actor Oscar nomination. However, it was his role in "Good-bye, Mr. Chips"

(1939) which won him his first Best Actor Oscar. His rivals that year was Clark Gable for "GWTW", Laurence Olivier for "Wuthering Heights", James Stewart for "Mr. Smith Goes to Washington" and Mickey Rooney for "Babes in Arms". 1939 was considered film makers' greatest year in history.

Donat suffered from chronic asthma which affected his career and limited him to appearing in only twenty films. His final role was the mandarin "Yang Cheng" in "The Inn of the Sixth Happiness" (1958) with Ingrid Bergman. His last spoken words in this film

were prophetic: "We shall not see each other again, I think. Farewell." He died June 9, 1958, at the age of 53 in London. His biographer, Kenneth Barrows, wrote on the cause of his death, "Perhaps the asthma weakened him, but in fact, it was discovered he had a brain tumor the size of a duck's egg and cerebral thrombosis was certified as the cause of death."

### Correct Callers

Born in the Lower East Side of New York City on Feb. 18, 1890, this week's celebrity was known before making it "big" as Gunther Schneider, with his professional name as his real middle name. He was interested in acting since his youth, making his first stage appearance at the age of 12 as "Lorenzo" in "The Merchant of Venice." He found work as an extra for Essanay Studios and World Studios, before landing his first significant role in 1916's "The Mislending Lady." He made his "talkie" debut in "Okay, America!" (1932). He recreated one of his stage roles in one of his early films "Whistling in the Dark" (1933) with Una Merkel. This film was later remade in 1941 starring Red Skelton. Our celebrity's role in the 1935 film "Diamond Jim", with Jean Arthur, Binnie Barnes and Cesar Romero, boosted him to stardom. He reprised his role in

## North Shore Middle School Need for Speed Project

North Shore Schools, Glen Head, NY - Seventh graders at North Shore Middle School were recently challenged to put their knowledge of motion and forces into action. "The Need for Speed Project", an interdisciplinary assignment that involved science, marketing, design and math skills, asked students to design a car out of inexpensive household items that could be raced at top speeds against their classmates! The low cost household items included a plastic water bottle, bottle caps, a straw, and a balloon!

As the students began to build their cars, they thought about the scientific concepts that they learned in class including action and reaction forces, thrust and friction, and air resistance. They also answered questions such as, "How do the mass and the net force acting on matter affect its motion?" But that's not all! Students in Christina Bianco and Lauren Mistretta's classes were asked to form groups and take on different managerial positions to successfully execute "The Need for Speed" task. The positions included:

- Chair of Finances (the student who keeps tracks of the money, how much the group spends on materials to create the car and calculates the profit in the end)
- Chair of Engineering (the student

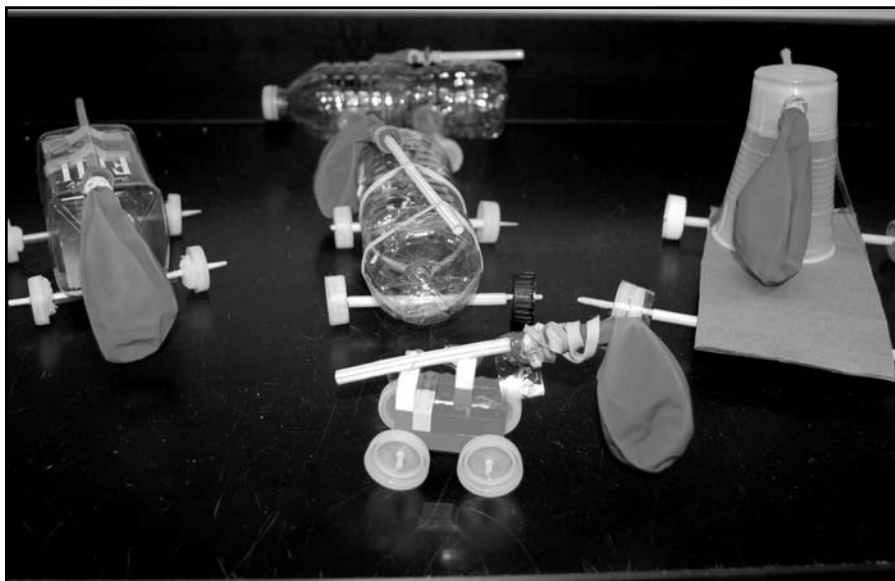
who draws a body diagram of the car, executes the construction of the car, and calculates its speed)

- Chair of Marketing (the student who designs materials to the car to make it more attractive for investors and creates a mini billboard to convince investors to add more money into their product)

Additionally, each student had to learn all of the tasks and collaborate with one another. Each group would race their car (the final product) against their peer groups to victory. Some innovative names of the cars were "Blue Mercury" and "Icy Storm Cat."

Some of the winners said, "This was a really fun project. We learned what materials would successfully affect the speed, motion, and distance of a car." Congratulations to all of the students for participating in this educational and exciting project.

LOCAL LAW 02-2015 of the City of Glen Cove establishing a City of Glen Cove Charter Revision Commission.

BE IT ENACTED by the Glen Cove City Council as follows:

### Establishment

There shall be established by the City Council of the City of Glen Cove a Charter Revision Commission pursuant to the provisions, and amendments if any, of the Municipal Home Rule Law §36(4) or (5).

### 2. Membership

The Charter Revision Commission of the City of Glen Cove, appointed pursuant to this Local Law, shall consist of no less than nine (9) members who shall be appointed by the Mayor with approval of the City Council. Members to be appointed by the City Council shall be pursuant to a resolution duly adopted by a majority of the City Council at a regular or special meeting of the City Council herein. All appointees shall be residents of the City of Glen Cove and shall be evidenced by a certificate, in writing, signed by the Mayor and filed forthwith in the office of the City Clerk. All certificates shall be attested to by the City Clerk.

### 3. Vacancies

Failure to attend three meetings of the Charter Revision Commission without reasonable excuse acceptable to the appointing authority shall be deemed a resignation from membership of the Commission. Any vacancies in the membership of the Charter Revision Commission for any reason including but not limited to, resignation, expiration of term, death or inability to serve, shall be filled by the appointing power in the same manner set forth in Section 2, above.

### 4. Officers of the Commission

The officers of the Charter Revision Commission shall consist of a Chairman, Vice Chairman and a Secretary. Said officers shall be elected by the members of the Commission from among their members at their first organizational meeting after appointment.

### 5. Duties

It shall be the duty of the Charter Revision Commission of the City of Glen Cove to recommend changes to the current charter including additions and deletions to the current Charter along with recommendations for new charter items for the City of Glen Cove containing such sections of the existing Charter as may be

deemed presently adequate and to add such new titles, articles, chapters, sections and subsections as may be deemed necessary to produce a workable Charter for the City of Glen Cove.

### 6. Compensation

The members of the Charter Revision Commission shall receive no compensation for their services, but shall be reimbursed for necessary expenses incurred by them in the performance of their duties.

### 7. Service of Public Employees

No person shall be disqualified to serve as a member or consultant of the Charter Revision Commission of the City of Glen Cove by reason of holding any other public office or employment, nor shall they forfeit any such office or employment by reason of his appointment to the Charter Revision Commission notwithstanding the provisions of any general, special or Local Law, ordinance or the Glen Cove City Charter.

### 8. Public and Private Hearings

The Charter Revision Commission may conduct such public or private hearings as it may deem necessary for the performance of its duties. Such public or private hearings shall be scheduled at such times within the City Hall of Glen Cove as the Commission may deem necessary. The Commission shall also have the power to take testimony and to require production of books, papers and public records if it deems this procedure necessary for the completion of its duties.

### 9. Technical Assistance

The Charter Revision Commission of the City of Glen Cove may appoint and remove, with the approval of the City Council, such consultants as it may require to provide technical assistance in the revision of the Charter of the City of Glen Cove. Compensation for such consultants, advisory services and technical assistants shall be appropriated as needed with the approval of the City Council of the City of Glen Cove, said funds to be made a charge against a City budget.

### 10. Submission of the Proposed Charter to the Common Council

The Charter Revision Commission herein created shall submit its recommendations to the City Council of the City of Glen Cove by filing said report with the City Clerk of the City of Glen Cove.

### 11. Terms of Office

The terms of office of the members of the Commission shall expire on the last day of each fiscal year of the appointment.

### 12. Local Law: This Local Law shall take effect immediately upon its filing in the Office of the Secretary of State.

## Everyone loves the Glen Cove Y..... the Y that was. To The Editor,

"The 13" who were "fired" from their volunteer Board positions might even love the Glen Cove Y more than you do. We are trying to preserve the Glen Cove Y that we helped build. The Long Island Y, however, is trying to change your and our Glen Cove Y. They are attempting to do this by instilling panic that we may lose the Glen Cove Y! But you aren't being told the facts.

The Long Island Y is taking the Glen Cove out of the Glen Cove Y. Not only have they disbanded the Board with over 100 years of volunteer experience, they are systematically culling out Glen Cove employees and administrators. They are taking the profits from the debt-free Glen Cove Y and spreading it around to the other Long Island Y's. They have refused the advice of Glen Cove Board members.

We asked if they had a renewed lease yet, and we even offered to facilitate negotiations. However, we were told by the Y-LI that we were to have NOTHING to do with the lease negotiations which were to only be between Y-LI and the landlord (The Neighborhood Association.)

But this fall, Y-LI began to worry - they still had no contract and the lease is set to expire in December 2015. They called an "emergency" Board meeting on approximately five hours notice, which is inappropriate. The purpose

was to approve a letter to be sent out to the membership the next day. We were vehemently against it - I, for one, stated that it would not be in the facility's best interest because it would instill panic in families who might prematurely avoid registering for camp and preschool.

Y-LI also said they wanted to start a postcard campaign directly targeting the landlord - the Neighborhood Association. I also advised against this, since embarrassing and annoying the landlord seemed counterproductive to the goal.

At the end of the (expected) poorly-attended meeting, Y-LI agreed to not put out this letter and post-card campaign. Quite unexpectedly, a few months later, a re-vamped letter was sent out without our knowledge. We were further surprised that now there was an online petition, also!

I have a big problem with online petitions as there is no defined community from which signatures are pooled. So don't be fooled when Y-LI or their "spokespersons" (FYI at City Council meetings, the President/CEO sends her friend to repeatedly badger the Mayor and Council, and sends staff who, as I suspect, probably fear losing their jobs if they don't do as they're asked) claim they have a certain number of signatures - these "signatures" can be from uninvolved parties who don't know the facts, who aren't from our area or who don't even belong to our Y.

Y-LI started this when they decided to use panic tactics in our community, against the advice of their well-versed and committed administrators and advisory board who have slowly been culled away from the Glen Cove Y.

The 13 volunteer Glen Cove Board members wouldn't sign their petition; they were fired by the Y-LI. No less than 5 high-positioned, long-term Glen Cove Y staffers were either forced out or moved to other LI branches. The Y-LI is taking money out of the Glen Cove Y. This must be stopped.

## SAFE and Glen Cove Police Department Conduct Prevention Education

SAFE Inc., and the Glen Cove Police Department partner to provide alcohol and substance abuse prevention, intervention and education to Glen Cove students. Sgt. Ryan Nardone delivered a powerful pre-prom presentation to juniors at Glen Cove High School on Feb. 27.

The School Committee of the SAFE Glen Cove Coalition Chaired by Denise Kiernan, Director of Health and Physical Education, invited Sgt. Nardone to speak to students about the ramifications of alcohol and substance abuse. The goal of his presentation is to keep kids safe on prom night. These annual pre-prom presentations aim to help teens make better choices about alcohol and drugs. The implementation of this prevention education lecture was a result of the 2014 Bach Harrison Prevention Needs Assessment Survey (PNA) which indicated that underage drinking is an area of concern among Glen Cove youth. According to the results, The 12th graders reported riding in a car with a drinking driver at a rate of 25.2%, a 4.7% increase from the 2012 PNA. Of surveyed 12th graders, 11.4% (a 7.8% increase from 2012) indicated driving after drinking

in the past month. According to Ashley Ferruffino, Coalition Liaison, "Juniors are just as susceptible as Seniors. Hopefully they will remember Sgt. Nardone's presentation when making decisions that could potentially be life threatening".

The Parent Committee of the SAFE Glen Cove Coalition, Chaired by Mrs. Laurent Caballero, works in conjunction with Ms. Kiernan to highlight Student Lifeline, an organization working to reduce the risks of underage drinking and driving. After the presentation, free SAFE Ride cards were given to students enabling them call for a safe ride instead of getting in a vehicle with a peer who is under the influence. Glen Cove High School's faculty and administrative staff were on hand during the presentation to support the message against underage drinking and substance abuse.

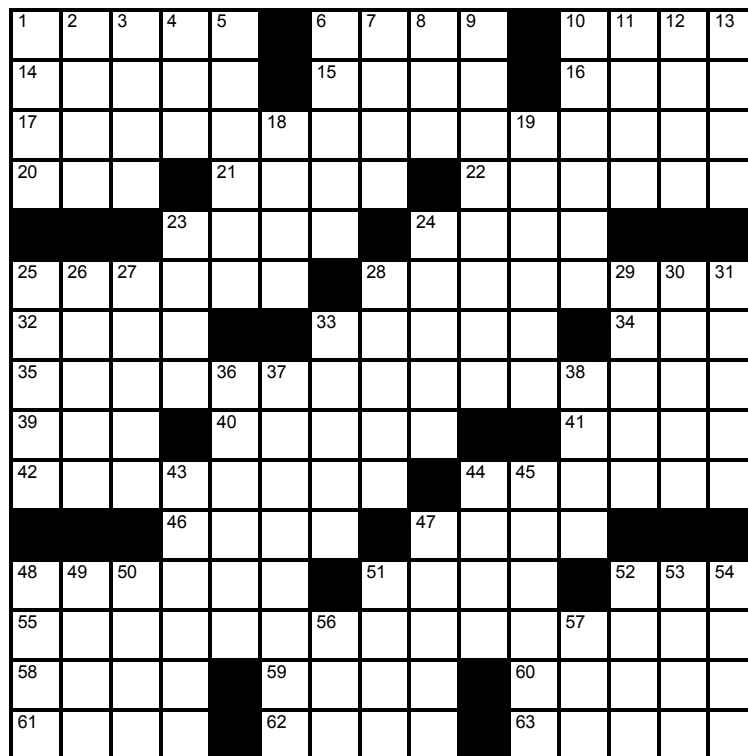
