



Tragic Murder On Glen Street

According to Glen Cove Police, in broad daylight, on March 26, at approximately 3:20pm, 32-year-old Yanira Estella Canjura Martinez was stabbed multiple times in the parking lot behind 221 Glen Street. The single mother had been in the area to pick up her five-year-old daughter (who did not witness the incident) from her babysitter at the time of the attack.

The victim was transported to Glen Cove Hospital but succumbed to her injuries. The defendant is described as a male Hispanic who fled the scene east on Pearsall Ave. towards Town Path after the attack, according to police. Glen Cove Police Dept. detectives, as well, as Nassau County P.D. detectives are currently investigating the crime. According to Glen Cove Detective Lt. John Nagle the incident was caught on a surveillance camera in the vicinity of the crime. "We believe the victim knew her attacker and we believe it was domestic in nature."

Chief William Whitton said that at no time, after the commission of this heinous crime, was the public at large in any danger. "Our investigation rapidly revealed details that this was a domestic related situation and, in the interest of making every effort to apprehend the suspect, we felt the need to not release information publicly. However, I want to stress that had there been indicators of danger to the general public, we would have made that information available immediately."

"I have the utmost confidence in Police Chief Whitton and his Police Department's ability to ensure the safety of our community," said Glen Cove

Mayor Reginald Spinello. "GCPD's seamless coordination with Nassau County Police and other related agencies will ensure that justice is brought on behalf of the victim. My thoughts and prayers are with the family as our community continues to mourn this tragic loss."

company and shortly afterwards, enlisted in the U.S. Navy during WWI. After the war, he returned to the stage and became a vaudeville headliner, then gained success on the N.Y. stage. He was spotted by Samuel Goldwyn and was given a film contract, his first film being "Beloved Enemy", as an Irish patriot, with Merle Oberon, Brian Aherne and David Niven. He was one of Hollywood's instantly recognizable character actors. His trademark pencil-thin moustache, slicked black hair, immaculate suits and sophisticated manners were his stock-in-trade for impersonating an assortment of rejected husbands, shifty politicians, lawyers and shady detectives. Among his films were "Deadline at Dawn" (1946) with Susan Hayward and Paul Lukas, "June Bride" (1948) with Bette Davis and Robert Montgomery and in "Mr. Skeffington" (1944), playing Bette Davis' ex-paramour. He was the short-lived partner, "Miles Archer" to Humphrey Bogart's "Sam Spade" in the "Maltese Falcon" (1941). He also played "Dagwood Bumstead's" boss, "Mr. George Radcliff" in several installments of Columbia Pictures 1957 version of "Blondie", based on the comic strip.

This week's celebrity was an American stage, film and TV actor born in New York City on Oct. 6, 1897. At eighteen, he joined a traveling stock

 Last week's celebrity was Edward Arnold. He appeared in over 150 movies. Although he was labeled "box office poison" in 1938 by an exhibitor (he shared this dubious distinction with Joan Crawford, Greta Garbo, Marlene Dietrich, Mae West, Fred Astaire and Katharine Hepburn), he never lacked for work. Rather than continue in leading man roles, he gave up trying to lose weight and went after character actor parts instead. He was such a sort-after actor, he often worked on two pictures at the same time. Other films were "You Can't Take It With You" (1938) with Jimmy Stewart and Jean Arthur, "Come and Get It" (1936) with Joel McCrea and Frances Farmer, "Meet John Doe" (1941) with Gary Cooper and Barbara Stanwyck and as New Hampshire Congressman and orator Daniel Webster to Walter Huston's "Mr. Scratch" in "The Devil and Daniel Webster" (1941). He was President of the Screen Actors' Guild from 1940-42. At age 66, he passed away on April 26, 1956, due to a stroke associated with atrial fibrillation.

Speaking Out for Tobacco-Free

To The Editor,

Local youth from Glen Cove High School are speaking out and standing up to the Tobacco Industry in an effort to end tobacco use once and for all. Our efforts are part of National "Kick Butts" Day. The Campaign for Tobacco-Free Kids sponsors "Kick Butts Day" each year as part of this national day of youth activism nationally, and around the world. Today, we are adding our voices to those other youth from around the country to voice our concerns about tobacco marketing and the impact it has on our Glen Cove and surrounding Community.

Tobacco use is still a major problem in New York State and we want to be the generation that ends it. We know that tobacco marketing at retail locations is a primary cause of youth smoking and we're asking for help from our community leaders to join with us and declare, "Enough is Enough".

"According to the 2014 Surgeon General's Report, if current smoking rates continue, 5.6 million Americans younger than 18 who are alive today are projected to die prematurely from smoking-related disease. In New York State, 108,500 high school students smoke cigarettes and each year more than 13,500 kids under 18 become new daily smokers," per Carol Meschkow, Nassau County Community Engagement Coordinator for the Tobacco Action Coalition of LI.

According to Dr. Sharon Harris, Executive Director of Glen Cove SAFE Coalition, "a study released recently by the American Cancer Society has found that smoking's toll on health is even worse than previously thought. The study found five additional diseases attributable to smoking and estimated that an additional 60,000 people die every year in the U.S. due to tobacco use, bringing the total annual death toll to 540,000". Local needs assessment data that surveyed students use obtained in 2014 indicated that Lifetime cigarette use continues to rise into the 10th grade (18.8%) and 12th grade (39.3%).

"Smoking kills and we've got to protect impressionable kids from these dangers, and that's why the Physical

Education and Athletic Department for the Glen Cove School District is particularly concerned and encourages our impressionable youth to take a stand and speak out for themselves. It is encouraging when students advocate for causes that they believe in such as challenging local pharmacies to reconsider the display of deceptive tobacco marketing promotions", said Anthony Gallo, GCHS Health Teacher.

In New York State, 82% of retailers including pharmacies, convenience stores and gas stations occupy at least half of the space behind the checkout counter to openly display tobacco products for all of our purview. We've seen enough tobacco marketing, and we are banding together with the same message that we want to be the first generation to be tobacco free.

Dear Parents and Guardians of Students in Public Schools:

Over the past few years, parents of our students have become increasingly aware of the high stakes consequences associated with the ELA and Mathematics tests for 3rd through 8th grade children. Last year, a number of Glen Cove parents opted to "refuse" the 3-8 tests for their children.

While it would be inappropriate for an individual teacher to advise a parent on "opting-out" of the State tests, we hope that you can use this information letter to help you form your own decision regarding your child's educational experience. Please refer to the links on the bottom of this letter for more information about your right to "refuse" the test.

The Glen Cove Teachers' Association, as well as its State affiliate NYSUT, fully supports parents' right to choose what is best for their children and a parent's right to "refuse" the State standardized tests if the parent believes State testing is inappropriate and/or may be harmful to his or her child. Additionally, students should not be subjected to any type of "sit and stare" policy that requires them to sit in a test room for up to 10 hours over the course of the testing period. We think that this practice is abusive and we oppose it. Thankfully, we have been told, the Glen Cove School District does not adhere to this "sit and stare" policy.

The New York State Education Department's overreliance on State tests creates unfortunate consequences for our students, teachers, and schools, not the least of which is the amount of valuable instructional time spent on test preparation. Please know that we value your children as more than a test score.

I am available to discuss concerns with any individual parent or community group.

ALL's Defense

To The Editor,

As a volunteer for many years with the Animal Lovers, I feel I must answer Cove Animal Rescue board member Barbara Hall's false allegations. ALL's contract with City Hall specified that if either party did not renew the contract that the City had the right to purchase any equipment from ALL that they wanted. An inventory was provided and the city decided they would purchase nothing. In a letter from Stefan Geiringer to A.L.L., he stated "Please discard everything else, both indoor and outdoor including all indoor and outdoor wire cages currently unused by Shelter animals and everything within the Quonset hut and plant room not specifically mentioned in the preceding paragraph." Of the items worth many thousands of dollars requested in his "preceding paragraph", only the shelves were not left to CAR, everything else was free. ALL complied with his demand, not

by discarding useful equipment, but by donating it to many rescue groups. Those who gratefully received the donations included Volunteers for Wildlife, Last Hope, STAR Foundation, A Home At Last, Trading Post at Elder Care, etc. As anyone knows who has moved knows, stored things are found broken and/or useless; that's what ended up in the dumpster. Anything, like carriers missing parts, that might possibly be repaired was left on the top if someone wanted it. The dishwasher was working the day we left, as were the washer, dryer and two refrigerators that were donated.

Every single animal in the shelter was examined by shelter veterinarians before we moved and explicit written instructions and medication left for the few pets on treatments. ALL's Shelter Director, a licensed Vet Tech, also went over the instructions and care with CAR's director. All animals were left with medical records containing current testing, deworming and inoculation dates, as well as their photographs in the folder and/or on cages. There is room for much data on a single medical page. The reason there were not multiple pages on every animal is that with ALL's good care the animals enjoyed a very high rate of good health, no matter how long they resided.

The personal information on the adoption records was blocked-out by legal agreement with the City as the Animal Lovers League respects the privacy of its donors and adopters. All adopters were given a folder with all the medical and tracking data necessary.

The only part of Ms. Halls letter I can agree with is "it's time for both sides to move forward". The funds that rightly belong to the Animal Lovers League continue to be used totally for the welfare of animals. Their existing outreach programs continue and negotiations for new ones are ongoing. Letters such as the one Ms. Hall wrote can be very damaging to her organization.

 With the Passover and Easter holidays this weekend, I will be seeing friends and family and, as always, someone will ask "What have you read lately?" I would love to have a title to offer so my question is: do you have something short and compelling that I could read over the next few days?
 Looking for Something Short and But Definitely Not Sweet

Dear Looking.....
 I have just the book for you: ALL THE OLD KNIVES by Olen Steinhauer- a wonderful foray into the morally ambiguous world of the CIA. Told from the perspectives of two agents- Henry and Celia- who had been stationed in Vienna six years before, this psychological thriller takes place almost entirely over one evening in an upscale Carmel restaurant. This novel is in many ways reminiscent of Herman Kohl's "The Dinner" with its elaborate

descriptions of food and wine and the gradual unraveling of the diners' psyches. In alternating chapters, the two former lovers recount the events leading up to a tragically botched rescue attempt at a Viennese airport in which 120 passengers were killed. New intelligence points to a CIA mole who- in all likelihood is either Celia or Henry. The outcome of their dinner tonight will be swift, annihilating justice. While tension builds throughout and there are clues aplenty, the ending is nevertheless shocking, and we are left with a disturbing moral quandary. Highly recommended!



Glen Cove business students Compete in Trade Show

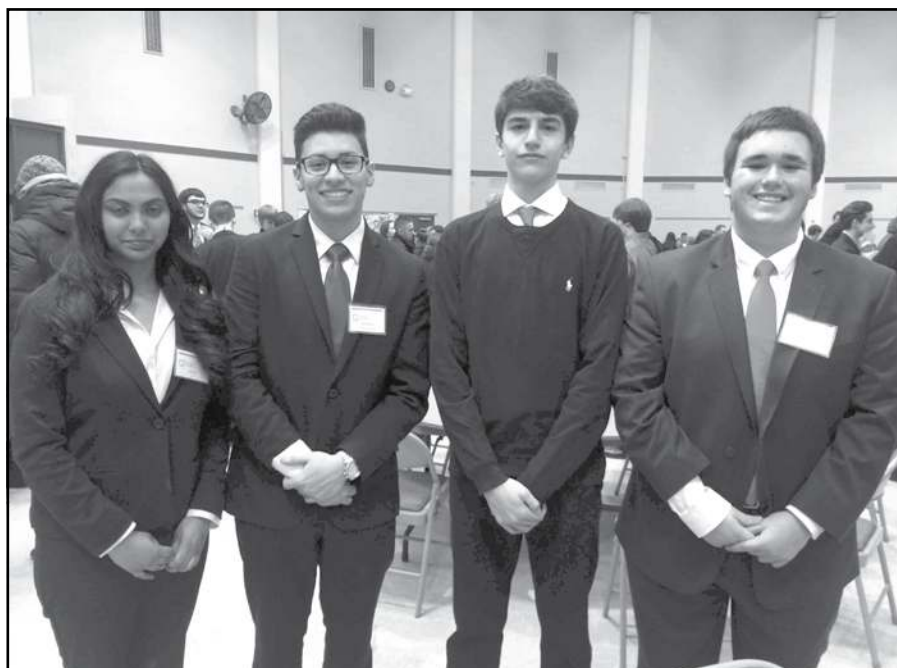
Glen Cove High School business students recently took part in the Long Island Trade Show and Business Plan Competition at SUNY Farmingdale.

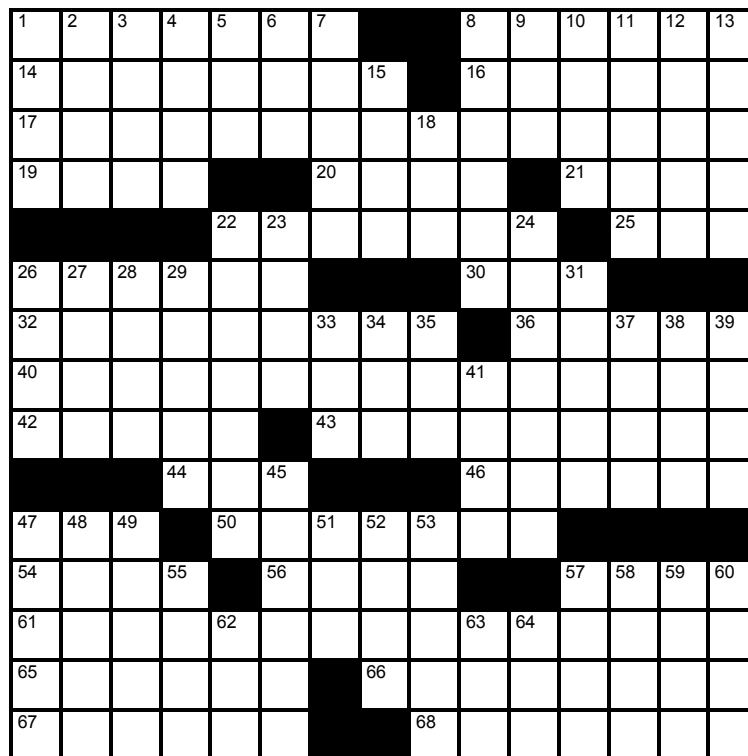
The trade show provided invaluable real-life business experience, and the Virtual Enterprise class is looking forward to their next trade show, which will be held in New York City in April.
