Fugitive from Justice Arrest

On April 10th the New York/New Jersey Fugitive Task Force contacted the Glen Cove Police Department regarding a possible fugitive who recently fled to Glen Cove from New Jersey. On April 13th, 2015 the New York/ New Jersey Fugitive Task Force met with Glen Cove Police Department requesting assistance in locating this fugitive. According to the GCPD, the fugitive was wanted for Aggravated Sexual Assault upon a person less than 13 years old. The crime occurred in New Jersey and involved sexual contact involving a 7 year old child. The Task Force proceeded to 41 Prospect Ave in Glen Cove, at which time the defendant was located in a side yard and was arrested by Glen Cove Detective Lieutenant John Nagle and Detective Karl Van Allen. The defendant is identified as Santiago Gonzalez-Ruiz (age 57). The defendant will be placed in the Nassau County Jail awaiting further legal proceedings. According to Lt Nagle the defendant was in Glen Cove less than two weeks before his arrest today.

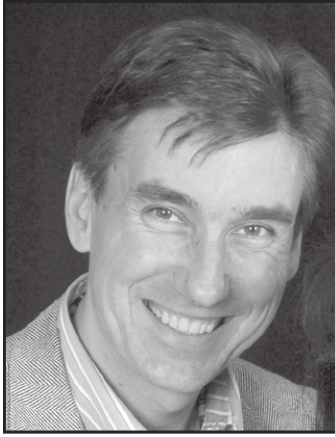

GC Anglers Hold Weigh-in for Awards

On March 11, 2015 the Glen Cove Anglers Club held its annual awards dinner to celebrate its members achievements in fishing for the 2014 season. This celebration is a highlight for the members who can lay claim to bragging rights for the year and reign as champs in the ever expanding competition categories, which is a testament to the enthusiasm and increased participation in events according to Jim Stanis, Chairman of the fishing committee and organizer of the night's awards festivities.

The event was well attended including local dignitaries; Mayor Reggie Spinello, Councilman Efraim Spagnoletti, Councilman and mayoral candidate Anthony Gallo Jr., Council woman Pam Panzenbeck and Councilman Joseph Capobianco.

The list of winners was long and distinguished including four time Angler of the Year Michael Caruso, Mike also won in 2006, 2007, and 2013. He also won three monthly derbies and several fish of the month awards. Mike also bagged largest bluefish of the year at 13.60 lbs. and largest blackfish of the year at 7.90 lbs. First year Commodore Sal Groe reeled in the largest striped bass at 44.25 lbs as well as largest weakfish at 3.50 lbs. Thomas "Sheppy" O'Rourke hooked largest fluke at 6.60 lbs and sea bass at 2.40 lbs. Ken Nelson had the largest porgy at 2.30 lbs. James "Birdy" Fallon had largest flounder.

Other notable winners were Frank Pena for Surf Angler of the Year, Sal Groe for the Arthur Leach Marathon Striper Derby, Out of Bounds Angler winner Jim Stanis, and new award Commodore Cup winners Oscar Flores and Steve Dunn. Most notably the winner of the Member of the Year, an award presented for achievements for other than fishing was presented to long time Past Commodore Tom Manzione who deservedly received the largest applause of the evening for basically making the GCAC what it is today, an entrenched institution in the City of Glen Cove and which will hopefully

remain so for years to come.

In the always-popular youth division newcomer Jocelyn Flores won for largest bluefish at 13.75 lbs and an achievement award for a 31.75 lbs striped bass. Another newcomer Sam McCrindler won for largest striped bass at 32.05 lbs, largest porgy and achievement award for a 2.65 lbs fluke. Youth division veteran Anthony Mandarino won for largest blackfish at 8 lbs and largest fluke at 3.45 lbs. The youth winners received a trophy for each of his or her awards. Also of note, two the youth division awards, particularly, the bluefish and blackfish were larger than the winners of the senior division. Indeed the future looks bright for these youngsters.

Fishing committee chairman Jim Stanis also noted that the GCAC won both inter-club yearly derbies held with three other local sporting clubs. One was an interclub striper derby and the other a rodeo involving multiple fish species. The fishing gods did look down upon us in 2014.

The GCAC is an environmentally conscious club that preaches the virtues of outdoor sportsman activities. We are a charitable organization that holds various events throughout the year to support local causes. We contribute to and sponsor local sporting organizations. We organize the local Snapper Derby every summer as well as hold various events for youth clubs, senior centers and hold events to show appreciation for our local public employees. Every holiday season we organize a toy drive during the Christmas as well as hand out turkeys for the more needy in our community. Just as in our fishing competition participation our charitable events are also expanding. A trend we hope we will continue for years to come.

Green Vale Rocket Club Team Qualifies to Compete at TARC Nationals for the Fifth Time!

For the fifth consecutive year, a Green Vale School Rocket Club team has qualified to compete in the national finals of the Annual Team America Rocketry Challenge (TARC). Green Vale's club, mentored by science teacher Peter Zaloom, is home to the only Long Island team that will face off against 99 other top qualifying teams from across the United States - in the quest for a national champion title.

The 13th annual TARC finals will take place on May 9th just outside of Washington, DC. TARC is the U.S. aerospace and defense industry's flagship program designed to encourage students to pursue study and career paths in science, technology, engineering and math (STEM). This year's qualifying challenge was to design, build and fly a raw egg-carrying rocket to reach 800 feet and return it to earth within 46 to 48 seconds -- with the egg (astronaut) uncracked. Students competing at Nationals must be able to fly their rockets to two separate altitudes on their first and second flights - check out the full rules here.

TARC gives students opportunities to apply their math and science skills to a real world project outside of the classroom. For many students, this experience yields their first significant

personal realization of how classroom lessons are relevant to endeavors that are fun, challenging and represent future career opportunities.

More than \$60,000 in prizes and scholarships are at stake on May 9th and the first place team will represent the United States at the International Rocketry Challenge held at the Paris International Air Show in June. In years past, Green Vale's club has been one of very few "middle school" teams competing at Nationals and has finished within the top twenty almost every year.

Congratulations and good luck to Frick, George and Justin! Mr. Zaloom is extremely proud of the entire club, not just this one team. He wrote, "I want to congratulate every member of Green Vale's Rocket Club for their enthusiasm and hard work throughout the year - you inspired and helped each other along the way. We can all be proud of our club and our school. I want to especially thank Dr. Meyer and Walter Gahagan '78 for their enthusiastic support of Green Vale's Rocket Club as our guides and mentors."

GCSB Bus Transportation Safety Issues Needed to be Addressed

To The Editor,

I am asking the residents of Glen Cove to take notice of a Board of Education meeting that will take place April 21, 2015 at 7:30 pm at Deasy Elementary School (parking lot off Forest Ave.) to discuss two items in particular. The first is a presentation by two applicant bus companies for the servicing of our school children that would begin with the 2015-16 school year. One applicant is Hendrickson Bus Line of Bayville, who has been successfully and safely servicing our district for many, many

years. The other is Montauk Bus Line which maintains a service yard in Center Moriches (nothing closer) and allows their bus drivers to take the buses home overnight to their private residences. They would then leave the next day, directly from home to pick up our children. This eliminates direct observation by the bus supervisors as to the appropriate condition of the driver and bus before picking up our children. Hendrickson requires the drivers and buses to be observed before assigned pick-ups take place each day (NY State Vehicle and Traffic Law 509 Article 19A).

Another issue that needs to be addressed is the appropriate number of drivers that Montauk would need to service the area, if they were to receive the contract. What then would happen to the jobs of 50+ Hendrickson drivers, who are residents of Glen Cove? Can Hendrickson reassign them?? Would Montauk absorb them onto their payroll?? If so, remember they are not allowed, by City of Glen Cove ordinances, to park non-garaged commercial vehicles overnight, let alone buses. The further away a driver/bus is from the pick-up, the higher the likelihood of lateness, if traffic snarls occur. There are other issues such as safety features of the buses, who absorbs the gas prices, if buses are traveling further away than where it is now in Bayville and what is the history of service of Montauk Bus Line with other school districts, if any? Questions need to be asked about prices of the services, as well.

These issues need to be addressed at the April 21st meeting. For the safety of our children, it is very important that residents, especially parents of children who will use the service, be present to ask these important questions. An impression needs to be made upon School Superintendent Maria Rianna and the School Board trustees, that we not only are concerned about our children but also of potential litigation, if safety features, or lack thereof, cause harm and/or injury. This not only hurts our children, but our pocketbooks.

The other item for discussion is the adoption of the school budget. Thank you.

Levin's photograph, titled "Rising" was awarded the National Silver Key

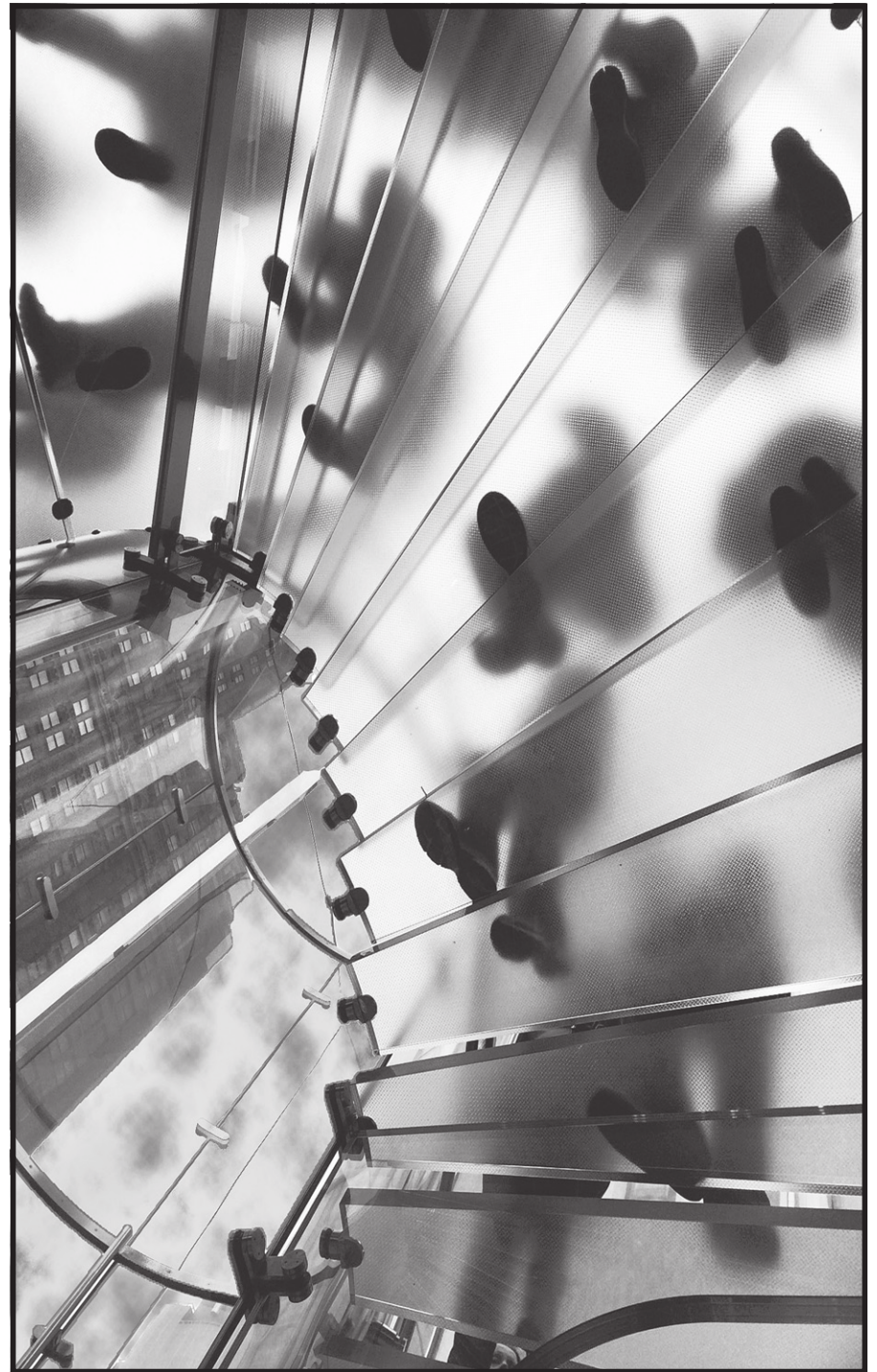

Daniel M. Pattarini died April 6, 2105, joining the love of his life in eternal rest. He was 94. Name the Celebrity



Carson took over the show and brought in Ed "Heeerrrr's Johnny" McMahon. While he was announcing the "Tonight Show", our celebrity began concurrent employment and a more than ten year run hosting the original version of the game show "Concentration", where the big prize was a mink coat or Cadillac. Haven't seen a mink coat given away as a contestant prize in decades. Those were the days! Hamburger anyone?

Last Week's Celebrity

Last week's celebrity was Scott Hastings "Scotty" Beckett. After appearing in the "Our Gang" short subject series, he continued in major films such as in "Kings Row" (1942) with Ronald Reagan where he played Robert Cummings' character as a child, in "Alibaba and the Forty Thieves" (1944) where he played Jon Hall's character as a child, as one of the unborn children in Shirley Temple's "The Blue Bird" (1940) and the son of Cary Grant and Irene Dunne's characters in "My Favorite Wife" (1940). After graduating Los Angeles High School, he took off from filming to try his luck on the stage. He won such important roles as that of young Al Jolson in "The Jolson Story" and "Junior" in the long running radio show "The Life of Reilly". In the late 1940s and early '50s, his career started to sputter. In 1948, he first arrest for possible DUI took place, with more following. In 1954, his career took an upward turn when he was cast as "Winky", the comic sidekick in the popular TV show "Rocky Jones, Space Ranger". That was short-lived. He was fired for excessive drinking and gained the reputation for not paying his gambling debts or repay money that was loaned to him.

After being fired from "Rocky Jones", Beckett made only a few subsequent TV and film appearances, some uncredited bit parts, before leaving show business forever. His post acting life was a series of arrests for DUIs, drug possession and assault. In 1962, he attempted suicide after a heavy drinking binge. He had a tragic car accident, which left him severely disabled. On May 8, 1968, he sought medical attention for a severe beating and the circumstances where never made clear. On May 10th, he was found dead in bed. He was 38 years old. A note and pills were found but the L.A. coroner stated the exact cause of death was unknown despite the fact that an autopsy had been performed.

Correct Callers

This week's celebrity was born on Valentine's Day 1921 in Akron, Ohio. He was a long time broadcaster, TV host and producer, news anchor, author, game show host and music composer. He attended Bluffton College and Wayne State University from 1938 to 1941. He worked as a radio announcer and program director at WLOK in Lima, Ohio after his first year at college. In 1940, he moved on to WWJ in Detroit. In 1943, he joined the NBC radio network at WMAQ, as an announcer in Chicago where he lived until 1954. He married a co-worker, Ruth Shaheen in 1944, 3 days after his 23rd birthday. They recently celebrated their 71st wedding anniversary.

He made his first TV news broadcast in Sept. 1945 from the still experimental studio WBKB-TV (now WBBM-TV), a station owned by the Balaban and Katz Theater, a subsidiary of Paramount Pictures. He became a TV regular, announcing for "Hawkins Falls", which was the first successful American TV soap opera and sponsored by Lever Bros. blue detergent, Surf. It was NBC's longest running soap opera until "The Doctors" exceeded it in 1967. Our celebrity also announced the Burr Tillstrom children's show "Kukla, Fran and Ollie." In March 1954, he moved to NY to accept a position as announcer for Pat Weaver's (Sigourney's Dad) "The Home Show" starring Arlene Francis (later of "What's My Line?" fame). He was the announcer for Sid Caesar's "Caesar's Hour" for the '56-'57 season.

In July 1957, he became a bona fide TV "personality" as Jack Paar's announcer on "The Tonight Show" until Paar's departure in March '62, and then he continued to announce for the show until Fall of '62 when Ed Herlihy took over the announcing reins. Herlihy held the position until Oct. 1, '62, when Johnny

Dear Lover of Books and TV, I recently finished a novel Daniel DiPietro recommended to me a few months ago. My book group really enjoyed it and I bet your friends will too: THE WHITES by Richard Price (writing as Harry Brandt). Price has written many police/crime novels, but THE WHITES is something more... a morality play based on the human need for retribution. Five young New York City police officers working together in the late 1990s became known as the Wild Geese, largely because of their strong sense of camaraderie and frequent use of unconventional tactics. Billy Graves, the protagonist and the only one of the Wild Geese still on the

police force, heads the Night Watch (10pm-6am), a brutal shift that wreaks havoc on body and spirit. The others- a funeral director, a real estate mogul, an apartment building super, and a campus security chief- are all long retired. But the Wild Geese all have their "whites", a case that continues to haunts them- the one in which someone literally got away with murder. It is Ahab's Moby Dick- the Great White Whale that must be hunted forever. Price shows in great detail how each of these modern Ahab's lives has been formed and malformed by the pursuit. Compromises are made, lines are crossed and we watch with horrified fascination as their stories unfold. Highly recommended!

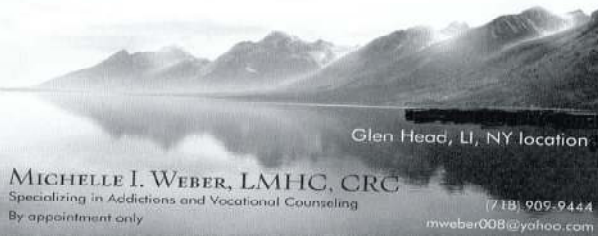
