# Operation Safe Child At Gribbin School

Glen Cove students at Gribbin School took part in Operation Safe Child, thanks to a collaborative effort between the Nassau County District Attorney's office and the Glen Cove Police Department.

The program, which collects vital

information on students and incorporates it on an identification card, can be used to aid parents and law enforcement officials in the event of an emergency. Students had their photo, fingerprints, height and weight taken by members of

the Glen Cove Police Department. That information, along with the child's hair color, date of birth and gender, were stored in a database in Albany that can be accessed within minutes all over the country if necessary.

Gribbin Principal Francine Santoro said the school has participated in Operation Safe Child for years because the safety of the school's children is paramount.

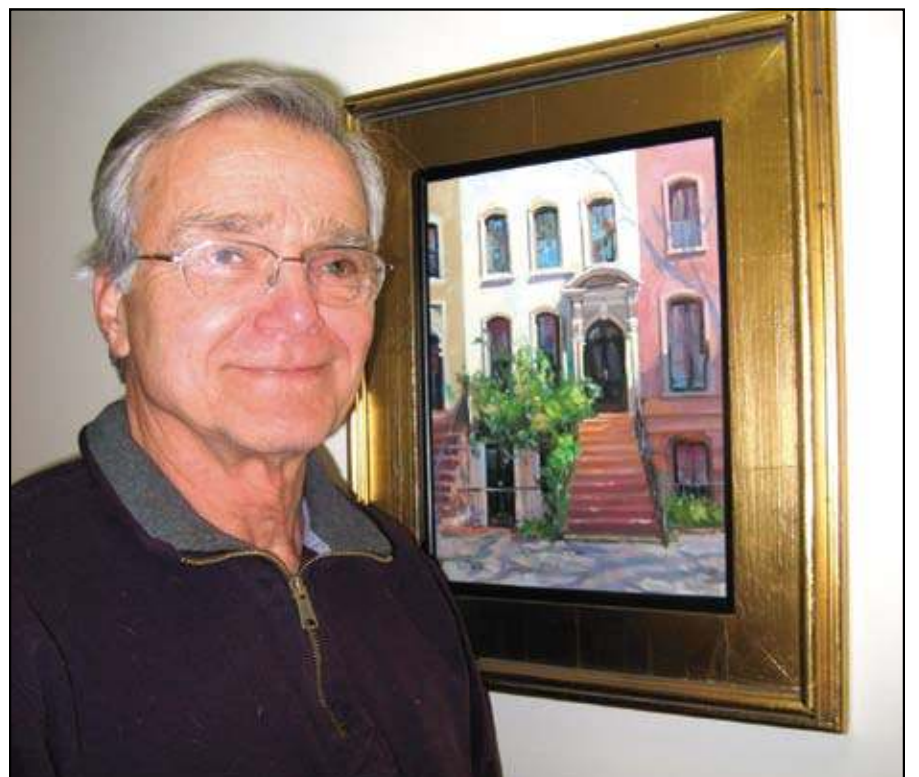

in various media, such as oils, acrylics, pastels and pencil. Presently he is working primarily in oils, a medium he finds best suited for the style in which he executes his paintings. The exploration of chiaroscuro, the varying relationships between light and shadow, play a dominant role in the development of his work. He is drawn to a wide variety of subjects including landscapes, seascapes and the bucolic scenery in and around his native Sea Cliff which he deftly paints with mastery and finesse. The monumentality and angularity of cityscapes and buildings hold a particular fascination for him, as well.

## Glen Cove Mayor Spinello Finds Treasures at Glen Cove Adult Day Program Shopping Event

The program also supports the needs of caregivers by giving them a daily respite from the responsibility of providing 24/7 care for their loved ones. ## Glen Cove Is Safe

On April 28th, Glen Cove Patch featured an article recognizing Glen Cove as one of the safest cities in America. Safewise, a community-focused security organization that researches community safety, placed Glen Cove in the top 100 because: "Relatively diverse, Glen Cove takes the health and safety of its residents seriously. Glen Cove supports "S.A.F.E." (Substance Abuse Free Environment), a community organization that works with other nonprofits, city government, and local businesses to eliminate alcohol and substance abuse."

Using 2013 crime data, Glen Cove was ranked number 76. With a population of 27,134, Glen Cove received these rankings based on low statistics of violent crimes and property crimes per 1,000 people. 0.62% of Violent Crimes per 1,000 and 5.41% of Property Crimes per 1,000 were yielded.

Substance Abuse Free Environment (SAFE, Inc.) formed a community based Coalition in 2003 to change societal norms about alcohol and substance abuse and to address the risk factors that contribute to them. The Coalition is overseen by SAFE's Board of Directors and Co-Chaired by SAFE Executive Director, Dr. Sharon Harris and City Councilman Tony Gallo. It is composed of twelve sectors of the community: Youth (an individual 18 or under), Parents/Youth Caregivers, Business

Community, Media, School, Youth-serving Organization, Law Enforcement, Religious Organizations, Civic Organizations, Healthcare Professionals, and Local Agencies with Expertise in the Field of Substance Abuse and associated issues.

"For the last twelve years, the Coalition has dedicated itself to its mission of eliminating alcohol and substance abuse through strategic planning using local prevention needs assessment data. As SAFE Board Chair and Coalition Strategic Planner, it is greatly rewarding to be acknowledged by the Safewise organization" said Georgie Connert.

Coalition members actively participate on one of four established Coalition Committees, each with its own charge. The Community Committee, Chaired by Councilman Anthony Gallo, serves as a think tank to examine needs assessment data and make recommendations regarding underage binge drinking, enforcement of underage drinking laws and social host laws.

The School Committee, Chaired by Denise Kiernan, Director of Health and Physical Education for the Glen Cove School District, utilize prevention needs assessment data to identify and provide Alcohol, Tobacco & Other Drugs (ATOD) prevention activities, and programs for youth.

The Parent Committee, Chaired by Laurent Caballero, acts as a bi-lingual parent resource for prevention, education, intervention, and research on alcohol and drug abuse.

The Youth Committee, Co-Chaired by Arlene O'Dell, Executive Director of the Glen Cove Youth Bureau and Melissa Rhodes, Executive Director of the Glen Cove Boys and Girls Club utilize needs assessment data to identify and provide prevention activities and programs for youth and participate in all planning activities regarding youth that help to reduce youth drug and alcohol use.

## SAFE Inc., Parent University help parents' learn to communicate with their Middle Schoolers

The SAFE Glen Cove Coalition sponsored another successful Parent University, free professional workshops designed for parents who want to learn about youth alcohol and substance abuse prevention, intervention and education. SAFE Inc., and High Functioning Family recently visited the Finley Middle School PTA on March 25th to talk with parents about how to improve communication with their middle schooler.

This month's interactive workshop was led by Margarita Daskalakis and Juarline Stravrinos Co-Founders of High Functioning Family a parent and health coaching company. High Functioning Family's mission is to empower families to turn their challenges into successes. Daskalakis and Stravrinos discussed tips and strategies parents can use when dealing with a pre-teen that is acting up. Audience members were praised for their "desire to educate themselves on how to be the best parent, care takers and teacher they can be". PTA members were encouraged to praise their children more than they react to bad moments. Parents were challenged to keep track of how many times a day they either praise or reprimand a child throughout the day.

Parental influence continues to play a major role in a child's development and decision making skills. SAFE Inc. encourages parents and caregivers to open lines of communication with their children, "Children need to know that they can go to a parent and speak to them about their concerns" said Ashley Ferruffino SAFE Coalition Liaison. By

strengthening communication skills parents are able to build stronger and more consistent relationships with their children.

In 2014, SAFE and the Glen Cove School District administered the Bach Harrison Prevention Needs assessment survey to students in 6th, 8th, 10th and 12th grades to determine risk and protective

factors for alcohol and substance abuse at school, in the community and at home. Results indicated that 44% of the 6th grade and 50% of the 8th grade are at risk for Poor Family Management and Exposure to Adult Antisocial Behavior.

"Parent University is an important prevention education experience that makes parents aware of the messages they are sending their children" said Dr. Sharon Harris, SAFE Executive Director. Children will model communication styles that they experience at home in their other relationships. By strengthening parent child communication patterns middle school children are able to learn to ask for help and share their concerns in a more supportive environment.

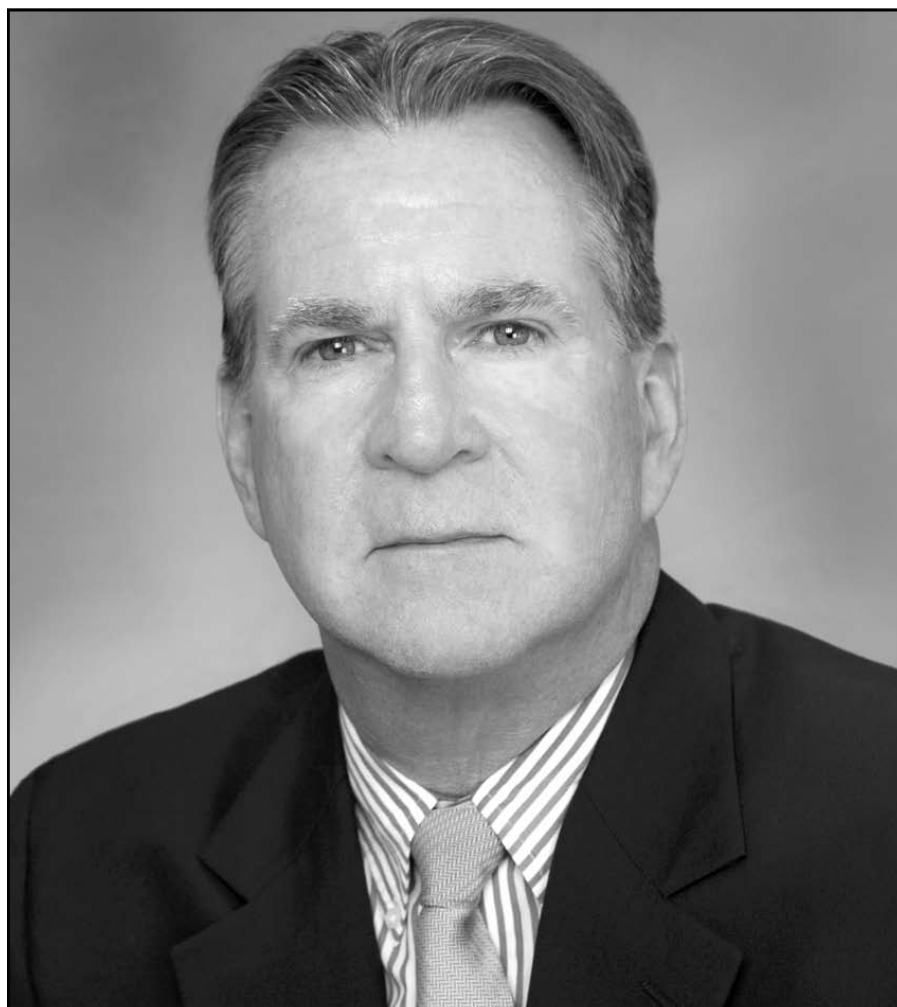

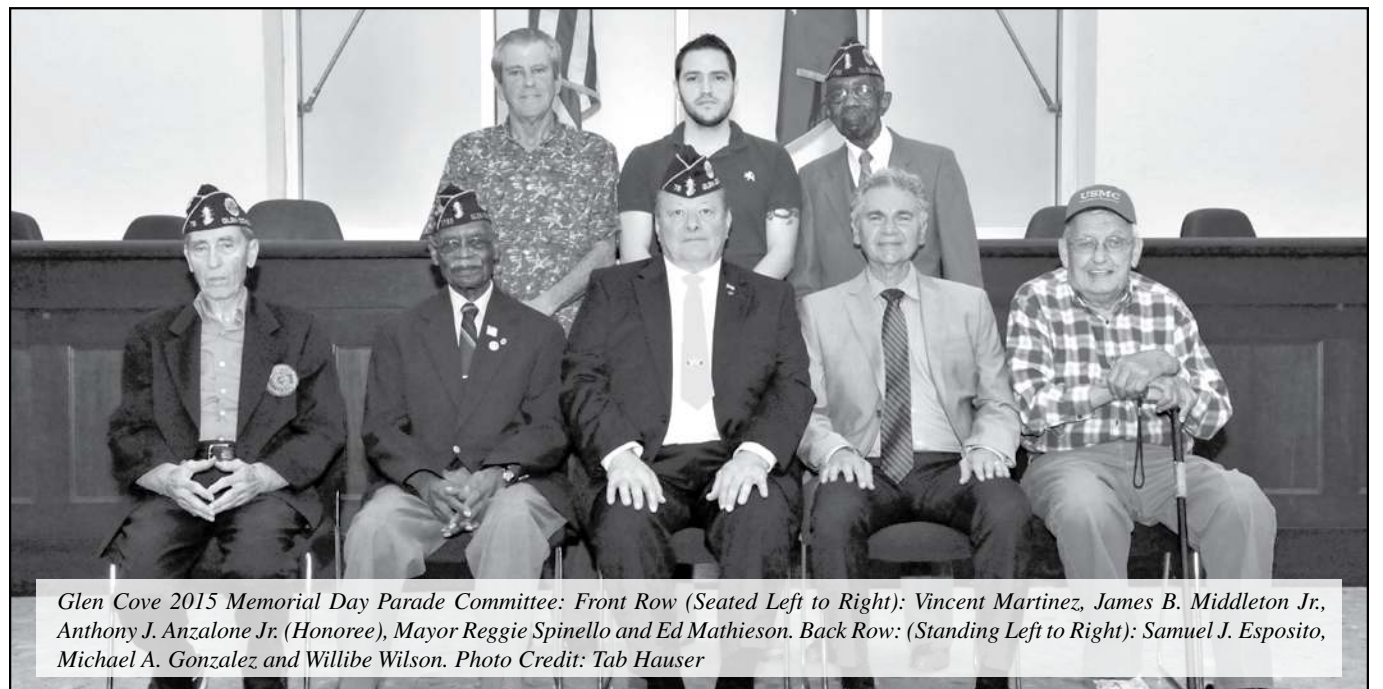
**Glen Cove 2015 Memorial Day Parade Committee Announced**

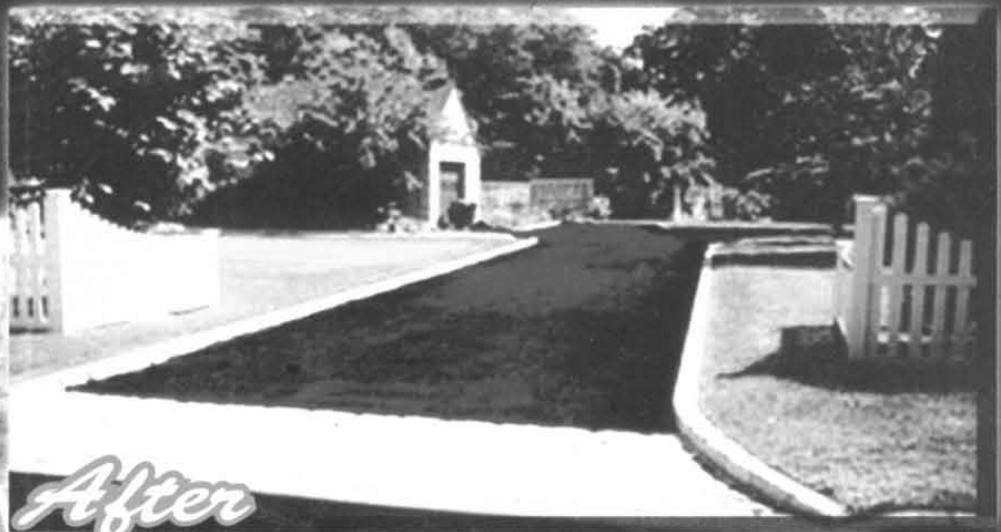

The students were made aware of the sounds heard in the GWL Japanese Garden including the rustling of the trees and the water circulating in the pond." The presenters and formal guests were dressed in traditional Japanese

"kimonos".

The Japanese tea ceremony originated when Japan adopted both Zen Buddhist beliefs and Chinese practices of drinking a powdered green tea. In the 1500's, the tea ceremonies were introduced. The traditional Japanese tea ceremony became more than just drinking tea; it became a special and unique spiritual experience that includes harmony, respect, purity and tranquility.

As the students quietly listened and watched with amazement, the two presenters first bowed to one another. The host (presenter) ladled water from the tea kettle "kama" into a tea bowl and then poured it out (helping to both purify the bowl and warm it). Utilizing a special spoon called the "chashaku," the green tea powder was taken from the container and put into the tea bowl then hot water was added. While the tea was prepared, the guest (second presenter) was able to take a bite of "chagashi" or Tea cookie. Next, tea whisks or "chasen" were used to create tea with light foam on top. Unlike American tea, green tea known as "Matcha" is made from very fine powdered green tea leaves. After bows were exchanged again, the host rotated the bowl 45 degrees (two times clockwise) to allow the guest to see the design on the front of the bowl. The guest then bowed and raised her bowl in a gesture of respect to the host. Before drinking, the guest rotated the bowl 45 degrees to avoid drinking from its front which is considered the face of the bowl.

She then took a sip and complimented the host on the delicious tea. After taking a few more sips, the guest wiped the rim of the bowl and rotated it 45 degrees (two times counter clockwise). She then took a moment to appreciate (or examine) the bowl and then bowed again to symbolize the end of the ceremony. This process was repeated two or three times enabling faculty, and various students to become the formal guests at the GWL Japanese Tea Ceremony.

What is the difference between Japanese Green Tea powder and tea in a bag? At the Japanese Tea Ceremony, the GWL children learned that when you drink tea using a tea bag, you drink tea extract (tea made from soaking the bag in hot water). When you drink Japanese green tea powder (made by grinding dried tea leaves), you drink the tea leaves! You get to enjoy every part of the tea leaf created by nature!

Many thanks to all those who conducted and participated in this very special Japanese Tea Ceremony. This hands-on learning experience provided knowledge of the customs and culture of Japan. Please don't forget to ask your children about this unique Japanese tradition!

### **Glen Cove Neighborhood Association Response**

As board members of the Neighborhood Association, which owns the land upon which the Glen Cove YMCA operates, we would like to clear up certain misconceptions and rumors about the controversy which has engulfed our community.

The land upon which the Glen Cove YMCA is located was originally donated by the Pratt Family for the recreational and beneficial use of the people of the City of Glen Cove and the surrounding communities. As such, the mission of the Neighborhood Association is simply to ensure that the operator of the facility does so with the best interests of the community in mind.

The Neighborhood Association has for years leased this land to the YMCA of Long Island for its operations in Glen Cove. That lease will expire at the end of 2015.

Recently, it has come to our attention that the YMCA of Long Island has dismissed the Board of Managers of the Glen Cove YMCA over a dispute concerning how the Glen Cove YMCA is to be run. Before renewing the lease with the YMCA of Long Island for another term, we believe it is our duty to investigate the issues concerning this dispute. In order to do that, we have asked representatives of both sides to meet with us so that we can make an informed decision. That process is underway and we hope to do that as soon as possible and resolve this controversy.

In the meantime, we wish to state that the City of Glen Cove is not a party to this lease nor part of this controversy and has no interest or say in the lease renewal process. We also wish to assure all, that no matter how all these issues are resolved, the facility which serves the people of the City of Glen Cove will continue to operate as it is operating now.

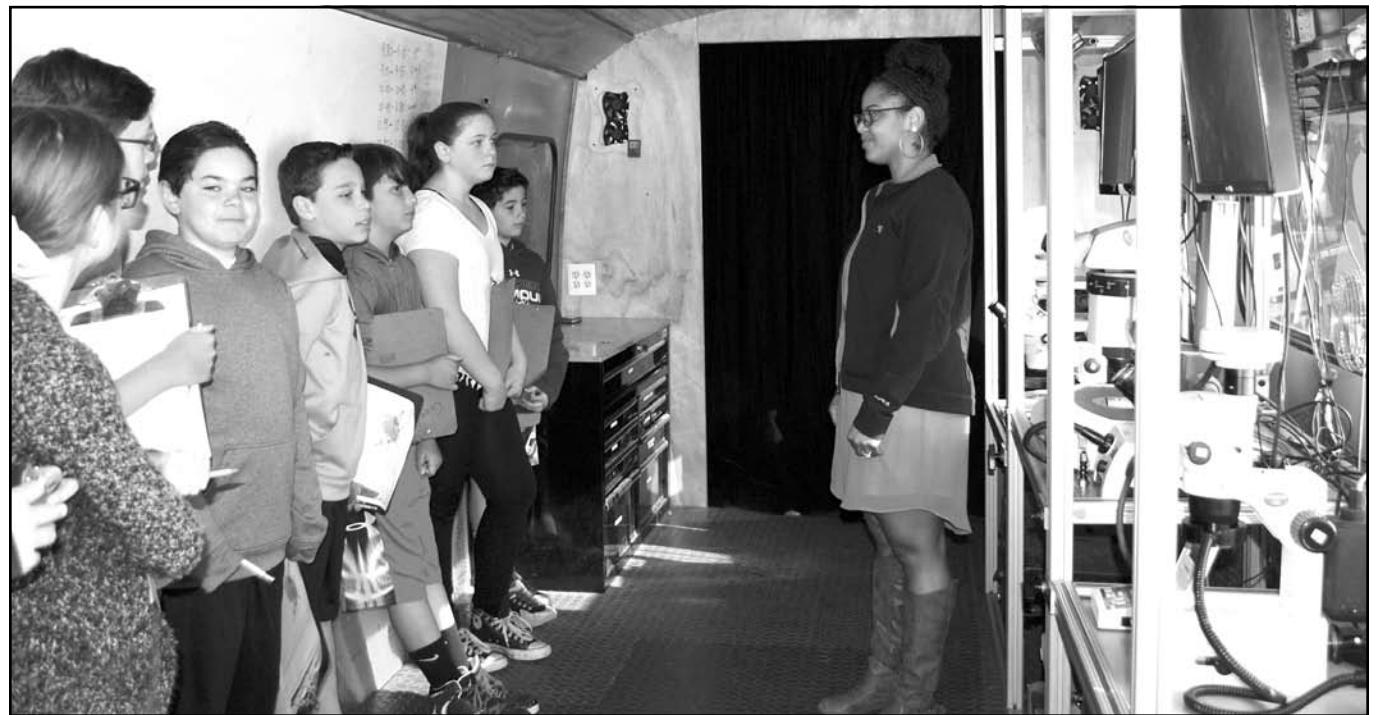
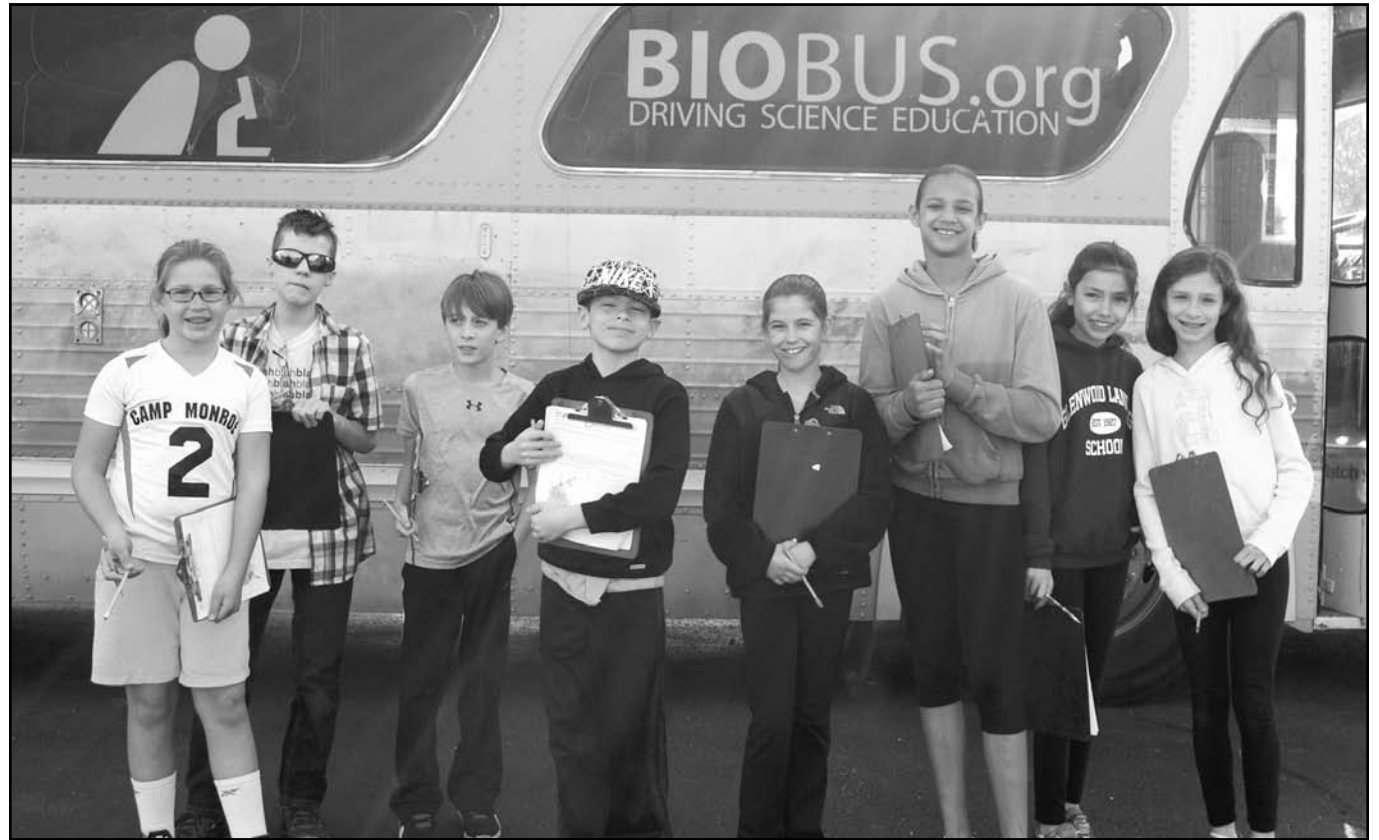
# BioBus Stops By Glenwood Landing School

Students had a special treat when the BioBus recently rolled into the parking lot of Glenwood Landing School. The BioBus is a high-tech science lab on wheels filled with research-grade equipment! As students boarded the bus, they were able to immediately explore the microscopic world around them in an inquiry-based setting that is supervised by Ph.D. level scientists.

With fluorescence stereo zoom microscopes and digital cameras, Glenwood Landing students were excited to explore first-hand the internal workings of a micro-crustacean organism called a Daphnia, more commonly known as a water flea. In addition, the young Glenwood scientists were able to ask many questions and learn about its physical and behavioral characteristics.

The BioBus has been on the road since 2008 giving 115,000 people at more than 420 schools and communities the opportunity to work side-by-side. It is operated by Cell Motion Laboratories, Incorporated, an educational non-profit organization based in New York. On their website, it states "Cell Motion Laboratories works towards a future in which all people have experienced the power and beauty of making a scientific discovery. We cultivate this vision by creating immersive laboratory environments in which scientists join students and the general public for hands-on scientific exploration." ## An Open Letter to the North Shore School Community

### “McCarthyism”

If anyone wants to know why no one is running for the school board this year; one only has to read the comments of Cathy Elorriaga and Tim Madden in Gold Coast Gazette. The focus seems to be on who is behind these ads and not on the behavior of our elected officials or the facts.

These ads represent the voices of a broad group of individuals and families, some of whom have lived here for decades. We are dismayed at the behavior of select members of current and former school board members and their proxies. Over the past few years, we have witnessed the personal destruction of good people who had one objective – the improvement of the schools and our community. Children of candidates have been the object of scorn, ridicule and bullying. And last year, we witnessed the abuse of the electoral system by a candidate. So forgive us for using a pseudonym to voice our opinions. One only has to read Ms. Elorriaga’s and Tim Madden’s Letter to the Editor last week, in which they raise the ugly specter of “McCarthyism”, to understand how low the politics of personal destruction have come in this community.

Pseudonyms have enjoyed a rich tradition in our country. Our forefathers used them during the public dialogue (Federalist Papers) on the merits of our newfound Constitution. Alexander Hamilton, James Madison and John Jay wrote under the pseudonym “Publius”. Pseudonyms have the benefit of allowing the authors written words speak for themselves, without people attempting to argue against those words based on WHO wrote them. Words and logic can be powerful.

Ms. Elorriaga and Mr. Madden write that our claims are unsubstantiated. This is not true at all. Our school district teaches our children to look at “primary documents” to support their arguments. We will do the same. Facts can be so inconvenient at times.

Fact: At a school board meeting immediately following last year’s election, Ms. Commander allegedly claimed that her attorney recommended that she not comment on the matter of using the robo-call system, but admitted to the use of the robo-call system nonetheless (See May 22, 2014 school board minutes). If Ms. Commander said this – it must be true. If the school board published these minutes – it must be true. These are primary sources on the matter.

Fact: A complaint has been filed with the NYS Education Commissioner seeking a formal investigation of this matter and to have a new election! This is part of the public record and last week’s article in the Gold Coast Gazette confirm that a complaint was filed (these can both be characterized as primary source documents).

Fact: Mr. Berliner as President of the School Board issued a Letter to the Editor earlier this year that was published in the Gold Coast Gazette. One week later, the school board’s attorneys published a letter correcting mis-statements made by Mr. Berliner (more primary source documents).

So how does the aforementioned represent “unsubstantiated allegations”?

The school board’s own legal response to the complaint filed with the NYS Commissioner of Education confirms these allegations in the most devastating manner. (Please re-read this last sentence because the ethics of the argument is disconcerting). Apparently, because people complained late about the cheating, the case should be dismissed!

As children, we learned the phrase “Cheaters Never Prosper”. Apparently not. You can cheat in an election and remain on the school board. The teachers have watched all of this behavior over the past few years and ask whatever happened to ethics and the free flow of ideas and tolerance?

We use the pseudonym “Committee that Speaks on Behalf of Those that can No Longer Afford to Live Here” because that is happening within our community. People can no longer afford to live here. Ask the school board to reconsider teaching Mandarin for kindergarteners and you are ridiculed. Enrollment is down in our elementary schools. People can’t afford to stay here. Young people can’t afford to move here.

Please vote for the budget. Please withhold your vote from Ms. Labatte and Mr. Berliner. We deserve better as a community.

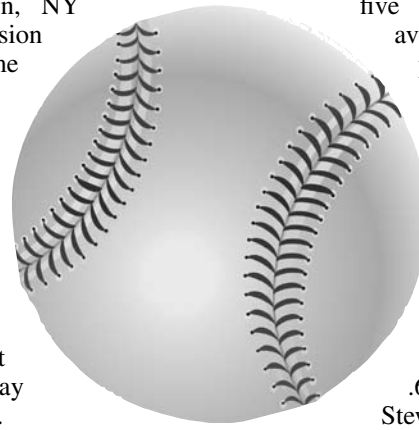

THE HARE WITH AMBER EYES by Edmund De Waal is a story of gains and losses, triumph and defeat, things large and small... spread over many years and many countries. The book begins in Paris 1871. Charles Ephrussi, the fabulously wealthy son of a fabulously wealthy family amasses a large collection of netsuke- tiny Japanese animal carvings- none bigger than a matchbook. We travel across Europe into the lavish, art-filled

homes of the Ephrussis with the book ending in Tokyo 2007 where one of the remaining family members has settled; much has gone on in between. The Ephrussis were Russian Jews who began a grain business in the early 1800's and then branched out over Europe making fortunes in a myriad of fields.
