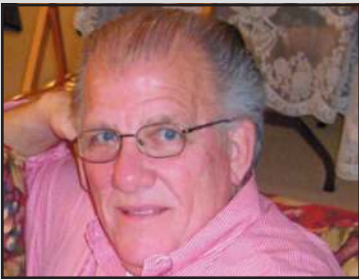


Community Mourns Wolke

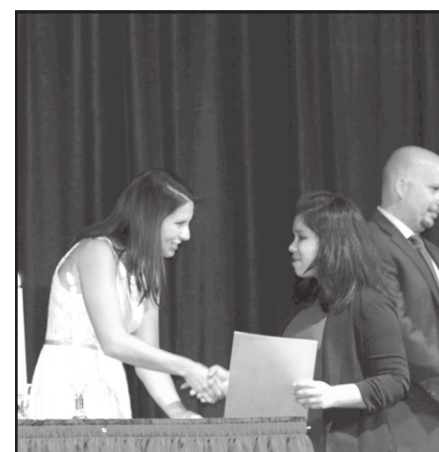

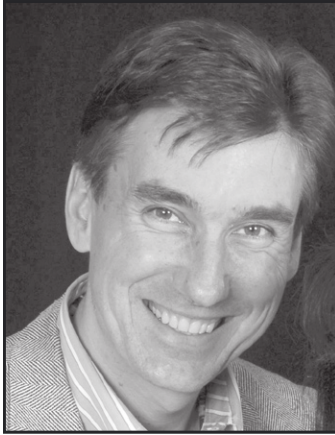

Wrong But Never In Doubt To The Editor,

The May 13-19 issue of another local publication masquerading as a weekly newspaper carried a letter critical of me for explaining in the Gold Coast Gazette several weeks ago why Glen Cove Mayor Reggie Spinello is right, and all of his critics are wrong, about the Mayor's statement that neither he nor the City of Glen Cove belong in current lease negotiations concerning the Glen Cove Y.

The letter asserts the proposition that Mr. Spinello was elected to "make everything that happens in Glen Cove his business," insisting that the public has some right to demand that its elected leader stick his nose into other peoples' business, whether invited or not, because he was elected to . . . well, to resolve every private dispute that occurs within the territorial limits of the City.

What the author of that criticism obviously did not know when he penned his reproach of both the Mayor and me was that the Neighborhood Association, the Glen Cove Y's landlord, was about to publish its own public statement at the same time his letter appeared so it could "clear up" what the landlord itself says are "misconceptions and rumors." In fact, the Neighborhood Association's published statement says ". . . we wish to state that the City of Glen Cove is not a party to this controversy and has no interest or say in the lease renewal process." Thus, the letter writer's demonstrably uninformed claims would appear to fall neatly into the category of "misconceptions and rumors."

If I were . . . say . . . a public school teacher with enough of an interest in local politics to challenge Mayor Spinello for failing to step in and fix the lease negotiations where the parties have expressly invited him to stay out of the talks, I'd give that letter writer's effort to criticize the Mayor and me a very poor grade indeed. Although he may have been 100% right that I am a friend of Mayor Spinello, it turns out that he's 100% wrong on his basic facts concerning the Glen Cove Y lease negotiations. Those two grades add up to an average of 50%, and that's an "F"

by anyone's standards.

This is not the first time this particular letter writer has sought to disparage me in a local newspaper. As usual, however, he continues to follow the principle that while he may be wrong, he's never in doubt.

Getting it wrong is what happens when you don't do your homework.

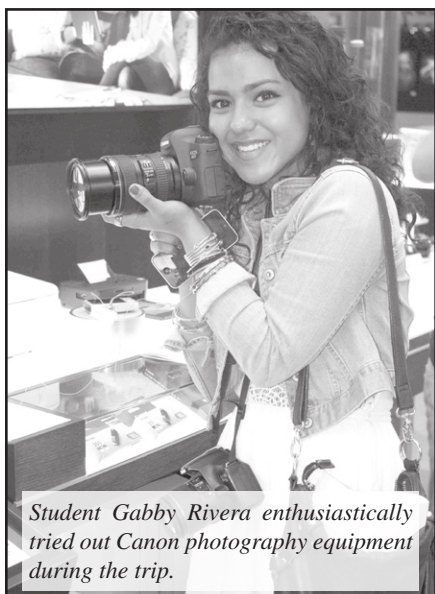
to go in this special Victorian structure!

According to Johnides, Canon's staff was impressed with the level of enthusiasm and photography knowledge shown by the students and shared information regarding the visit via Twitter.

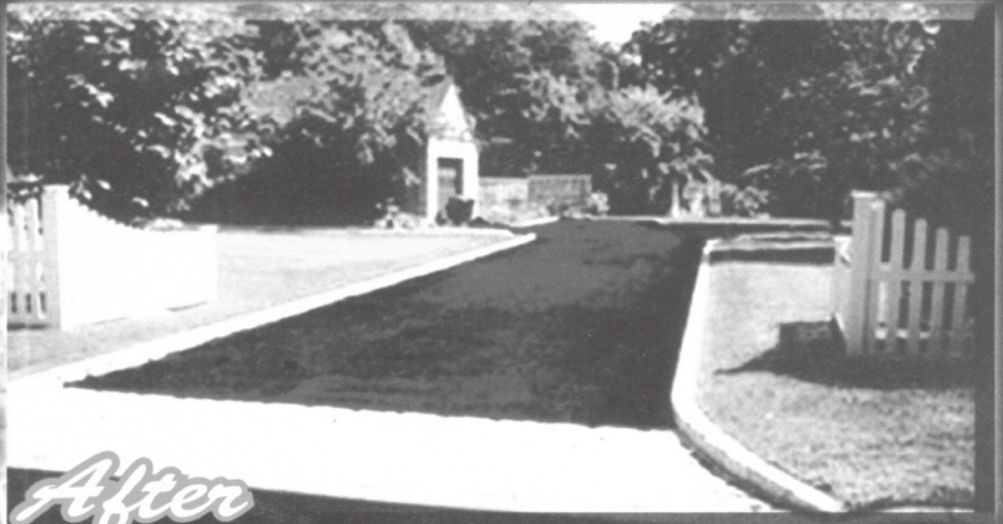

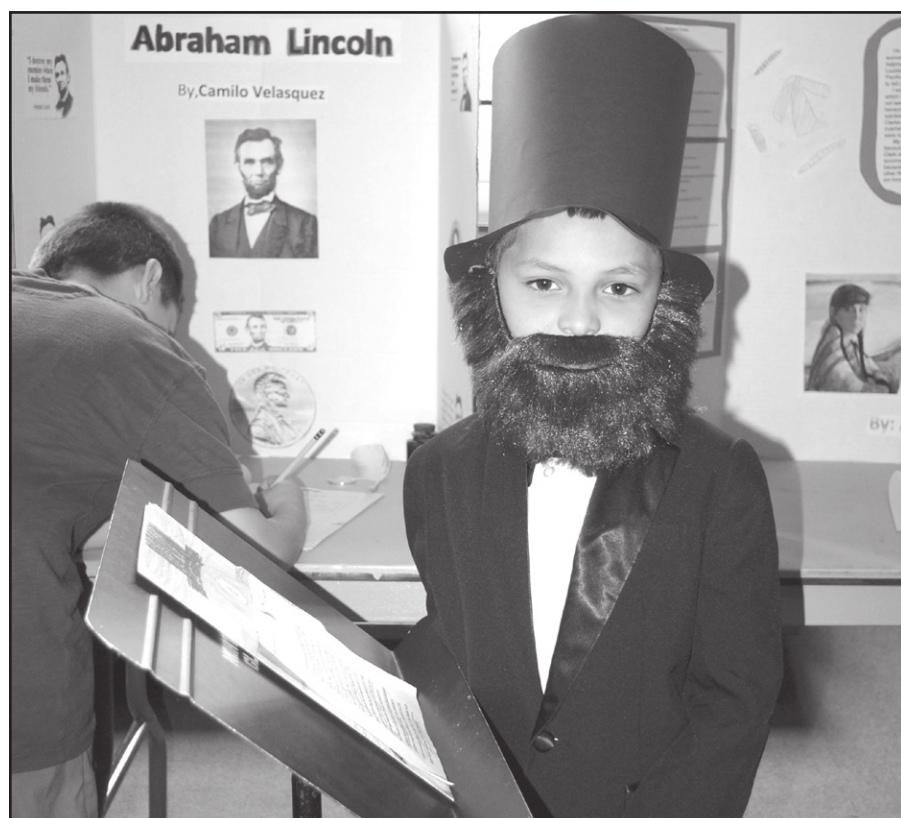

8th Graders at NS Middle School Embark on Decades Project

Under the direction of their social studies teachers including Mr. Curtin, Mr. Freund and Ms. Larkin, North Shore Middle School eighth graders embarked on a Decades Project. This comprehensive assignment engaged students in many the events and historic people that helped shape the America in which we live in today. Ms. Larkin said, "We researched the military, political, social, and pop culture events that made a lasting impact on the past and still influence the country and world today." She continued, "Our students were divided into groups of four researched events from one of the following time periods: 1945-1955, 1955-1964, 1965-1974 and 1975-1991." Some important topics included post WWII, the Atomic Age, the Cold War, the Civil Rights Era, Cuban Missile Crisis, Freedom Riders, Woodstock, the Energy Crisis, the birth of Rock 'N Roll, Vietnam War, and the Iran Hostage Crisis.

Eighth graders in each group will specialize in a different aspect of the time period based on their individual preferences. After they became knowledgeable "historians," each group will decide on an appropriate manner in which to display and present their final projects. Possible choices include a movie, time capsule, board game, calendar, timeline, or an interpretive selection (i.e., dance). In addition, each group had to answer the essential

question in their final presentation, "How do the political, social, military and cultural aspects of the decade contribute to changes in America?"

Please take the time to ask your middle school students about their Decades Project and how important military, political, social, and pop culture events

shaped American history as well as the world in which we live in today. Which topic did they research? What did they learn from it? And, how did it impact their lives today? Their answers will amaze you!

Glen Cove After 3 Students Master the Art of Creating APPs

Thanks to generous support from the Verizon Foundation and Nassau County Legislator Delia DeRiggi Whitton, students at Glen Cove After 3 have been learning how to make APPs. The middle school students have been busy designing an APP to benefit local food pantries. The APP will allow the pantries to monitor their inventory, organize contact information on clients and reach out to the community for donations. Elementary students have been designing an All About Kids APP that promotes fun events and activities for children and families in Glen Cove. Through their research, the students are becoming more aware of their community, its needs and resources. The APPs will make their debut later this year.

Glen Cove After 3 is an afterschool and summer enrichment program that is offered by the Glen Cove Youth Bureau. The program is available to students in grades K-8. Students meet for 3 hours a day after school and for 6 hours a day during the summer. They receive homework assistance; participate in enrichment activities, sports and positive youth development lessons. During the summer, mornings are spent on English, math and science in an effort to combat summer learning loss. Enrichment, sports and positive youth development fill the afternoons; Friday's are reserved for field trips. Registration is now underway for the summer session. 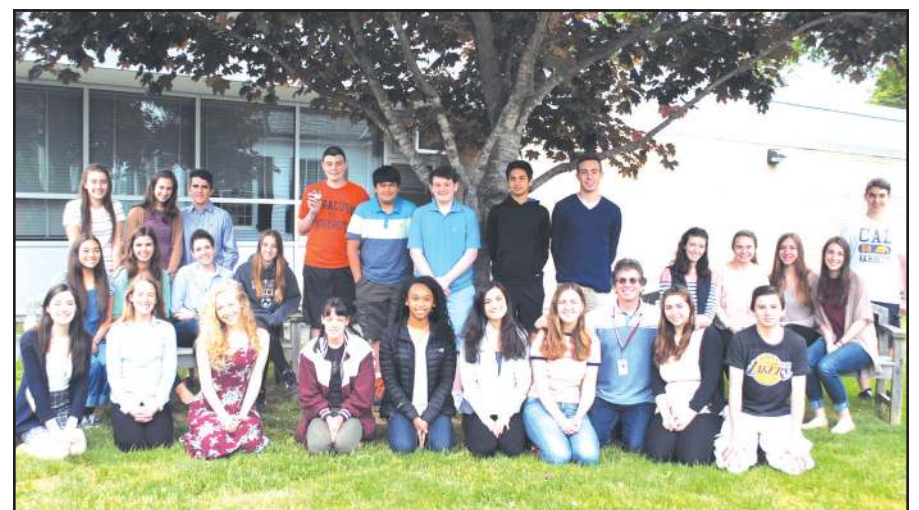

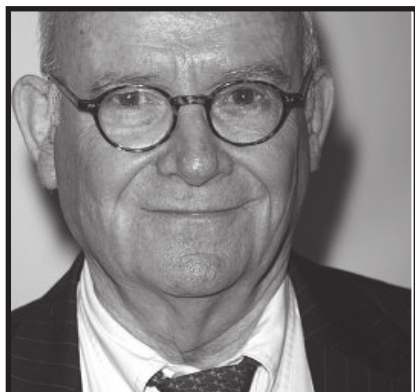

Name the Celebrity



This week's celebrity was born Henry Zuckerman on Dec. 9, 1930 in NYC. He is the son of silent film actress Ruth Taylor. Always with the comic flair, he teamed up with comic prankster, Alan Abel, as the spokesman and quietly outraged president, "G. Clifford Prout", for the group, "The Society for Indecency to Naked Animals (SINA)." Beginning May 27, 1959, on the NBC "Today" show, he presented SINA's mission to clothe naked animals throughout the world. The hoax began as a satire of media censorship but it took on a life of its own with sympathizers offering unsolicited contributions, that were always returned, citizen summonses for walking naked dogs, and sewing patterns for pet clothes. This last activity actually stuck around. He continued this hoax on several talk TV and radio shows for three years, including the "CBS Evening News" on Aug. 21, 1962.

His dry humor attracted attention in the entertainment community. He became a cast member on TV programs such as "The New Steve Allen Show" (1961) and "That Was the Week That Was" (1964-65). He was co-creator and writer for "Get Smart" (1965-70) with Mel Brooks. He won a Primetime Emmy for Outstanding Writing for "Get Smart" in 1967. He was nominated for an Academy Award twice in 1968 for Best Adapted Screenplay for "The Graduate" in which he appeared with Dustin

Hoffman and in 1979 for Best Director for "Heaven Can Wait" in which he appeared, as well, with Warren Beatty.

Last Week's Celebrity

Last week's celebrity was Una Merkle. She was an MGM contract player from 1932 to 1938, appearing in as many as twelve films in a year, often on a loan-out to other studios. She was also often cast as a leading lady to a number of comedians in their starring pictures, including Jack Benny, Harold Lloyd, and Charlie Butterworth. In "42nd Street" (1933), she played a streetwise showgirl, who was Ginger Rogers' character's buddy. In the famous "Shuffle Off to Buffalo" number, they sang the verse, "Matrimony was baloney. She'll be wanting alimony in a year or so./Still they go and shuffle, shuffle off to Buffalo." Merkle appeared in the 1934 and 1952 film versions of "The Merry Widow" playing different roles in both. One of her most famous roles was in the western "Destry Rides Again" (1933) in which her character, "Lillibelle", gets into a famous "cat-fight" with "Frenchie" (Marlene Dietrich) over the possession of her husband's trousers, won by "Frenchie" in a crooked card game. She played the elder daughter to the W.C. Fields character, "Egbert Souse" in the 1940 film, "The Bank Dick." She was nominated for an Academy Award for Best Supporting Actress for "Summer and Smoke" (1961) for playing Debbie Reynolds' mother. She was also featured as Brian Keith's housekeeper in the original Walt Disney comedy "The Parent Trap" (1961) with Hayley Mills. Her final film appearance was opposite Elvis Presley in "Spinout" (1966). On June 2, 1986, she died of undisclosed causes at the age of 82.
