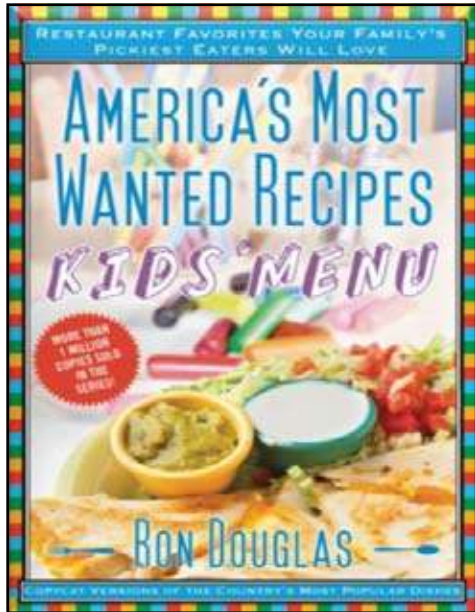

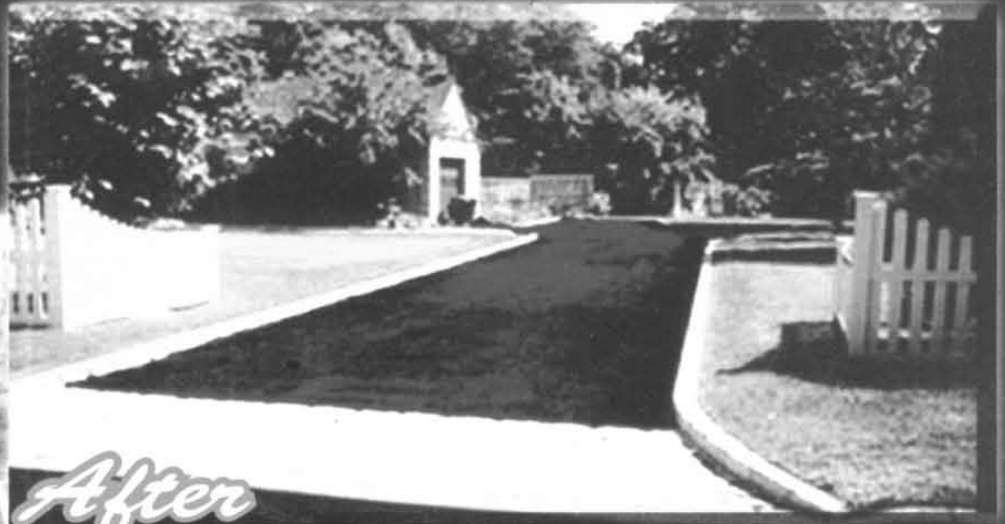

Glen Cove IAC Celebrates Social Worker Month at Glengariff

The Glen Cove IAC recently held its monthly meeting at Glengariff's Pratt Pavilion facility. Matthew Levy, Administrator of Glengariff Healthcare Center provided a brief overview of the services available at Glengariff while Eleanore Lubick, Director of Social Services provided members with important information on patient directives and discharge plans.

Mr. Levy said that Glengariff Healthcare Center serves two distinct populations – short term physical rehabilitative services at Pratt Pavilion and long term nursing care, including a special wing for residents suffering from dementia at Welwyn Pavilion. Pratt Pavilion has been fully renovated and caters to patients of all ages. Patients receive intense physical and occupational therapy. The goal is to get the patients as high functioning as possible so they can return home and get on with their lives.

Welwyn services the long-term care population and includes a secure floor for those suffering from dementia. Welwyn also hopes to offer dialysis services soon. Glengariff is in the process of building a 5,000 square foot state-of-the-art dialysis center at Welwyn that should open next year.

Eleanore Lubick discussed the importance of having health care proxies and Medical Orders of Life-Sustaining Treatment (MOLST), especially for elderly loved ones. She said that it is often difficult to bring up the subject with

the elderly, but it is important in order to make sure that their wishes are followed should they be unable to advocate on their own behalf. When making a health care proxy, it is important to give your proxy to a person who will follow your directives and make the best decisions for you. Conversely, a MOLST gives you a way to make decisions for yourself about Do Not Resuscitate (DNR) orders and Other Life-Sustaining Treatments (LST). Ms. Lubick also spoke about Glengariff's discharge procedure and the collaboration that exists between physicians and Glengariff staff to make sure that the patient has the support services and outpatient therapies that are needed when the patient returns home.

Glengariff is located off of Dosoris Lane. It has a total of 262 beds: 100 in the sub-acute care facility at Pratt Pavilion and 162 for long-term care, of which 40 are designated for dementia patients in the Welwyn facility.

The Glen Cove IAC includes community leaders representing a variety of human and social service agencies throughout Glen Cove. It reflects Glen Cove's rich cultural, religious and ethnic diversity and meets regularly to identify and address changing needs in the community. This network has resulted in numerous projects and collaborations that benefit Glen Cove residents on a daily basis. For more information about IAC, please visit iacglen Cove.org.

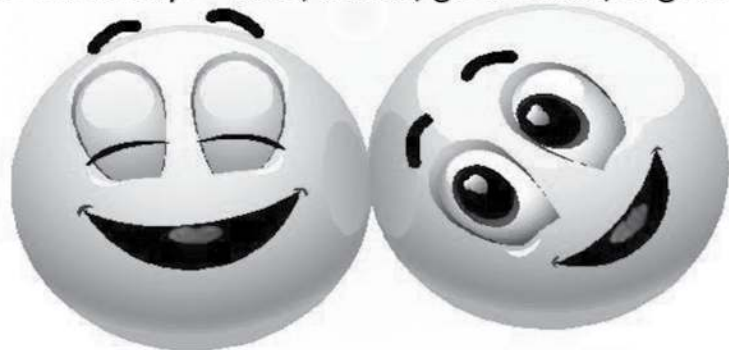

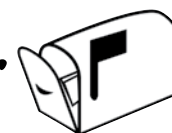

So, Why Is He Really Running?

To The Editor,

Tony Gallo certainly presents himself like a nice enough fellow. He ran for a seat on the City Council on the same ticket as Mayor Reggie Spinello. Back then, he represented himself as a team player who could be counted on to work with the new administration and support the improvements to Glen Cove that Mayor Spinello has managed to accomplish since he was elected – lots of new businesses, a cleaner city, an improved work force, a popular community garden – yep, all sorts of good things. And all of these things have been accomplished not because of Mr. Gallo, but in spite of his opposition to working collaboratively with the Mayor.

Now, just a year and a half later, Mr. Gallo wants to unseat Reggie by challenging him in a primary for the Mayor's job. You just have to wonder what he's up to. Reggie has been cross-endorsed by the Republican Party, the Democratic Party, the Independence Party and the Conservative Party because he's doing a great job. So what is it that Mr. Gallo knows that everyone else doesn't?

When he first announced his intention to run an insurgent campaign, Mr. Gallo declared that he went into politics because (1) government took parking spaces away from his father's fruit store on Cedar Swamp Road when the street was improved, (2) he loves Glen Cove and that's why he should be its mayor, and (3) he's "all about transparency."

Well, if he ran for office because of the lost parking spaces, you have to wonder why he didn't run for the County Legislature. Didn't he know that Cedar Swamp Road is a county road and it's not maintained by the City of Glen Cove?

As to his love of Glen Cove, is he suggesting that the guy he wants to toss out of office doesn't love Glen Cove? Is that what he's really trying to imply - that a guy who was born and brought up here and who can afford to live anywhere he wants, but chooses instead to live in Glen Cove, doesn't love it?

And about "transparency" in government, who isn't for it? I've been around here for almost 40 years and no previous mayor before Reggie has had City Council meetings streamed to the public so you can watch them on television. No other mayor has regularly put out more information on what's happening in the city government than Reggie. No other mayor has been more accessible than Reggie. In fact, no other mayor has been as successful in the job as Reggie.

So, to sum it up, if you want to run for public office, there needs to be some rationale, or reason, for why you think you should have the job. Either the guy in office is not doing a good job or you think you can do it a lot better. But you need a reason for running. Right now, running

because of parking spaces, love for Glen Cove and being "all about transparency" doesn't add up to a reason.

Maybe in due course, Tony Gallo will choose to explain to voters why he's really running for Mayor. So far, he hasn't done that and until he does his candidacy just doesn't make any sense.

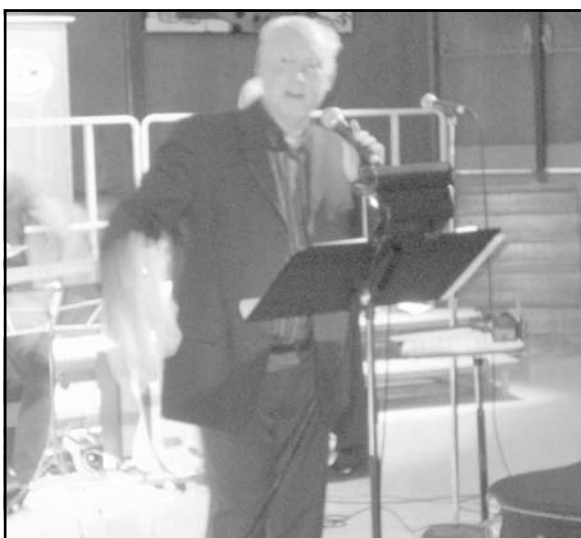

Last Week's Celebrity

For over two decades, last week's celebrity, Porter Hall (born Clifford Porter Hall), made a career out of playing villains and pompous, unpleasant people. His movie career was not a mirror of his real life, however. Mr. Hall was well known as a generous and outgoing person who was well-liked by almost everyone he knew. It was ironic, since he was a deacon in his own church, that one of the roles he is most often seen in today is that of an atheist in "Going My Way" (1944) with Bing Crosby, Barry Fitzgerald and Frank McHugh. He was active on Broadway from 1926-1934. He was in the original cast production of "The Great Gatsby" in 1924. In films, he was one of the senators in "Mr. Smith Goes to Washington" with Jimmy Stewart and "Jason Maple" in "The Petrified Forest" (1936) with Humphrey Bogart, Leslie Howard and Bette Davis. As "Herbert MacCauley", he was the "The Thin Man's" accountant, in the movie of the same name, starring Myrna Loy and William Powell. A little point of interest, "The Thin Man" was not William Powell's character, private detective "Nick Charles", as so many people think he was, but the character "Clyde Wynant" played by Edward Ellis. As for our celebrity, Hall who didn't make his first movie until he was 43, remained active until his death from a heart attack on Oct. 6, 1953, at age 65.

So many of our celebrities get to be celebrities because of the tremendous talent of journalists, authors and screenwriters, such as our celebrity this week. On her return home, she was hired as a writing assistant, an actress and general assistant by Lois Weber Productions, a film company owned and operated by pioneer female director, Lois Weber. Weber has been credited as pioneering the use of the split screen technique to show simultaneous action in her 1913 film, "Suspense", an early Lon Chaney Sr. film. Our celebrity was often cited as the most renowned female screenwriter of the 20th century alongside June Mathis, remembered for discovering Rudolf Valentino and Anita Loos, author of "Gentlemen Prefer Blondes". She was the first writer to win two Academy Awards. One Oscar was for Best Adapted Screenplay in 1930, for one of the first prison films, which was also nominated for Best Picture, "The Big House" with Chester Morris, Wallace Beery, Lewis

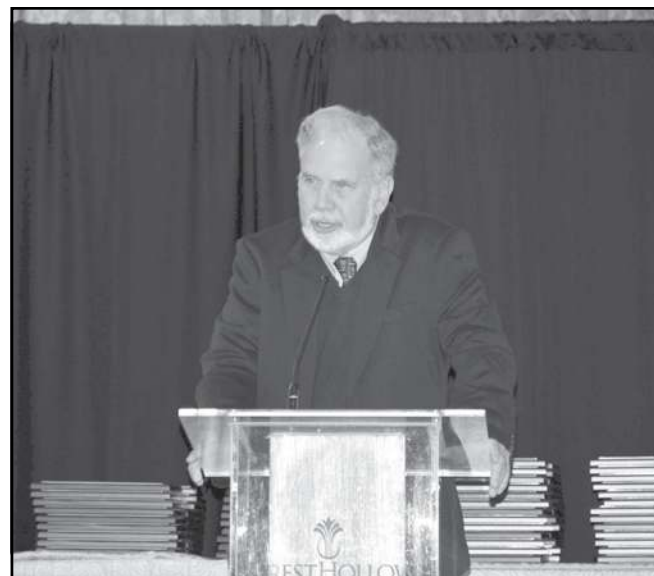
"You have a great obligation to use your talents and to expand your great gift of intelligence," he said.

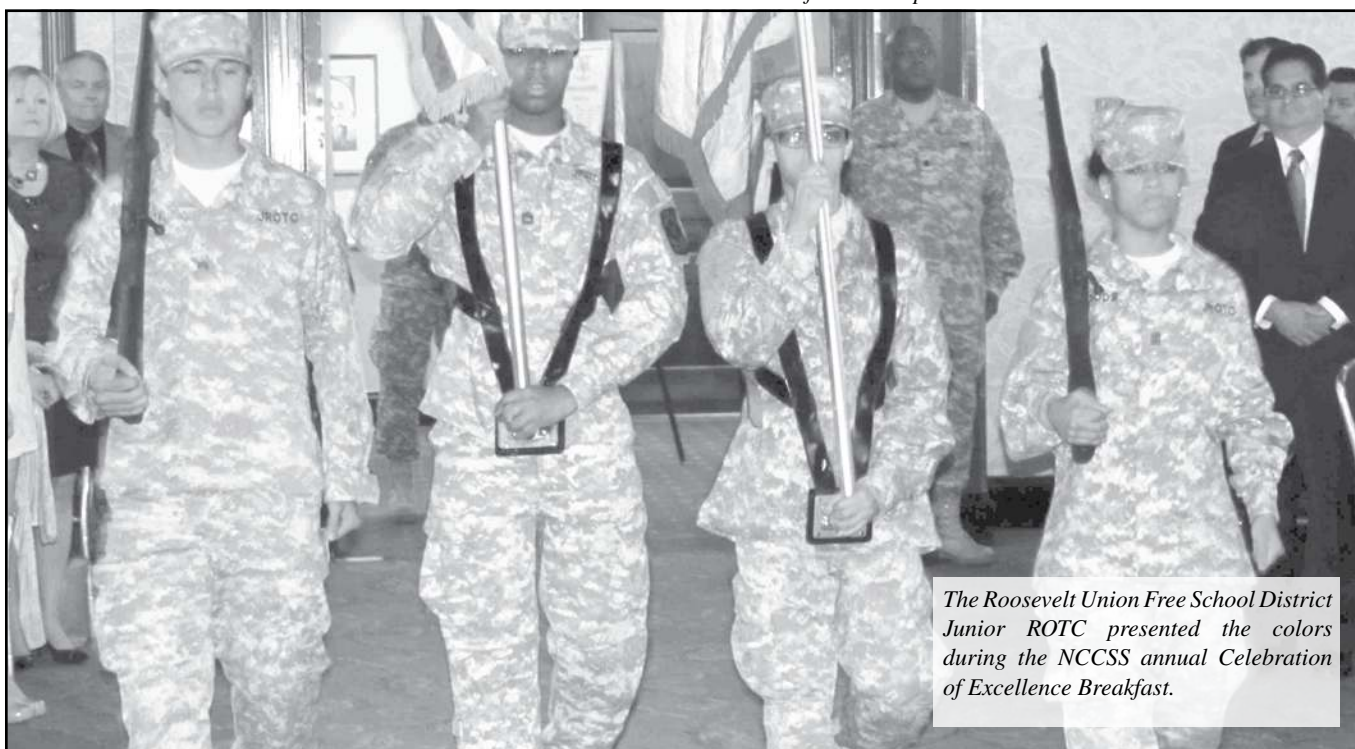
