Community Mourns Neice

The Sea Cliff community lost a dear friend, activist and volunteer with the passing of Peggy (Murray) Neice on June 2, 2015. Peggy a long-time resident of Sea Cliff was born in Glen Cove 1939. Peggy married Edwin "Brud" Neice in 1963 (who passed in 1997) and settled into life in Sea Cliff. As the wife of a Sea Cliff Fire Department Chief and Chief of the Sea Cliff Auxiliary Police, Peggy was often on the scene at community events or in time of crisis and was among the first to pitch in and lend a hand, always with a smile on her face.

Peggy was an active member of the community and during the late 1970's she was a certified CPR instructor and traveled all over Long Island with a small group from Sea Cliff teaching for over 10 years. In the early 1980's Peggy began volunteering for Long Island Riding for the Handicap, an organization designed to help children and young people with varying degrees of physical challenges master the ability to ride horses. Peggy loved seeing the smiles and accomplishments of those riders struggling to do what most take for granted. Peggy went on to become the Volunteer Coordinator for LIRHA and was an integral part of the organization for over a decade.

As a long-time resident and 'family' of the Fire Department, Peggy was a natural fit to be one of the first (and last active) charter member of the newly formed Fire Medic Unit formed in the early 1990's. She went "back to school" in 1994 and received her certification as an E.M.T. Eventually Peggy served as 2nd Lieutenant, 1st Lieutenant and Captain of the Fire Medic Unit. She was a dedicated and respected member of the unit, known for her compassion and bedside manner assisting hundreds of residents over her

25 years of service in the Department. Peggy received many honors and awards over the years, including; Fire Medic of the Year, Firefighter of the Year in addition she also received the prestigious White Cap Award.

She was also a dedicated volunteer for meals on wheels as well as junior guild and in early years a den mother to her son Kenny's boy scout troop. She attended St. Patrick Elementary school and graduated from Glen Cove High School.

Peggy is survived by her son, Kenny and his wife Joanna (Keenan), her daughter Elaine and her grandchildren, Drew Davies and Abigail Neice.

The following is an excerpt from the Eulogy presented by her daughter Elaine at her funeral.

.....
You're all here because you knew our mom in some way, family, friend, neighbor. Some of you may have known my mom forever and some just a short time and some maybe really not at all. Over the last couple of days Kenny and I have heard stories from people about ways in which our mom had an impact on them; especially her calmness and bed-side manner as a medic and the 25 years she served the village in the Medic Unit is pretty cool for a little 'ol Nana..... Over the last few weeks I've had to go looking for things of my mom's and I've come across little things she left behind. Words she couldn't say out loud she left for us to find, reassuring us that she loved and cared for us all. I'd like to share some with you...

In a poem book I came across this with her tick mark beside it;
 What mean you by this weeping
 To break my very heart?
 We are both in Christ's keeping,
 And therefore cannot part
 You there, I here, though parted
 We are still at heart are one;
 I only just in sunshine
 The shadow scarcely gone.
 What though the clouds surround you,
 You can the brightness see,
 'tis only a little way
 That leads from you to me.
 I was so very weary
 Surely you would not mourn.
 That I a little sooner
 Should lay my burden down.
 Then weep not, weep not
 God wipes away all tears
 'tis only a little way
 Though you may call it years.

We thank you all for being part of her life and we ask all of you that knew my mom to share the stories, the funny moments and the laughter. Even if they make us cry because there will be laughter through the tears and that is what the Murray family did – they laughed. The stories are all we have left for our children and I know that I plan on telling them all.

Wednesday, June 24 was Hawaiian Day in Glen Cove. The virtual trip to Hawaii started at the Glen Cove Senior Center early in the morning. Arriving seniors were greeted by the sight of the Center decorated in a Hawaiian motif. In the lobby was a large mural of a parrot and a toucan; the tables sported colorful tropical tablecloths. The Regency provided the seniors with coconut-breaded shrimp and a piquant dipping sauce to enjoy with morning coffee or tea.

Many seniors were decked out in Hawaiian shirts or stunning mumus. Upon entering the dining room, decorated with tikis, tropical fish, palm trees, a hula girl and a fire dancer, every senior was given a lei to place around his/her neck. Some fashioned their garlands into floral headdresses that encircled their heads.

At lunch diners were treated to a luau of Hawaiian chicken and pineapple. As the seniors dined on a delicious meal, scenes of Hawaii, from Pearl Harbor to Maui to the Volcanoes of the big island, were projected on a large screen. After feasting, those gathered viewed a video of Hawaiian dancers prior to the beginning of the real show.

Jenny introduced Olivia Iolani Meyers, founder and dance instructor at the Dance Aloha Hula in Melville. Olivia, a native Hawaiian from the island of Oahu, took the audience on a fanciful journey to the sunny and enchanted 50th state through folk lore, music and dance. Joining Olivia were dancers Nani Loa and Anela. With hips gently swaying, the dancers used hand gestures to tell stories of the islands, its people and Hawaiian culture. Authentic musical instruments, such as rattles, gourds and pu'ili sticks, were accompaniments to the various dances. The dancers performed to many familiar tunes, like "Blue Hawaii," "Tiny

Bubbles," "A Little Grass Shack" and to several traditional Hawaiian songs.

Olivia asked for a male volunteer to join her and, by popular demand, Joe Cusimano graciously stepped forward. With Joe seated on a chair, Olivia performed a seductive courting dance to "My Tropical Baby." Then Joe joined Olivia in swaying sensuously and rhythmically to the song. Following this dance, Olivia solicited volunteers to participate in a hula lesson. Each participant was then dressed in a brightly colored hula skirt and after a quick lesson, the volunteers performed a dance, with appropriate hand movements, to "We're Going to a Hukilau," a song about fishing. Nani Loa, Anela and Olivia made dancing the hula look easy, but our hula-dancing seniors will readily admit that it is quite difficult to rotate your hips in various directions to the beat of the music while telling a story with your hands.

The performance concluded all too soon for the seniors who were having a fabulous afternoon at the luau. Olivia, Nani Loa and Anela received thunderous applause from a most grateful audience. The program, the final Lifelong Learning presentation of the season, was a celebration of Hawaiian culture organized by Jenny Weiss, Activities Director, and volunteer Sharon Collins who made the decorations and the slide and video shows.

After the performance at the Glen Cove Senior Center, Olivia and her Aloha Hula Dance troupe headed off to the Regency for another luau performance. Several members of the Senior Center followed the performers to the Regency to enjoy another wonderful program by Dance Aloha Hula. At the Regency Olivia, Nani Loa and Anela were joined by young Olana, who, although a teen, is quite an

adept and awesome dancer. The Regency prepared a tropical fruit punch, cake and a mango sorbet for the residents and guests. The program at the Regency was different than that of the Senior Center, but just as entertaining and informative. Mahalo, Olivia, the Dance Aloha Hula

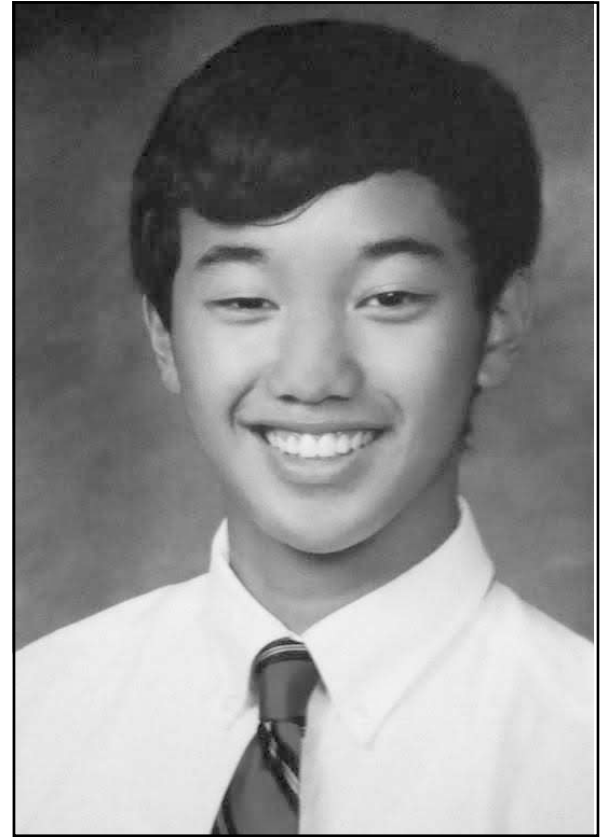

Waves of Progress for City of Glen Cove Waterfront Project Momentum Builds as Multi-Million Dollar Remediation Work Nears Completion

“The Glen Cove Waterfront is a continuing story about reclaiming our City’s destiny to be a vibrant waterfront community, a destination for work, leisure and recreational enjoyment and a tax revenue generator for the City,” said Glen Cove Mayor Reggie Spinello.

After over two decades of undertaking one of the most ambitious remediation projects on Long Island and within New York State and investing over \$100 mm of public money, the City has reached a critical progress point for the future development of the Glen Cove Waterfront. “We are bringing back 56 acres of a blighted Superfund property and restoring it to be prime waterfront land that is very livable, marketable and one day soon, will become home to a new group of Glen Cove citizens,” added Mayor Spinello.

Driving down Garvies Point Road progress can be seen as Glen Cove’s industrial past has been cleaned up to open the door for Glen Cove’s future. Vertical construction has begun on Glen Cove’s Ferry Terminal, Garvies Point road reconstruction is set to begin before years end, and the final phases of remediation are in motion. Mayor Spinello, the Glen Cove City Council along with local boards and agencies continue to work with the Garvies Point

redevelopment team to ensure that there are a complement of public amenities and benefits for Glen Cove residents to enjoy.

Listening to the needs of the Glen Cove community and answering the hard questions, Mayor Spinello has aggressively sought modifications to the Garvies Point master development plan by ensuring public access to all of the over 29 acres of open space and public amenities, reducing density of residential housing by reducing the number of buildings on the waterfront and the gross square footage of the development, eliminating the building of a hotel, and most importantly, increasing the acreage for open space and public amenities that will include a public waterfront esplanade, marinas, parks, water recreational activities, playgrounds, an amphitheater and a new restaurant at the tip of Garvies Point, more parking and connectivity to downtown Glen Cove. “This is a Win-Win situation and a good example of a Public/Private interests working together to revitalize a Superfund site, realize tax revenues for the City of Glen Cove and our school district, spur economic growth, provide residents with new jobs, offer public access to great new amenities and business opportunities,” said Mayor Spinello. “Without the good

faith of RXR, this project would have died and Glen Cove would be faced with barren lands, abandoned buildings and a blighted area that would continue to be a tax burden to our residents.”

“While much has been invested over the past 20 years to get us to this tipping point on the Waterfront Project, there is still substantial investment needed because of the costs involved in a Superfund site that requires public infrastructure, utilities and continued remediation,” said Mayor Spinello. Years ago this project started out with the belief that government would pay for the clean-up costs but obviously that is no longer the case noted Mayor Spinello. Today, with eight Brownfield sites, approximately \$30 mm to reconstruct and improve Garvies Point/Herb Hill Road (the main access roads to the Waterfront), and the cost impact dictated by New York State Department of Environment Conservation on the remediation and design of the site, to continue the Waterfront’s progress, new financial solutions are being pursued.

To fund the next evolution of the Waterfront’s development, the City is exploring Tax Incremental Financing (TIF). TIF is an innovative economic development tool that creates funding for projects by borrowing against the future

property tax gains of a development. TIFs are a public financing method used for redevelopment projects in blighted areas and are used as to subsidize infrastructure costs while increasing tax revenues and instigating positive economic development. “A TIF offers the City of Glen Cove a potential non-recourse solution to make the vision of Glen Cove’s Waterfront a reality and the City would realize tax benefits on day one,” said Mayor Spinello. “While there is zero risk involved for residents since the City would not assume financial responsibility for the repayment of the loan and the benefits to our community are tremendous from an economic viability perspective (e.g., monies will be paid first for all essential government services) we will not move forward unless this makes smart economic sense and the City comes out in a strong financial position,” added Mayor Spinello. Mayor Spinello and the Glen Cove City Council have officially started the TIF public review process, which will involve review by the Planning Board, School District, and Nassau County, as well as a Public Hearing by the City Council. The City anticipates making a decision by late summer.

The ride begins at Tappen Beach in Sea Cliff. On Saturday, June 28th, bikers from the tri-county area took the challenge. With helmets on, water bottles filled, and maps in hand, bicyclists began the ride that is touted as the “Best Ride on Long Island.” Whichever course is chosen: 25, 56 or 66 miles, the extremely well marked ride provides beautiful scenery along the roads of Long Island’s magnificent North Shore.

The Sea Cliff community lost a dear friend, activist and volunteer with the passing of Peggy (Murray) Neice on June 2, 2015. Peggy a long-time resident of Sea Cliff was born in Glen Cove 1939. Peggy married Edwin "Brud" Neice in 1963 (who passed in 1997) and settled into life in Sea Cliff. As the wife of a Sea Cliff Fire Department Chief and Chief of the Sea Cliff Auxiliary Police, Peggy was often on the scene at community events or in time of crisis and was among the first to pitch in and lend a hand, always with a smile on her face.

Peggy was an active member of the community and during the late 1970's she was a certified CPR instructor and traveled all over Long Island with a small group from Sea Cliff teaching for over 10 years. In the early 1980's Peggy began volunteering for Long Island Riding for the Handicap, an organization designed to help children and young people with varying degrees of physical challenges master the ability to ride horses. Peggy loved seeing the smiles and accomplishments of those riders struggling to do what most take for granted. Peggy went on to become the Volunteer Coordinator for LIRHA and was an integral part of the organization

for over a decade.

As a long-time resident and 'family' of the Fire Department, Peggy was a natural fit to be one of the first (and last active) charter member of the newly formed Fire Medic Unit formed in the early 1990's. Over the last couple of days Kenny and I have heard stories from people about ways in which our mom had an impact on them; especially her calmness and bedside manner as a medic and the 25 years she served the village in the Medic Unit is pretty cool for a little 'ol Nana.....

"Over the last few weeks I've had to go looking for things of my mom's and I've come across little things she left behind. Words she couldn't say out loud she left for us to find, reassuring us that she loved and cared for us all. I'd like to share some with you...

"In a poem book I came across this with her tick mark beside it;

*What mean you by this weeping
To break my very heart?*

*We are both in Christ's keeping,
And therefore cannot part
You there, I here, though parted
We are still at heart are one;
I only just in sunshine
The shadow scarcely gone.
What though the clouds surround you,
You can the brightness see,
'tis only a little way
That leads from you to me.
I was so very weary
Surely you would not mourn.
That I a little sooner
Should lay my burden down.
Then weep not, weep not
God wipes away all tears
'tis only a little way
Though you may call it years.*

We thank you all for being part of her life and we ask all of you that knew my mom to share the stories, the funny moments and the laughter. Even if they make us cry because there will be laughter through the tears and that is what the Murray family did – they laughed. The stories are all we have left for our children and I know that I plan on telling them all.

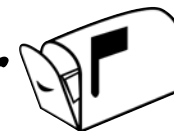

After listening to accolades to the city on little league baseball play this season at a recent City Council meeting, I believe it is time to set the record straight on the exclusion of Glen Cove Junior Baseball/Softball from utilizing our city fields this year.

Glen Cove Junior Baseball/Softball had a long standing tradition for over 60 years in promoting the sports of baseball and softball to thousands of young Glen Covers.

However, this past year, primarily through the efforts of Mayor Spinello and Councilman Mike Famiglietti, the venerable 501C3 organization led by dedicated volunteers were asked to finish the 2015 season during a transitional period for a new group to take over in 2016. The organization was also informed that their field use permit would not be renewed in 2016.

I have been hearing recent arguments that the organization refused to open its financial records to the Glen Cove Recreation Commission for review. Glen Cove Junior Baseball/Softball was willing and ready to open its financial books for scrutiny.

The organization did not raise its permit fees the last several seasons to give young players and their families regardless of race, color, nationality or creed, the affordable chance to meet new friends and develop sportsmanship.

I also feel it is disingenuous that Mayor Spinello and Councilman Famiglietti complained about Glen Cove Junior Baseball/Softball performance last season and at the same time accept a \$23,800 check for 2013 and 2014 for field lighting from the group after last summer's successful Mayor's Trophy tournament.

Last year's Mayor Trophy tournament drew about 100 teams from Nassau, Suffolk, Queens and Brooklyn for its exciting tournament play.

Lastly, our City Attorney Charles McQuair remarked to me several months ago that the board members "were tired and burnt out". Charlie confirmed that the city was willing to give the organization a permit for one more season and break in another group to take over.

Charlie, I am sorry to tell you making

that offer to any organization would be an insult to their efforts and goodwill. Our Glen Cove Junior Baseball/Softball board members deserved the opportunity to continue their good work and retire when ready with dignity and grace.

Name the Celebrity



This week's celebrity, a radio, film and Broadway actress, was born on Nov. 6, 1904, in New York City, to an actress and a playwright. At one time, her mother recounted, in a newspaper article, that she used to take our celebrity along with her to Broadway play rehearsals and performances. One night, the then seven year old went missing. While the mother frantically searched for her, holding up act two, the audience became restless. The youngster finally turned up. She had gone on stage, dressed up in her mother's act two costume and made a bow, much to the audience's amusement. Our celebrity later remarked, "And that is the first time I was ever on stage and I like it so well, I stayed."

She turned to acting despite the objections of her parents. Nonetheless, her father wrote the 1921 Broadway play, "Lancelot and Elaine" to provide both her and her sister, Josephine, with their professional roles as "Guinevere" and "Elaine", respectively. Eventually, she landed a part on her own, in the 1923 Theatre Guild production of "Peer Gynt" and became a respected Broadway actress. She made her one film of the 1930s, in "Misleading Lady" (1932) with Claudette Colbert and Edmund Lowe. She also played "Mrs. Alleta Sullivan", the mother, in the 1944 American biographical war film, "The Fighting Sullivans" with Thomas Mitchell and Anne Baxter. Originally, released as "The Sullivans", it was nominated for the now-discontinued Academy Award for Best Story. It was the true story about the lives of the five Irish-American Catholic Sullivan brothers. They grew up together in Waterloo, Iowa during the days of the Great Depression and served together in the U.S. Navy during WWII. They enlisted on Jan. 3, 1942 with the stipulation that they serve together. They all were tragically killed, in the Pacific Theater,

aboard the light cruiser USS Juneau, sunk on Nov. 13, 1942, during the Naval Battle of Guadalcanal.

A little historical diversion in honor of our celebration of our country's freedom and for those who fought for it, ...the death of the five Sullivan brothers was impossible to imagine. So horrible, it forced the U.S. War Department to adopt "The Sole Survivor Policy", so it would never happen again. The Navy named two destroyers, a DDG-68 and a DD-537, "The Sullivans", to honor the brothers. These were the first American Navy ships ever to be named after more than one person. The motto for both ships was the very motto of the Sullivan brothers, "We stick together." This movie inspired, at least in part, the 1998 film, "Saving Private Ryan."

LAST WEEK'S CELEBRITY

Last week's celebrity was Helen Vinson. Her screen career often featured her in roles in which she played the part of the other woman or pre-Code loose women with active romantic lives. Her first film was "Jewel Robbery" (1932), which starred William Powell, as the suave, charming jewel thief and Kay Francis, as the bored housewife. She appeared as "Doris Delafield" in "The Kennel Murder Case" (1933), which also starred Powell again as "Philo Vance." Another performance was in the RKO film "In Name Only" (1939) in which she was cast as the treacherous friend of Carol Lombard, Kay Francis and Cary Grant. Another stand-out role for Vinson was an undercover agent posing as a femme-fatale opposite Richard Cromwell in Universal Pictures' anti-Nazi action drama entitled, "Enemy Agent" (1940). After 27 films, she brought her film career to an end in 1945, appearing with her first male lead from 13 years earlier, William Powell, in "The Thin Man Goes Home." She left film making to enjoy many trips to NYC Broadway shows, numerous Mardi Gras visits to New Orleans and her life long passion of horse-back riding, especially on her personal mount, Arrabelle. On Oct. 7, 1999, she died at the age of 92, in Chapel Hill, North Carolina, her beloved "horse country".

 I can't wait to hear Jenn perform Friday too, and I do have a book to recommend- a fascinating historical/literary mystery set in 1840's Dublin: THE CONVICTIONS OF JOHN DELAHUNT by Andrew Hughes. Hughes is a social historian and archivist who became intrigued with the story of John Delahunt, a convicted murderer who was hanged before a mob of 10,000 angry Dubliners in 1842. The

novel is written in the first person of Delahunt, a poor young Trinity College student who becomes a paid informant for the brutal secret police of the time- "the Castle." Hughes paints a shockingly vivid portrait of Victorian Dublin with its teeming tenements, squalid public houses, corrupt police officials, and doomed politicians- all presented through the eyes of the sociopath Delahunt. The book opens as he prepares to be hanged for a horrific murder and decides to recount for the events that brought him to this moment. Recommended and highly recommended if you are as intrigued as I am by Irish history!

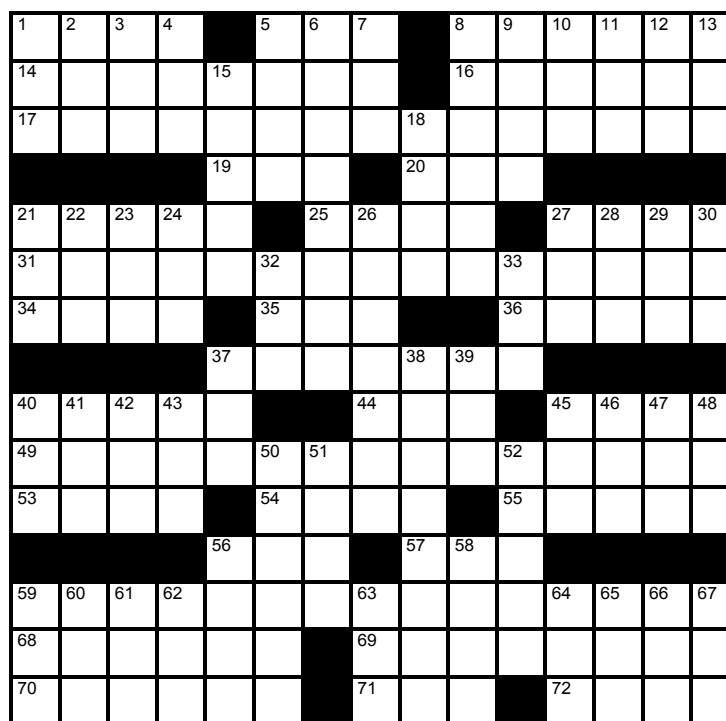

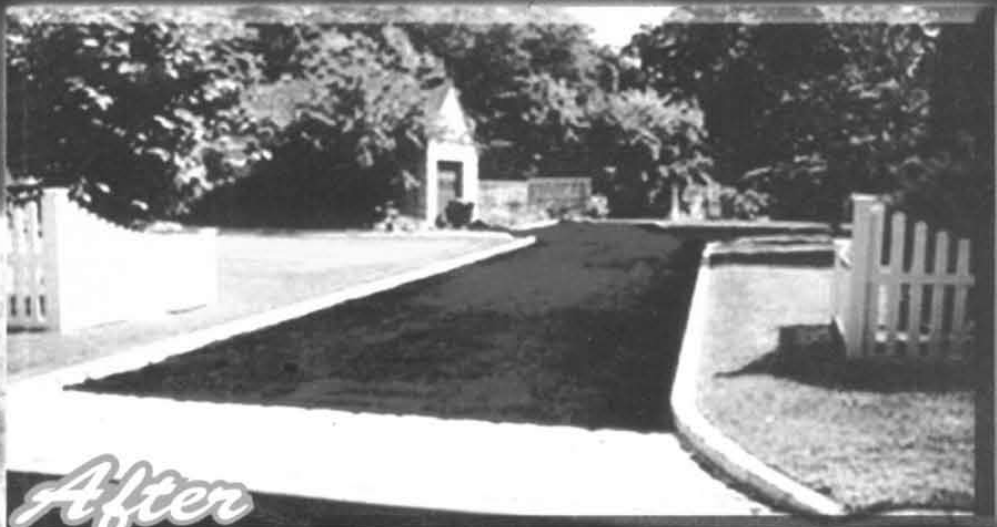
