Local Father and Son Dedicate Decades to a Grand Old Dame of the Sea

Glen Cove resident Mike Emmert learned a lot from his father, Rich. He learned woodworking, he learned to sail, he learned self reliance and he learned to never give up. Forty three years ago Rich Emmert, of Glen Head, saw a 1937 wooden yawl named Golden-Eye in need a desperate repair, but he also saw a classic Phillip Rhodes one design that had a great pedigree and worth saving. So in 1972 he bought the boat and dedicated the next nine years rebuilding and reviving Golden-Eye from bow to stern, from mast top to bottom. Rich had just read about a new process of fibreglassing the hulls of wooden boats. A pioneer in the art, he made the craft once again sea worthy. In 1981, Golden-Eye was relaunched, 100 percent restored.

And so began the long bond between the Emmert family and sailing. As school let out each spring, the Emmert's weighed anchor and sailed from the Canadian boarder to the southern edge of the Chesapeake, up and down the east coast. Sailing all summer, the family usually arrived back in Glen Head just in time for the school term to begin. Mike started skippering at 16 and has been

Glen Cove Youth Bureau Receives Laptop Donation from Comp4Kids Computer will be Used to Increase Student Accessibility to Technology

The Glen Cove Youth Bureau recently received 90 newly refurbished laptop computers from Comp4Kids, a 501(c)(3) charity that collects and refurbishes used computer equipment. The laptops will be used by students who attend the Glen Cove After 3 program or participate in programming at the Glen Cove Youth Bureau, thus allowing them to work on school projects and increase their computer skills. The Youth Bureau will also collaborate with the Glen Cove Library to assure that all students in Glen Cove have access to technology for educational purposes.

Jon Zimmerman, a Great Neck Middle School science teacher presented the laptops to Arlene O'Dell, Executive Director of the Glen Cove Youth Bureau. Mr. Zimmerman, founder of Comp4Kids, is a previous recipient of Nassau BOCES Education Partner of the Year Award which he received in recognition of his charitable work serving the students of Long Island.

Over the past year, the Glen Cove Youth Bureau increased its emphasis on improving the computer skills of Glen Cove youth, thus preparing them for success in their future endeavors.

Thanks to a generous donation from Nassau County Legislator Delia DeRiggi-Whitton, the Youth Bureau was able to purchase ten iPads for use in the

Glen Cove After 3 (GCA3) enrichment program. With the proceeds from a grant from the Verizon Foundation, the students learned how to create Apps for the iPad. Students in the GCA3 elementary school program created an App that explores fun family activities in the Glen Cove area while middle school students are creating an App to help local food pantries meet the nutritional needs of their clients.

Library and Halm Industries Agree on Purchase of Property Dependent Upon Public Approval

The Gold Coast Public Library Board of Trustees and the owners of the Halm Industries property have agreed to terms for the prospective purchase of the Halm property, located at 180 Glen Head Road. The purchase is contingent on a public referendum that would consist of the \$5.7M to purchase the property plus the costs for building a new library on the site. Building costs as well a date for the referendum have yet to be established.

After ten years in its original location, the facility no longer meets the needs of the community and has become increasingly inefficient to run. The site sits between Glen Cove Drive, the American Legion Post 336, the Town of Oyster Bay Community Center and the community's much-used sports fields.

"Since the Library's first informational mailer in December, the Library Board and Director have welcomed feedback from our residents while we continue to develop plans for consideration," said Nancy Benchimol, President of the Library's Board of Trustees. "It is clear that the community values the Library and wants more from it. The first design focus groups this spring, with more to follow, will form the foundation for draft design plans. Anyone with ideas to share

will certainly still have opportunities to participate."

The Library is working with KG&D Architects of Mount Kisco, NY on the proposed design. KG&D has extensive experience in the design of public libraries including the West Hempstead Public Library and Great Neck Public Library as well as school libraries in Pleasantville, Brewster, Seven Bridges and White Plains.

"With negotiations completed and the contract signed, now we can have a detailed dialogue with our fellow residents so that we can all make well-informed decisions," said Benchimol.

The Library will publish a schedule of community presentations. Additionally, a website dedicated to the building project, www.thenewgoldcoastpubliclibrary.org, will provide the community with up to date information.

sailing and racing ever since.

People told Mike not to race Golden-Eye; she was too old, too heavy and couldn't compete with these modern day all fiberglass boats. Mike's goal was to prove them wrong. In 2003, he started entering Golden-Eye in The Around Long Island Regatta, an annual 190 mile race run each year by the Sea Cliff Yacht Club. He entered again in 2005, and in 2009 and every year since. Against some of the biggest and best boats on the Sound, Golden-Eye has won first overall in the non-spinnaker division in 2010. She has won class honors in 2012 through 2014.

Golden-Eye has not only been successful locally, she finished 3rd in the 2006 Heineken Regatta in St. Martin besting over 200 other boats. In Antigua, she finished 2nd overall in the 2011 Antigua Classic Race Week, the most prestigious wooden boat regatta in the world.

Rich, now retired, and Mike, president of Golden-Eye Construction, his own construction company specializing in home renovations and rebuilds as well as new construction, have done 100 percent of the refurbishing and maintenance on Golden-Eye over the years. Mike states, "The craftwork on the boat has taught me a lot about construction and attention to

detail. My shipwright skills has elevated my work for our clients, all instilled in me by the work ethic taught to me by my father".

On July 30th, father and son will once again sail in the 39th Around Long Island Regatta. Rich as helmsman and Mike as tactician, they will circumnavigate Long Island defending their title and look to finish first across the Glen Cove

breakwater, bringing their grand old lady, and still a champion, back to their home port.

To The Editor,

A letter appeared in this paper last week entitled, "If it were true . . ." It's authored by a fellow who says he is a current member of the Glen Cove Y Advisory Board. He challenges facts alleged in an earlier letter to the editor from a former member of the Glen Cove Y Advisory Board who was among the group that criticized the Board's parent entity, the Long Island Y, and then got rewarded with a summary dismissal from the Board for complaining.

What's so significant about this latest salvo in the war between the disputing parties over the failure of the Long Island Y to get a lease extension for its Glen Cove facility is not what it says, but what it doesn't address. If you read between the lines to see what's missing, you'll notice that there is no discussion – none at all – by this Long Island Y supporter which suggests that Mayor Reggie Spinello has any role to play in the Great Lease Extension Debate. In his letter, this current Board member says, "Personally, I cannot begin to fathom the motivations of those who are spreading misinformation . . ." Exactly!! That's precisely what the Mayor's political opponents have been doing all along. Spreading misinformation.

Mayor Spinello's current political opponent, Tony Gallo, who insists that the Mayor is doing a lousy job that he (Mr. Gallo) could do better, has been among the critics who insist that Mayor Spinello should have intervened in a matter where he was not invited. Mr. Gallo says that if he were Mayor, he would have "mediated" a resolution of the Glen Cove Y lease brouhaha. After graduation, Desirae worked as an Assistant Teacher at Hickory Hill Day School in Plainview and as a Family

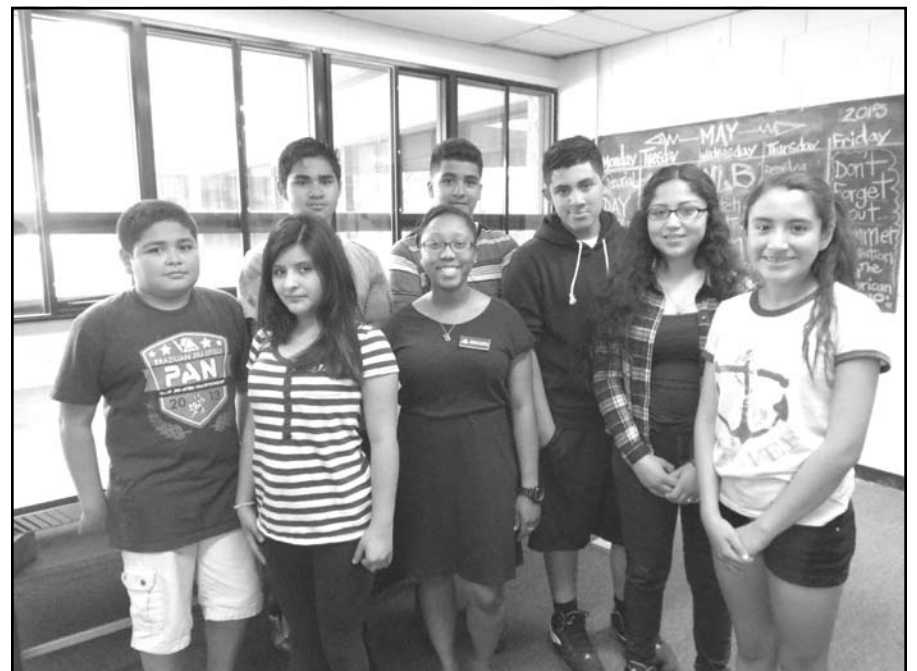

While working on "Mary Hartman, Mary Hartman". she also wrote scripts for several TV sit-coms, including "The Mary Tyler Moore Show", "Phyllis" and "M.A.S.H.", usually with collaboration with Linda Bloodworth, who later would create "Designing Women." In 1983, she had a key role in the Lawrence Kasdan ensemble piece "The Big Chill" as "Meg" with Glenn Close, Jeff Goldblum and Kevin Kline.

Last Week's Celebrity

Last week's celebrity was Selena Royle. Her body of work contained many radio shows such as the title role in "Hilda Hope M.D.", "Against the Storm" and "The O'Neills". In the 1940s, her return to film included the title character's mother opposite Ingrid Bergman as "Joan of Arc (1948)", "Miss Bliss" in the "Harvey Girls" (1946) and as Elizabeth Taylor's mother in "Courage of Lassie" (1946). In 1951, when she refused to testify about her alleged Communist sympathies before the House Un-American Activities Committee, her acting career came to a sudden standstill. She appeared in only two more films afterwards, including the low-budget "Robot Monster" (1953) with George Nader. She was also an author of several cookbooks and "Guadalajara: as I Know IT, Live IT, and Love IT". She died at the age of 78, on April 23, 1983 in Guadalajara, Jalisco, Mexico.

IAC Receives SNAP and Medicare Updates at The Atria

The Glen Cove IAC recently held its monthly meeting at The Atria in Glen Cove. Members were warmly welcomed by Kathleen Johanssen, Executive Director. The Atria has 80 apartments that are filled with vibrant folks who bring the best life experience with them when they choose to live at The Atria.

At the meeting, IAC members heard about two important programs for Glen Cove residents. First, Maritiza Quintera of the Health and Welfare Council, a 68-year old organization that assists those in need, provided members with an update on the SNAP, formerly food stamp program. Ms. Quintera said that 90 percent of seniors qualify for SNAP because they are living solely on Social Security and/or retirement benefits. Many families who pay for child care or care for an elderly loved one may also qualify. An applicant must have legal status in the United States to qualify for benefits. Ms. Quintera reminded everyone that the benefits from the SNAP program can be felt throughout the community. Not only does the beneficiary receive support; they use their benefits to buy food from local businesses which creates local jobs.

IAC members also heard from Adam Abraham of the Metro Jewish Health System. Metro Jewish Health System offers Elderplan (Medicare assistance) and Home First (managed long term care assistance). Mr. Abraham spoke about the difference between Medicare (health care program for people over 65 and for those with end stage renal disease) and

Medicaid (income-based health care program).

He encourages people to begin to explore their Medicare and long term care options before they are eligible. It is a complicated issue and it takes time to make informed choices. Metro Jewish Health System will help you through the process free of charge.

The Glen Cove IAC includes community leaders representing a variety of human and social service agencies throughout Glen Cove. It reflects Glen Cove's rich cultural, religious and ethnic diversity and meets regularly to identify and address changing needs in the community. This network has resulted in numerous projects and collaborations that benefit Glen Cove residents on a daily basis. For more information about IAC, please visit iacglencove.org.

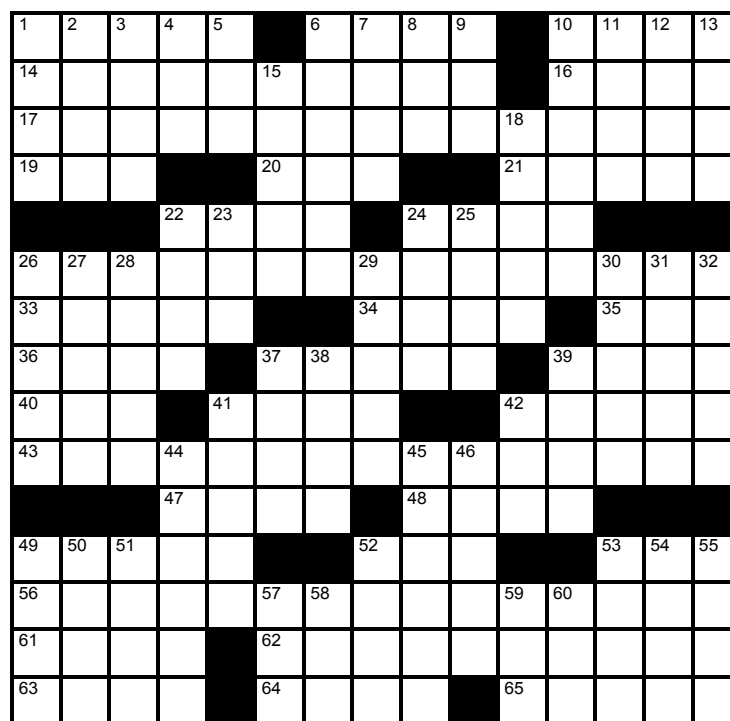

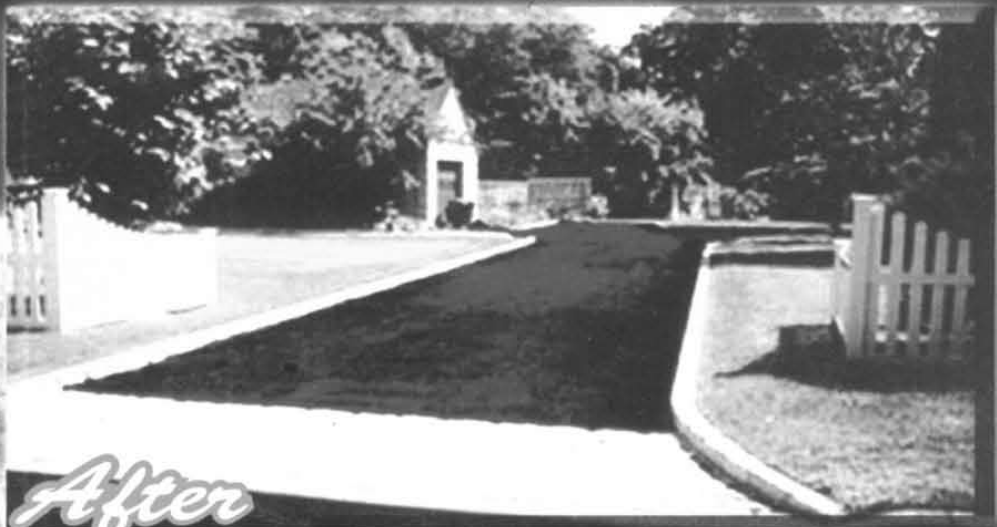

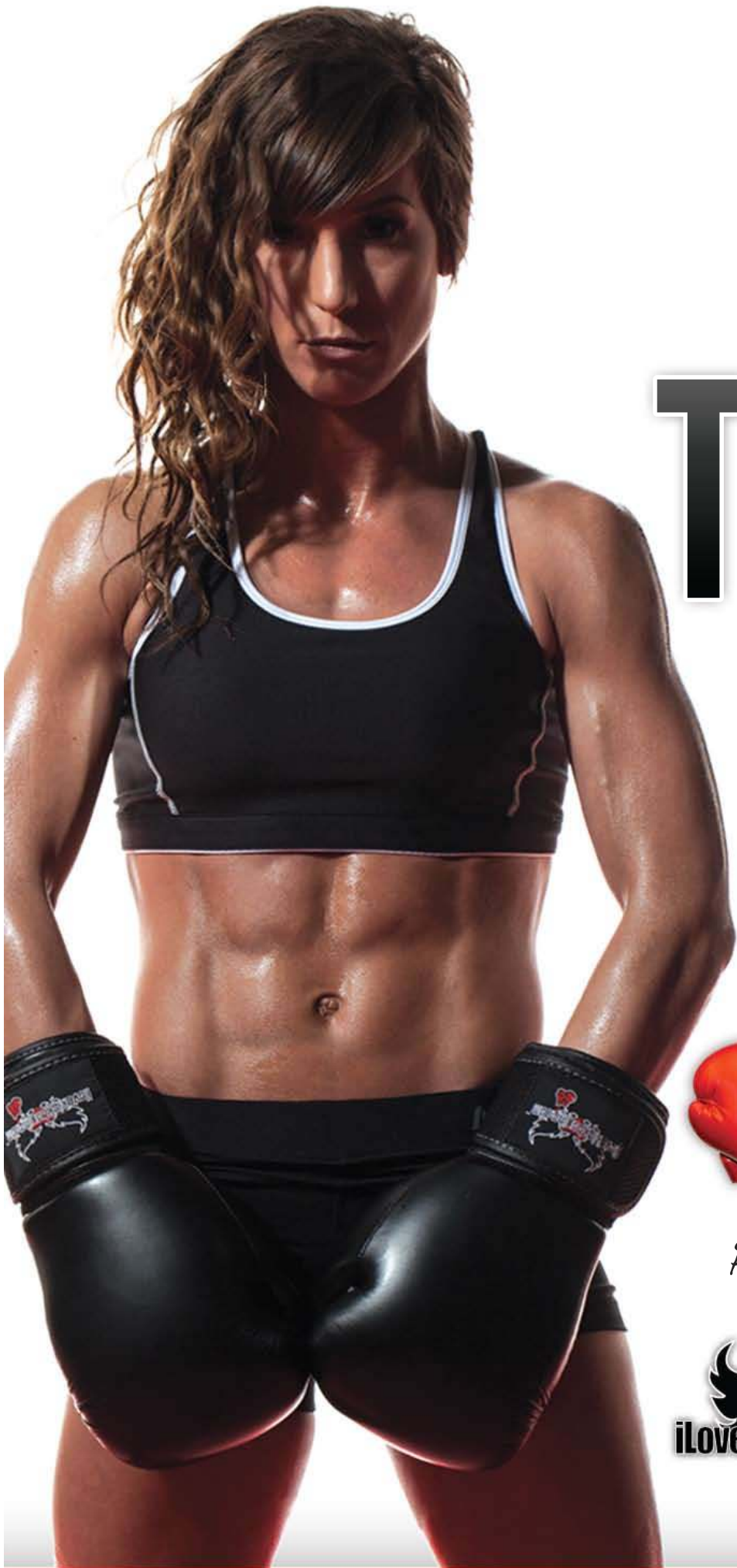
