II. Minutes:

Baldessari & Coster Contract Renewal

City of Glen Cove Memorial Day Committee Special Access Request

Personnel

The Director asks for the approval to appoint full-time senior clerk Marissa Damiano to Librarian Trainee, pending approval by the Glen Cove Civil Service Commission. Marissa has been accepted to the Information and Library Science Master's Program at the University of Buffalo's Graduate School of Education.

Building Projects

The window project has been put out to bid. Gallin-Beeler has received at least nine inquiries about the bid package. The walk-through will be held on May 23rd.

Elite has recruited two contractors to submit bids under the state contract on the flood recovery project. One of the contractor's masonry subcontractors has made us aware there is a possibility that flood hardening can be achieved with flood-proof doors for the basement entrances. Initial investigation of the roof by Elite Construction and its subcontractors points to the likelihood it will have to be torn off and replaced. Environmental testing of the roof has revealed the existence of asbestos in a small portion of the roofing materials. Abatement will be included in bids for replacement. It is hoped at this time that the process can be sped up by selecting contractors under the state contract when the time comes.

Miscellaneous

The Library will be closed on Sunday, May 29th for carpet cleaning.

V. Committee Reports

A. Petrash reported that the Friends of the Library met on May 11th. A winner of the Carol Rubin Award was chosen at this meeting. This award is given by the Friends in honor of Carol Rubin, current President of the Friends. The Carol Rubin Award is \$500 for a college-bound senior to be used for college books. Carol Rubin and A. Petrash will present the reward at the Glen Cove High School on June 2nd. The next Friends meeting is scheduled for June 8th.
