## People from Glen Cove join in the March for Life

In the early hours of Friday, Jan. 27, 2017, mass was offered at St. Patrick's Church in Glen Cove. After, a group of 80 local families, many parishioners from St. Rocco and St. Patrick, and students at All Saints Regional Catholic School, boarded two buses and headed to Washington, D.C. They were determined to participate with hundreds of thousands of other Americans in the March for Life.

The March for Life was established after the Jan. 22, 1973 Supreme Court decision *Roe v. Wade*, which recognized the constitutional right to abortion. The March advocates for the overturning of this law. Those marching were there not only to reflect upon how the decision to legalize abortion has affected the lives of so many, but to stand together to promote a world where every life is protected and valued from its natural beginning to its natural end.

"The March is an ecumenical, interreligious and nonreligious event," said Father Elias Carr, the pastor at St. Rocco Catholic Church. "It affirms the dignity of every life."

The March has evolved over the years. "During the 1970's the March was critical of *Roe v. Wade*," Carr explained. "Now

The Gemelli family held a ribbon cutting ceremony with members of the Glen Cove Chamber of Commerce and the Glen Head-Glenwood Business Association near the entrance of their store, which officially opened on Nov. 17, 2016.

The Gemelli family has operated their

business in Long Island since 1988. Their first store was a huge success in Babylon and her family hopes to emulate what she started.

## County extends deadline to accept property tax grievance

The Assessment Review Commission and Department of Assessment will accept property tax assessment grievance filings until March 10.

A video is accessible on the ARC website at [www.nassaucountyny.gov/arc](http://www.nassaucountyny.gov/arc) to guide homeowners through the property tax assessment appeal process. The instructional video, walks filers through the appeal process and demonstrates how to navigate the ARC website to access comparable sales in the neighborhood, as well as detailed information for the subject's home.

Homeowners who believe that their assessed value for the 2018-19 school and gen-

eral property tax year is too high, or property's classification or exemption status is incorrect, are encouraged to file an "Application for Correction of Assessment" with ARC before the close of the grievance filing period on Mar. 10, 2017. ARC applications can be obtained online at [www.nassaucountyny.gov/arc](http://www.nassaucountyny.gov/arc). For individuals who do not have Internet access, the application can be obtained in person at ARC, 240 Old Country Road, Mineola, or by contacting ARC at (516) 571-3214. ARC hours of operation are from 9 a.m. to 4:45 p.m. There is no fee to file the application with Nassau County.

it's a more general affirmation of the right to other things so people can flourish. The March is framed now as a more positive holistic event."

When the buses arrived in D.C., the group from Glen Cove encountered an estimated crowd of approximately 500,000 people from all over of the country, from all walks of life and from all religions. A rally was underway at the Mall where many speakers, including presidential advisor Kellyanne Conway, N.Y. Archbishop Timothy Cardinal Dolan, and Vice President Mike Pence encouraged those marching to pressure government leaders to recognize the dignity of human lives and to use our laws to protect them.

The volume of people made it difficult for the people from Glen Cove to move through the crowd to reach the Mall. So, they moved towards the beginning of where the actual march was to start instead. Joining other marchers, they peacefully walked up Constitution Ave. and past the Supreme Court building holding signs saying, "A Person's a Person No Matter How Small," "I am the Pro-Life Generation" and "Choose Life."

Being a participant in the March was a first for Luigi Greco, of Glen Cove. "It was an amazing experience, especially to see the youth marching for what they believe in," said Greco, who is a youth minister at St. Rocco's. "I told the kids how powerful the march was. They said they saw how powerful spiritually is and that they were affected by the experience."

Marilyn Johnson, who has gone to the March for many years said this year she saw more priests and nuns participating. "Everyone was very jubilant and hopeful," Johnson said. "No one cares about life anymore. They care more about animals but not humans."

There were Dominican and Franciscan friars marching, as well as elderly people and parents pushing their children in baby carriages.

"I believe that events like this are so important for our youth," said Adrianna Mendoza, a parent chaperone for the students from All Saints at the march. "To be able to take part in something that honestly allows them to take a stand united towards the future and to voice their convictions is enormously inspiring."

The theme for the March for Life was

"The Power of One." After marching many were so inspired by this theme that they decided to visit their representatives in Congress to encourage them to uphold the value and dignity of life.

"It is our patriotic duty to speak out for the most vulnerable among us who have no voice," said Kelsey McManus, who organized the Glen Cove trip. "This includes not only the unborn and the elderly, but the woman who is feeling pressured who may not know of the alternatives to abortion."

The group then visited St. Joseph's par-

ish in D.C., which held a eucharistic adoration and prayer service led by the Diocese of Rockville Centre's Bishop Emeritus William Murphy.

The day was picture perfect and one that no one will forget anytime soon.

close-knit family that we want our consumers to be a part of this as well."

Adriana, 24, works with her twin sister, Alessia, her brother, Marc, and their parents, Bob and Patrizia. The name Gemelli means twins in Italian and since Adriana has cousins who are also twins, her family thought this was a fitting name for their restaurants. Adriana's grandmother died in July 2015 and in the following months, the Gemelli family felt that opening this store was the best way to honor her.

"She would go above and beyond for the customers making sure that everyone who came into the store felt like family," she said.

Marc, 28, was happy to see that his family's hard work is paying off and that the community has embraced their restaurant. He's proud that customers in the restaurant know each other on a first-name basis and that his family is already building a strong bond with some of its residents.

"We've only been open for two months but we're already seeing repeat customers," he said. "Everyone's been super friendly and it's a great community. I think it's great not only just to come in and buy something but to also develop a relationship with people."

Local resident, Catherine Scarola, has occasionally visited the market since its opening and she enjoys everything about it.

"The people are very nice and they seem to have a fresh selection of everything and it's nice to be able to have lunch here too,"

Scarola said. "I wish them plenty of luck, I hope they do well and I'll be stopping by in the future."

Glen Cove Chamber of Commerce member, Mary Stanco participated in the ribbon cutting ceremony and stated that she's de-

lighted to see a family-owned business making its way in the community.

"I'm happy that there's so many people that showed up today at this event," Stanco said. "Any kind of business you have, whether large or small, we like to promote them and we hope that they stay in this area."

Just as they have established on the South Shore, Adriana hopes this market will cater to surrounding communities, like Glen Cove, Sea Cliff, and Glenwood Landing. As their relationship between the community and the store continues to grow, she hopes to see their business expand as well.

"Our mentality is to open up more stores and open up more locations on Long Island," she said. "We've established this in Babylon, we would like to build that rapport here and we have more than enough family members to do it. We're here to serve the community and anything that they need, we're here for that."

Her brother expressed the same feelings and he wants to see his family closely connected no matter how large their business grows.

"We want to stay close and continue working together," Marc said. "We'd like to give back to the community and keep going forward."

Before children learn to read print, they need to become more aware of how the sounds work in words. Phonemic awareness is an essential pre-reading skill but also enhances reading achievement, vocabulary and spelling.

Dear Great Book Guru,

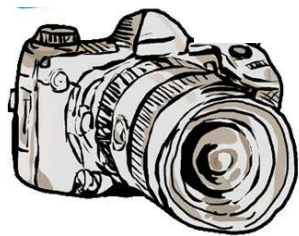

Dear Eager Reader,

John Grisham's latest bestseller "The Whistler" is a wonderful choice for winter's waning months. Known as an immensely talented writer of thrillers, Grisham is also a social critic of much note. In this novel he takes on corrupt judges, whistle-blowers, Indian casinos, capital punishment, and organized crime. The main character Lacy Stoltz is an investigator for the Florida Board on Judicial Conduct. She and her partner

Hugo Hatch, a former Florida State football star, are contacted by a previously disbarred, charismatic attorney, Randy Mix, who has information on . . . as he says: "the most corrupt judge in American history" — Claire McDover — a local justice with a very extensive collection of condos, jewels, and gold coins. Before the story ends, Lacy is confronted with grave mortal and moral dangers. Adding to the suspense, neither she nor the reader knows the identity or motivation of the "whistler," until almost the end of the novel. The complex laws that govern Native American lands and the panhandle terrain add a rich subplot to this fast moving thriller. Highly recommended!

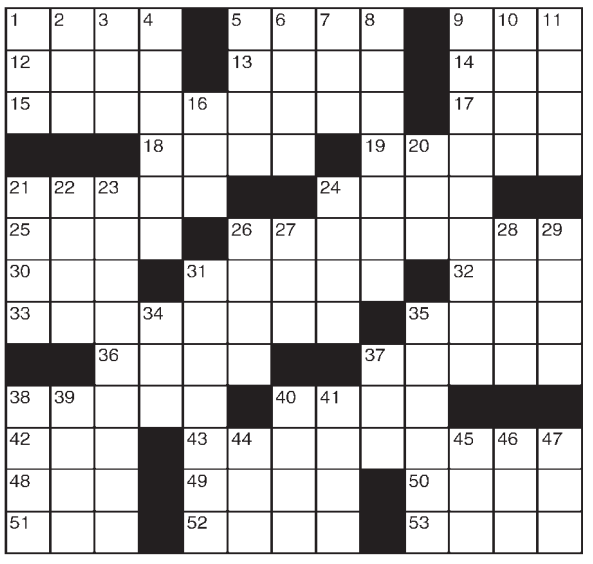

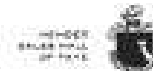
