“Glen Cove Is Officially Reopened For Business”

Officially taking the oath of office as the Mayor of the City of Glen Cove on January 1, Reginald Spinello proclaimed, “Glen Cove is officially reopened for business.”

The official swearing in took place at 12 noon at the Finley Middle School.

Incumbent Council members Anthony Gallo, Jr., Timothy J. Tenke, Michael T. Famiglietti and Nicholas A. Dileo, were sworn in along with new council members Pamela D. Panzenbeck and Efraim Spagnoletti.

The new Spinello administration will keep some of the prior administration’s staff including City Clerk Tina Penberton and Controller Sal Lombardi. Planning Board Secretary Lois Stemcosky, Director of Senior Services, Carol Waldman, Executive Director of Youth Bureau, Arlene O’Dell, and City Marshall Michael DiLeo were also re-appointed.

Joining the staff are Deputy Mayor Barbara Peebles, Secretary to the Mayor Caterina Bianco, Chief of Staff, Zefy Christopolos, City Attorney Charles G. McQuair and Deputy City Attorney Kristina Heuser.

A signal 10, working house fire, in Sea Cliff was called in to the dispatcher at 8:13 p.m on December 28. Sea Cliff Chief Danny Whittemore said the department made a fast response to the burning house located at 7th and Roslyn Avenues only a block from Sea Cliff firehouse. High flames and smoke were billowing out from the second floor of the large wood frame turn of the century house when the fire department arrived. Chief Whittemore immediately called for mutual aid from Glen Cove, Glen Cove EMS, Glenwood, Locust Valley, Roslyn, Oyster Bay and East Norwich fire departments. First Assistant Chief

Held in conjunction with the Glen Cove Junior Soccer League's Soccer Fest, this event is designed to provide parents and youth with information about healthful services in Glen Cove while celebrating healthy living. As soccer games were underway, Glen Cove residents stopped by the tables and spoke to local doctors, service providers, and representatives from local agencies that promote healthy bodies and minds.

"On behalf of the Board of Directors and staff of SAFE, we thank the Glen Cove Junior Soccer League for collaborating again with us on our Annual Health and Fitness Fair" said Rev. William F. Wendler, SAFE Board Director.

PRIDE Coalition volunteers disseminated over 300 backpacks, containing prevention literature, PRIDE stress balls, and free water bottles. Ernie Longobucco and 2nd Assistant Mark Vitale were also on the scene.

Whittemore said the 1st due engine layed in immediately and hit the second floor of the house with water where the fire apparently had started. The chief spoke to neighbors who said the homeowners were out. Earlier an elderly woman came out of the house.

Initially, the fire department knocked down the flames, but they flared up again on the second floor rear of the building

and were quickly extinguished again. The third floor also was involved as the fire spread upward.

A newly married couple who were living in the house and in the process of moving to Brooklyn lost many of their possessions including a value able cosmetic collection. A Fire Relief Fund has been set up to help them

Name the Celebrity



Last Week's Celebrity

Last week's celebrity was born Robert Shaen Dawe but was better known to his audience as Robert Shayne. After many stage performances, his first film was in Dec. 1929 at the Warner Bros. Vitaphone Studio in Brooklyn. It was a N.Y. comedy starring Bert Lahr (Oz's "Cowardly Lion"), entitled "Faint Heart". This was an experimental two-reel talkie and was also Lahr's first film, as well. According to Shayne's daughter, Stephanie, one of his favorite roles in films was the "restaurant sequence between Shayne and Bette Davis in "Mrs. Skeffington", whom, he would often say, was "the consummate professional" and enjoyed every minute he worked with her. He was one of the most recognizable faces in show business, but he was probably best known for his signature role of "William J. Henderson", a Metropolis police inspector in the 1950s TV series "Adventures of Superman" with George Reeves. Coincidentally, in 1944, when he was working with Jane Wyman, Jack Carson and Alan Hale, on the set of "Make Your Own Bed", he also worked with actor, Bill Kennedy, who eventually would become the announcer for the introduction of "The Adventures of Superman.....Up in the Clouds...It's a bird. It's a plane....." He briefly appeared in Alfred Hitchcock's "North by Northwest" (1959), seated at a booth in a hotel bar where his character meets Cary Grant's character, just as Grant is about to be kidnapped. In the 1960s, he began his association with Disney films, starting with "Son of Flubber" (1963), as the Asst. to the Defense Secretary. This was the sequel to the successful "The Absent-Minded Professor". He was in "The Barefoot Executive" (1971) with Kirk Russell, Wally Cox and Joe Flynn of TV's "McHale's Navy" and "Million Dollar Duck" (1971) with Dean Jones. On Nov. 29, 1992, he passed away from natural causes at the age of 92.

Correct Callers

Callers who knew our celebrity last week were: Marrio Moccia, Don Adams, Roberta Pezza, Tony Mercado, Will and Babs Hutchins, John Rogalski.

Our celebrity was born on Dec. 30, 1934, in Los Angeles, Calif., a son of actors and brother to the organist for the 1960's band "The Standells". He was discovered at the age of 10 by actor, Lloyd Bridges, after acting in a play. His first film appearance was as a small, non-speaking role in the 1948's "The Boy With Green Hair" starring Pat O'Brien and Dean Stockwell, in the title role. Stockwell, who has a Glen Cove connection of his own when he filmed "Werewolf of Washington" (1973) in Morgan Park, continues to be a very close friend of our celebrity. Our celebrity's daughter has, since she was a young child, has regarded Stockwell, Dennis Hopper, and the musician Neil Young, her "godfathers". Our celebrity portrayed the young "Saul" in Cecil B. DeMille's 1949 version of "Samson and Delilah". He played the younger version of John Dall's character in the 1950 film noir "Gun Crazy". Later, the same year, he had a minor role as Elizabeth Taylor's younger brother in "Father of the Bride", as well as, in the following year's sequel, "Father's Little Dividend". He was also a young soldier in boat camp in 1953's "Take the High Ground" with Richard Widmark and Karl Malden. His training as a gymnast in high school and abilities as a acrobat prepared him for his breakout role as "Gideon", the youngest brother, in 1954's "Seven Brides for Seven Brothers". Theater to Re-open in Spring of 2014

Outgoing Mayor Ralph Suozzi announced on Friday that the new owner of the Movie Theater, the Dinoto Group, has signed a lease with a new movie operator. The deal follows a PILOT arrangement with the Industrial Development Agency (IDA) creating a tax reduction that is in line with a third-party economic analysis recently performed on the movie theater property at the request of the IDA.

The new operator owns multiple theaters and has over 30 years in the movie business and under the agreement has 90 days to renovate the theater with new seats, state of the art digital projection equipment and other physical amenities like new awnings, carpeting, etc.. Mayor Suozzi stated, "The movie theater plays a critical role as an anchor in our downtown business district. The City and the IDA have been working with Mr. Dinoto since June and this PILOT with the IDA and the subsequent signing of the lease sets up a successful entertainment venue for our downtown for at least the next 15 years and beyond."

Mr. Dinoto commented, "I thank Mayor Suozzi and IDA Executive Director Kelly Morris for working so hard to move this along. I believe Glen Cove is

a great market for a movie theater and the new owner brings decades of movie operating experience into what will be a very successful movie theater."

While the actual opening date will be announced later it is anticipated that the theater will reopen sometime between March and April of 2014 as announced at the October Press Conference announcing the purchase of the theater property by the Dinoto Group.

Address By Hon. Reginald Spinello At His Inauguration As Mayor

The Following is the Inauguration address delivered by Glen Cove Mayor Reginald Spinello on January 1 before a packed crowd at Finely Middle School in Glen Cove.

Wow, what a crowd! I am so humbled by your support. I thank all of you for taking time from your busy schedules to be here today to share this new beginning for our city.

Special thanks to all our elected officials who've joined us today. County Executive Mangano, thank you for your kind words. I look forward to working with you and your great team.

Why it is that every time I see you, the first thing I want to say is "Thanks, Ed Mangano."

There are just so many people to thank. If I tried to mention everyone's name, I'm sure I'd forget someone. So, if I may, let me just say thank you to each and every one who worked so hard for my election. It would not have been possible without you, I truly appreciate your help. By the way this place looks great special thanks to Billy Melillo, Mike Salantino, Joe Solomito, and your staff. Much appreciated

Of course, the one name that I will mention is my wife Coleen. Thank you so much honey for all you do every day, not just for me but for so many others throughout our community. And I want to also thank my daughter Serena, my mother, Helen, my sister, Diana, her husband Dominick, and all my family and friends here today. I love you all.

Well, it's been a long time in coming, and I'm pleased to announce today that Glen Cove is once again open for business. We've got a lot of work to do to reverse the trends of the last 20 years, but if I didn't think we could do it, I wouldn't have run for mayor. My vision for our city's future is very positive.

With my election to our city's highest office, the voters have now given me the chance to prove that with an open, honest, transparent and hardworking government, there is nothing we can't accomplish. I may have been elected to serve as your leader, but I won't forget that you are still my employer. And it's my job over the next two years to prove that hiring me was a good idea.

After more than two decades of one-party rule and one-party ideas, the voters have asked for a change in the way Glen Cove is governed. And I intend to lead that change.

In our system – a system that respects majority rule while it protects minority rights - Glen Covers have asked for a different approach to running our city.

Believe me, I am well aware of the narrow majority which has brought me to this office. And today I do not declare any mandate for my office other than to say that I believe I have a mandate from all Glen Covers – those who voted for me and those who didn't – and that mandate is to reopen our city for new business and make it once again the gem on the Gold Coast that so many of us fondly

remember.

These next two years will pass like the blink of an eye, and if Glen Cove is going to make meaningful strides forward, one person cannot do it alone. It will take a team effort; and that team cannot be comprised just of people who work at City Hall or the fine group of council members seated here behind me. Let's give them another round of applause. I look forward to working with every one of you. Along with our council members, our team must include residents of Glen Cove willing to join with us in making the improvements that are needed if we're going to make this a better city and restore the quality of life we

all once enjoyed.

Unlike many other communities, Glen Cove truly reflects our national identity. Our demographics include a wide variety of ethnic and religious groups, people of varying socio-economic status, blue collar workers, white collar executives – people from all walks of life who, working together, can, and should, be the engine of a thriving community with great promise. Each and every one of us has something to offer. We can learn from each other by keeping open minds and searching for the best in each other. My friends, the fact is that right here in Glen Cove, we value our differences because that's our strength, not a weakness, and I intend to use that strength to build a better city.

In so many ways, a small town government like ours has a greater and more immediate impact on our daily lives than any state or federal government. Unlike those governments, a local government's principal function is to deal directly with real quality of life issues each and every day.

It's the City of Glen Cove, not the state or federal government that picks up your garbage.

It's the City of Glen Cove, not the state or federal government that repairs the potholes and plows your streets.

It's the City of Glen Cove that opens the beaches in the spring and picks up your leaves in the fall.

It's the City of Glen Cove that provides and takes care of parks, tennis courts, the golf course and a host of other

amenities that are all a part of our quality of life.

And it will be the City of Glen Cove that will revitalize our downtown and finish developing our waterfront so that it will no longer be the blighted and polluted site that it was for years, but it will become a tangible recreational, commercial and residential success story.

It's all those things that affect your daily life that your city government must constantly work at to give you the best that your tax dollars pay for and what you deserve. And that's why I ran for this office. To make sure that happens. I promised during the campaign that I would focus on quality of life issues, and I intend to keep that promise.

As one of my first orders of business, I'm going to direct my attention to addressing the illegal housing problem which has been a burden on our community. When a property owner seeks to profit by renting housing to more people than the law permits, not only are the renters endangered living in an illegal environment, but an entire neighborhood is negatively affected. How many times have we seen properties with an unusually large number of cars parked on them? Illegal rentals can turn the best of neighborhoods into an unsightly mess. Too many people cramped into too little space overcrowd our schools and they burden our infrastructure. We all wind up paying for that. Illegal tenancies PUNISH Honest people who live around them. That has to stop, and I intend to devote my efforts to see that it does.

Starting right now, the era of looking the other way is over.

Starting right now, the era of giving breaks to friends or supporters has ended.

Starting right now, it makes no difference who you are or who you know. If you violate our city code by permitting illegal housing on your property you will be prosecuted and you will be fined in accordance with our City Code.

So long as I'm mayor, the illegal housing business will no longer be business as usual in Glen Cove. If we're going to respect each other, we need to start with a mutual respect for our laws.

Now, let me turn to a more positive note, because that's what we're here for today. I started out by saying that as of today, Glen Cove is reopening for business and I see a bright future for us. While we can all agree that bringing in new business is a great idea, no idea is really good unless there's some way to implement it with positive action.

So, beginning tomorrow, our new Deputy Mayor, will make arrangements to meet with the director of our Chamber of Commerce, our Business Improvement District, and our Community Development Agency to begin laying the groundwork for new business development in Glen Cove.

New business is not going to happen by accident. And that's why my administration will not sit on its hands waiting for good potential businesses out there to find us here in Glen Cove.

No, we're going to get out there and help them discover us and let them know there are many opportunities here if they bring new business in to our community. We're going to establish innovative and creative ideas for generating new business right here in our city. And we're going to work on that each and every day that I'm mayor.

We aren't the first community to experience a negative trend in our business environment over the years. And we certainly don't need to be the last to figure out how to turn it around. We will study what other communities have done successfully to turn themselves around. And just as importantly, we'll also learn from them how to avoid mistakes. We don't need to reinvent the wheel; we just need to own it.

Starting right this minute, I am encouraging every one of you - Glen Covers as well as residents of our surrounding communities - to think about shopping Glen Cove first and supporting our local businesses before going elsewhere.

We need to work on making sure that the businesses which are here will stay here, and that new ones will come in because they know that the business climate is right in Glen Cove and our residents and neighbors will support them.

I also intend to place a strong emphasis on grant procurement to assist us in our efforts to revitalize the city. My new Executive Director of the CDA is an experienced grant writer and administrator with the ability to coordinate grant opportunities from the many arms of government that provide them. Under her leadership and direction, our team of talented grant writers will find new opportunities for monies needed to assist in the revitalization of our city. Others have done it. We can do it, too. In fact, we'll do it better.

Another area to which I will devote my attention is improving the reputation of our schools. It's no secret that our schools suffer from an unfair, negative reputation. That's not just unfair to our students and teachers, some of whom are among the best in the state, but it's also unfair to our homeowners whose property values are adversely affected when our schools are not viewed in a more positive light.

While our schools are not run by the mayor, that doesn't mean that our mayor cannot be a cheerleader for our school system and use his influence to work at improving the reputation of education in Glen Cove. I am a proud product of Glen Cove schools, and my education right here in this community was just fine. Heck, I even became the mayor of Glen Cove.

As part of our to soon to be formed recreation committee I will appoint an individual with the expertise to bring fresh ideas on how best to improve and develop new youth sports opportunities and facilities in Glen Cove. Unlike many other communities around us, our city enjoys a host of athletic fields and

facilities that with some creativity can be put to better use in developing programs to encourage our youth to join up and become more involved in sports. What better way to bring a diverse community together and to keep our young people engaged in positive activities than to encourage their interest and participation in sports?

Now, I've been thinking about those things for a long time, and they're just a few of my initial thoughts on how Glen Cove can be reopened and reshaped, starting now. As a former business executive, I am trained to be open to new and different ideas coming from all quarters - from those who supported me to those whose support I will seek. Good government demands good executive skills. I believe I bring those skills to the table and I will use them to the fullest to see our city become a model of reinvention.

My friends, Glen Cove is a 50-million dollar business. It would be a fool's errand for one person alone to try handling all the details of running a business that size without assistance. And that's why I am totally committed to bringing good, knowledgeable and experienced people into our city government to help me get this job done. There are so many talented people who already serve the city and together with my new team I see nothing but better days ahead for our community. Our taxpayers deserve no less!

Summer research at Brookhaven National Laboratory paves way for honor.



affect the experimental result," added D'Silva.

D'Silva's research led to recommendations to study and eliminate the effects of CBO and he presented his findings to the Muon g-2 collaboration in a national teleconference, where his proposal was accepted. "It is believed that my recommendations will save the collaboration a few million dollars," said D'Silva.

David Etwiler, CEO of the Siemens Foundation, praised D'Silva and the other winners in a press release for their groundbreaking work. "These incredible students have invested significant time and energy to advance research and exploration in critical fields."

D'Silva traces his passion for physics back to the Honors Physics class he audited a year ago as a junior with Dr. Conor Buechler. "By demonstrating practical application, Dr. Buechler showed us the value in further exploring such a field. I enjoyed the class so much that it encouraged me to pursue it further in the form of scientific research."

In addition to Siemens, D'Silva plans to submit his research findings to Intel's Science Talent Search and present at Intel's Science and Engineering Fair, as well as submit the Siemens paper and an additional one for publication in scientific journals.

Following his summer research at the Brookhaven National Laboratory in Particle Physics, Friends Academy senior Ian D'Silva (Dix Hills) has been chosen as one of 331 semifinalists in the 2013 Siemens Competition in Math, Science & Technology, the nation's premier research competition for high school students.

Selected from a record 2,440 students nationwide, D'Silva's project was judged among a total of 1,599. D'Silva's research paper, "A Thorough Systematic Error Study of the Effect of Coherent Betatron Oscillations in the Muon g-2 Experiment" involved using Magnetic Resonance Imaging (MRI) to study the behavior of muons, which are "cousins" of electrons. D'Silva represented Friends Academy in the competition.

"The Muon g-2 Experiment provides the strongest evidence for new physics," explained D'Silva. Initially conducted at the Brookhaven National Laboratory from 1999 to 2001, the experiment is scheduled to resume at Fermilab in Chicago in 2017. "A less than perfect injection system causes the muons to oscillate around, rather than follow their ideal path. These oscillations, known as Coherent Betatron Oscillations (CBO) can cause a systematic error that can greatly

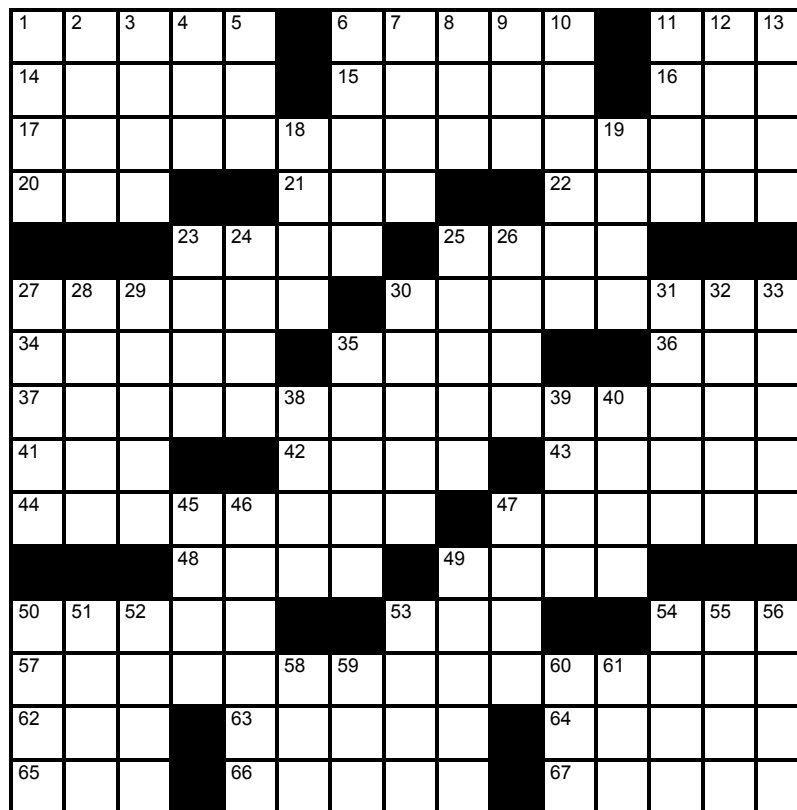

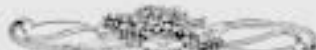
