



There will be a North Shore Board of Education/Town Meeting on Thursday, January 16, 2014 at 7:30 p.m. at Sea Cliff School. Please note, the earlier time for the public session. 

Starting With 100 To The Editor,

On the first day of a new college course my brother always told the students "Today you have a grade of 100 (A). What you do with it is up to you." The newly elected Glen Cove City officials start their term of office on January 1, 2014. They start with a grade of 100. What will they do with it remains to be seen.

Over the past 8 years the City of Glen Cove has progressed forward and upward. At this point in time it has reached a level of involvement with the community and support to the residents and businesses that has not been seen in the past. Mayor Suozzi and the City Council, the City Departments and Commissions and all of those involved have raised the bar to a very high level and have shown that that level of close support to, and strong management of, Glen Cove can be maintained.

In the pharmaceutical industry, a company has to maintain a set level of manufacturing rigor to meet regulatory requirements. When it exceeds the requirements for a product and can maintain a higher standard the FDA now sets that as the standard for that product made by that company and there is no reversing this without a severe penalty.

The Government of Glen Cove has shown that it can maintain the high level of community service, quick response to concerns, fast action in situations of emergency, attention to the infrastructure, proactive interaction with State and Federal agencies and with businesses both here and potential, good will and open government for several years – far more so than it has ever done in the past. It is critical to the City and the Gold Coast region (which is affected in some instances by the acts of the City) that this process does not become regressive but the high level now present continues and that the City remains recognized for being sensitive to the residents and businesses and responsive to the needs and concerns of all. Knowing that the incoming officials can do this and do it well, I wish all a Happy and successful New Year.

A Mill Neck Manor Tradition: Story Time at Locust Valley School

Longstanding traditions are not always holiday-themed. For the past 21 years Betty Quartuccio, Speech Therapist at Mill Neck Manor School for the Deaf, has been visiting Locust Valley kindergarten classes for a particularly interactive story time. At each visit, Quartuccio is accompanied by one of her Mill Neck students. Recently, Yoli Gomes, a high school student at Mill Neck, joined Quartuccio to present "The Gumdrop Tree" to the Locust Valley youngsters.

At the MacArthur school's library, the kindergartners sat attentively as Quartuccio read aloud. Simultaneously, Gomes signed the words to the children. The engaging story revolves around some colorful gumdrops and a little girl's wish to have more by planting them, hoping to grow a tree's worth of the sweets. Quartuccio and Gomes paused several times during the story, allowing the children to practice some sign language with the names of the colors and other words in the book. The little ones were eager to try and showed off their dexterity in forming the signs. After the reading and the surprise unveiling of a "real" gumdrop tree, the kindergarten class was excited about

creating their own trees.

The annual reading event serves a twofold purpose. One, Quartuccio said, "is to bridge the gap between deaf individuals and hearing students." The other relates directly to her speech therapy work with her students, specifically, giving them additional opportunities to interact outside their Mill Neck environment. "It's important for them to practice their communication skills in the community," said Ouartuccio.



Studying Imperialism at the North Shore Middle School

Name the Celebrity



This week's celebrity was born Ragnar Lind, on Feb. 16, 1909, in Auburn, Mass. and was a school teacher before he began his acting career. He came to Hollywood and made his film debut in "Out Where the Stars Begin" (1938). He achieved notable success in 1938 appearing with the Lane Sisters and Claude Rains in "Four Daughters". The popularity was so great that it was followed by three sequels "Daughters Courageous" (1939), "Four Wives" (1939) and "Four Mothers" (1941) with our celebrity reprising his role in each of them. After the success of "Four Daughters", he was screen tested for the role of "Ashley Wilkes" in "Gone With the Wind" (1939). He was considered to be the front runner for the role, partly due to his physical resemblance to the character, as written. He was used exclusively during the "Search for Scarlett" playing "Ashley" in the screen test for many actresses who tried out for the part. As we know, David O. Selznick eventually cast Leslie Howard. Instead, he acted in "The Roaring Twenties" (1939) a gangster film that reunited him with "Four Daughters" star, Priscilla Lane, as well as, James Cagney and Humphrey Bogart. As one of a two friends, and the only one not to "go bad", he won excellent reviews.

Last Week's Celebrity

Last week's celebrity was Russell Irving "Russ" Tamblyn. He appeared with Glenn Ford and Broderick Crawford in "The Fastest Gun Alive" (1956), where he performed an extraordinary "shovel" dance at a hoe-down early in the film. Though un-credited, he served as a choreographer for Elvis Presley in 1957's "Jailhouse Rock". He portrayed "Norman Page" in the 1957 film of "Peyton Place" with Lana Turner and Hope Lange. He was nominated for an Academy Award Best Supporting actor. In 1960, he portrayed "The Cherokee Kid" in "Cimarron" with Glenn Ford and Anne Baxter. He appeared in two 1962 MGM-Cinerama movies, "The Wonderful World of the Brothers Grimm" and "How the West Was Won". From 1990-91, he starred as "Dr. Lawrence Jacoby" on the David-Lynch created "Twin Peaks", though his scenes in the 1992 film, "Twin Peaks: Fire Walk With Me" were cut. In 1999, he portrayed "Dr. Hayden" on daytime soap opera "Days of Our Lives". In 2000, he made an appearance with his daughter, Amber, on another soap opera, "General Hospital" as the character he portrayed 10 years earlier on "Twin Peaks". He made another appearance in 1997 on "GH" dancing with his daughter during the Nurses' Ball. However, he may be best remembered for his performances in film musicals in the title role of "tom thumb" (1958) and "Danny", one of the sailors, in the 1955 film version of "Hit the Deck" with Debbie Reynolds and Jane Powell. His most famous musical role was as "Riff", the leader of the Jets in the 1961 "West Side Story" with Natalie Wood

For Whom the Bell Tolls

Dear For Whom...,

Yes, THE MAID'S VERSION by Daniel Woodrell is a very good read and it does indeed deal with community, but not in the lovely way you describe. The main character is Alma Dunahew, the maid whose life past and present is forever

scarred by a fiery dance hall explosion in which 42 people, including her beloved, fun-loving sister Ruby, were killed. The town is haunted for generations by the mystery of who was responsible. Alma 's hard life is made even harder when she questions those whose money and position put them above suspicion. In exquisitely drawn tiny portraits, we meet victims and their survivors; the innocent and the guilty, the poor and their masters, and we are shown over and over the power of money to make "things" go away. When we come to the end of the book, we realize we have learned much about Alma's community- its bigotry, its cruelty, its injustice, and, yes, at times, its generosity. Highly recommended!









