# **Property Tax Shift Due To Decommissioning of Glenwood Plant "Not To Exceed 1%"**

At the conclusion of a meeting with Sea Cliff Mayor Bruce Kennedy recently, Deputy Nassau County Assessor Steven L. Corte sent the Mayor an e-mail confirming Kennedy's contention that a tax shift from the closed Glenwood power plant to residential properties by more than 1% per year was not legal. In addition Corte wrote "the school tax revenue shortfall this upcoming year will be made up by Community Development Block Grant Funds."

Mayor Kennedy has been raising questions about the property tax implications ever since the announcement from LIPA that they would be decommissioning the Glenwood Landing plant. The inquiries have been specifically about the property tax assessment on the National Grid/LIPA properties and how they might be assessed most fairly, in the best interest of North Shore community residents.

tem we've instituted to let all residents know about emergencies," he said. It also works to simplify resident's lives. In the past two weeks, codeRED has called with dates and information about recycling, snow removal and garbage collection. Mayor Kennedy urges those who have not yet entered a telephone number into the system to do so immediately. Residents can go to www.seacliff-ny.gov in order to register.

Erinn McDonnell of Sea Cliff's Section 8 sought support from the board for a senior outreach program. Her proposal in the current 40th year is preceded by last year's unsuccessful efforts. She has also submitted for funds for an ADA bathroom to be created at St. Luke's Episcopal Church. This idea stemmed from the ADA-compliant restroom that was constructed in the Sea Cliff Children's Library to accommodate people with disabilities. McDonnell continues to seek new ideas for community development within the budget allotted. "I can assure residents that these funds are serving the village very well," Trustee Carol Vogt said.

Vogt also pointed out that the bus for seniors provided 54 rides during the month of December alone. The installation of a wheelchair lift on a new bus has further encouraged residents to make use of this service. Due to the dedication of the Senior Action Committee and the volunteer drivers, these buses are also able to transport seniors to and from doctor appointments. "We are continuing to increase our participation," Vogt said on behalf of the senior population.

Last Monday, the US Coast Guard informed the New York Power Authority of an oil slick in the Long Island Sound. Upon further investigation, NYPA declared the oil to be non-toxic and therefore not a health hazard. However, the oil is currently flowing into the Sound at the Sands Point mouth of Hempstead Harbor at a rate of 3.5 to 3.8 gallons per hour. The NYPA has positioned skimmer boats to limit the spill until it can be stopped completely in an estimated two weeks from now. Shell fishing in the harbor is permitted in the meantime.

The New York State Department of Environmental Conservation will hold a public meeting in Village Hall on Thursday, Jan. 30 at 7 PM. Representatives will present a Proposed Remedial Action Plan for the Powers Chemco site located on Charles Street in Glen Cove. The plan will address the groundwater under the site, which was contaminated with solvents from previous manufacturing practices at that location. The public will have a chance to comment and make suggestions at that time.

Mayor Kennedy also drew attention to the heightened New York American Water bills many residents have been receiving as of late. "If you're still getting water bills that seem too high, certainly report it," he said. The mayor noted that his personal experience has been that water bills have decreased from \$1.60 per day to \$1 per day.

Trustee Vogt announced that the town is interviewing anyone seeking a position as a lifeguard this summer. She additionally noted that the Glen Cove YMCA offers a "Lifeguard in a Week" class over February break. Participants must be at least 15 years of age in order to receive an American Red Cross Lifeguarding Certificate amongst other certifications upon completing the course.

Trustee Lieberman excitedly showcased Village Hall's new podium with the official seal stamped on the front. The podium had been highly anticipated since the previous one began to shake. "I knew it wasn't me," Lieberman joked of his experiences speaking at the podium.

After the counsel finished the meeting's agenda, the public was given the chance to speak. Althea Macdonald took advantage of the opportunity, making sure to first applaud the counsel for their efforts before addressing her own concerns. She then went on to seek a solution for the exhaust fan that broke last year at Bernard's Market & Café. The fan was extremely loud for about three days and could be heard from her house. She suggested that extra fans be available in case this situation recurs.

Macdonald also spoke about pedestrian safety at the beach. She made note of the already narrow crosswalk in front of the Sea Cliff Yacht Club, adding that parked cars often protrude over it. Mayor Kennedy stated that the town has purchased more pedestrian signs to be placed near the crosswalk to ensure that cars won't prevent people from crossing the street. Referencing last year's troubles, Mayor Kennedy said, "It was a learning experience."

The second annual SpringFest will be held on June 8 from 11 AM to 5 PM. Trustee Lieberman said that the day is meant to showcase any volunteer groups that would like to claim a booth. The festival will take place on Sea Cliff Ave. between Roslyn and Main.

Sea Cliff's Grievance Day will be Tuesday, Feb. 18 from 9 AM to 7 PM, during which time complaints will be received in response to the Proposed 2014 to 2015 Assessment Roll. The Proposed Assessment Roll can be found at the Office of the Village Clerk from Feb. 3 to Feb. 18.

Next month's board meeting has been postponed until Feb. 11 at 8 PM due to scheduling conflicts.






## Monica Randall's Winter Dreams Exhibit at NSHM

Author and historian Monica Randall's current exhibit at North Shore Historical Museum is her collection of winter gowns worn by ladies of prominent Gold Coast families, along with her photographs of models, Monica and her friends, in authentic costumes reproducing vignettes of that era. The photos were tinted to look aged and were shot on the property of various mansions on the North shore.

This is the second exhibit of clothing from Monica Randall's collection. The first exhibit Abandoned Trunks was a very successful well attended exhibit. In addition to Monica Randall's collection are two photographs depicting winter scenes at Inisfada with a poem written by Victoria Crosby, vice president of NSHM, "Ode to Inisfada." The word Inisfada is Gaelic and means Long island. The mansion in Manhassett, the former St Ignatius Retreat House owned by the Jesuits and sold to a developer, was recently demolished. The mayor approached Legislator DeRiggi-Whitton with his research and requested she assist in setting up a joint meeting with the appropriate county officials. Together they met with both the Nassau County assessor's office and several representatives from the Nassau County attorney's office.

Mayor Kennedy's main contention has been, under New York State Real Property Tax Law, it would be illegal to shift the tax burden from one property tax class to another tax class (i.e.: business to residential) by more than 1% per year (this is known as a shift in base proportions). The County Assessor's office concluded that he was, in fact, correct.

Legislator DeRiggi-Whitton stated that she, along with all of her colleagues on the Nassau County Legislature voted to approve the 2014 tax levy. She asserts that the numbers they approved confirm that there is no spike for residents and business owners stemming from the changes at National Grid.

This is just a preliminary announcement regarding a large, complicated issue. As our local elected officials continue their research, there are several important issues that must be dealt with. For one thing, when the PILOT's for other LIPA/National Grid properties expire, DeRiggi-Whitton would like to explore a regular taxing scenario. She also will work to push for redevelopment of the property in a timely manner to make sure taxes are coming from the property at an optimum amount.

Legislator DeRiggi-Whitton commended Mayor Kennedy on his knowledge and persistent efforts on this issue and points out the progress that can be made when elected officials work together to better serve their communities.



Name the Celebrity



This week's celebrity was widely regarded as one of the most respected innovators of the American stage. He also enjoyed a tremendous success as a producer, screenwriter and perhaps most remarkable of all, as a character actor in a prolific later career, begun at the age of 70. He was born in Bucharest, Romania on Sept. 22, 1902. His mother was British, while his father was an Alsatian Jew of Romanian descent, who owned a grain business. His father's substantial wealth and mother's background led him to be raised in the United Kingdom, where he was educated at Clifton College. After becoming a British citizen, he entered the family grain business as an international speculator traveling first to Argentina and later immigrating to the U.S.A. in 1924. Initially holding a seat on the Chicago Board of Trade, he was rendered nearly destitute by the Stock Market Crash of 1929. In 1935, he began a fruitful, but stormy creative partnership with the brash, enormously talented Orson Welles, then barely 20 years old. Ironically, the Depression that destroyed our celebrity's business led to many unique artistic opportunities enabling the pair, under the auspices of President F.D. Roosevelt's Works Progress Administration (WPA), to form the Negro Theatre

Project. Our celebrity and Welles made history that year when they presented a controversial version of "Macbeth" set in Haiti, with voodoo priestesses playing the roles of Shakespeare's weird sisters.

#### Last Week's Celebrity

Last week's celebrity was Jeffrey Lynn. After his success in "The Roaring Twenties" (1939), he continued with such films as "The Fighting 69th" (1940), in which he portrayed poet-soldier, Joyce Kilmer, opposite Jimmy Cagney and Pat O'Brien, "It All Came True" (1940) with Humphrey Bogart and Ann Sheridan, "All This and Heaven, Too" (1940) with Bette Davis and Charles Boyer, and "Million Dollar Baby" (1941) again teamed up with Priscilla Lane. His movie career was interrupted by military service during WWII and when he returned to the screen in 1948, he was not able to establish himself again. He was in the notably success "A Letter to Three Wives" (1949) with Ann Sothern and Paul Ford, but his film career had stalled. Lynn starred in "Home Town Story" (1951), which featured Marilyn Monroe in a minor role. It was not until the 1960's that he achieved more successes with "BUtterfield 8" with Elizabeth Taylor and "Tony Rome" (1967) with Frank Sinatra. He began appearing on TV shows such as "Robert Montgomery Presents" and "Your Show of Shows". His final acting appearance was a guest role in "Murder She Wrote", in 1987, with Angela Lansbury. This episode was a TV sequel to the feature film "Strange Bargain" (1949), which reunited him with his original co-star, Martha Scott. He died on Nov. 24,1995, at the age of 86, from natural causes.

## Sea Cliff Chief Wins Painting of Firehouse



#### What is Happening with Glen Cove Hospital?

Ms. Susan Kwiatek, Director of NSLIJ Hospital at Glen Cove and Dr. Barbara Barnett were kind enough to come to the Glen Cove Senior Center today, January 10, 2014, to let us know what is going on at the hospital and what is planned for the future. Although Glen Cove will be giving up inpatient services as we know it, the hospital will be expanding its Emergency Services and Stroke Center, and will have thirtysix hour inpatient care for about twenty patients at a time. Within this stay, aggressive care will be provided including physical therapy to keep the patient moving as best he/she is able from the start. If more intensive care is needed, the patient will be transferred to the most appropriate facility. Once a patient is released, the hospital plans on stepping up its aftercare by making sure a strong discharge plan is in place that will include meals, therapy if needed, and doctor, nurse, and aide visits when needed. As well, the hospital will be expanding mental health services and dental care. The goal is to see up to 5,000 patients in the dental unit in the near future.

The Don Monti Oncology Center

will remain and will include Hospice services in house. The Ambulatory Surgery Unit will be expanded. Family Practice will be kept in tact, and the Rehab Unit will incorporate nutritional services, as well as a Pulmonary component as of February 14, 2014, thanks to intensive input from the Glen Cove Senior Center's Advocate, Shirley Pinckney.

The Hospital recently did a pilot program in which nurse practitioners were sent into the local nursing homes, and it was quite successful. They are now looking into implementing this service on a more regular basis. They are also looking into incorporating more alternative methods such as acupuncture, massage therapy, and others to support their goal of prevention and wellness as opposed to re-admission and repeated treatment of same illness.

Many of the local doctors have already joined NSLIJ, and others are being invited to become a part of the Glen Cove Campus. Ten Medical Plaza will remain with its services and doctors.

If you have any questions, concerns, or suggestions, feel free to contact the hospital, and let them know. Their goal is to have a strong working relationship with the community to make NSLIJ Hospital at Glen Cove a model that hospitals across the country will want to emulate.

# **Obituaries**

#### **Burt Sloane**



Burton Sloane died peacefully January 4, 2014 after a brief illness. He was 92 years old. He was predeceased by his wife of 67 years, Charlotte, and is survived by his sons Gary (Barbara) and Steve (Melanie), daughter Louise (Don), and four grandchildren.

Born August 16, 1921 in Brooklyn, he worked as a business reporter for The New York Times before and after his induction into the Army Air Corps, where he served with distinction as a B24 navigator and as an intelligence officer. His last official rank was Lt. Colonel.

Burt visited the new New York Times building in 2011with his son, Steve. There they met with Arthur Sulzburger, Jr. who confirmed that Burt was both the youngest NY Times reporter in its long history, only twenty in 1940, and the only one without a college degree.

Later, aided by the GI Bill, Burt earned a BS in Economics from Brooklyn College a MS in Retailing from NYU. He had a long career as a manufacturer's agent starting as an associate with his brotherin-law Sig Morvay's firm, Mitchell and Morvay in 1949. Going out on his own, he became the first manufacturers' agent for Salton, Inc. After twenty five years with the firm, Marty Kabak, Salton's VP of Marketing presented Burt, who by then was one of the Salton's owners, a plaque cerifying that he was "a man with something rare...principles." His son Steve joined him in 1973. At their peak they simultaneously represented Revereware (20 years), Salton (25+ years), (Braun 12 years), Chemex (10 years), Eltron Shavers, Allesi and Gaggia. Steve continues in the business with a new partner, his daughter, Burt's granddaughter, Molly.

Burt taught economics and merchandising courses at Queens College to nightschool graduate students.

Known among friends and family for his unfailing wit and generosity, Burt was a founding member of LI Hospice and after retirement volunteered as a lecturer and grief counselor.

During the past two years he has been a member of Glen Cove Writers' Group, where he has regularly contributed expertly crafted short stories. He described himself as having lived his life in a comfortable glow of self-appreciation.
