DEC Proposes New Remediation Amendment for Powers Chemco Site

The Department of Environmental Conservation hosted a meeting on Thursday, Jan. 30 at Village Hall in Sea Cliff to publically review a proposed amendment for the Powers Chemco site in Glen Cove. Powers Chemco purchased the site from Columbia Ribbon Carbon and Manufacturing Co. in 1979 to manufacture photographic equipment and supplies. Columbia had emptied its production waste into open pits behind the building during its time at the location, which was later deemed to be subsurface contamination during excavation for Powers Chemco.

A remedial investigation in 2011 and 2012 revealed that volatile organic compounds, commonly referred to as VOC's, exist in the water table below the site, primarily in the silt and clay. This was one of several investigations conducted since 1984, when the issue was first discov-

ered.

After further investigation, 4,645 tons of contamination was removed from the site. A remedial investigation from 1988 to 1991 determined that VOC's were the primary source of the contamination. The DEC approved a cleanup plan in 1992 that remained in effect from 1994 to 1999 but was later shut down due to operation expenses. The site has been monitored since 2000.

Due to the continued contamination, the DEC has proposed a new amendment to its original 1991 plan. Bill Fonda, Citizen Participation Specialist for New York State's DEC, introduced the new proposal, which seeks to eliminate public health and environmental concerns stemming from the site. Specifically, the DEC's plans include disposing of 10,000 cubic yards of contaminated soil and replacing it with clean fill and additionally treating

any impacted soil to the north of the property. It also intends to chemically treat any residual contamination left after the excavation. The estimated cost to execute the operation is \$5,504,900.

Some residents noted that plans have been implemented before with little success. "We have a pretty high probability of success here," said Nathan Epler, Principal Hydrogeologist of Roux Associates, a consulting and project management firm in Islandia.

Further VOC contamination was found after the remedial operation's end in 1999. A 2008 limited subsurface investigation determined that some groundwater carried contaminants at levels above the Standards, Criteria and Guidance parameters. Although site-related contaminants do exist in certain off-site locations around the property, they are not in quantities high enough to harm those exposed.

"We evaluated soil vapor intrusion in a number of residences near the site. There were some contaminants found but not at levels of concern," DEC Public Health Specialist Nathan Walz said. The air quality will be monitored during the project's execution.

The DEC representatives at the meeting believe that this proposal can be quickly implemented and is the most permanent solution feasible. Project Manager Girish Desai stated that the estimated time for excavation is approximately four months. He is confident that the entire project will be completed within two years.

After the presentation, one resident commented that it should have been given near the Powers Chemco site in Glen Cove, rather than in Sea Cliff. Bill Fonda noted that the DEC also would have preferred a more relevant location but that the representatives in attendance did not have final say. Several others echoed this sentiment, stating that most of the residents who will be most affected by the amendment were not there to hear about it. After increasing its efforts, the DEC is now holding an additional meeting at Glen Cove City Hall on Thursday, Feb. 13 at 7 PM. All are encouraged to attend.

Both Glen Cove Mayor Reginald Spinello and Sea Cliff Mayor Bruce Kennedy were present at the meeting. "I've seen their plan for remediation. I think it's terrific. I'm here to show my support," Spinello said.

Meet Glen Cove Chief Joseph Solomito

Chief Solomito was sworn as chief of Glen Cove Volunteer Fire Department for the second time in January 11 of 2013. Joe said growing up in Glen Cove he spent time at the firehouse and he always wanted to be a fireman having come from a long line of family firemen starting with his grandfather Genera Solomito who was a captain in the Chemical Hose Company. His son Peter Solomito also serves as a firemen in the Pacific Company in Glen Cove Fire Department and his two uncles Henry and Al Biscardi also served in the department. He said he has good memories of the old fire house located on Bridge Street West before the City built the present more modern headquarters on Glen Cove Avenue. He still enjoys spending time at Glen Cove firehouse and the camaraderie that comes along with it.

Solomito's long service record includes joining the Glen Cove Volunteer Fire Department in 1982, as part of the department's Pacific Engine and Hose Company. In 1986 he became the Company's 2nd Lieutenant, 1987 he became its 1st Lieutenant then Captain in 1988. He became first officer in the Rescue Squad also in 1988 and served until 1989. In 1992-93 he served 3rd Assistant Chief of the Department, in 1994-95 as 2nd Assistant Chief, in 1996-97 he became 1st Assistant Chief and in 1998-99 he served his first tenure as Chief of Glen Cove Fire Department. In 2008 he again began to move up the ladder to becoming chief. From 2008-2009 he served as 3rd Assistant Chief, in 2010-2011 as 2nd Assistant Chief, in 2012-13 as 1st Assistant Chief and in 2014 he was proudly sworn in again as Chief of Glen Cove Fire Department and will serve until 2015.

The Chief said his first major fire after joining the department was in February 1982 at the Temple on Crescent Beach road that lasted two days. Other major incidence he participated in were Long Island's Nor Easter in 1992, where he helped evacuate Morgan's Island residents and assisted flood victims in Bay-

ville. He also participated in the Wild Fires out East in the 1990's, and the Avianca plane crash in Oyster Bay Cove in 1990. Besides these major emergencies, Glen Cove has had it fair share of major fires within the City of Glen Cove itself. In addition, to fighting fires he is trained to participate with the Rescue Squad in cutting injured people out of their cars.

Other involvements Solomito has participated in are the Jr. Drill Team for several years, before he became an official member of GCVFD, later he became a member of the Senior Drill Team for several years including two years as its captain. For six years he served as a department cook along with Vinny Melillo, he has also participated in numerous fundraising events, and the department's sponsored car shows.

When asked what made him decide to run for chief again, he said he was asked to run for a second time and decided he would do it. Solomito said he tries to be fair as chief and he hopes his experience helps him to make the right decisions for the department and the residents he serves

Name the Celebrity



This week's celebrity, an Irish stage, film and TV actor in American cinema, was born George Brendan Nolan, on March 15, 1899, in Raharabeg, County Roscommon on the opposite bank of the River Shannon from the town of Shannonbridge, County Offaly, Ireland. He was the son of a British Army officer. During the Irish War of Independence (1919-22), our celebrity was part of an IRA Active Service Unit as early as 1920, carrying out IRA directives. He fled with a bounty set on his head by the British, although he claimed only to have been a courier for guerilla leader and tactician, Michael Collins. He came to the USA in 1925, touring with a production of "Abie's Irish Rose." During the next five years, he acted in stock companies in Colorado, Rhode Island, Florida and Massachusetts. In 1927, he appeared on Broadway in "Love, Honor and Betray", alongside Clark Gable. He eventually moved to Hollywood and made his first film, "Under Suspicion" in 1930. Over the next two years he appeared in a number of minor films produced by Universal Studios and Fox, before being signed

to a contract by Warner Brothers in 1932. He would remain at Warner's for the next 20 years, carving out a successful career as a top-flight leading man during the 1930s and '40s. He played opposite Ruby Keeler in "42nd Street" (1933), Greta Garbo in "The Painted Veil" (1934), Jean Arthur in "More Than a Secretary" (1936) and Myrna Loy and Tyrone Power in "The Rains Came" (1939), among others.

Last Week's Celebrity

Last week's celebrity was Jessie Ralph. She starred in 55 movies altogether, 52 between 1933 and 1940. Although she made her Hollywood debut in 1916, she only became a permanent Hollywood actress in 1933. She was nearly 70 at this time, so her roles were restricted to those of dumpy old ladies, but her expertise of stealing scenes captured the imagination of cinema-goers of the time. Some of her best known roles besides "Nanine" in "Camille" (1936) were as W.C. Fields' battle-axe of a mother-in-law in "The Bank Dick" (1940), "Cuckoo" in Pearl S. Buck's "The God Earth" opposite Luise Rainer and Paul Muni, "Mrs. Weaver" in "Drums Along the Mohawk" (1939) with Claudette Colbert, Henry Fonda and Edna May Oliver, "Kathleen Forrest" in "After the Thin Man" with William Powell and Myrna Loy and as "Mrs. Burley" in "San Francisco" (1936) with Jeannette MacDonald, Clark Gable and Spencer Tracy. Our celebrity retired in 1940, after her leg was amputated, and she died 4 years later, in 1944, at the age of 79. She was married to Bill Patton, who was a bit-part actor in Westerns.

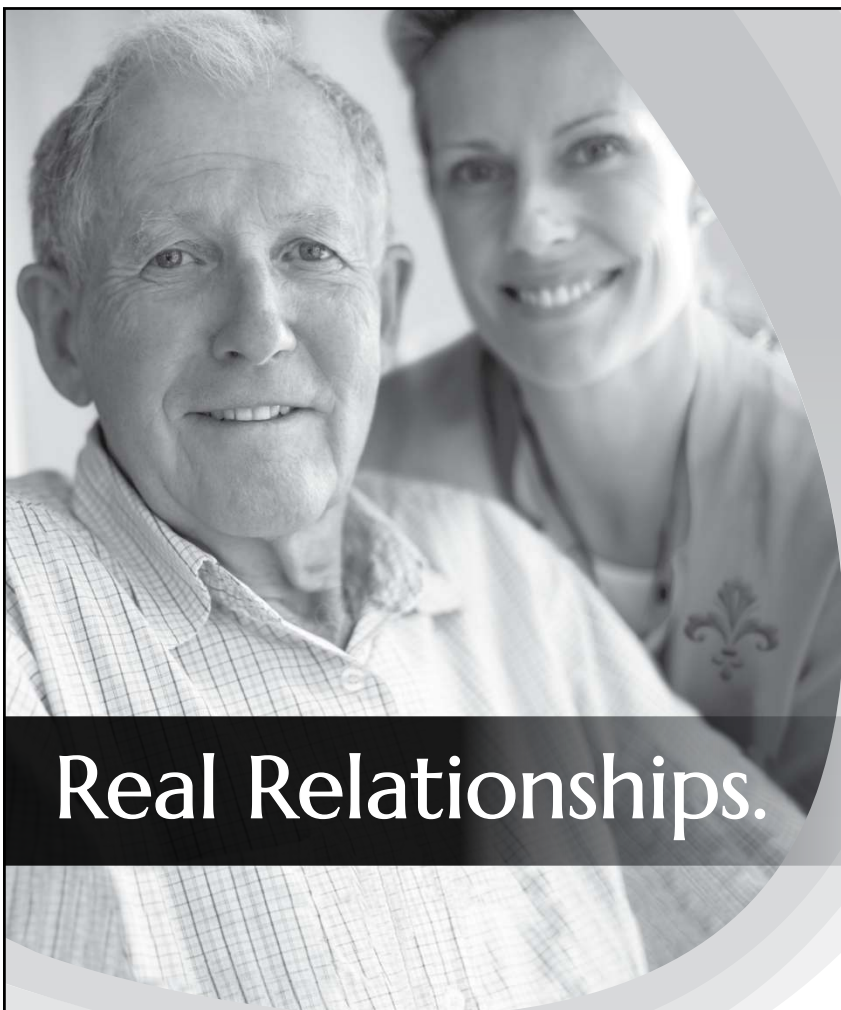

I read a wonderful biography of Woody Guthrie a few months ago that presented a detailed description of Pete Seeger and the movement Seeger led for so many years. The book was RAMBLIN MAN: THE LIFE AND TIMES OF WOODY GUTHRIE by Ed Cray. While a rich record of Guthrie's troubled life, this book also highlights a vast array of characters that brought song and protest

together: Leadbelly, the Clancy Brothers, Tommy Makem, Jack Elliott, Cisco Houston, Joan Baez, Alan Lomax, Bob Dylan... with Pete Seeger- ever present and ever the movement's moral compass. Guthrie was a much more ambiguous character- an immensely talented song writer and chronicler of the country's political and economic ills, but tortured by debilitating illnesses, family tragedies, and a ruthless determination to become a legend in his own time. This book is a tribute indeed to those men and women who with their songs attempted to create a more just society. Highly recommended!

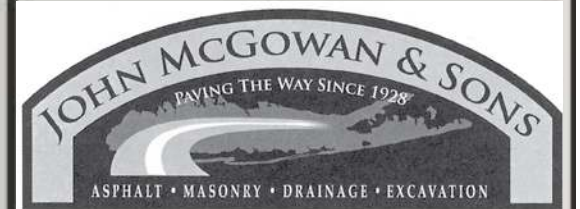

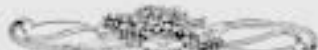

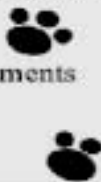
