After months of rumors that the hospital was closing its doors, a panel comprised of officials and physicians came together for an open discussion with the public.

Board of Education Honors High School Good Samaritans

The Glen Cove Board of Education commended three young men from Glen Cove High School who have been demonstrating great character in the community through their volunteerism and selfless acts of kindness. Elijah Ambles, Brandon Aviles and Corey Dinkins have been helping people out in the community for years, most recently by shoveling snow for senior citizens, the disabled and others who could benefit from their help. "These boys shoveled driveways for people all the way from the middle school to Carpenter Street...and didn't take any money," said Bonnie Arnett, one of the Glen Cove residents they helped out – who is blind. Ms. Arnett was so moved by the gesture, she contacted Glen Cove High School Assistant Principal Allen Hudson to tell him all about the help the boys were providing. Once Mr. Hudson notified Superintendent of Schools Maria L. Rianna, she shared the information with the Board and all agreed that Elijah, Brandon and Corey should be honored.

NY State Gives Sea Cliff a Positive Financial Outlook Score

Sea Cliff Mayor Bruce Kennedy was pleased to receive an excellent score from the State Comptroller's Office as it relates to the financial outlook of local governments.

New York State Comptroller Tom DiNapoli has developed a public fiscal stress monitoring system that identifies local governments and school districts that are in fiscal stress, as well as those showing susceptibility to fiscal stress. The data for monitoring system measures are drawn from the information local governments and school districts submit to OSC. The main indicators that are considered in creating a score are year end fund balances, operating deficits/surpluses, cash position, use of short term debt, and fixed costs. A score is calculated for each financial indicator to arrive at an overall score for each local government and school district, which is used to classify whether the unit is in "significant fiscal stress," "moderate fiscal stress," is "susceptible to fiscal stress," or "no designation."

Each calculation is linked to a pointbased scoring system and drives an overall financial indicator score with the potential for a total of 29 points. The score is then assigned a level of fiscal stress as follows:

- ≥ 65% Significant Fiscal Stress
- ≥ 55% Moderate Fiscal Stress
- ≥ 45% Susceptible to Fiscal Stress

The Office of the State Comptroller notified Mayor Kennedy this week that the Annual Update Document (AUD) for the Village of Sea Cliff indicates that


the Village is currently classified as No Designation with a score of 3.3%. While Kennedy was expecting to score well, he was delighted that the comptroller has recognized Sea Cliff as one of the most financially responsible local governments in New York State with a very positive economic outlook.

A review of the comptrollers website showed that both Nassau County and the Town of Oyster Bay scored 62.5%, Glen Cove scored 60%, and the North Shore School District scored 22.5%.



Portledge Student to Compete in World Championship Pee Wee Hockey



Portledge 7th grader Vincent Salgado will travel to Quebec, Canada in February to play goaltender for the Junior Islanders hockey team in the 55th Quebec Pee Wee Hockey Tournament. Salgado joins 17 other elite players to participate against 2,300 young hockey stars from 16 countries in what is considered the most important minor hockey tournament in the world. Salgado began skating at age 4 and playing hockey on the house league at the Iceland Rink near his home in New Hyde Park at eight and has sinced played on a variety of Long Island teams, including the Ice Cats and the Gulls.

Now Salgado is skating under Frank Barker, current assistant and goalie coach of the Junior Islanders Hockey team, with amazing results. He credits Barker with building both his physical and mental skills, and says he feels, "transformed." His experience speaks to the importance of good coaching in building character. If it were not for Frank Barker, "my mentor," he says, he would not be at Portledge, where he feels supported academically and on the ice, with a flexible schedule that allows him to pursue his dream. The Portledge Middle School program emphasizes character development through trying, learning from mistakes, and trying again in all pursuits: academic, artistic, athletic and social action. It is a philosophy that resonates with Vincent, who says simply, "I need to push if I want to succeed."

On the eve of playing in the World Pee Wee Championships, which attracts 200,000 fans per year and is responsible for introducing legendary players like Wayne Gretzky, Guy Lafleur and Mario Lemieux, is Salgado nervous? "Inside I get nervous. That's natural. But I'm focusing on now, year by year, game by game, it's all now."

Montesano Co-Sponsors Bill To Protect Glen Cove Hospital

Assemblyman Michael Montesano (R,I,C-Glen Head) is officially cosponsoring legislation to prevent the elimination of services by Glen Cove Hospital. Assembly bill 8327 is sponsored in the state Senate by Sen. Marcellino and would stop the Commissioner of Health from eliminating beds and services from the hospital unless a public hearing showing that there will be no negative effect on the community-at-large is held.

Montesano has been an outspoken advocate for maintaining services and beds at Glen Cove Hospital, petitioning both Commissioner of Health Nirav P. Shah and the U.S. Department of Justice to stop changes that would cost 1,200 hospital employees their jobs and severely impinge the abilities of the over 50,000 community members who rely on the hospital to receive the treatment and attention they need and deserve. This year's legislation is the next step in preserving jobs and top-notch medical care while also ensuring residents have their voices heard on this serious matter.

"Simply put: Our community needs Glen Cove Hospital," said Montesano. "We must oppose any move by bureaucrats to change the hospital, without public input, into an entity that fails to meet the needs of our residents. Glen Cove Hospital provides important services to this community and we deserve to have a voice in discussing any restructuring of the facility.

"The bill I am co-sponsoring will provide for a public hearing on this matter and would stop the elimination of beds and services at Glen Cove Hospital unless a responsible plan is put forth that meets our community's approval and maintains the high level of medical care and attention Glen Cove residents deserve."

Four Chaplains Ceremony

On Sunday, February 2nd the Nassau County American Legion held its annual Four Chaplains Ceremony at St. Mary's Church in Roslyn. The Pastor

of St. Mary's Church, Reverend John McCartney welcomed everyone. This annual event traces the history of the sinking of the transport ship the Dorchester on February 3, 1943. What made this day so special in history was the fact that the Four Chaplains gave up their life jackets so four soldiers on the ship could live. The Four Chaplains went down with the ship holding hands and singing hymns. This is the first time in history that this event was held at St.

Mary's Church. The church was near full capacity with an audience of approximately 250 people. Ralph Casey the Nassau County American Legion Chaplain coordinated the program. The National Anthem was sung by Ryan Torino and Taps were played by Dylan Smith. The choir from St. Mary's Church sang a number of patriotic songs, including the Navy Hymn with the assistance of organist Paula Berardinelli. The Nassau

County American Legion Commander Angelo Grande presented the colors. The following Boy Scouts from Troop #195 acted the part of the survivors: Eric



Busse, Joseph Doyle, Andy Vogel and Jack Vogel. The Leader of Troop #195 is Scott Rudegeair. The story of the Four Chaplains was read by Chaplain Ralph Casey. Ralph Epstein, the son of the late Ben Epstein conducted a slide presentation about the sinking of the Dorchester. The late Ben Epstein was the last survivor of the Dorchester. He passed away last year. The clergy from three religious denominations were in attendance. The

clergy read the biographies of the Four Chaplains. The Reverend John McCartney, Pastor of St. Mary's Church read the biography of Father John Washing-

ton, Rabbi Janet Liss, from the North Country Temple read the biography of Rabbi Alexander Goode, the Reverend Robert Romero, Pastor of St. Boniface Church read the biography of the Reverend George Fox and Dr. Kimberly Watkins of the United Methodist Church read the biography of the Reverend Clark Poling.

These four men who gave up their lives to save others were true heroes, in doing this they have achieved immortality. Their actions have created an enduring example of faith, courage, selflessness

MS 8th Graders Study Antibiotics Most Effective in Inhibiting E. Coli and B. Cereus Bacteria

North Shore Schools, Glen Head, NY - Students in Maryalice Kelly's 8th grade "Disease" class recently conducted a lab using the Kirby-Bauer method to determine which antibiotic is most effective on E. coli and B.cereus bacteria.

Mrs. Kelly said, "This technique is used in hospitals and medical labs to help doctors prescribe the most effective antibiotic to their patients with bacterial infections." She added, "The antibiotics that we examined were: Gentamicin, Penicillin, Streptomycin and Ampicillin."

Under Mrs. Kelly's direction, her students learned that Antibiotic Susceptibility Testing (AST) is carried out to determine which antibiotic will be most successful in treating a bacterial infection. Small wafers containing antibiotics were placed onto an agar plate where bacteria were growing. She said, "If the bacteria are sensitive to the antibiotic, a clear ring, or zone of inhibition, is seen around the wafer indicating poor growth. The size of the ring is measured."

The disc that has the largest "inhibition ring" will be declared as the most effective in killing the bacteria. Mrs. Kelly concluded by saying, "My students discovered that Streptomycin worked best on inhibiting the growth of B.cereus and Ampicillin worked best in inhibiting the E. coli."

Laurent Caballero, SAFE's Bilingual Outreach Worker and Coalition's

Parent Committee Chair has facilitated these workshops throughout the district. "Through the program, I have seen parents from the Spanish speaking community develop more knowledge & skills, become more active in the Glen Cove community, and gain the confidence they need to take home and parent their chil-

dren," said Caballero.

Parenting workshops will be made available in the spring '14 in both English and in Spanish.



TERMS OF SALE

Such tax liens shall be sold subject to any and all superior tax liens of sovereignties and other municipalities and to all claims of record which the County may have thereon and subject to the provisions of the Federal and State Soldiers' and Sailors' Civil Relief Acts.

Glen Cove Hospital

Dr. Eric Hochberg, a local physician, echoed the sentiments of many in attendance when he stated his confusion surrounding the matter. He referenced a recent statistic released by US News & World Report that placed Glen Cove Hospital in the top 15 percent of New York State hospitals. However, just six months ago, it was announced that the hospital would eliminate inpatient services.

Senior Vice President of Strategy and Business Informatics of North Shore-LIJ Jeff Kraut spoke about the residents' role in the recent struggles. According to him, the last three years have seen more change in healthcare than over the last 10 to 20 years collectively. He attributes these changes to the Affordable Care Act and rapidly advancing technology, among others. In 2012, only 30 percent of residents were treated at the hospital, which is geographically closest to them. Kraut claims that although some of this statistic is due to the need for treatments that are not offered at the hospital, approximately half of all residents seek treatment elsewhere. There has been a 13 percent decline in the number of patients within the last five years and a 29 percent decline in the last 10 years. "This is not unique to Glen Cove," Kraut said, referencing the 400 empty beds in hospitals across Nassau County.

A proposal has been made to keep Glen Cove running as a full-service hospital in the future. Many audience members questioned the definition of "full-service". "It will provide every possible service the community needs," Jeff Kraut said.

Vice President Solazzo admitted that the exact services provided by the hospital have yet to be determined. However, he did note that the operating rooms are to remain in use.

Advocate for the mayor and city Richard Garber said, "As a community and as your advocate, I think we really need to drill down and understand what the services will be and how many jobs we'll keep."

Solazzo defended the hospital's efforts during this period of confusion and chaos. "Nobody has lost jobs in any of this transition." In fact, the administration hopes to expand its 600 employees once the proposed new services are implemented in the future.

Although residents would like to see the hospital bring back many of its former services, Dr. George Dunn of North Shore Family Practice said, "We're not looking to be something we can't do well." Specifically, audience members requested the return of a pediatric unit. Dunn feels that certain care should be left to specialty hospitals. There are no plans to redevelop a pediatric program at this time.

Senator Carl Marcellino was also in attendance. He seemed to concur with an overwhelming number of residents. "This meeting should've occurred six months ago, at the beginning of this process," he said. Like many others, he hoped to feel resolved about this matter upon leaving the meeting. "You're giving us your commitment that Glen Cove Hospital will stay open."

The panel agreed that another meeting is likely to take place to update the public on any new developments. Dr. Dunn emphasized that in order for the hospital to thrive, its administration must work together with the community. "We're going to have to learn, but you're not going to have to go a distance for primary and secondary care."



My friend Jim Doherty mentioned Elmore Leonard as an author I might enjoy. Any thoughts? Be My Valentine

Dear Valentine.

I had never read any Elmore Leonard until recently and I do think you might find him a good choice. Known as the Dickens of Detroit for his colorful characters and conversational flavor. Leonard has written over thirty novels, many that have been made into movies and television series ("Get Shorty", "Justified", "Out of Sight" among others}. His early books were Westerns but later he concentrated on contemporary Detroit and its surroundings- always with desperate but decent heroes who show little respect

On January 16th at the BOE/Town meeting, Superintendent Dr. Edward Melnick presented the Initial 2014-15 for the North Shore School District.

2014-15 BOE Budget Goals

As part of the budget goals, Superintendent Melnick made the following clear:

- · Trustees and administration would maintain a budget that is responsive to current economic pressure and remains within the permissible tax levy limit
- · Resources in the budget would be reallocated to fund initiatives aligned with our district vision and mission (e.g. IB Program and World Language Program)
- · We would work collaboratively with the community in the preparation of the bud-

Preliminary Budget Numbers


Dr. Melnick explained that the Preliminary 2014-15 proposal is \$97,101,191 (this is an initial draft). To remain within the allowable tax levy limit, Trustees in the months ahead will still need to cut an additional \$933,166 (approximately) from this proposal, resulting in a final budget of \$96,168,075. 


