## Waterfront Redevelopment Discussion

Mayor Reginald Spinello organized a meeting on Wednesday, Feb. 19 at Glen Cove City Hall to discuss the plans for the waterfront redevelopment project.

Rick Parisi, a landscape architect with M. Paul Friedberg & Partners, reviewed the proposal with the public using a series of images that project the future appearance of the land upon completion. If approved, the new waterfront will include several parks, pathways, recreational space, as well as retail, a café, and an amphitheater. There will be

## Surveillance System Catches Burglar In The Act

On February 13th the Glen Cove Police received a call from a homeowner from Marietta Road in Glen Cove. Although the homeowner wasn't at home she had a home surveillance system installed in her residence which allowed her to monitor her home via a smart phone.

According to Det. Lt. John Nagle, The homeowner was shocked when she observed an unknown person inside her home and immediately notified the Police. Glen Cove officers Vincent Oppedisano and Eddy Linares responded and observed a front window open. The Officers while checking the rear of the residence observed the defendant flee from the house from a rear sliding glass door. The Officers gave chase as the defendant jumped a rear fence at that location and as he was attempting to scale the fence of the adjoining yard he was apprehended by the Officers. The defendant was identified as David Bradford age 26 of Flushing Queens. The defendant has numerous prior arrests. The defendant was charged with Burglary 2nd degree and Possession of Burglars Tools. The defendant will be arraigned today in District Court.

28.8 acres of open space allotted to the development.

Multiple parks will feature open space with shaded seating. Renaissance Park will also boast an 8,000 square foot playground. Additionally, there will be a full-service marina and observatory pier at Yacht Basin Park.

After hearing the plans, Parisi invited audience questions. One of the main public concerns was that there is only one prospective road leading into the area. "That's a project being built apart from our project," Parisi said. He did not comment on who is leading this segment of the project.

However, he did go on to say there would be parallel parking available on both sides of the road leading to the marina. There will also be a parking that the

public will share with residents of a Glen Cove apartment building on the water-front. The public can also utilize the two levels of parking underneath the building. Although many in attendance were eager to know the exact parking space plans, the project's representatives could not offer many details.

"The city has its own traffic and open space consultants. There's an elaborate parking plan," City of Glen Cove attorney and special counsel for this project Michael Zarin said. He did note that there would be approximately 1,700 to 1,800 parking spaces in total. Signs will be created to designate certain parking areas. He emphasized that the goal of the meeting was to share the general proposal with the residents, not to explain in detail every element of the project at this

time.

"One of the overall objectives of this project is to link public amenities with residential areas," Zarin said. He went on to explain that the private entities surrounding the waterfront are likely to maintain it well in an effort to increase their property value.

Most of all, the audience was anxious to know what stage this project is in. Vice President and Project Executive with RXR Thomas Graham claimed that construction is hoped to begin next spring.

Spinello announced another meeting with greater detail early this spring.

"This project has come a long way, but there are a lot of moving pieces to it. It's a living, breathing organism," Zarin said.








## Green Vale Students Take First Place in the Nassau County SumDog Math Competition

## Eight North Shore High School Athletes Sign National Letters of Intent



### SAFE, Inc. PRIDE Project Coalition Partners with NYS OASAS and the New York National Guard Counterdrug Task Force to address community concerns



# TO THE EAST A FOUR MONTH JOURNEY

## Two Chomps In Thailand

I awoke at sunrise and walked out of my bungalow directly onto the golden sands of the Hornbill Bungalows' private beach. CoCo, the family's golden retriever, was the only other creature stirring; we sat in the sand together, my feet buried in the gold and his paws on my legs. Looking out across the pristine Andaman Sea, I found the Thailand I was searching for: a deserted, unspoiled island without Wi-Fi, modern plumbing, air conditioning and, most importantly, tourists. Electricity is only run on generators for a few hours each night. For me, this is paradise.

Julia and I were spoiled by Vietnam and Laos, both of which we visited during the low season for tourism. The Thai islands have long been vacation destinations for an array of travelers, especially popular among Europeans, Russians, and Chinese tourists. It only takes one step on those white sand beaches to understand what has made Thailand so loved by visitors, but many of the country's more beautiful islands have turned into overcrowded tourist traps or been spoiled by an excess of partying Farang (Thai slang for western tourists).

A more authentic trip to Thailand can still be salvaged, so don't waste your precious vacation time following the crowd. There are still plenty of unblemished Thai islands left to explore, just ask the locals. I took advice from two expat restaurateurs in Bangkok who have lived in Thailand for over ten years. The owner of the café Chomp - the name catching my attention for obvious reasons - drew me a map of the best islands from her twelve years of experience in the country.

This map lead me on an overnight barge journey, on which I slept in a cargo hold full of bunk beds and had the most comfortable sleep in weeks. After traveling across the peninsula, I took a small commuter boat which dropped me directly on to the golden sands of Koh Chang Noi (little Chang island) and the Hornbill Bungalows. Not to be confused with the larger Koh Chang on the Gulf, this small, elephant-shaped island is home to a tiny population of Thai locals and resident ex-pats.

The sand truly is gold - not the yellow beaches of the Hamptons or the white sands of Mexico and most of Thailand's tourist beaches. On the private beach of the Hornbill Bungalows, I paid ten dollars a night for golden sand and crisp blue water the temperature of a warm bath. After one afternoon, I understood why the lovely owners, Mr. Ao and Mrs. Jib, said they never wanted to return to Bangkok.




Prior to my stint in utopia, I spent a week on Koh Tao, the diving capital of the world. I was warned by my Chomp counterpart that, while it is overcrowded with Farang, the island is still worth a visit for the price and ease of getting certified; with more dive shops than any other island, it only takes one week to achieve an advanced 30m (98ft) diving certification. Apart from the lure of diving, the small island still maintains its beauty and laid back atmosphere despite its touristic charm. It is a running joke/ truth in the expat community that the island is impossible to leave. I certainly began to feel that way in my final days there; those who do stay are some of the craziest, funniest people I've ever met, truly a welcoming and kind family of ex-

A week after pulling myself away from Koh Tao, lazily sitting by the sea on Koh Chang Noi, I watched a dive boat glide off the water and onto the shore. Mr. Ao acted as my tour guide for the day and drove me around the tiny island, where we swam in the reservoir and shared a beer with the general store owners. As we sat on Ao Yai, the main beach, and watched the ship anchor, Mr. Ao called out in greeting to the men disembarking the boat. They had just returned from a dive trip to the Similan Islands, and my recently developed interest in diving sparked up a conversation. The next morning, I was picked

up by the same boat, now headed for the near shores of Myanmar and a seven day dive trip of the country's beautifully preserved reef. I waved at my Hornbill hosts until the last glimpse of gold was out of sight, then looked out at the horizon of the Andaman; from this moment onward, I realized, diving was about to become a focal point of my trip to the

He was known for playing eccentric characters such as the nosy neighbor "Clarence Appleton" in "Sitting Pretty" (1948) with Maureen O'Hara and Robert Young and "Jonathon Wilson", Jennifer Jones' character's fiancé, in "Cluny Brown" (1946). He was a regular on the "Burns and Allen" Radio Show and was readily recognized for his deliberate over-nasal and over-enunciated speech manner of stage delivery. He was particularly memorable as "Thomas, the Man-servant" in "And Then There Were Ten", the 1945 adaptation of Agatha Christie's murder mystery book, "Ten Little Indians", with Walter Huston and Barry Fitzgerald. For the baby-boomers, he may be remembered in the 1964 episode, "The Mad, Mad Tea Party Affair" of Robert Vaughn's "The Man From U.N.C.L.E." and as the Japanese businessman in a 1968 episode of Elizabeth Montgomery's "Bewitched", titled "A Majority of Two". The original "Twilight Zone" aficionados may remember him for his portrayal of "Mr. Bartlett Finchley", a quirky, self-absorbed technophobe, who is confronted by every machine in his home in the episode, "A Thing About Machines".

Last week's celebrity was B.D. Hyman. She was also known as Barbara Davis Sherry and Barbara Merrill, which she was credited as in "Whatever Happened to Baby Jane?". (1962) She is the daughter of film star Bette Davis and artist William Grant Sherry. Bette Davis and Sherry divorced in 1950 and Sherry married B.D.'s nanny, with whom he had two more children. When Bette Davis married her fourth husband, actor Gary Merrill, he adopted B.D. and she took his last name. However, she took back her last name, Sherry, upon turning sixteen, claiming she wished to distance herself from Merrill. She appeared in two movies with her mother, "Payment on Demand" (1951) and "Whatever Happened to Baby Jane?" (1962). B.D. met Jeremy Hyman, the British nephew of Seven Arts owner, Elliott Hyman, on a blind date for the film's ("Baby Jane") showing at the Cannes Film Festival. In 1963, the couple wed when B.D. was sixteen and Jeremy was 29. Her mother gave her consent and publicly supported this "underage" marriage. The couple remain together and have two sons. In 1985, B.D. wrote two books highly critical of her mother, which was met with mixed sentiment by the public. In 1987, Bette Davis wrote her own memoirs and described in an open letter to B.D., all the inaccuracies of her daughter's books. Bette Davis eventually disinherited her daughter. Today, B.D. is a TV evangelist and pastor of her own church and ministry in Charlottesville, Virginia.

I attended a fabulous Presidents' Day brunch over the weekend, and one of the fun things we did was choose our favorite president. Many of us, myself included voted for Theodore Roosevelt. I have visited Roosevelt's homes in Oyster Bay and Manhattan, read a number of his biographies, but I would like to learn still more about this fascinating man. Any thoughts? A Fan of T.R.

Dear T.R. Fan.

I too have always been fascinated by our 26th president. I just finished a great book by a favorite author of mine- Doris Kearns Goodwin: THE BULLY PULPIT. This is more than a standard biography of a president- it delves into Roosevelt's relationship with his handpicked successor William Howard Taft and also the role journalists played in creating the narrative of Roosevelt's life before and after his election. In fact the subtitle of the book is "Theodore Roosevelt, William Howard Taft and the Golden Age of Journalism. Taft and Roosevelt make for such a wonderful contrast- the sickly child who devoted his life to becoming

healthy, athletic, and fit and Taft, robust as a child, who went on to spend his adult life unsuccessfully fighting severe obesity. Both progressives, Roosevelt was the consummate politician and friend of journalists while Taft had little political acumen, shunning interviews and photo ops . Despite these differences, they had an intense friendship which came to a devastating end when Roosevelt decide to run against Taft for reelection with Democrat Woodrow Wilson winning the election. It was only years later, shortly before Roosevelt's death that the two men were to reconcile. A very long book (900 pages), BULLY PULPIT gives us an interesting look into a time when the presidency, politics, and the media were all reconfiguring. A very worthwhile and enjoyable read!






