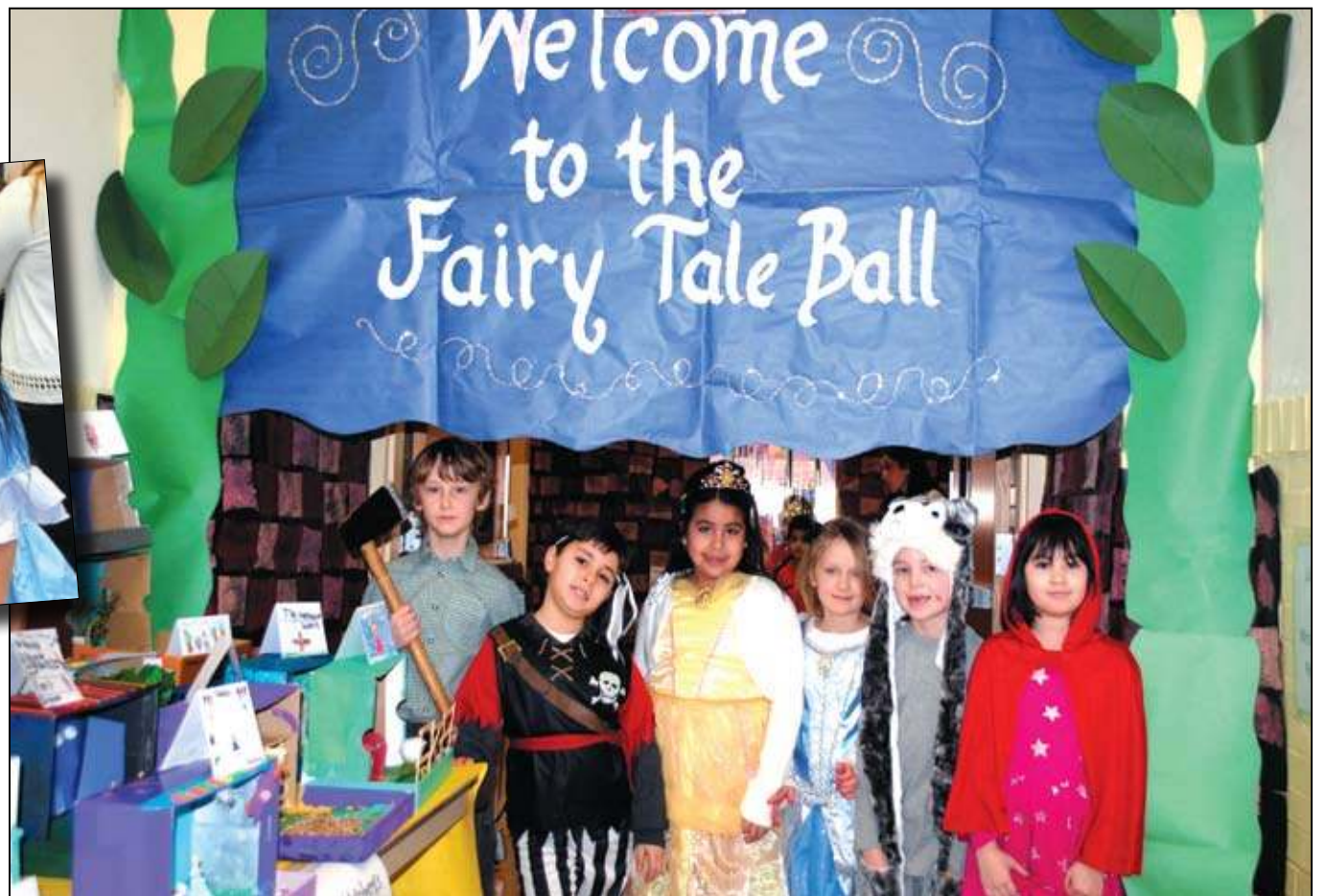


## First Graders Celebrate the Fairy Tale Ball

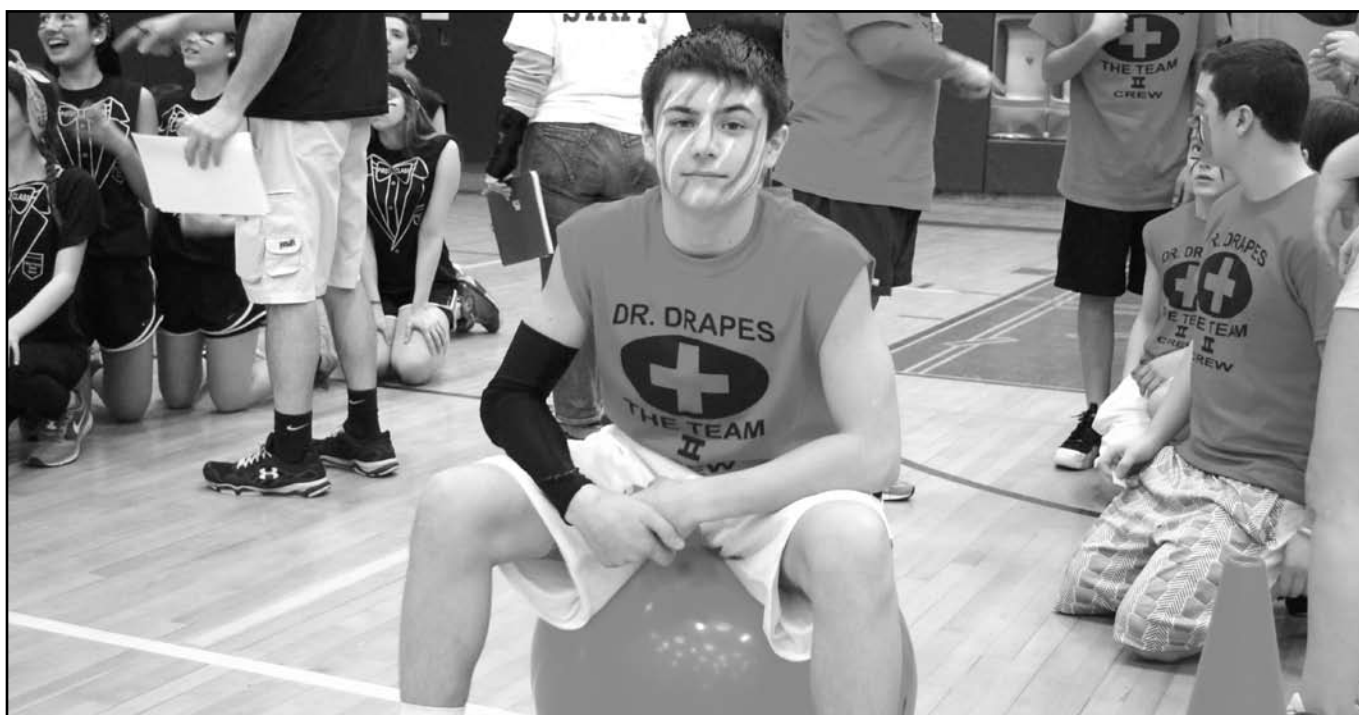
# Annual North Shore Middle School Team Challenge

# Letters to the Editor

## The Glenwood Landing Power Plant

### To The Editor,

I have read several articles and letters to the editor about "saving" the massive Glenwood Landing Power Plant main building and converting it to a community center or some other public facility.

Not once have I seen anyone lay out the cost to do this, and to maintain and run the huge edifice for such a purpose.

Just the cost of converting this large multistory structure for any community use would be in the range of 25 to 50 million dollars, possibly more. This would include full restructuring of the interior to meet current code, a complete new HVAC system, elevators and ramps for the handicapped as well as facilities, offices, public space, windows, water and electric modifications and on and on.

In addition, before this could start there would have to be an architectural site plan and a final site plan that would have to go before the Zoning and Planning Boards (attorney, engineering, architecture, and other costs) and be approved.

Even if approved and finally completed the annual cost of maintenance alone (including utilities and staff for this) could range from \$300,000 to well over \$500,000 per year. This does not include the cost of the functional staff and the cost of the programs and materials needed for operation.

Because this building is in the Town of North Hempstead and not in the Town of Oyster Bay (TOB), even though it is in Glenwood Landing, the Town of North Hempstead (TNH) would control the process. Interestingly enough the parking across the street is mostly in the Town of Oyster Bay.

That also means that the taxes needed to create and run the facility would have to come from the few Glenwood Landing properties in the TNH and from all of the property owners in the TNH, raising the question of not only who would pay for but who would benefit from any community project on this site (assuming that the taxpayers in TNH and TOB even agreed to foot the bill.)

Perhaps the proponents could come up with a financial plan that would not raise taxes, and a plan for a fully shared facility, if they are serious.

# Name the Celebrity



This week's celebrity may be a little more difficult than usual. He has the face you recognize but the name escapes you. He was born in Manchester, England on Oct. 1, 1903. His father was a merchant of Greek origin .....that's a clue! He was raised in England and attended London's Central School of Speech and Drama, in the company of fellow student, Sir Laurence Olivier. His stage debut was in 1926 with "Henry V" at the Old Vic, and by 1929, he made his first Broadway appearance, followed by his first Hollywood film role in 1933. A major impact on his life was Orson Welles, whom he met in 1936, when they both had roles in the Broadway production of Sidney Kingsley's "Ten Million Ghosts". Welles invited our celebrity to join his Mercury Theatre, and in 1937, he performed the role of "Mark Antony" in the company's debut production, an innovative modern-dress production of "Julius Caesar". In "Citizen Kane" (1941), he played "Walter Parks Thatcher", a financier similar to J.P. Morgan. He won a National Board of Review "Best Actor Award" in 1941 for his performance in "Citizen Kane". Orson Welles was the only other "Citizen Kane" actor to win the same

award. In 1940, in "All This and Heaven, Too", he played the spying man-servant, Charpentier, to Charles Boyer's "Duc de Pralin" and Bette Davis' "Henriette Deluzy-Desportes". In 1944, he played the gangster "Jim Mordinoy" with Cary Grant, Ethel Barrymore and Jane Wyatt. If you know our celebrity call us at 516-671-2360 or e-mail: mail@goldcoastgazette.net

Last week's celebrity was born George Richard Haydon, but known professionally as Richard Haydn. His nasal twang may be remembered by the baby-boomers in his performance as the voice of the "Caterpillar" in the 1951 Disney animated adaptation of "Alice in Wonderland". However, there were times that the "twang" was put away, such as in his role of "Alfred North" in "Please Don't Eat the Daisies" (1960) with Doris Day and David Niven. He switched to a "burrrrrrr" in his role of Scottish schoolmaster "Jason Reid" in "The Green Years" (1946) with Charles Coburn and a young Dean Stockwell. Remembering his fellow actor in his role as "Herr Falkstein" in "Young Frankenstein", Mel Brooks said of Haydn's way of dealing with Hollywood's pressures, "He used gardening and horticulture as a means of escape from the Hollywood grind and eschewed the Hollywood lifestyle." Perhaps his most acclaimed role was as "Uncle Max Detweiler" in Rodgers and Hammerstein's 1965 film musical "The Sound of Music" with Julie Andrews. On April 25, 1985, at the age of 80, he died after a heart attack in Los Angeles, California.

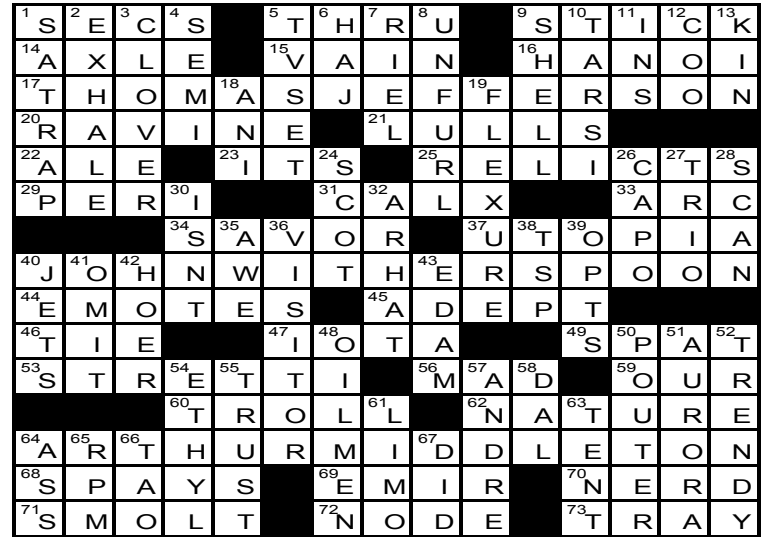

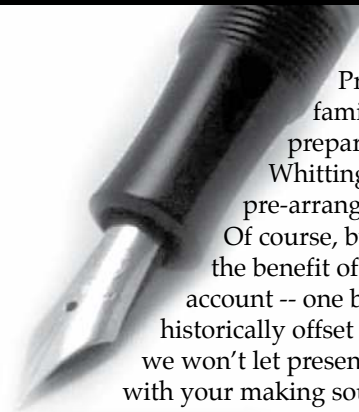

## Mayor's Column

**HOSPITAL:** I coordinated a town hall meeting held in City Hall on February 12 to discuss the status of the Glen Cove Hospital. It was great to see so many residents from Glen Cove and our surrounding communities join my colleagues in government, the Committee to Save Glen Cove Hospital, physicians, nurses and staff from the hospital. We had a lively discussion that quite a few people said should have taken place more than eight months ago. The Hospital COO, Mark Solazzo, Dr. George Dunn, the hospital's Chief Medical Officer David Battinelli, a hospital senior vice president, Jeff Kraut, and the hospital's executive director Susan Kwiatek fielded our questions and provided us with a firm commitment that the hospital will continue to provide inpatient beds based on the needs of the community. Additionally, surgery along with an anesthesiologist will continue on a 24-hour basis.

**WATERFRONT:** On February 19 a town hall meeting was held to discuss the public amenities and open space components of the redevelopment project. A detailed description of public parks and amenities that will be built funded and maintained in perpetuity by the redeveloper, RXR was shown to the many members in attendance. Among the many items for public use will be a connection to the Garvies Point Preserve, small boat basin, kayak and paddle boat rentals, lawn amphitheater, playground, restored wetland ecology and habitat, full service luxury marina, yacht slips, restaurants, ferry terminal, esplanade bike path, cafes, coffee shop and restaurants.

**VERIZON FIOS:** I have coordinated a public hearing that will be held at 7:30 P.M. on March 11, 2014 in the Main Chambers of City Hall, for the purpose of considering a proposed initial franchise agreement for cable television service in Glen Cove with Verizon New York Inc. For your convenience, copies of the franchise application and of the proposed franchise agreement are on file at City Hall and may be viewed during normal business hours, between 9:00 A.M. and 5:00 P.M., Monday-Friday. A copy of both documents is also available on the City of Glen Cove website: www.glencove-li.us.

**EARLY RETIREMENT INCENTIVE/HEALTH BENEFITS CONTRIBUTION:** Since 1995, the premiums for health insurance have quadrupled and to reduce the cost to our City's taxpayers I redefined the eligibility requirements for future employees and retirees. Effective January 1, 2015, only full-time City employees will be eligible for health insurance and employees hired after January 1,

2015, unless required by a collective bargaining agreement, must have ten years of full-time public service within New York State whereby five years of which must be with the City of Glen Cove to be eligible to continue on the City's health insurance plan upon retirement. In addition, unless otherwise required by a collective bargaining agreement, City employees hired after January 1, 2012 that are otherwise eligible for health insurance are responsible to pay 10 % of the insurance premium. Of those employees eligible to continue in the health plan upon retirement, they are responsible to pay 10 % of the insurance premium each month to remain on the City's insurance plan.

**CARBON MONOXIDE DETECTORS:** As specified in our municipal code, the installation of carbon monoxide detectors is mandatory for multiple dwellings, as well as in one and two family dwellings. The detectors are being installed in all City buildings and I have begun working on legislation to require their installation in all places of public assembly. Having checked with the director of facilities for our school district, I was pleased to confirm that all our school buildings are equipped with the detectors.

**THE PIAZZA:** The Piazza project in our downtown is currently moving through our planning board process. The project is a mixed use development that includes residential over 25k sq. ft. commercial/retail. Additionally, the project includes 20k sq. ft. of open space in the heart of our downtown. A Panera Bread drive-through is being proposed as part of the project.

Dear Enthusiastic,  
 I love this event too- the best part for me is seeing all of Sea Cliff out and about after the numbing isolation of winter. I have an interesting book that is a quirky sort of mystery, character, historical and geographical study: THE LAST ANNIVERSARY by Liane Moriarty. Set in Australia and in particular on a picturesque island a short ferry ride from the mainland, the novel is told from varying perspectives and over a number of years starting with the 1930's up until 2010.

The novel's focal point is "The Baby Munro Mystery"- Alice and Jack Munro disappeared over seventy years ago from a small cottage on the island- the couple left with a marble cake cooling, a pot of tea ready to be poured, a trail of blood, and, oh yes, an infant daughter lying happily in her pram. 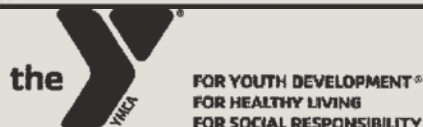
