



Mother & Son Arrested For Multiple Felonies

The Glen Cove Police received a frantic call for help from a resident in the Landing area in Glen Cove at 11:19am on March 11. The police arrived and spoke to the homeowner at the scene.

The front door to her house had been forced in and the homeowner told the officers that the persons responsible were still at the scene. Lieutenant Nagle arrested a Glen Cove woman named Laura Purnell age 40, and Detective Glennon arrested her son Jesse Thomas age 21.

Its alleged that Purnell attempted to rob the homeowner minutes earlier on Coles Street in Glen Cove but the victim was able to get away and managed to get back to her residence in the landing area. After the complainant returned home, the defendant and her son proceeded to the victims house at which time Jesse Thomas kicked the

Verizon Comes to Glen Cove

The Glen Cove City Council held a public hearing on Tuesday, March 11 at Glen Cove City Hall.

Mayor Spinello called the meeting to discuss a proposal from Verizon to break Cablevision's monopoly as the only cable provider to serve Glen Cove for the last 25 years.

Cablevision attorney Jeff Forchelli argued that Cablevision has long been a loyal and reliable provider to the community and offers a superior franchise agreement to that of Verizon. "How could this happen to an entity that has been here for so long? It's just unfair," he said.

Vice President of Government Affairs for Cablevision Adam Falk felt that the proposed agreement discriminates against his company. "Cablevision is not afraid of Verizon," Falk said, emphasizing that Cablevision welcomes competition. Falk reminded the audience that Cablevision has been very supportive of the community. In response to demand, Cablevision was able to offer Public Education Grants to the city of Glen

Cove. It asked in return that should residents ever turn to a new provider, the city request the same funding from that entity. The potential contract with Verizon, however, asks for much less.

Falk added that Verizon is unwilling to make certain provisions in its contract that Cablevision has long instilled, such as claiming accountability for any property damage the company may incur. "They're really shortchanging the city and its residents," he said.

He also noted that Verizon provides benefits to many communities on Long Island that are not to be provided in Glen Cove, as per the contract. "The grants they've given to other communities surpassed the ones they're willing to give here," Verizon denied the accusation.

Cablevision is headquartered on Long Island, invests in the communities, and largely employs locally.

Verizon Attorney Paul Trane then took the podium. He scrutinized Glen Cove's contract with Cablevision, saying that the language of the contract is convoluted and allows Cablevision to take

away the benefits it offers at any time.

Mayor Spinello shifted the focus to Verizon's prospective agreement. As such a large corporation and one trying to win over residents, Spinello questioned why Verizon's contract proposes less than the current one with Cablevision. Trane did not seem to have a clear answer, yet continued to say that there cannot be a level playing field while Cablevision monopolizes the city and that competition will force rates down for the residents.

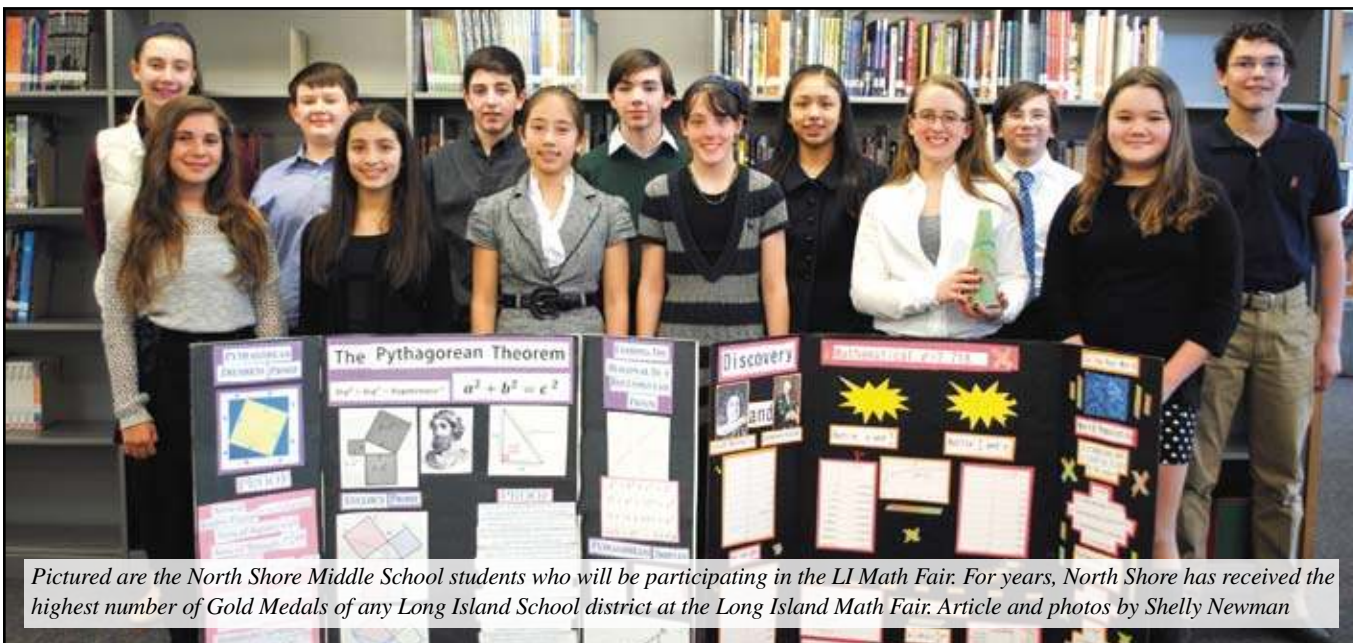
Spinello requested increased grants from Verizon in order to gain council support. Trane agreed to double the original \$21,000 proposal to \$42,000 in grants to the city.

One resident, Mike McMahon, voiced his frustration with Cablevision. After calling its service center, he was told that the senior discount many customers enjoy does not apply to Glen Cove residents.

Brian Pemberton, a resident and Verizon employee, felt that Verizon FiOS is

McGilloway, Reali and Villafane Appear at Sea Cliff Meet the Candidates Night

Sea Cliff residents turned out for the Civic Association's Annual Meet the Candidates Night on March 6th. Addressing the audience were Kevin McGilloway, a first time candidate for Village Trustee; Elena Villafane, who is seeking a Trustee seat after serving on the Board from 2003 to 2008; and John Reali who is running for his 7th term as Village Justice. Current Village Trustees, Peter Hayes and Tom Powell did not seek re-election.

Kevin McGilloway, a 27 year resident of Sea Cliff, is a current member of the Zoning Board of Appeals and served as the Chair for five years. If elected he will step down from the Zoning Board. In his opening remarks, he stated that he and his wife, Jane raised four daughters in Sea Cliff and both have been active in school programs. He is also a Board member of the Henry Viscardi School (for severely disabled children) and Abilities Inc. (for retraining disabled adults), both in Albertson. Professionally, he has used his MBA in Finance and a MS in Computer Science for a successful career with Lehman Bros and AXA/Equitable. McGilloway stated: "Over the next two years there will be a number of important issues to address, from dealing with a shifting tax base through revising village statutes to keep them current. In order to effectively deal with these opportunities and issues, I commit to you that I will listen to the Sea Cliff population and then work with the Mayor, the other Trustees and Village volunteers to address those issues and realize the opportunities."

Elena Villafane, a 34-year resident of Sea Cliff, is a practicing attorney and partner in the Glen Cove law firm of Pollin, Prisco and Villafane. She's a graduate of Union University, Albany Law School and the College of Mt. St. Vincent. Villafane began her remarks with a statement about her previous Trustee experience. "My prior years of service as a Village Trustee provided me a first-

hand opportunity to gain a deep understanding of the issues facing the Village. During that time, I worked closely with many of the organizations in the Village and on numerous programs. As a result of that experience, I realize that it takes commitment and dedication to get the job done. But what I accomplished in my prior terms is only noteworthy as a testament to my ability to get the job done. The specific accomplishments are not all that interesting because they have become such an integral part of today's Village. It is hard to remember what the Village garage looked like in 2003, before it was renovated, or what the beach area looked like before the boardwalk was finished. What they do show is that I come to you fully versed in the workings of Village government and can hit the ground running on day one."

John P. Reali, a 38-year resident of Sea Cliff has been the Village Justice since 1990, following 10 years as a Village Trustee. Reali is a practicing attorney and past Director of the Nassau County Bar Association. In 1994, he received the New York State Bar Association Pro Bono Attorney of the Year for Nassau and Suffolk Counties Award. In his remarks, Reali stressed his philosophy of treating everyone who appears in his court with the respect and dignity that all citizens deserve.

In the question period, Sea Cliff resident, Doug Barnaby asked the candidates if they would consider the creation of a committee or board to review actions of Village appointed board members if there is a concern for possible ethics breaches. The Trustee candidates replied that if elected they would consider it. All the candidates thanked the Sea Cliff Civic Association for sponsoring the event and, while there are no opposition candidates, they urged residents to show support by voting on Tuesday, March 18, between 12 noon and 9:00 pm at the Village Public Works Building on Altamont Avenue.

Second Concert Festival Orchestra

Performance Features Eight Talented Youths

On March 2, 2014 at the Connetquot Public Library in Bohemia, NY, the Concert Festival Orchestra, led by Maestro Vladimir Polezhayev, gave its second public concert in a performance featuring eight soloists: seven pianists and one vocalist.

The orchestra began the festivities with an elegant reading of the 1st Movement of Eine Kleine Nachtmusik. We appreciated Maestro Polezhayev's understated interpretation that allowed the music to speak for itself, beautifully. The first soloist, 11 year-old Brian Tsai, gave an energetic performance of Bach's Concerto in d minor, 1st Movement. Mingzi Yan, at 9 years the youngest performer of the day, was next playing the 1st Movement of Bach's Concerto in f minor at a fast clip with very even finger work. The third performer, Michelle Wong, 15, performed the 3rd Movement of the same concerto with the sophisticated phrasing to be expected of an older musician. Rachel Martini, 12, played with flair in a performance of the less well-known Polunin Concertino in a minor.

After intermission the program resumed with Mahesh Tiwari giving a restrained interpretation of Mozart's famous d minor concerto, 1st Movement. 15 year-old Tara Mathias-Prabhu showed drive in her rendition of the 1st Movement of Mozart's 12th Concerto in A Major. Christian Wong, 11, gave a

spirited interpretation of the 3rd Movement of Haydn's charming and underplayed Concerto in D Major.

The concert finished with vocalist Gwyneth Campbell singing the haunting "Ritorna, oh caro e dolce mio Tesoro" from Handel's opera Rodelinda, and the famous and very demanding "Alle-

luja" from Mozart's Motet "Exsultate, jubilate". Miss Campbell, who was chosen to represent the U.S. singing at the Vladimir Spivakov International Charity Foundation's "Moscow Meets Friends" last summer, had color, dynamic and breath control, interpretive ability, and a vocal range unexpected for her age.

The high C that ended the Alleluja was thrilling. The festivities ended with Mingzi Yan receiving a stuffed bear as the youngest performer, and Gwyneth Campbell receiving a bear and serenade by Maestro Polezhayev, this time at the piano, to wish her happiness on her 15th birthday.

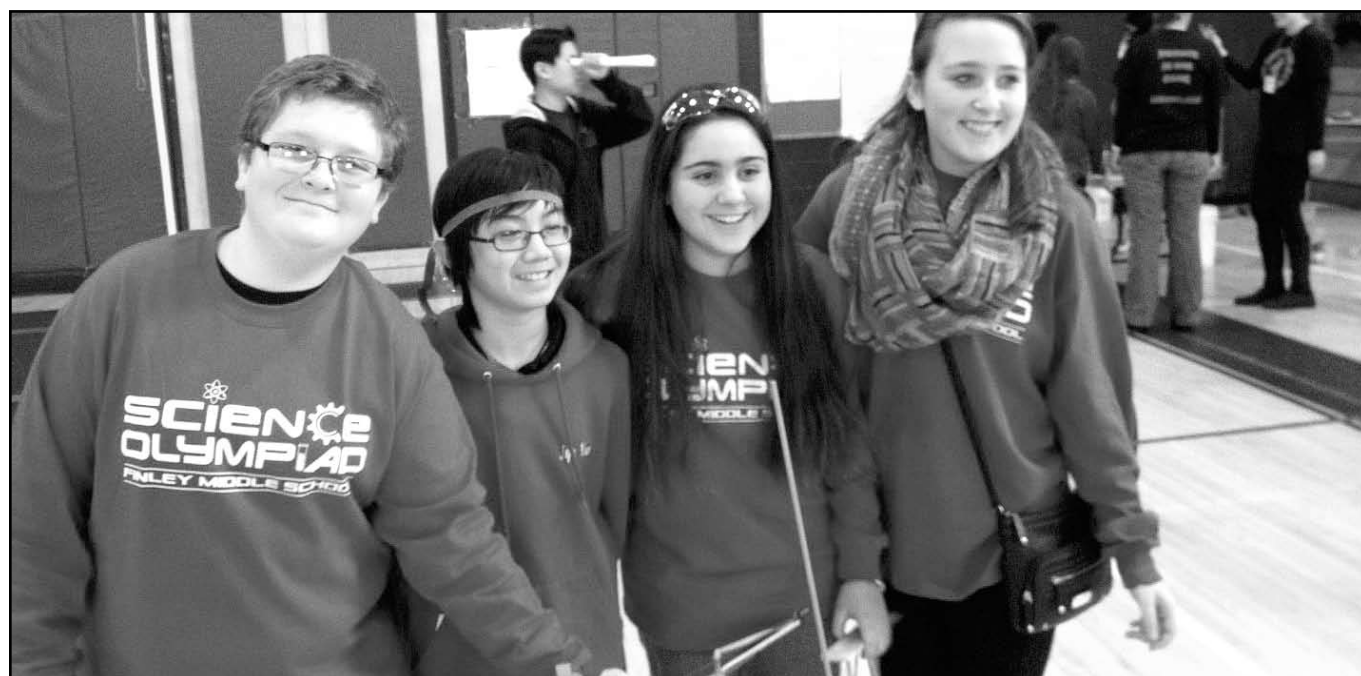

“Verizon FIOS or Cablevision, Two Choices are better than One”

To the Editor,

For the past three years many residents of Glen Cove have reached out to me and shared their frustration with having only one choice for a cable provider. Throughout my first and second terms on the City Council, I have consistently argued in favor of allowing and acquiring Verizon FIOS to be a cable option for the residents of Glen Cove. On Tuesday, March 11th, the Glen Cove City Council voted 5-2 in favor of approving a Cable Franchise Agreement between the City and Verizon.

I have done my due diligence and taken the time to understand and comprehend the compelling arguments made by both Cablevision and Verizon. However, at the end of the day, my rationale for voting in favor of allowing Verizon FIOS as a franchise can be summed up in one word, choice. I believe that choice for the residents trumps all of the other arguments. My guiding principle is that the people of Glen Cove should have the ability to choose another cable provider if they desire to do so. Furthermore, I believe that the residents will achieve monthly savings as Verizon and Cablevision compete for Glen Cove customers.

For decades, the people of Glen Cove had only one option for cable television. I believe that this vote is a victory for many Glen Cove residents because two choices are better than one.

Health and Human Services Update

To The Editor,

When I began my second term this year as a Nassau County Legislator, I was proud to be named Ranking Member of the Health & Human Services Committee.

Health issues have always been a priority for me. My own daughter was diagnosed with type one diabetes at the age of three, which caused me to become active on health-related concerns.

As a board member of the Long Island Diabetes Research Institute Foundation, my involvement in local efforts has led to about \$800,000 in fundraising for diabetes research, which I believe is rapidly pointing to a cure. I also actively seek to engage with other local health efforts, like the wonderful Glen Cove CARES and Relay for Life events. I have honored people at the Legislature who have made major strides in raising awareness and funds as well, such as Laura and Anthony Perfetti, who have done so much to promote the Children’s Tumor Foundation, and Lori Schneider and Matthew Ruderman of Penelope’s Odyssey, who focus on improving the lives of children with cancer.

There are two specific health and human services related items that have come up this month within my office that I would like to share.

First, I was glad for the opportunity to participate in the affidavit process supporting state legislation by Senator Carl Marcellino and Assemblyman Chuck Lavine. The legal proceeding we signed sought to stall closures at Glen Cove Hospital until a public hearing could be held, based on their legislation. I had been meeting with the hospital but I also believed a public hearing should have been held. It is good to hear that the hospital has come to promise relocation for displaced employees and a functional in-patient operation based on what our community needs. I will continue to do what I can to ensure that my constituents concerns are addressed related to this matter. Anyone with questions or issues should feel free to contact me.

A recent Health & Human Services legislative item involves funding we recently approved for a revolving grant program aimed at preventing homelessness. The Emergency Solutions Grant program is 100 percent federally funded, so the monies we allocated create no additional cost to Nassau County taxpayers. It provides speedy housing assistance to individuals and families who are experiencing a housing crisis or homelessness. It can help people who are in arrears with rent or utilities and the

program aids those in need of housing. If you know someone who might need more information, they can call the Nassau County Department of Housing & Homeless Service at 572-1900.

Please Ask the School District to Stop Wasting Your Tax Dollars!

To the Editor,

In this critical time of budget concerns facing our public schools today, the district must use care not to waste our tax dollars. Especially on runaway legal fees that could be used for staff and educational purposes. Please ask your Board of Education how much money they have used out of the legal fund to pay for the following matter:

As a valuable taxpayer to the North Shore School District who pays about \$13,000 every year to the district and whose children do not attend the public schools, I bring more money to the district than those with attending children. Not only do I pay significant school taxes, but estimates are that I am saving the district \$42,000-\$46,000 p/yr by educating my 2 children in a non-public school. In exchange, the law provides that I shall receive transportation of my children to and from the school at a cost to the district so long as I submit a written request by April 1 for the following September. NYS Educ. Law 3635(2) requires school districts to provide bus transportation to non-public school children in recognition of the fact that their parents effectively pay tuition twice. Also, the district is directed to make exceptions to the deadline whenever there is a reasonable excuse provided for the delay.

Last spring, I timely requested bus service for each of my children then attending different schools. However, due to important reasons for my son, it became necessary to enroll him into the same school his brother attends. In May I asked the Bus Depot to change my request instead for a seat on the same bus coming for his brother, but I was flatly refused. When I advised them that they needed to consider if I have a reasonable explanation, they met in secret unlawful meetings and decided to refuse my request without informing me. Given the district’s utter lack of transparency, coupled with unfair treatment of my son,

I implored the district to reconsider before I was left with no other alternative but to bring legal action. Instead, I was told by the Superintendent, “the School Board is not concerned about legal fees since the attorney is on retainer.” When I asked for the name of the school attorney so that I might discuss settlement, I was told to file the lawsuit in order to obtain the name. I found the name, called the boss, and never received a phone call to this day. NOT ONE PHONE CALL has been made by their attorney to stop the expense that this is causing.

The Board has now expended your tax dollars on legal fees that are drawn out of the legal fund in reserve or retainer that they should seriously try not to spend. They can use it for better purposes and if the fund is overdrawn, they have to put more money in and keep on paying. We now proceed on and this will keep on costing taxpayers since there is a policy by the BOE indicating that they intend to continue to wrong others in the same way. I am offering free legal consultation until this is resolved. I urge you to please email your elected officials at nsboe@northshoreschools.com to make an inquiry.

front door in and proceeded to demand money from those inside.

According to Lt. Nagle, The defendant then physically attacked one of the persons inside the house and then menaced him with a large kitchen knife. Shortly thereafter Jesse Thomas's mother Laura Purnell, arrived and illegally entered the residence demanding money. Purnell then began going through the victims purse and desk drawers. Laura Purnell

was charged with 12 Felony charges including eight pending drug felonies, Burglary second degree attempted robbery in the second degree, attempted robbery in the third degree and possession of stolen property in the fourth degree. Jesse Thomas was charged with five felonies including; two counts of burglary in the first degree, burglary second degree, attempted robbery second degree, and criminal possession of a weapon third degree. The defendants will be arraigned on Wednesday in First District Court.

simply superior to Cablevision in terms of quality and service.

Some were concerned about the legal implications of breaking off the long-standing contract with Cablevision. "Is the city now going to get caught in a legal dispute?" one resident asked.

In a statement issued after the meeting, Cablevision said, "Cablevision competes effectively in Glen Cove and every other city and town where we operate, and while we welcome competition, we note that this agreement shortchanges Glen Cove residents by excluding them

from the benefits that Verizon provides to every other franchised community on Long Island. As such, we will continue to compete vigorously and also take the necessary steps to ensure that competition is on a level playing field."

Ultimately, the council voted in favor of Verizon's contract. Councilmen Michael Famiglietti and Timothy Tenke did not support the resolution due to the provisions of the agreement. After giving his approval, Spinello said, "Cablevision has really been a good friend to this city." For the first time in 25 years, Glen Cove residents will soon be able to choose a cable provider.

Electronic Recycling Presentation At Ns Kiwanis

NS Kiwanis welcomed Tim Almeida, former Facilities Manager of schools whose mission is to help make our environment healthier for children, is currently the Business Development Manager of eWorks Electronic Services, a company that safely and productively recycles electronic ware. He gave a dynamic overview on the complexities of combining these two important issues to make our community a better place in which to live.

Tim described how eWorks achieves its goal by providing competitive recycling, refurbishment and resale services of office technologies and consumer electronics, with the statement that basically says "if it plugs into a wall" they will take it. This includes all electronics plus household appliances. This project liberates consumers who are saddled with obsolete electronics and disposes them in a "green" manner.

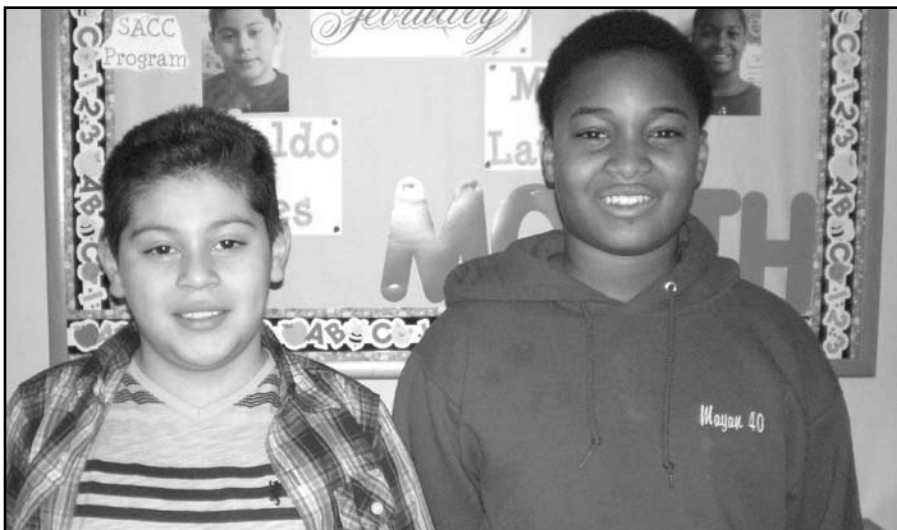
Commanders' Military Ball

Leaving Assets Outright to Beneficiaries is a Common Mistake

The Question: I have heard different things about how I should leave my estate to my family. Should I provide in my Will that my children receive my estate as long as they are at least 21? Is it better to leave it to them in a trust even if they are older than 21 when I die?



The Strategy: Because we live in a litigious society where divorce and lawsuits are common, your estate plan should be designed to protect your beneficiaries so their inheritances will not be lost. Leaving assets outright to beneficiaries upon reaching age 21 or even in staggered distributions (e.g., at ages 25, 30 and 35) is usually a mistake. Instead, I generally recommend that clients pass inheritances in a more protective fashion -

in a beneficiary controlled trust (BCT).

How It Works: The BCT can be a trust within your Will designed to provide the primary beneficiary with all of the rights, benefits and control over the trust property that the beneficiary would have had if he or she owned it outright. However, it provides superior protection against claims from divorce, creditors and other lawsuits that may exist against your beneficiaries. In addition, by passing assets in a properly structured BCT rather than outright or in stages, the assets can be excluded from the beneficiary's taxable estate (this tax savings can be very significant and potentially extend to multiple generations) and not count against the beneficiary if the beneficiary becomes disabled and needs public benefits. The primary beneficiary of the BCT is typically a co-trustee and has the ability to fire any other trustee and select successor trustees.

The Result: An inheritance held in a properly drafted trust can be protected from judgments, creditors, divorcing spouses, medical and long-term care expenses, and further estate taxation. Also, the trust can control who shall receive the inheritance upon the death of the beneficiary. Most people would prefer to see a deceased child's inheritance go to their grandchildren rather than their deceased child's spouse.

Name the Celebrity



Born Francis Timothy McCown in Los Angeles, California, our celebrity spent his early years in Santa Cruz. The son of a professional gambler, he was of Scotch-Irish and Spanish ancestry. He was only nine months old when his father died. His mother remarried and he occasionally went by Frank Durgin, using the last name of his stepfather. At age thirteen, he stole a revolver, for which he was sent to the California Youth Authority's Preston School of Industry Reformatory at Ione, California. He escaped while in the adjustment center, which is a jail within a jail. After robbing several jewelry stores, he stole a car and drove it across state lines. This made it a federal offense and when he was re-captured, he was sentenced to three years in prison, and served his sentence at the U.S. Medical Center for Federal Prisoners in Springfield, Missouri. After finishing his sentence, he was transferred to San Quentin prison on other charges. He remained there until he was paroled shortly before his 21st birthday.

After his release from San Quentin, he worked at a number of odd jobs. In 1943, while riding horseback in the Hollywood Hills, he met actor Alan Ladd whose wife was an agent. Susan Carol Ladd landed our celebrity a one-line role in a Laurel & Hardy comedy, "The Bullfighters". Shortly afterwards, the Ladds hosted a party attended by David O. Selznick employee Henry Wilson, an agent known for his assortment of young, handsome marginally talented actors to whom he gave new, unusual names. Wilson signed McCown to a contract and initially christened him "Troy Donahue". It was soon changed to what his fans know him as today. Wilson carefully

groomed his new client and taught him the social manners he had never learned in prison. His first public appearance in the film capital was as Lana Turner's escort to the premiere of Alfred Hitchcock's "Spellbound" (1945), a Selznick production. The glamorous blonde and her handsome companion attracted the paparazzi, and photos appeared in newspapers and fan magazines. Selznick then began loaning his contract players to other studios. Subsequently, he appeared in "Adventure Island" with Rhonda Fleming, "The Red House" with Edward G. Robinson and "That Hagen Girl" with Shirley Temple, Ronald Reagan and Lois Maxwell. These films were all released in 1947.

Last Week's Celebrity

Last week's celebrity was born as Margaret Kies, but was professionally known as Margaret Lindsay. She was noted for her supporting roles in the 1930s and '40s such as "Jezebel" (1938) with Bette Davis and Henry Fonda and "Scarlett Street" (1945) with Edward G. Robinson and Joan Bennett. She had leading roles in lower-budgeted B movies such as the "Ellery Queen" series at Columbia in the early 1940s with Ralph Bellamy. Critics regarded her portrayal of Nathaniel Hawthorne's "Hepzibah Pyncheon" in the 1940 film adaptation of "The House of the Seven Gables" as her standout career role. Her co-stars were George Sanders and Vincent Price. While her work in the late 1940s would occasionally involve a supporting role in MGM films like "Cass Timberlane" with Spencer Tracy and Lana Turner, her film career went into decline with roles in films at Poverty Row studios like Monogram Pictures. She returned to the stage and co-starred with Franchot Tone in "The Second Man." She died at the age of 70 of emphysema on May 9, 1981. Her life partner, actress Mary McCarty, pre-deceased our celebrity. Miss Lindsay was also survived by one brother and four sisters. One of those sisters, Jane Kies, was an actress, professionally known as Jane Gilbert, married to William Hopper, who was "Paul Drake" in the TV "Perry Mason" series with Raymond Burr.

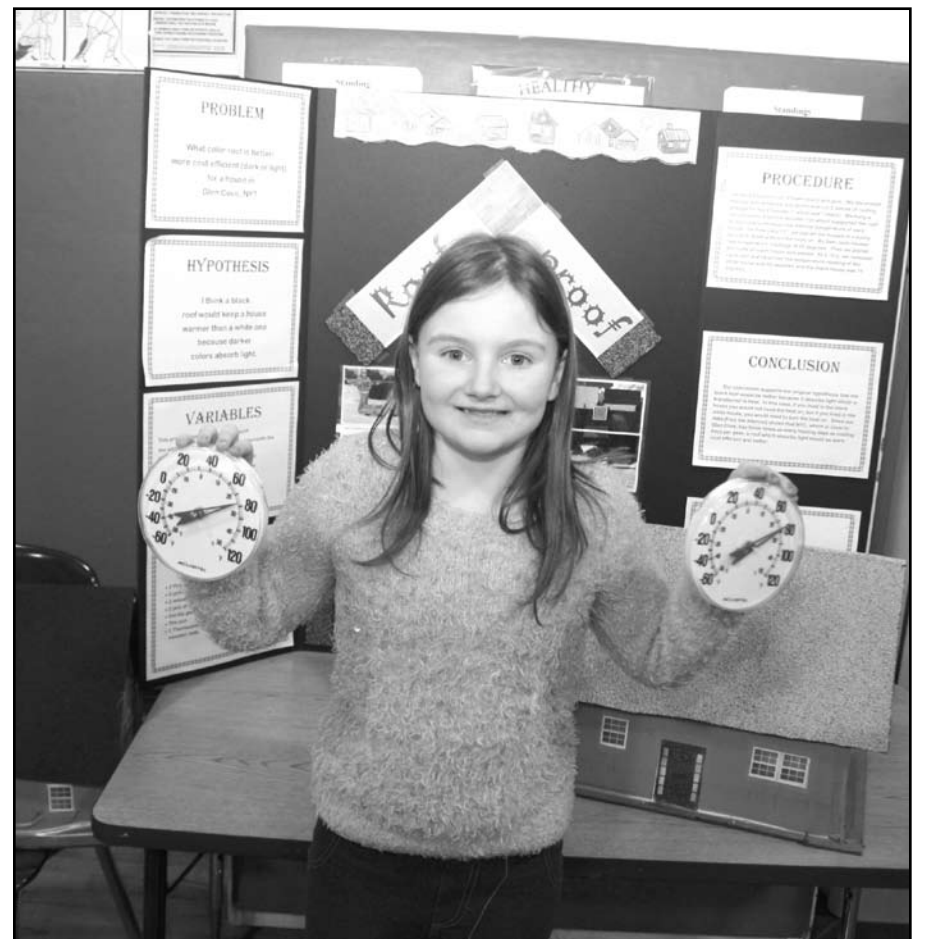

North Shore Trustees Eliminate Over \$1 Million from Initial 2014-15 Budget Proposal

BOE Agrees To Stay Within Allowable Tax Levy Limit

The Next BOE Budget Review is on Thurs. March 20, Public Session at 7 PM

At the recent Board of Education meetings on February 27th and March 6th, North Shore Trustees eliminated over \$1,000,000 from the Superintendent's Initial 2014-15 Budget presentation. The school budget proposal currently stands at approximately \$96 million, representing a 2.2% budget-to-budget increase from last year. It is within the allowable tax levy limit.

Trustees will continue to review the budget expenditures line-by-line to determine whether any other reasonable cuts will need to be made. The next budget review will take place on Thursday, March 20, 2014. Please note, the public session will be at 7 PM in the HS Library and the executive session will follow at 8 PM.

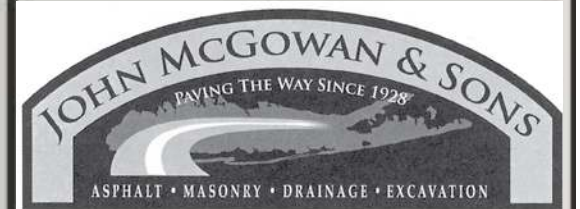

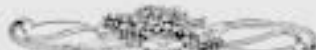
