Schubert-Fest At North Shore High School On Saturday, April 5, 8 Pm

The North Shore Community Chorus (NSCC), under the direction of Stephen Goldstein, will present the harmonious choral work and songs of Franz Schubert, one of the greatest and most frequently performed Romantic composers, at North Shore High School, 450 Glen Cove Avenue, Glen Head, on Saturday April 5, at 8:00 p.m.

Schubert, who is credited with creating the German Lied or art song, was inspired by the wealth of late 18th - early 19th century lyric poetry and the development of the piano. It was Schubert who dared to explore and experiment with the possibility of representing the poetry of Goethe, Schiller, Heine and others in musical form. The prolific composer wrote symphonies, chamber works, masses and more than 600 songs by the time of his premature death at age 31. Featured on the program will be Schubert's Mass in G Major, composed at the tender age of 18.

Soloists include Arlene Travis, soprano; Brana Williams, alto; Matthew Koraus, tenor; and Ron Meixsell, baritone. The Island Chamber Symphony Strings, under the direction of Jeremy Kempton, will provide the orchestral accompaniment. Timothy Carl will accompany the vocal soloists on the piano.

Judge Tammy S. Robbins presently presides in the County Court of Nassau County and oversees one of the busiest criminal parts in the County Court. Judge Robbins has also presided in the New York State Supreme Court, Nassau County Family Court and the Domestic Violence Court.

Prior to her election in 2004 to the Nassau County Court, Judge Robbins served in the Nassau County District Attorney's office where she was an assistant district attorney for eleven years. She spent many of those years prosecuting serious criminal matters including nar-

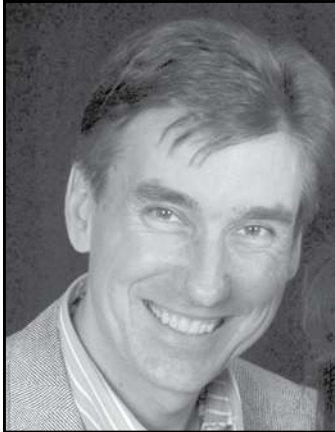

Name the Celebrity



Born on June 7, 1924 in Chicago, our celebrity was a stage and film actress. Her parents divorced when she was two and her father died when she was seven. Her mother took her to Hollywood. She was performing as a cabaret singer in local clubs when she was fourteen and within a year, she was 'discovered' by Rudy Vallee, who gave her a guest spot on his nationwide radio show. Among her any stage roles, she appeared on "Two on the Aisle" (1951), "Carnival in Flanders" (1953), "Destry Rides Again" (1959), "Sherry!" (1967) and "42nd Street" (1986). She also performed the lead role in "Annie Get Your Gun" in its first London production in 1947. Some of the films she appeared in were "Lady for a Night" (1942), "Mr. Skeffington" (1944), "Its Always Fair Weather" (1955) and "Kismet" (1955).

Last Week's Celebrity

Last week's celebrity was Rory Calhoun. As his career gained momentum, he appeared in several westerns, musicals and comedies including "Way of the Gaucho" (1952) with Gene Tierney and Richard Boone, "With a Song in My Heart" (1952) with Susan Hayward, "How to Marry a Millionaire" (1953), as a love interest of Betty Grable and Otto Preminger's "River of No Return" (1954). The last two films featured Marilyn Monroe. In 1957, he formed a production company, Rorvic, with well-known talent agent and film producer, Victor Orsatti, to make and star in films "The Hired Gun", "The Domi-

no Kid" and "Apache Territory". In the same year, he co-produced and starred in CBS's "The Texan", a western series that ran on Monday evenings until 1960. After "The Texan" was canceled, he was strongly considered for the role of "James West" in "The Wild, Wild West", but the role went to Robert Conrad. He continued to appear on both TV and film throughout the 1970s and '80s, including "Rawhide", "Gilligan's Island", "Hawaii Five-O", "Smith & Jones", and "Starsky and Hutch". In 1982, he had a regular role on the soap opera "Capitol" being persuaded to do it by his family after his regret over turning down a part in "Dallas". On April 28, 1999, at the age of 76, he died from complications of emphysema and diabetes.

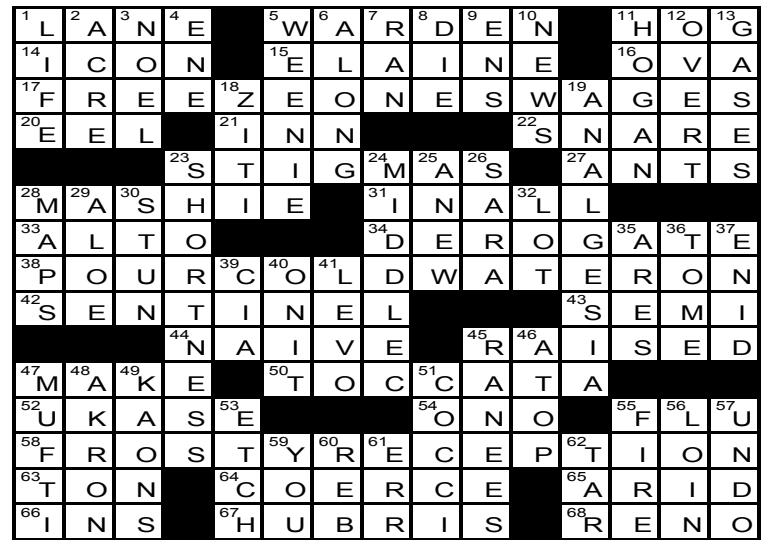

The Mayor always suggests it's one of his favorite yearly events. His sincerity couldn't be more evident judging by what seemed to be the perpetual smile on his and everyone's faces throughout the awards portion of the dinner. Joining the Mayor was Councilwoman Pam Panzenbeck who recounted some childhood tales of fishing with her dad on Dosoris Pond. Also attending were Councilmen Tim Tenke and Efraim Spagnoletti.

To open up the awards ceremony, Glen Cove Anglers Club Commodore Tom Manzione presented Mayor Spinello with an official GC Anglers Club jacket that he proudly modeled "GQ" style.

The 2013 fishing season wasn't a banner year for western sound anglers. Constant spring rains and run-offs seemed to drive the bait east as well as the striped bass. Fluke fishing picked up, but then blackfish season, the fishing season's closing event that everyone eagerly anticipates wasn't as abundant as it had been in recent years.

Nonetheless some members bagged nice fish including Thomas "Sheppy" O'Rourke with the biggest striped bass at 44.85 lbs. He also won "Surf Angler of the Year", "Outstanding Member of the Year"—an award presented for recog-

inition of contributions to the club other than fishing and he was co-winner with Fishing Committee Chairman Jim Stanis of the "Art Leach Marathon Stripper Derby", a season long cumulative weight contest. Largest Fluke of the Year was snagged by Tim Binder at 8.35 lbs. He also reeled in the largest blackfish at 9.80 lbs. James "Birdy" Fallon won largest weakfish 6.65 lbs. Squeaking by in the "Out of Bounds" contest by one point was Tom Glynn. This contest recognizes fish caught outside the clubs usual fishing boundaries between the Throggs Neck Bridge and Eaton's Neck. Mike Caruso won the overall "Angler of The Year" award. Mike has won this award three times over the last decade.

As always the shining part of the evening was the presentation of the Youth Division Awards, magnified infinitely this year with the beaming ear to ear smiles of member Sean Sheridan's young daughters Isabelle who hooked the biggest fluke at 4 lbs. and McKenzie who received an achievement award for her blackfish. Those specific awards begged someone to question proud pop Sean, "hey, now we know who catch all the fish on your boat." Youth division veterans Mike Mandarino Jr. and his brother Anthony won largest bluefish fish and blackfish respectively.

Commodore Tom Manzione couldn't thank everyone enough for making the night a memorable experience that left some with memories that will last a lifetime. Tom as always wished everyone good luck and tight lines for the 2014 fishing season.

Glen Cove IAC Holds Monthly Meeting at First Presbyterian Church

The Glen Cove Interagency Council recently held its monthly meeting at the First Presbyterian Church on North Lane in Glen Cove. Reverend Betsy Simpson warmly greeted IAC members and provided an overview of Presbyterianism in general and the Glen Cove church in particular.

Presbyterians believe in the Bible, the Book of Order and the Book of Confession. They believe that God alone is the Lord of Conscience. The Church grew out of the Reformation in the 1500s. The Church of Scotland was the home church. All clergy have at least three years of education; most have much more. It took longer to spread the word in the United States because the clergy had to be educated before they could establish religious footholds. There are 56 or 57 individual Presbyterian churches on Long Island. They meet together four times a year as a way to connect and partner for missions.

Each individual church has an elected board of elders. A person can serve 2-three years terms. Reverend Simpson is not a member of the First Presbyterian Church in Glen Cove; rather, she is responsible for taking care of the church and its paternal care. She has been here for 14 years. The Glen Cove church was constructed in 1905 and is one of the most liberal on Long Island. It is open and affirming, houses the men's shelter and strongly believes in social justice. The

church believes it is okay to ordain gays and lesbians but the national denomination has not yet approved gay marriage. The church has a youth group that works with other churches. The youth are going to Honduras for a week this summer to help build a church. In addition to the Presbyterian congregation, two Spanish congregations use the church for servic-

es and AA meets daily at the church.

The Glen Cove IAC includes community leaders representing a variety of human and social service agencies throughout Glen Cove. It reflects Glen Cove's rich cultural, religious and ethnic diversity and meets regularly to identify and address changing needs in the community. This network has resulted in nu-

Non-Stop

A movie review by Katherine Kranz

Runtime: 106 min

Rated PG-13 (Intense action sequences, mild language)

Stars: Liam Neeson, Julianne Moore, Michelle Dockery

The possibility of facing any sort of danger during air-travel raises so much concern in modern times that having such a threat as the focus of a movie instantly makes audiences uneasy. While many have incorporated such a scenario into their screenplays, not since 1997's "Air Force One" has the story of an imperiled airplane been equal parts nerve wracking suspense and thrilling fun. It should come as no surprise that it would be beloved Irishman Liam Neeson who would lead the way to delivering just that.

Neeson is Federal Air Marshall Bill Marks, whom we are introduced to as he is stirring alcohol into his morning coffee with a toothbrush not long before he boards the flight he is entrusted to protect. He is not hindered however, from taking notice of every possible detail and discreetly observing his fellow passengers. Taking an interest in Bill is Jen Summers (Julianne Moore) who sits beside him after demanding a window seat. Also along for the trip is paranoid traveler Jack Hammond (Anson Mount), technology programmer Zack (Nate Parker) police officer Austin Reilly (Corey Stoll), a schoolteacher (Scoot McNairy) and a young girl travelling alone (Quinn McColgan). It should be a routine flight to London.

Without wasting any time the movie quickly changes gears. Bill receives a text message from an unknown sender stating that unless \$150 million is wired into a specified account, a passenger will die every twenty minutes. Everyone is immediately a suspect. Somehow the anonymous sender has eyes all over the plane, watching Bill's every move. It is a plot reminiscent of "Phone Booth" (2002), only set at 40,000 feet in the air in a vessel moving over 500 mph.

Director Juame Collet-Serra has previously worked with Neeson on the entertaining but forgettable thriller "Unknown" (2011). Prior to "Unknown" was 2009's "Orphan," the filming of which was borderline child abuse. Here he uses the single location to his advantage, creating a claustrophobic environment that never becomes tiresome. "Non-Stop" is by far his best work, hopefully putting an end to a dreadful track record. At Collet-Serra's disposal is a gripping screenplay from John W. Richardson, Christopher Roach, and Ryan Engle, with Richardson and Roach credited with the story.



Tapping into the potential of Smart technology, the film maintains a tense realism as well as some unique visuals. The frequent texts Bill receives float on the screen as a texting bubble which offers some opportunities for playful graphics. Scenes of close combat action are the movie's foible. An abundance of clumsy camerawork and quick cuts come off as shambolic rather than alarming. Upon close scrutiny, there is some uncertainty as to when particular plot developments could have been made possible. A flashback or a view of a scene from an alternate angle would have cleared up these discrepancies.

As per usual, Liam Neeson is the driving force who commands full attention. He plays his flawed character to perfection, at one moment holding his own in a fistfight, the next being wholly vulnerable and admitting the more regrettable parts of his life. Neeson seizes every opportunity to demonstrate his mysterious charm, the rough mystique that has audiences filling theaters. Julianne Moore expertly keeps Jen's talkative, eager to socialize demeanor from becoming bothersome. Recent Academy Award winner Lupita Nyong'o makes a small appearance along with Michelle Dockery as flight attendants desperately trying to maintain peace among the panicked flyers.

While the passengers turn on each other and ultimately on Bill, the viewer is also in a constant state of frazzled exhaustion. It is the sense of control being violated that elicits the most fear, as Jen says "control is an illusion." The palpable tension is relentless until the very end as mounting pressure is placed on Bill. The climax is nothing short of breathtaking and brings a satisfying conclusion. What's more is when the perpetrator's motives are finally revealed, it is a discussion worth having.

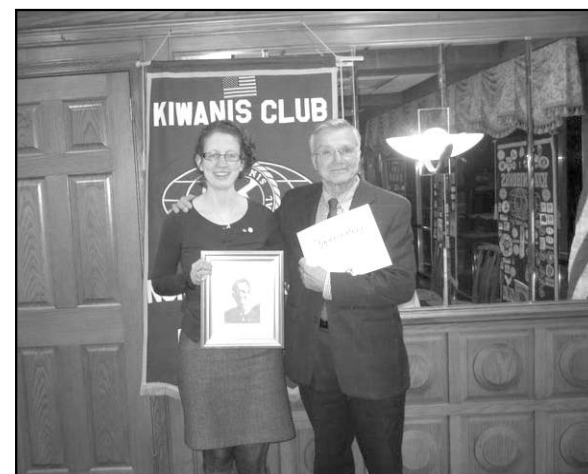
In-House Artist Presents Program At N.S. Kiwanis

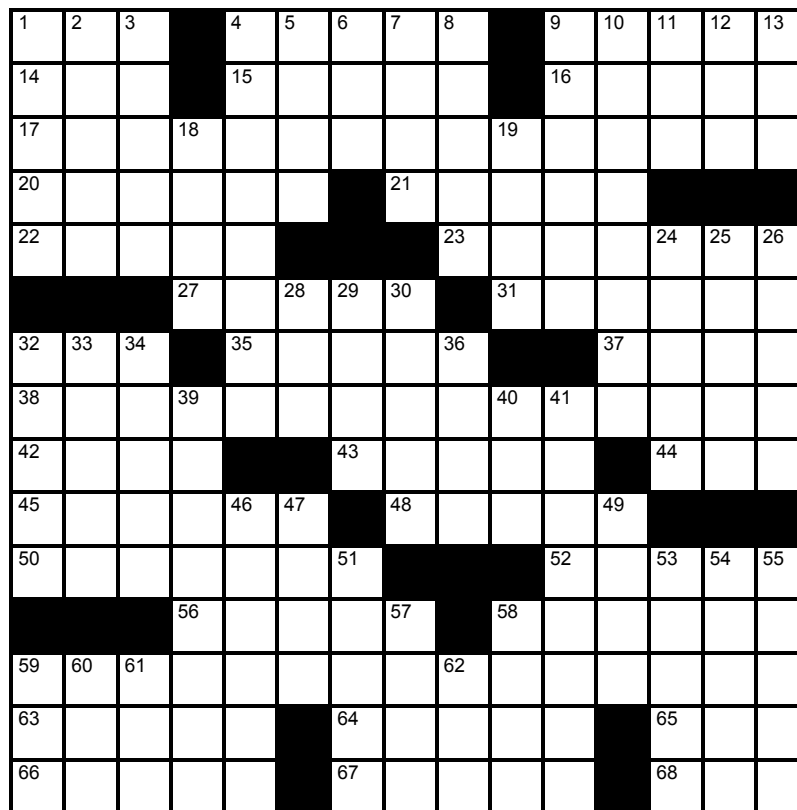
Mayor Spinello Congratulates Young Anglers
