Community Mourns Warden

William H. Warden Jr., proud Scot, accomplished sailor, father, husband, spinner of tales, and gushing fountain of knowledge, died on March 16, 2014. He was cooking eggs, doing the crossword puzzle and, characteristically, reading up on the sail specifications of an obscure class of wooden sailboat at the time of his death. He is survived by his sons Bill and Doug, his daughters-in-law, Sandy and Amy, and his spectacularly feisty grandchildren Matthew, Alice, and Henry.

Bill was a devoted husband, having spent the final decades of his life caring for the first love of his life, Toni Warden who pre-deceased him by almost exactly one year. Bill rarely spoke the words "I love you" to his sons, instead choosing to shout those words at them every day of their lives in the secret language of the Warden family men since time immemorial. That language was the tongue of stubble filled hugs that leave the children's faces gratifyingly pink with friction burns and after-work wrestling matches that left his best suits torn from crotch to knee. It was the dialect of extravagant father-son science experiments involving box kites and cameras on wings that would sail up the kite string to take pictures of

Spinello Honors Retiring Public Works Employees

Before proceeding to the official business of the March 25 City Council meeting, Glen Cove Mayor Reginald Spinello honored two Glen Cove Public Works employees who are heading into retirement. Michael Salentino began serving the community 42 years ago at a sewage treatment plant while John McKenna started 34 years ago as a laborer. Spinello awarded both men with plaques and gave them the opportunity to say a few words.

Salentino emphasized the achievements and dedication of his coworkers. "They're the people that do the job for us for free. It's not Mike Salentino. It's the men that work for public works. We love our city," he said.

When the meeting commenced, Councilman Anthony Gallo proposed that any warrants discussed during city meetings be posted as PDF files on glen-cove-li.com in the future "to make them more accessible to the public." Doing so will allow people to stay updated without having to come to City Hall to read the extensive documents. The panel agreed to execute the idea.

Crescent Beach has been closed to bathing since June, 2009 due to elevated

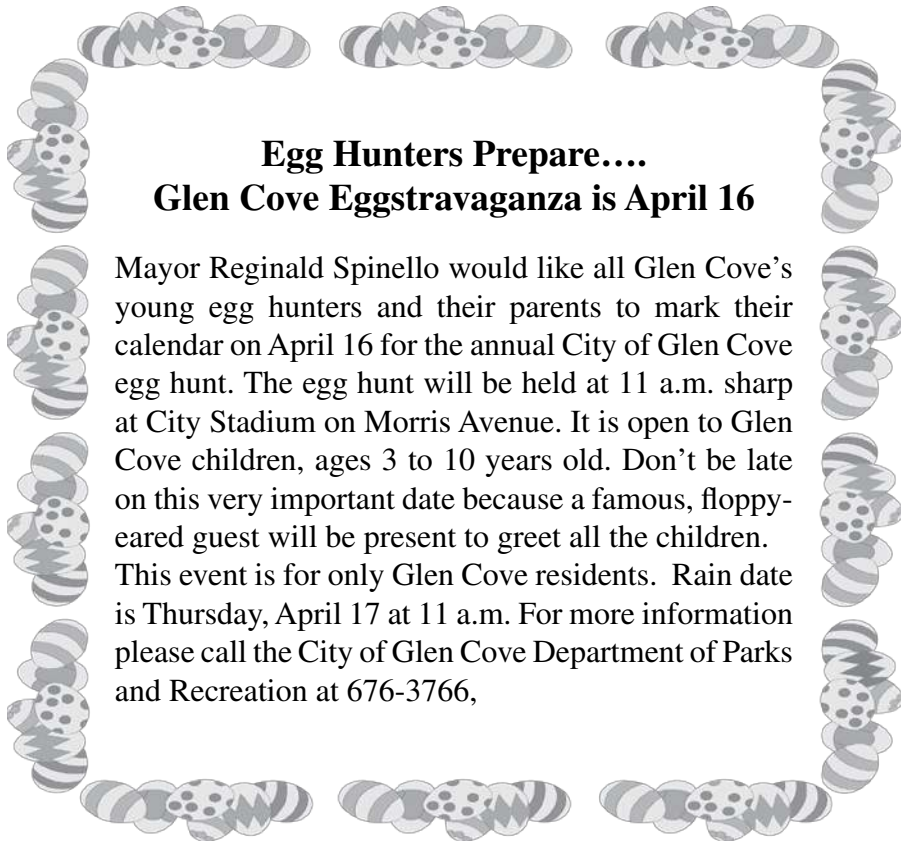
bacterial contamination from unidentified sources. The level is deemed unacceptable by NY State Department of Health standards.

Fire hydrants are going to be opened in the beginning of April for the semi-annual flushing of dead-end water mains. This is to get rid of accumulated dissolved mineral sediments in the water mains prior to the peak usage period.

During the hydrant flushing period, residents may detect some water pressure fluctuation and water discoloration. The discoloration poses no health risk. Customers may choose to keep a supply of clear water in the refrigerator for drinking and cooking during periods of any discoloration in the water.

Mill Neck Services Continues to Find Jobs for People with Disabilities



Ken Longstreet is not deaf, but he has always been hard of hearing, so much so that he has a disability. He spent much of his younger years working as a house painter or as a landscaper, but he always knew he'd have to find less physically demanding work as he aged. Yet, with a disability he couldn't compete for employment without help.

Over 20 years ago, Longstreet went to Mill Neck Services (MNS) for assistance with finding a job. He landed the job of his dreams – working for the National Weather Service. Now retired, he volunteers at Mill Neck Manor. "Part of my reason for volunteering at Mill Neck is to thank them for helping me," Longstreet said.

Working in the office services unit

at the Weather Service, Longstreet maintained the copy machines, ordered supplies, handled the mail, and, considered a valuable employee, was given opportunities to work on special projects. The reason for his retirement – as technology advanced there was little need for his position.

These days there are many people competing for jobs. MNS is committed to ensuring people who are deaf and/or disabled are considered. They provide help with resume writing, filling out job applications and setting up interviews. Additionally, many clients need an interpreter to sign for them at an interview. "They take a lot of the stress out of the interview," Ken said.

MNS Executive Director Loretta Murray, Esq. said it isn't always easy to convince employers to hire people who are disabled. "When two people apply for a job, one disabled, one not, an employer may be hesitate to hire the person with the disability," Murray said. "We try to reassure the employer that it isn't hard to hire people with disabilities, and often, they are wonderful employees."

Murray said many employees who

are disabled just need the opportunity to show their abilities to an employer. "Ken worked for many years and was a valued member of the work team," she said.

MNS continues to support those they place in jobs. Each person is provided with a job coach who will work with the employer to help engage the employee in the work world and assist in finding an amiable resolution should any issues come up. "My job coach came in twice a month and would ask if everything was o.k.," said Ken. "If there were any problems she'd step in and we would all go to the supervisor and talk it over."

Also, some people placed by MNS are deaf and can't speak to their employer without the assistance of their job coach. On and off the job, MNS coaches have proven to be valuable allies for the people they support; one such example being helping employees with circumstances that may make it difficult for them to get to a job, like finding child-care.

Mill Neck Services, which has offices in Mill Neck, Manhattan and Queens, includes a three tier employment program: for people who are deaf with no other disability; people with multiple disabilities and people who are developmentally disabled. There are currently 180 people in the program, which includes those with jobs who continue to receive ongoing support. There are approximately 100 people still looking for work.

The need for making employers aware of the advantages of hiring people who are disabled continues. Many

don't realize that hiring people who are disabled may make them (the employers) eligible for tax credits, for example. President Obama, recognizing how difficult it is for a person who is disabled to become employed, recently ordered federal agencies to hire people with disabilities. "That's a wonderful thing because among people who are disabled, 70 percent are unemployed," said Murray.

Once an employer hires a person with a disability, it usually fosters the practice in the future. "Their work ethic is tremendous," said Murray "Ken is but one example of just how valuable someone with a disability can be for any company."

Established in 1986, Mill Neck Services has placed more than 1,000 deaf, hard of hearing or otherwise disabled workers in over 400 businesses operating on Long Island. Mill Neck Services is part of the Mill Neck Family of Organizations, which also includes Mill Neck Manor School for the Deaf, founded by Lutheran Friends of the Deaf in 1947, Mill Neck Manor Early Childhood Center, Mill Neck Audiology, Mill Neck Interpreter Service and Mill Neck Foundation for Deaf Ministry. Congratulations Cast & Crew of GREASE!

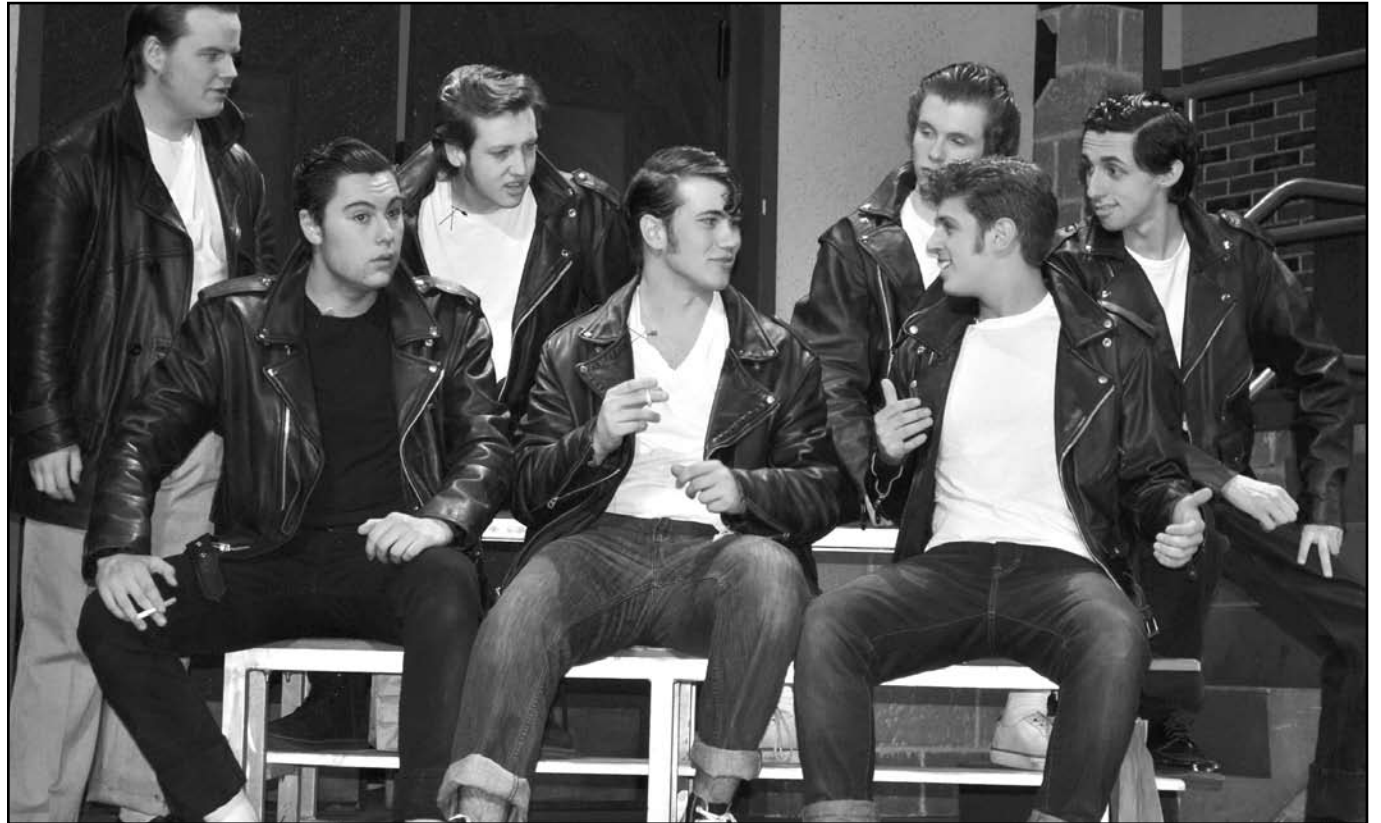

Name the Celebrity



Last Week's Celebrity

Tall and sultry, with generous lips, last week's celebrity, Dolores Gray, had a rich contralto voice that one London critic described as "warm brandy." Her London success with "Annie Get Your Gun" led her to major Broadway shows. Among those, she starred in the musical "Carnival In Flanders", which she won a Tony in 1954 for best musical actress. Ironically, the show lasted only six performances and it still ranks as one of the shortest-lived winning performances. Although the show was far from a hit, the song she introduced in it, "Here's That Rainy Day" by Jimmy Van Heusen, with lyrics by Johnny Burke, later became a standard. She stepped away from the stage for a few years, in the mid-'50s, to make films, including "Designing Woman" with Gregory Peck and Lauren Bacall, where she ceremoniously dumps a plate of spaghetti on Peck's lap! When she returned to the stage in 1959, she made headlines. On May 28, 1959, during a matinee of "Destry Rides Again", opposite Andy Griffith at the Imperial Theater, the stage curtain caught fire as Ms. Gray sang a love song, "Anyone Would Love You." As the theater's fireman and crew noisily started fighting the fire from backstage, Miss Gray kept singing. "When I spotted the flames, I nudged Andy," she would say later. "Neither of us moved. I just kept on singing louder and louder to try to drown out the noise of the stage. She was later credited with keeping the full house of 1,504 people calm as the fire was extinguished. There was a 40-minute intermission for damage assessment and clean-up and then the show went on! She died suddenly on June 26, 2002, at age 78, in NYC, from a heart attack.

Correct Callers

Callers who know our celebrity this week were: Mario Moccia, Don Adams, Roberta Pezza, Will and Babs Hutchins, M. Zarrmba, Sal C. and Sandy Shane.

This week's celebrity was an American film director, producer, and actor. He directed more than 21 films and 10 TV shows, acted in over 30 films and produced over 44 films. Some of his best known works include "Jerimiah Johnson" (1972) with Robert Redford, "The Way We Were" (1973) with Barbara Streisand and Robert Redford, and "Three Days of the Condor" (1975) with Faye Dunaway, Robert Redford, Cliff Robertson and Max Von Sydow, which also received an Academy Award nomination for Best Film Editing. Despite earlier plans to attend college and then medical school, he left his home state of Indiana for NYC soon after finishing high school at age 17. He studied acting with Sanford Meisner at the Neighborhood Playhouse from 1952-54, working on a lumber truck between terms. After two years of army service until 1958, he returned to the Playhouse at Meisner's invitation to become his assistant. In 1960, John Frankenheimer, a friend of our celebrity, asked him to come to L.A. in order to work as a dialogue coach for the child actors on Frankenheimer's first big picture, "The Young Savages." It was during this time that he met Burt Lancaster, who encouraged the young actor to the try directing.

Gwl: Reality Vs Truth To The Editor,

For the past year, I've appealed to National Grid and our political representatives to hold off demolition of the Glenwood Landing power plant—the almost 100-year-old, historically and architecturally unique Long Island landmark—until full consideration can be given to ways this landmark building might be most advantageously repurposed as a commercial, tax-paying enterprise as quickly as possible, and its prime waterfront revitalized and made accessible for our Glenwood Landing-North Shore-Hempstead Harbor communities.

National Grid is demolishing the GLW plant, as planned, to reduce its tax assessment. It will "warehouse" the minimally remediated, paved-over, fenced-off property for "future energy use"—leaving Glenwood Landing's waterfront inaccessible, unused and, for the present, not generating badly needed revenues to make up for the loss of taxes from the utility. Once the building is gone, any hope for Glenwood Landing's renewal and waterfront revitalization will be lost. Given the utility's history and recent in-

stallations, we can expect a proliferation of transmission infrastructure, turbines and substations on that site.

I had no illusions about the futility of my project in the face of National Grid's enormous power and influence. But, if history has anything at all to teach us, it is that powerlessness does not justify silence. If enough powerless people speak up, power can sometimes shift . . . or not. About 900 area residents signed a petition to "Save the Glenwood Landing power plant," which I will forward to National Grid and all our political representatives (join us; sign the petition: change.org).

We tried. We did not fail. National Grid and our political representatives failed us.

While National Grid's power and self-interest represent the inescapably harsh and pragmatic reality of the corporate bottom line, we must look elsewhere for the truth about the company's and our politicians' behavior. We need look no further than our simplest fables and popular fantasy literature to understand the timeless and enduring truths about human nature. We would do well to take Dr. Seuss' Lorax and Tolkien's Lord of the Rings to heart, for example, for their unflinching truths about unfettered capitalism and power, namely that they invariably devastate the communities and environments they exploit . . . UNLESS

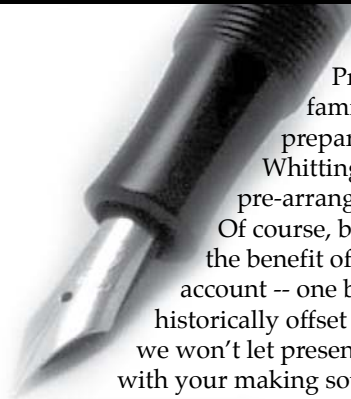

I wonder if you have a book to recommend about that “war to end all wars”?

History Buff

Dear History Buff,
I just finished a short novel (118 pages): 1914 by Jean Echenoz. This is a story of five young men from a small village in the Loire Valley of west central France whose lives are forever changed when their village bells begin to toll on a lovely summer Saturday afternoon, calling them to war. Anthime is bicycling

through the village on his way to a picnic, Charles is experimenting with his new Reve Ideal camera, while Padioleau, Bossis, and Arcenel, three friends, are enjoying the afternoon at a local café. While all realize the war has begun for them, they believe it will end quickly, perhaps in two weeks or so. Their concerns at first are of attractive uniforms and romantic farewells. Of course, all of this changes. Echenoz relates, almost dispassionately, the horrors these five Frenchmen endure, but this only underscores his fury at the absurd savagery of war. There is no beauty, no grace, no redemption in this account of – as it was called – the Great War.
