Schubert-Fest - North Shore High School - Saturday, April 5, 8pm

The North Shore Community Chorus, under the direction of Stephen Goldstein, will present the choral work and songs of Franz Schubert, one of the greatest and most frequently performed Romantic composers, at North Shore High School, 450 Glen Cove Avenue, Glen Head, on Saturday April 5, at 8:00 p.m.

Schubert, who is credited with creating the German Lied or art song, was inspired by the wealth of late 18th - early 19th century lyric poetry and the development of the piano. It was Schubert who dared to explore and experiment with the possibility of representing the poetry of Goethe, Schiller, Heine and others in musical form. The prolific composer wrote symphonies, chamber works, masses and more than 600 songs by the time of his premature death at age 31. Featured



on the program will be Schubert's Mass in G Major, composed at the tender age of 18.

Soloists include Arlene Travis, soprano; Brana Williams, alto; Matthew Koras, tenor; and Ron Meixsell, baritone. The Island Chamber Symphony Strings, under the direction of Jeremy

Kempton, will provide the orchestral accompaniment. Timothy Carl will accompany the vocal soloists on the piano.

Tickets are \$15 for adults; \$10 for seniors/children, and may be purchased at the door.

"I think it important that residents of our community are made fully aware of the environmental problem that exists at one of our City's favorite beaches. I urge everyone to attend this forum whose focus will be Crescent Beach; its problems and their possible solutions. During the meeting the City's consultants, Dvirka and Bartilucci, will be making a presentation. The consultants will be joined by representatives from the Nassau County Department of Health to answer any questions" said Mayor Spinello.

Crescent Beach has been closed to bathing since June, 2009 due to elevated bacterial contamination from unidentified sources. The level is deemed unacceptable by NY State Department of Health standards.

Name the Celebrity



Born Terry Ingstad, on Nov. 3, 1947, in Jamestown, North Dakota, our celebrity is a radio host, voiceover actor and television personality. He may not be visually recognizable to everyone unless you saw the April 1, 2014, April Fool's "Price is Right" show or a fan of the TV classic "Hollywood Squares" revival shows. He was the announcer for both the 1986-89 and the 1998-2004 versions. In the last season of the second revival he

was a quest host, as well as, the middle square on the lower row. He got his start on many mid-west radio shows, but before long, he gained significant popularity and became the announcer and sidekick on the nationally syndicated TV series "The Steve Allen Show". Along the way, he also became one of the most recognized voices when he replaced Casey Kasem as the host of "American Top 40." His voice was also heard as the voiceover for "G.O.D." in the Off-Broadway musical "Altar Boyz."

Last Week's Celebrity

Last week's celebrity was Sydney Pollack. His 1985 film "Out of Africa" with Robert Redford and Meryl Streep, won him an Academy Award for directing and producing. He was also nominated for Best Director Oscars for "They Shoot Horses, Don't They?" (1969) with Jane Fonda, Bruce Dern, Gig Young, and "Tootsie" (1982) with Dustin Hoffman, Terri Garr, Jessica Lange, Dabney Coleman, Charles Durning, Geena Davis, Bill Murray AND Sydney Pollack. "Tootsie" earned a total of ten Academy Award nominations and in 2000 the American Film Institute ranked "Tootsie" as the

second funniest film of all time. His disputes with Hoffman during the filming of "Tootsie" became well-known. Eventually, Hoffman began pushing the idea that Pollack play the role of his agent, and Pollack reluctantly agreed despite not having had any film roles in 20 years. Their off-screen relationship added authenticity to their scenes in the movie, most of which feature them arguing. He subsequently took on more acting roles in addition to producing and directing. Before passing away due to stomach cancer on May 25, 2008, he had made many

appearances on TV including, "The Sopranos", "Entourage", "Just Shoot Me", "Mad About You", and a recurring guest star appearance on the NBC sitcom "Will & Grace", playing "Will Truman's (Eric McCormack) unfaithful, but loving father, "George Truman."

Dear Great Book Guru, I read with great interest and enthusiasm your review of Dave Eggers's THE CIRCLE, so much so that I convinced my book group to read it last week. Well, while the overall reaction was not as positive as yours or mine, it did provoke a spirited discussion. Do you have another book we could read to follow up on this debate on privacy, government, and technology? Fan of Fiery Debates

Dear Fan of Fiery Debates, I am sorry that your friends did not appreciate my recommendation but I do think the best discussions are not always about the most liked books. I suggest you read George Orwell's 1984 as a follow up to THE CIRCLE. Apparently the sale of this 1949 classic increased seven-fold the week the NSA surveillance tapes were released so it is indeed a relevant choice. Set in the then future year 1984, the novel opens with its hero, everyman Winston Smith questioning his role in this strangely gray, frightening world of Big Brother, doublespeak, thought

crimes, and memory holes where War is Peace, Freedom is Slavery, and Ignorance is Strength. We follow Winston as he tries to unravel the mysteries of existence in this society where truth is a constantly changing commodity. Many of us read 1984 in high school but a second reading as an adult living in 2014 is a very different experience and highly recommended.

If you find this Orwellian dystopian world a bit overwhelming, you might want to head out to the Village Green on Friday, April 4 for Sea Cliff's first ever Warm Up. From 5:30pm on local musicians will perform on the Green, bars and restaurants will feature great specials plus live music, and shops will stay open late. A great way to celebrate community and Spring!

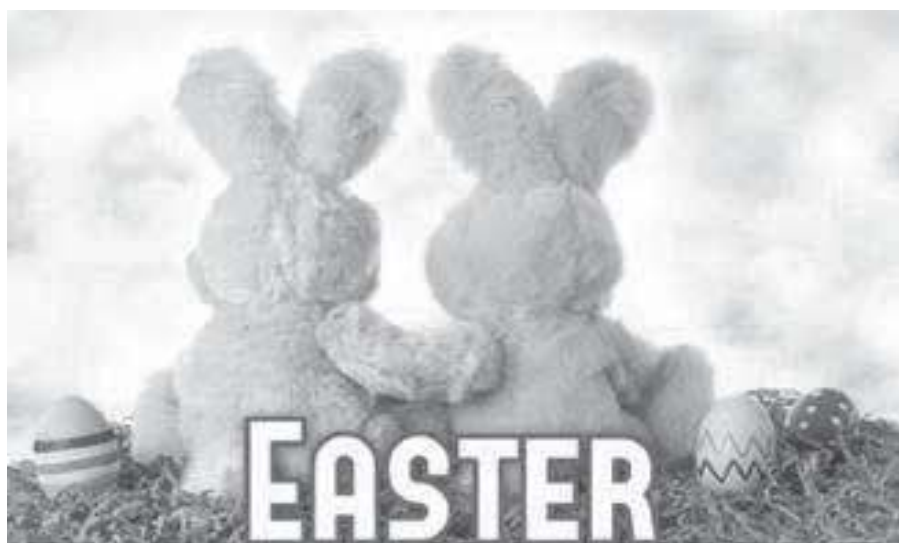

SAFE and Glen Cove Police Department Conduct Annual Pre-Prom Presentation

Sgt. Ryan Nardone brought a powerful pre-prom presentation to juniors at Glen Cove High School on Feb. 27. SAFE's Glen Cove PRIDE Project Coalition's School Committee invited Sgt. Nardone to speak to students about the ramifications of Social Host law and of the dangers of underage drinking and driving. His objective, to keep kids safe on prom night and throughout the year is an objective that SAFE's Coalition is closely committed to. The implementation of this prevention education lecture was a direct result of the 2012 Bach Harrison Prevention Needs Assessment which indicated that underage drinking continues to be a problem among Glen Cove youth.

Also handed out at the presentation was SAFE Rides cards. In response the 2012 Bach Harrison prevention needs survey, the Coalition's Parent Committee decided to team up with Student Lifeline, a local organization working to reduce the risks of underage drinking and driving through issuing SAFE Rides cards. After the presentation, free cards were given to students enabling them to avoid potential danger by calling for a ride home rather than taking the chance of driving with a peer who has been drinking. Glen Cove High School's Administrative Staff were also present to answer questions the students had in anticipation of the junior prom and to support the message against underage

drinking.

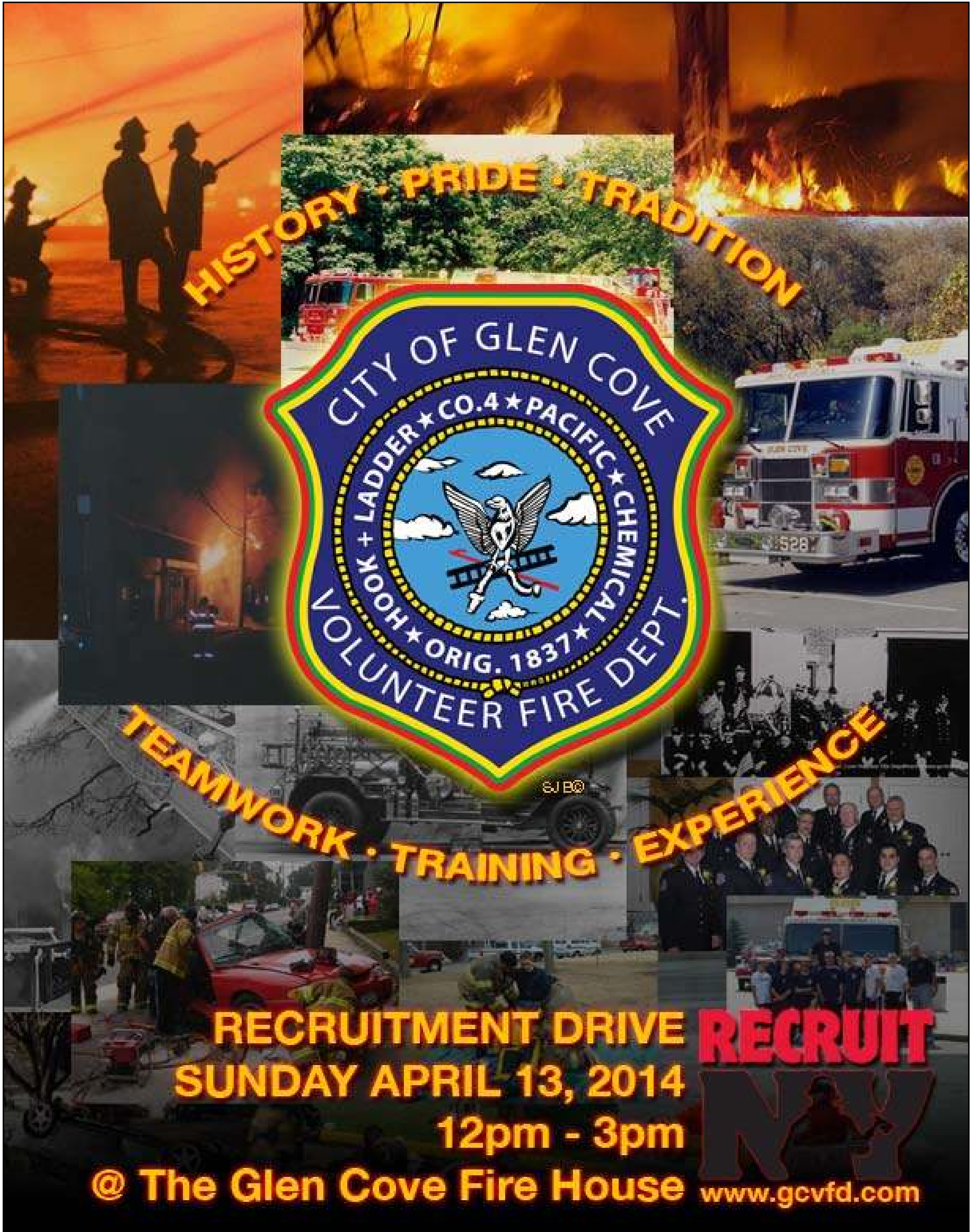

The rumba was followed by a Swing performed by Vincent and Stephanie. This wasn't your ordinary swing as performed by teenagers of the 1940s; this Swing was comprised of complex well-choreographed steps, blended together, demonstrating the physicality inherent in the jive. The demonstration portion of the program concluded with Vincent and Stephanie performing a sultry bolero/mambo that would make Rudolph Valentino swoon. Vincent and Stephanie glided across the floor as one, she spinning and gyrating to the Latin sounds and he lifting her, then dipping her as she went into a split. The demonstration ended with thunderous applause from the audience who were left wanting more. Spencer, Stephanie and Vincent brought a taste of their version of "Dancing with the Stars" to downtown Glen Cove, heating up a bitterly cold, windy day.

The second part of this enjoyable afternoon began with the professionals inviting audience members to the dance floor for dance lessons. Vincent and Stephanie instructed the participants in the fundamentals of the rumba, starting with the rumba box step and followed by a rumba break step. Lesson completed, the music started as each performer took a senior's hand and other seniors paired off to practice the newly learned rumba steps.

Next Stephanie and Vincent taught the group how to dance Swing. Stephanie started with a lesson in the basic swing step and then added a turn step for the females. Once again seniors and professionals paired off as the spritely music of the big band era made our feet move and our hips sway to the beat and our hearts seem young once more. The senior dance students and audience alike were extremely appreciative of the creative and professional entertainment presented by these three masters of the art of dance.

Unbeknownst to many of his Martial Arts devotees, Spencer Gee is extensively involved with dance. As a dance in-

structor, he has lead dance workshops at the Eglevsky Ballet Camp, Manhattan's Theatre Works, the Great Neck School of Dance, the North Shore School of Dance and the Two Worlds Dance and Fitness Center. He has performed key roles in



the Viennese Waltz, Chinese Dance and the Party Scene in Danny Holstein's production of the Nutcracker Ballet at SUNY College at Old Westbury. He received 1st Place in several dance categories, including the American Cha Cha, Bolero, and Rumba at the 2005 Empire State Dance Sport Championship. That same year he was awarded 1st Place in Rumba, Cha Cha, Swing, Bolero, and Salsa at the Tri-State Challenge in Connecticut. In 2009 Spencer received the Bronze International and American Cha Cha and Rumba Exam with Honors from the US Imperial Society of Teachers of Dance. Presently, Spencer is studying Flamenco and classical Spanish dance while constantly honing his skills in Latin and Ballroom Dance. Spencer sees a strong correlation between Tai Chi and Ballroom Dancing. Both involve graceful, choreographed, rhythmic moves, and each discipline

helps refine the skill and movement of the other.

19 National Title last weekend when she competed in the US Nationals, played at Princeton University. Sabrina maintained a perfect record with three-game victories throughout the tournament. This is her third consecutive U19 title at only seventeen years of age! To top it off, the week prior to winning the Junior National Title, Sabrina won the USA Senior National Title, a feat only accomplished once before in 1987.
