Deasy Tribute Plays to a Special Guest



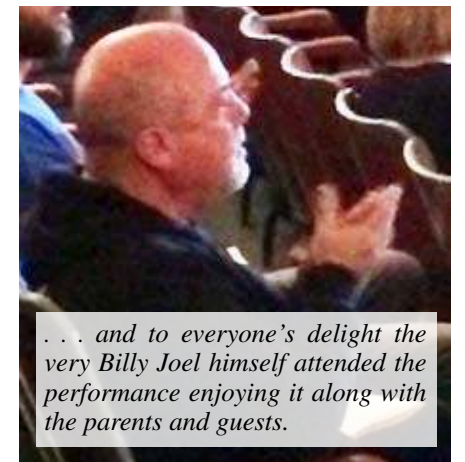
Deasy Elementary School Students perform a "The River of Dreams: A Billy Joel Tribute Concert" . . .

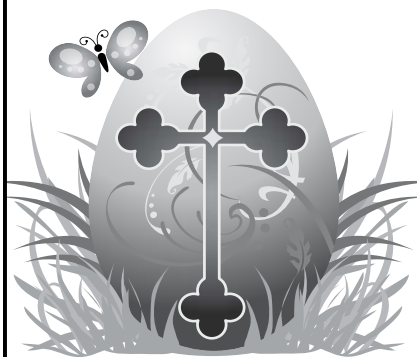

Name the Celebrity



This week's celebrity was born on July 14, 1930 in Knoxville, Tennessee. In a six-decade-plus career (she started out as a radio performer at age 14), there are very few facets of entertainment that our celebrity has not conquered or, at the very best touched upon. A nightclub and Columbia recording artist of the 50s and 60s, she is just as well known for her film and Emmy-winning dramatic performances, as she is for her wry comedic gifts. She attended Compton Junior College before Paramount mogul, Hal B. Wallis, caught sight of her and signed her up with his studio. Having made an isolated film debut a year earlier in the Monogram western "Across the Rio Grande" (1949), Wallis showcased her as a decorative love interest in the slapstick vehicles of Dean Martin and Jerry Lewis, the (then) hottest comedy team in Hollywood. Those films did little for her although she presented herself well. MGM and Universal had the idea to cast her in a more serious vein with co-starring roles in their dramas, "Escape from Fort Bravo" (1953) with William Holden, "Arena" (1953) with Gig Young and co-written by Glen Cove's own Arthur Loew (he once owned the property on Red Spring Lane which is now known as The Legends), and "Cry the Hunted" (1953) with Barry Nelson. However, again, she was overlooked. Disappointed, she looked elsewhere for her rainbow. She had her own TV show, a Broadway debut with Harry Belafonte in "John Murray's Almanac" (1953), and a 5 year regular panel seat on the TV game show, "To Tell the Truth" with emcee, Bud Collyer, of "Beat the Clock" fame. It wasn't until she played the wife of Gregory Peck and

the designated victim of a revengeful psychopath, played by Robert Mitchum, in the original "Cape Fear" (1962), did her film career reignite.

Last Week's Celebrity

Last week's celebrity, Shadoe Stevens, started off in radio in 1958, as an 11-year old, in his native city of Jamestown, North Dakota. Urban Legend has it that LIFE Magazine picked up the story that he was on the air as "The World's Youngest Disc Jockey." On the road through many job opportunities on Boston radio and as the announcer on "The Steve Allen Show", he eventually returned to radio to become a legendary Program Director creating and launching, "World Famous KROQ-FM (K-ROCK)." He received many awards including Clio Awards, the Big Apple Award, and Billboard Magazine Personality of the Year Award. He created the Branding, Advertising and Marketing Campaign for a West Coast home electronics company called Federated Group. Shadoe's more than 1,100 different commercials for Federated led first to a 3-picture deal with Dino DeLaurentis Entertainment, to the number one TV series "Hollywood Squares", then to the Fred Silverman's one hour CBS series "Max Monroe: Loose Cannon" followed by the hit CBS sitcom, "Dave's World." Other TV guest star roles included appearances on "Beverly Hills 90210", "Baywatch", "The Larry Sanders Show", "Caroline in the City", "Clueless", "Fast Track" and "Burke's Law", to name a few. He was the Founder, Chairman and President of "RhythmRadio", created "Cabo Wabo Radio" and "Mental Radio", a talk/entertainment radio show described as "Coast-to-Coast as if done by Monty Python". Since 2005, he can be heard each night as the voice of CBS's "The Late, Late Show with Craig Ferguson." He, also, continues to be the voice of countless commercials and TV shows including The Grammys, The Emmys and Comic Relief.

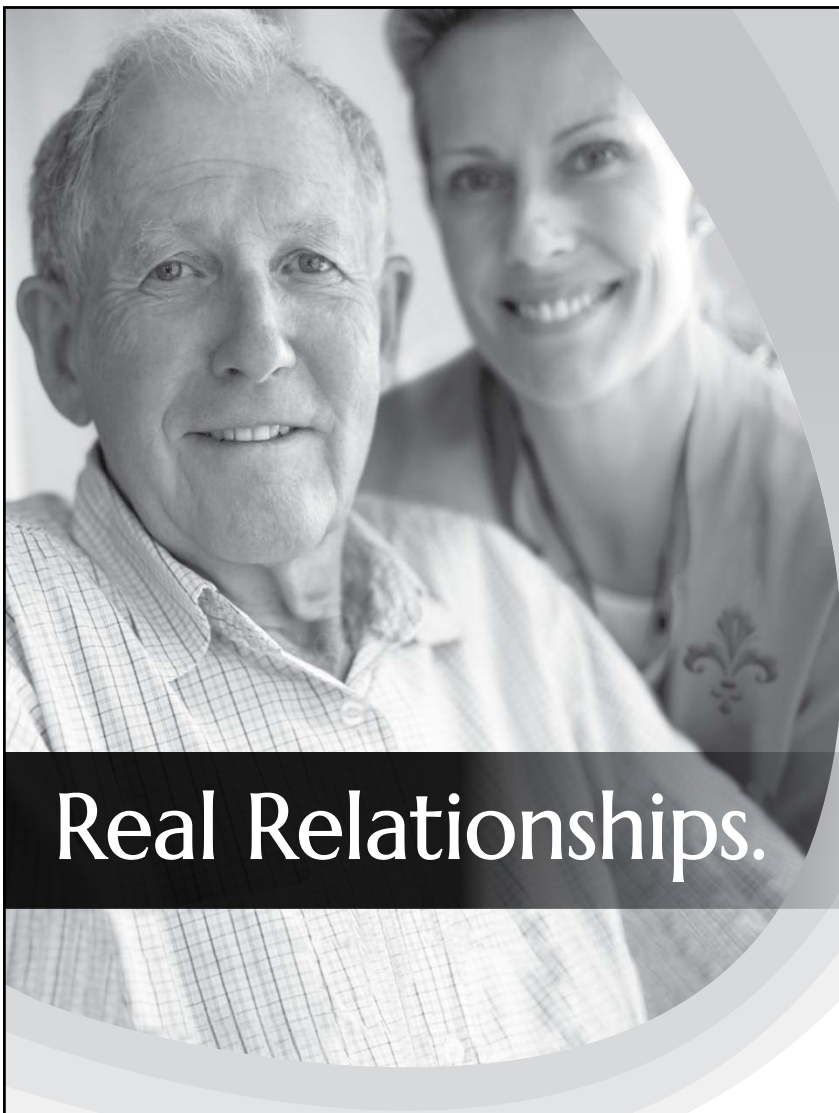

Avoiding Financial Ruin From Nursing Home Expenses

The Question: If I have to go into a nursing home or have other long-term care expenses, will Medicare pay the bill and save me from financial ruin?

The Problem: Seventy percent of Americans over age 65 need some form of long-term care. Forty percent are spending at least two years in a nursing home. Nursing homes are extremely expensive and average \$12,000 per month. Our health care system discriminates based on the type of illness you have. For example, if a Medicare eligible person needs heart surgery, has cancer, or needs a hip or knee replaced, Medicare will provide coverage subject to certain deductibles and co-payments. If, however, a person gets the wrong disease, such as Alzheimer's, Parkinson, or ALS, Medicare will pay little to nothing because the person needs only custodial care.



How It Works: Medicare provides certain medical benefits for eligible persons over the age of 65. However, it does not pay for a nursing home on a long-term basis. Medicare provides a maximum of 100 days of coverage in a nursing home. Medicare would pay the first 20 days in full. After that, the patient has a co-payment of \$152 per day (for 2014) for days 21 through 100. This co-pay may be covered by supplemental insurance, often known as Medi-gap insurance. After the 100th day, Medicare and the supplemental insurance no longer provide any coverage and a person is on their own to pay the nursing home unless proper planning has been done.

Going Green at Glenwood Landing School! Students Teach Their Peers About Composting

North Shore Schools, Glen Head, NY - Throughout the school-year at Glenwood Landing, students have been actively participating in measures that will help our environment including recycling, growing their own vegetables in the Outdoor Classroom garden, and composting.

Thanks, to the "Compost Kids," the entire Glenwood Landing student body together has begun composting. Students and faculty have been encouraged to throw their food scraps into compost trash cans which are later emptied into compost tumblers. These scraps would normally be thrown into the garbage, resulting in more trash in landfills. Instead, food scraps are being turned into rich soil to grow vegetables in the GWL Outdoor Classroom. These vegetables can then be eaten by students in the cafeteria! Mrs. Marcantonio, GWL Enrichment Teacher, who is leading this effort said, It is an exciting and wonderful cycle!

By definition from Wikipedia, Compost, is organic matter that has been decomposed and recycled as a fertilizer and soil amendment. Compost is a key ingredient in organic farming. At the simplest

level, the process of composting simply requires making a heap of wetted organic matter (leaves, "green" food waste)

and fungi further break up the material. Compost can be rich in nutrients. It is used in gardens, landscaping, horticultural

In addition, the "Compost Kids" have held many presentations and have provided poster education which is currently being displayed on the walls of the cafeteria. Do You Know How the Metabolic Rate Is Affected by Temperature? Students in AP Biology Determine the Heart Rate of *Daphnia Magna* & Casper Fish

North Shore Schools, Glen Head, January 7, 2014 - 11th and 12th graders in Nancy Cunningham's AP Bio class caught *Daphnia magna* and Casper fish to determine under the microscope how their heart rate is affected in different temperatures of water. Three temperatures of water - hot, room temperature, and cold) - were utilized in this experiment. The students were asked to use nets to gently catch the fish and then place them in slides that contained the different temperatures of water to view them under a microscope. Because you can see through Casper fish (under the microscope), the students were able to see their beating hearts and count the individual heart rates utilizing a hand-held counter and timer. Mrs. Cunningham gave a formula and example to the AP students to help them calculate the metabolic rates of the fish. The example was, "Assume $Q_{10} = 1.5$. At 15C, the heart rate is 120 beats/minute. What would the heart rate be at 25c and 35c?"

Where R is the rate
T is the temperature in Celsius or Kelvin.

Q_{10} is a unitless quantity, as it is the factor by which the rate is multiplied for every 10 degree increase in the temperature.

Can you answer these questions? If not, please ask our AP Biology students to share with you what they learned in biology lab. You will be inspired by their answers! Hint: When the water temperature cooled off, did the heart rate speed up or slow down?



Portledge Students Welcomed at Sainte-Mère-Église, Sister City to Locust Valley

Portledge School in Locust Valley sent ten students to France in March as part of the Portledge foreign exchange program. This year, however, their itinerary included a goodwill trip to the little town of Sainte-Mère-Église in Normandy, to meet with dignitaries and deliver a small token of friendship from Portledge School.

Sainte-Mère-Église, the sister city to Locust Valley, was the first town liberated by the Allies during WWII and will celebrate the 70th Anniversary of D-Day this June. The commemoration, with world leaders in attendance, will include a performance of a play about peace, "Et si on bâtissait la paix ensemble..." ("And if we built peace together...") by Laurence Bohec, featuring French and German high school students alongside students from Portledge School and Friends Academy. This unique, trilingual project encompassing lessons in art, history, and community service, has provided an unprecedented opportunity for the two Locust Valley independent schools to collaborate.

In anticipation of the D-Day Commemoration, the Portledge student delegation delivered to each of the French officials a tote bag especially designed for the occasion by Portledge tenth grader Antonia Bentel, as well as a "Memory Book" - a compilation from 4th -12th grade students consisting of letters, poems, pictures, and messages in French to the people of Sainte-Mère-Église.

The Portledge Lower School students had learned all about the history that ties Locust Valley to Sainte-Mère-Église from French teacher Marie-Therese Mathieu. They engaged in "thinking routines," reflecting on what it might be like to experience such a conflict in their home country. Likewise Portledge eighth graders deepened their understanding about the war when Laurence Bohec, the playwright/director of the planned Normandy performance for peace, visited their classrooms and spoke about D-Day history, the commitment to peace, and the power of an individual to change the world by speaking from the heart through art. The students' sensitive and thoughtful work on this project illustrated how deeply they understood and empathized with the French.

Kaye Weninger of Operation Democracy helped to arrange the Portledge visit to Sainte-Mère-Église with the help of Michelle Coupey, an American who lives there.

Mme. Coupey spent the bulk of the day with students as guide and arranged a delicious picnic lunch, paid for by Operation Democracy and by the AVA (Amis des Veterans Americains), Friends of American Veterans. "We are so grateful

which consists of a large ledger book in which visitors record their ideas of what "peace" means (in whatever language they choose).

Portledge students used English, French and Polish -- all languages they write fluently in -- to express their feelings.

Next, the group met with locals who experienced D-Day first hand at the Musée Airborne in Sainte-Mère-Église. Ma-

the war. The students were amazed to see a pencil inscribed "Locust Valley Sainte-Mère-Église" that he had preserved unused since it was sent to him through Operation Democracy, over sixty-five years ago, during his schooldays (when the only thing available in abundance were the shortages and the rations).

At the Musée Airborne, surrounded by planes, tanks and WWII artifacts, Portledge tenth graders Kristina Wirkowski and Antonia Bentel performed the French (La Marseillaise) and American (Star Spangled Banner) national anthems on the violin. Given those in attendance who remember the war, it was a poignant tribute to the friendship between the two nations and a proud moment for Portledge.

Before leaving the museum, Monsieur Renaud presented the group with a gift that all members of the Portledge community will treasure. It is a piece of a parachute recovered from a field near Sainte-Mère-Église on June 6th, 1944 in the early hours of the morning.

It will hang in Gilmour Library at Portledge School for all to see and admire. The final stop of the day was the visit to the Town Hall of Sainte-Mère-Église,

where Deputy Mayor, Antoine Simon, and his staff greeted the group. After a welcome speech by Mr. Simon and the presentation of the Memory Book and the tote bags by Dr. Atkins, everyone enjoyed refreshments in the official conference room. A wonderful first contact was made between members of the Portledge community and the people of Sainte-Mère-Église, with many more to follow.

Portledge is an independent, college preparatory, pre-nursery to grade 12 school. Within this inclusive community, students are inspired to realize their individual potential by developing the critical thinking skills and moral courage necessary for success and life-long learning in an increasingly complex world. www.portledge.org for more information.



for the partnership with those organizations," said Portledge World Languages and Culture Department Head Dr. Elizabeth Atkins, "We thank them for their generosity and hope to strengthen our connection with them in years to come."

Portledge students were invited to visit the Chateau de Bernaville (which had been requisitioned by the German army during WWII and used as the German army's headquarters in the region), by its current owner, Simon Rock de Besombes. He described to the enthralled students the history of his property and the pivotal role it played in the early days of June, 1944.

The students next visited the iconic church in Sainte-Mère-Église, with the parachute and a dummy representing Private John Steele still symbolically hanging from its roof. Inside, they admired the unique stained glass windows, which depict paratroopers where one would usually see angels or saints. Having met Soeur Theresita of the "Maison de la Paix" during her October 2013 visit to Locust Valley, several students decided to participate in the project she began,

dame Andrée Auvray, who was a newlywed, nine months pregnant with her first child when the Allies landed, recounted how she lived through those dramatic days. Having formerly worked for the Red Cross, she was prepared to help out when her country farm was transformed into a shelter/hospital. When the explosions began, the Auvrays offered a safe haven in the countryside for the inhabitants of the village, and any who had been injured could be tended to by the local doctor and by Mme. Auvray herself.

The students' personal guide at the museum was one of its founders, Henri-Jean Renaud. The son of the wartime mayor, Alexandre Renaud, and his wife Simone, the woman known affectionately as the "Mother of Normandy" for her work in service to the memory of the American soldiers who died liberating Sainte-Mère-Église, Henri-Jean was ten years old on D-Day. The entire group was deeply moved and also charmed by Monsieur Renaud, whom students described as "vibrant" and "extremely kind." They hung on his every word - in French - as he recalled his experiences of

Portledge Summer Adventures to Inaugurate New Summer Institute Program

Portledge Summer Adventures turns the Portledge school-year mantra “explore, create, excel” into a summertime opportunity for students to follow a passion as far as it will take them - whether it's exploring cyberknife technology at Winthrop- University Hospital's Simulation Center, or playing soccer with Major Indoor Soccer League former pro Michael Todd. The emphasis is on the student experience, no matter the age. “We have grown with our students,” says Melissa Worth, Director of Supplemental Programs at Portledge, “many of whom are repeat customers and we want to offer them opportunities to follow their passions.”

Still available are the perennial favorites for younger kids that parents have come to rely on year after year for safe, healthy fun like “Early Childhood Messy Hands,” “Chess” and “Rock-etry”. These hands-on offerings, taught by qualified and expert instructors, are as popular as ever. For grades 7-12 programs in the Summer Academic Institute take students off-site to study subjects like nanotechnology and gross anatomy. Summer Adventures staff will partner for the first time this summer with the New York Institute of Technology and Winthrop-University

Hospital to give pre-college students a more intense, professional learning experience. Portledge also builds on an extremely successful partnership with Gold Coast Football Club, who had a huge impact on its fall soccer program, by offering summer soccer with their top tier NSCAA Advanced National Diploma soccer coaches, some of whom have played professionally. There is even a design course where students expand their portfolio by working with local artisans in their studios under the guidance of designer Evelyn Chin to bring their

design concepts to fruition. Worth says it is exactly this type of out-of-the-classroom-setting that makes the Portledge Summer Institutes a unique opportunity for students this age who are no longer satisfied with traditional summer camp.

Portledge will hold a Summer Adventures Open House on Saturday April 26th from 10am to noon and its annual Summer Fun Day will take place on May 17th to give participants and their parents an opportunity to explore the offerings and meet instructors. The Open Houses, says Worth, are a great way to

expose younger children to camp options they may not have realized were available. Children can explore some of the activities, and parents are invited to tour the facilities and speak to instructors.

SAFE uses hard facts to fight drugs

Every year SAFE's PRIDE Project Coalition participates in the National Drug Facts Week campaign by creating a program for students at Finley Middle School and Glen Cove High School. The hope is that if our youth are armed with information they will either stop taking drugs or choose never even to try them. SAFE's campaign this year included a visit from Staff Sergeant Dave You who spoke to students about the dangers of marijuana and alcohol. He during an After 3 program to a group of students using the firsthand experiences of people he knew to drive home his points.

“I feel that they learned a good amount about marijuana and alcohol, for example what the substances actually do to your body,” said You. “And I think what they found most valuable were the real life stories that I told them about my old high school football teammate and my cousin. They were two true stories that unfortunately did not end well for either of them.”

The Sergeant added that these stories put the dangers of marijuana and

drunk driving into perspective for the students.

The National Drug Facts Week campaign also included morning announcements over the loud speaker where drug facts were shared – kind of a wake-up call to start a student's day. Students also played the WreckEd card game in their health class. This game is an educational youth component of the PACT 360 Program. (PACT360 is a law enforcement-led community prevention education system designed to deal with and reduce existing drug issues.) Wreck-Ed encourages teens to think more introspectively about their decisions regarding drugs and alcohol. This program not only encourages youth to look at their own behavior, but also to reach out and look out for their friends who may be making the



wrong unhealthy decisions. WreckEd began with a 10 minute video depicting what's going on everyday with teens when it comes to drugs and alcohol.
