Movie Theater Reopens In Glen Cove



Mayor Reginald Spinello announced today that Glen Cove's only movie theater, located in the heart of downtown on School Street, is now open with new

owners and new management.

"We had a ribbon cutting ceremony today and I couldn't be more excited," the Mayor said. "When the former mov-

ie theater operator closed the doors, it didn't just affect our residents who traveled out of town to see a movie, it devastated a number of our local businesses that relied on the movie traffic. With the re-opening of our new theater, which is outfitted with larger, more comfortable seats, six big screens, a second-floor children's birthday party room, a new concession stand and a new arcade, our City continues on the road to be back in

business."

The Mayor said the renewal of this critically important entertainment facility in Glen Cove's downtown, he is hopeful that new, supporting businesses will open in Glen Cove, and that the ones who have toughed it out will see a big improvement in their operations. "We're working every day to keep Glen Cove on the move, and we're succeeding," said Mayor Spinello.

Friends Academy senior selected as 2014 Intel Semifinalist

Erik Loscalzo is one of 300 semifinalists chosen nationwide.



Senior Erik Loscalzo (Manhasset) has been selected as a Semifinalist in the 2014 Intel Science Talent Search, for his work in environmental studies.

Loscalzo's project, "The Most Environmentally Effective Method of Eliminating Spilled Oil from the Oceans" earned him an award of \$1,000 and the chance to vie for the finalist round. Ultimately 40 students were selected from the semifinalist pool and invited to Washington, D.C. from March 6-12 to participate in final judging, display their work to the public, meet with notable scientists and compete for the top award of \$100,000.

"The Science Department at Friends is very excited about Erik's recognition," said Biology Department head Jennifer

Newitt. "He is a wonderful science student who shows curiosity, initiative, creativity and persistence. What is particularly remarkable about his Intel project is that he conceived of it on his own and performed the research in his basement fish tank needing only minimal guidance from our faculty," she added.

Intel STS, established in 1942, is a program of Society for Science & the Public and is the nation's most prestigious pre-college science competition. According to Intel, "alumni of STS have made extraordinary contributions to science and hold more than 100 of the world's most distinguished science and math honors, including the Nobel Prize and the National Medal of Science."

Loscalzo was selected from among 1,794 entrants, representing 489 high schools in 45 states, the District of Columbia and seven overseas schools.

In addition to the semifinalist award, Intel also awards each semifinalist school \$1,000 to recognize excellence in teaching and school support of individual student research.

Enrolling 776 students from age 3 through Grade 12, Friends Academy is guided by its Quaker heritage and the principles of integrity, simplicity, patience, moderation and a peaceful resolution of conflict. The school is located on 65 acres at the intersection of Piping Rock and Duck Pond roads in Locust Valley/Glen Cove.

New Proposals for Crescent Beach

Glen Cove residents could be swimming in the waters of dormant Crescent Beach as early as this summer. Mayor Reginald Spinello held a public forum on Wednesday, April 9 at Glen Cove City Hall to discuss new proposals for the beach, which has been closed since 2009.

Spinello clarified his objective for the meeting immediately. "This is not a forum to solve the problem tonight. It's just to present the facts," he said.

A major rainfall in 2009 closed down Crescent Beach for what was expected to be 24 hours. However, City of Glen Cove Parks and Recreation Director Darcy Belyea explained, test results received around the same time determined that the bacteria in the ocean water exceeded state regulated levels, making it unsafe to swim. The beach shut down for further testing.

Additional sampling revealed the contamination to be human fecal matter. The city conducted DNA testing in 2009 and 2010 to rule out the presence of waste from other sources, which garnered both positive and negative results. This further complicated the treatment plan. One of the few conclusions is that the source of the bacteria is the stream adjacent to the beach, only 750 feet away.

Representatives from Dvirka and Bartilucci Consulting Engineers, an environmental planning and design firm, proposed a new sampling plan to find the exact origin of the contamination, a feat made difficult by the constant runoff. One panelist likened searching for the source to finding "a needle in a haystack". They propose monitoring the stream and sampling the water three times a day for eight weeks. The three samples would be taken from the left, center, and right sides of the beach, as well as the stream.

Another proposed method is to conduct weekly "hydro-raking", a system of churning up the sand in order to restore natural hydrology to the area and hopefully increase water quality near the

stream.

To ensure that the water is not further contaminated during the testing period, canine decoys have been placed around the beach to deter waterfowl and subsequently, additional waste from entering the site.

During the beach season there will also be daily trash removal and bi-weekly beach cleaning.

Glen Cove City Attorney Charles McQuair explained that the city is considering a new program to inform residents of the cesspool locations near their homes. "One of our goals is to encourage everyone to have their systems pumped on a three year basis," McQuair said.

Over the past two years, sampling projects at the beach have cost the city \$50,000. The new proposals are estimated at an additional \$100,000.

Many residents are frustrated that after so much time and money, there has been what seems to be minimal progress in eradicating the contamination. Several voiced opinions about spending more money to test water that has already been confirmed to contain unsafe bacteria. "\$100,000 seems like a lot to figure out a problem we already know," Glen Cove resident Victor Scarmato said.

Aside from the new expense, one resident also expressed concerns over property values, specifically of homes near the beach. A homeowner who lives on Crescent Beach Road described taking walks with her husband on their street. "It smells like we're walking next to a sewer," she said.

Ultimately, Spinello acknowledged that the ideal solution would be to install sewers around the beach. However, this could take several years and millions of dollars that are not available at this time. The panelists expressed their confidence in the proposals, which could be initiated much sooner and for a much lower price.

The speakers and residents both agreed that they want to see Crescent Beach open for the 2014 season, a goal that finally seems attainable for the first time in five years.

cousins and aunt ran through fields and forests, seemingly on an endless trek. Reaching the border they were greeted by German soldiers sitting in a tank who told them, "You can't go through." Her aunt bribed the soldiers with cigarettes and money and they crossed over to Germany. "Don't look back." But look back she did. She could see the horizon completely aflame. Everything was burning. They reached the village of Dietersdorf, a small hamlet of 500 residents. The family found shelter in a bombed out barn. They would dig into the snow and into dirt to clear an area in which to sleep, desperately trying to escape the bone-chilling cold. Still there was nothing to eat or drink. Every night she would feel the

This column features a life-altering event that has had a great impact in a senior citizen's life, molding that person into who he or she is today. The people interviewed are all members of the Glen Cove Senior Center.

No adult should have to live through the terrors of war, much less an innocent child, but that is exactly what happened to little Janina, age 5.

The year is 1939; the place is a suburb of Krakow, Poland. Hitler had just invaded Poland. Young Janina had been born in Poland to a German mother just five years prior to the German invasion. In the dead of night the Gestapo burst into their house with machine guns drawn. The German War Machine is efficient and vicious. Children to the left; adults to the right they barked their orders in German. Janina and her two brothers are separated from their beautiful mother. Her memories are etched into her mind not like a well-developed screen play, but rather like discordant flashes of images from a horror movie. She remembers, quite vividly, massive graves. In her mind's eye, she can see people lined up, hear bursts of machine guns, see corpses piled in the street and hear moans emanating from within that pile of humanity. She has a vision of herself and her brothers standing in the snow behind the barbed wire of an abandoned castle somewhere in Czechoslovakia. She remembers the hunger, the constant, overwhelming feeling of hunger and the children starving to death.

Her memory shifts to her gorgeous aunt, an entertainer, coming to her and her young family in the night. "Don't ask any questions. We have to run." And run they did with burlap wrapped around their bare feet to protect them from the freezing snow. She, her brothers, her

constant hunger that would gnaw at her until sleep overcame her. But there was no place for her family in this small village so they had to move on.

They next reached nearby Gemunda. This is the place that Janina calls home. This is where a kindly woman named Anna Kurz gave her a slice of bread. The memory of this small, welcoming gesture comes rushing back to her consciousness with love and gratefulness. Janina remained in Gemunda from 1942 until 1950, when at age 15 she and her family would migrate to the United States. Here she and her siblings would be reunited with their beautiful mother.

Janina's experiences of growing up in war-torn Europe could have left her a hateful, bitter woman and no one would blame her, but she is just the opposite. She is a gracious, handsome lady who's amazingly huge heart outshines her wonderful smile and the twinkle in her eye. She is open, warm and compassionate. Her love of life and love of her fellow human beings is endless. This unassuming woman has dedicated her life to the service of others, volunteering seven days each and every week. Weekdays you will find her at the Glen Cove Senior Center from early morning under the doors close for the evening, just as her mother had done before her. She was awarded the Exceptional Service Award by the United States Air Force, an honor of which she is very proud. On Senior Day 2014 she will receive the well-deserved Award for Service and Dedication to the Senior Community. We are very proud of Janina who gives of herself selflessly and completely, the picture of dignity, never complaining and never judging.

Mock Trial requires students to understand and present a court case written by lawyers and judges from across New York State. Teams must work both sides

State of the Village Address

The following was presented by Mayor Bruce Kennedy at the Village Annual meeting last week.

Board of Trustees, Appointees, Volunteers and fellow residents; thank you for your attendance this evening for the 2014 Village of Sea Cliff Annual Meeting. It is my pleasure and honor to present the State of the Village Address. This has been another good year for our Village. Despite still being in the grips of difficult financial times we once again have proven that government can continue to offer all vital services while being extremely financially responsible.

Since 2009, the Village has maintained a virtually flat year to year budget without resident service cuts – in fact the Village offers more to the residents today than we did 5-years ago. The New York State Comptroller's office has recently adopted an evaluation system of measuring and reporting the fiscal health of local governments. Sea Cliff scored in the top 1% of all the 535 village governments across New York State. Last year, Standard & Poor's upgraded our Village Bond Rating to a AA+ and after an additional review last week, they renewed this exceptional rating.

We have heard a lot in the past couple of years from our Governor that he wants to decrease the property tax burden that we on Long Island have to shoulder and the Board of Trustees and I strongly support Governor Cuomo in this effort. However, the Governor needs to take a hard look at what is driving costs and in turn property taxes. While facing mandated costs such as state pensions, health insurance, and workman's compensation which annually grow at double digit rates in the face of decreasing state funding; it is no great mystery why property taxes on Long Island are so high. Local government cannot cap costs that they cannot control. Fixing this dilemma is going to take a lot of teamwork between the state - local governments – and school districts but I am confident that overall property tax relief is an achievable goal. We have proved it here in Sea Cliff.

We have seen some changes in personnel at Village Hall this past year. Our Community Development Director, Kathleen Van Bloom, as well as our

Section 8 Administrator, Lenny Kaplan, have retired. We will miss both Kathleen and Lenny; we thank them for their years of service and wish them the best in their well deserved retirement years. In an effort to create greater synergies in the staff, both of those part-time positions have been combined as well as the responsibility of grant writing into one new full time position which has been filled by resident Erin McDonnell. Erin is off to a great start and has already proven herself as a tremendous asset to the Village. Erin, on behalf of all of us, welcome to the team.

The Fire Department held its election last week and I am proud to announce the appointment of Ernie "Bullet" Longobucco as the Chief, Mark Vitale as the 1st Assistant Chief, and Michael Hallquest as the 2nd Assistant Chief. Our gratitude is extended to Chief Danny Whittemore for his leadership in guiding the Fire Services for the past two years.

This was a tough winter with extreme cold temperatures and record snowfall amounts. Our Department of Public Works staff once again proved their dedication to the job. Despite very difficult conditions, these men were out countless hours, both day and night, to ensure the safety of our residents. How about a round of applause for these often underappreciated gentlemen? Now that spring is apparently here, it is time to start our roadwork, cleaning the parks & walkways, and other seasonal work in preparation of baseball and beach season. Our DPW staff is coordinating with the beach staff in preparation for another incredible summer. The food vendor has been selected, lifeguards are being hired, and talent is being scheduled for the Friday Night Concert Series at the Beach Arts Gazebo.

Our Senior Outreach Worker, Karen Montagnese, continues her good work in identifying and addressing the needs of our Senior Citizens. Karen has also been collaborating with our other committees and volunteer groups to further enhance the lifestyles of all our residents. Karen

developed a Senior Survey which has been well received that helps us to be of greater serve to our seniors. If you are or know a senior that has not completed the survey, please fill it out so you can get the benefits that our Senior Services offer.

A couple of years back we made additional property tax relief available to our senior citizens and this year we will be putting forth legislation that will offer similar relief to the often forgotten champions of our community – our Veterans. I would like to take this opportunity to thank our veterans for their selfless sacrifices and service to our nation. Will the veterans in the room please rise so that we can recognize you.

So often people think things "just happen" but we all know that nothing good happens without the initiation of citizens that are working for the betterment of their community. Sometimes these people are your elected officials. Carol Vogt, my Deputy Mayor, is one of those people. Last Week's Celebrity

This week's celebrity was an American actor and comedian remembered for his amiable screen persona, comic timing and enormous smile. He was one of the most popular American comedians of the 1930's and '40's. He was born in Holgate, Ohio on July 28, 1891 and spent most of his childhood in Toledo. In 1902, at the age of nine, he joined a troupe of circus tumblers known as "The Five Marvelous Ashtons", who toured the country on both the circus and vaudeville circuits. Later, he became a professional baseball player. Despite his skill, he declined an opportunity to sign for the NY Yankees to pursue his career as an entertainer. After appearing on Broadway, first in the musical "Jim Jam Jems", he began making films in 1928. In 1929, He started with Warner Bros. and quickly shot to stardom after appearing in the first all-color, all-talking musical comedy "On With The Show" (1929) with Arthur Lake, a.k.a "Dagwood Bumstead". After several lavish Technicolor musical comedies, he put his baseball skills to work in "Fireman, Save My Child" (1932), a comedy which he played a member of the St. Louis Cardinals. Then "Elmer, the Great" (1933) and "Alibi Ike" (1935) with Olivia deHavilland. In both of the latter films, he portrayed ballplayers with the Chicago Cubs. In his later career, he starred in Billy Wilder's "Some Like It Hot" (1959), as "Osgood Fielding III", in which he speaks the famous punchline "Well, nobody's perfect". Last week's celebrity was born Nelia Pauline Burgin, but was professionally known as Polly Bergen. She received an Emmy Award for her portrayal of singer Helen Morgan in the episode "The Helen Morgan Story" in the 1950's TV series "Playhouse 90". Signed to Columbia Records, she enjoyed a successful recording career during the 1950's. She also was known as "The Pepsi Cola Girl", having done a series of commercials for the product. In 1963, she co-starred with Doris Day and James Garner in the film comedy "Move Over Darling", a remake of Garson Kanin's "My Favorite Wife" (1940) with Cary Grant and Irene Dunne. She earned an Emmy nomination for her role as "Rhoda Henry", wife of "Capt. 'Pug' Henry", played by Robert Mitchum, in two ABC miniseries, "The Winds of War" and its sequel, "War and Remembrance". From 2007-11, she had a guest role in ABC's "Desperate Housewives" as "Lynette Starvo's" mother "Stella Wingfield", which earned her another Emmy nomination. She became a semi-regular cast member of 2006's "Commander-in-Chief", as the mother of "Mackenzie Allen", President of the USA, played by Geena Davis. Bergen herself played the first female President of the USA as "President Leslie McCloud", in the 1964 film "Kisses for My President" co-starring with Fred MacMurray. When not working, Bergen lives in her home in Connecticut.

“Seasons at Cedarmere”

The Friends of Cedarmere, a non-profit, 501(c)(3) organization, will host a Spring Benefit Luncheon at 12 pm Sunday, May 4 at Sea Cliff Yacht Club. The Friends are a vital support group for the restoration of the museum and public property known as Cedarmere, home of 19th century poet, journalist and civic leader William Cullen Bryant. This occasion is the first in a series of events under the heading “Seasons at Cedarmere.” Guests will enjoy a sumptuous lunch buffet, prepared by the Yacht Club’s culinary staff, and also a complimentary bar drink. Featured presenter will be noted author Gilbert H. Muller, whose recent 2008 biography William Cullen Bryant: Author of America was hailed by The Wall Street Journal as “...captivating ... richly researched and readable.”

The important role played by Bryant in American life, in addition to championing abolition and Lincoln, is captured on the jacket of Muller’s book: “The bedrock of Bryant’s cultural authority was his reputation as ‘America’s first poet’...[who] enthralled a nation and his peers—including Whitman, Poe, Longfellow, and Emerson—who praised the excellence of his verse. A literary celebrity for almost seventy years, Bry-

ant served as the editor of the New-York Evening Post for five decades, and was a major force behind the establishment of Central Park, the National Academy of Design, and the Metropolitan Museum.”

Bryant’s Cedarmere estate in Roslyn Harbor is a unique 7 acre historic property, comprising a Main House, a Mill and Pond, a Parterre and a Sunken Garden. It was deeded to Nassau County in 1975 by his descendants as a memorial to Bryant, to be used by the public for historical, cultural and educational purposes. The museum was closed in 2009 for much-needed restoration, which the County is undertaking with help from The Friends, The Gerry Trust and, most recently, The Hagedorn Foundation.

"Nassau was home to the leading industrialists of the day who were often embarrassed by lopsided losses that were reported in the local newspapers. Under the Nassau system, the worst loss was 3-0. This system prevented bruised egos and kept the matches competitive."

From Aug. 4-10, 2014, Nassau Country Club will again be in the spotlight as 156 of the top female amateur golfers compete in the 114th U.S. Women's Amateur Championship, conducted by the United States Golf Association. At stake will be the Robert Cox Trophy, the oldest trophy that the USGA awards in a women's championship, as well as

the title of national champion. Founded in 1896, Nassau Country Club hosted the 1914 U.S. Women's Amateur, won by Katherine Harley Jackson. This year marks the 100th anniversary of hosting the same championship, which is a rare achievement for any club. Nassau Coun-

Sea Cliff S.T.E.M. Fair Exhibits A Passion For Learning

North Shore Schools, Glen Head, March 18 - Sea Cliff students showcased their science, technology, engineering and math knowledge in the 2014 S.T.E.M. Fair. In a symposium format, students displayed and presented their projects for the entire school to see! In the evening, parents and guests were invited to explore the uniquely innovative selection of S.T.E.M. related projects.

Fourth grade students worked in partnerships and used the math problem-solving process to solve complex math word problems. At the Fair, 4th graders presented the strategies they used to understand and solve their unique problems, as well as hands-on approaches to check their solutions. Students used a wide range of strategies to work toward valid solutions; draw a diagram, guess and test, work backwards, make a table and algebraic reasoning.

This year, the 3rd graders joined fifth grade students in presenting experimental science projects at the S.T.E.M. Fair. Third and fifth grade experimental studies followed the steps to the scientific method and students demonstrated their skills at developing experimental questions, forming hypotheses, analyzing data, and drawing conclusions.

Some third graders explored areas of science including; chemical reactions, aerodynamics, and ultra-violet radiation. The 5th graders investigated a wide variety of interest-based experimental questions, such as how does entry speed affect the height of an aerial flip, how does the type of sweetener affect taste preference, and how does the type of water filter affect the cleanliness of the filtered water?

Fourth grade students shared Forensic science presentations and informed their peers about the work of forensic

scientists. Visitors had the opportunity to take part in forensic labs in the areas of toxicology, fingerprinting, chromatography, and handwriting and fiber analysis.

Technology and engineering projects were presented by students in second through fifth grades. Applying the principles of the Engineering Design Process, second grade students took part in Space Science Engineering. Students engineered solutions to the problem of providing oxygen to astronauts living on a space station. The second graders presented their discoveries and the workings of their space station model to visitors.

Third grade students engineered solutions to the world's plastic problem. Students learned about the 5 Gyres of Plastic Waste and the Great Pacific Garbage Patch. They participated in a school audit of plastic waste and engineered solutions to reduce the use of plastic waste at Sea Cliff Elementary. Students shared a presentation outlining their plan.

Students in fifth grade shared independent social action projects in a "TED Talk" format, educating the audience on child labor, consumerism, water security, deforestation, endangered species, alternative sources of energy, Global Warming and the Greenhouse Effect. A fifth grader said, "I think the S.T.E.M. fair is a great experience because I had the chance to present a topic that I am interested in and share what I learned with others."

As parents walked around the different exhibits, you could hear one proudly remark, "The student work at the S.T.E.M. Fair is impressive and really shows a passion for learning!"

Incorporating Technology for Convenience To The Editor,

Technology has been growing in leaps and bounds over the past decade. Today, information is disseminated at a rapid pace through e-mails, text messages, and through social media outlets like Twitter and Facebook.

Traditionally, governments tend to lag behind the times in keeping up with technological innovations. As a result, the public is subject to an archaic system of sharing information that makes access to information, not impossible, but less convenient, which perpetuates the disconnect and leaves the public out of the loop of information.

The payments of warrants are approved by the City Council every month. The warrants are paid with tax dollars and sometimes with grants. These bills are contained in a vast spreadsheet sometimes 30 pages long. The monetary range of warrants paid can range from and total from \$300,000 to \$2 million.

Quite frankly, there exists an antiquated system for public to access these warrants. Currently, the procedure for accessing these warrants as a member of the public is to physically attend a City Council Meeting and cull through a vast paper copy of the warrant document. This task is arduous, time consuming and is not practical or convenient for most of the public. I believe that the procedure for accessing these warrants should be changed by incorporating technology. For example, the City Council receives an electronic copy of these warrants for review prior to every City Council Meeting. My suggestion is to upload this same electronic copy of the warrants on the Glen Cove City Website. In doing so, the public will be more informed and gain easier access to information.

I don't expect governments to keep pace with technological advances; that would be impossible. However, we are in the 21st Century and owe it to the public to make the sharing of information more accessible and convenient.

I initiated the monthly Birthday Rose Ceremony. So, anything we can do to help keep this wonderful community resource alive is a pleasure to do.

Also, in Glen Cove, we are applying to aid the After 3 program with a new iPad curriculum, which would train students on the use of tablet computers. This will be a regular part of life and school for young people, so the implementation of training into their afterschool support seems like a very good idea, at a low cost.

In Port Washington, I was thrilled to meet with the leadership at Landmark on Main Street along with my esteemed predecessor Wayne Wink. Wayne put through a grant for the Landmark to redo their gym floor and we celebrated the completion of this project recently together.

Also in Port, I have been working with the Art Guild to hopefully get their site back in full swing. The group is on a county property, Elderfields, which has been in limbo ever since hurricane Irene and a subsequent fire. I am exploring how to help the Art Guild make the most of this historic building because I believe their plans for the site can benefit the community in many ways.

I am currently working with various community groups and businesses to develop some beautification projects in Port Washington. There are such a wealth of restaurants and businesses in Port and I would like to support them with improvements to the entryways and walkable areas that make visiting even more inviting and pleasant.

This same preliminary exploration also includes Sea Cliff, where I am seeking to renew the area along the water on Shore Road and also possibly spruce up the walkable region along Sea Cliff Avenue.

I have met with representatives from Nassau County's administration and Department of Public Works to get the ball rolling on these Port Washington and Sea Cliff projects.

Going Green at Glenwood Landing! Students Teach Their Peers About Composting

North Shore Schools, Glen Head - Throughout the school-year at Glenwood Landing, students have been actively participating in measures that will help our environment including recycling, growing their own vegetables in the Outdoor Classroom garden, and composting.

Thanks, to the "Compost Kids," the entire Glenwood Landing student body together has begun composting. Students and faculty have been encouraged to throw their food scraps into compost trash cans which are later emptied into compost tumblers. These scraps would normally be thrown into the garbage, resulting in more trash in landfills. Instead, food scraps are being turned into rich soil to grow vegetables in the GWL Outdoor Classroom. These vegetables can then be eaten by students in the cafeteria! Mrs. Marcantonio, GWL Enrichment Teacher, who is leading this effort said, It is an exciting and wonderful cycle!

By definition from Wikipedia, Compost, is organic matter that has been decomposed and recycled as a fertilizer and soil amendment. Compost is a key ingredient in organic farming. At the simplest level, the process of composting simply requires making a heap of wetted organic matter (leaves, "green" food waste) and waiting for the materials to break down into humus after a period of weeks or months. The decomposition process is aided by shredding the plant matter, adding water and ensuring proper aeration by regularly turning the mixture. Worms and fungi further break up the material. Compost can be rich in nutrients. It is

used in gardens, landscaping, horticulture, and agriculture. The compost itself is beneficial for the land in many ways, including as a soil conditioner, a fertilizer, addition of vital humus or humic acids, and as a natural pesticide for soil.

Recently, fourth graders at Glenwood helped their peers in Ms. Krista Pitman's class begin composting; the soil will end up in the Outdoor Classroom garden beds. In addition, the "Compost Kids" have held many presentations and have provided poster education which is currently being displayed on the walls of the cafeteria. Mrs. Marcantonio stated, "Since, the student body generates so much compost in one single day, we can only compost once a week! Fridays have been dedicated to composting."

Mrs. Audra Marcantonio concluded by saying, "The overall objective is to help the world by having all the kids first educated, then composting in school, and hopefully even begin to do so at home." To our North Shore parents and guardians, please take the time to ask your GWL students about composting and their efforts to help make our environment and ultimately the world a better place. Go Green!"

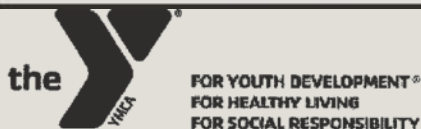
