“If you don’t come, there will be a massacre”



On April 30th, (Thursday morning) at 1:32am the Glen Cove Police received a 911 phone call from a woman who needed assistance. When questioned about the situation further the woman hung up the phone, according to Det. Lt. John Nagle. The officer was able to call her back and spoke to her further about the incident. During the phone conversation the caller stated to the officer, “If you don’t come there will be a massacre.”

Officer Brian Simmons and Andrew Mozer were dispatched to her location. Once they arrived at 238 Glen Cove Ave in Glen Cove the caller met them outside in the driveway. The caller told the officers that she had been arguing with her husband for a few days and were in the process of a divorce. She went on to tell the officers that their three children (ages 4, 3, 1) were inside the house and that she was afraid that her husband might kill her. The two officers entered the house to locate the husband and discovered him in an upstairs bedroom. The husband was holding a shotgun in his hands and was in the process of loading it when he was startled by the officers. The shotgun was a double barrel and one of the barrels was already loaded with a shell and the defendant was in the process of loading the other shell. When the defendant saw the officers he turned towards them with the weapon at which time the officers tackled the defendant, said Nagle.

The recovered shotgun was a 16 gauge Springfield double barrel shotgun, the shotguns barrel and stock was cut down making the weapon much shorter than originally manufactured. The husband identified as Brandan Ashby age 29 of 238 Glen Cove Ave Glen Cove NY was charged with criminal possession of

a weapon second degree, criminal possession of a weapon third degree, resisting arrest, and three counts of endangering the welfare of a child. The three young children were sleeping at the time of the incident and were not hurt. The

defendant will be arraigned in District Court on April 30th.

0“This incident could have quickly turned into a tragedy without the quick thinking and bravery of these two officers,” said Nagle.

Occupation:

Over the course of my professional career, I have held a number of different positions both in public schools and on the collegiate level. I was a physical education and health teacher at Elmont High School where I coached various varsity level teams. Subsequently, I became the Director of Health, Physical Education and Athletics for the Lynbrook Schools. I completed my public school service in the same position for the Harborfields School District. I then became an adjunct professor at Adelphi in the School of Education. In addition, I was the Coordinator of Student Teaching for the Department of Health Services and Kinesiology at Hofstra University. Currently, I am fully retired but dedicated to offering my expertise as a volunteer to serve our community.

Qualifications:

My professional and personal commitment has been to ensure every student the opportunity to maximize their potential as well rounded individuals in a safe and nurturing environment. As a result, I have implemented a wide range of policies and programs directed to health and wellness of the thousands of children in my charge. This committee is responsible for developing all regulations affecting high school athletes. I was the Chair of the Suffolk County Athletic Committee Appeals Committee that arbitrated issues concerning student athletes eligibility. A major responsibility as the Athletics Director was the fiscal management of a large detailed budget.

Name the Celebrity



This week's celebrity was an American actor probably best known for roles in western TV shows. He was born on Sept. 14, 1914 in Chicago, Illinois and by age 8 he was a circus acrobat and appeared at the Century Of Progress exposition in Chicago in 1934 with a trapeze act. As a young man, he worked successfully as a John Robert Powers model. He moved to Hollywood in the late 1930s and worked as a stunt man and bit player between modeling jobs. He was an occasional player in B westerns and the lead in 4 Republic Studio cliffhangers. and two for Columbia. He served with the US Army Air Force in WWII and made training films. Some of his films were "Forlorn River" based on a Zane Gray novel, "Kit Carson" (1940) with Jon Hall and Dana Andrews, "The Son of Monte Cristo" (1940) with Louis Hayward, Joan Bennett and George Sanders and "Ghost of Zorro" that ended up opening doors for this actor. He was quite popular with the younger TV viewers in the 1950s, especially when he made appearances at the Old Madison Square Garden and shared the stage with Lassie! They played to a packed house and the best was when the kids hurried down the steps to reach out and shake his hand. It was a little overwhelming for Lassie to lend a paw but looked on with excitement at all the smiles and squeals!

Last Week's Celebrity

Last week's celebrity was George Sandford Becker, more commonly known as Sandy Becker. There were times he would have 2-3 shows on at different times, day and evening and even weekends. Sadly most of Becker's programs were not preserved. Most went live and were not kinescoped or videotaped. They live only in the memories of those fortunate enough to have watched his shows. Some clips are surfacing on the internet. After he withdrew from on-camera hosting in 1968, he helped other children's shows create puppets and characters and he became known as a mentor to new generations of children's hosts. On his morning and later, afternoon children's programs, Becker

created such characters as double talking disc jockey "Hambone", added but brilliant "Big Professor", who claimed to know the answers to every question in the world, "K. Lastima", an Hispanic kid's show host, incompetent, mad scientist "Dr. Gesundheit", and showing a remarkable knack for silent comedy, earnest bumbling "Norton Nork". Sandy's show was so popular in the NY area that when he began using a version of the "Hambone" theme music from an old 78 RPM record by Red Saunders which was recorded in 1952, the OKEH record company re-released the song on a 45 RPM record. Enough kids bought the record that it reached Survey charts as #22 on local music radio station WMCA (The Good Guys) in March 1963. For the morning show's own theme music, Sandy used Guy Warren's "That Happy Feeling" as recorded in 1962 by Bert Kaempfert. The evening show used "Afrikaan Beat" also by Kaempfert and it, too, made it to the radio's Survey charts in the mid-'60s. Becker has a Glen Cove connection. After a fire at the Temple Tifereth Israel on Landing Road, Becker appeared during a fundraiser for the

building restoration in the mid-'50s. He kindly signed all the children's books, papers and shirt sleeves. We were all ecstatic!! On April 9, 1996, at the age of 74, Becker suffered a fatal heart attack at his home in Remsenberg, Long Island, a hamlet of South Hampton.

I'd like to take this opportunity to announce my candidacy for Trustee of the North Shore School Board of Education. I have lived in the district for 8 years, having relocated from the south shore of Long Island. I have embraced the peacefulness, beauty and sense of community I have experienced since my move. It is a truly special place.

Effluent of the Affluent To The Editor,

Crescent Beach has been closed for six years because of contamination from human waste. This has been documented by the Nassau County Department of Health.

This year a socially prominent Glen Cove property owner was sited and fined for deliberately diverting his own fecal waste into the flood plain that washes our beach. There was no expense to the taxpayer for its remediation which was funded by our errant neighbor. Subsequent testing by the County recorded a partial reduction in pollution. This was a minor but significant victory for the City of Glen Cove.

There are in our city seventy more, similar properties, owned by rich, socially prominent, politically connected neighbors, unconnected to our municipal waste system. It would be expensive to connect them. For many decades it has been cheaper for them to just use cess pools.

Some properties have more than one cesspool gone rogue. When it rains they overflow onto public property exuding human feces. This contributes significantly to the contamination of Crescent Beach and LI Sound.

The climate has changed. Water tables have risen. These derelict cess pools have become a public health hazard. They are soiling Crescent Beach, depressing surrounding property values and degrading quality of life.

It is irresponsible for our City to continue allowing the owners to pollute our flood plain, our beach, and our public waters. It is the responsibility of property owners to maintain their own facilities and clean up their own messes but they have been unwilling without legal ordinance.

An ordinance has been proposed to the City Council that would regulate cess pools and septic systems. Similar ordinances are already effectively in place on the other side of LI Sound. To follow suit would cost nothing. City Council should pass it and property owners should comply.

Albert Anthony Sommerfeld

Albert Anthony Sommerfeld of Greenvale, 93, passed away on April 20 after a long illness. He was born on June 3, 1920 in Brooklyn, NY. He graduated from Jamaica High School in 1938 and attended Queens College. He left college to join the Navy in August 1941. While training in San Diego, he was fortunate to walk away from a plane crash. During World War II, he was a pilot with the famous "Jumpin' Joe Clifton's" Carrier

Air Group 12 squadron, flying both the Dauntless and the Helldiver dive bombers. He spent about a year in the Pacific theater on the USS Saratoga and participated in over 42 air strikes against enemy bases.

After returning to the United States in mid-1944, he served as a flight instructor at Cecil Field in Jacksonville, Florida. He was later assigned to Floyd Bennett Field in Brooklyn and remained on active duty until early 1946. Following the war, he continued his service in the Naval Reserves, retiring as a Commander in 1973.

After leaving active duty in the Navy, he earned his bachelor's degree in civil engineering at Brooklyn Polytechnic Institute (now Polytechnic Institute of New York University), graduating magna cum laude in 1948. He married Doris Adele Johnson on May 22, 1949.

He began working for the New York Telephone company in 1948, and retired as a district manager in 1981, shortly before the breakup of the Bell system.

He was a member of Our Savior's Lutheran Church in Glen Head where for many years he managed the usher corps. He also enjoyed participating in the Manhasset Men's Club and attending performances of the New York City Opera with his wife Doris for many years.

He was an active volunteer, serving on the Village of Roslyn Harbor zoning board for several decades. He also helped raise funds for and participated in alumni activities at Brooklyn Polytechnic for many years.

He was preceded in death by his parents Albert Anton and Petronella Sommerfeld, and his sisters Marie Knipe and Harriet Hettick. He is survived by his wife, Doris A. 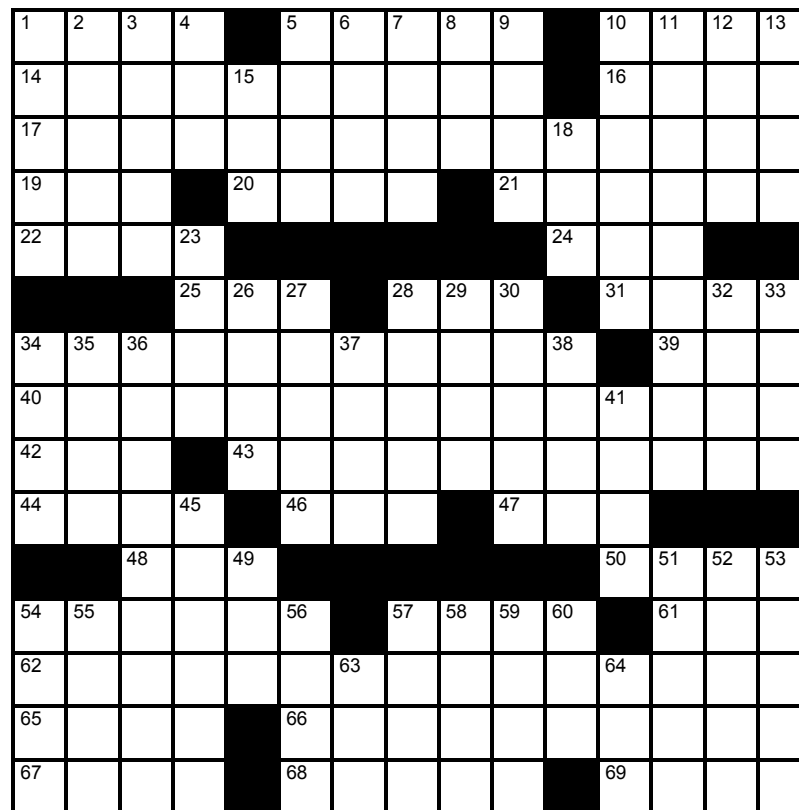
